(57) **CLAIM**

The ornamental design for my tri-configuration travel golf bag, as shown and described.

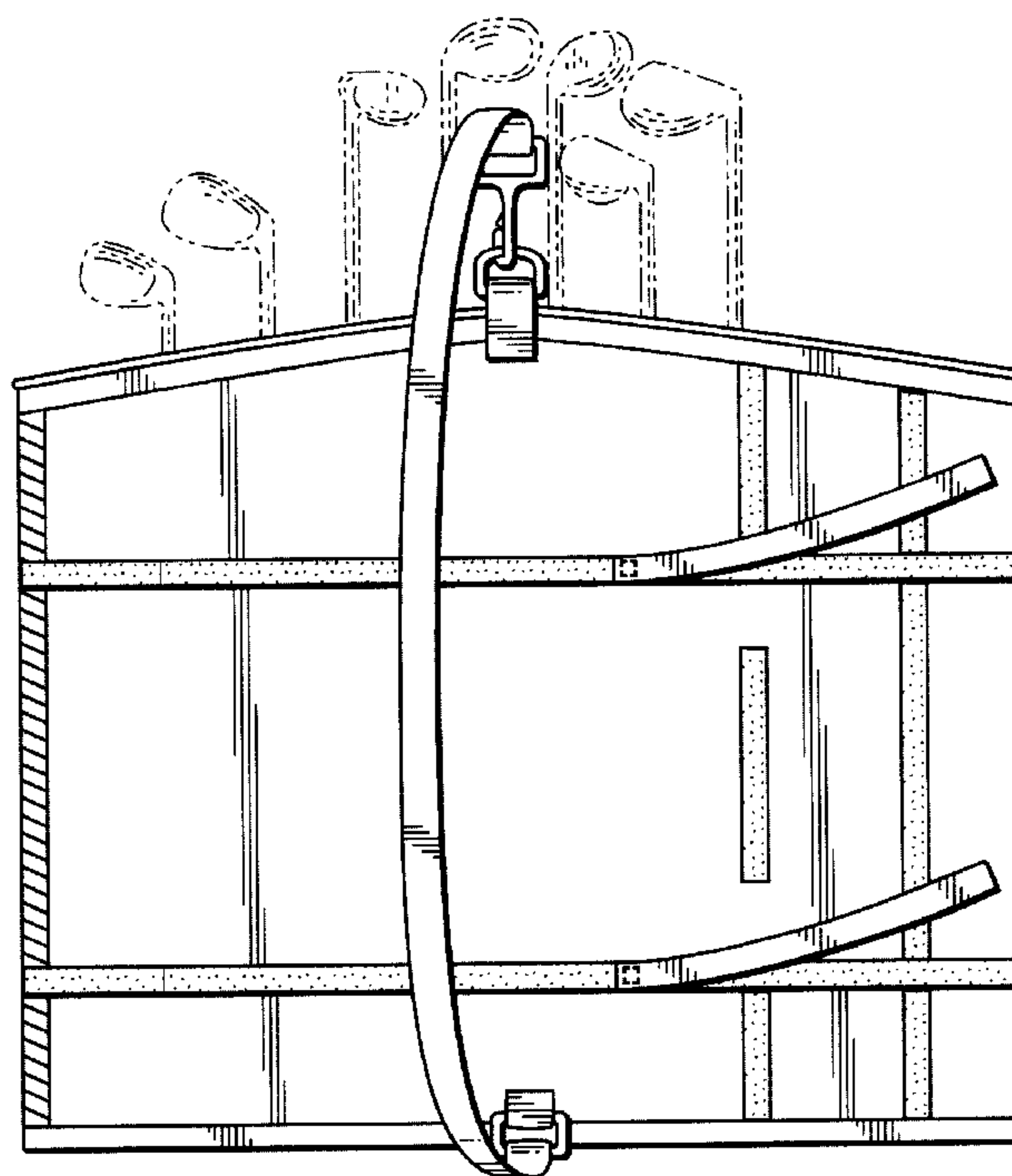
FIG. 1 is a side elevation view of the inside surface of the tri-configuration travel golf bag, in flattened configuration, with clubs, in phantom, inserted in the carrying pockets. The broken lines showing the clubs are for illustrative purposes only and form no part of the claimed design.

FIG. 2 is a side elevation view of the inside of the tri-configuration travel golf bag, in flattened configuration. The broken lines showing the clubs are for illustrative purposes only and form no part of the claimed design.

FIG. 3 is a perspective view of the tri-configuration travel golf bag, in transport configuration, with the clubs, shown in phantom, inserted in the bag, with the shoulder strap in view so that the bag so configured forms a smaller cylinder. The broken lines showing the clubs are for illustrative purposes only and form no part of the claimed design; and,

FIG. 4 is a perspective view of the tri-configuration travel golf bag, in playing configuration, with the clubs, shown in phantom, inserted in the bag, with the side opposite the shoulder strap in view, so that the bag so configured forms a larger cylinder, and with the shoulder strap in alternative position from FIG. 3, so that it not here in view. The broken lines showing the clubs are for illustrative purposes only and form no part of the claimed design.

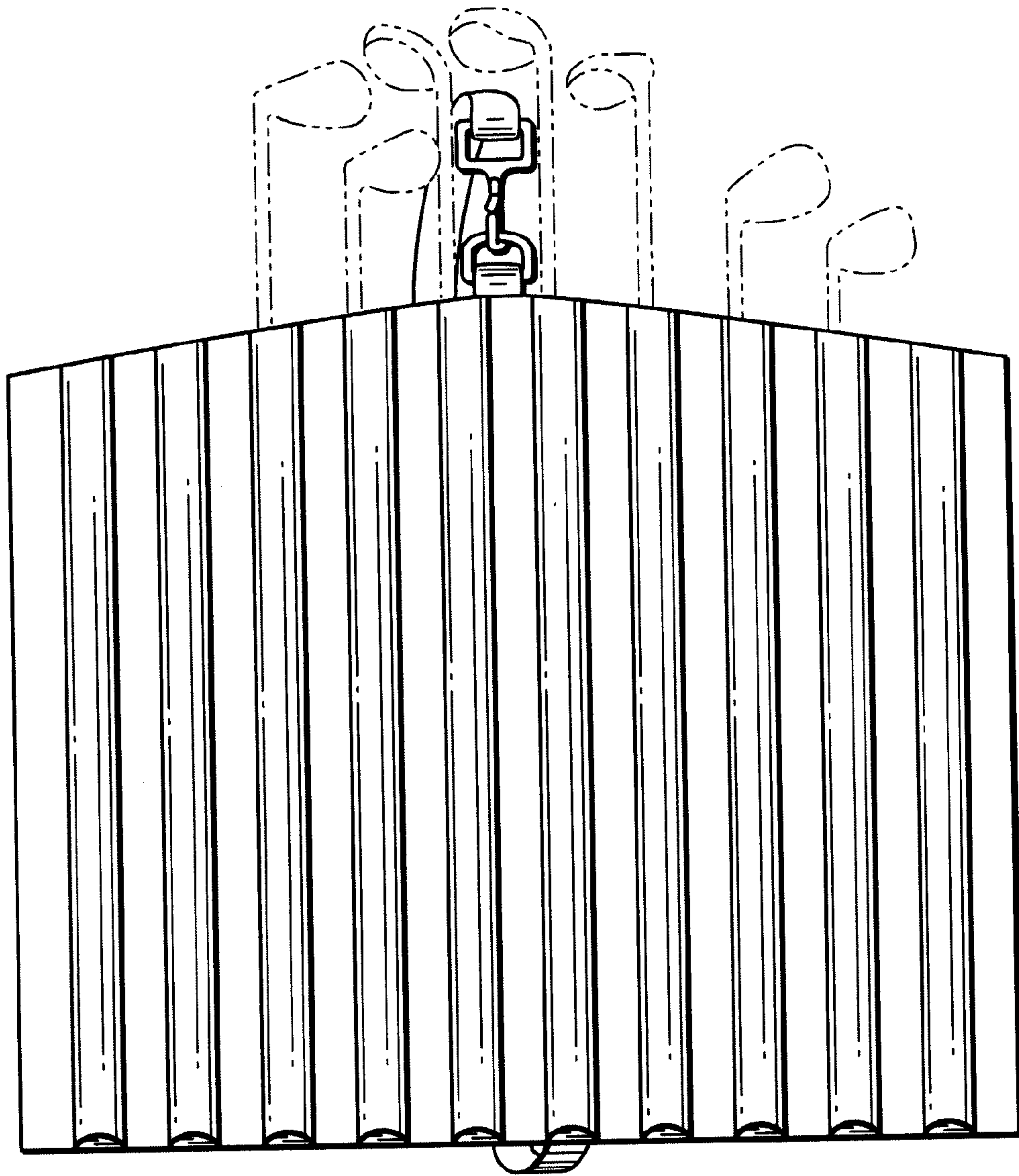

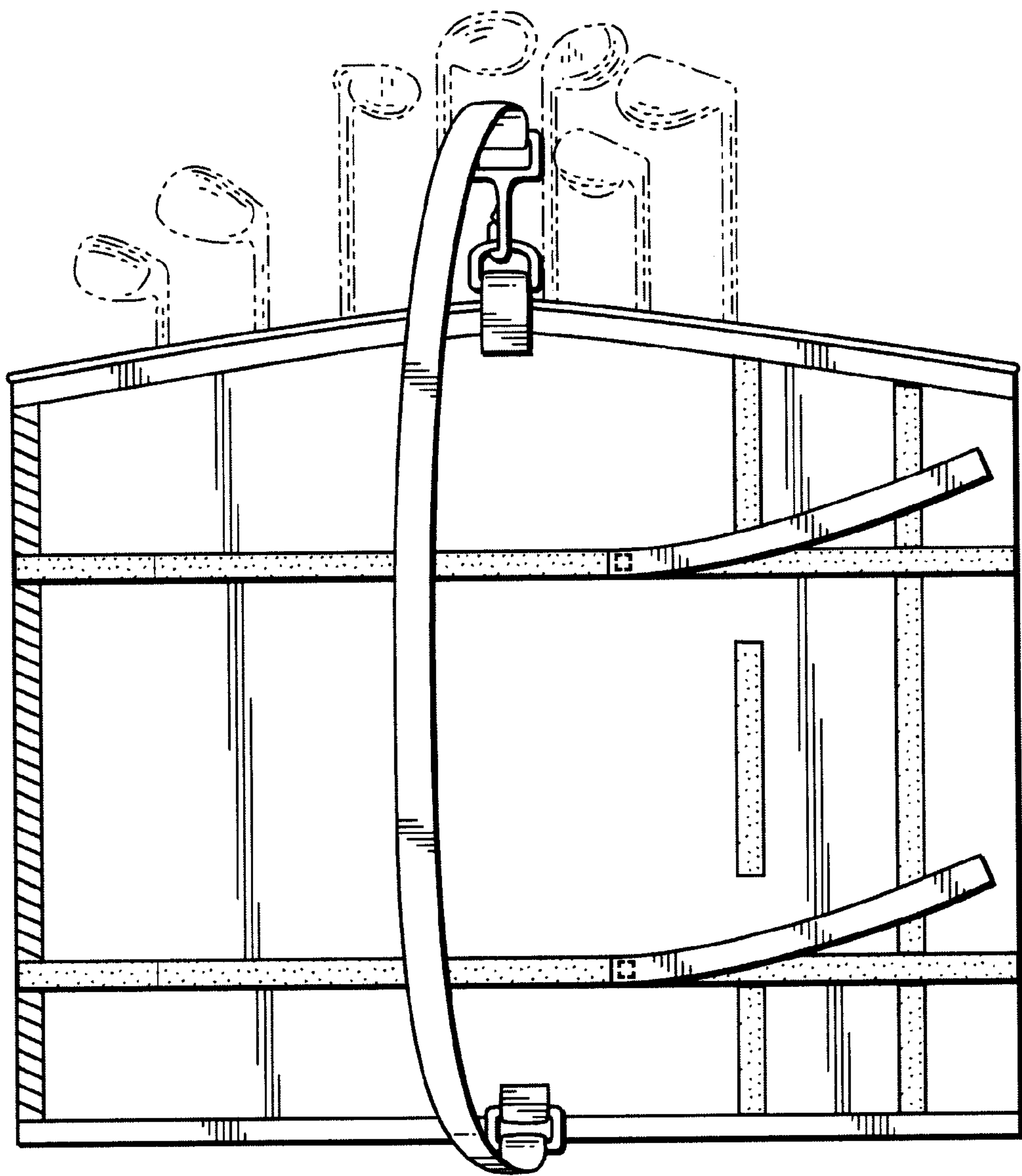

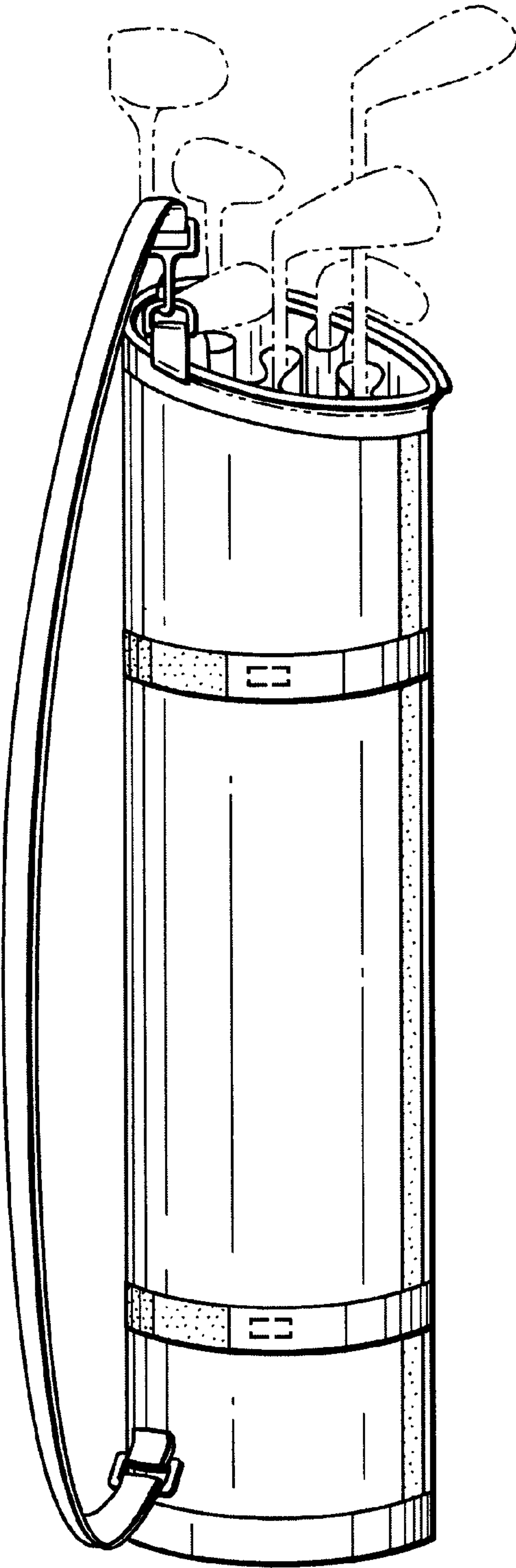

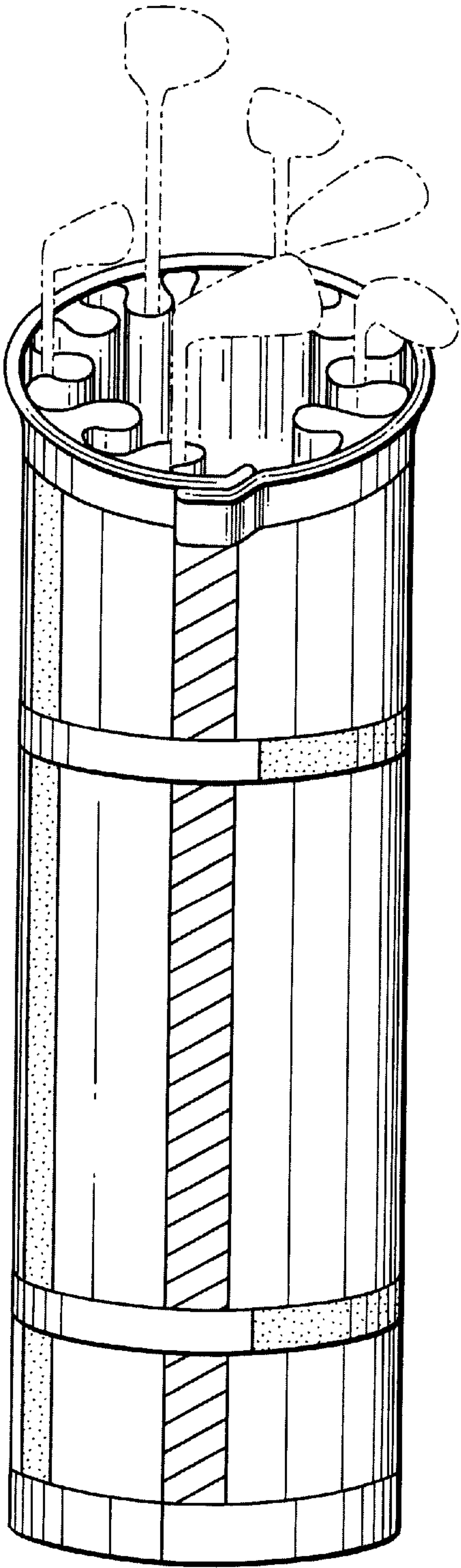
