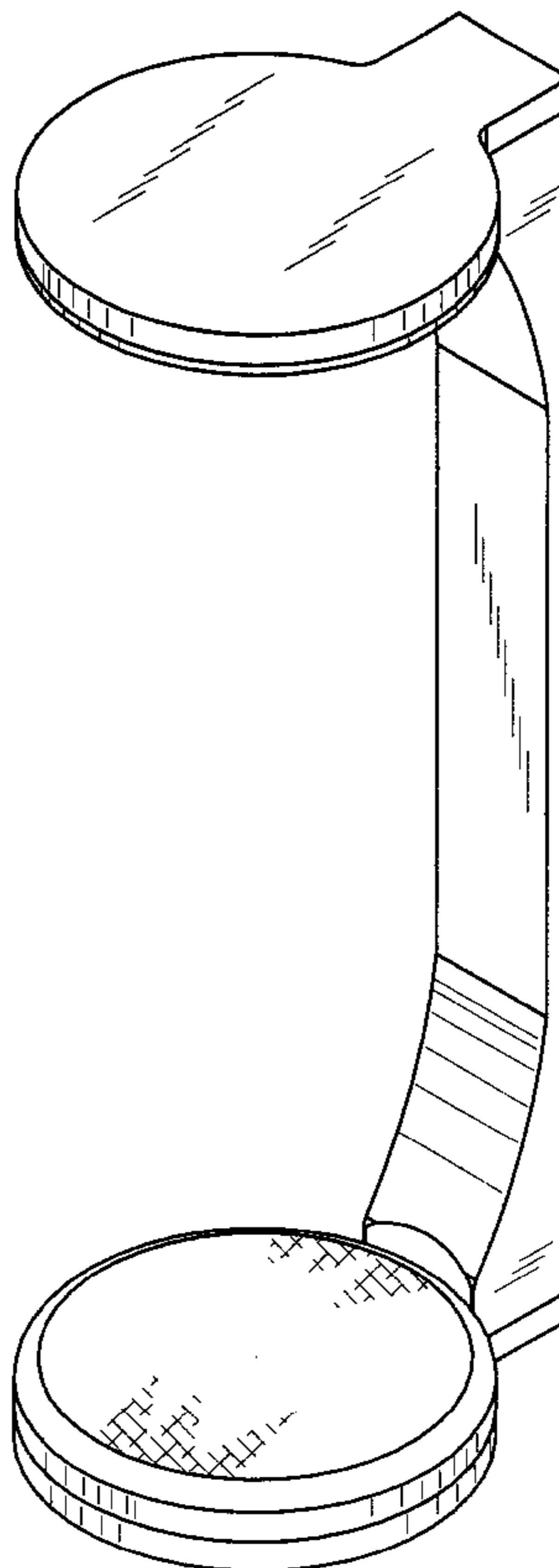
(57) **CLAIM**

The ornamental design for a head rest with mirror, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, right side perspective view of the head rest with mirror embodying my design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational thereof; FIG. 4 is a top plan view thereof, the bottom view being a mirror image thereof; FIG. 5 is a right side elevational view thereof, the left side elevational view being a mirror image thereof; FIG. 6 is a cross sectional view taken along line 6—6 of FIG. 5 showing of the mirror; and, FIG. 7 is a cross sectional view taken along line 7—7 of FIG. 5 showing of the headrest.

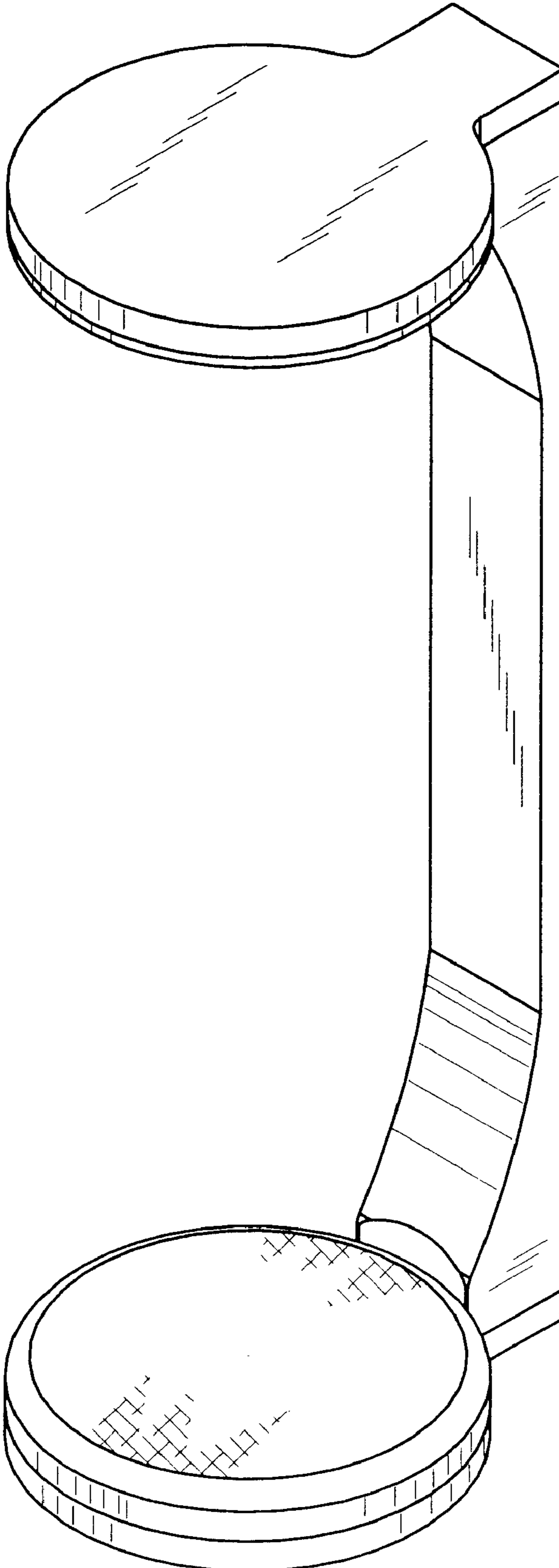

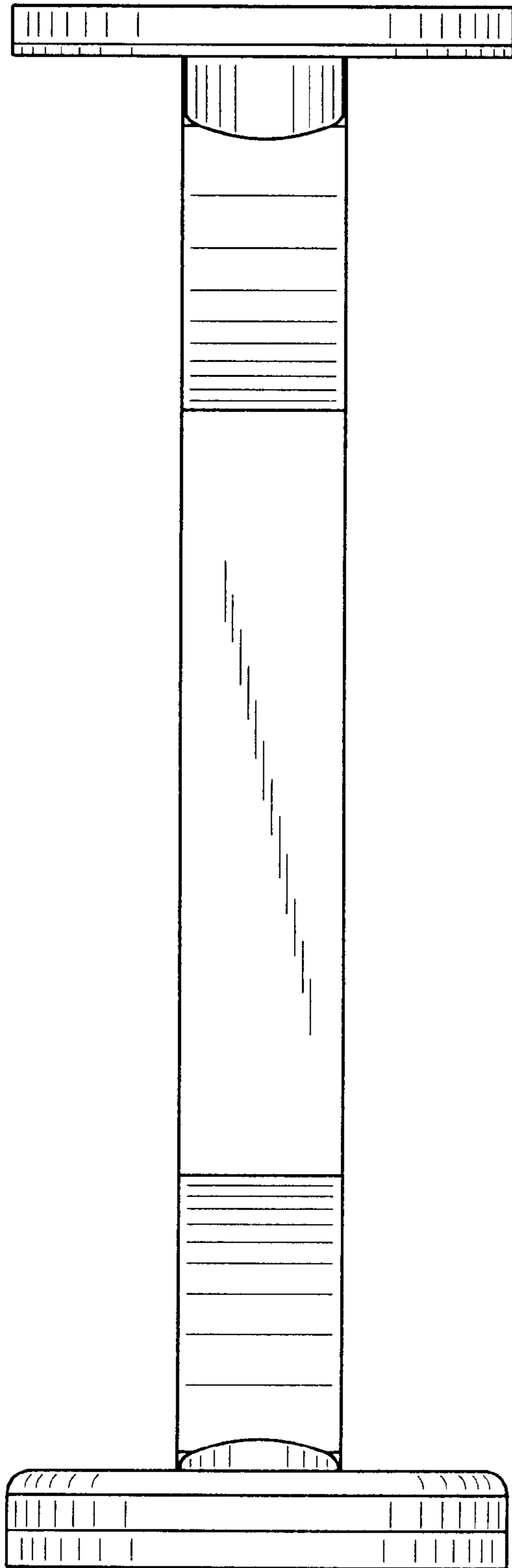

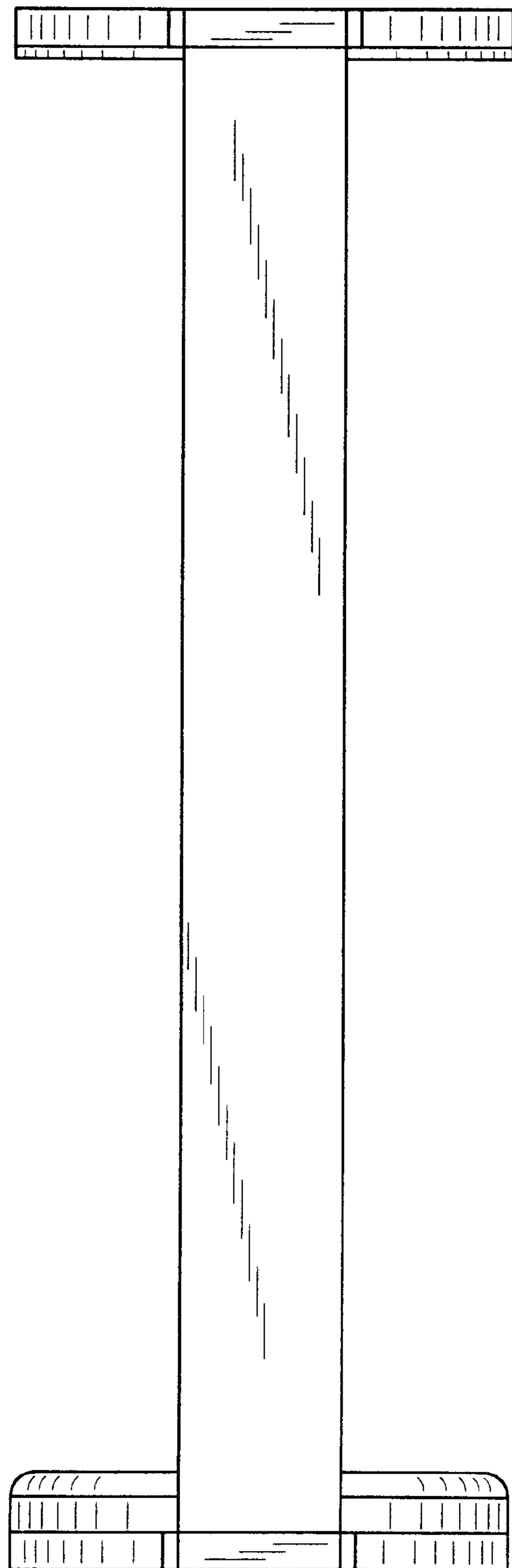

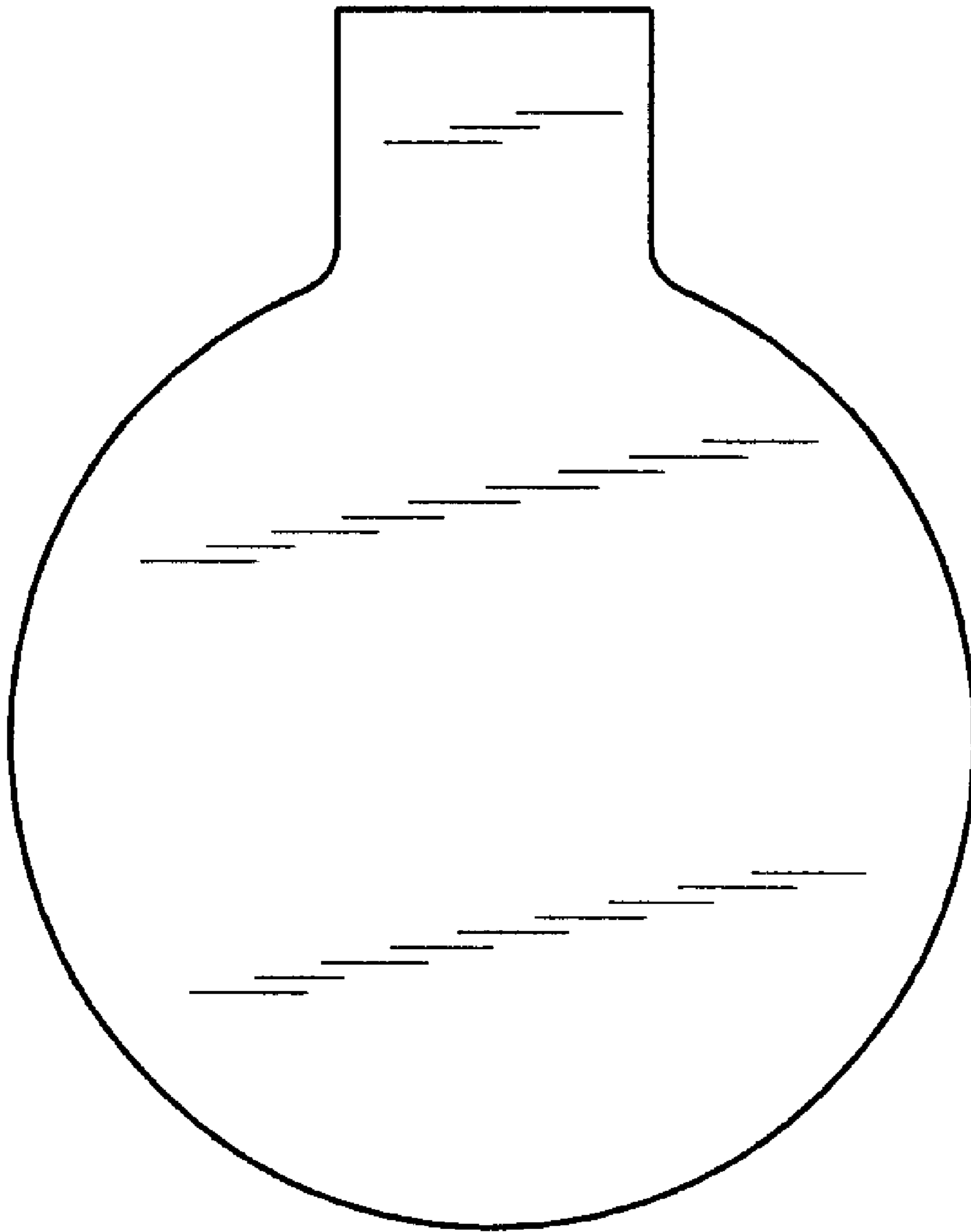

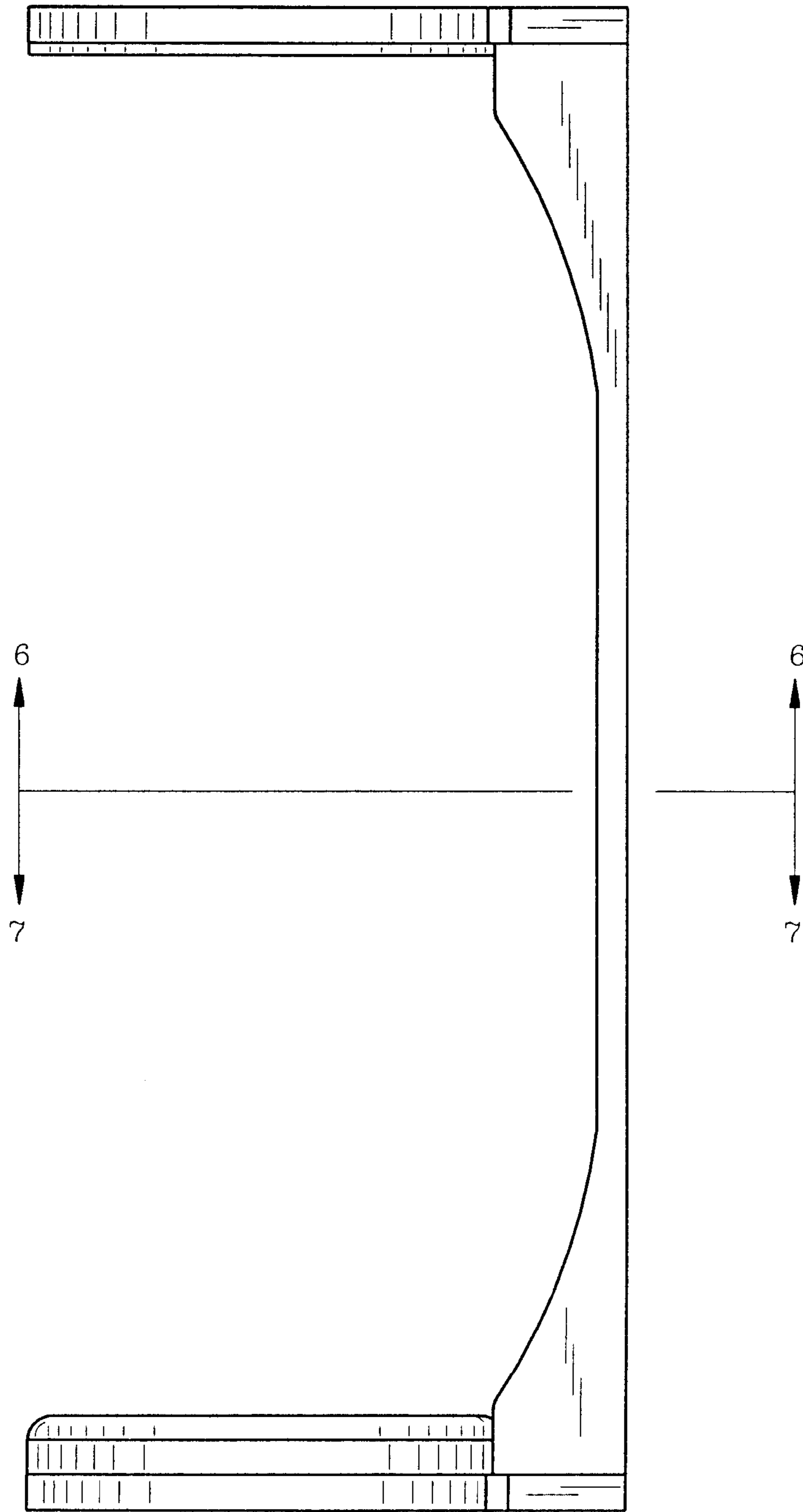

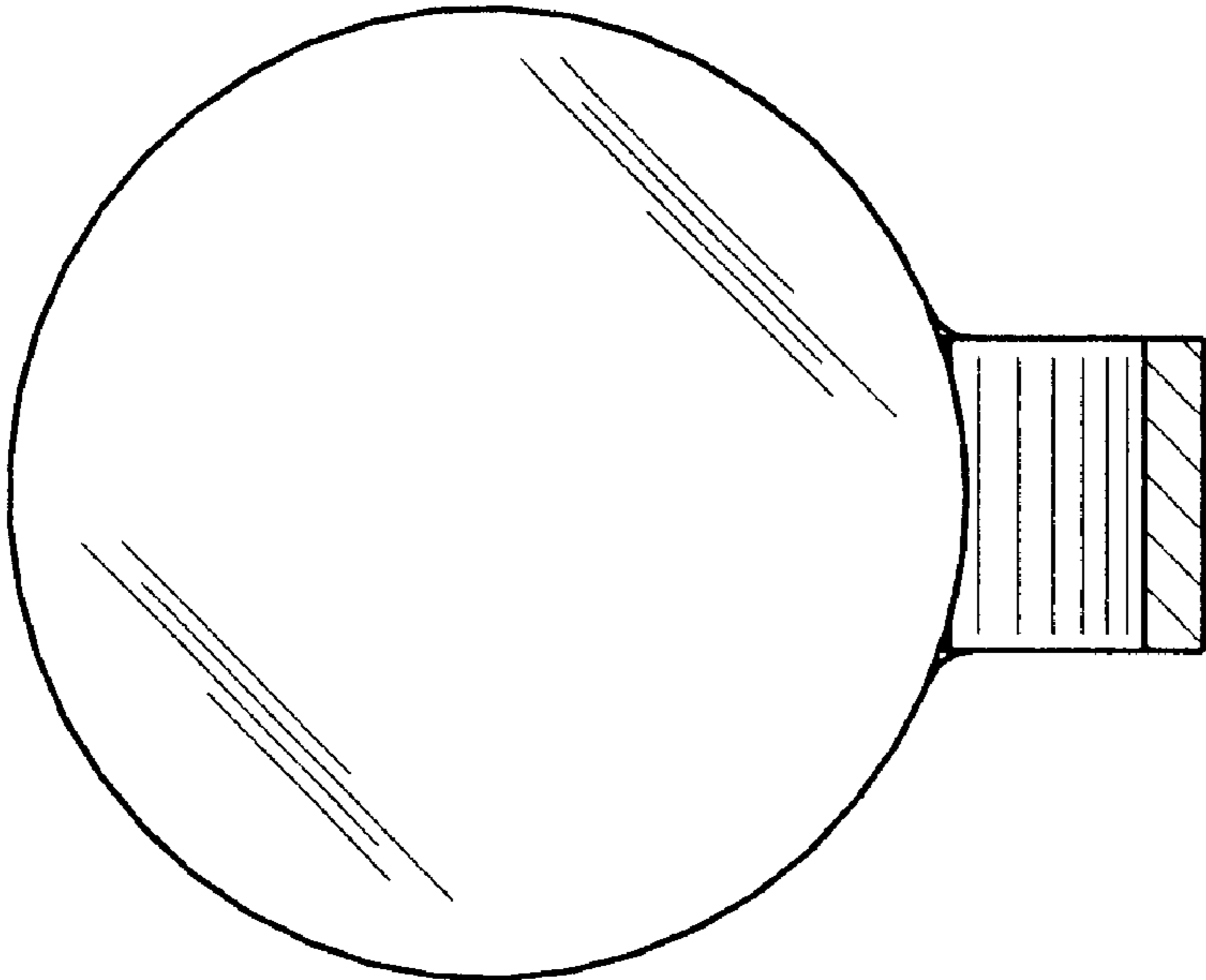

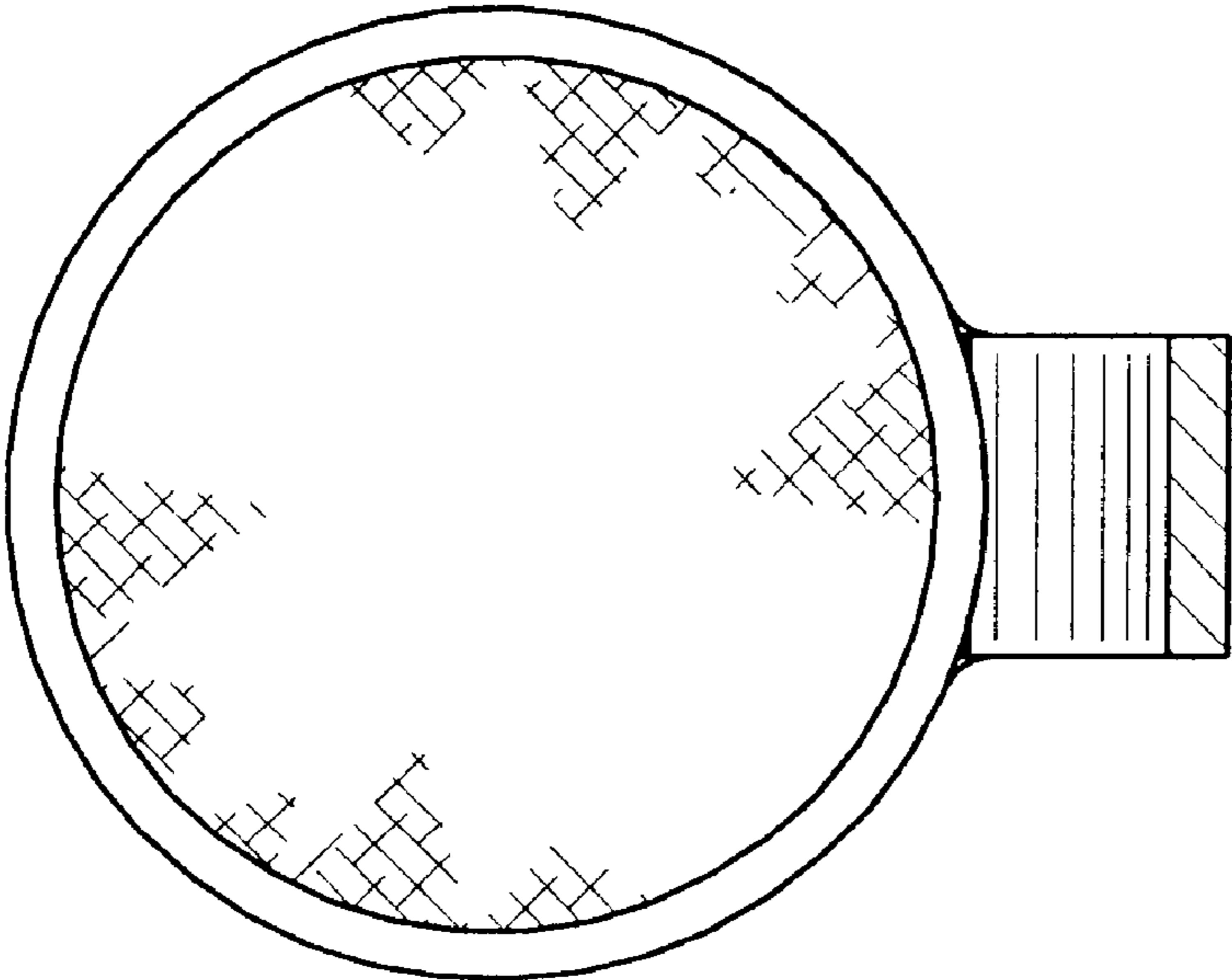
