DESCRIPTION

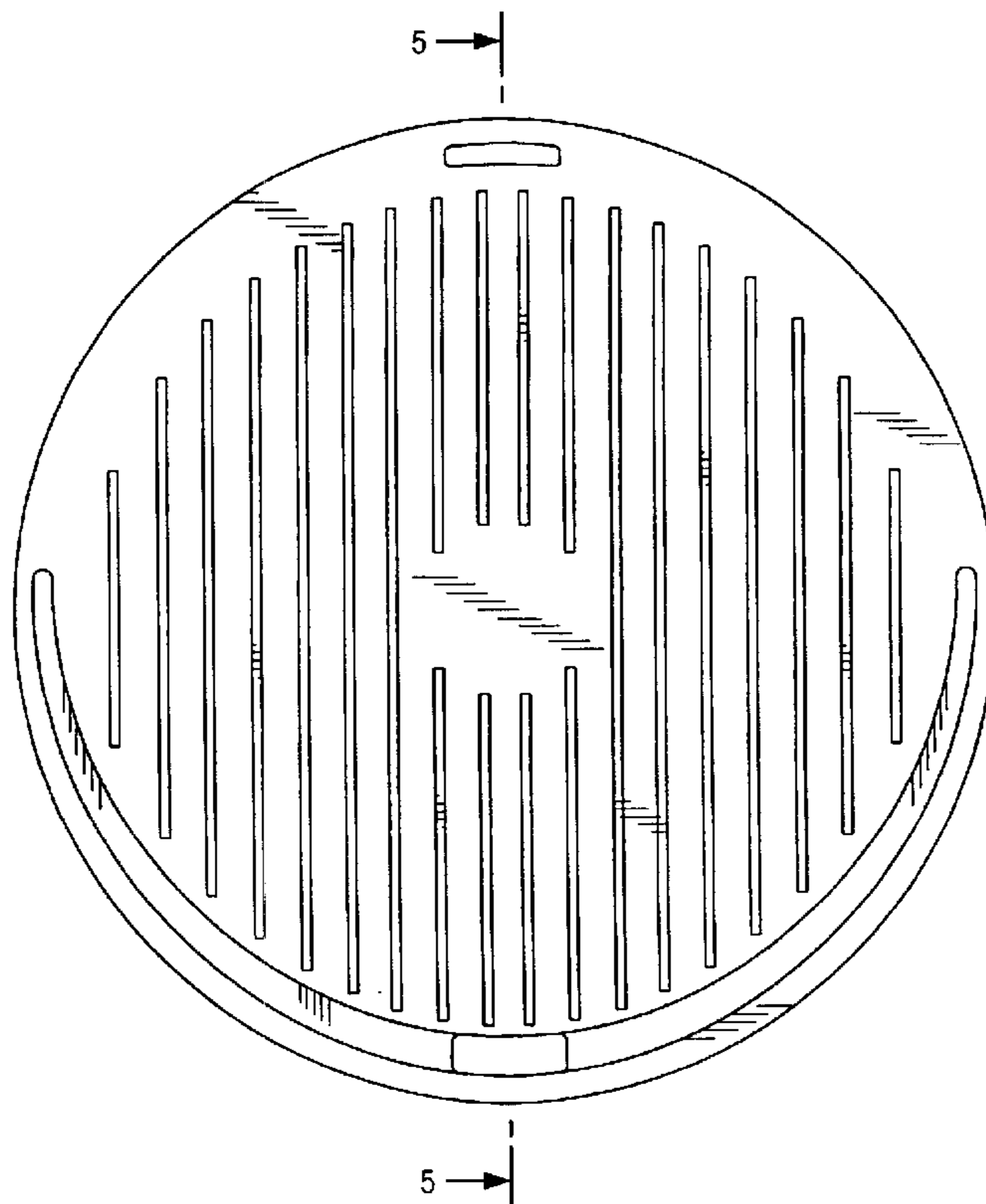
FIG. 1 is a top plan view of a first embodiment cooking grill having the claimed design;
 FIG. 2 is a side elevation view of the cooking grill of FIG. 1, the opposite side being a mirror image;
 FIG. 3 is a front elevation view of the cooking grill of FIG. 1;
 FIG. 4 is a rear elevation view of the cooking grill of FIG. 1;
 FIG. 5 is a cross-sectional view of the cooking grill, taken along line 5—5 of FIG. 1; and,
 FIG. 6 is a bottom plan view of the cooking grill of FIG. 1.

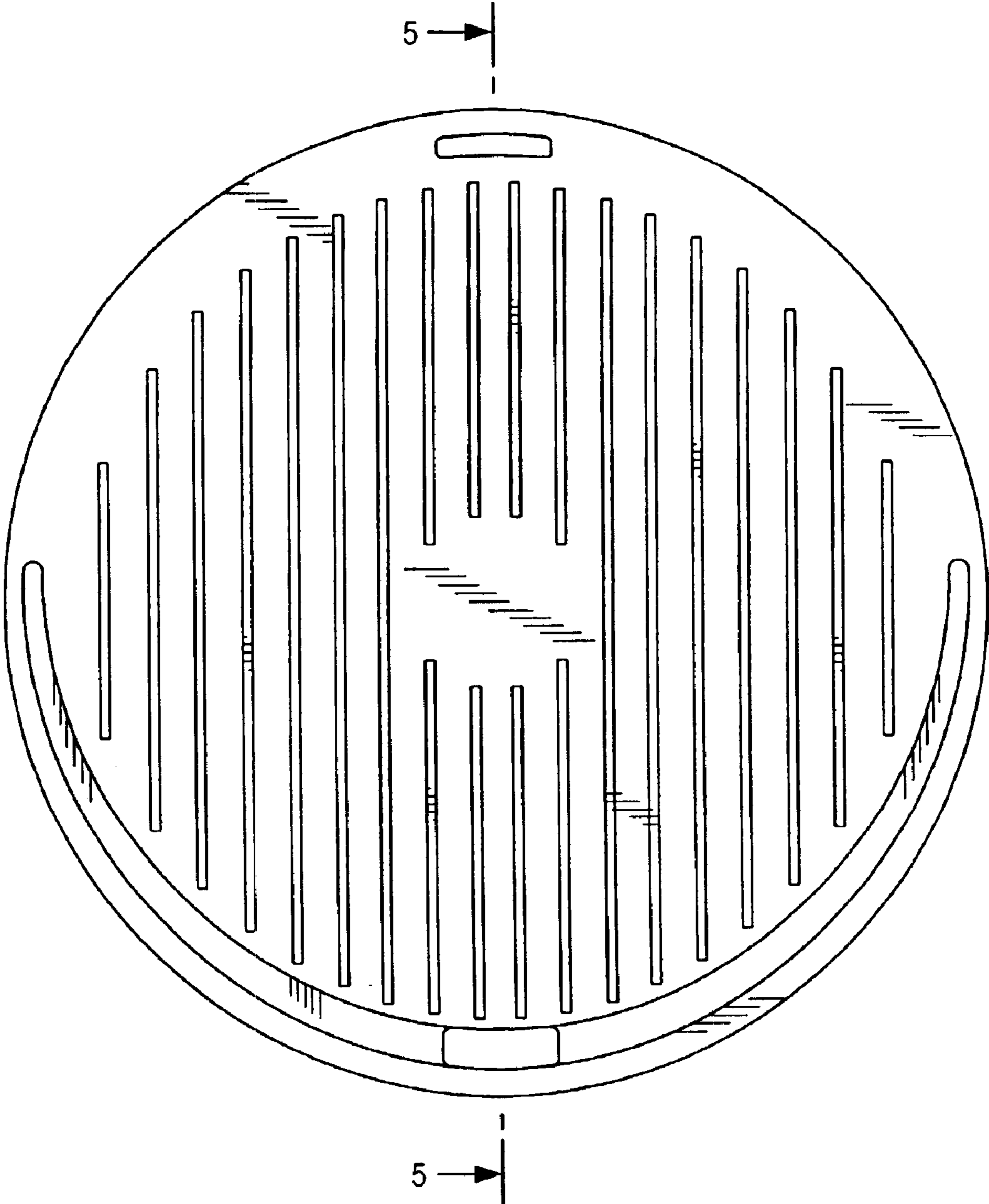

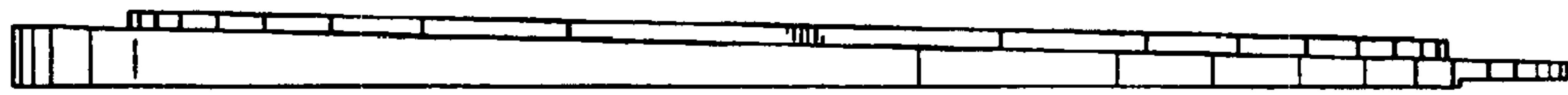

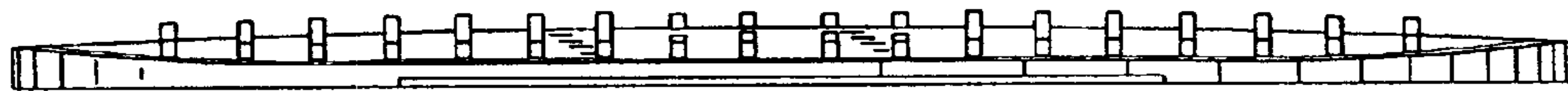

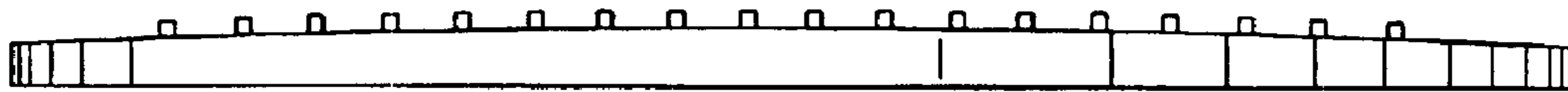

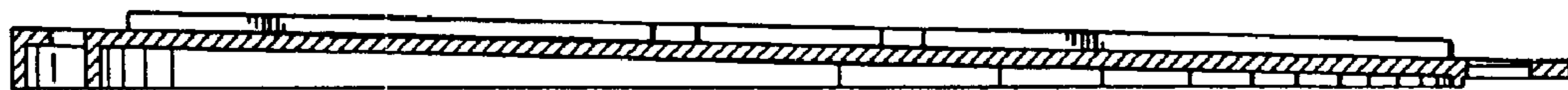

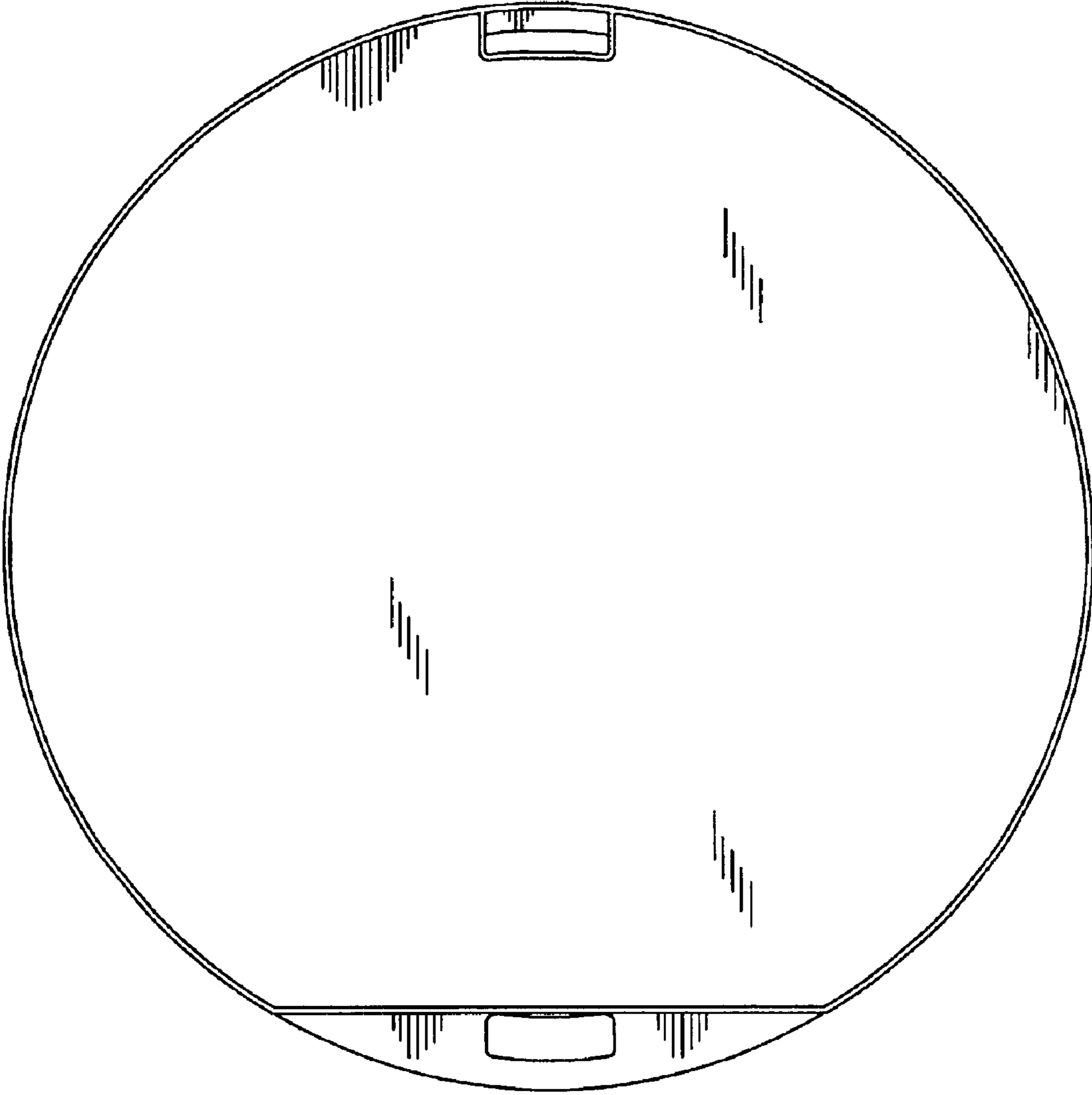
