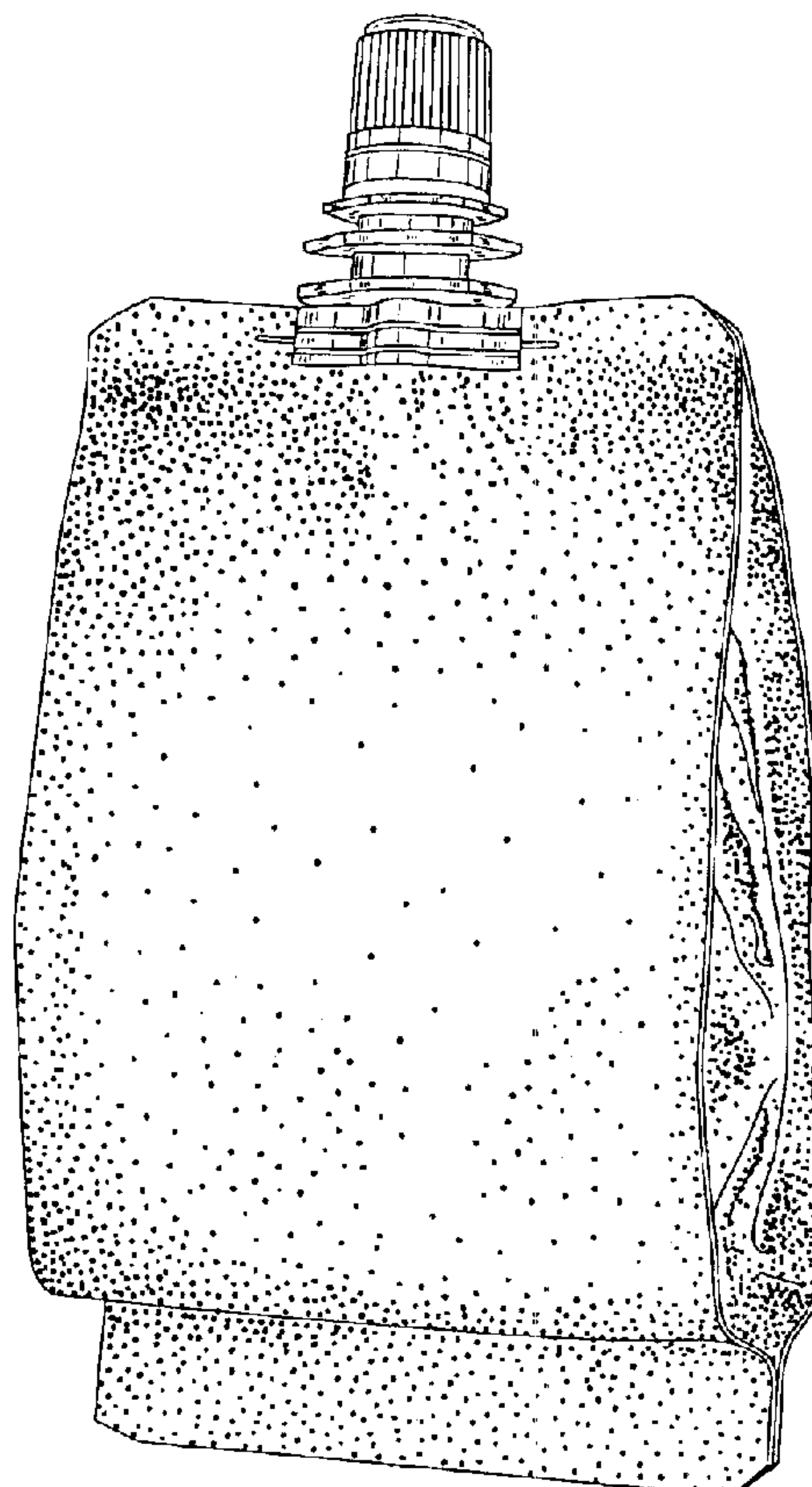

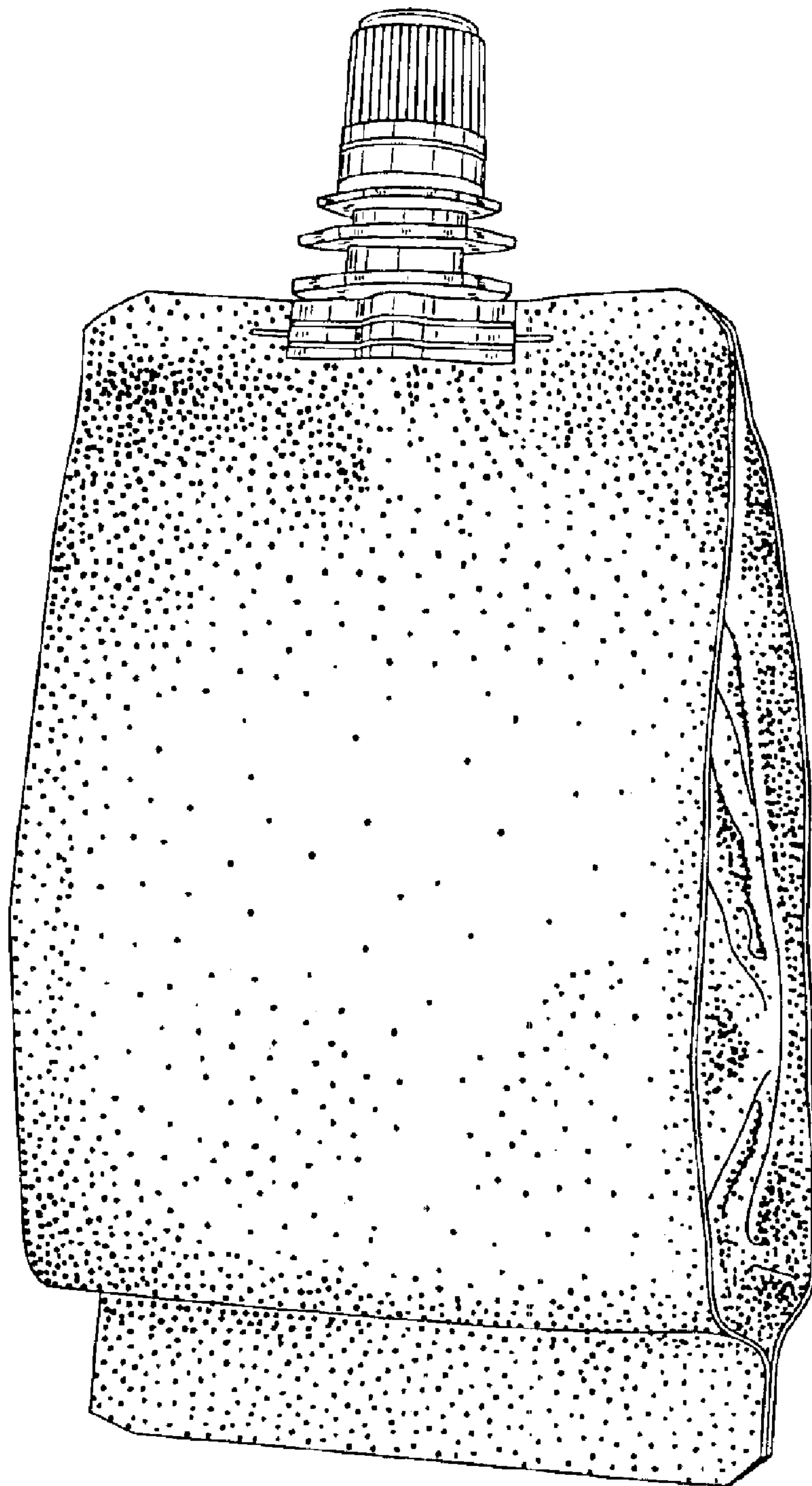

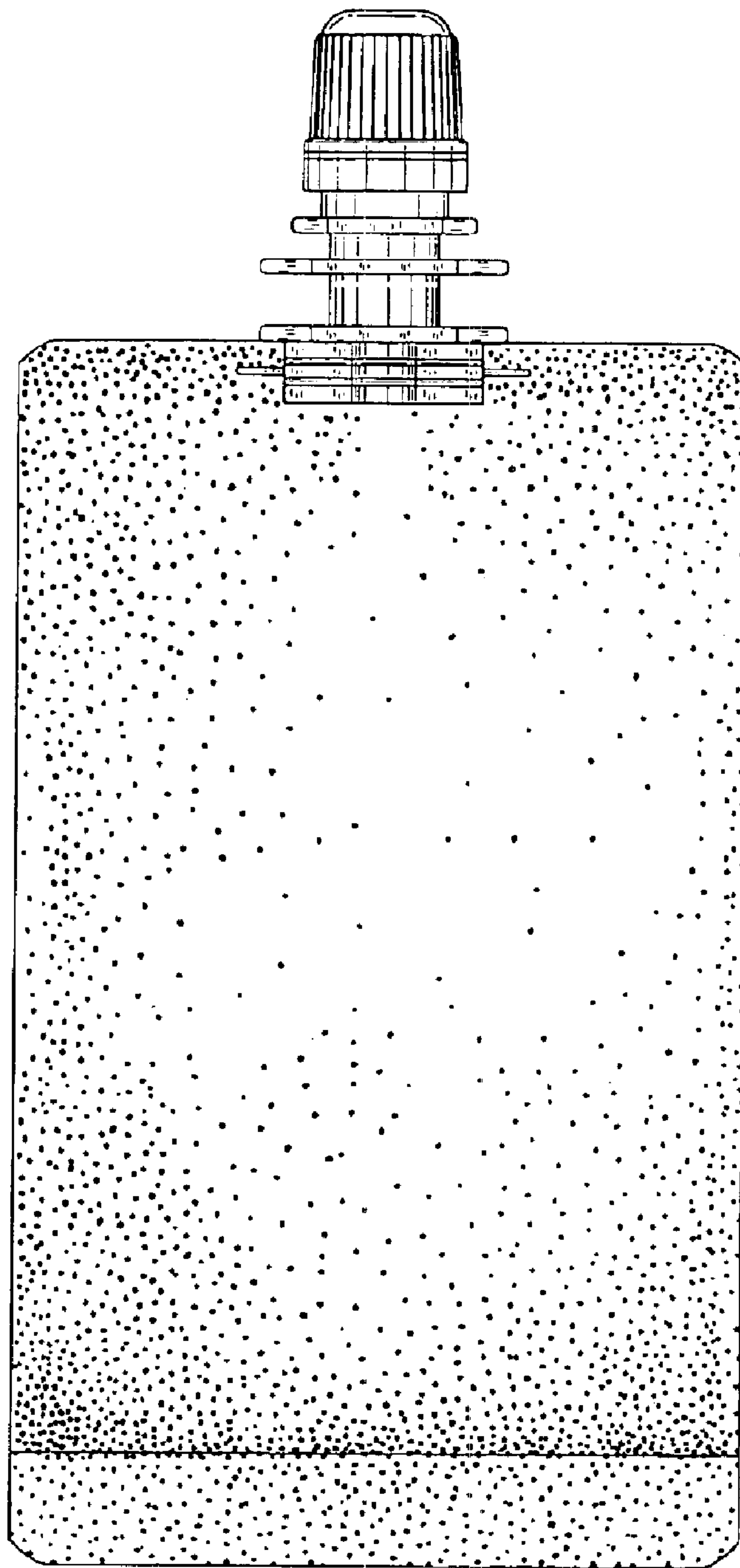
FIG. 1 is a right-front, perspective view of the flexible container showing my new design;

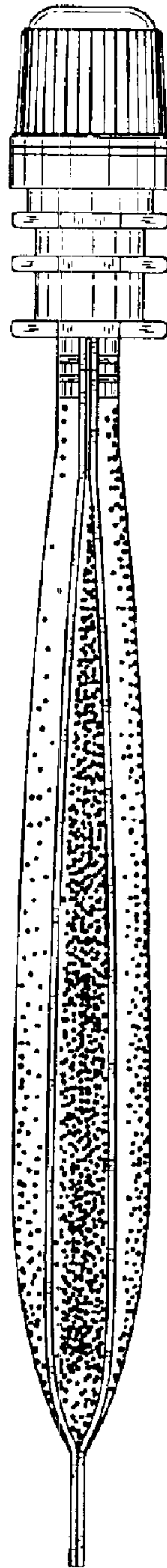




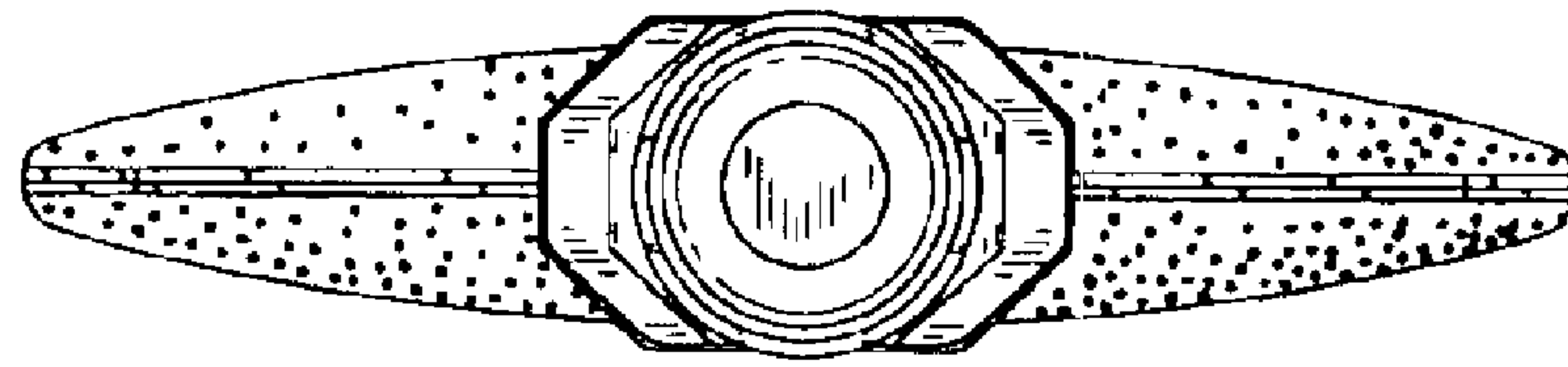

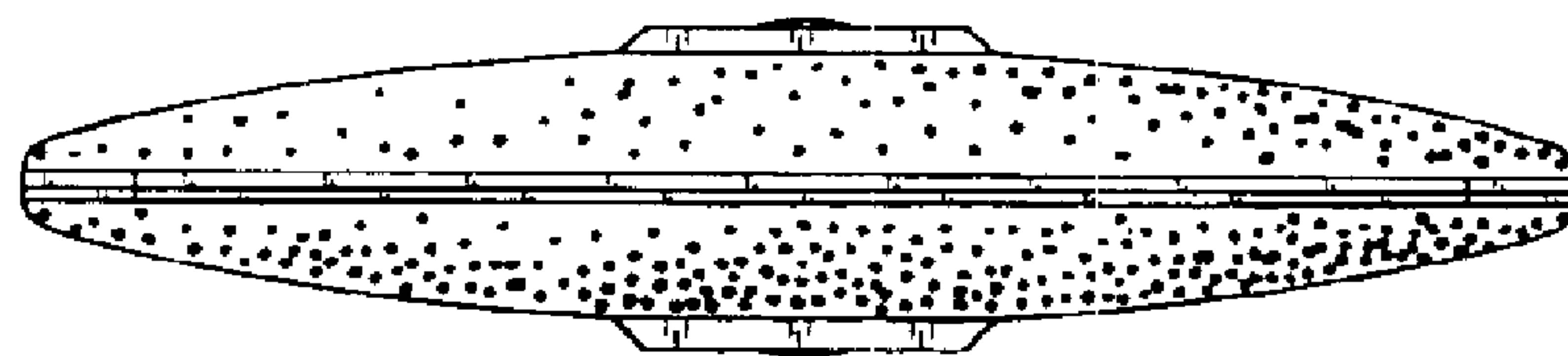

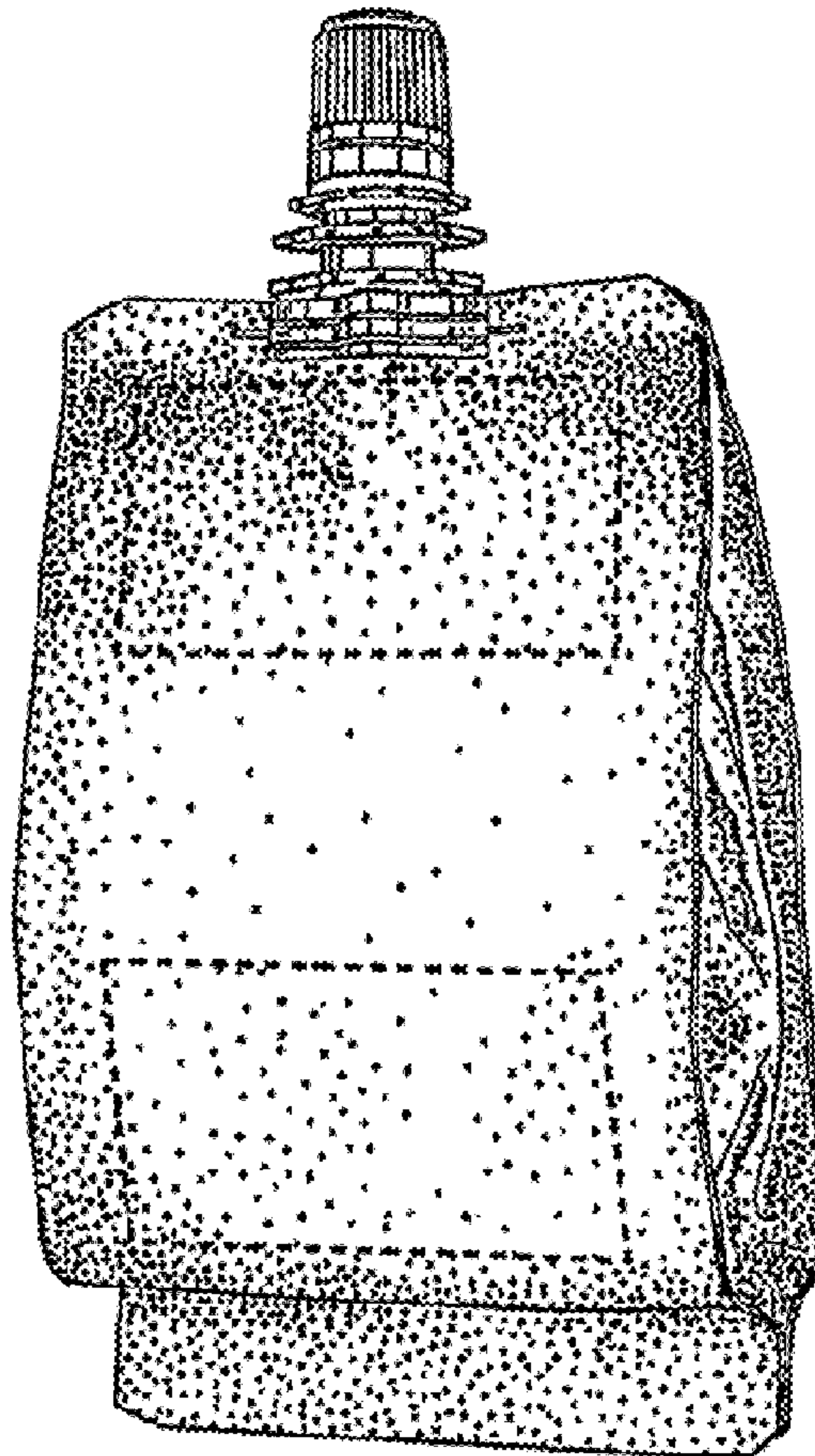

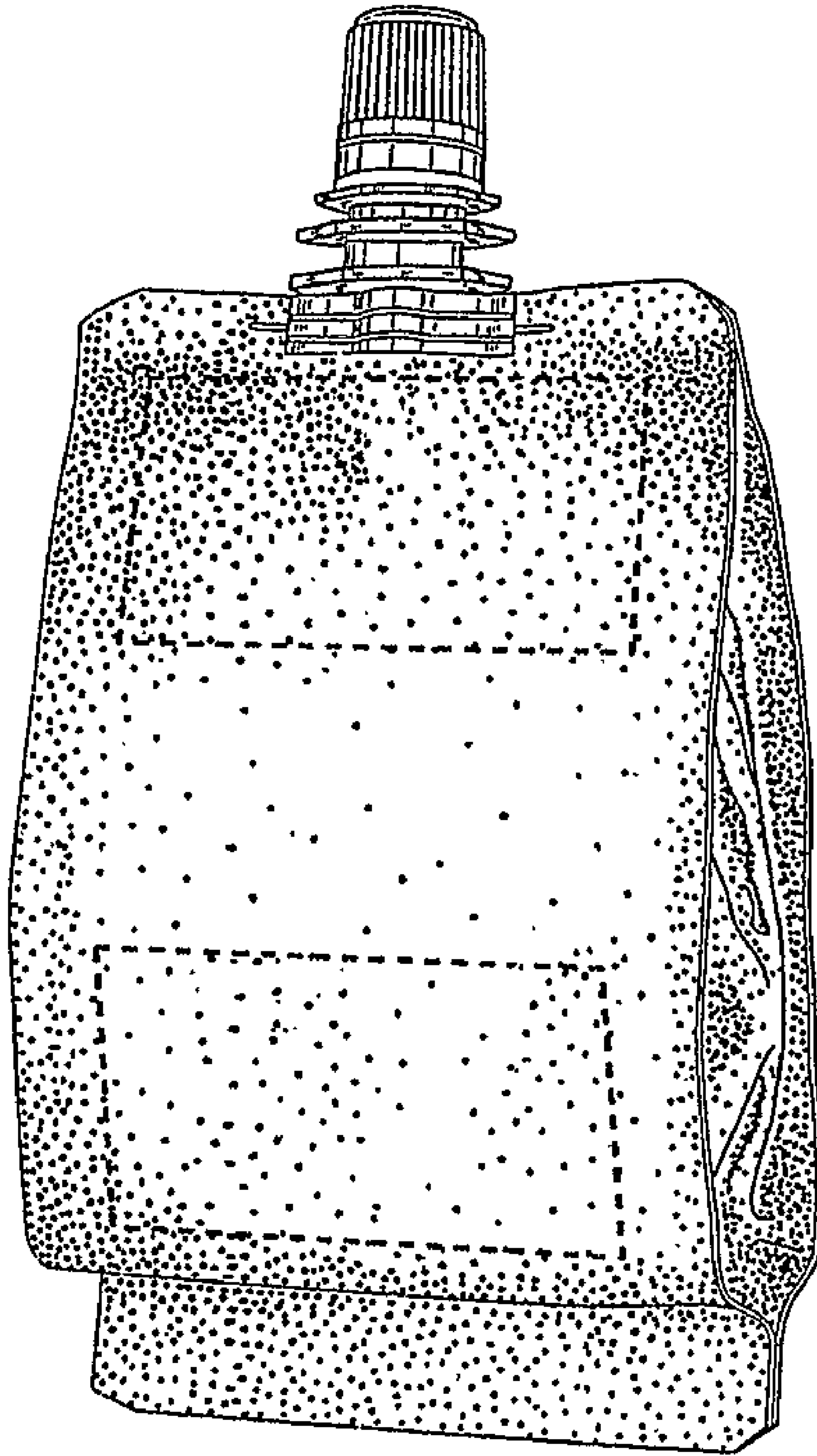

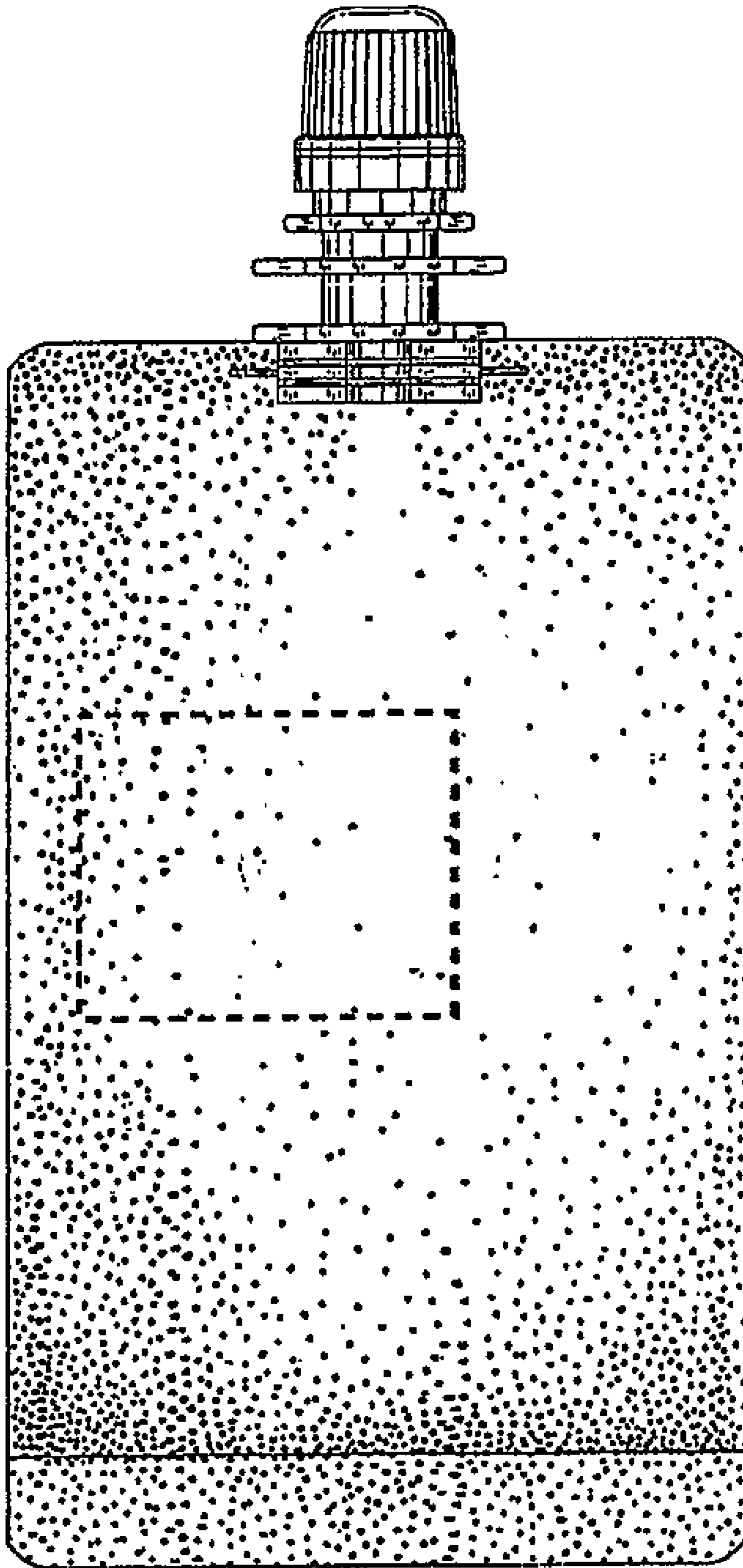
