FIG. 6 is a bottom plan view of the ear cone; and,

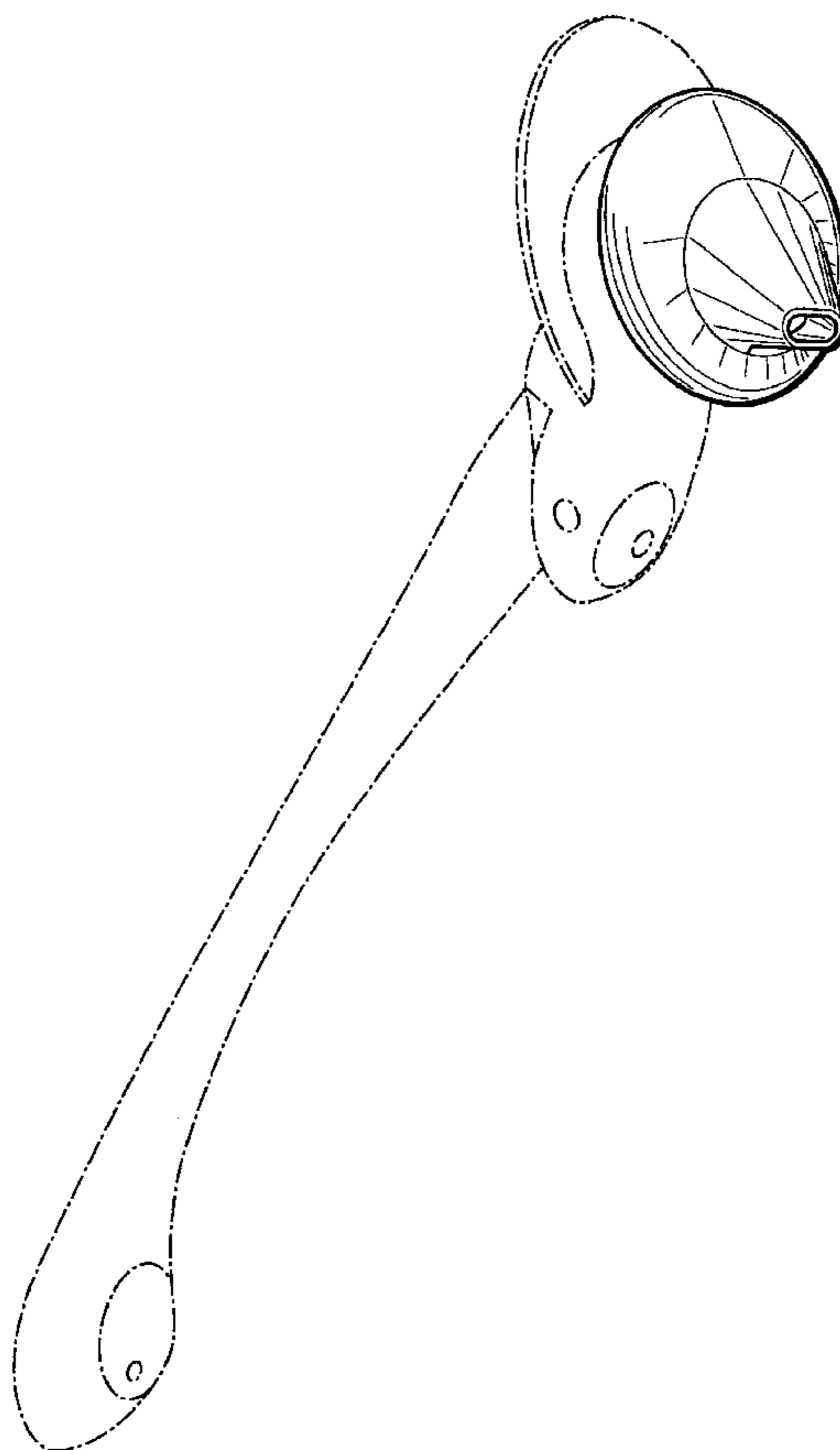
FIG. 7 is a side cross-sectional view of the ear cone taken along line 7—7 in FIG. 2.

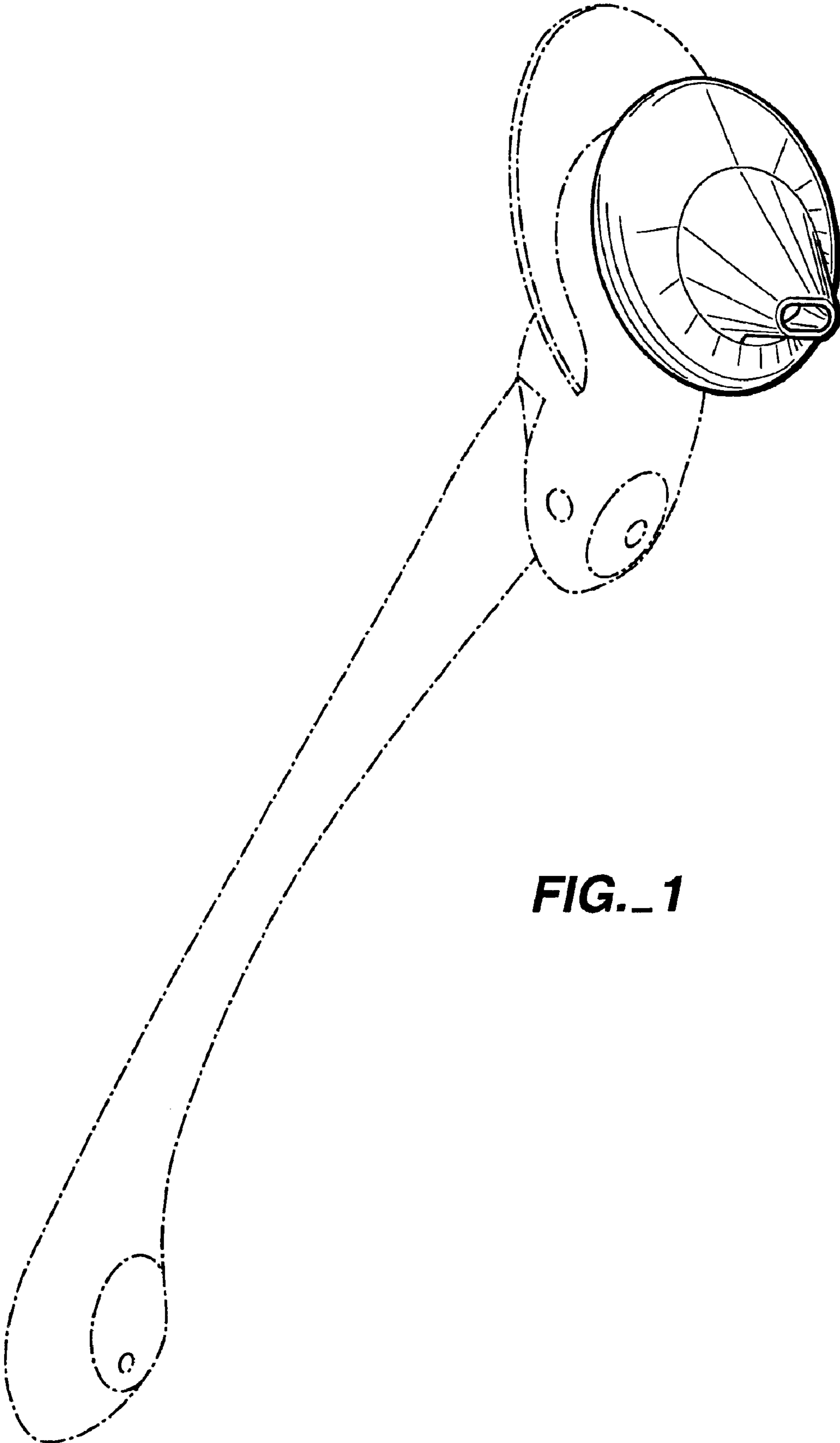

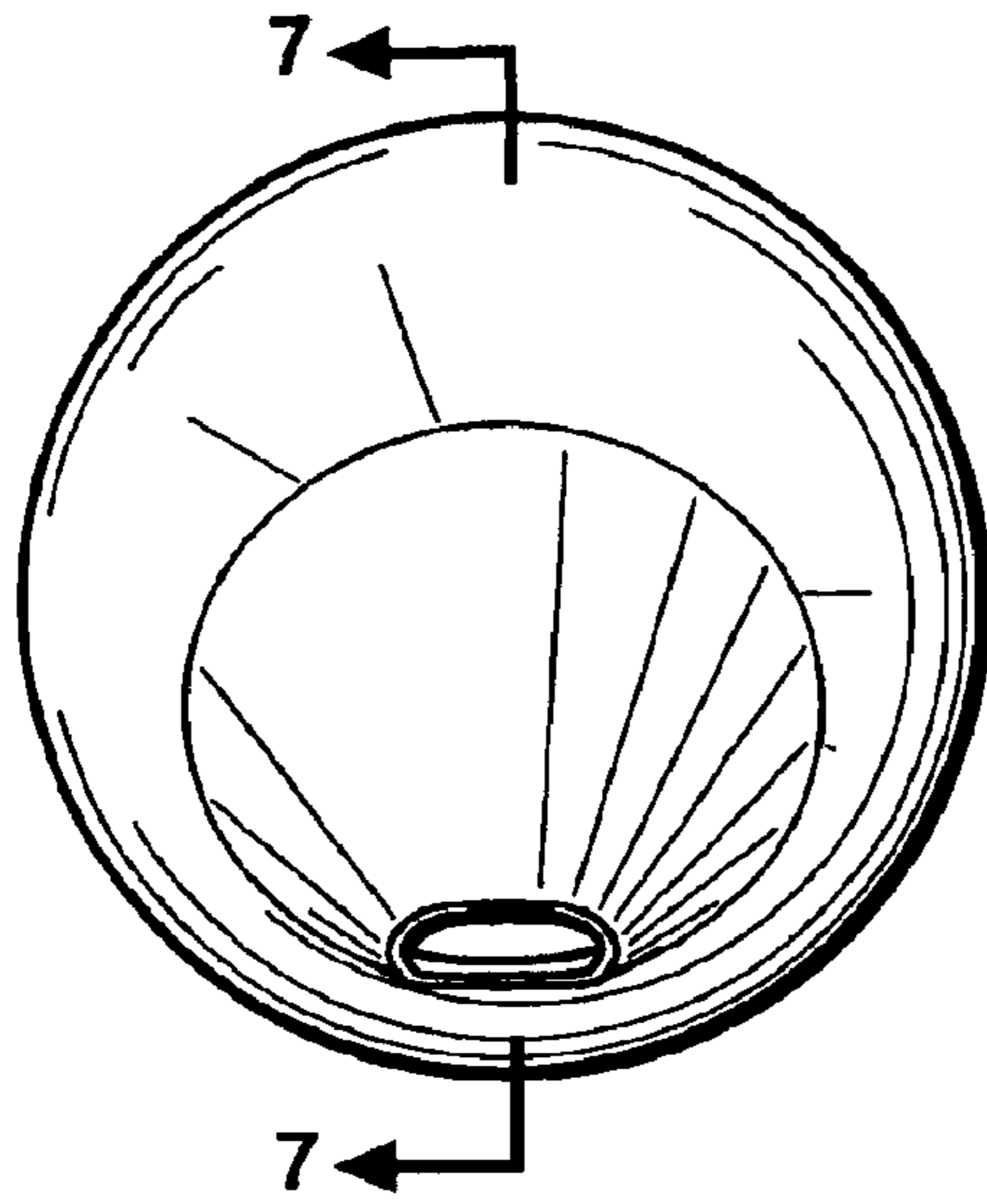

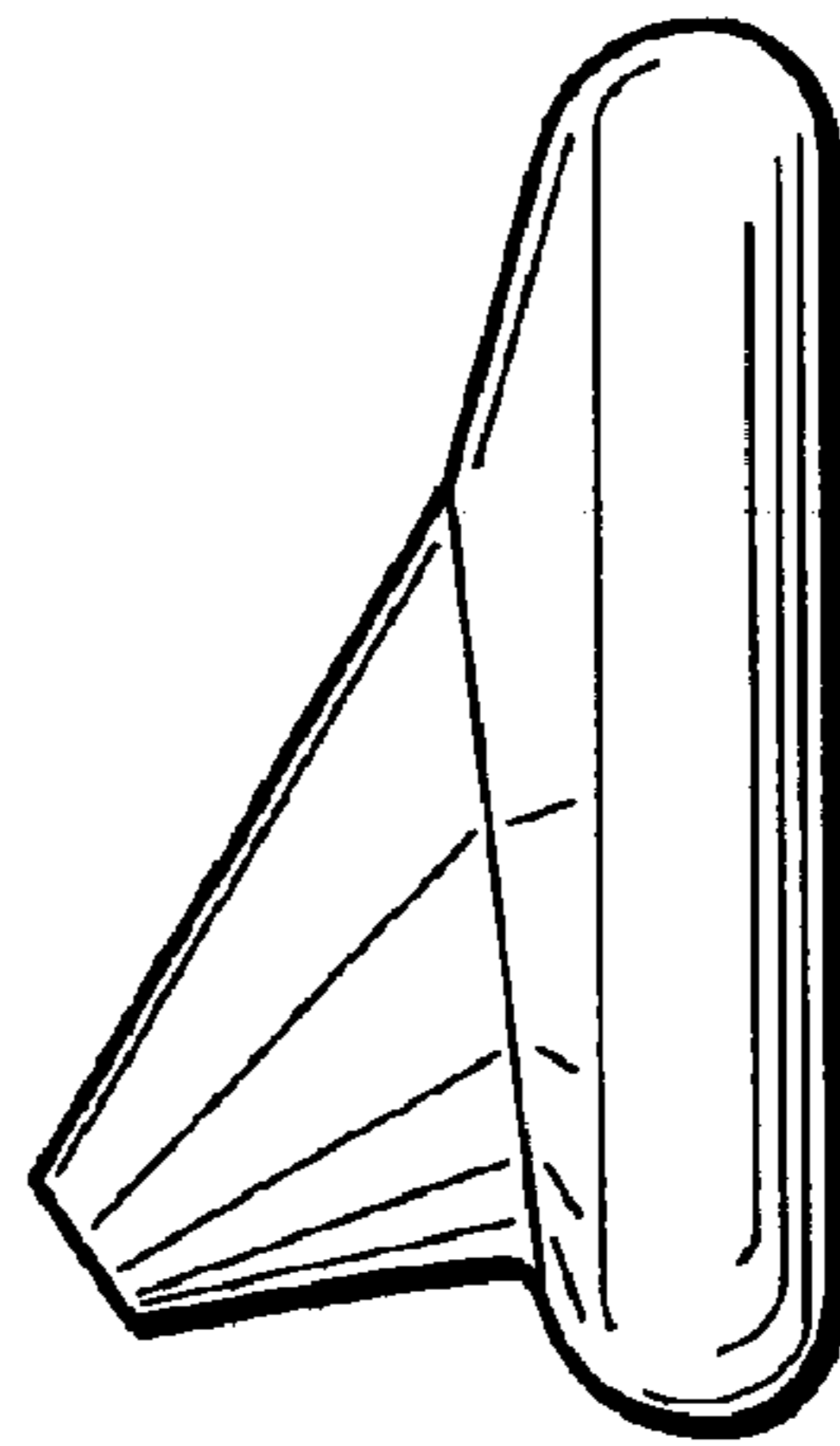




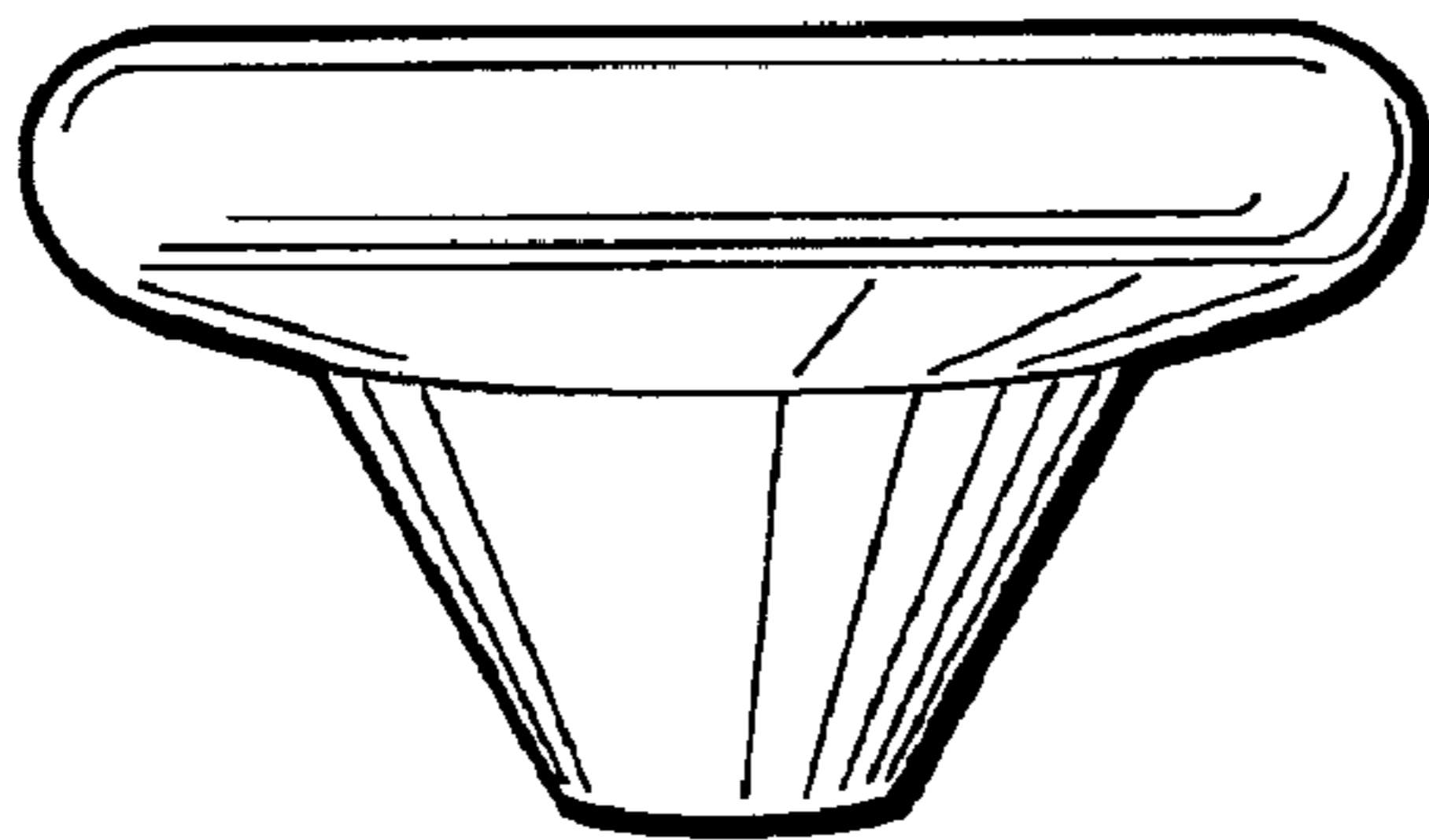

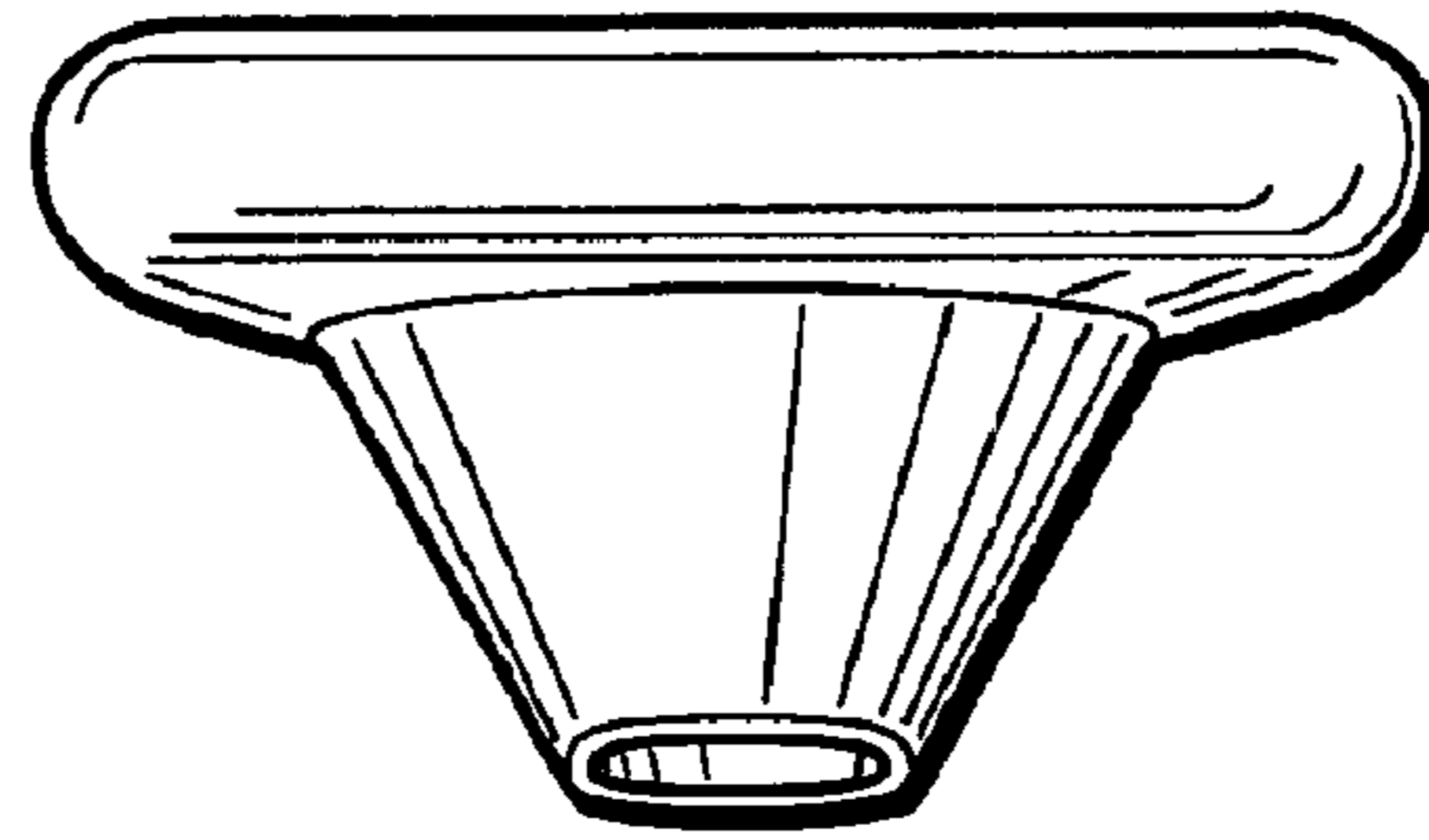

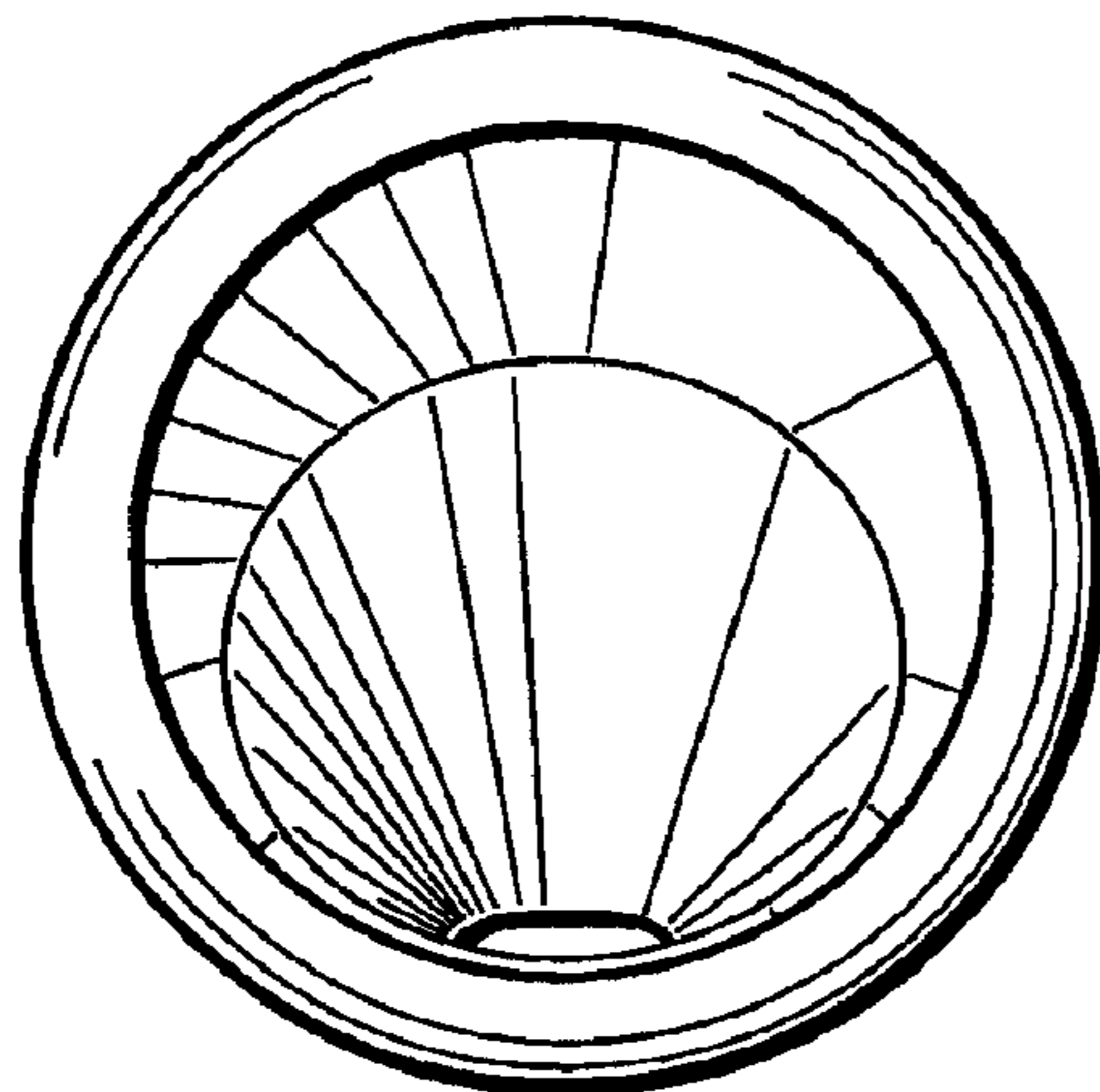

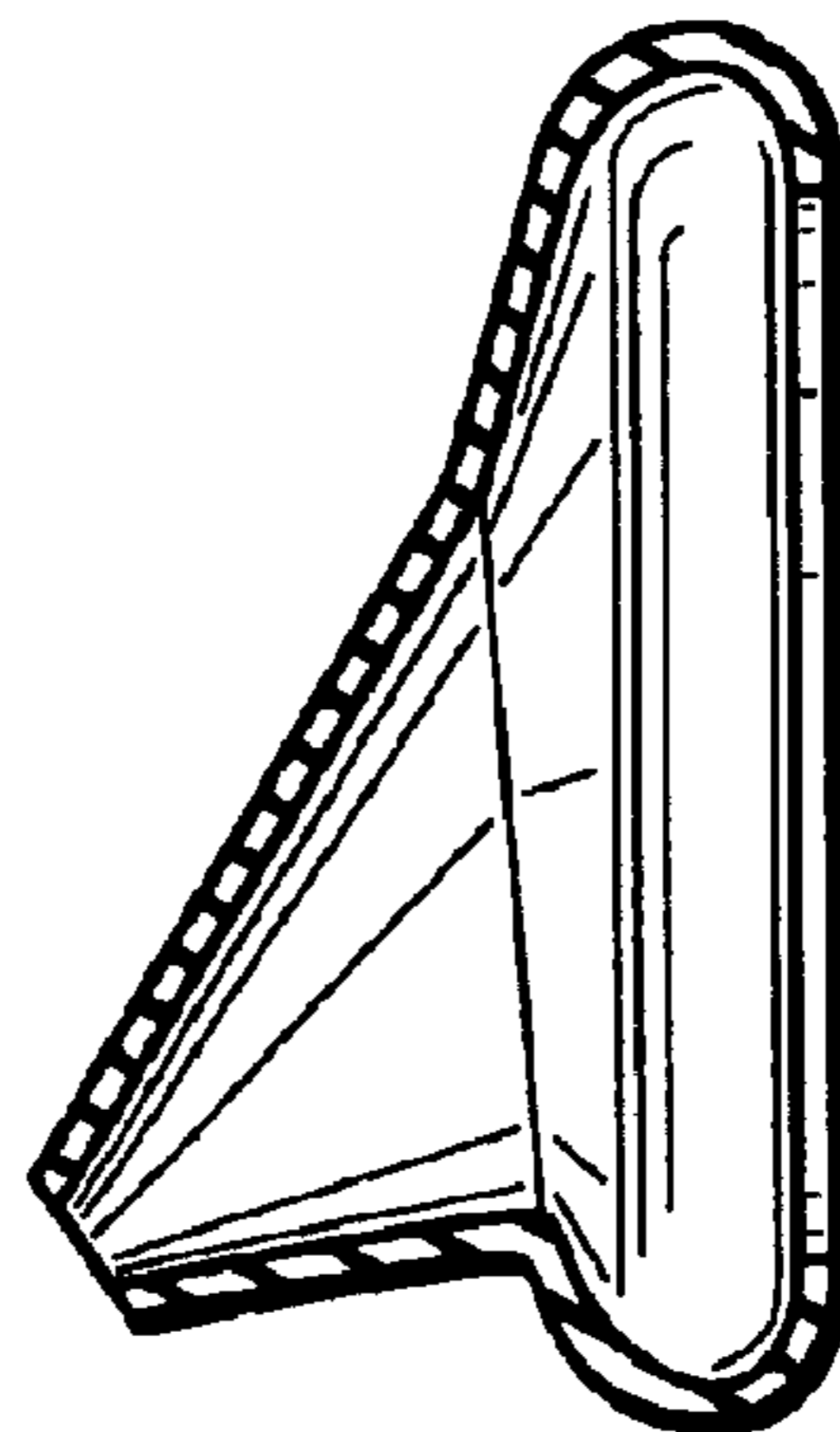
