(57) **CLAIM**

The ornamental design for a rotor guard of spinning reel, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the rotor guard of spinning reel in accordance with my new design; FIG. 2 is a rear elevational view of the rotor guard of spinning reel in accordance with my new design; FIG. 3 is a bottom plan view of the rotor guard of spinning reel in accordance with my new design; FIG. 4 is a right side view of the rotor guard of spinning reel in accordance with my new design; FIG. 5 is a left side view of the rotor guard of spinning reel in accordance with my new design; FIG. 6 is a right bottom perspective view of the rotor guard of spinning reel in accordance with my new design; FIG. 7 is a left top perspective view of the rotor guard of spinning reel in accordance with my new design; and, FIG. 8 is a cross sectional view of the rotor guard of a spinning reel shown along line 8—8 of FIG. 3.

The broken line showing of environment (the remaining structure of the rotor guard of spinning reel) in the Figures is for illustrative purposes only and forms no part of the claimed design. Moreover, the structure shown in broken lines is hereby disclaimed.

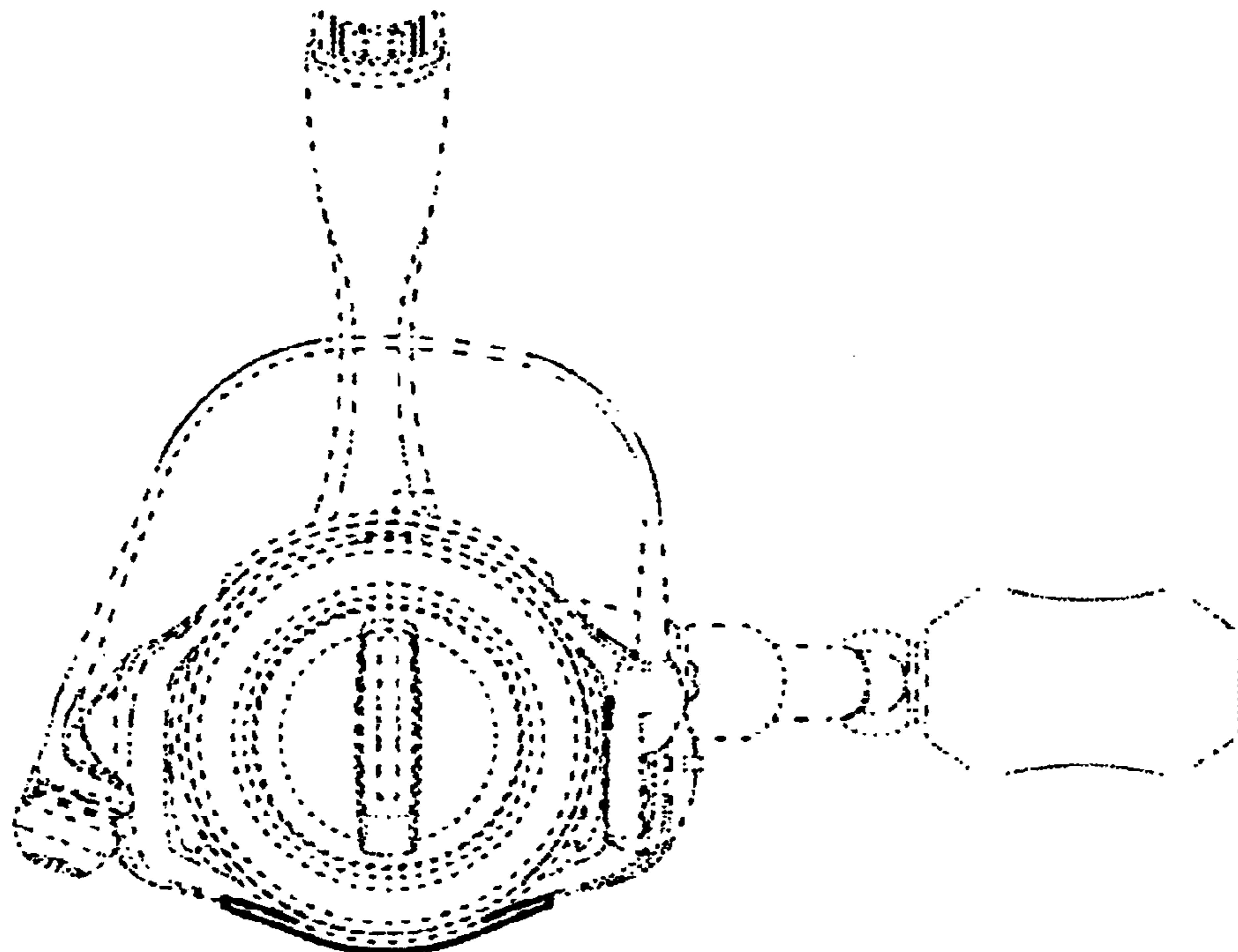

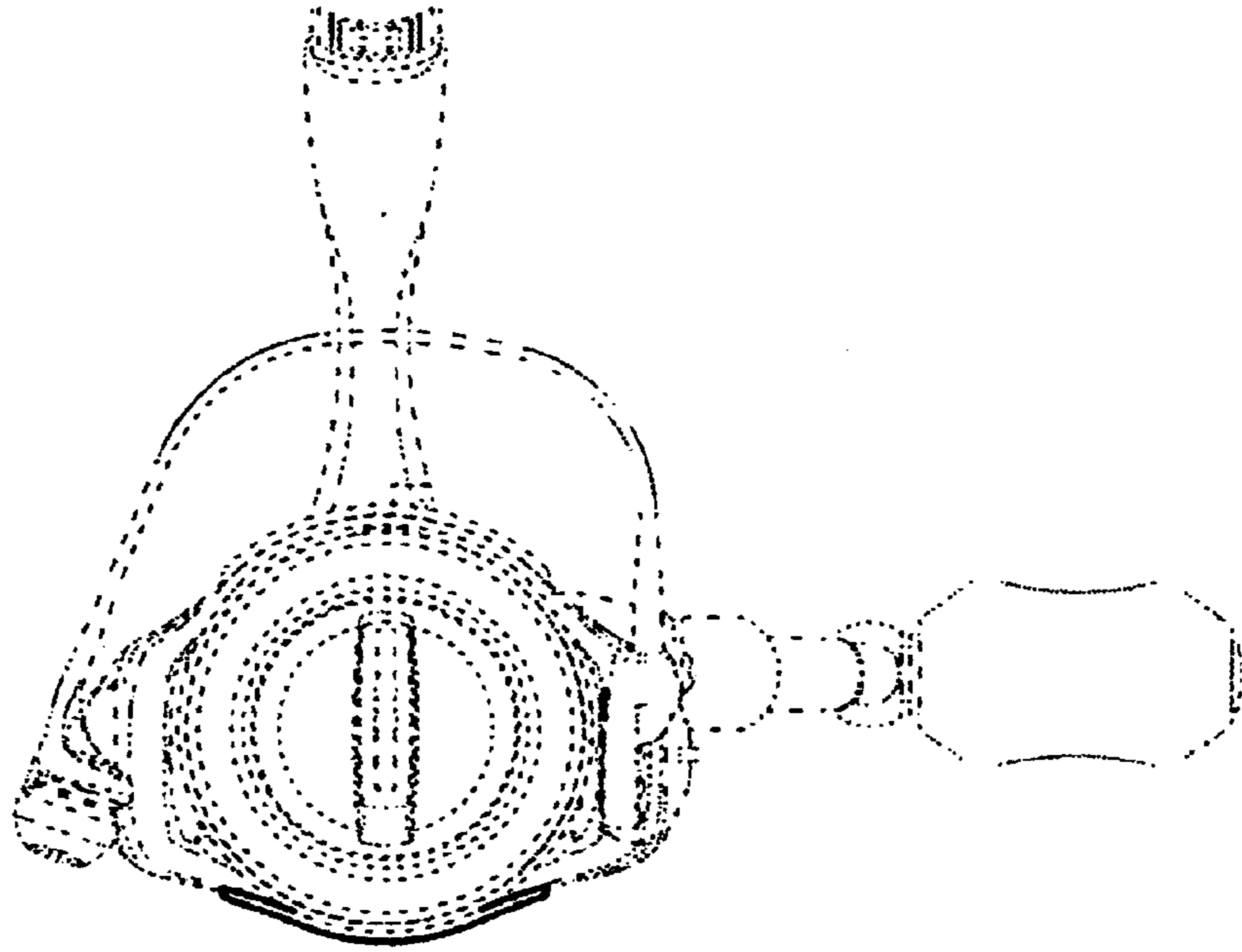

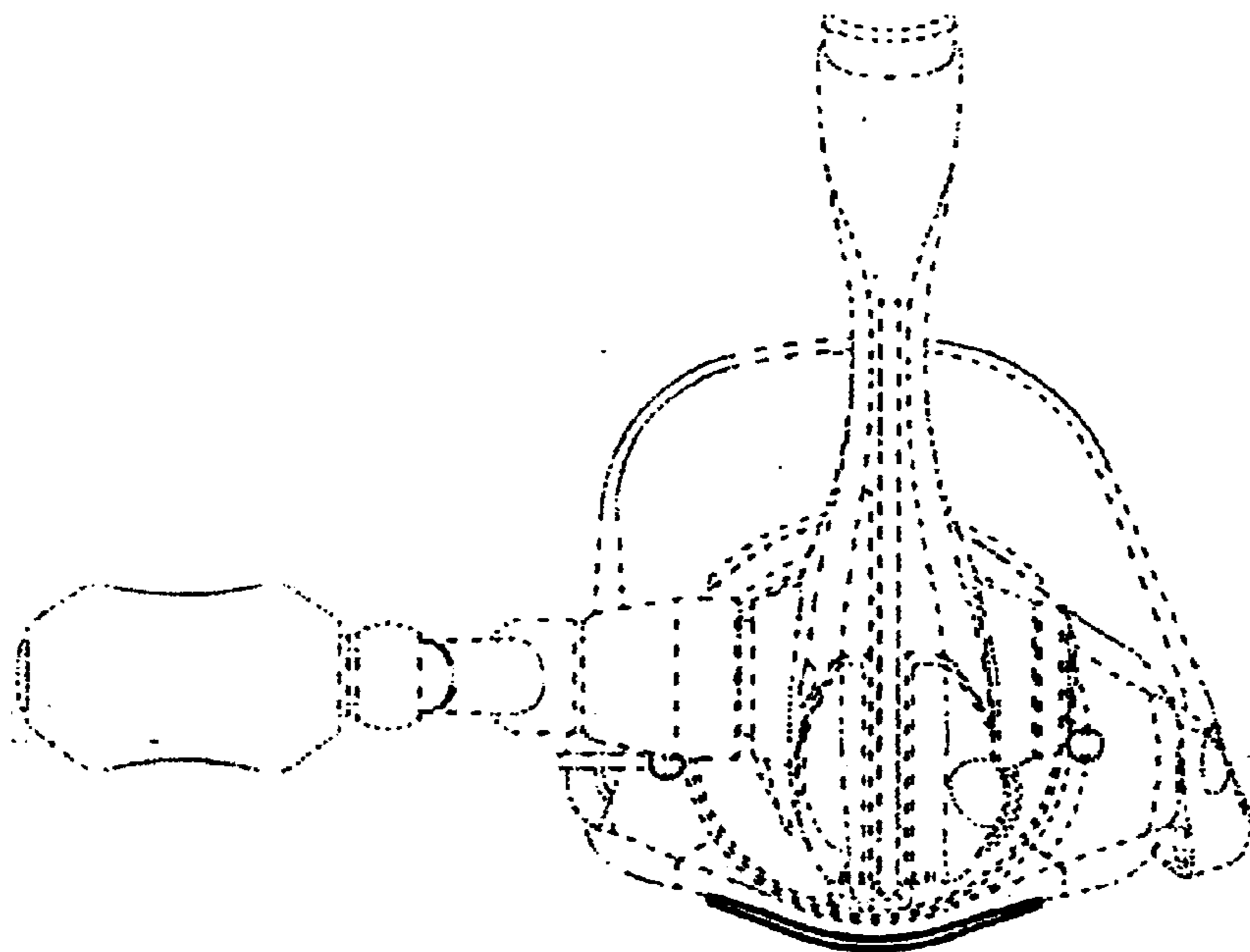

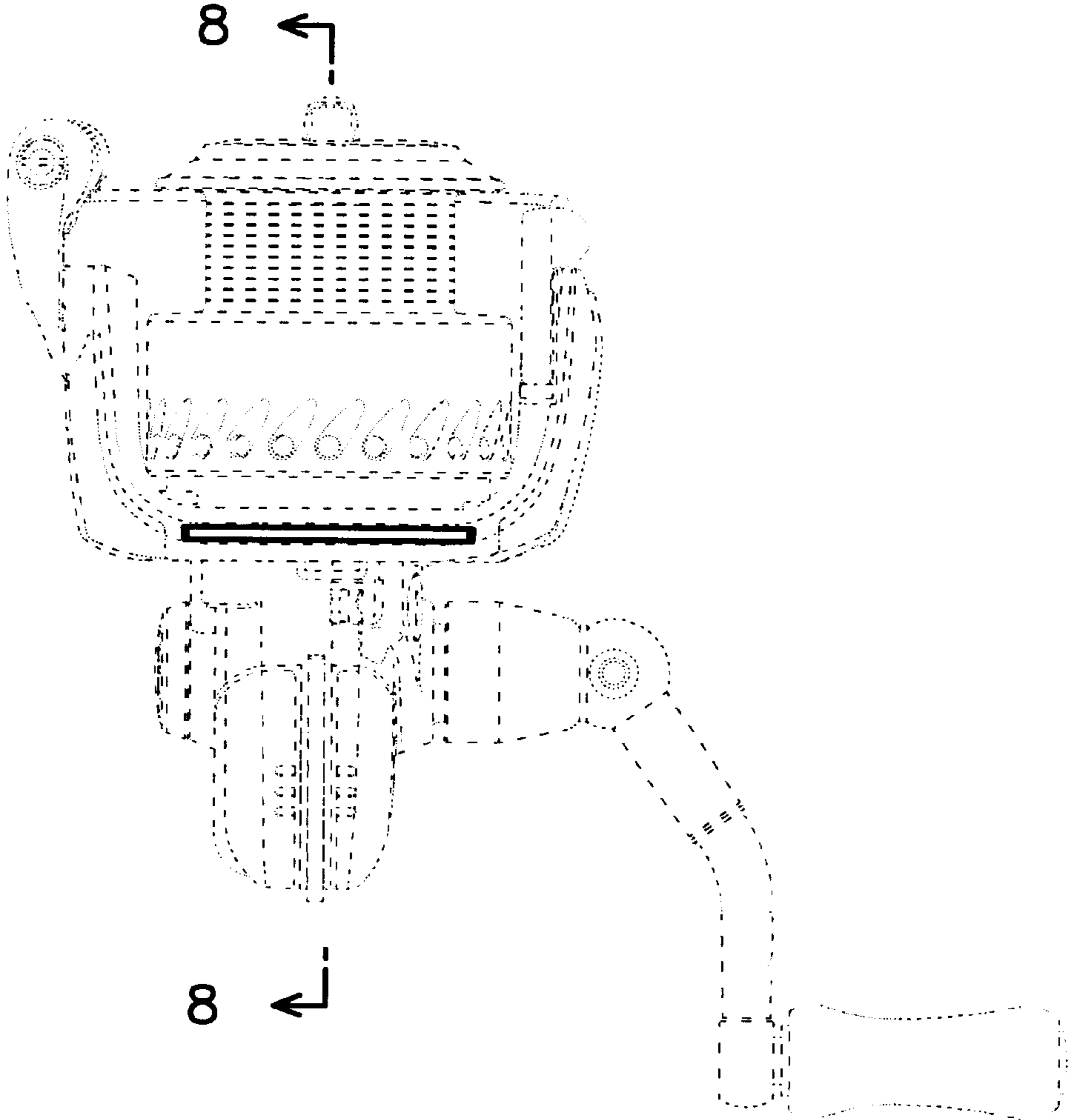

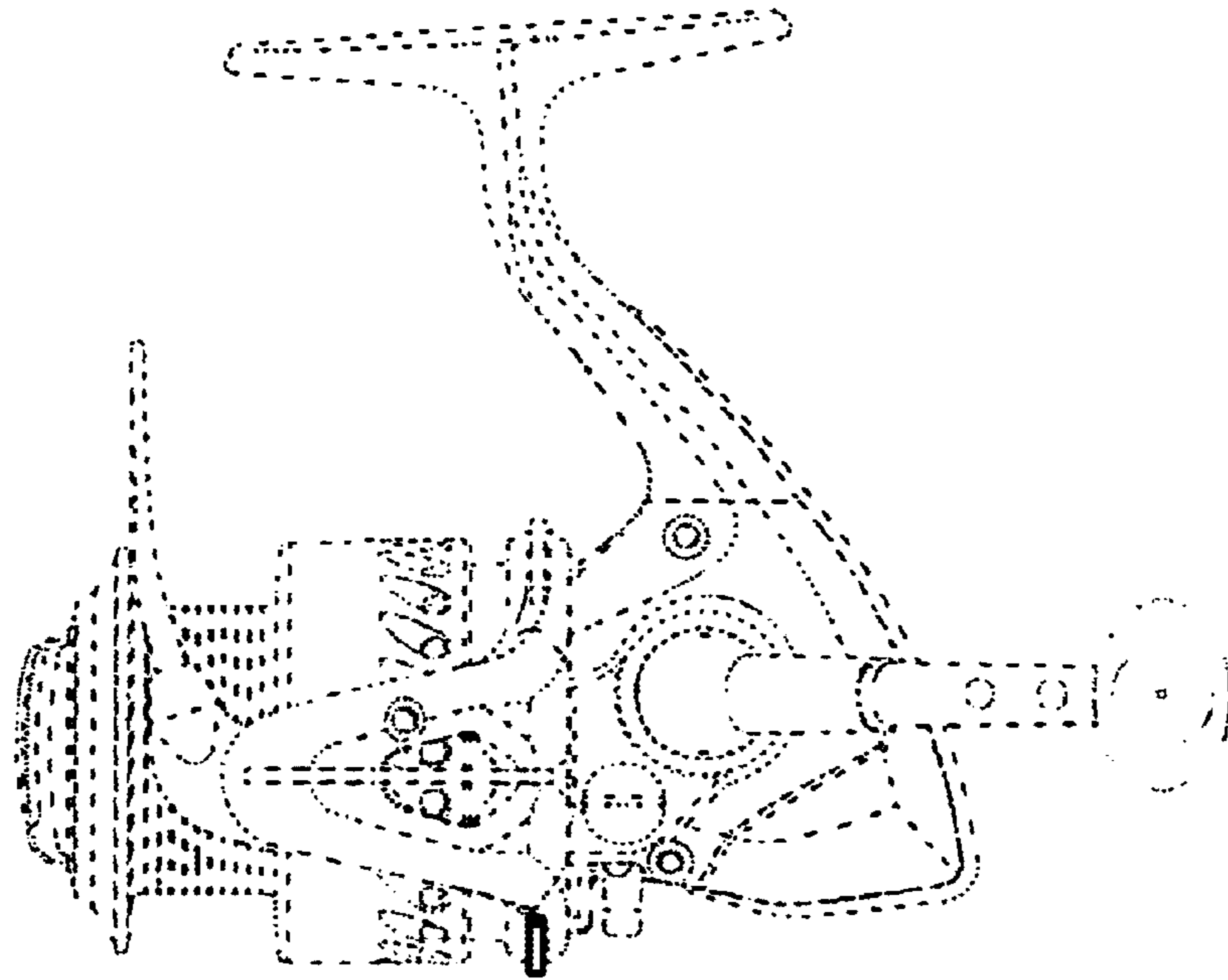

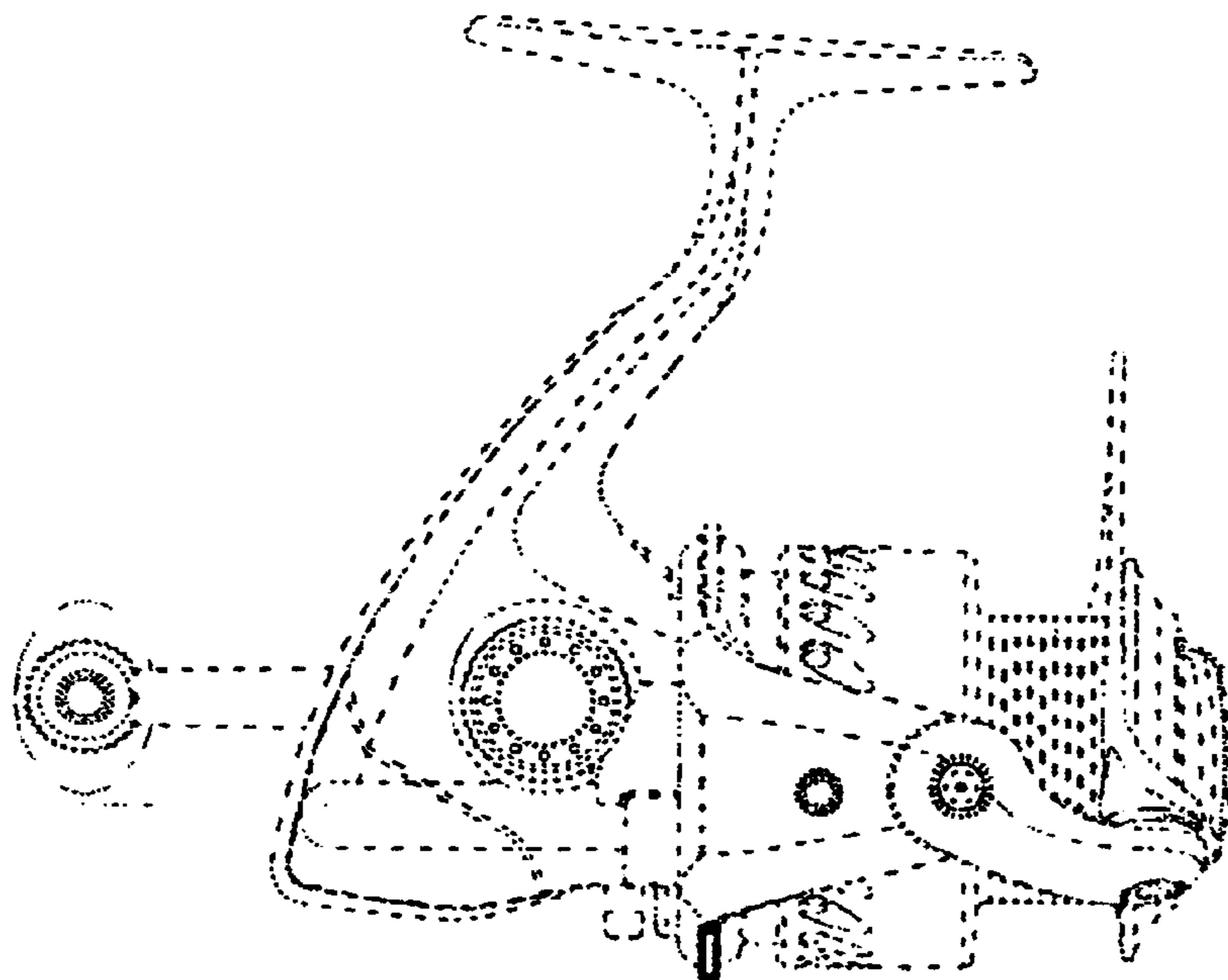

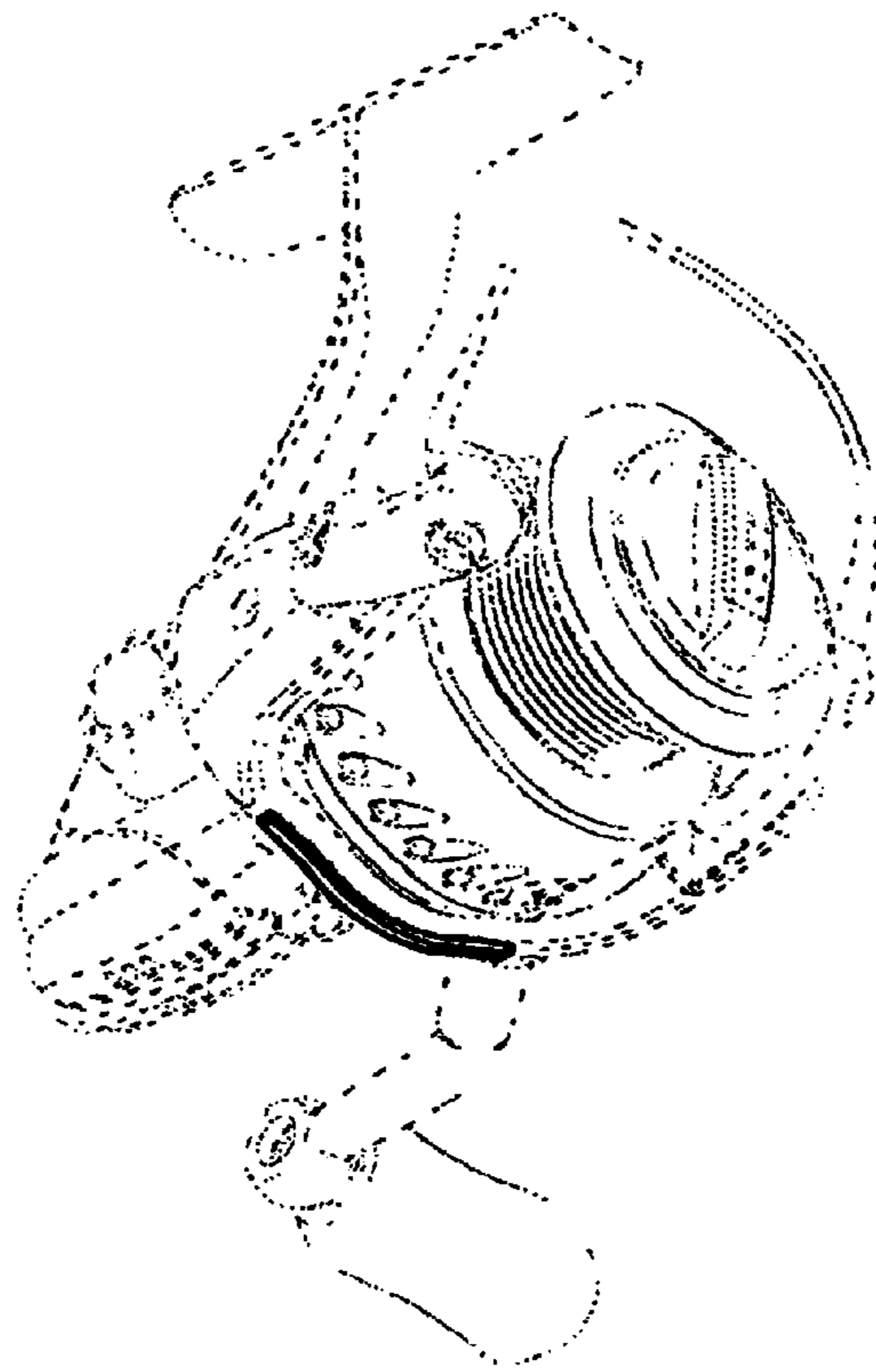

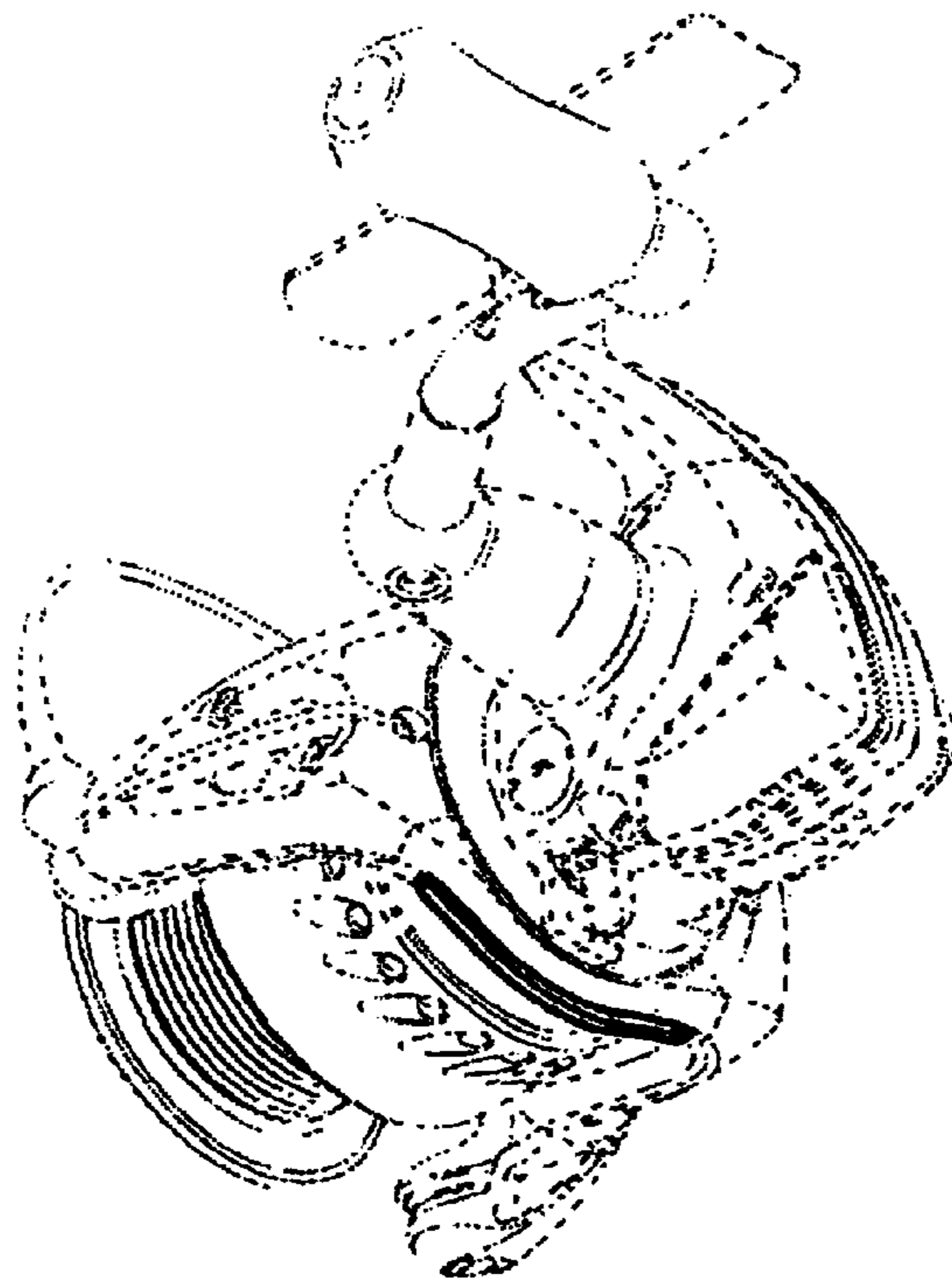
