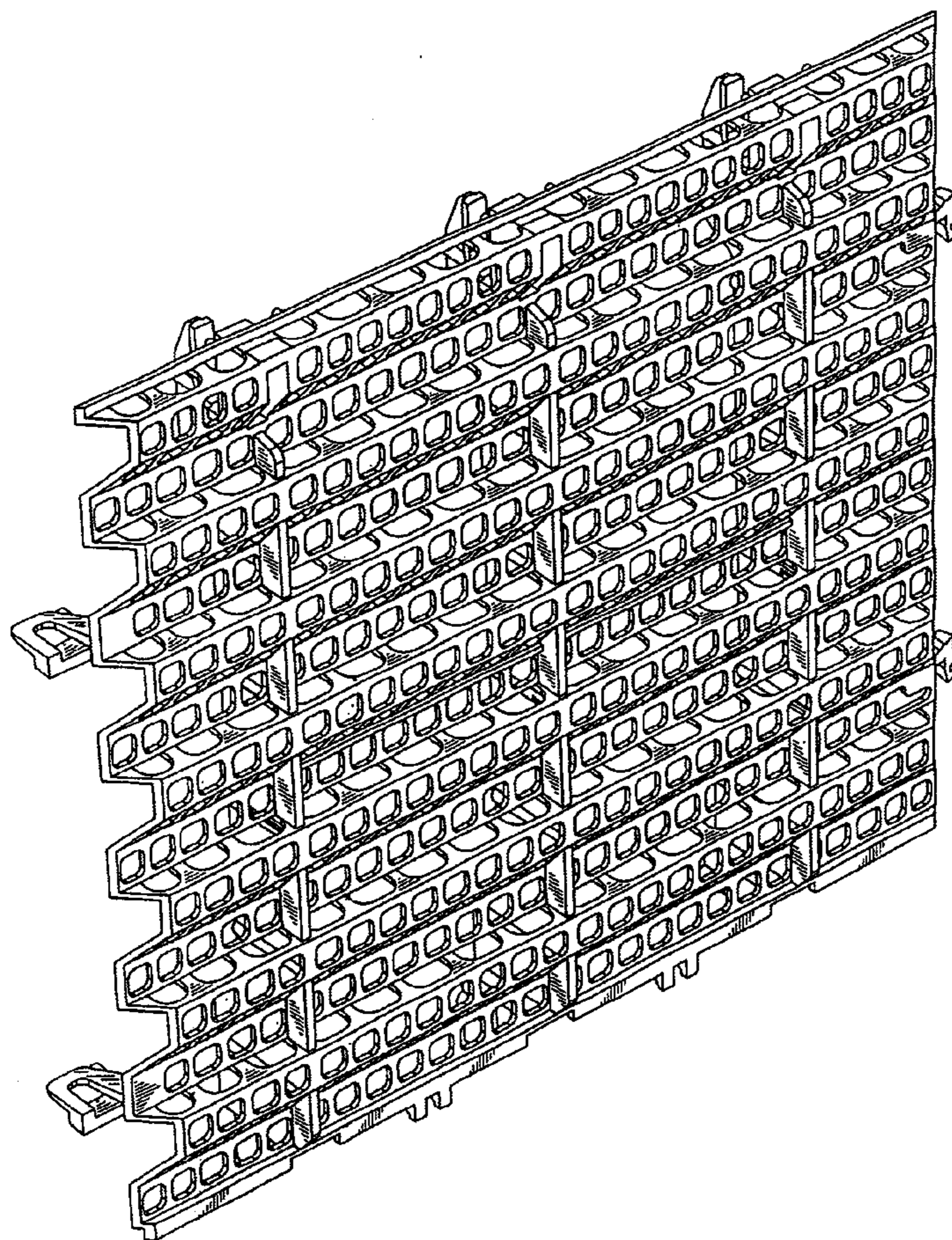
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is top front perspective view of the render formwork showing my new design;  
 FIG. 2 is a rear bottom perspective view thereof;  
 FIG. 3 is a rear plan view thereof;  
 FIG. 4 is a front elevation view thereof;  
 FIG. 5 is an end elevation taken from the left in FIG. 4;  
 FIG. 6 is an end elevation taken from the right in FIG. 4;  
 FIG. 7 is a top plan view;  
 FIG. 8 is a bottom plan view;  
 FIG. 9 is top front perspective view of a second embodiment of the render formwork;  
 FIG. 10 is a rear bottom perspective view of the second embodiment thereof;  
 FIG. 11 is a front elevation view thereof;  
 FIG. 12 is a rear elevation view;  
 FIG. 13 is an end elevation taken from the left in FIG. 11;  
 FIG. 14 is an end elevation taken from the right in FIG. 11;  
 FIG. 15 is a top plan view; and,  
 FIG. 16 is a bottom plan view of the second embodiment of render formwork.

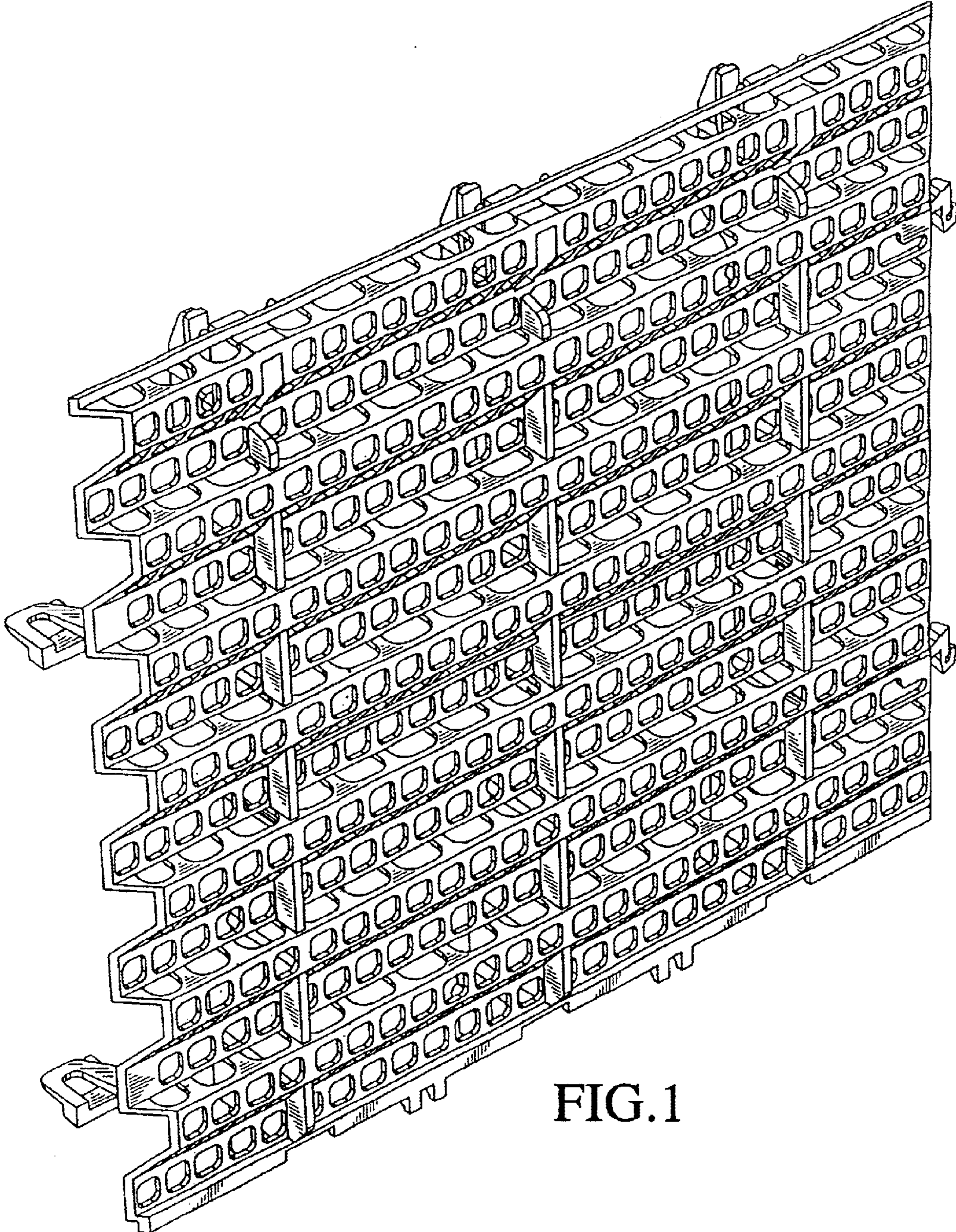

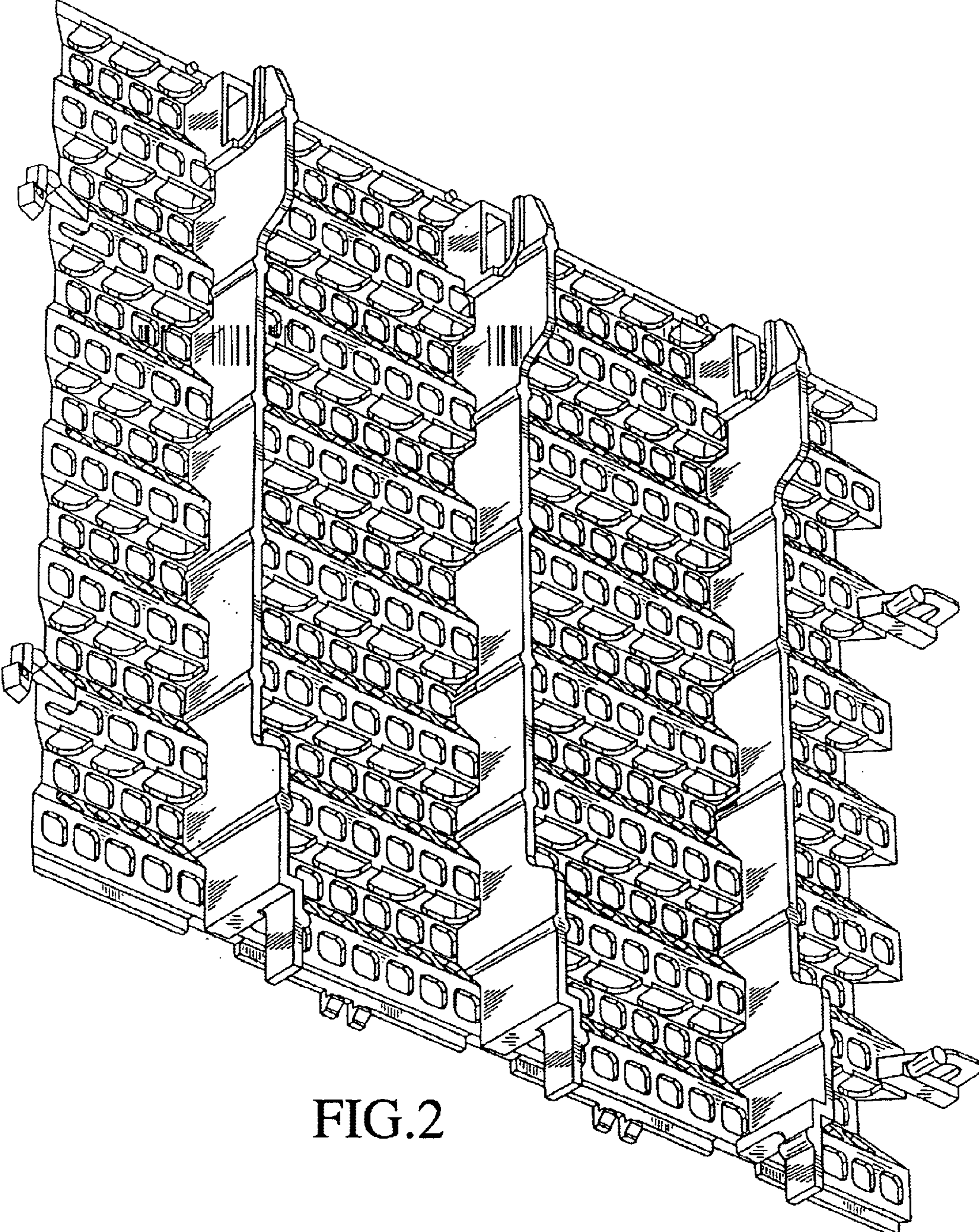

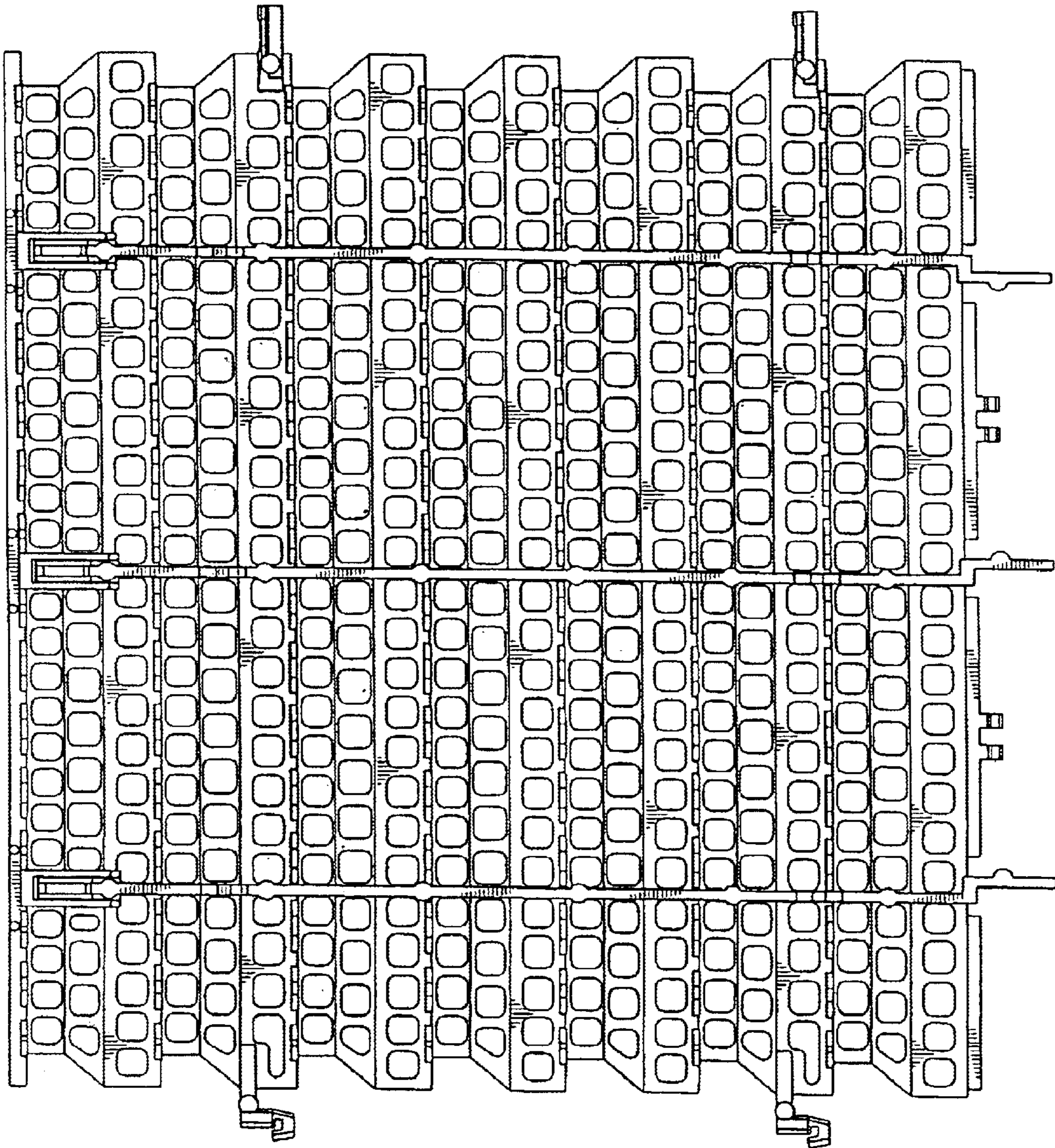

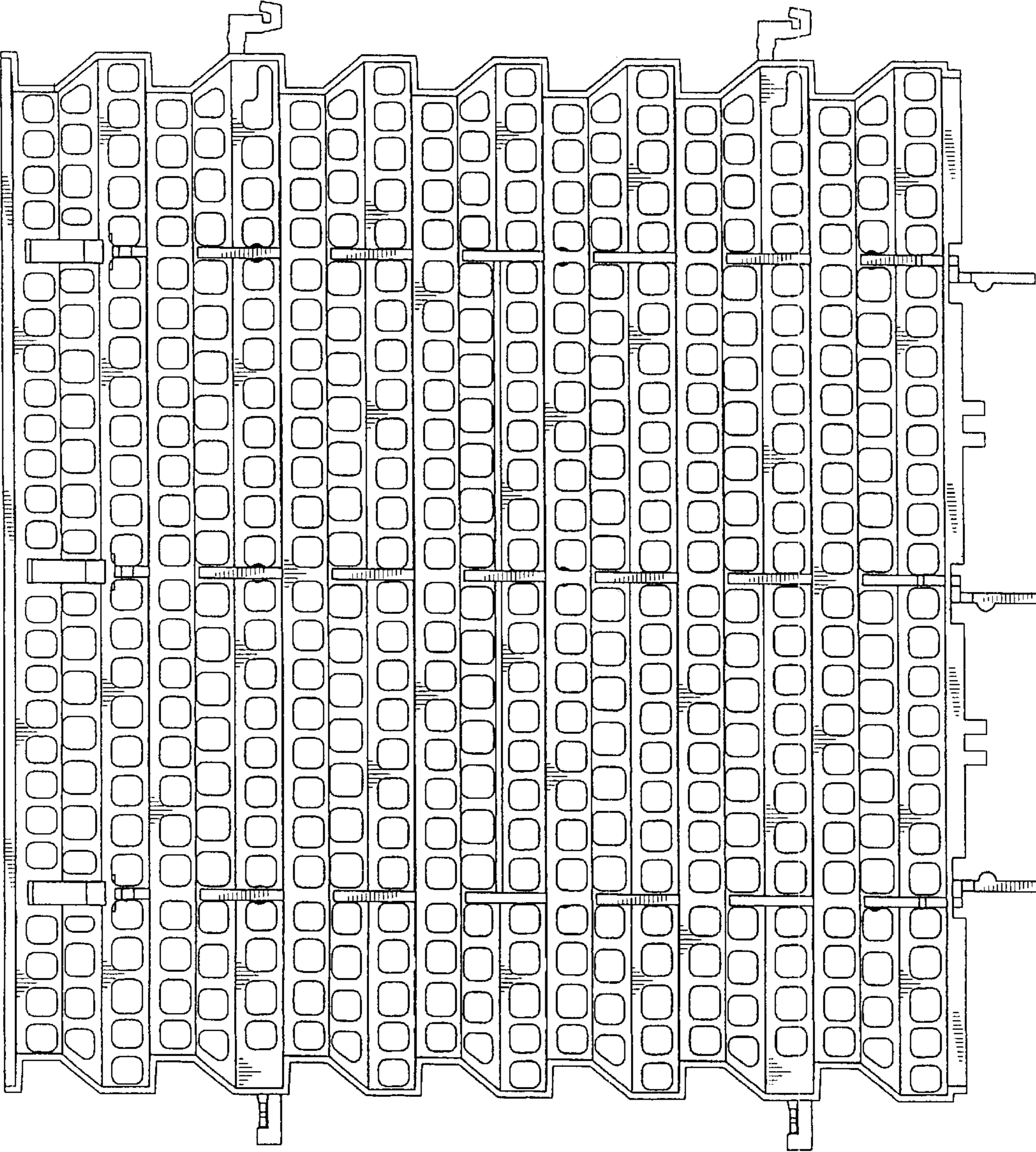

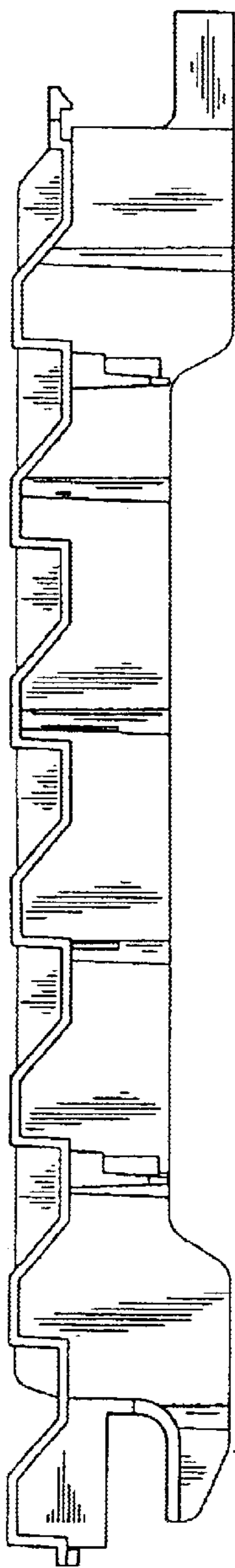

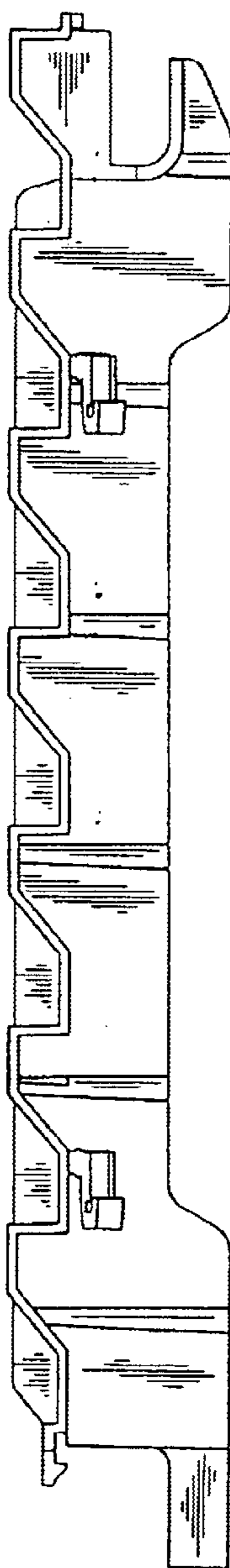

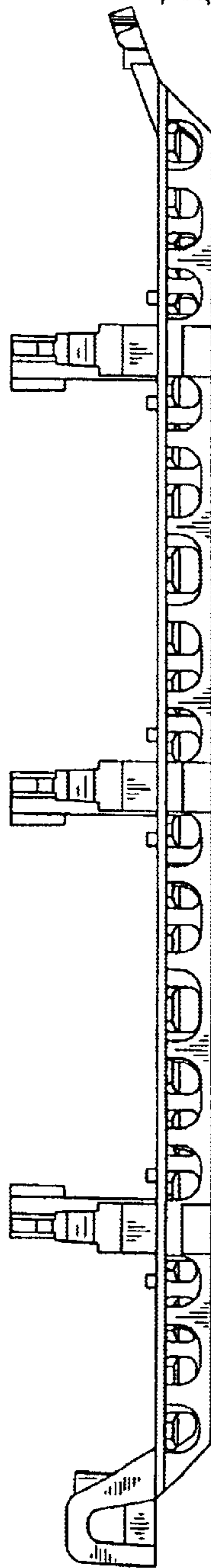
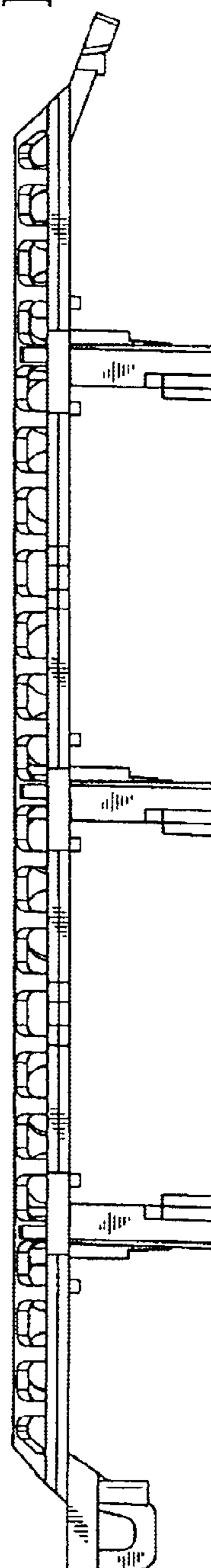

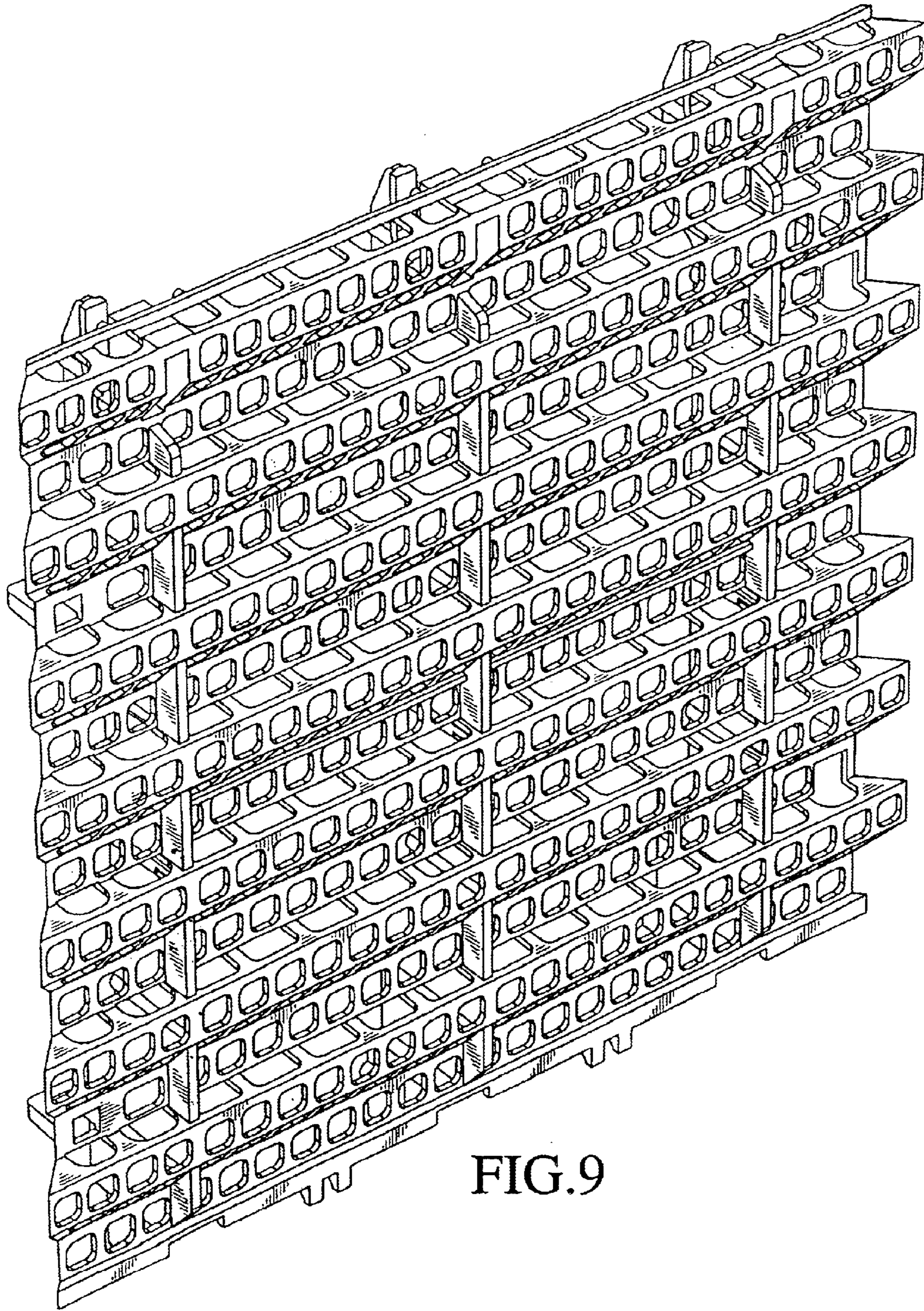

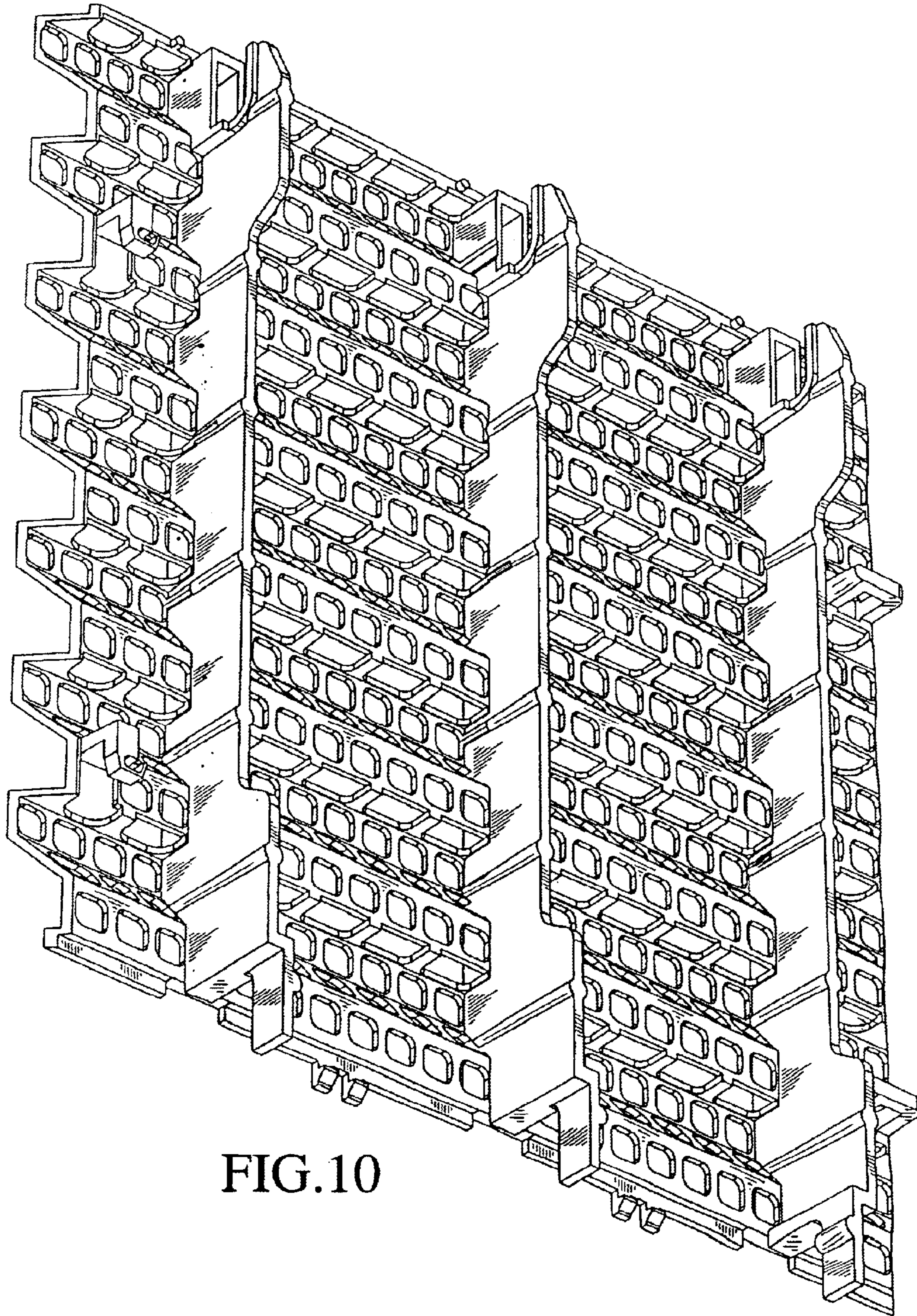

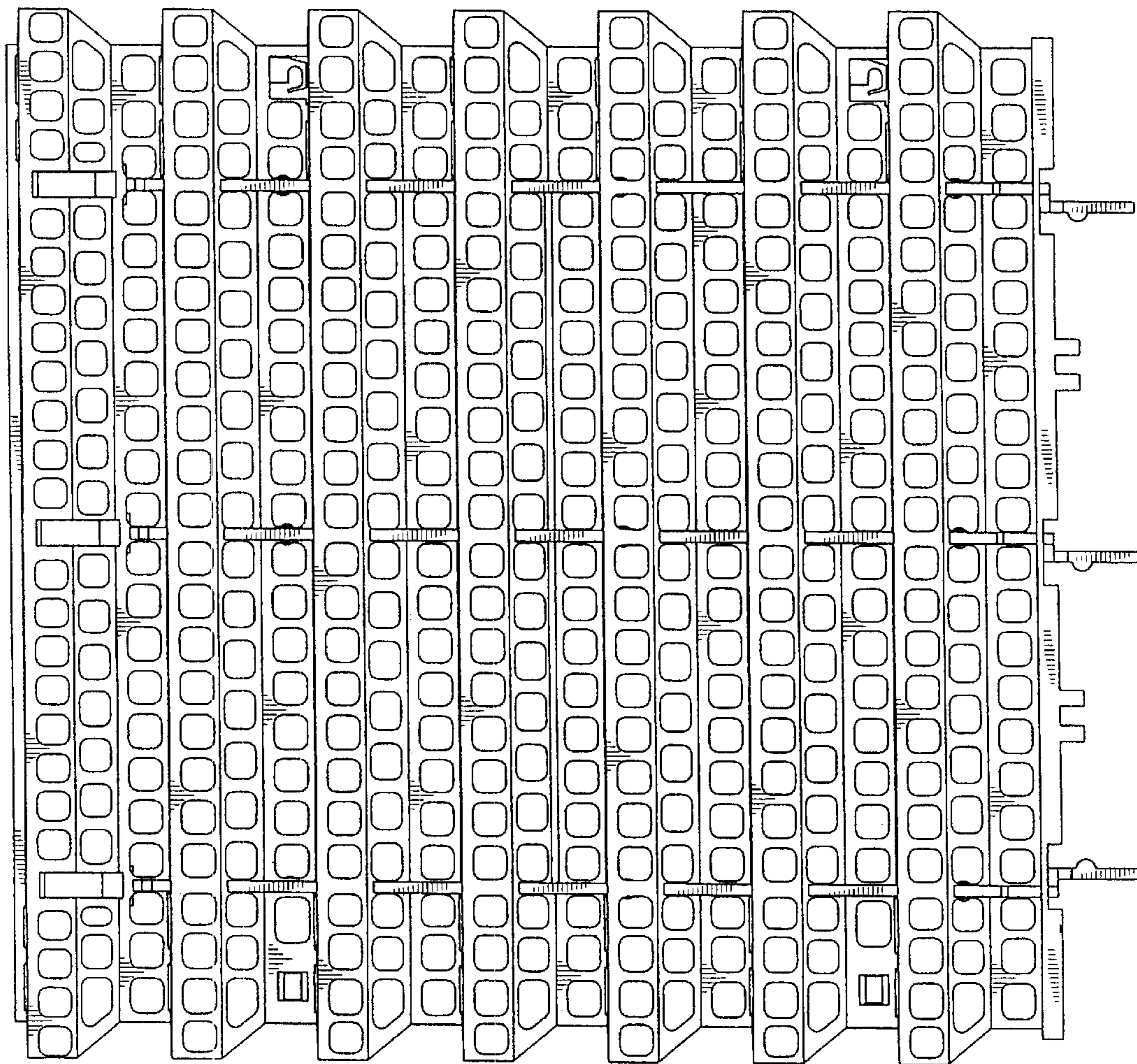

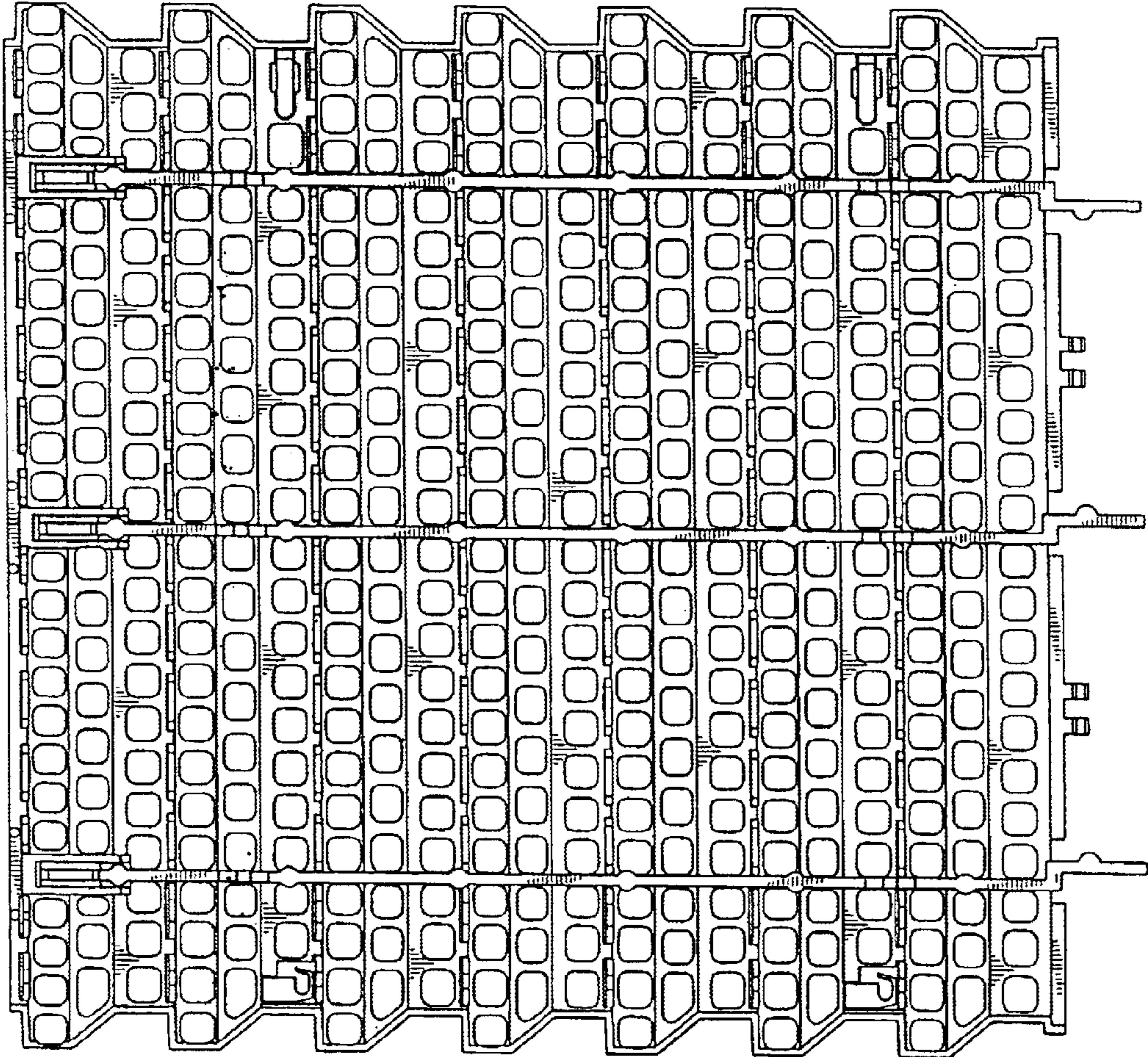

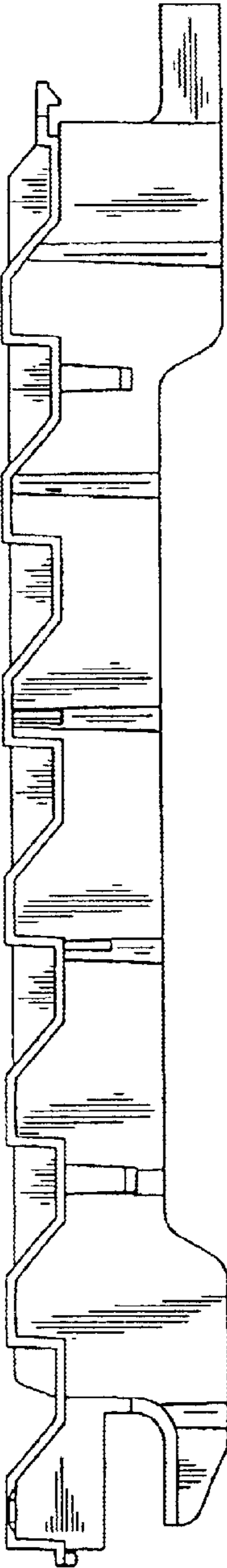

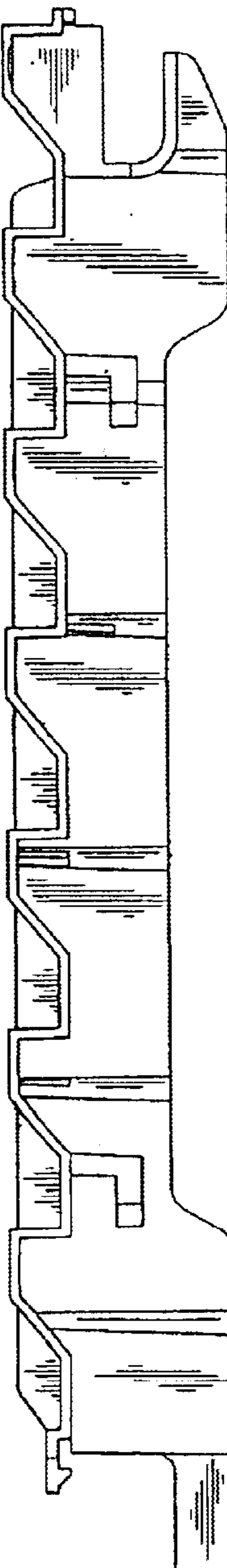

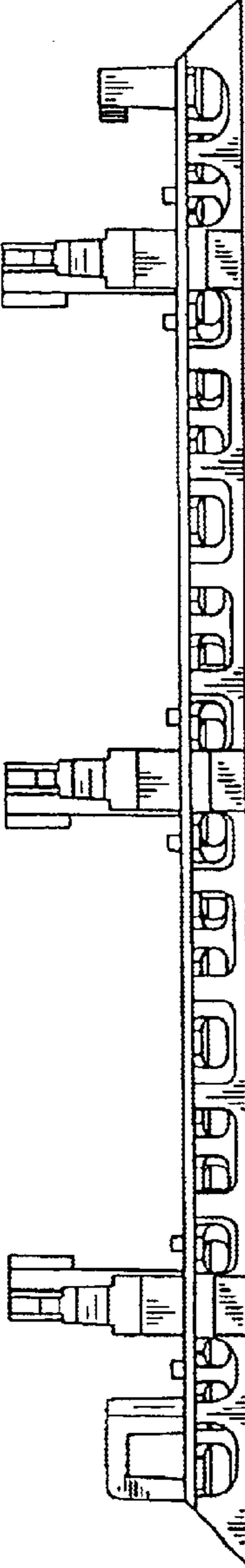
