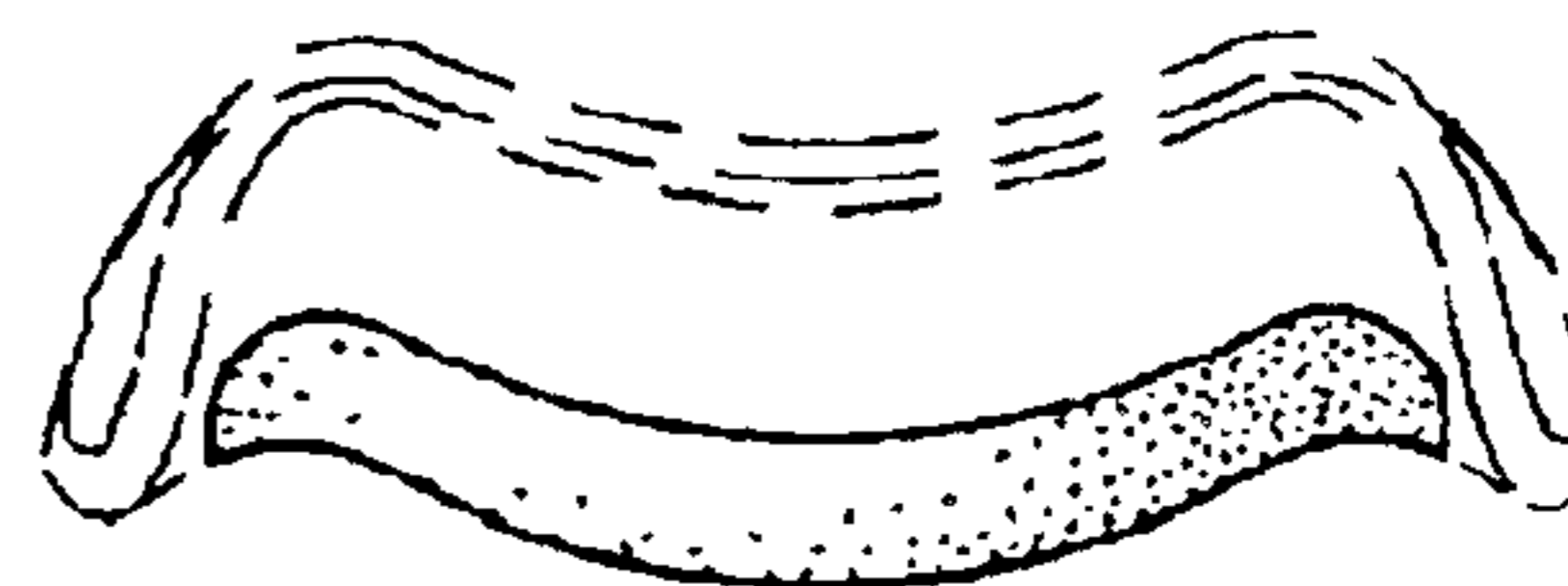
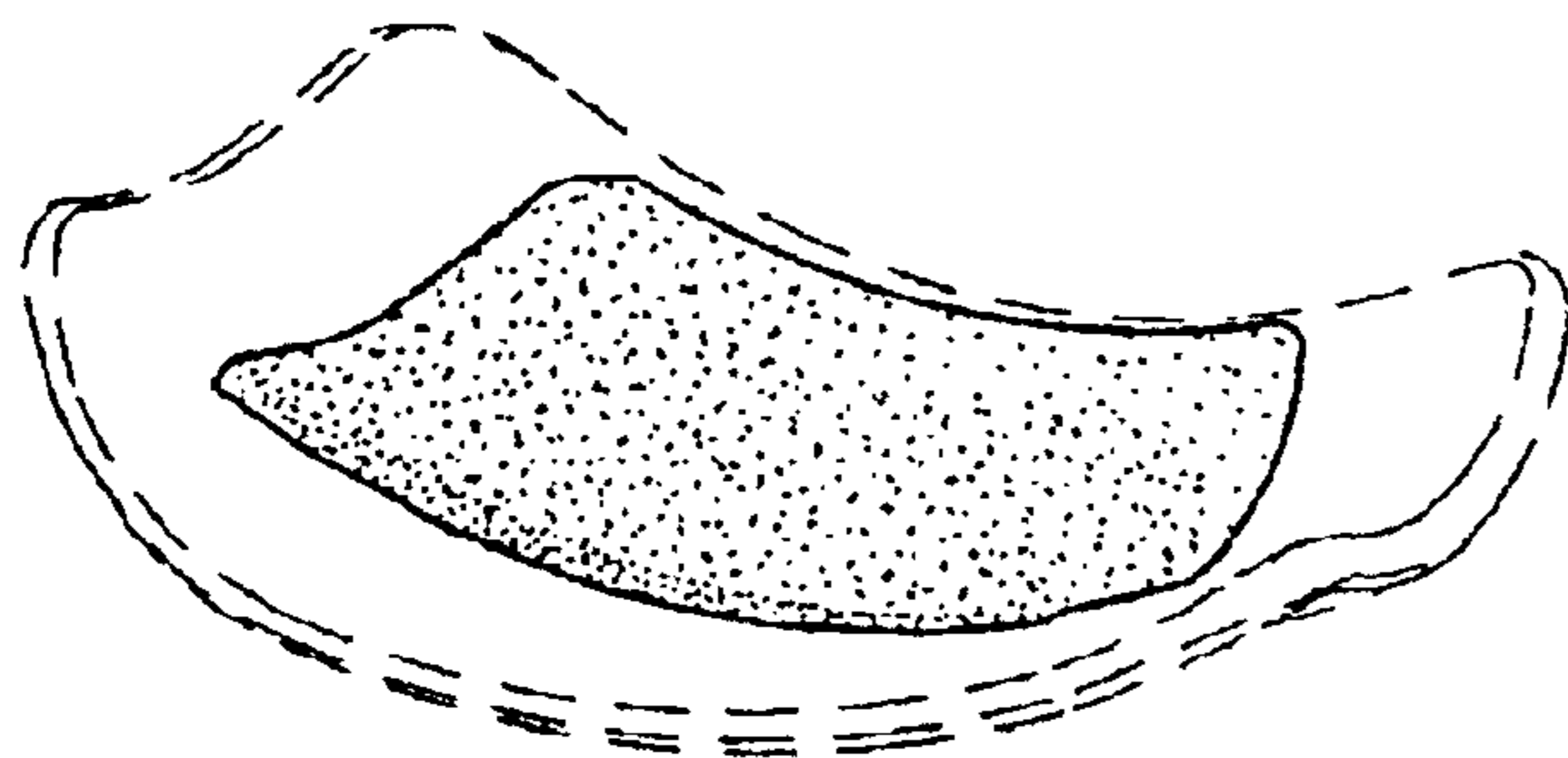
(57) **CLAIM**

The ornamental design for a snack chip, as shown and described.

DESCRIPTION

FIG. 1 is a side view of the snack chip; FIG. 2 is a perspective view of the snack chip of FIG. 1; FIG. 3 is a front view of the snack chip of FIG. 1; FIG. 4 is a back view of the snack chip of FIG. 1; FIG. 5 is top view of the snack chip of FIG. 1; and, FIG. 6 is a bottom view of the snack chip of FIG. 1. The broken lines immediately adjacent the shaded areas represent the bounds of the claim and all other broken lines are for illustrative purposes only. None of the broken lines form a part of the claimed design.

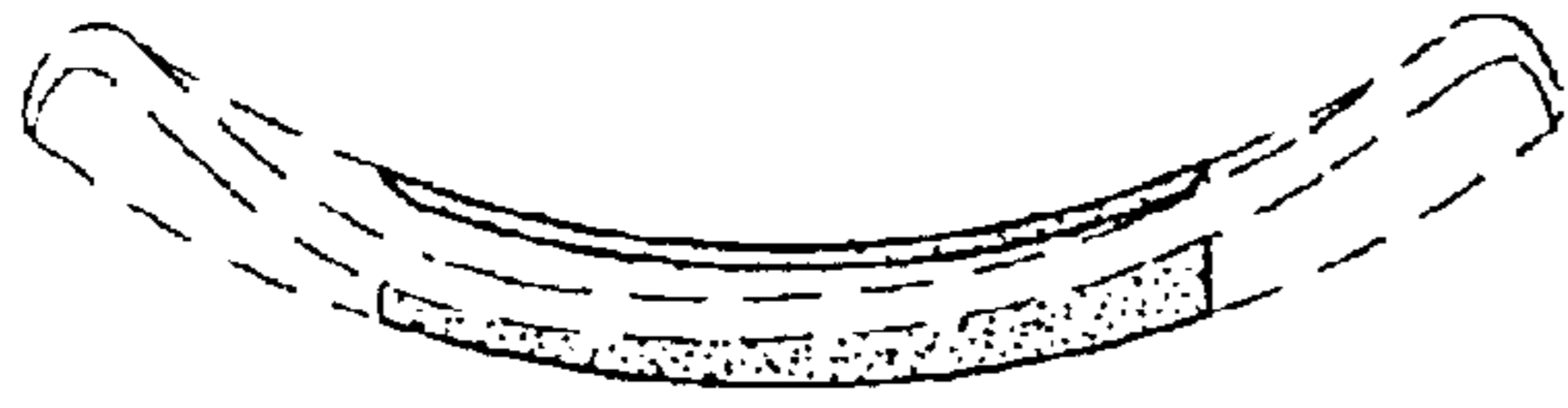

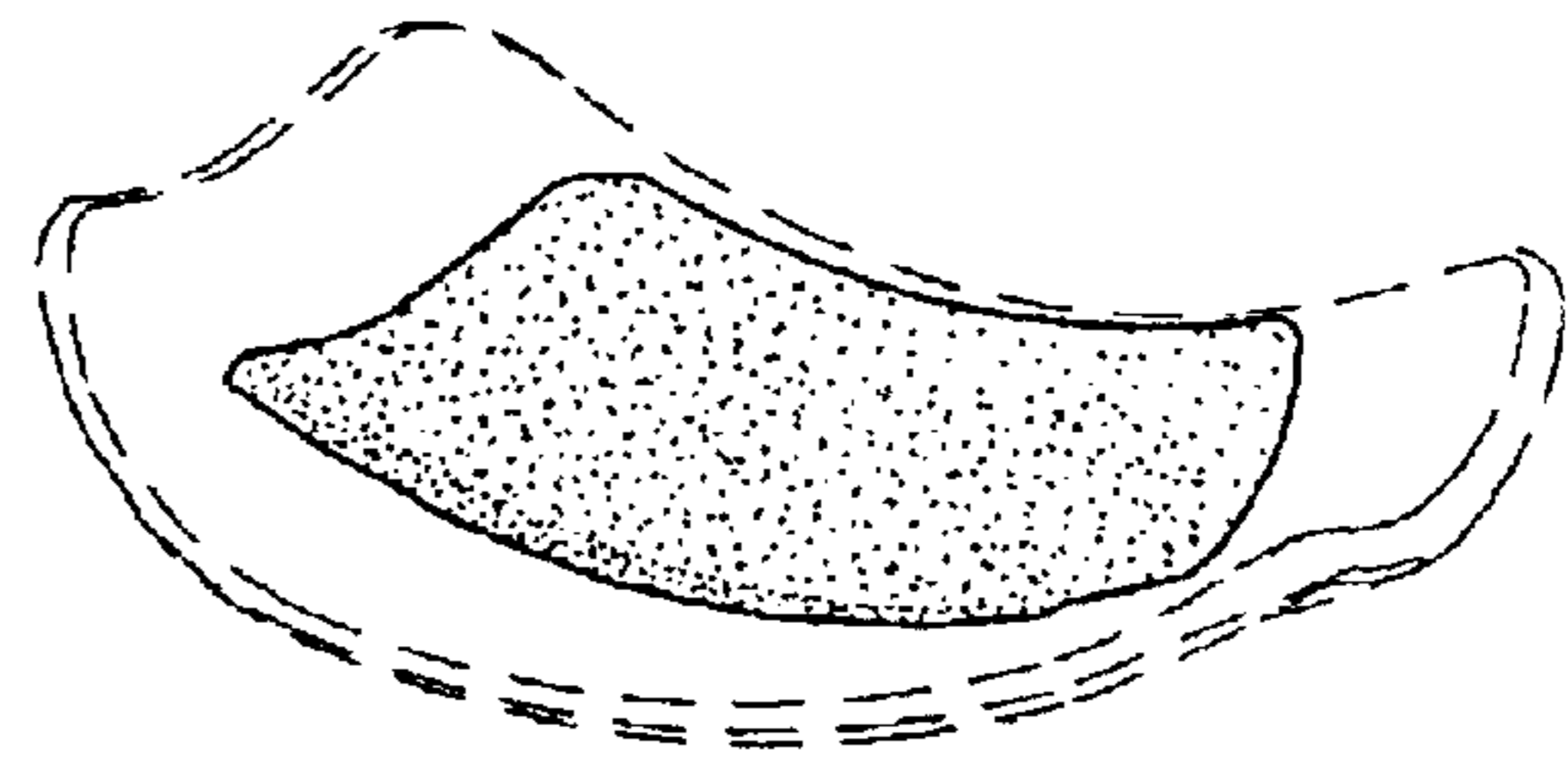

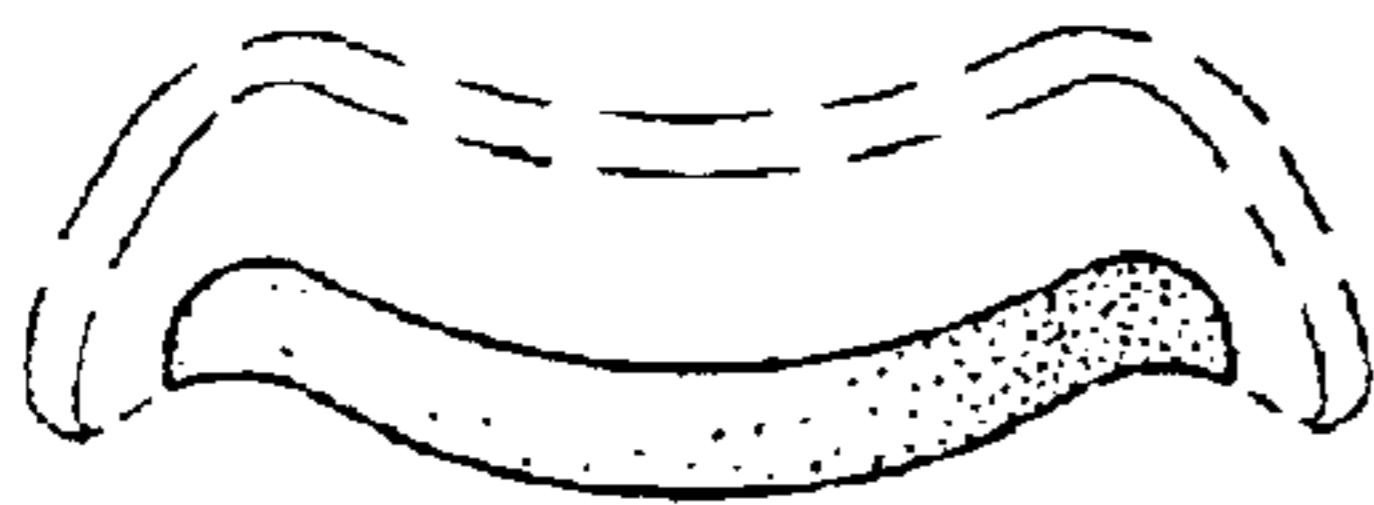

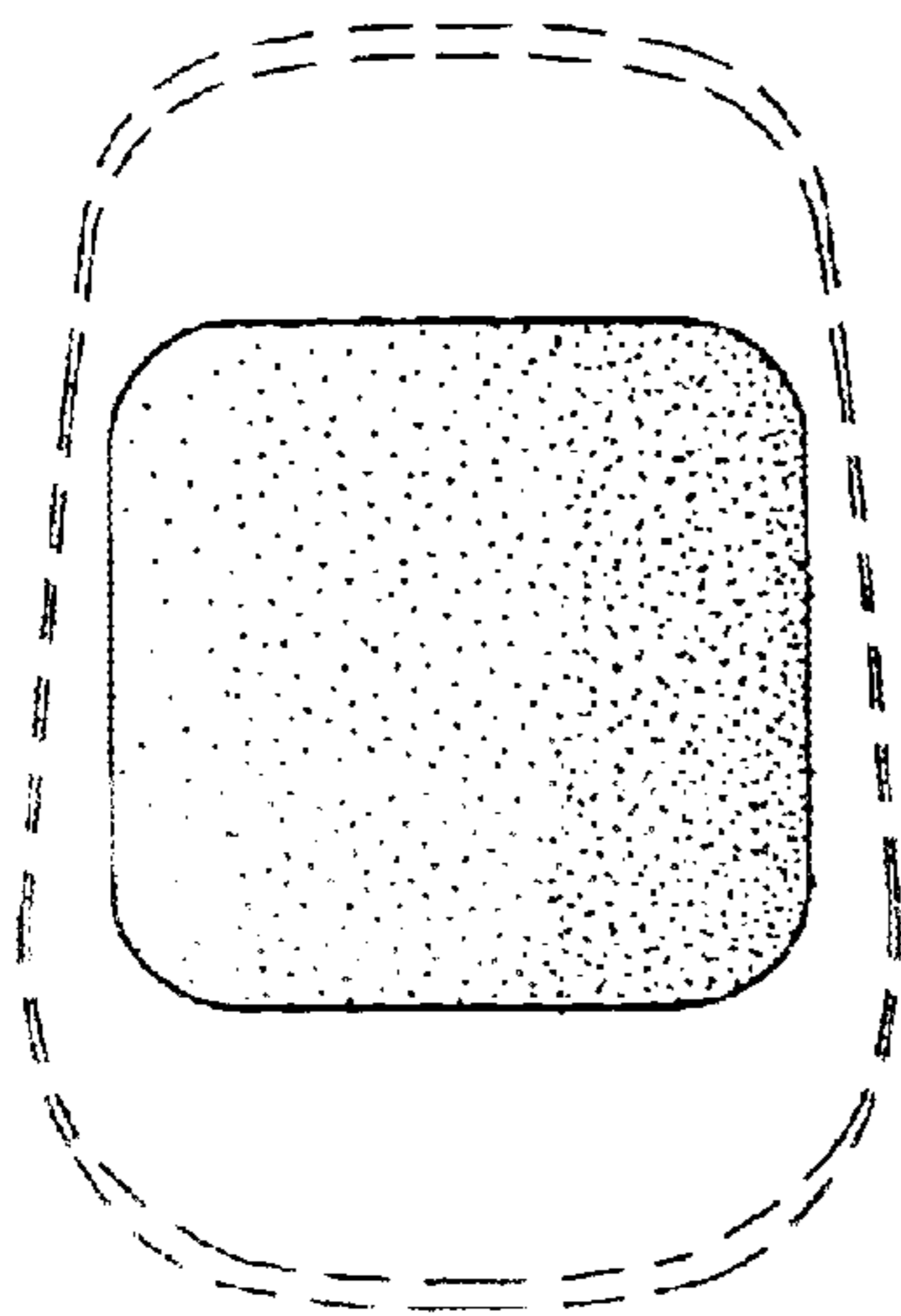

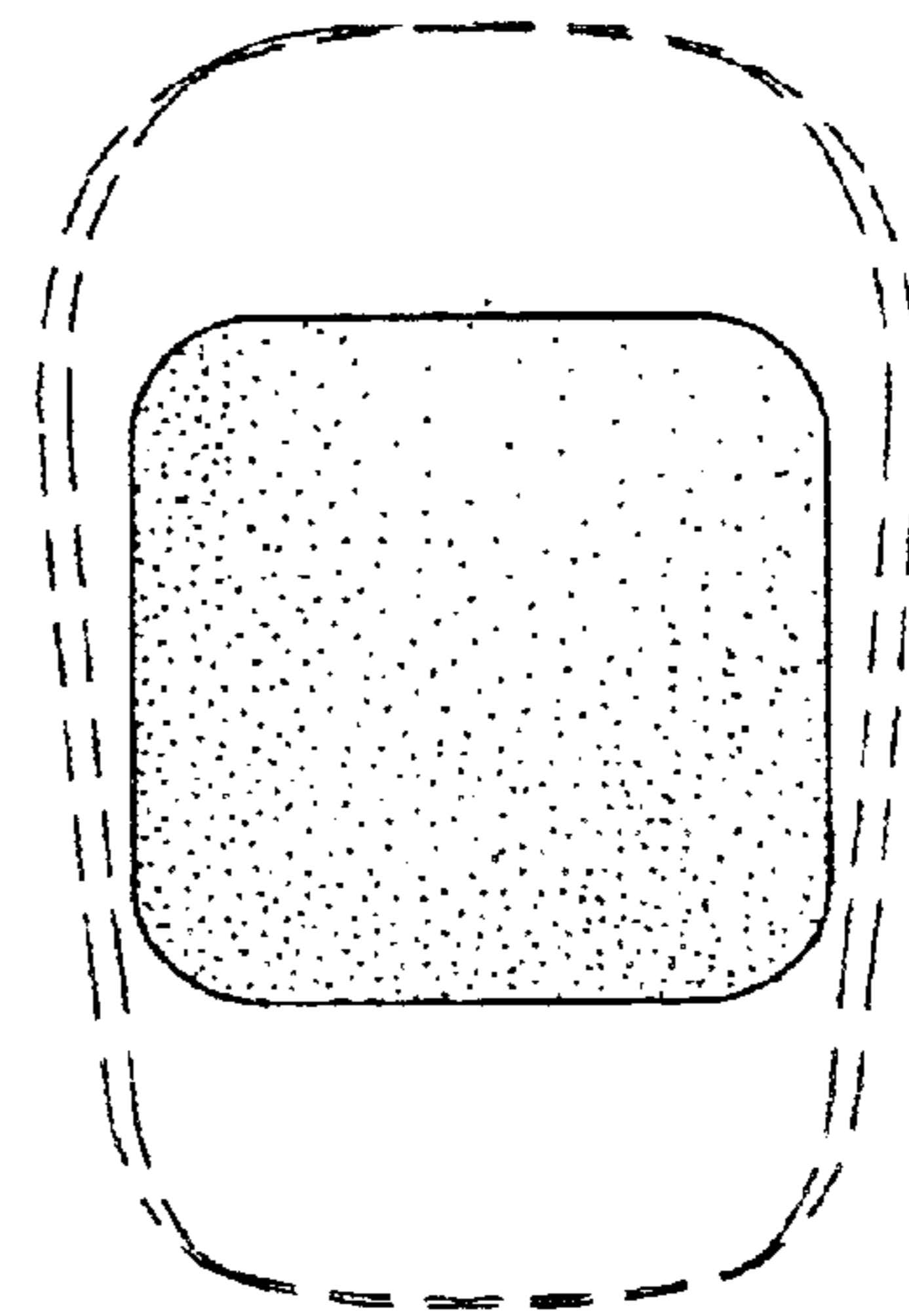
