(57) **CLAIM**

We claim the ornamental design for a backpack, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a backpack showing our new design;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a left side view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a top view thereof;

FIG. 6 is a bottom view thereof; and,

FIG. 7 is a top view in an open position thereof.

The broken lines shown on the surface of the backpack throughout the views, are understood to represent stitching.

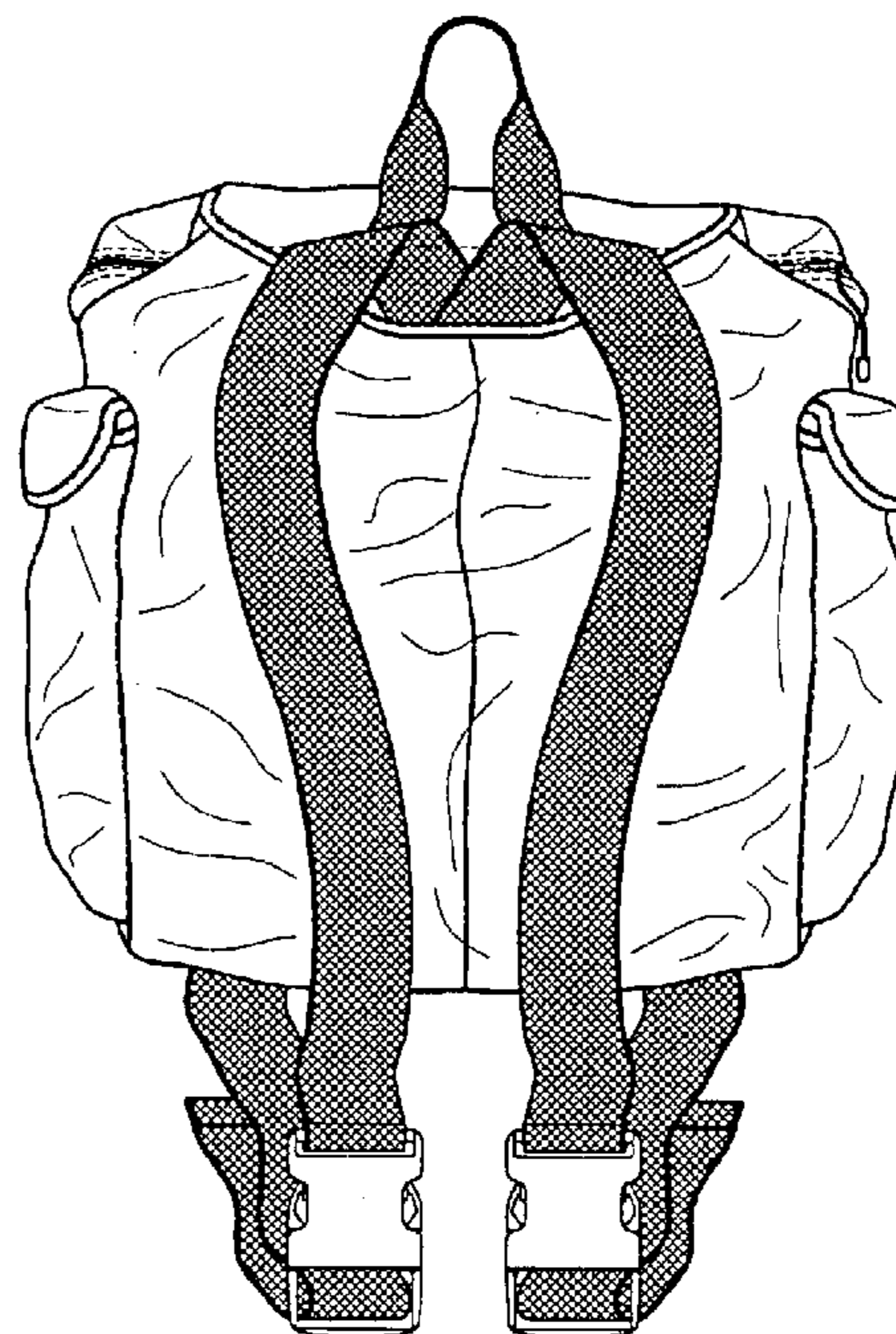
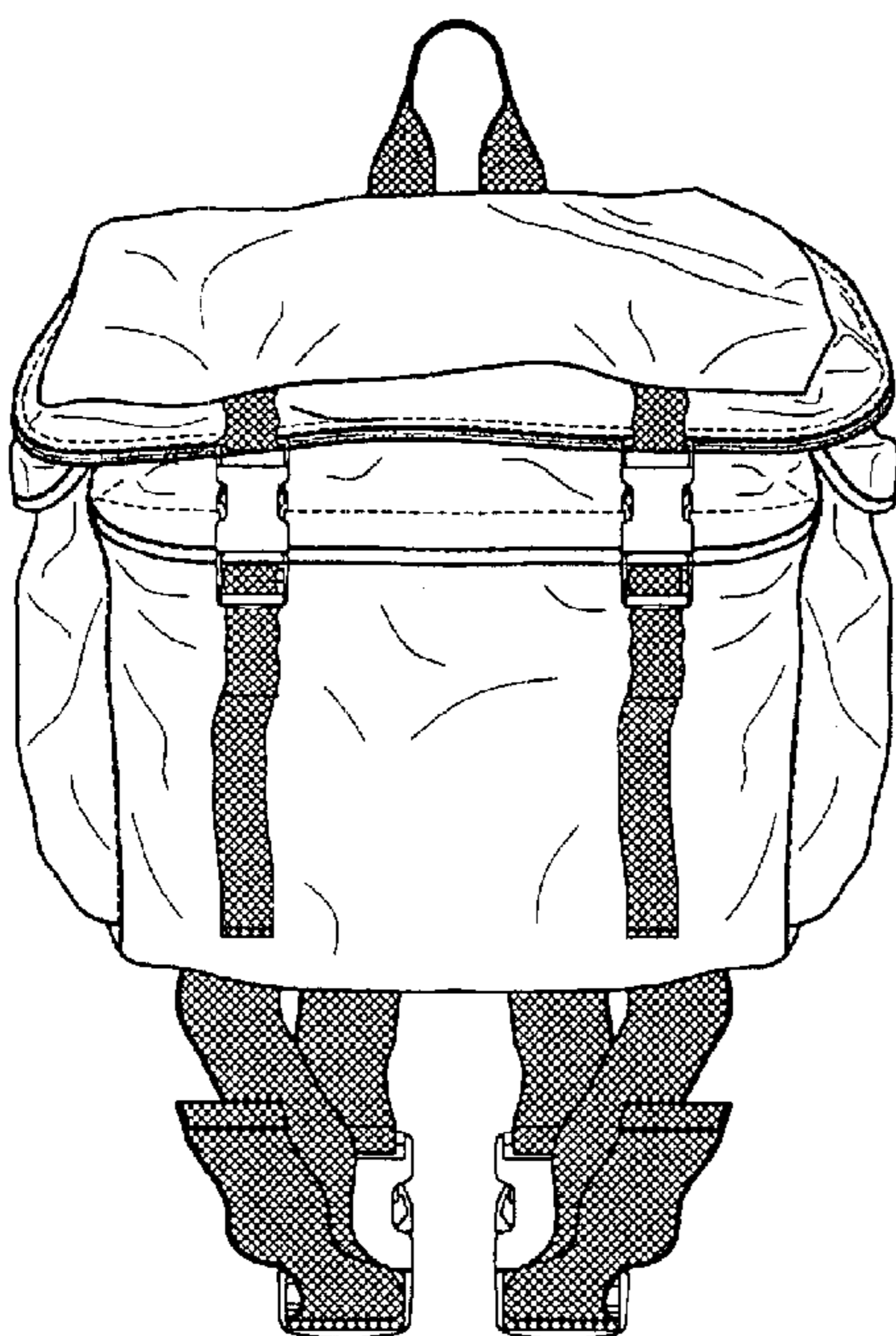

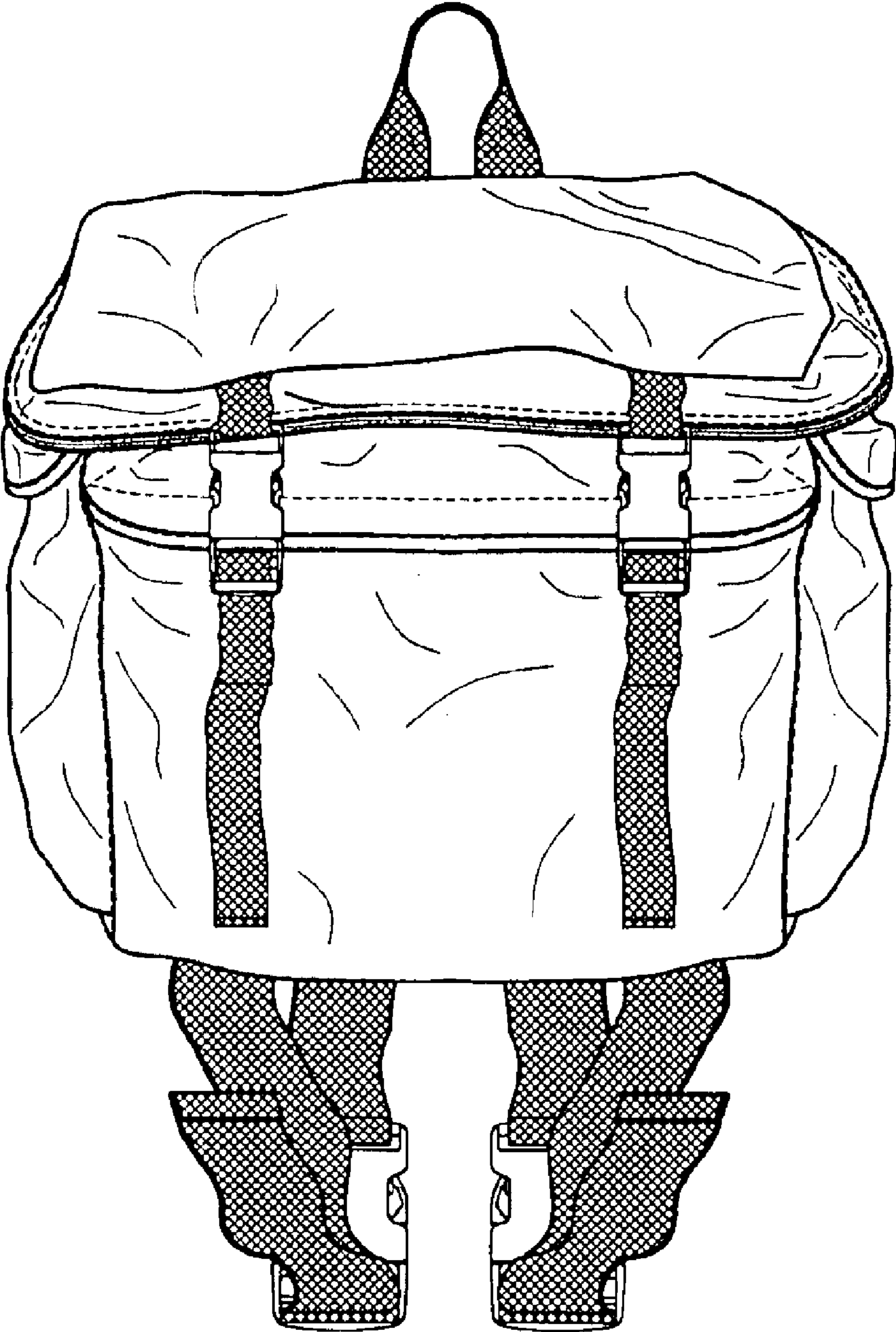

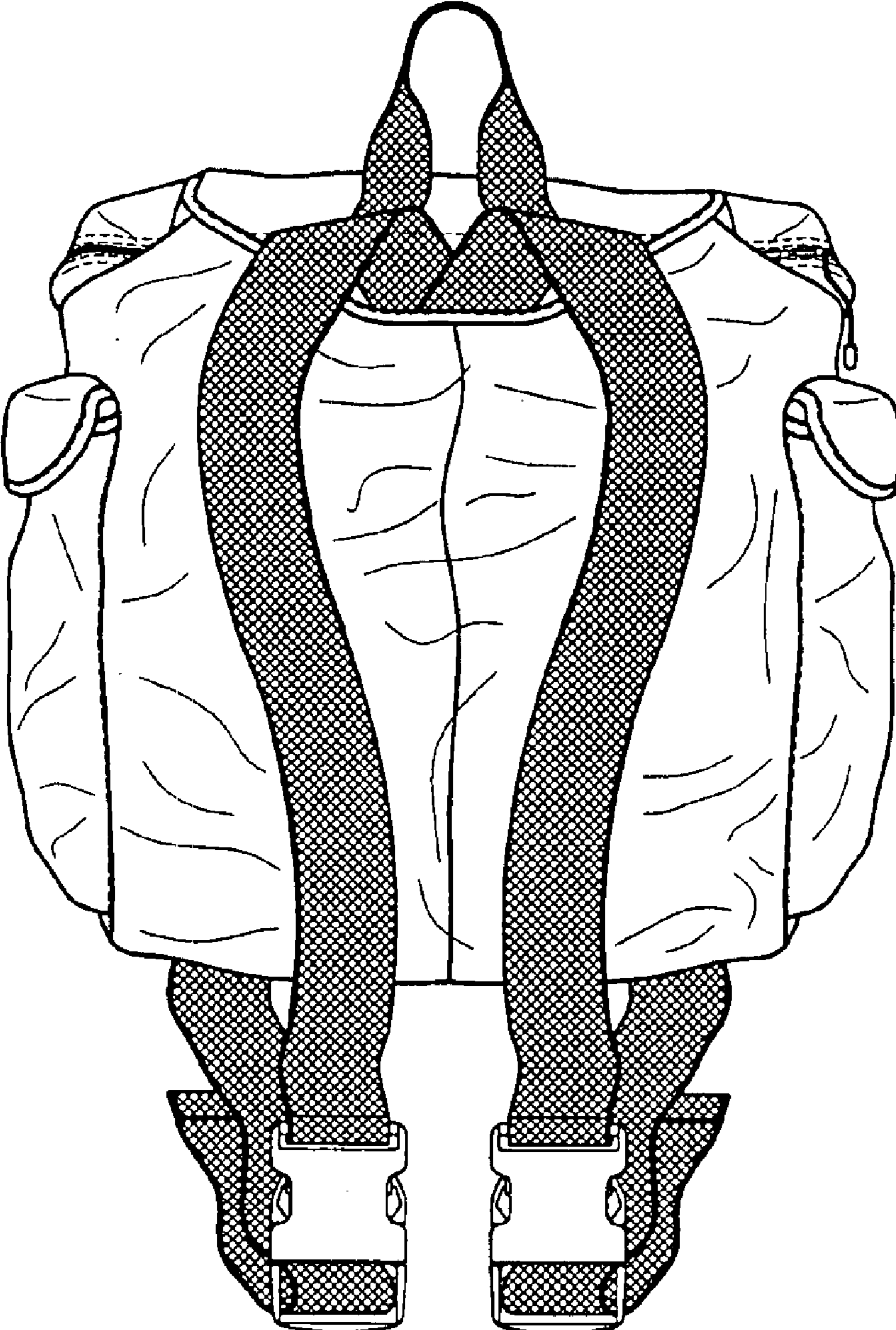

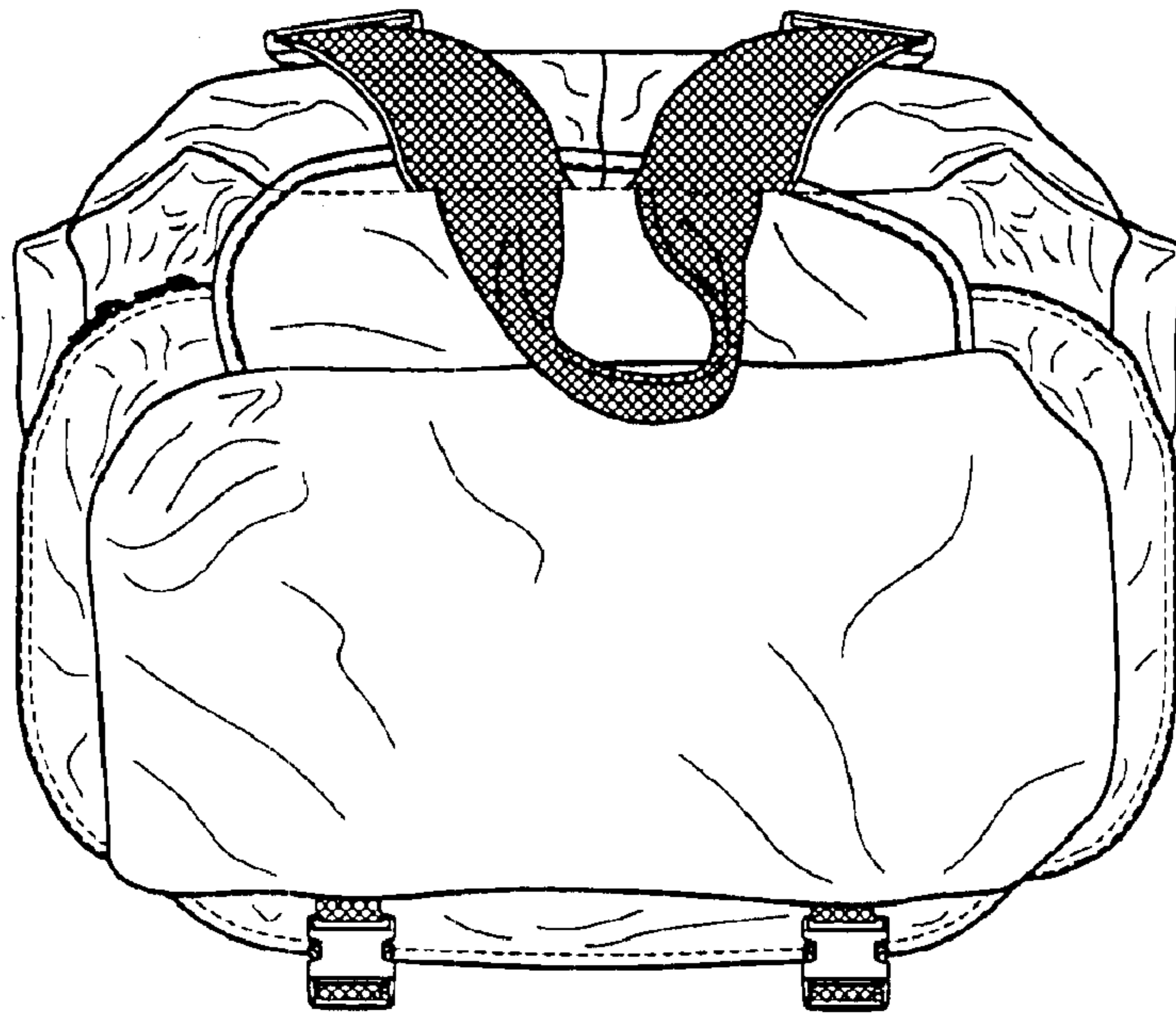

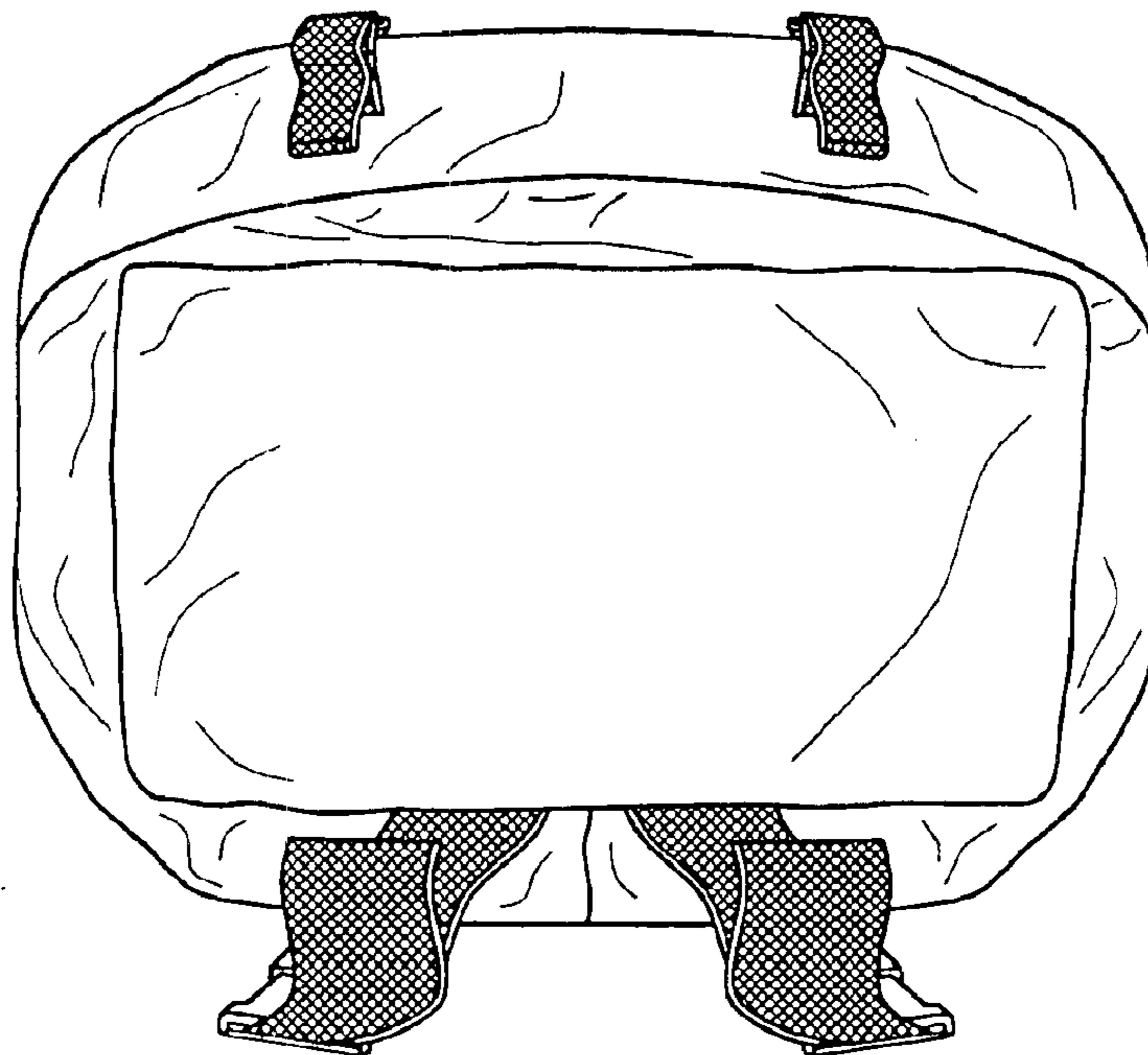
