FIG. 1 is a front view of a T-shaped nail brush, the rear view being a mirror image of the front.

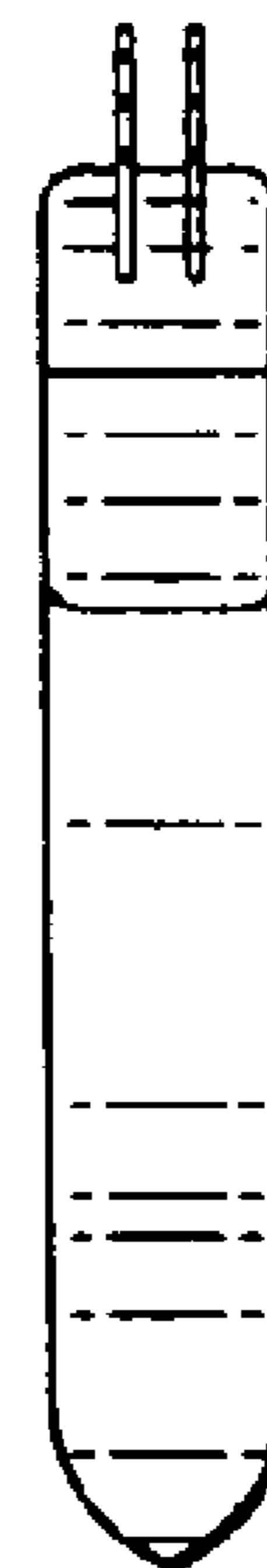
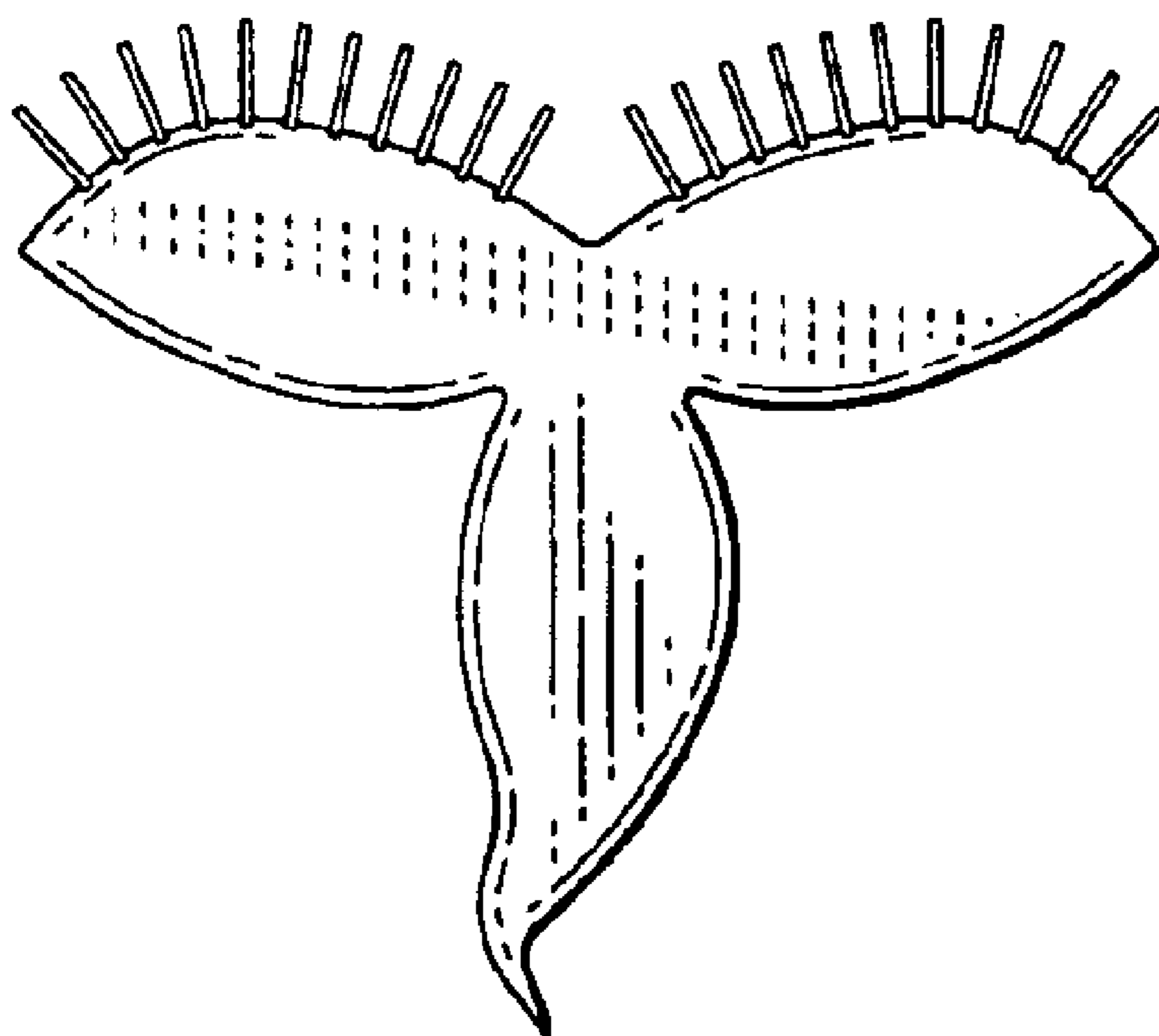
FIG. 2 is a left side view of the nail brush.

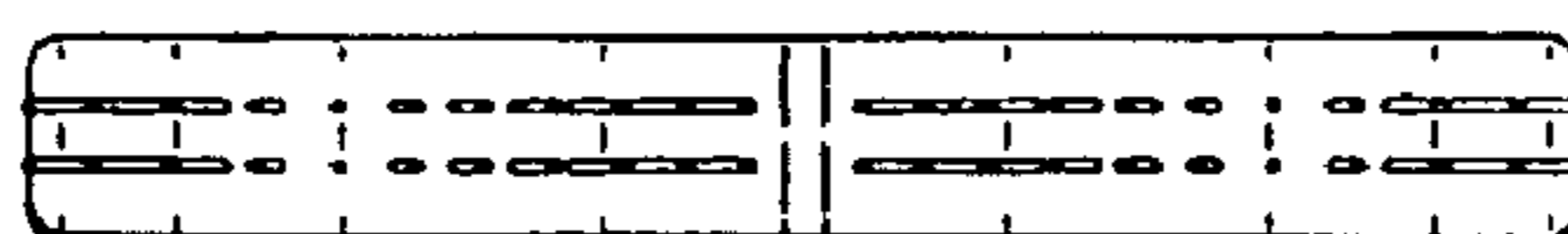

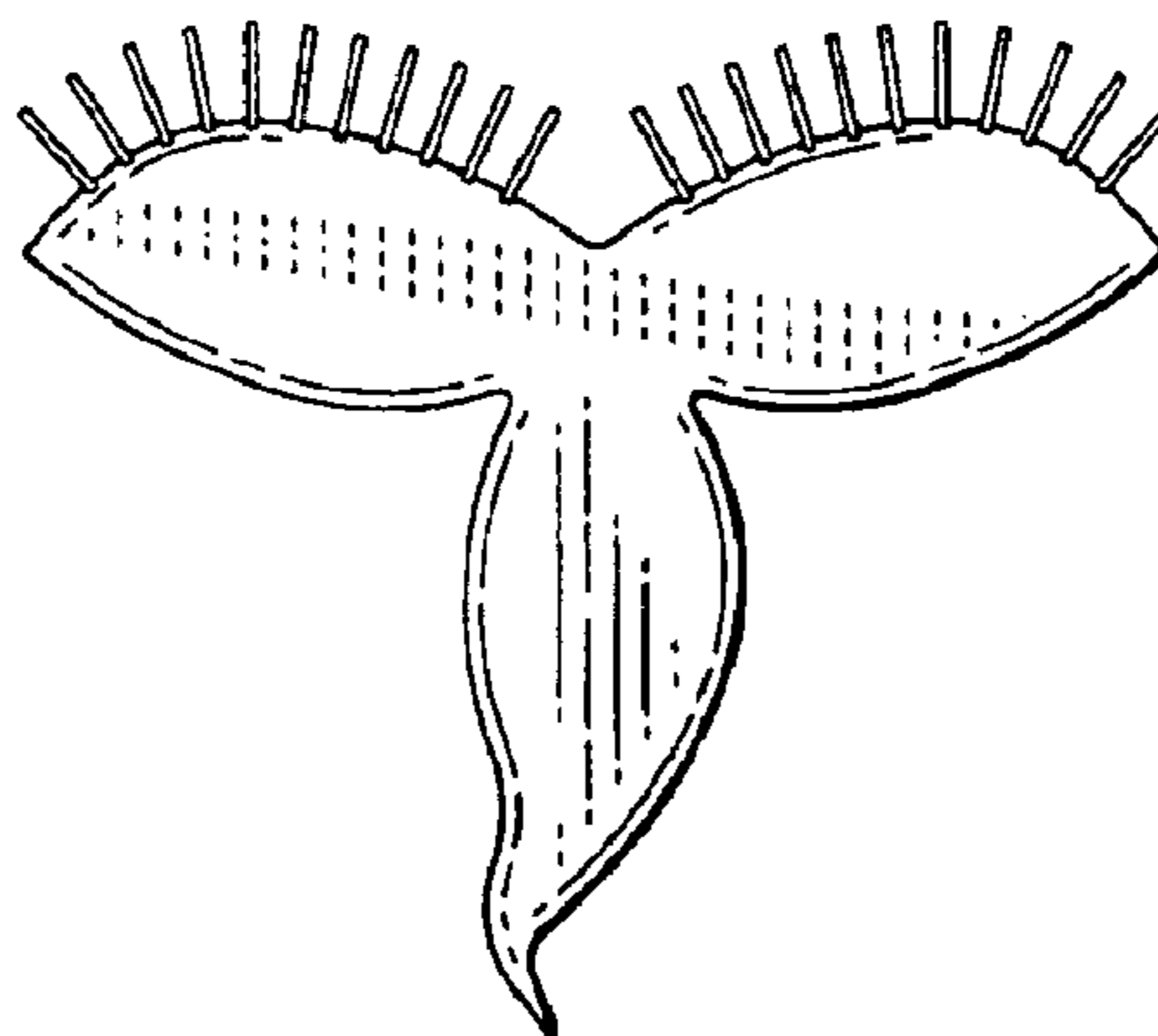
