The ornamental design for a bottle with cap, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle with cap showing our new design;
 FIG. 2 is a front elevational view thereof, the left side, right side, and rear elevational views being identical; and,
 FIG. 3 is a top plan view thereof.

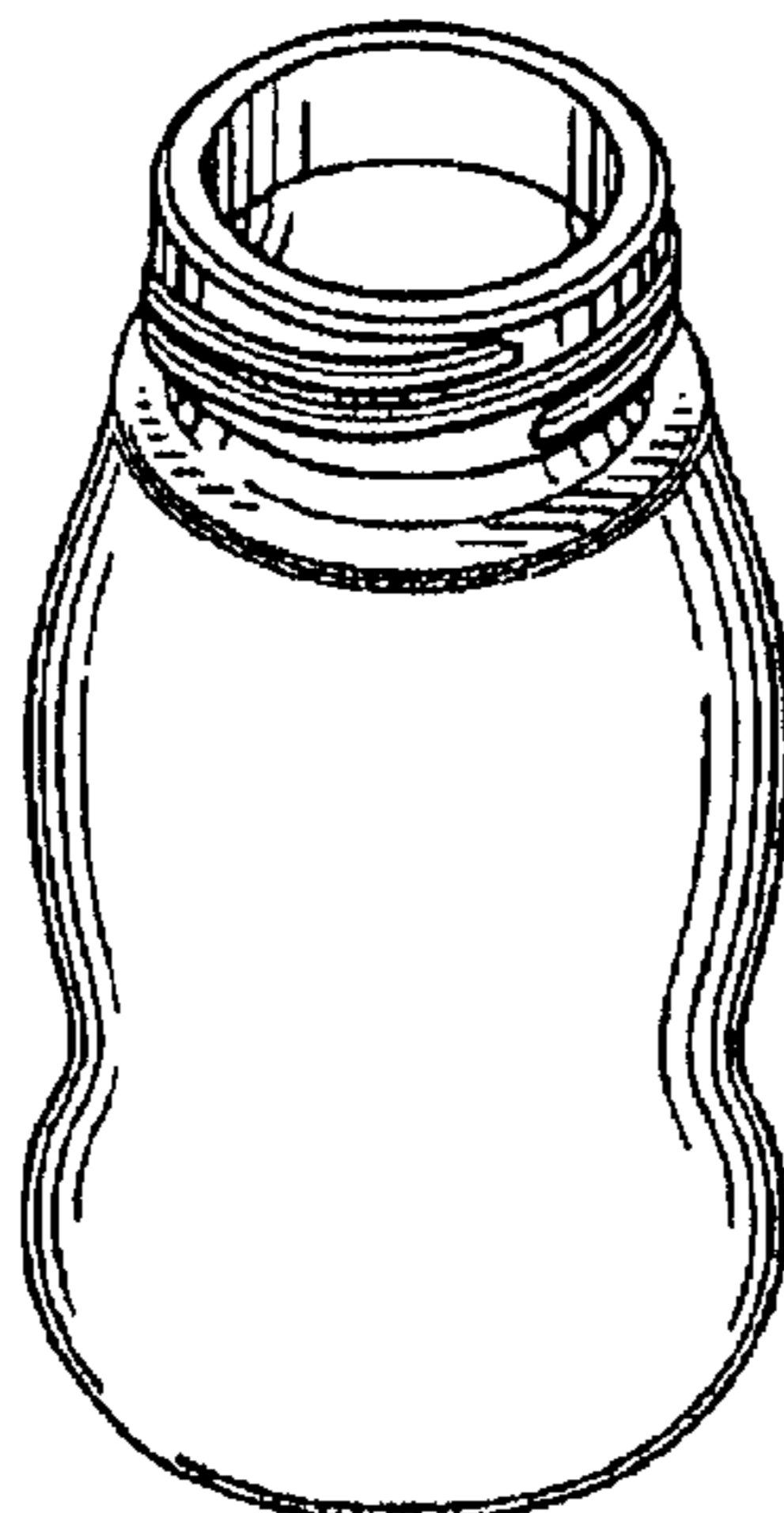

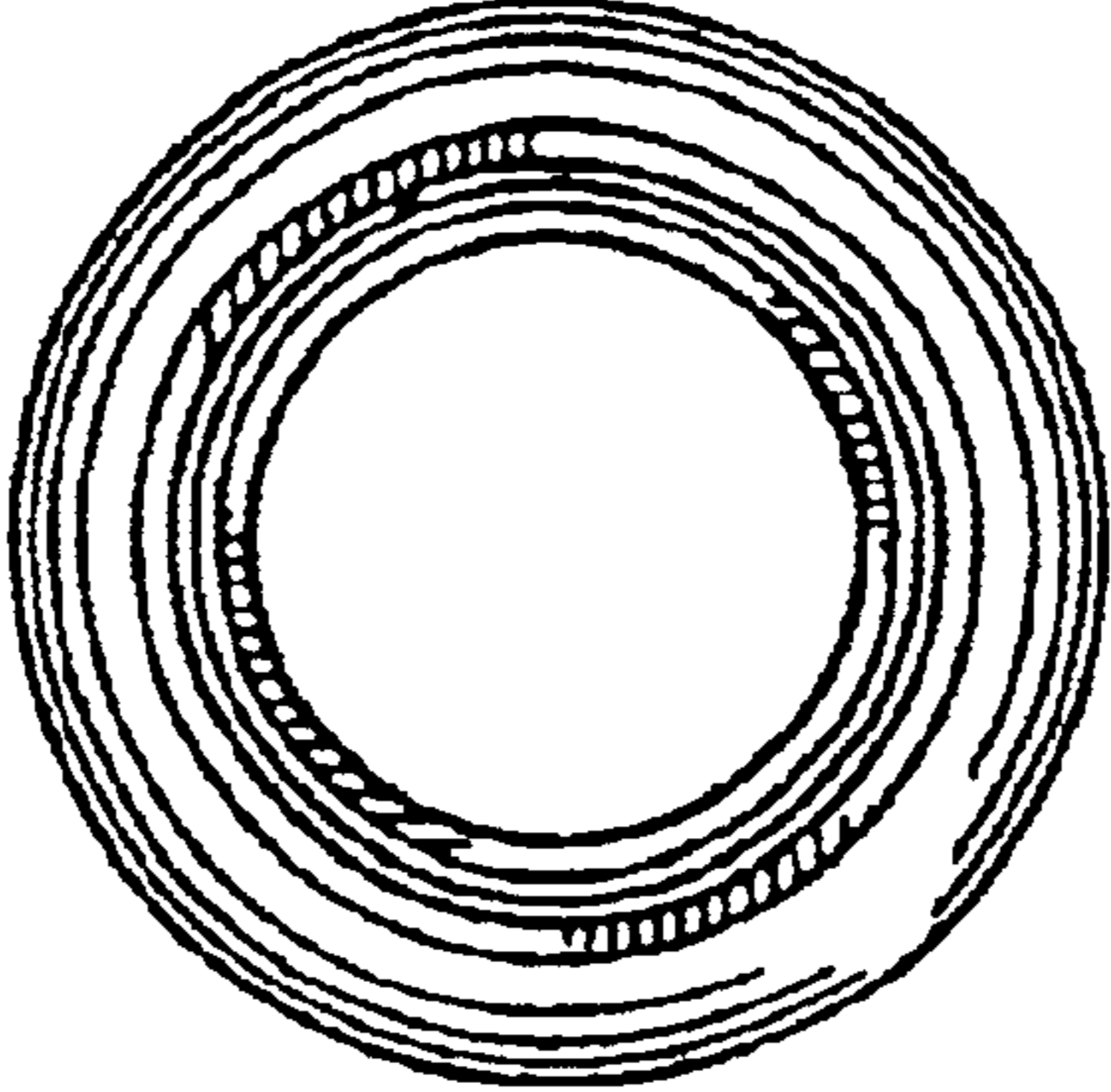

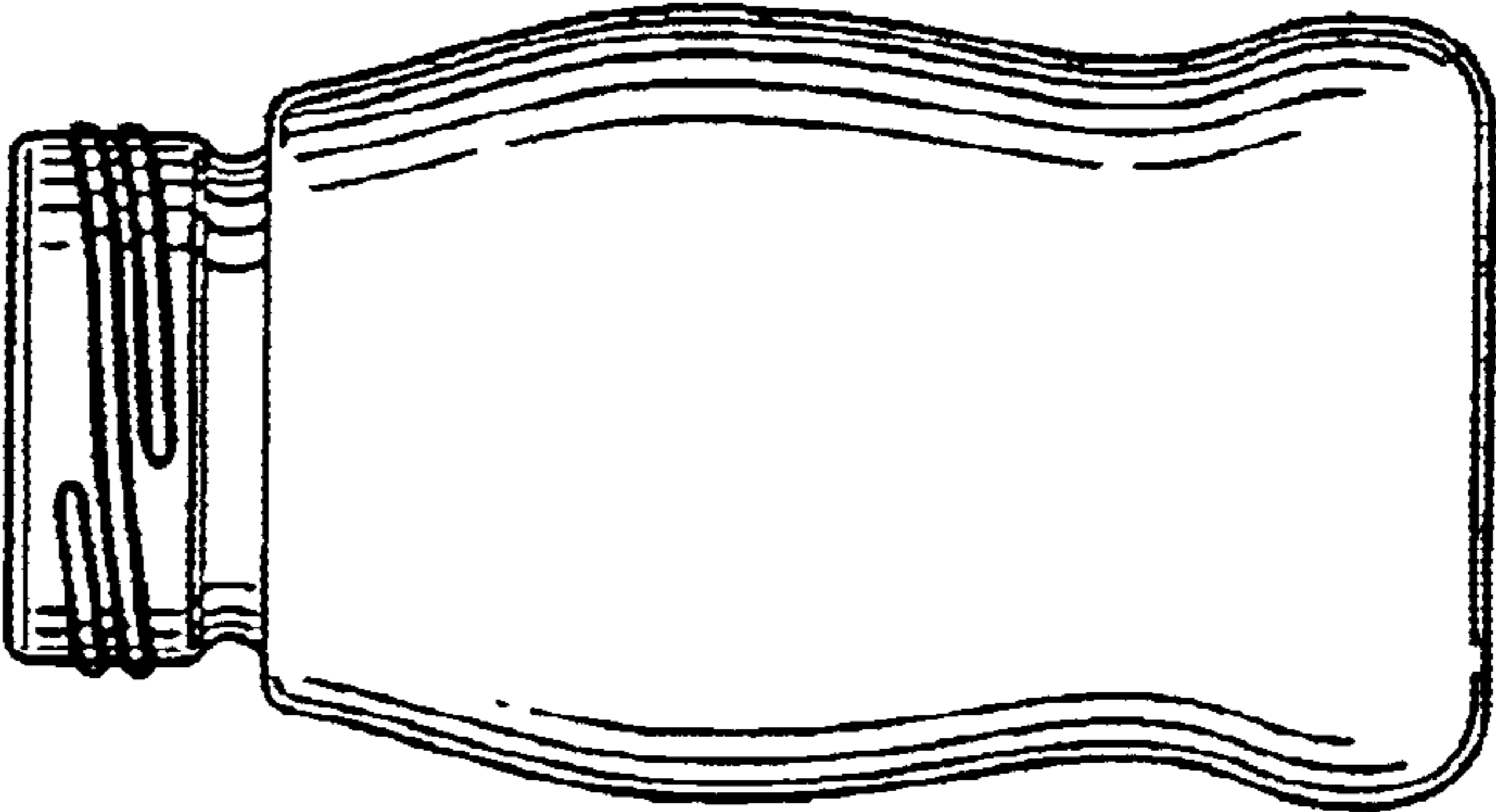
