DESCRIPTION

FIG. 1 is a perspective view of front right side of a wristwatch showing my new design;

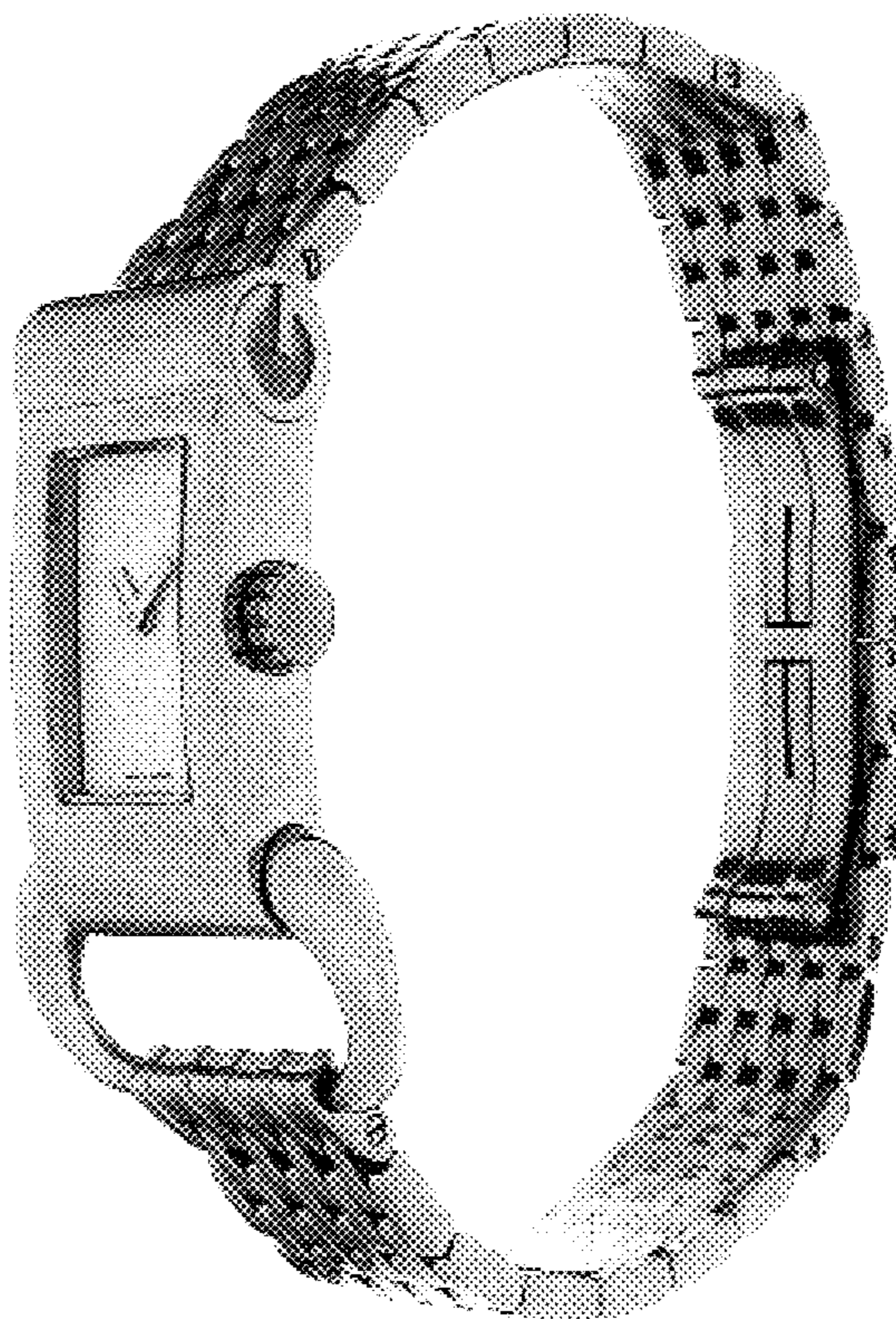

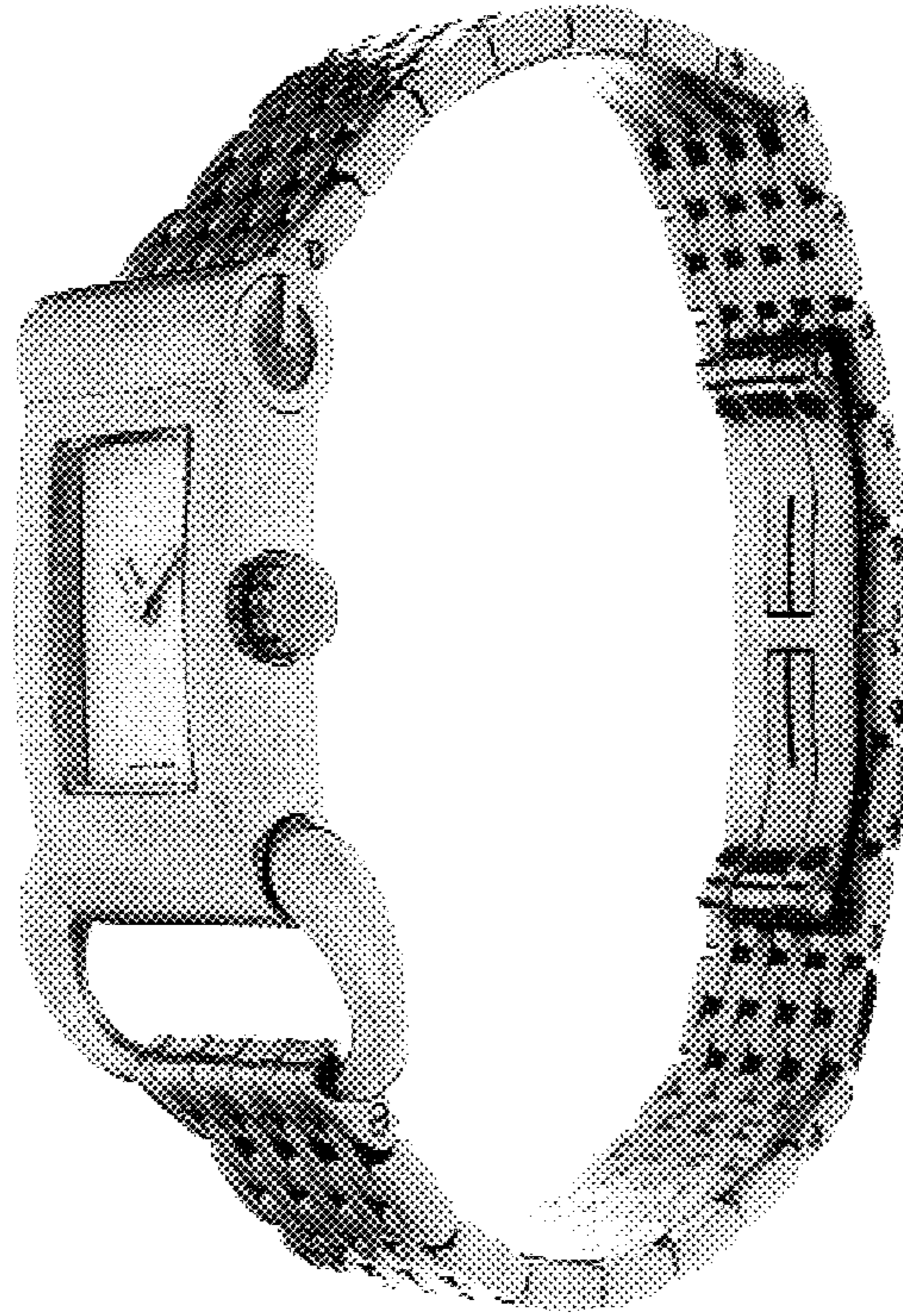

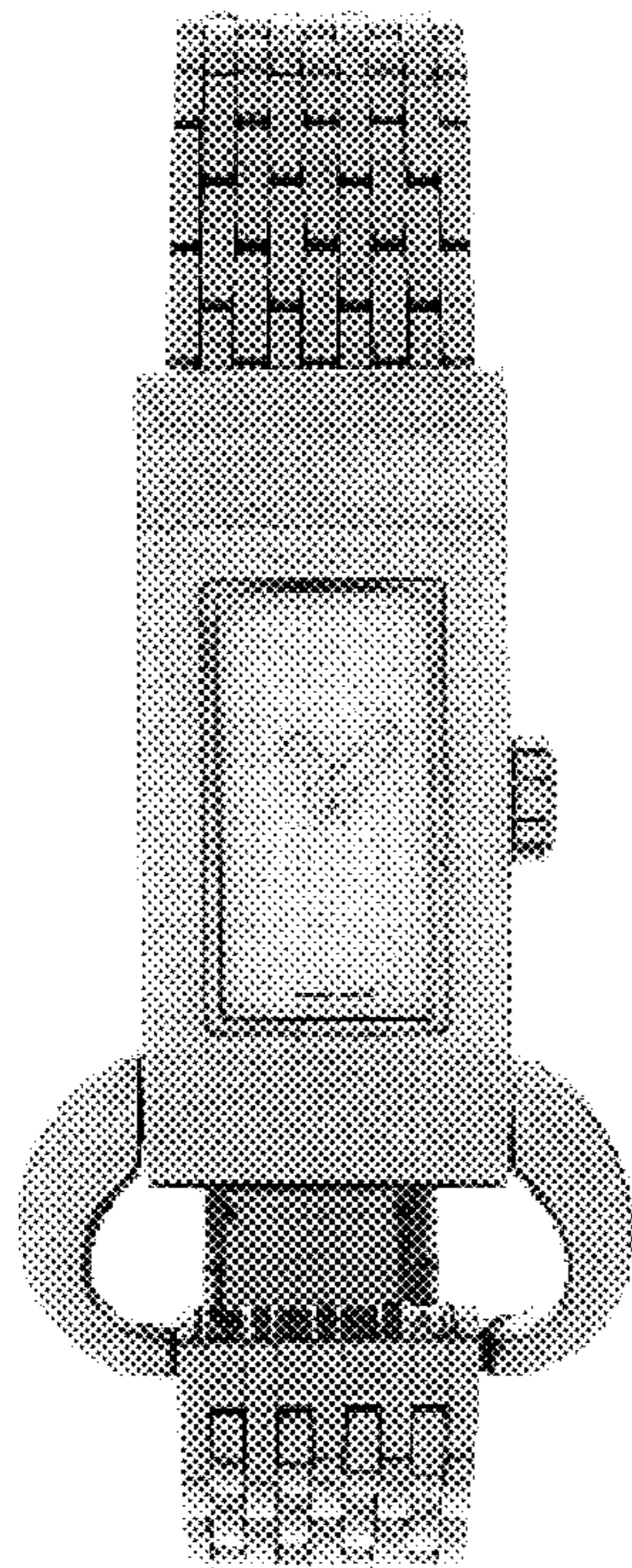

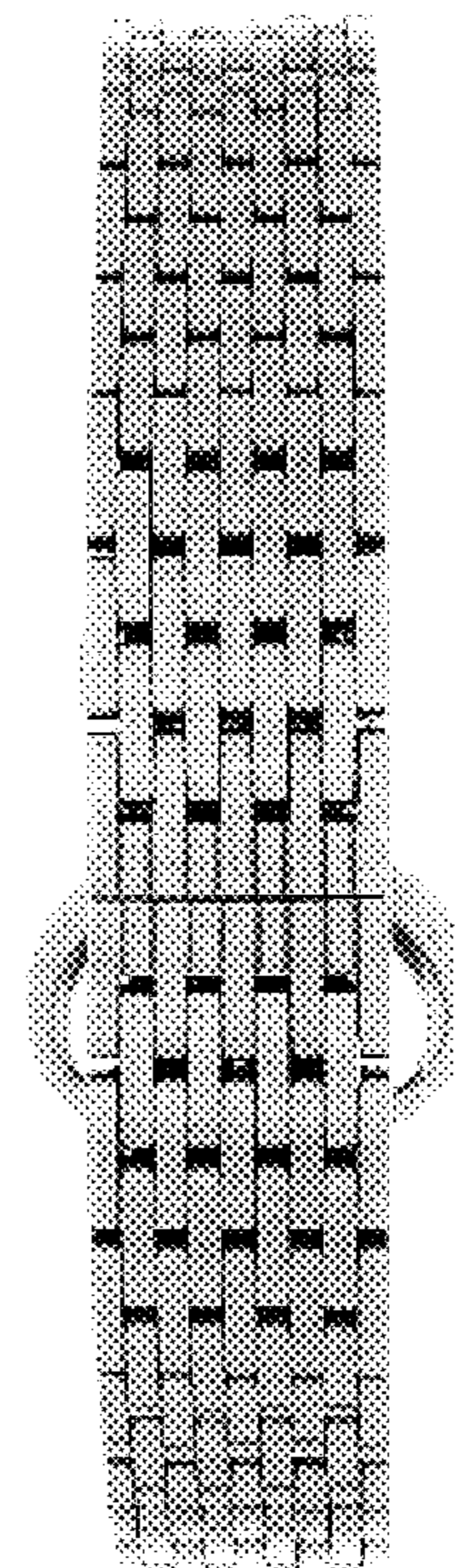

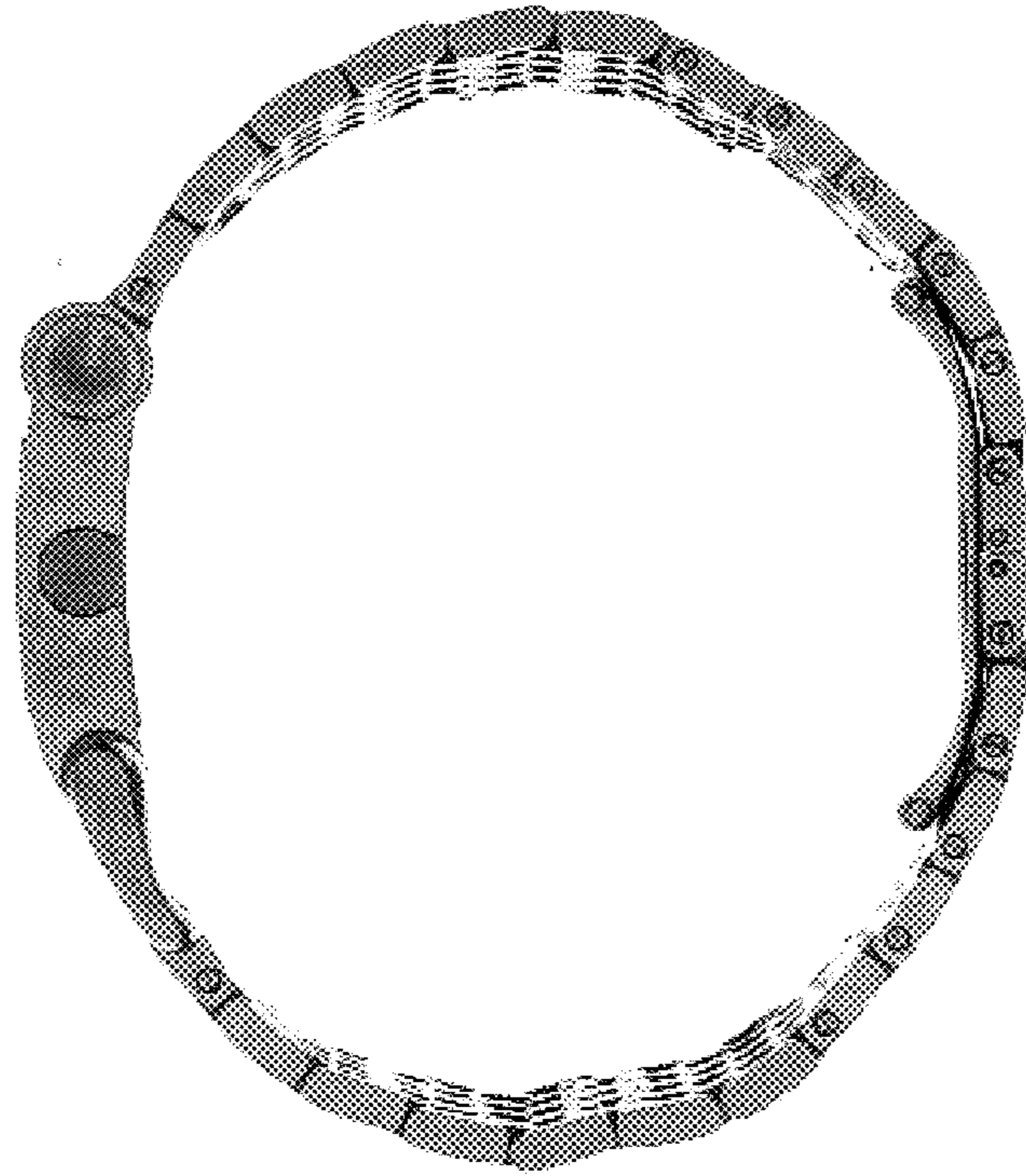

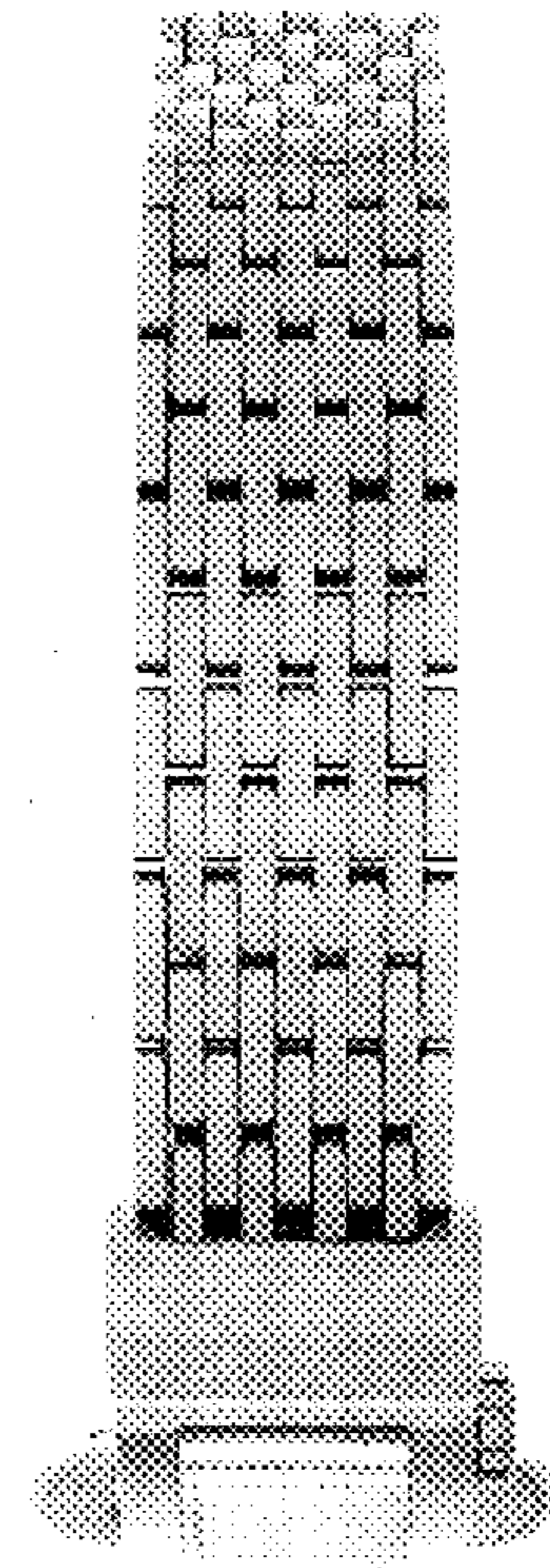
