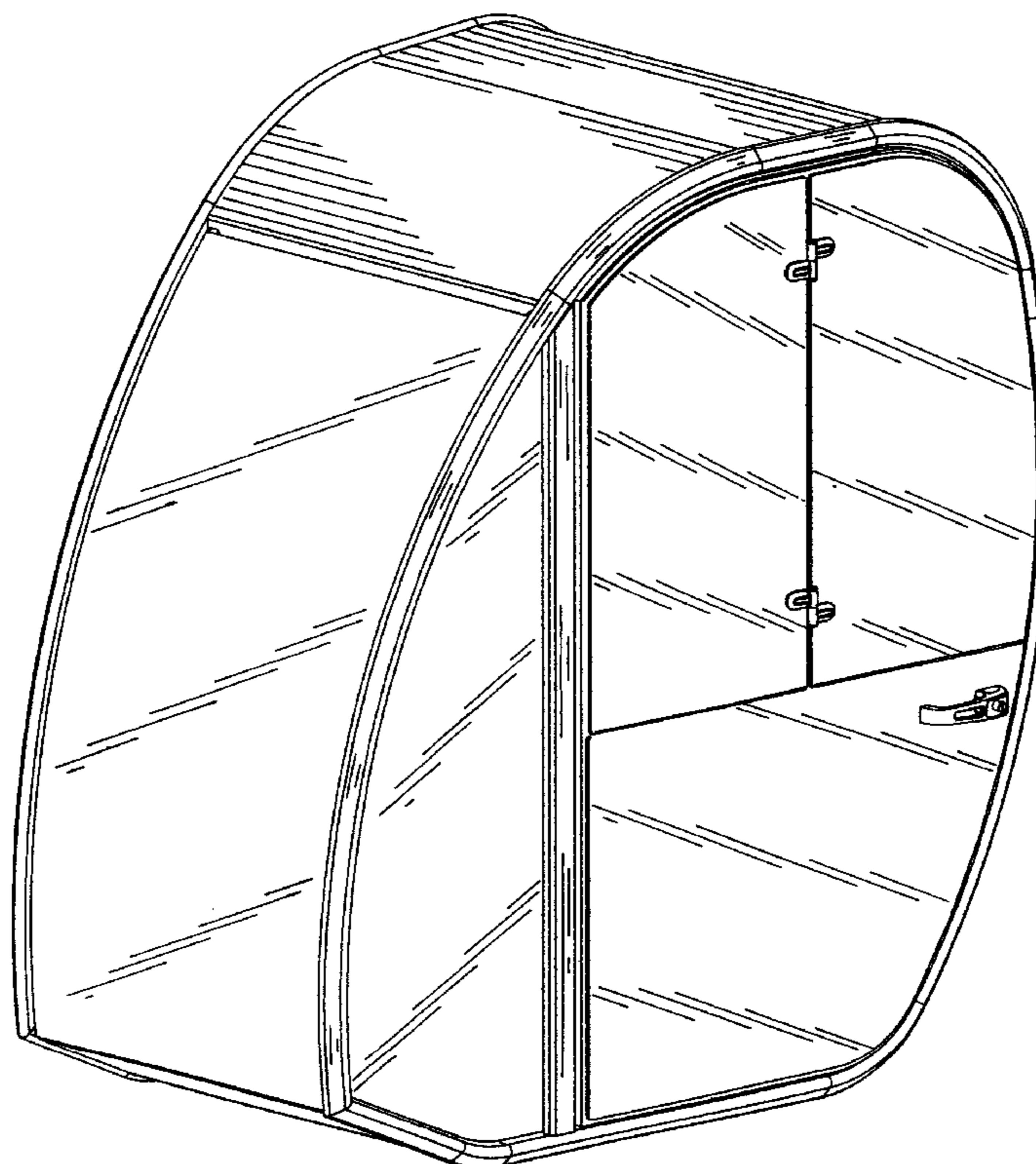
(57) **CLAIM**

I claim the ornamental design for an off highway mobile
equipment cab, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of the off highway mobile
equipment cab showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;

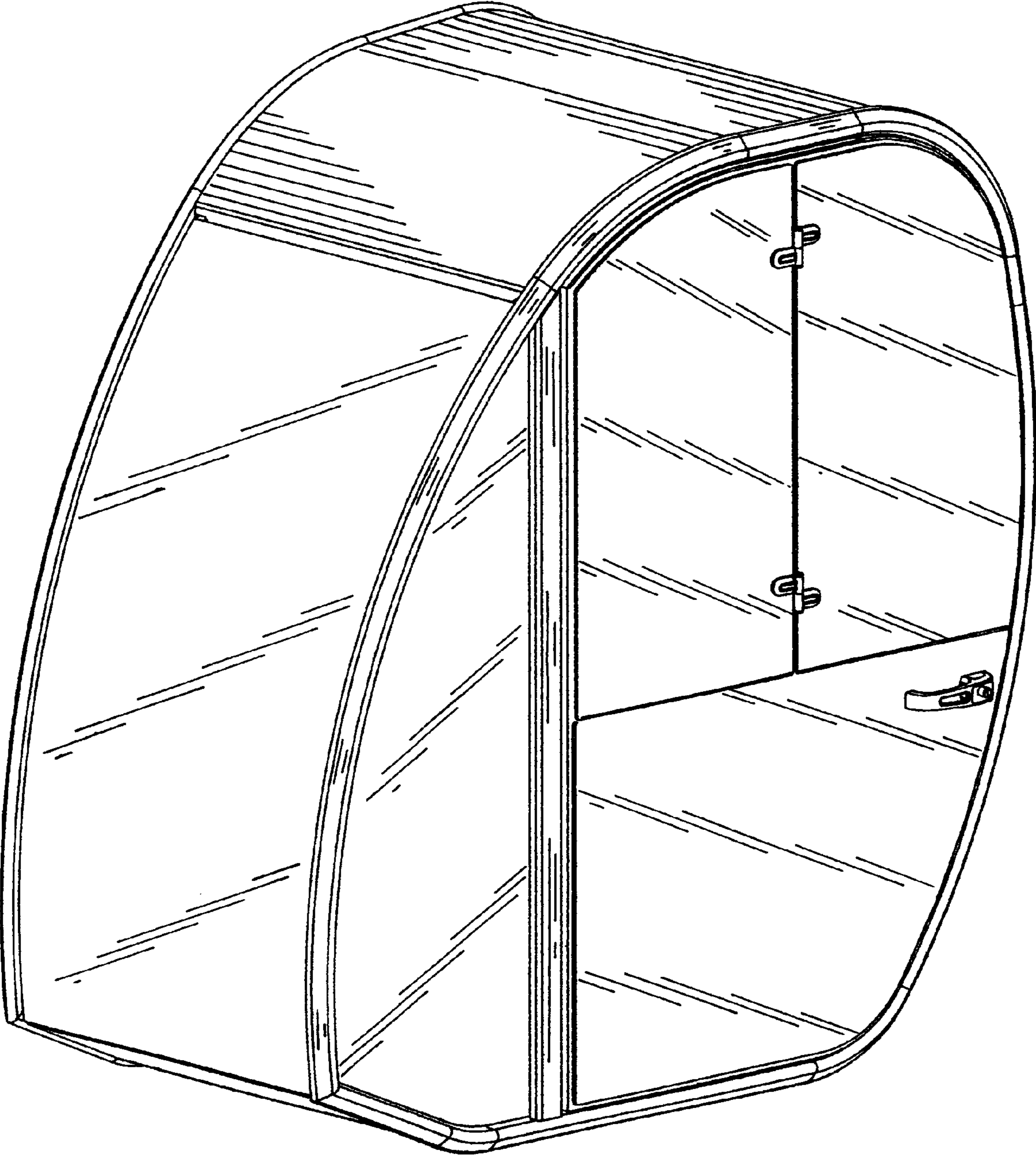

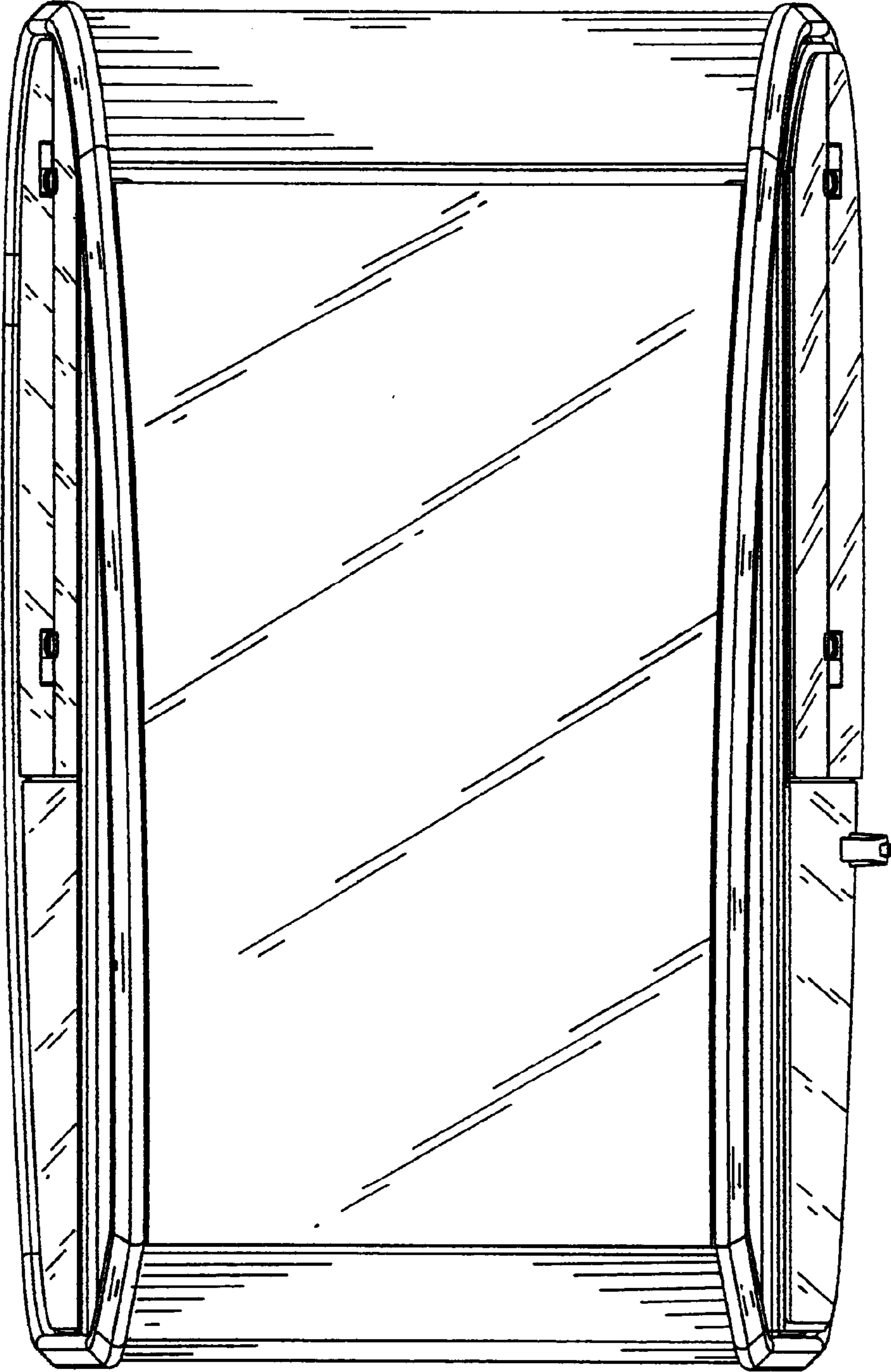

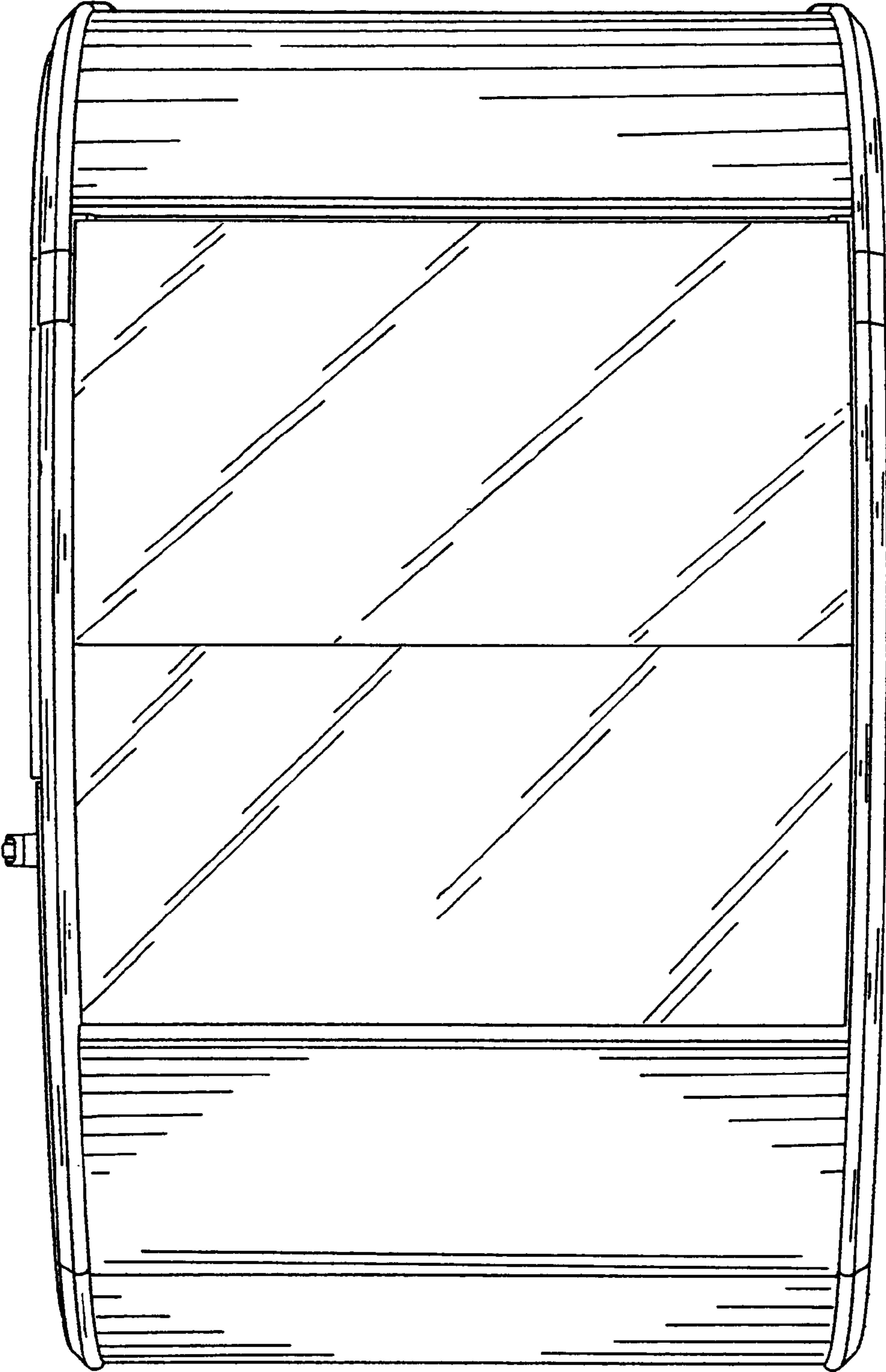

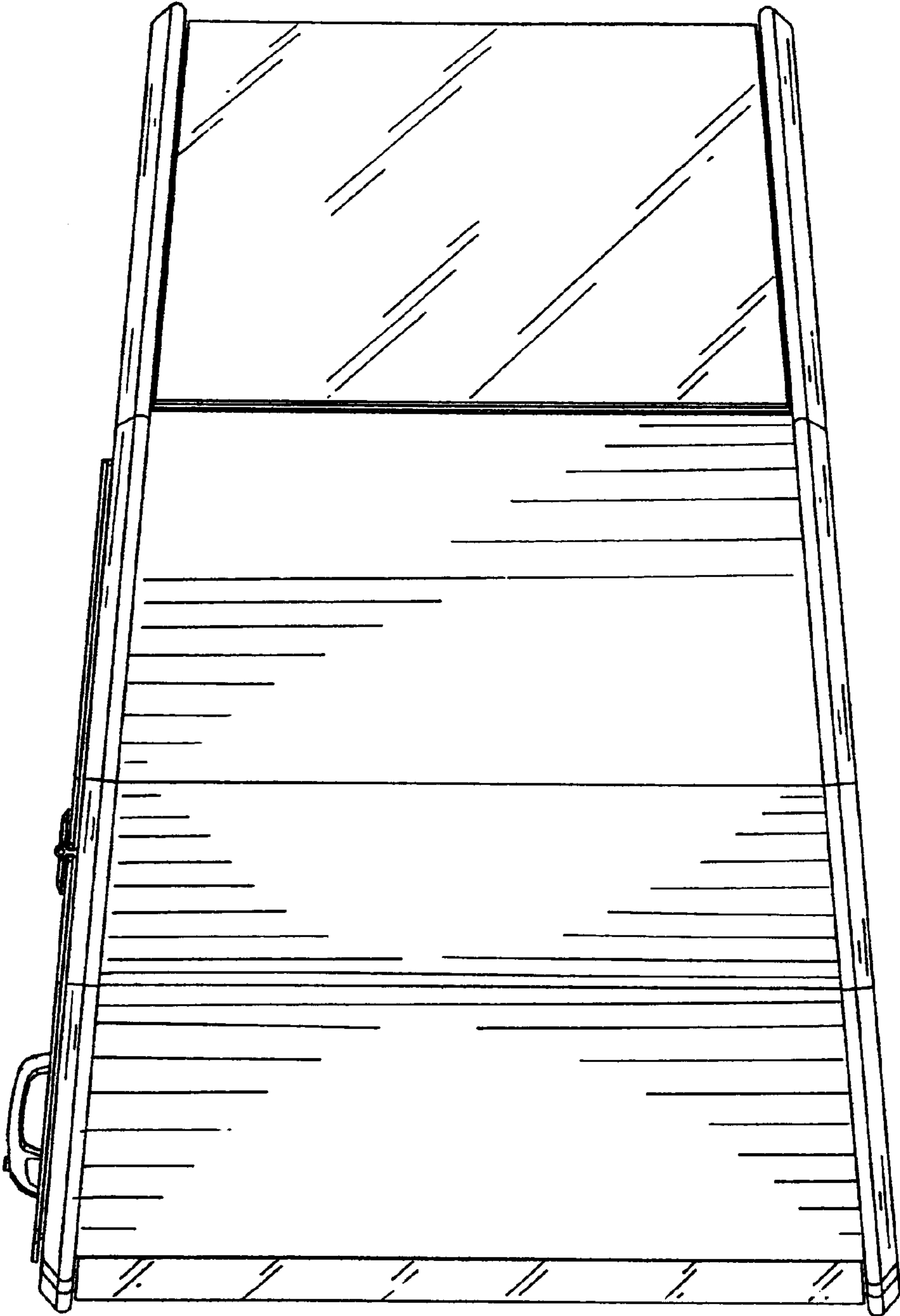

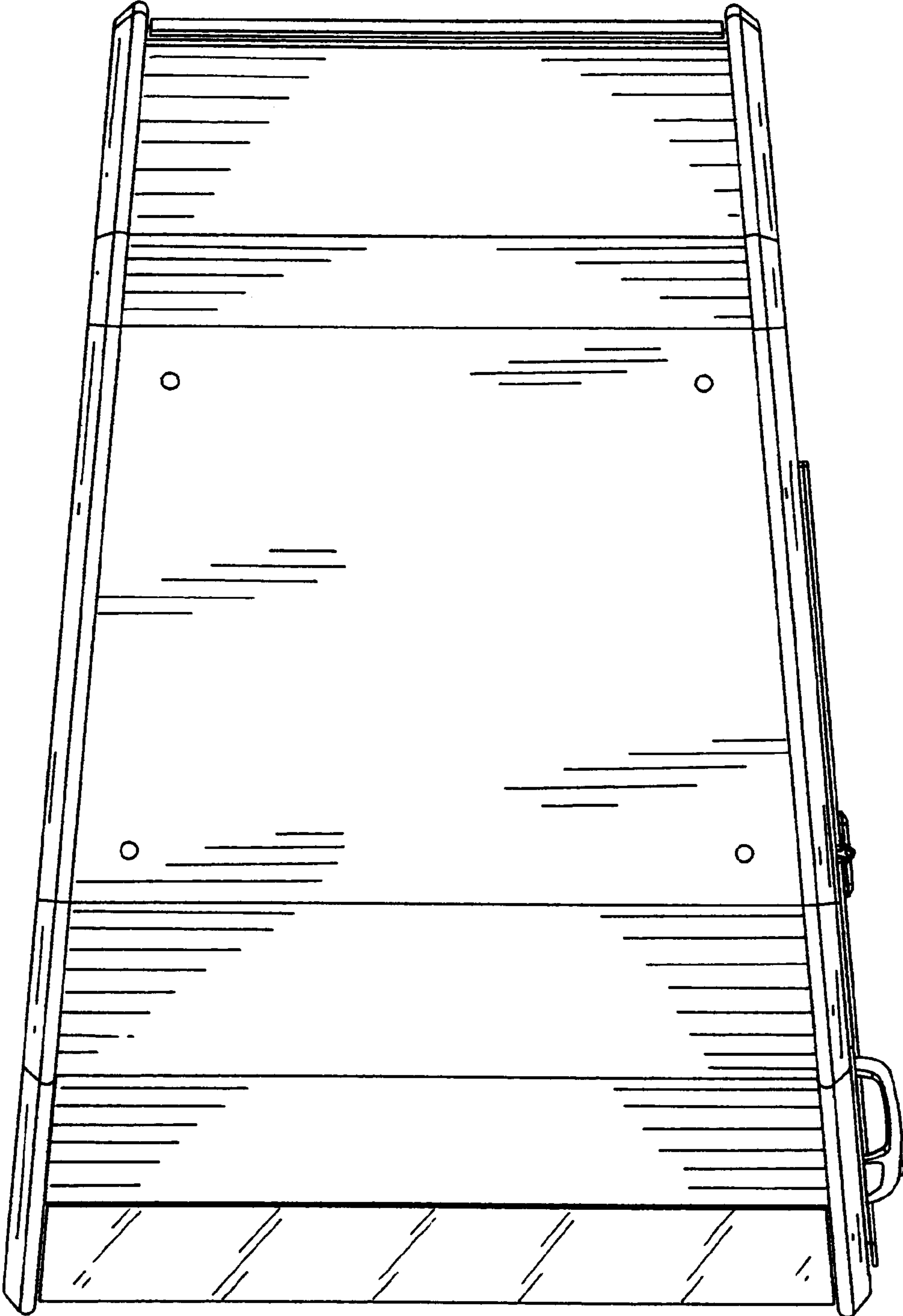

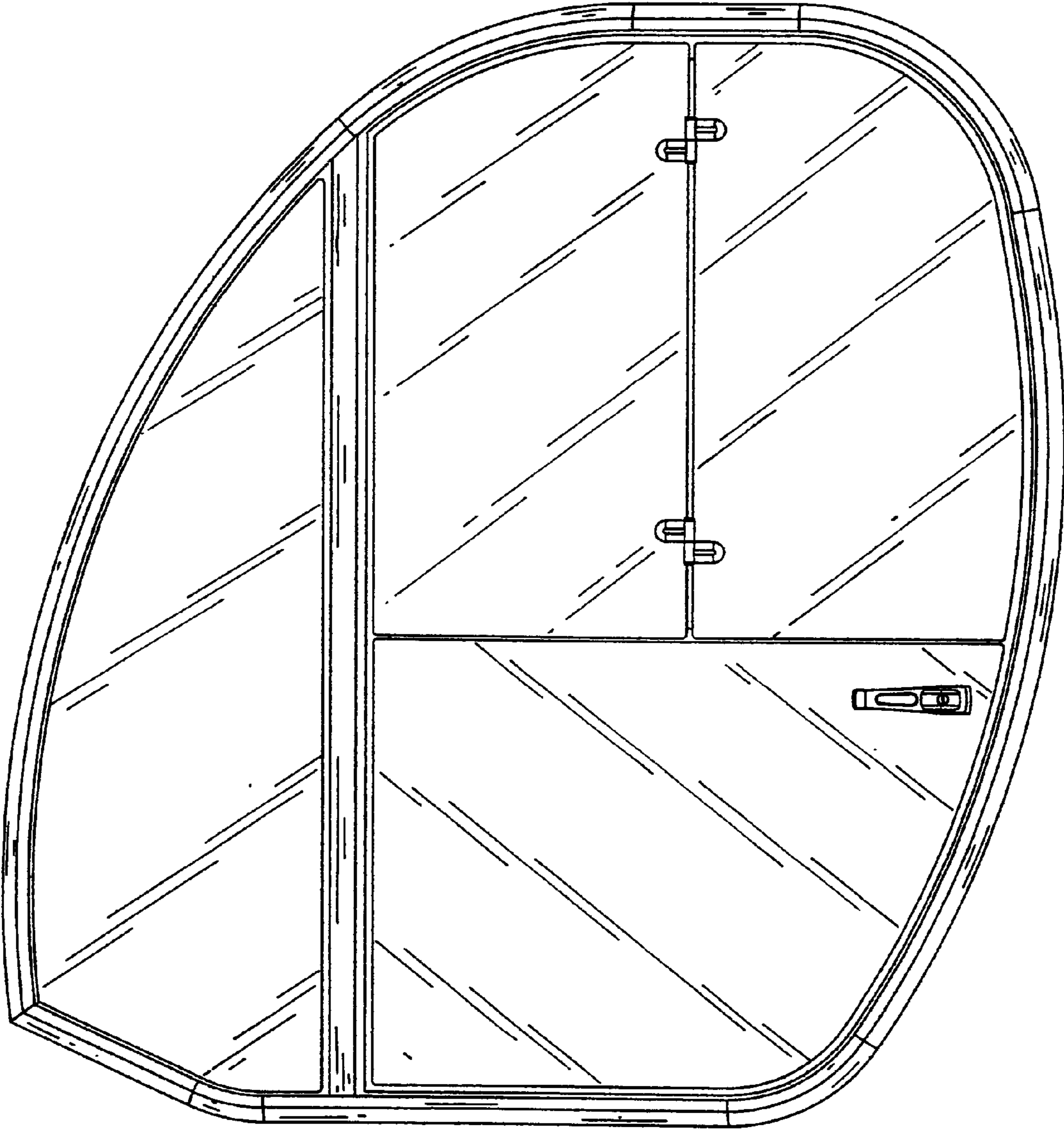

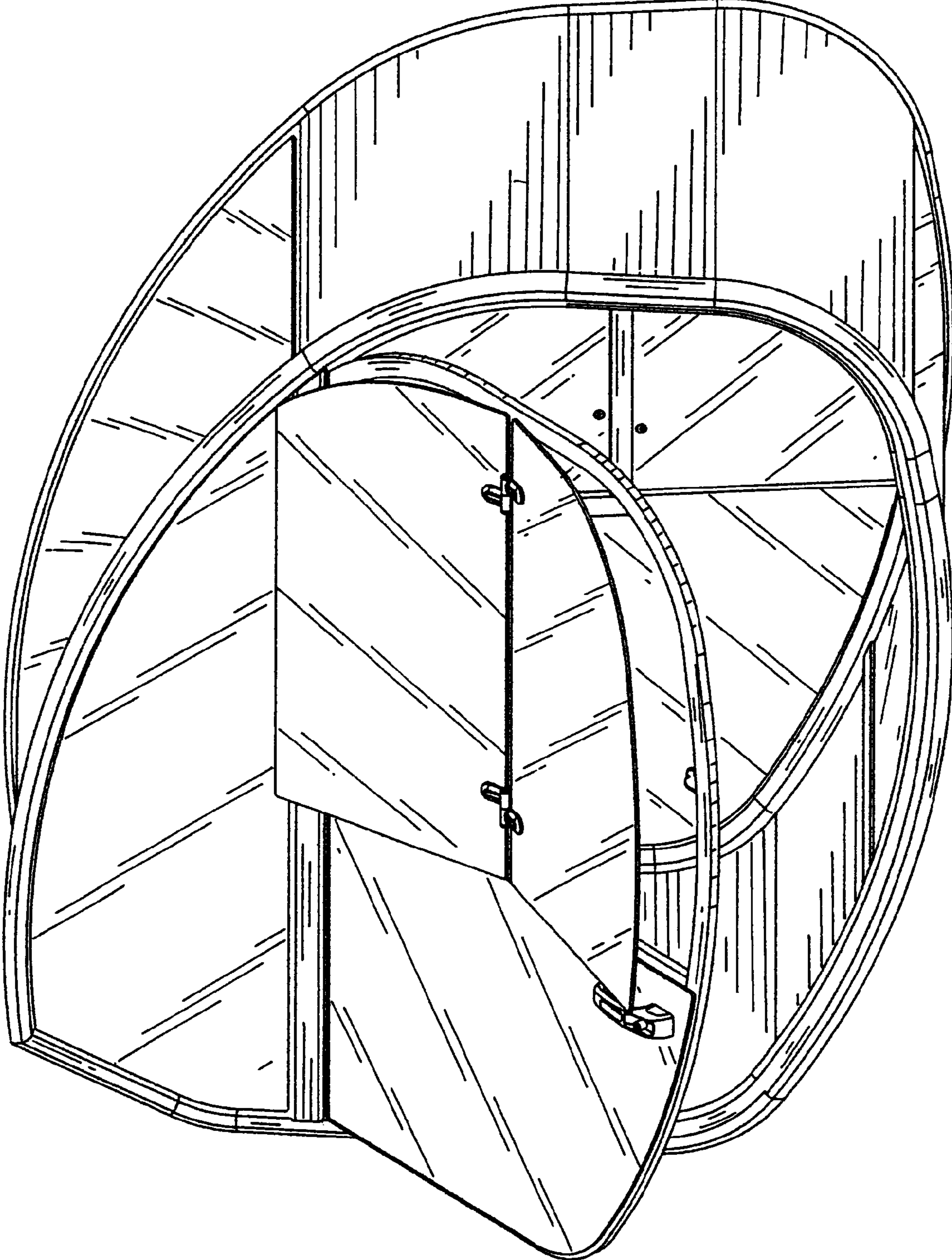

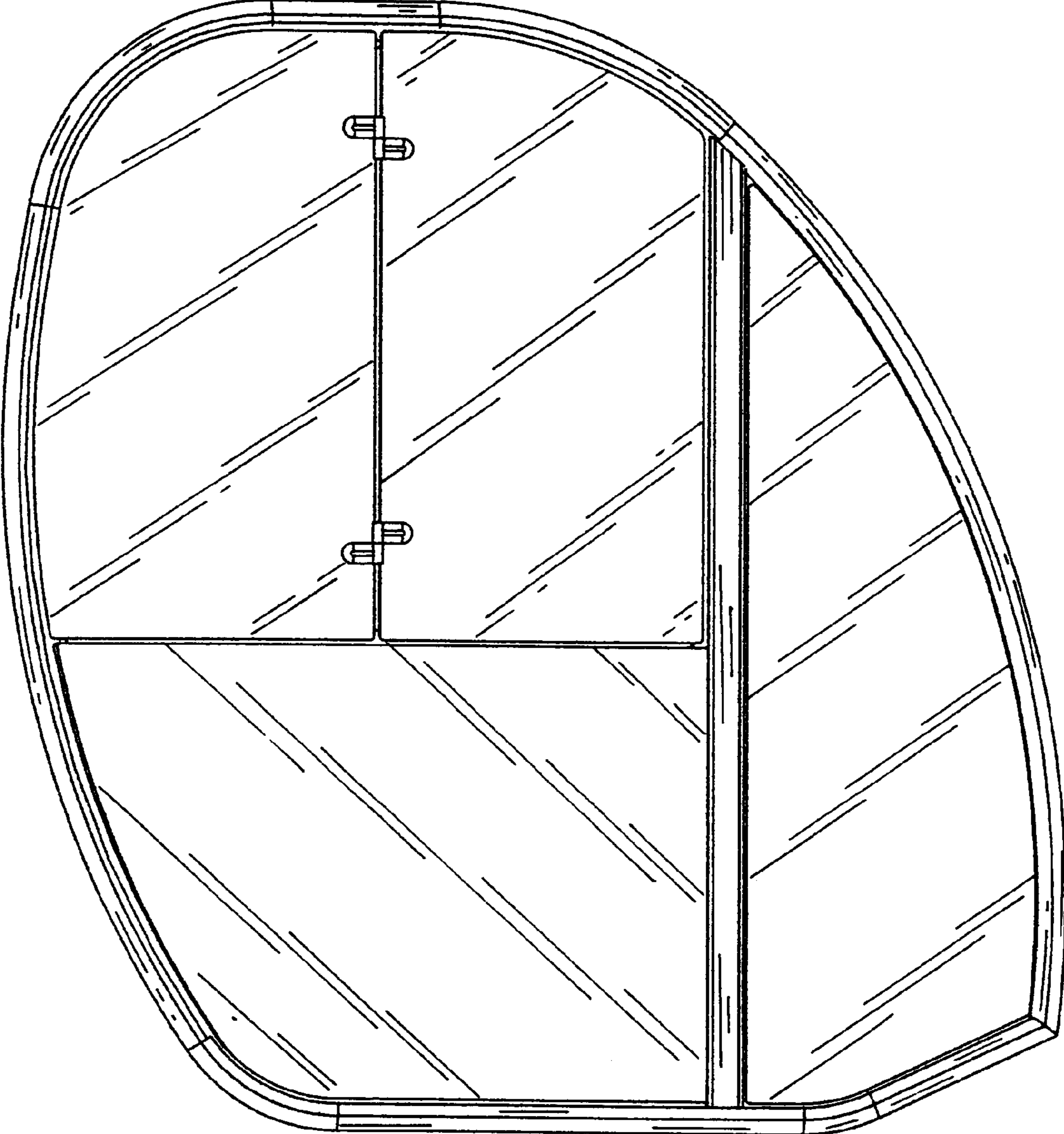
