The ornamental design for a credit or stored value card with wood layer, as shown and described.

**DESCRIPTION**

FIG. 1 is a view in perspective of a credit or stored value card with wood layer.

FIG. 2 is a front plan view of the credit or stored value card with wood layer of FIG. 1.

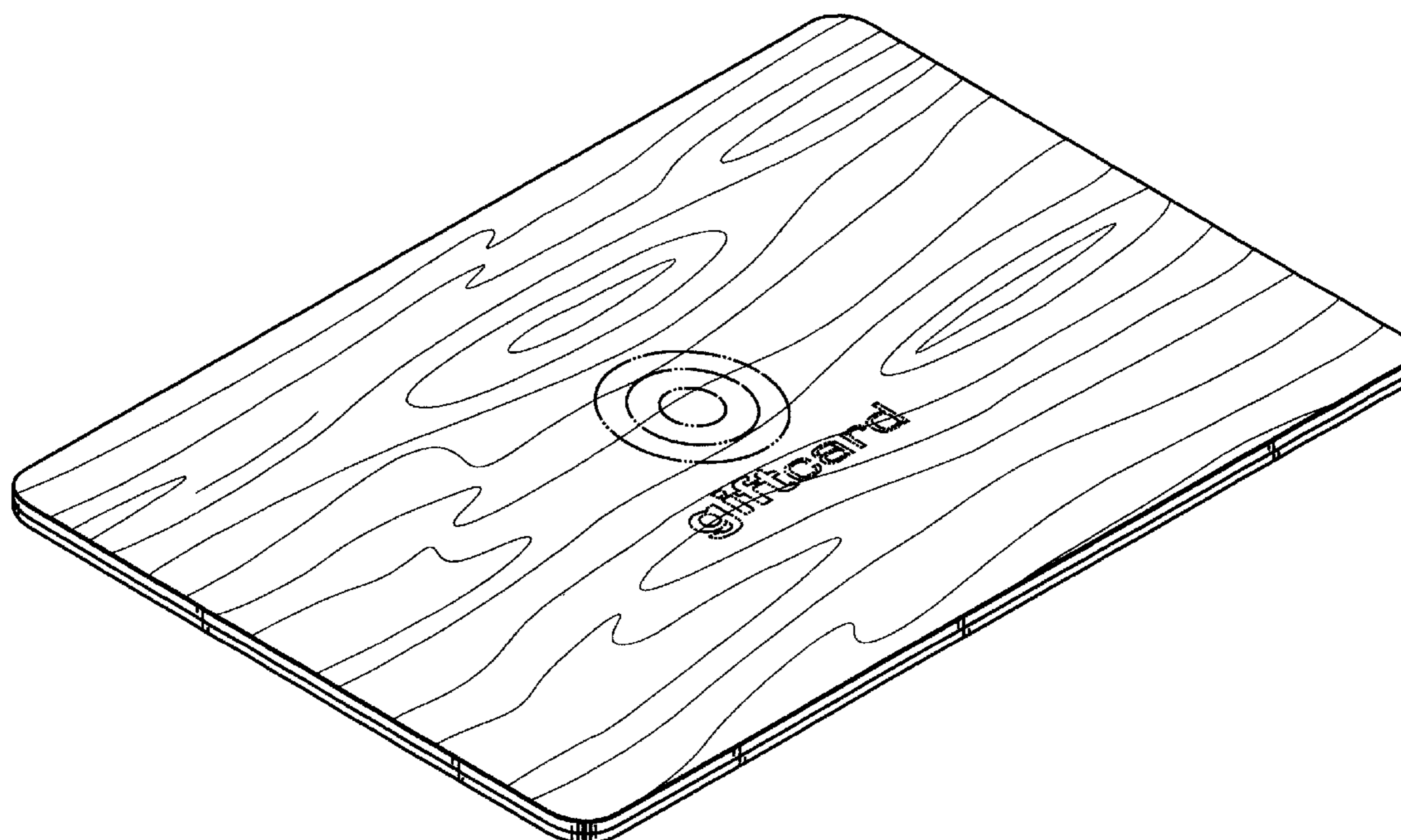
FIG. 3 is a rear plan view of the credit or stored value card with wood layer of FIG. 1.

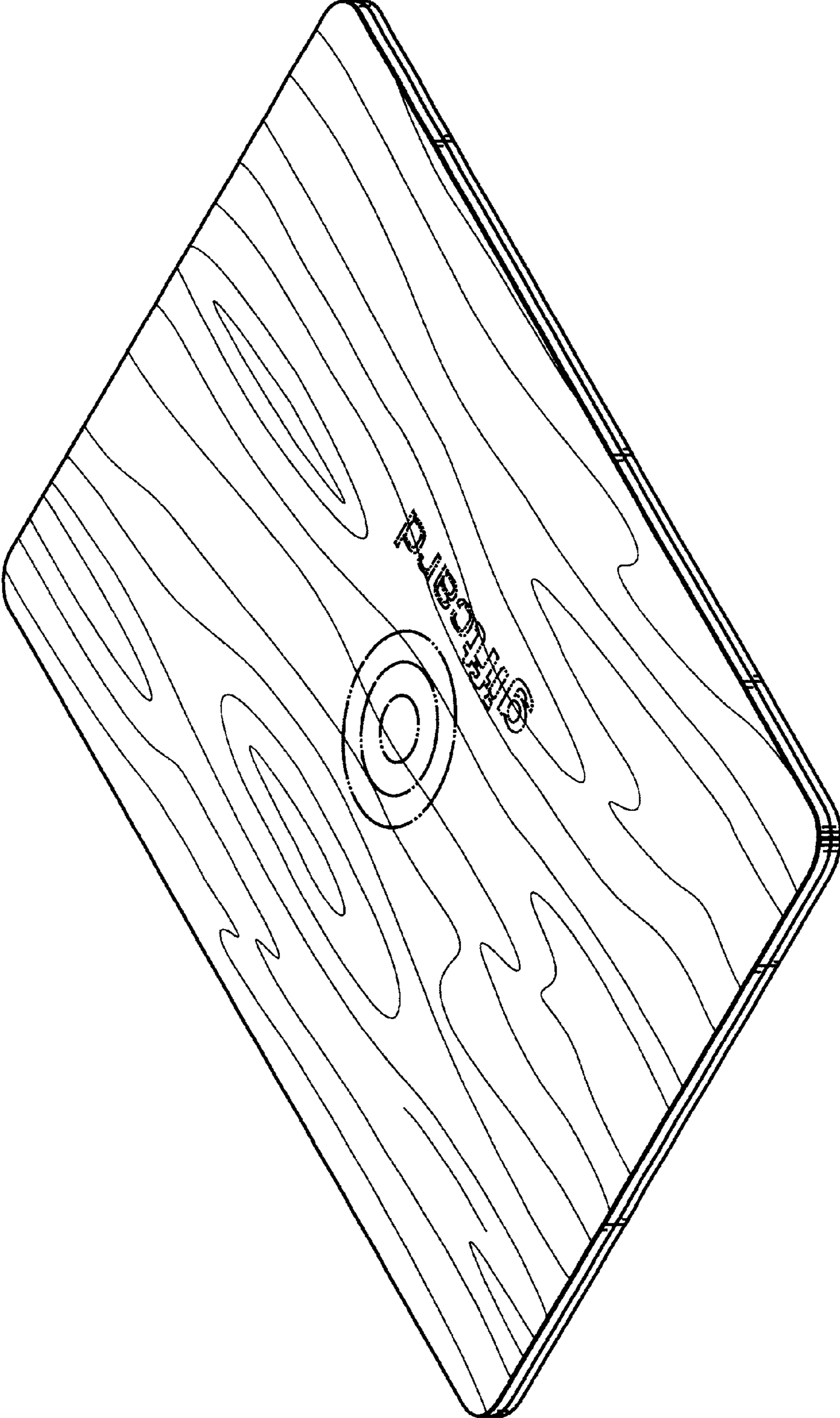

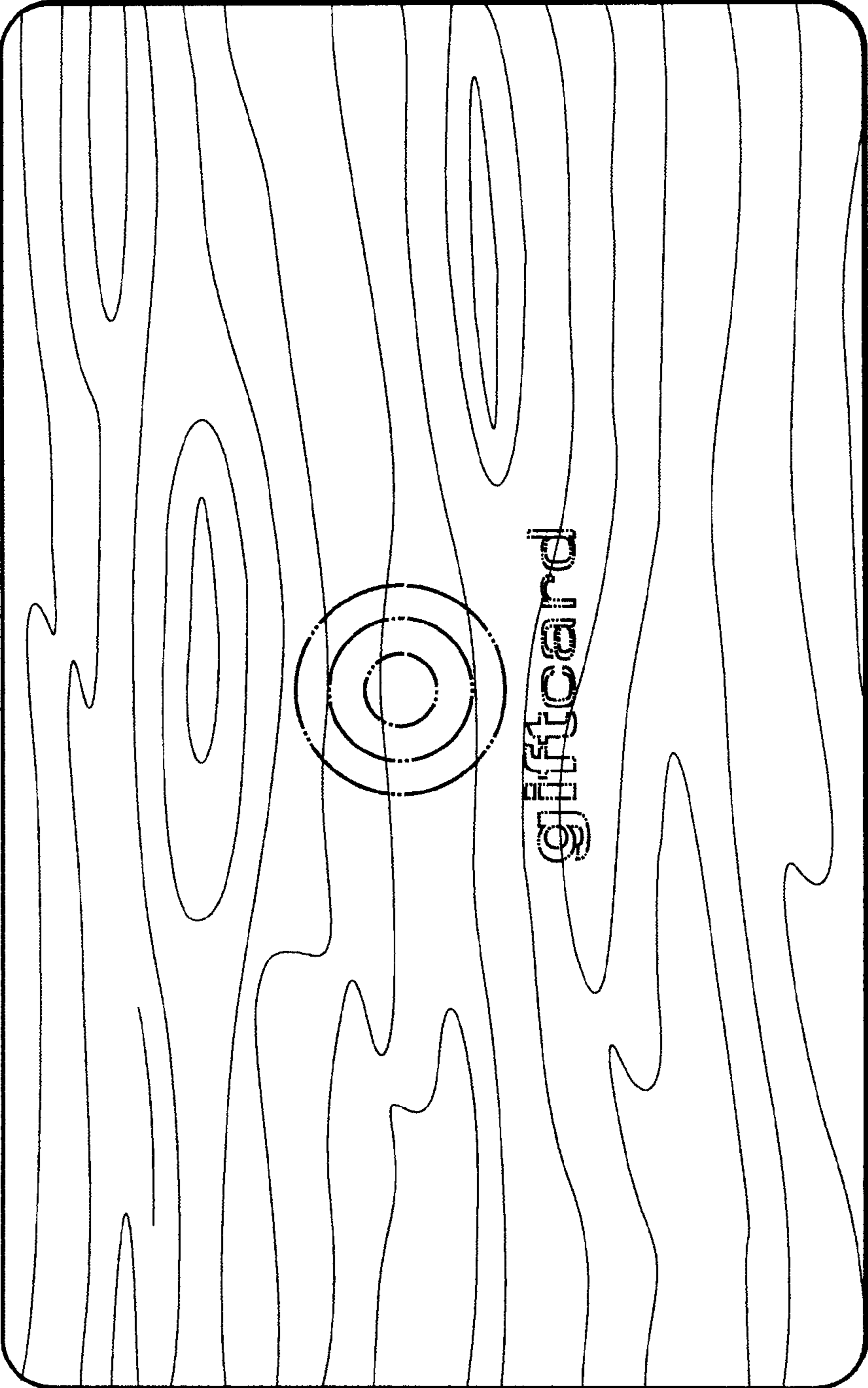

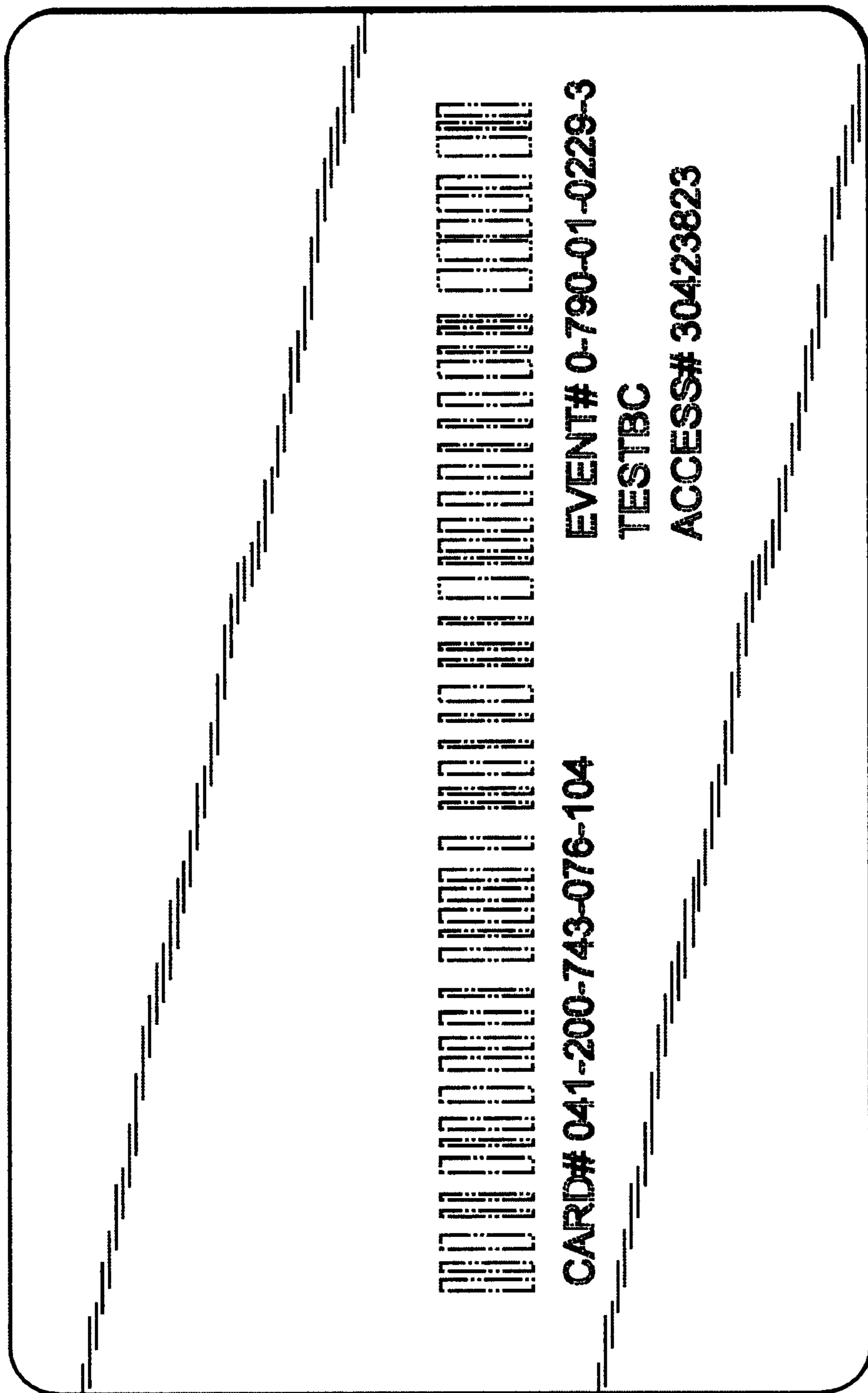
