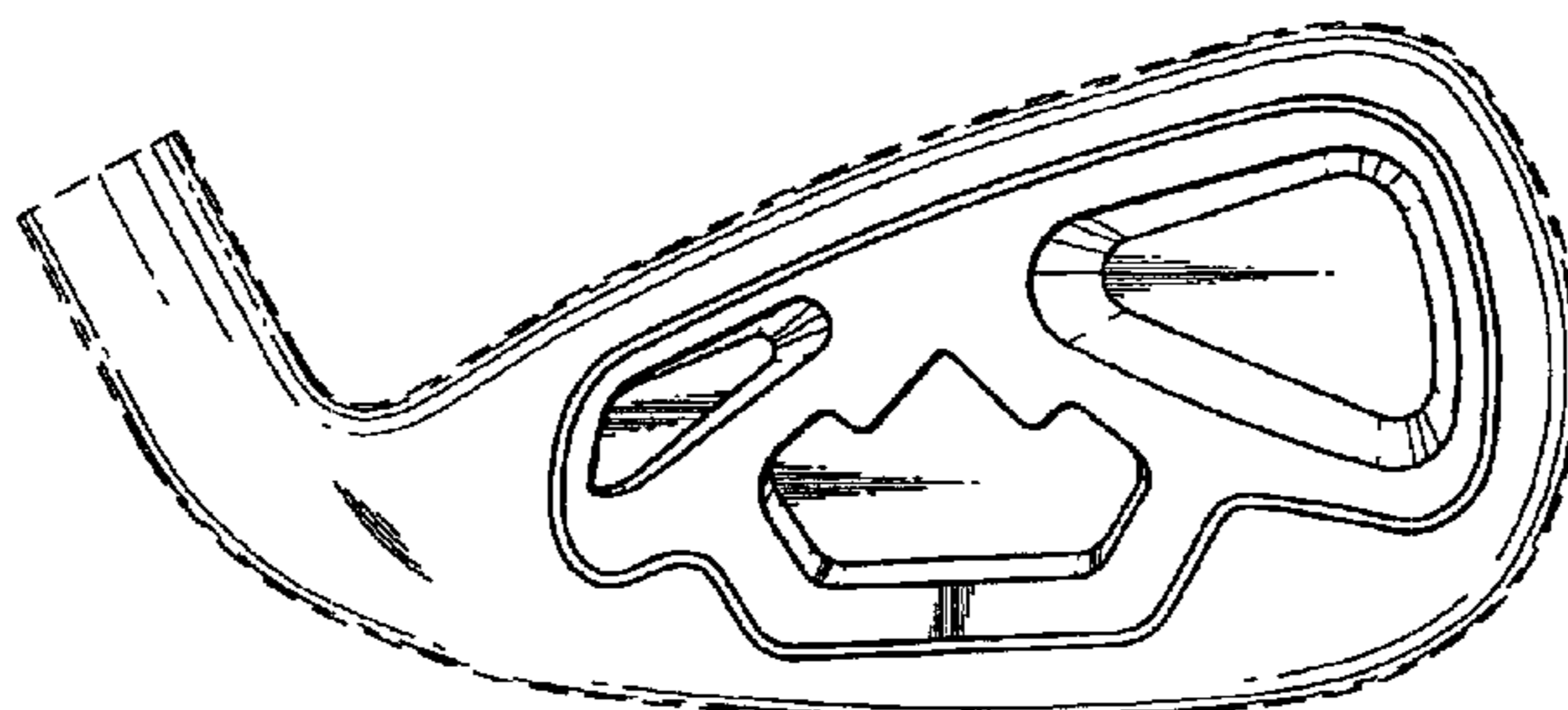
(57) **CLAIM**

The ornamental design for an iron golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the golf club head as claimed herein;
FIG. 2 is a rear elevational view of the golf club head thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a heel end view thereof; and,
FIG. 6 is a toe end view.
The broken line showing is for illustrative purposes only and forms no part of the claimed design.

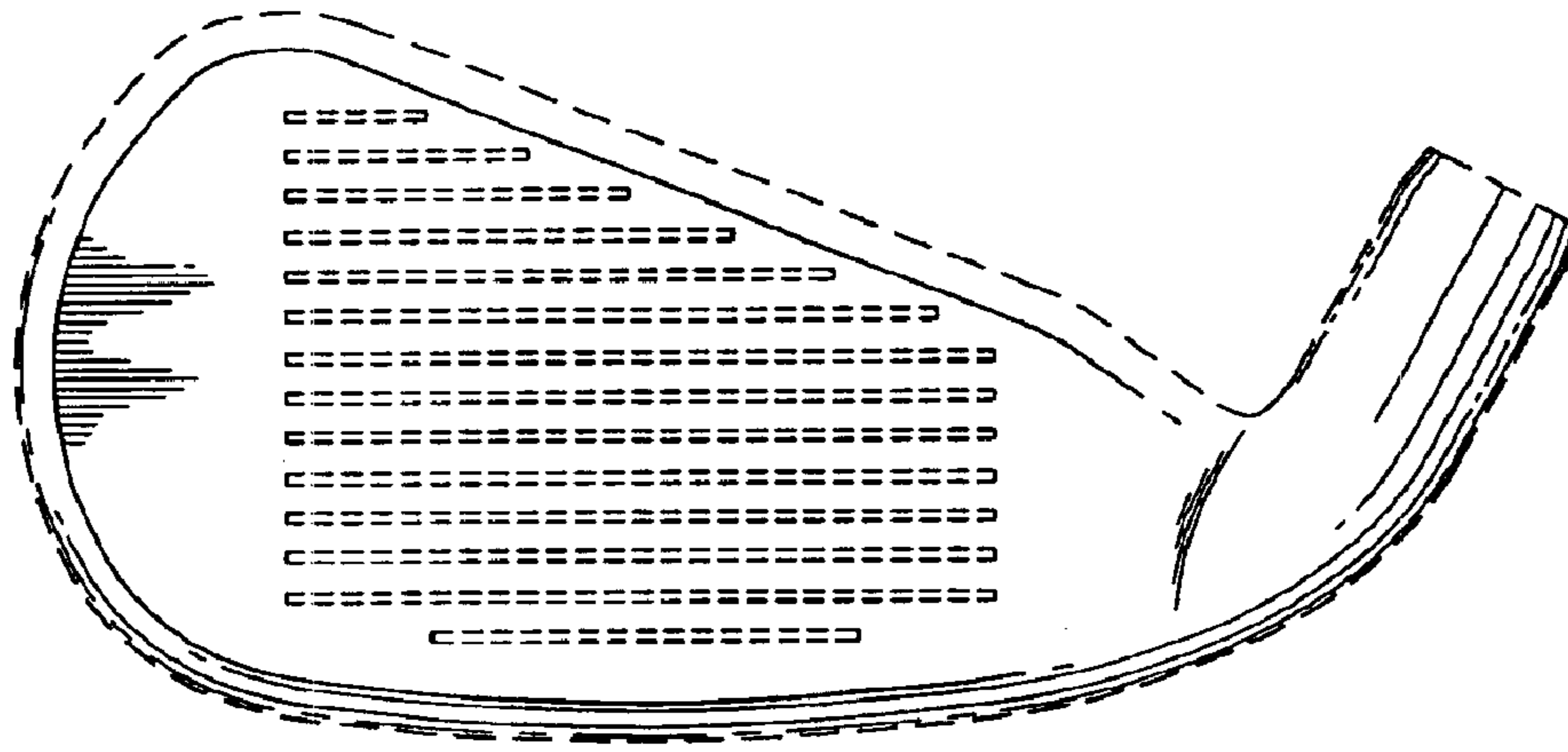

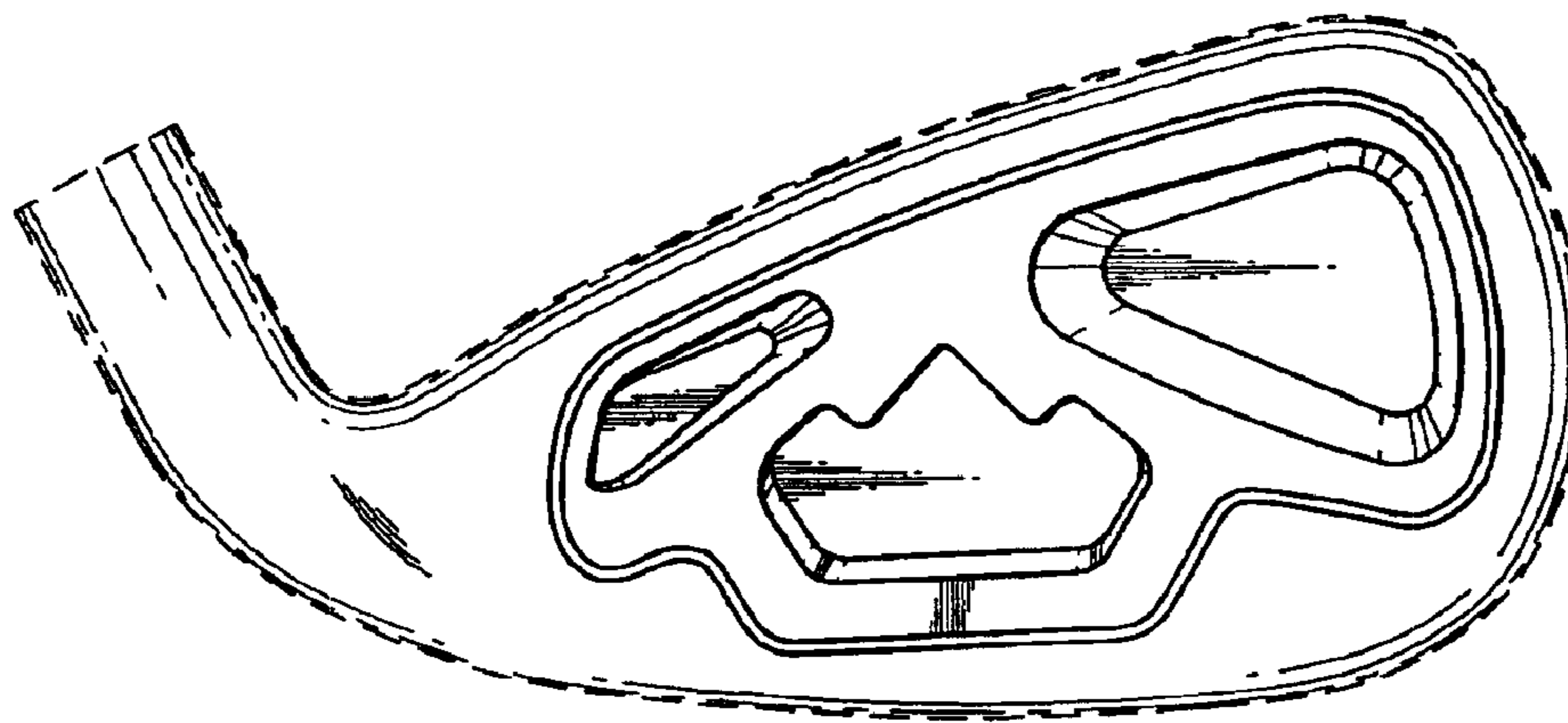

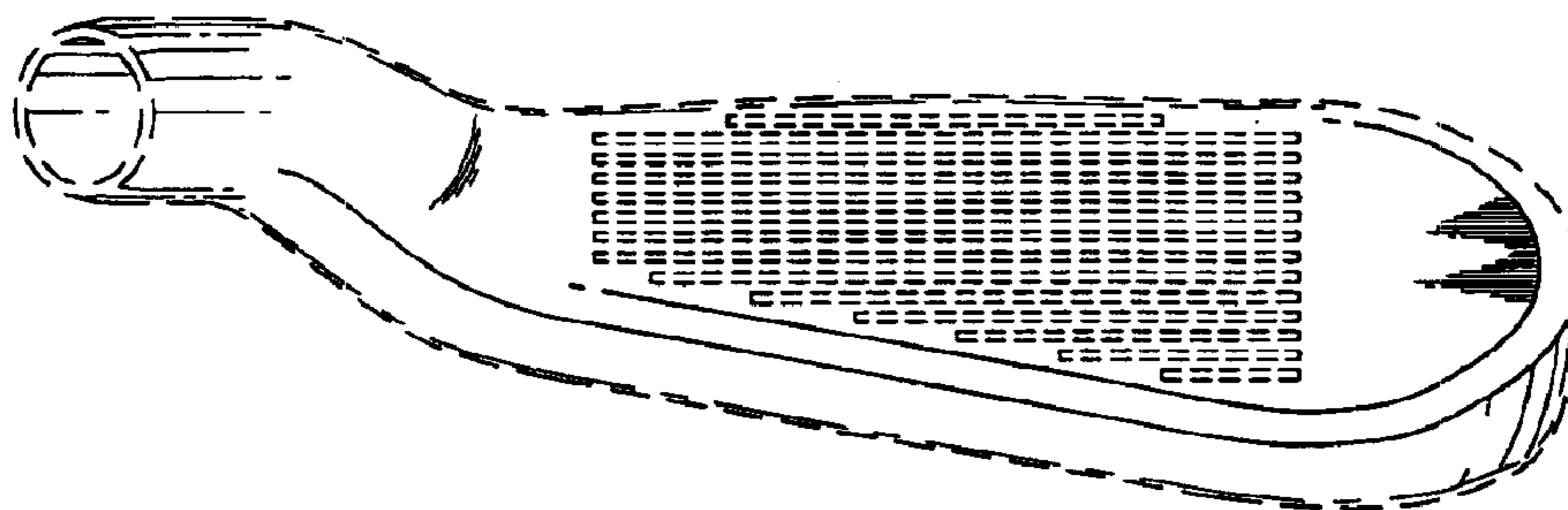

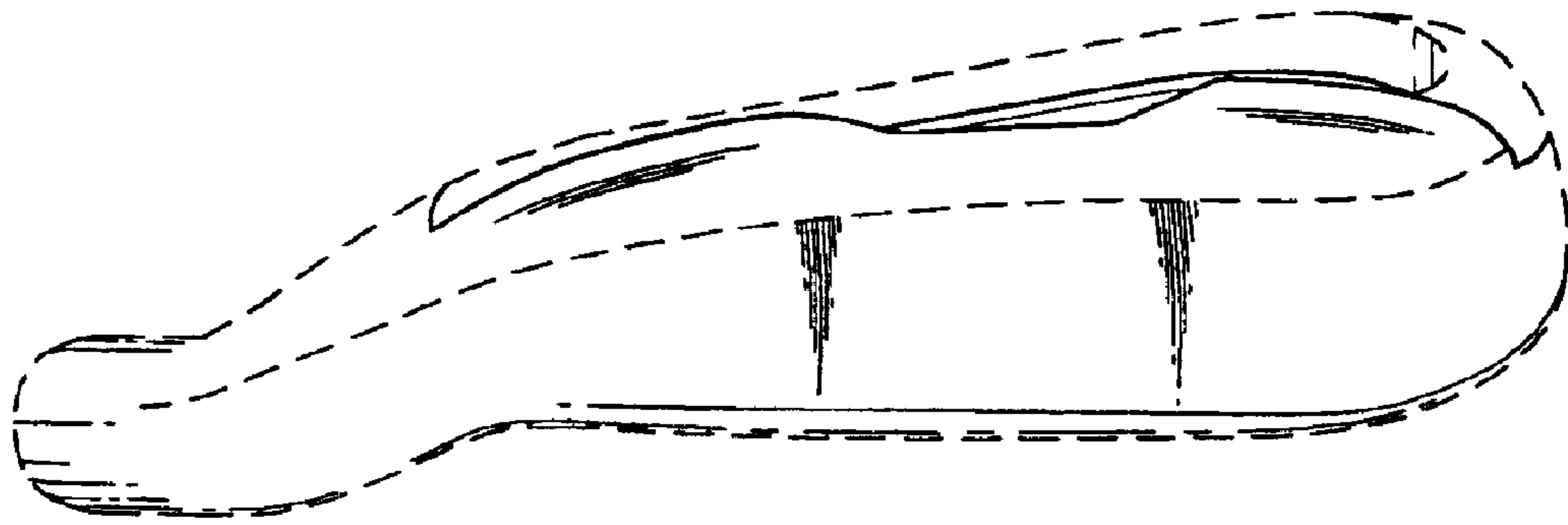

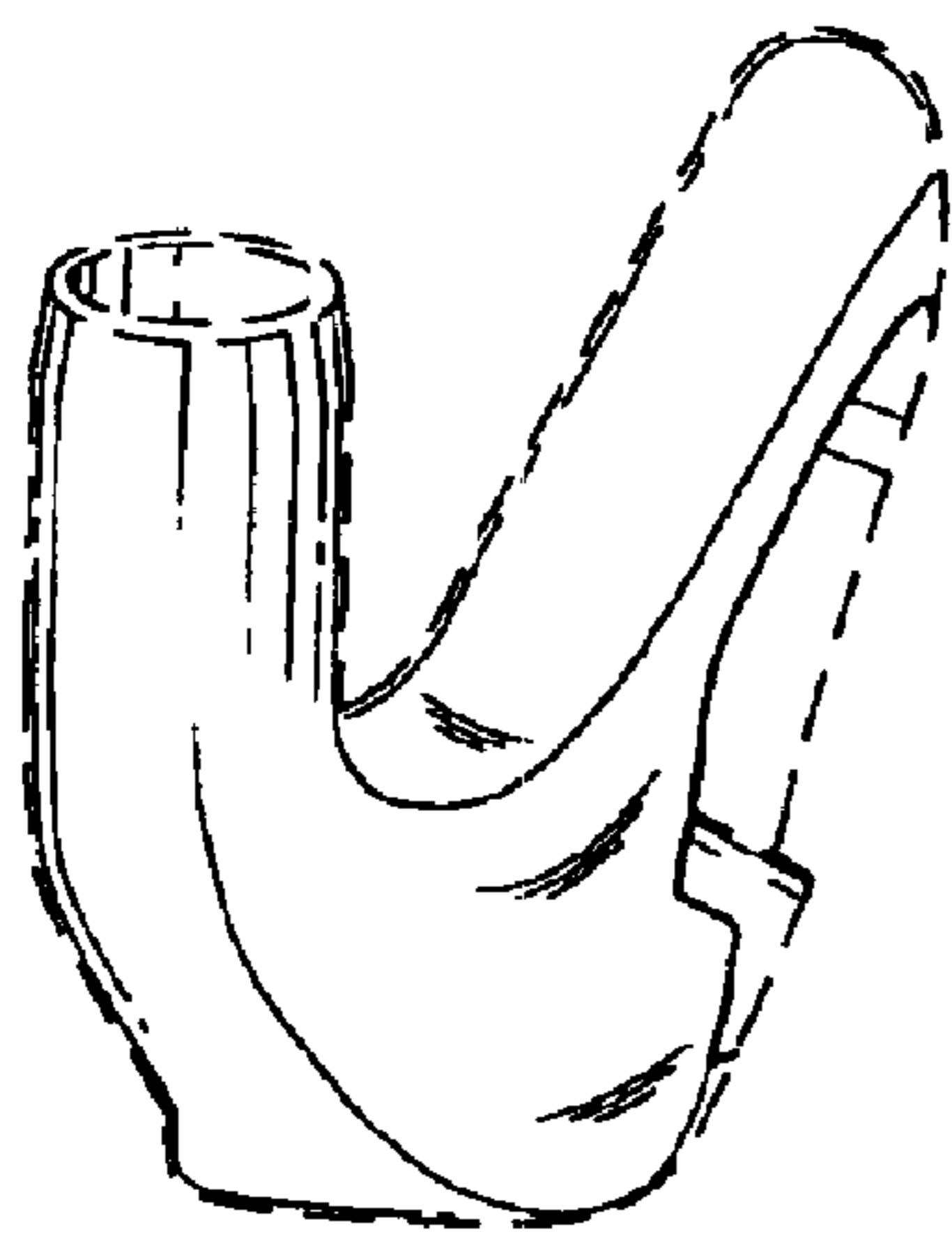

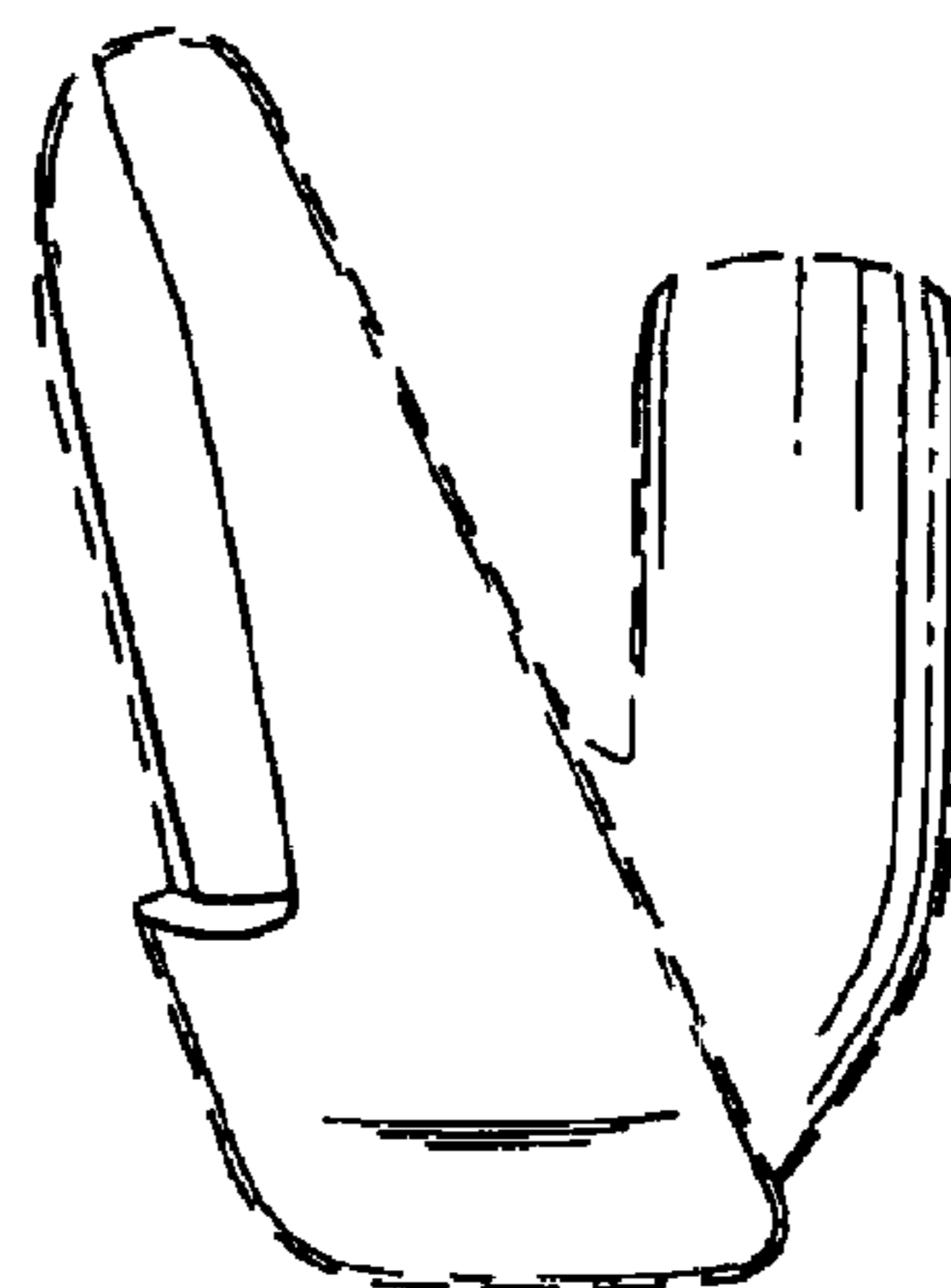
