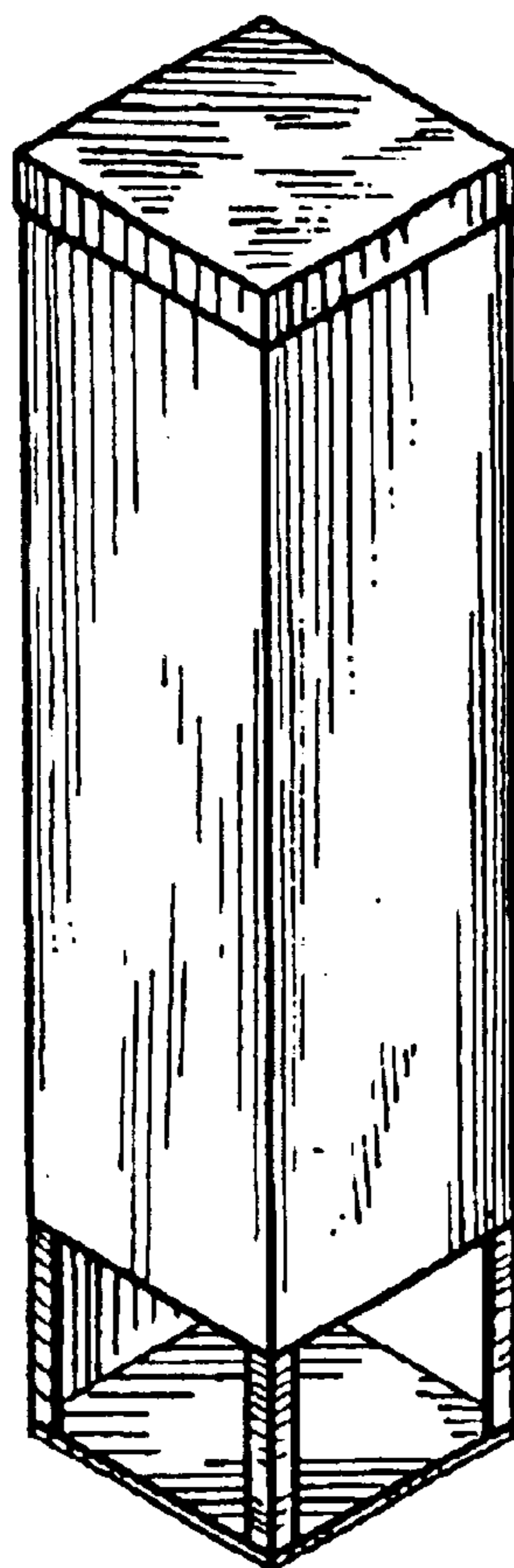
(57) **CLAIM**

The ornamental design for a dispenser for stacked blocks of animal feed, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and side perspective view of a dispenser for stacked blocks of animal feed, showing my new design; FIG. 2 is a front view thereof; FIG. 3 is a side view thereof, the unshown opposite side being of identical appearance; and, FIG. 4 is a rear view thereof.

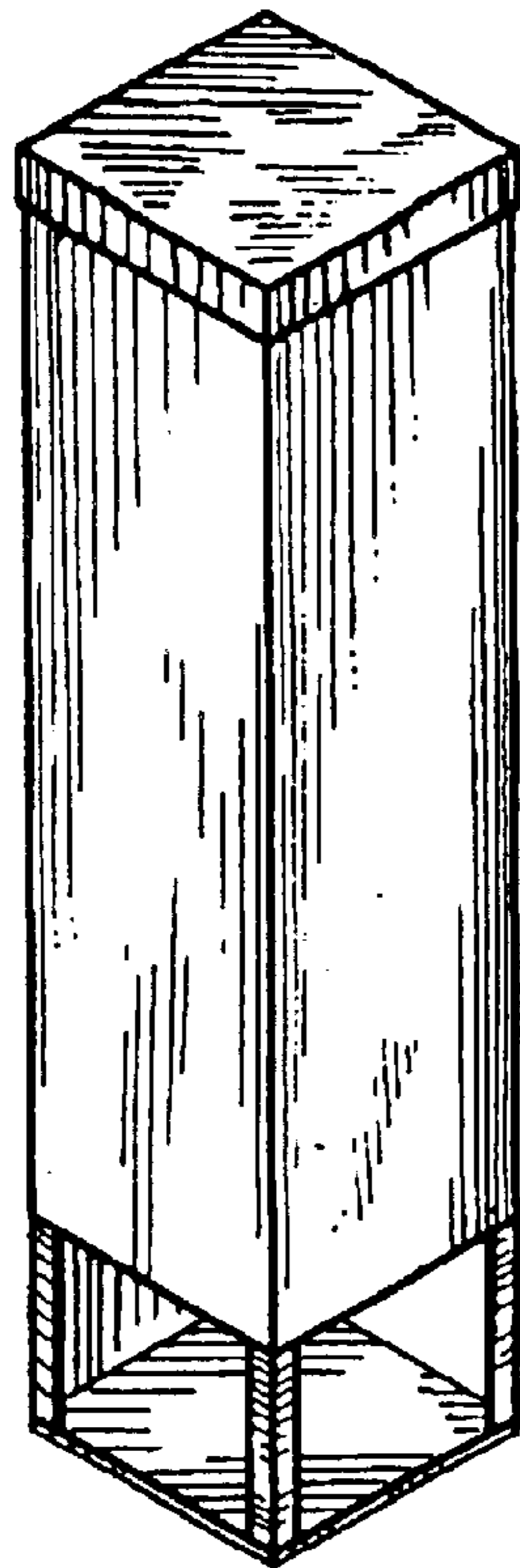

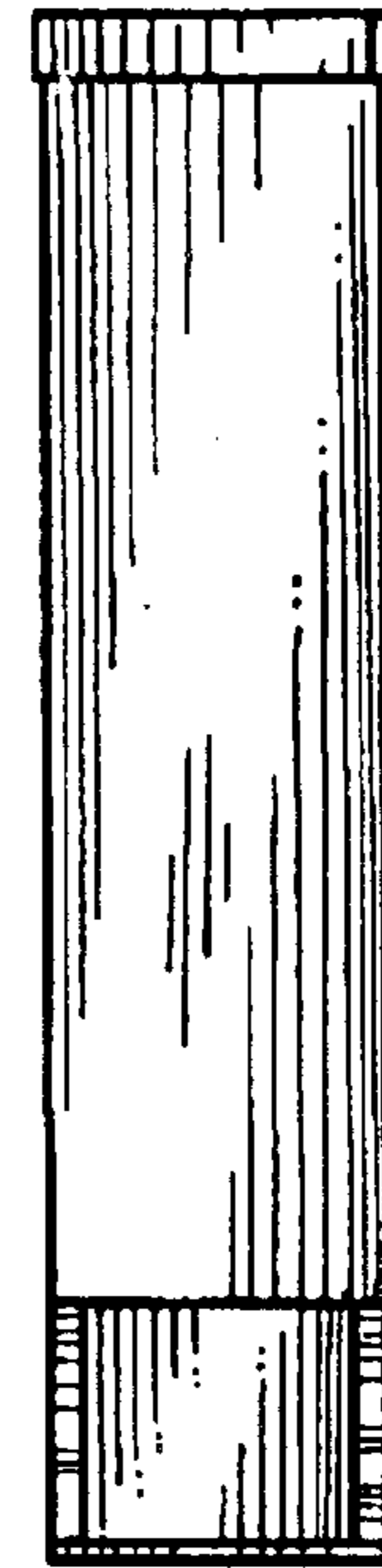

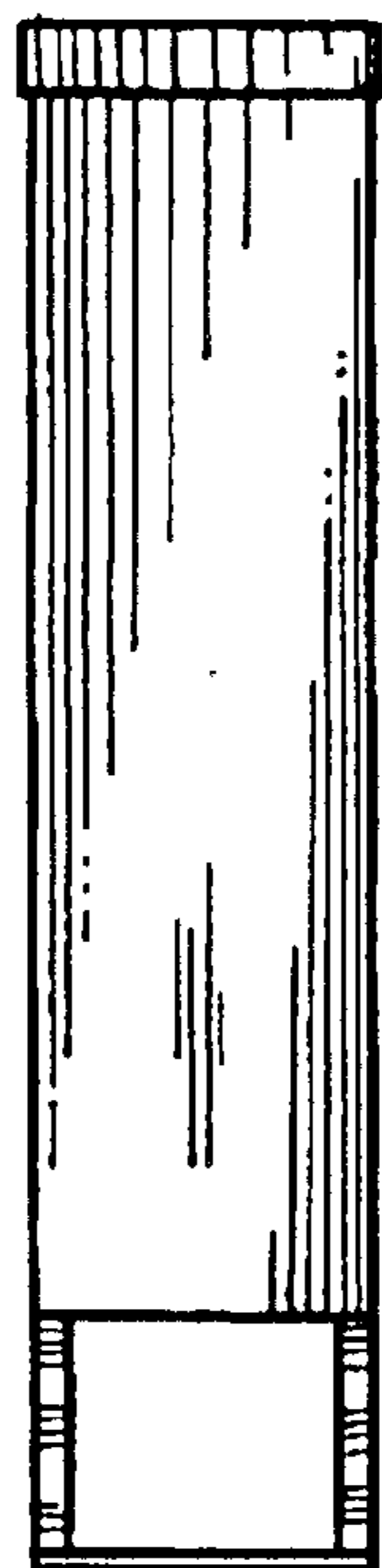

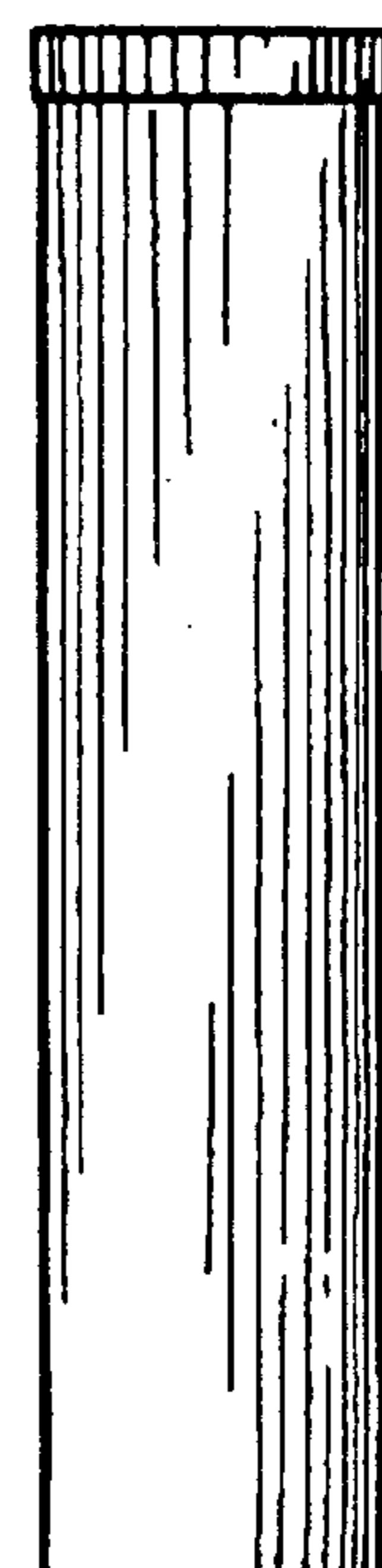
