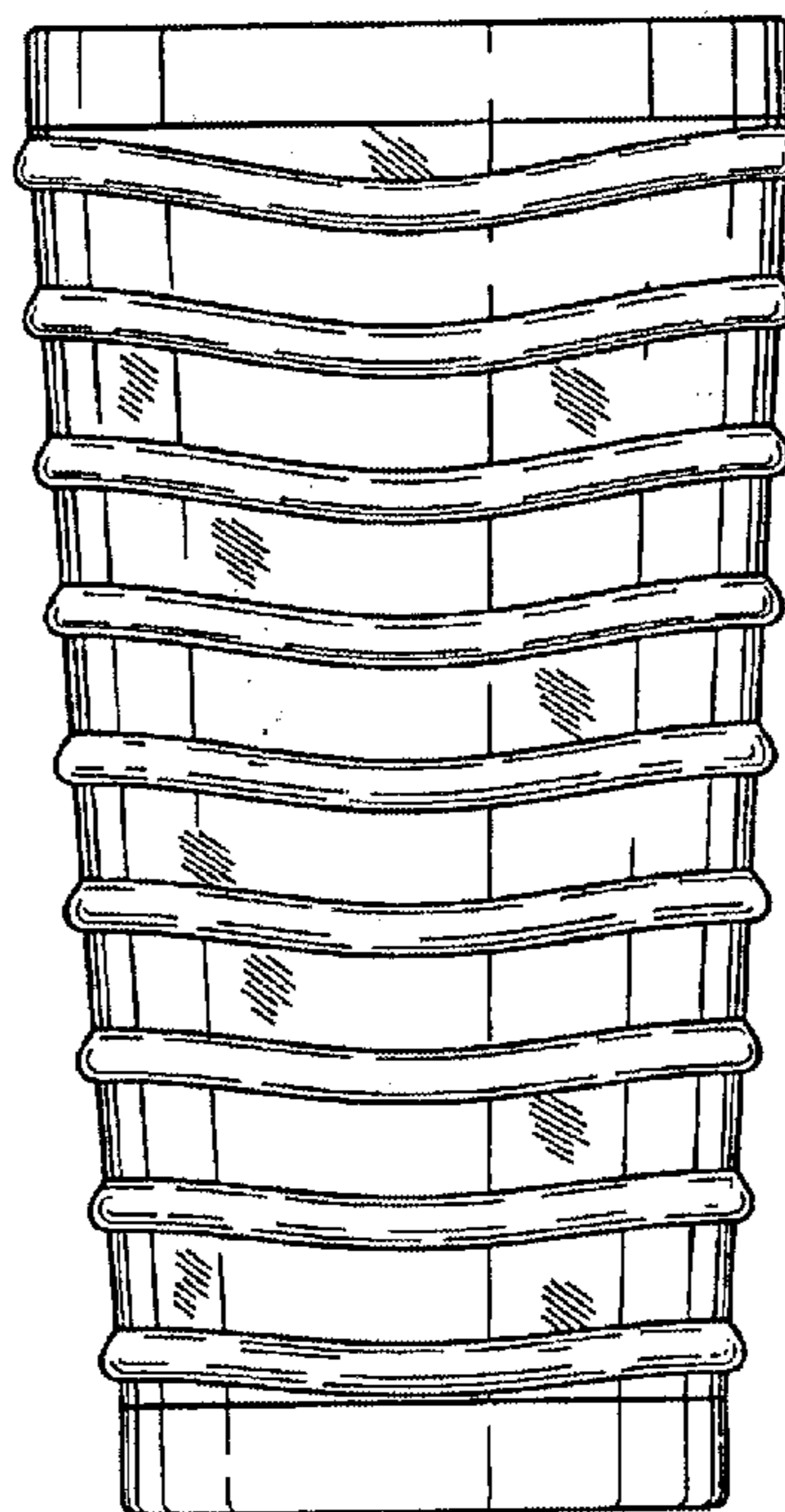
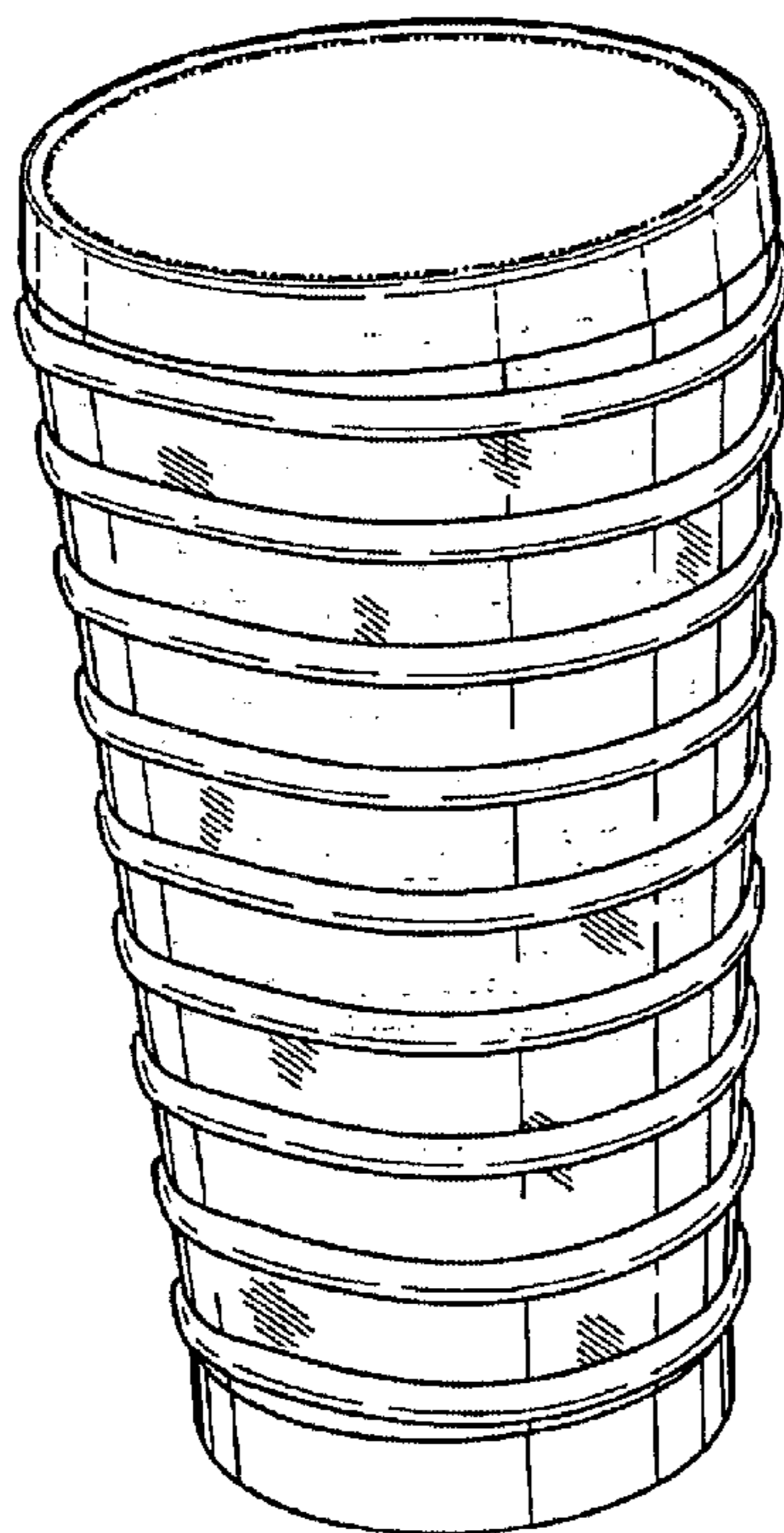
(57) **CLAIM**

I claim the ornamental design for a drinking vessel with wavy-circular patterning, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a drinking vessel with wavy-circular patterning showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a front elevational view thereof, the rear elevational view being a mirror image thereof;
 FIG. 5 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;
 FIG. 6 is a perspective view of a second embodiment of drinking vessel with wavy-circular patterning showing my new design;
 FIG. 7 is a front elevational view thereof, the rear elevational view being a mirror image thereof; and,
 FIG. 8 is a right side elevational view thereof, the left side elevational view being a mirror image thereof.
 The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design.

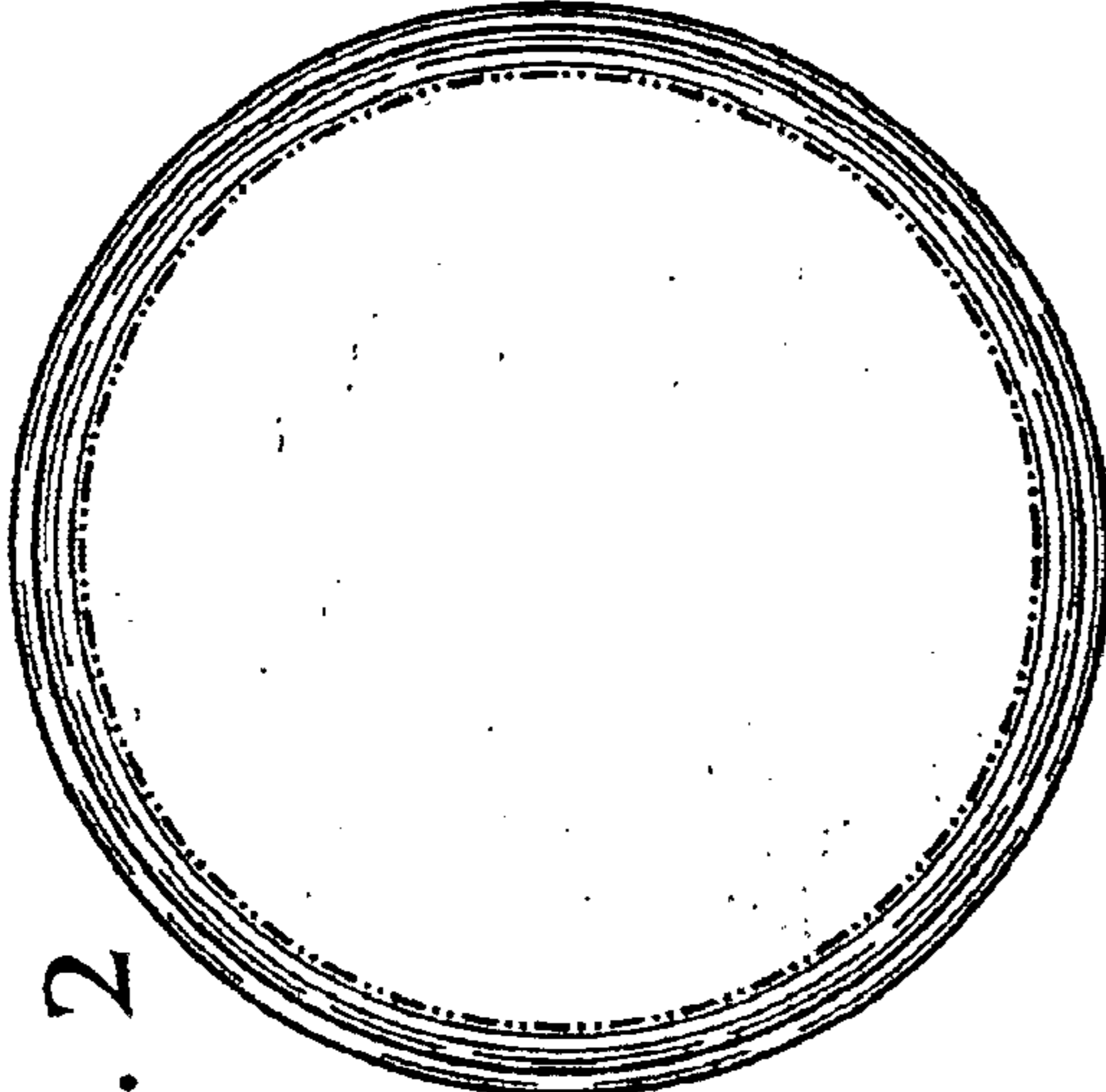

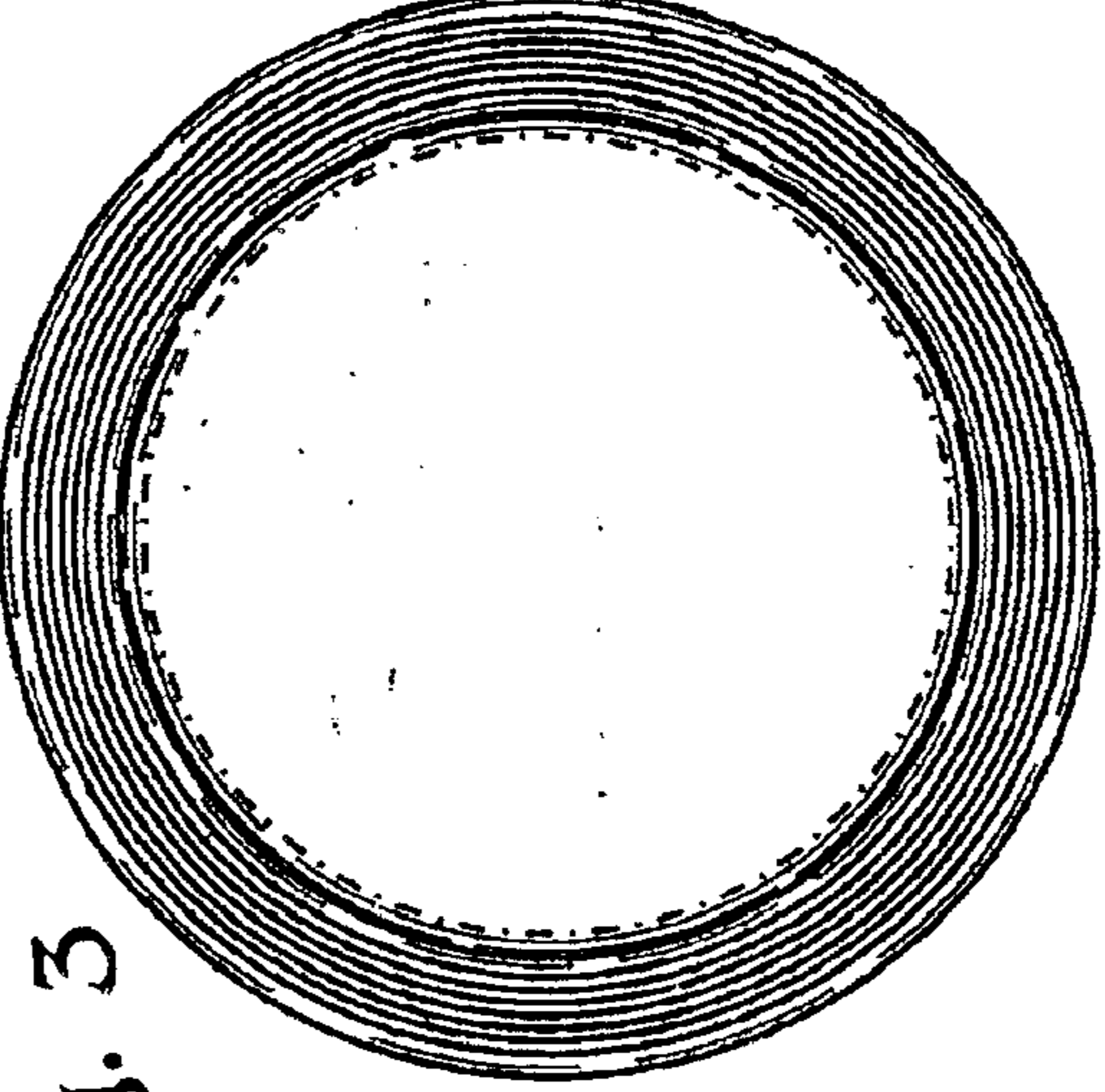

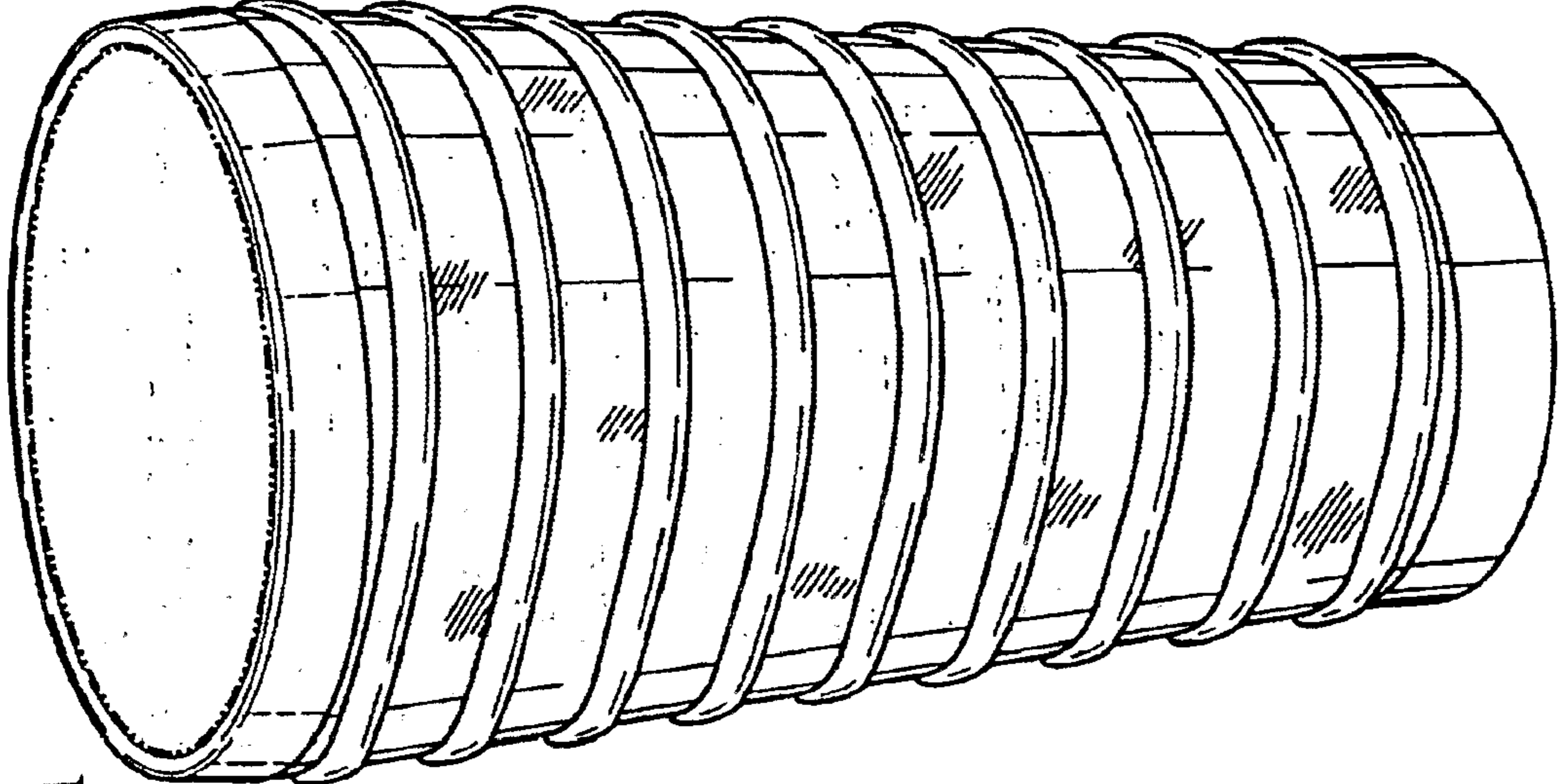

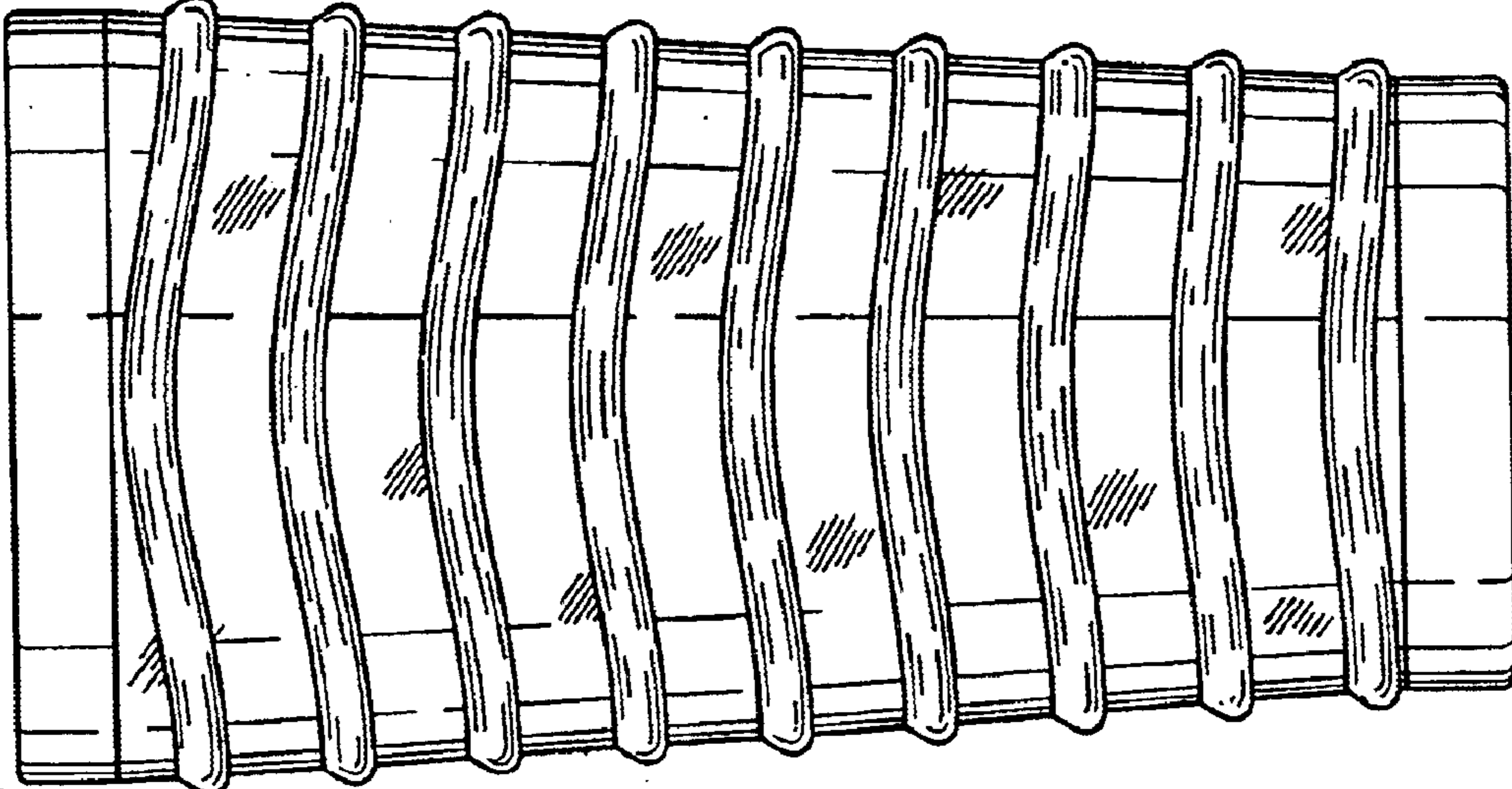

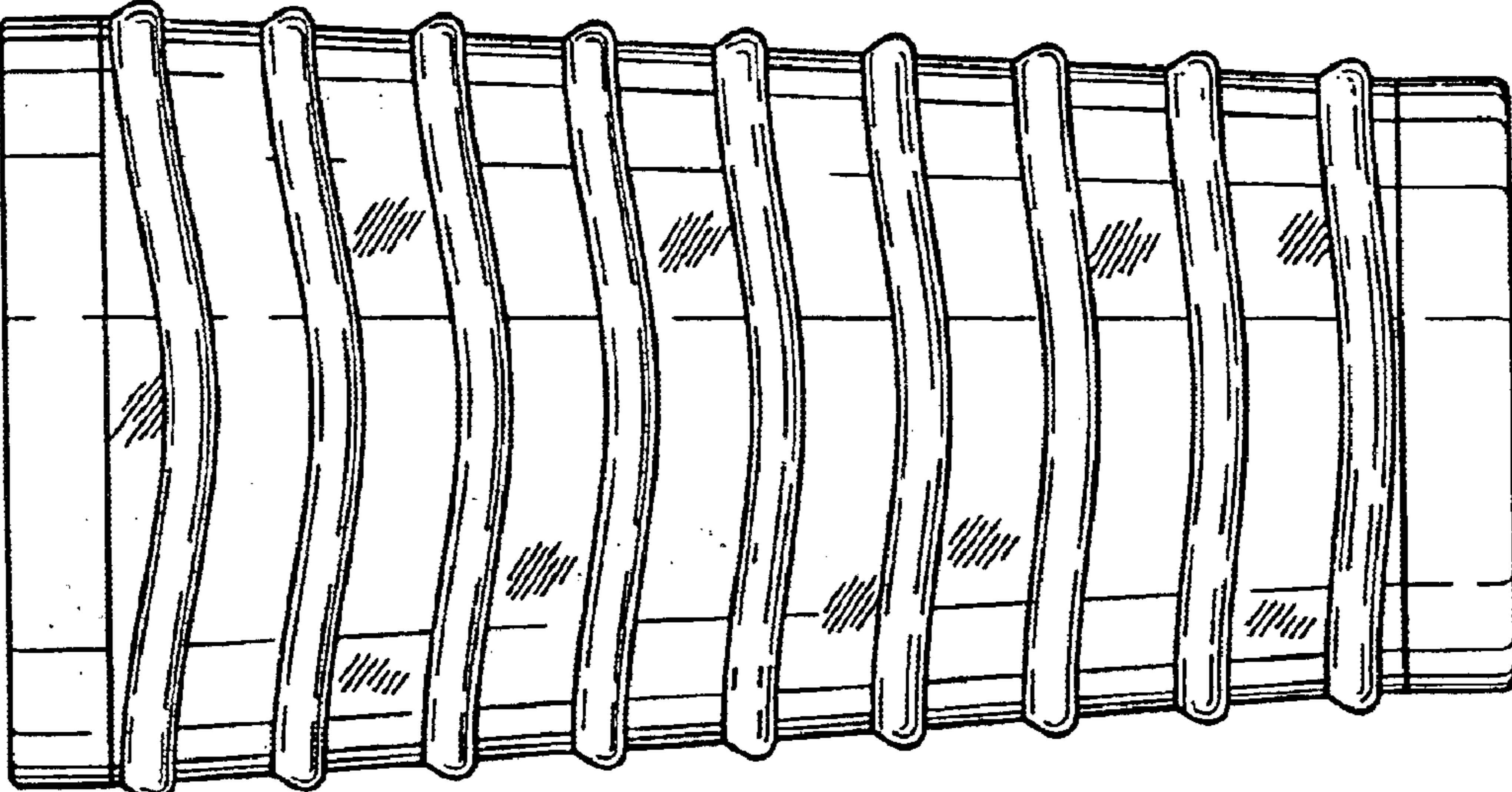

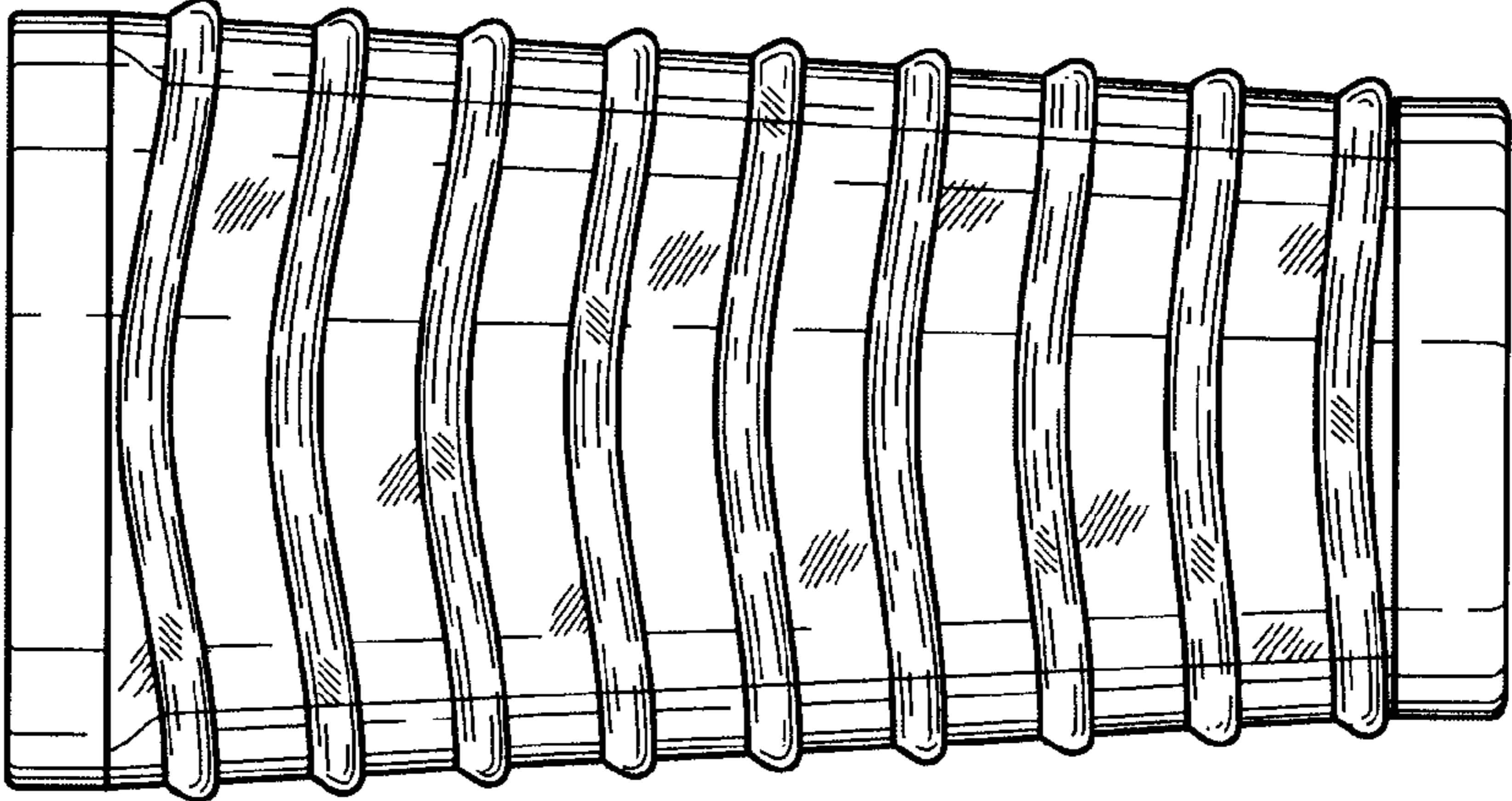

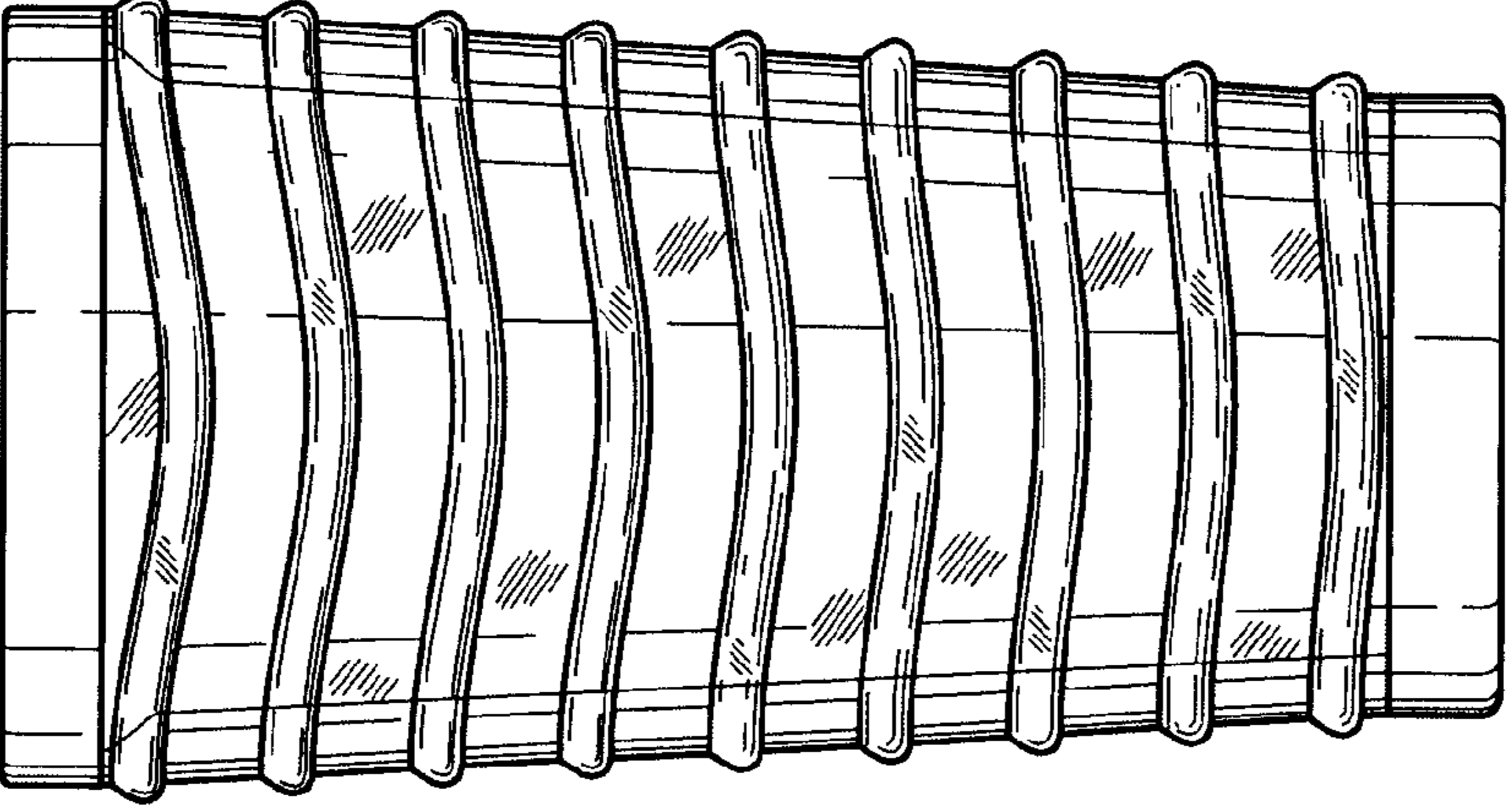
