FIG. 4 is side elevation view of the clamshell package of FIG. 1;

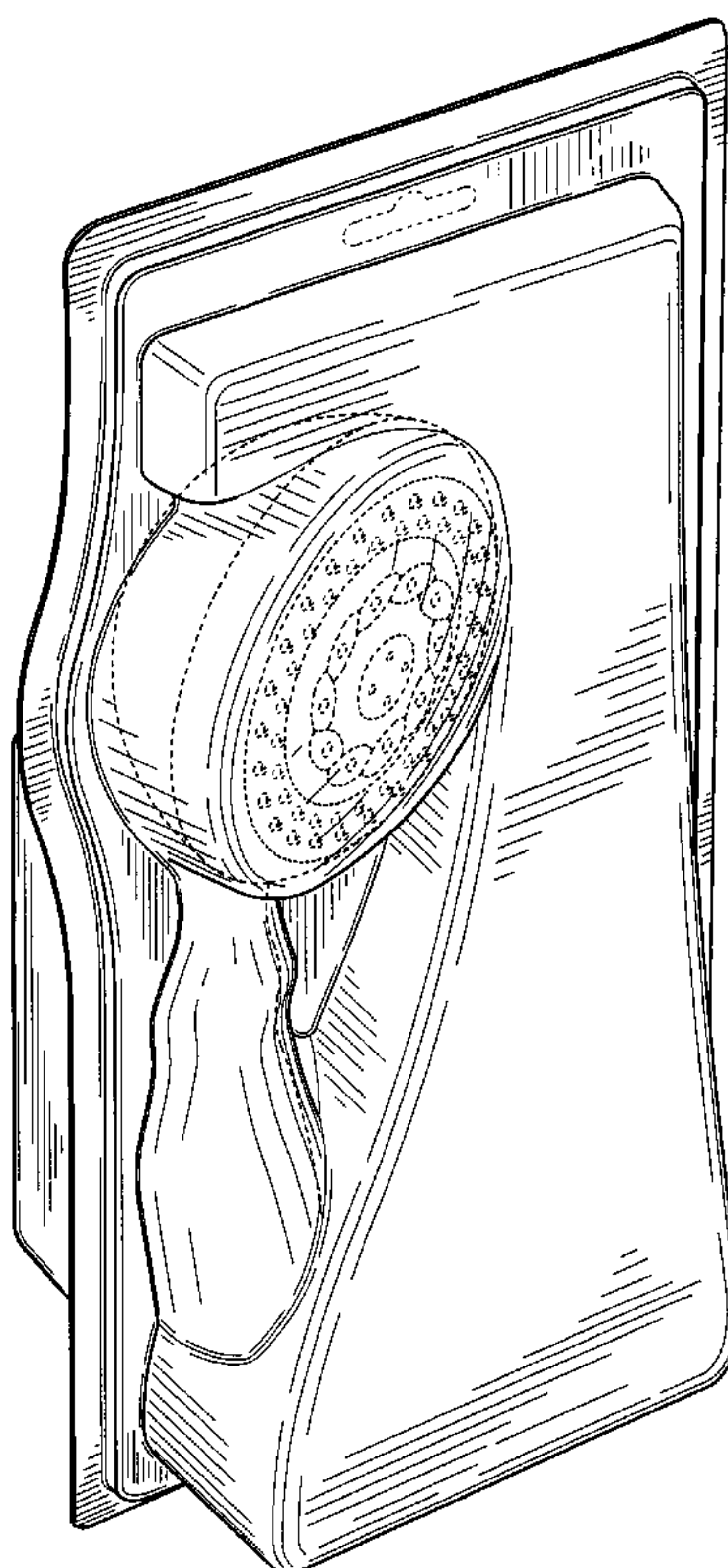
FIG. 5 is an opposing side elevation view of the clamshell package of FIG. 4;

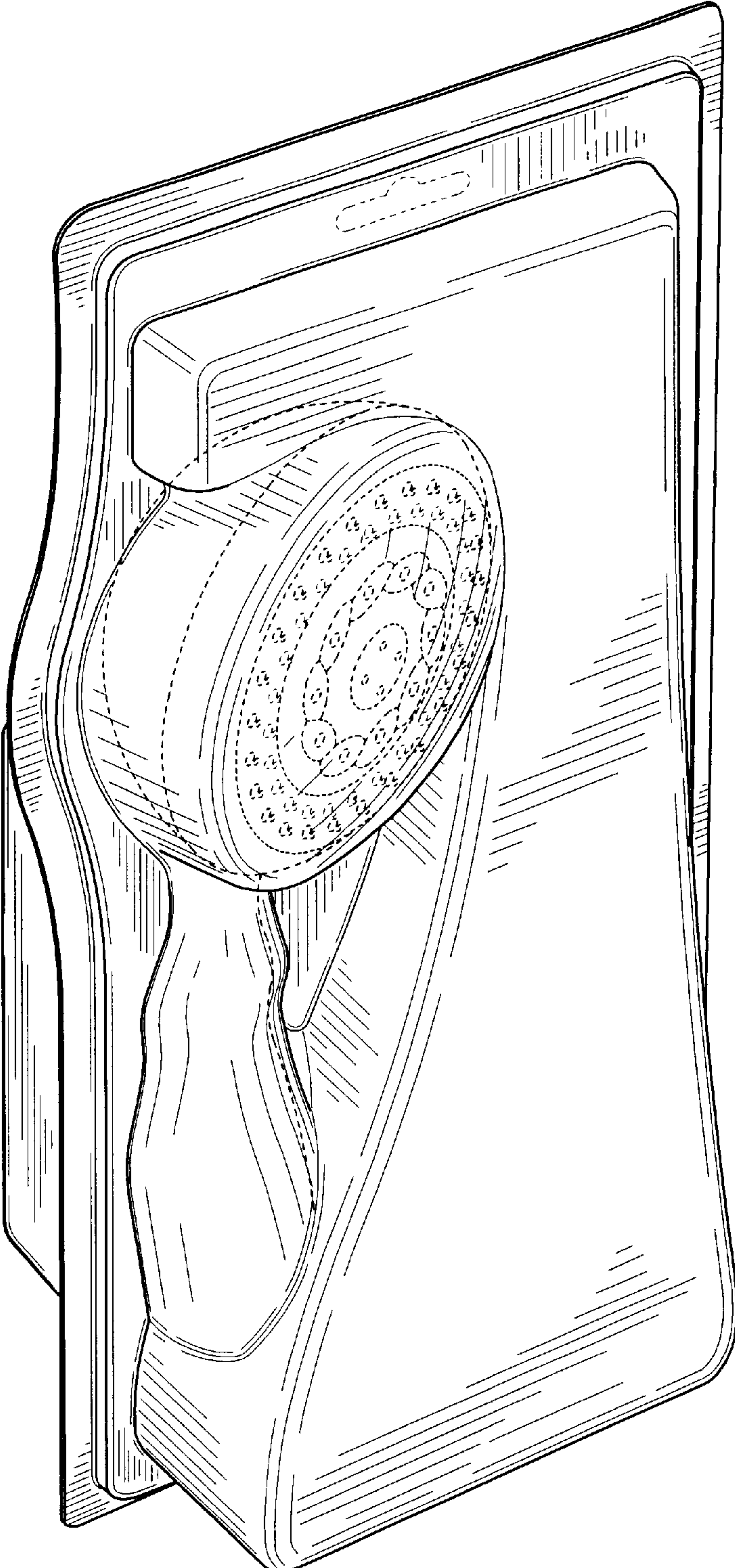

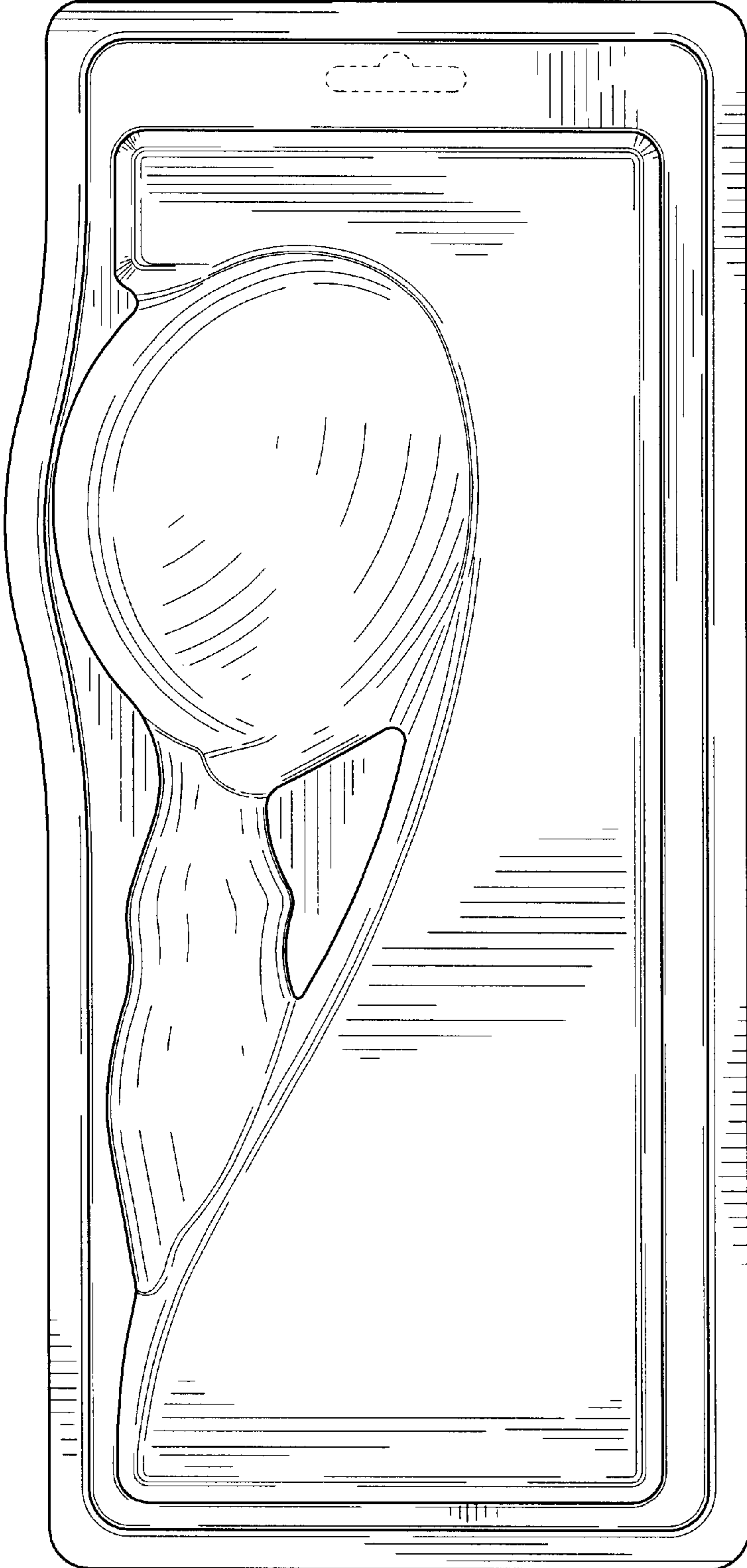

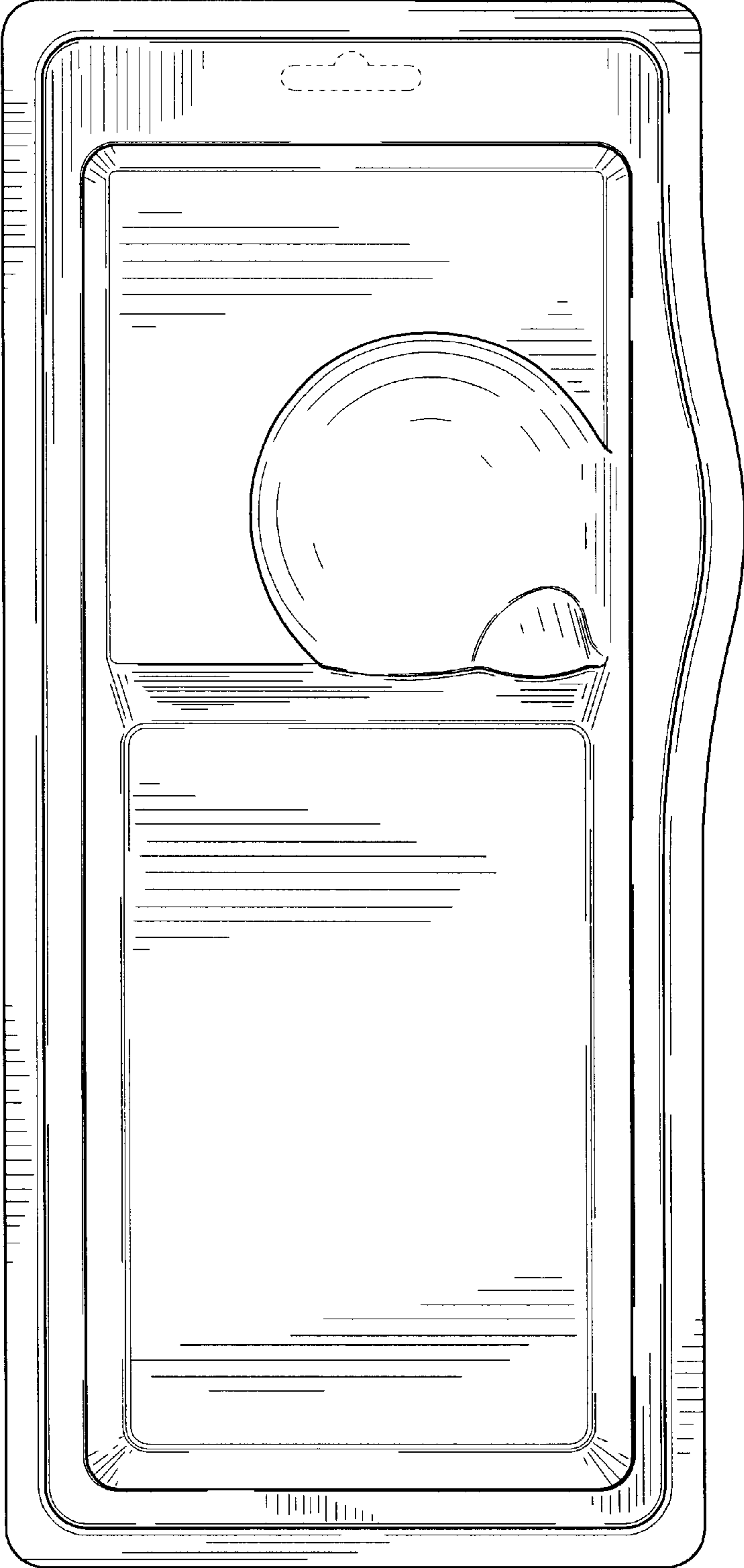

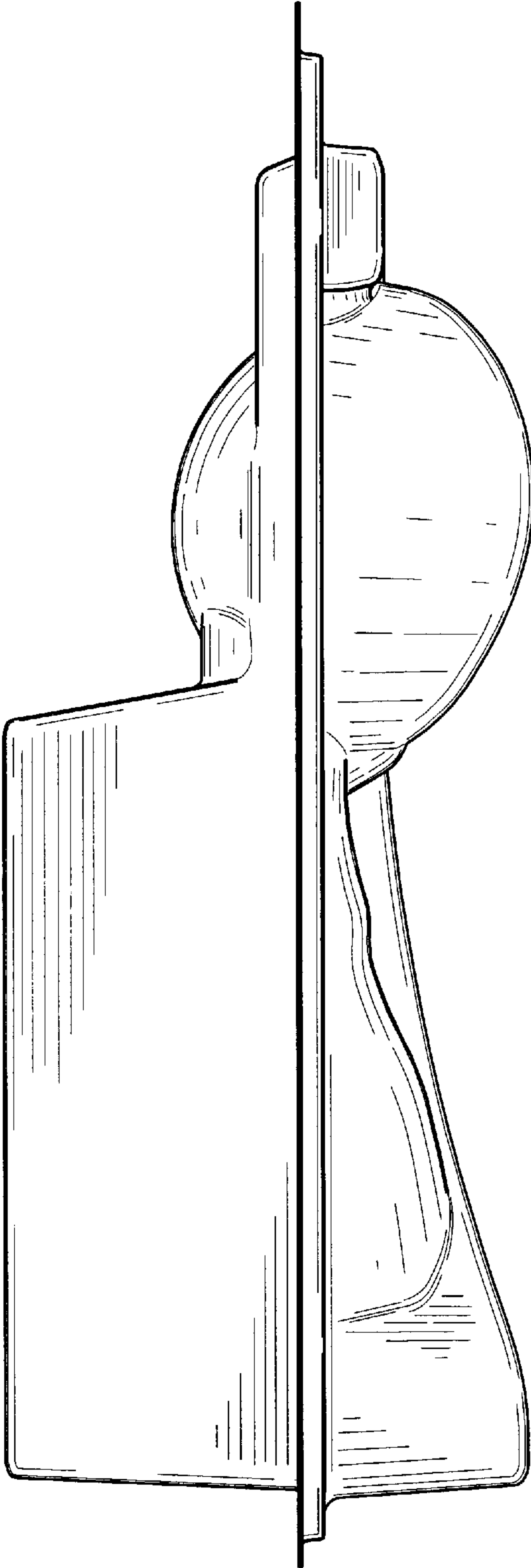

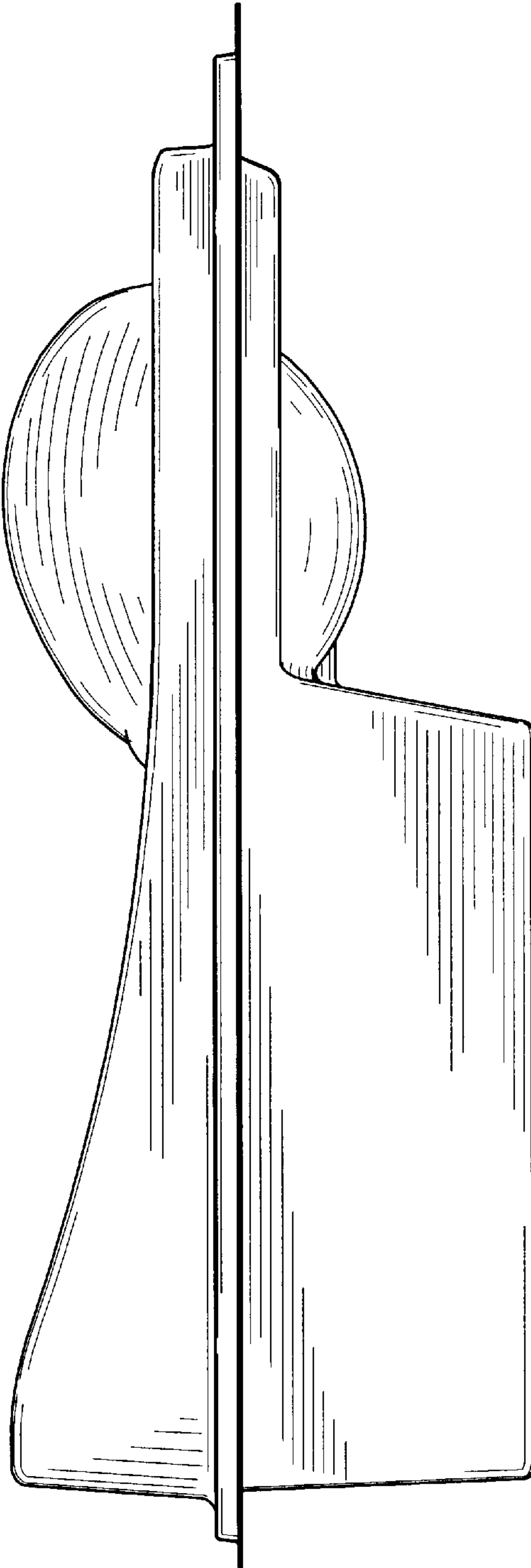

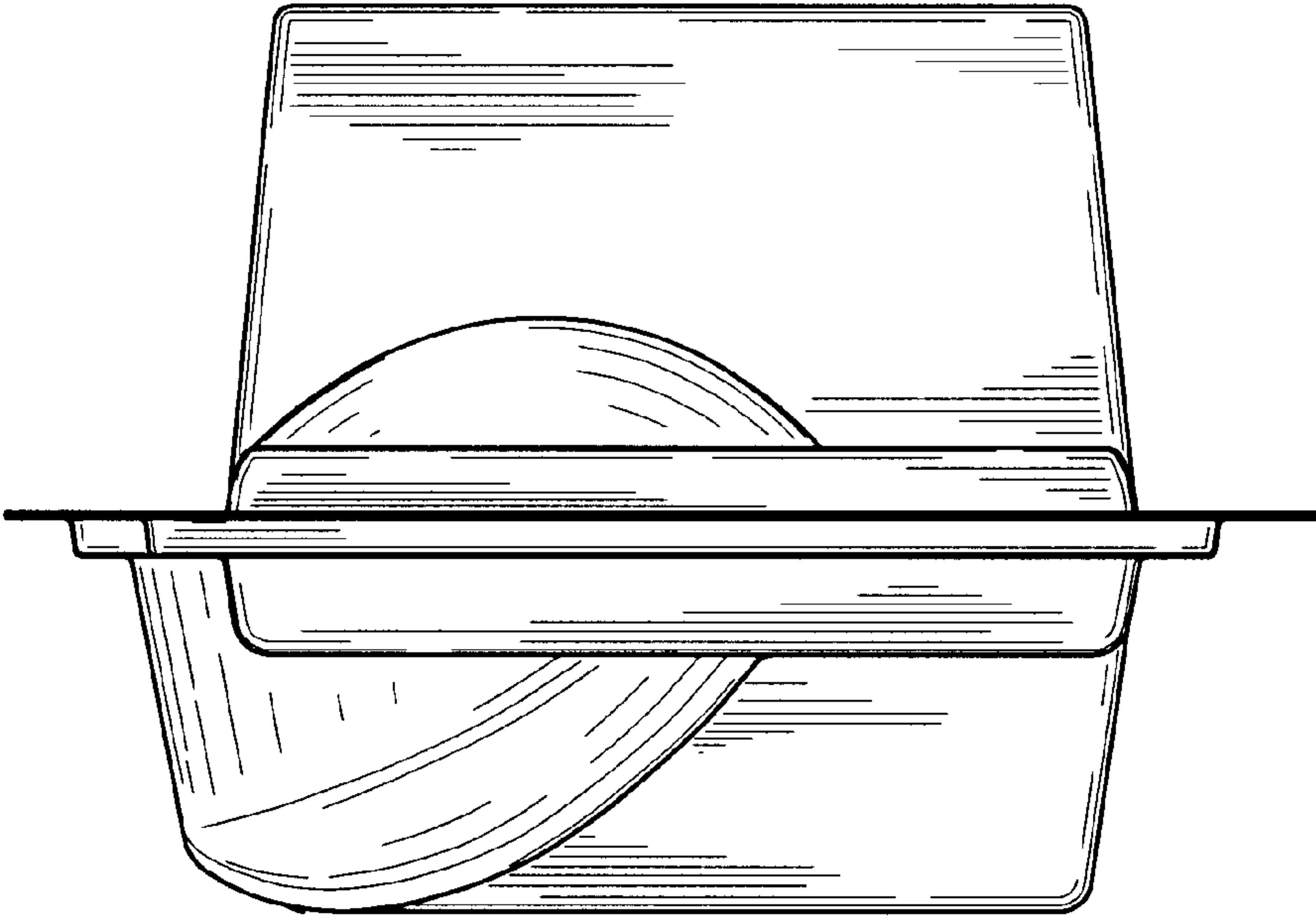

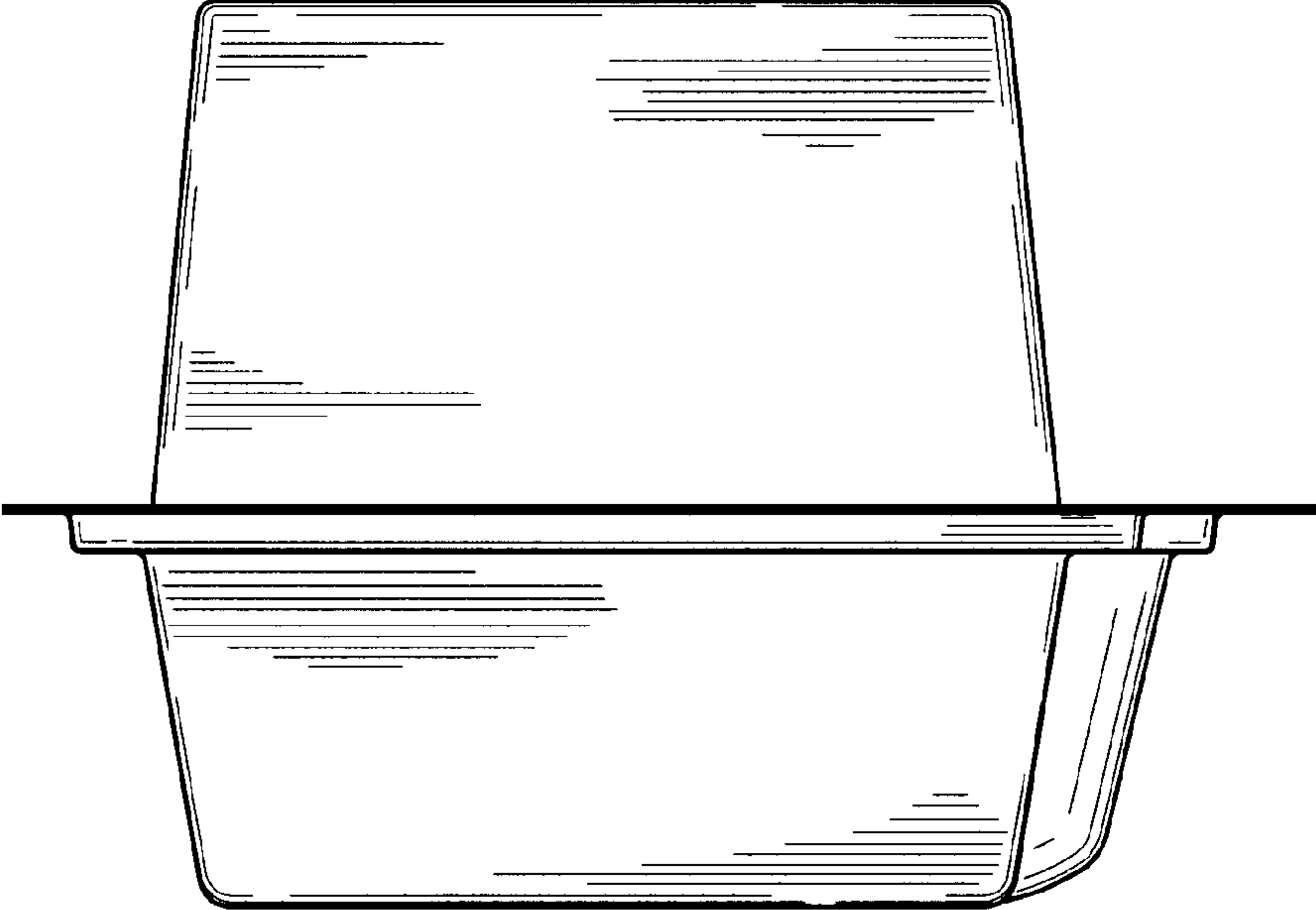
