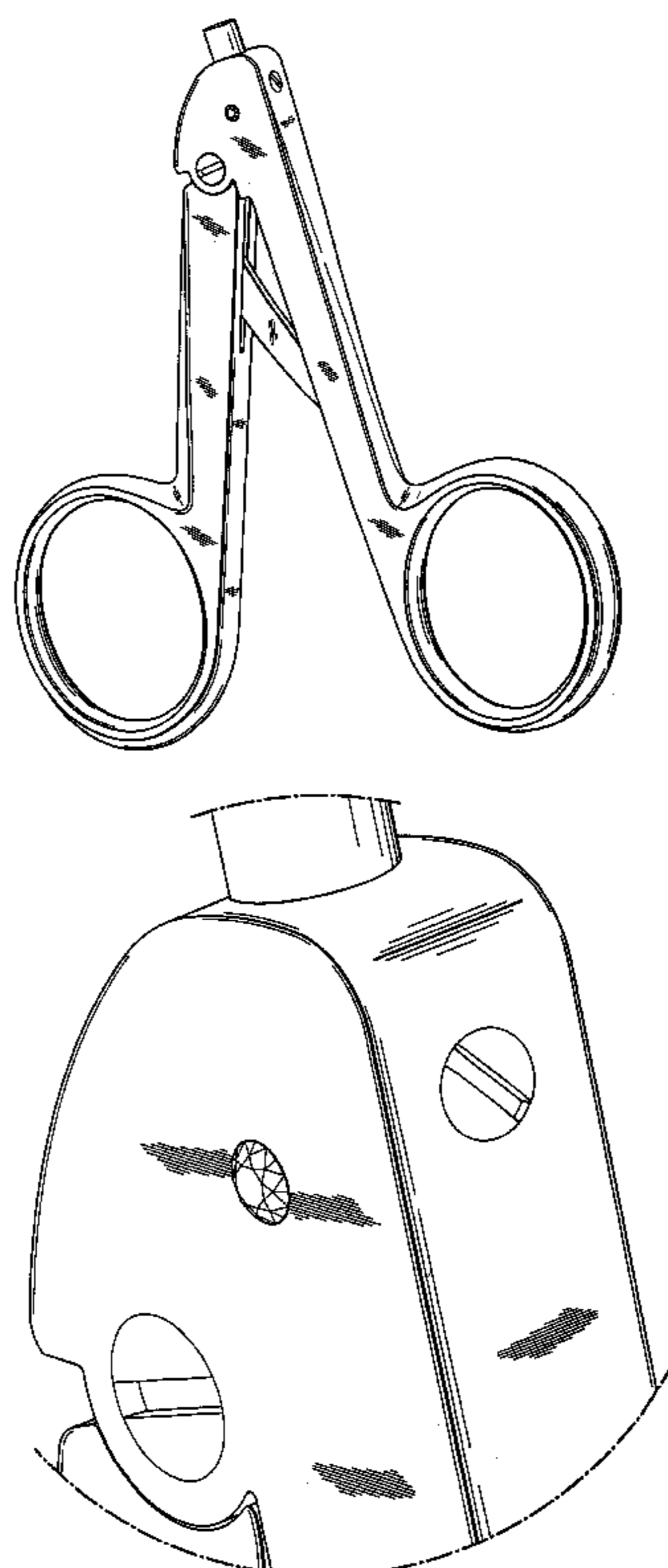
(57) **CLAIM**

I claim the ornamental design for handle for a circular punch, as shown and described.

DESCRIPTION

FIG. 1 is a right side, rear and top perspective view of a handle for a circular punch showing the new design;
FIG. 2 is a left side view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a front view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a top view thereof;
FIG. 8 is a detailed, fragmentary perspective view taken from the right, rear and top thereof; and,
FIG. 9 is a detailed, fragmentary elevation view, taken from the right side thereof.

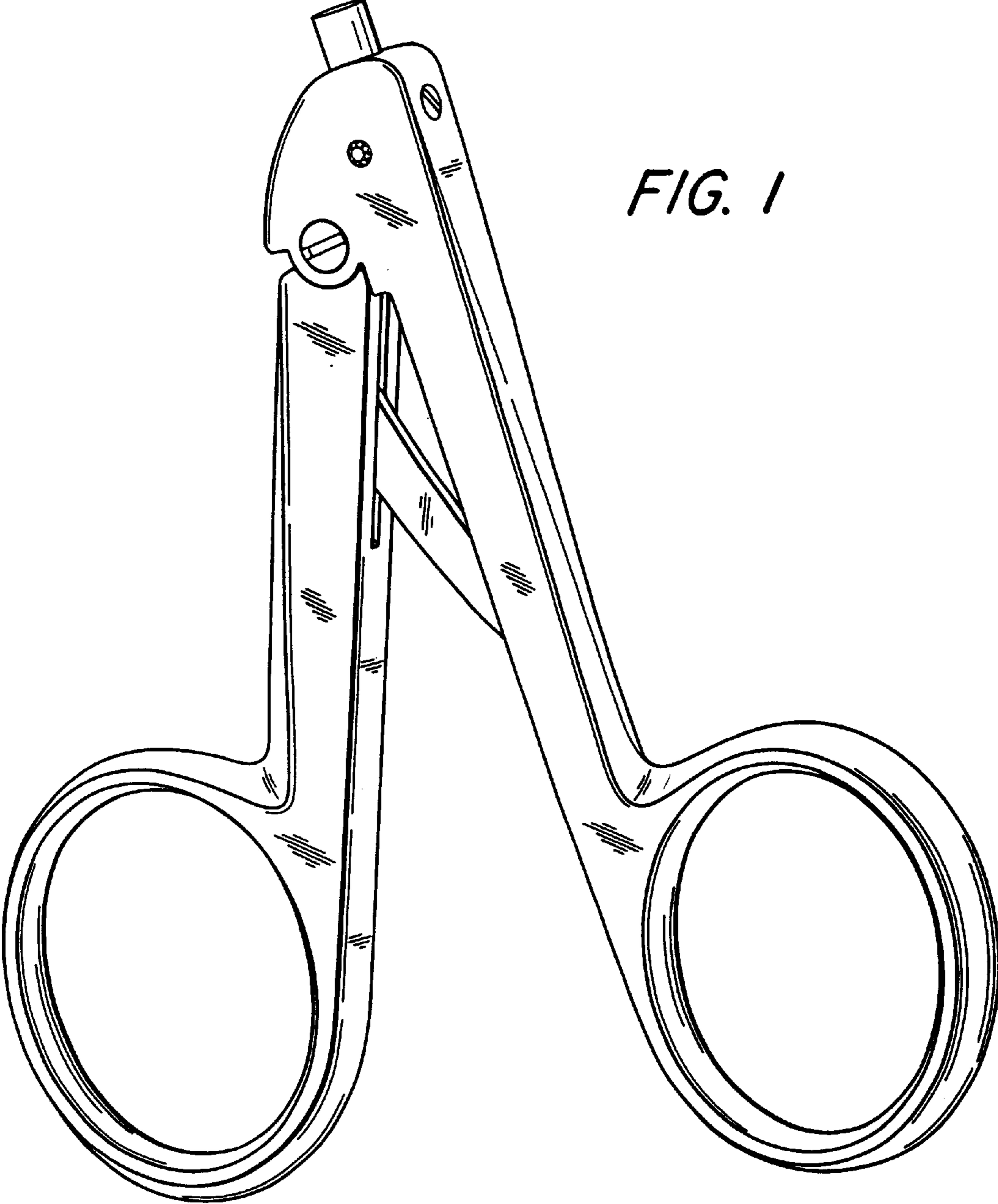

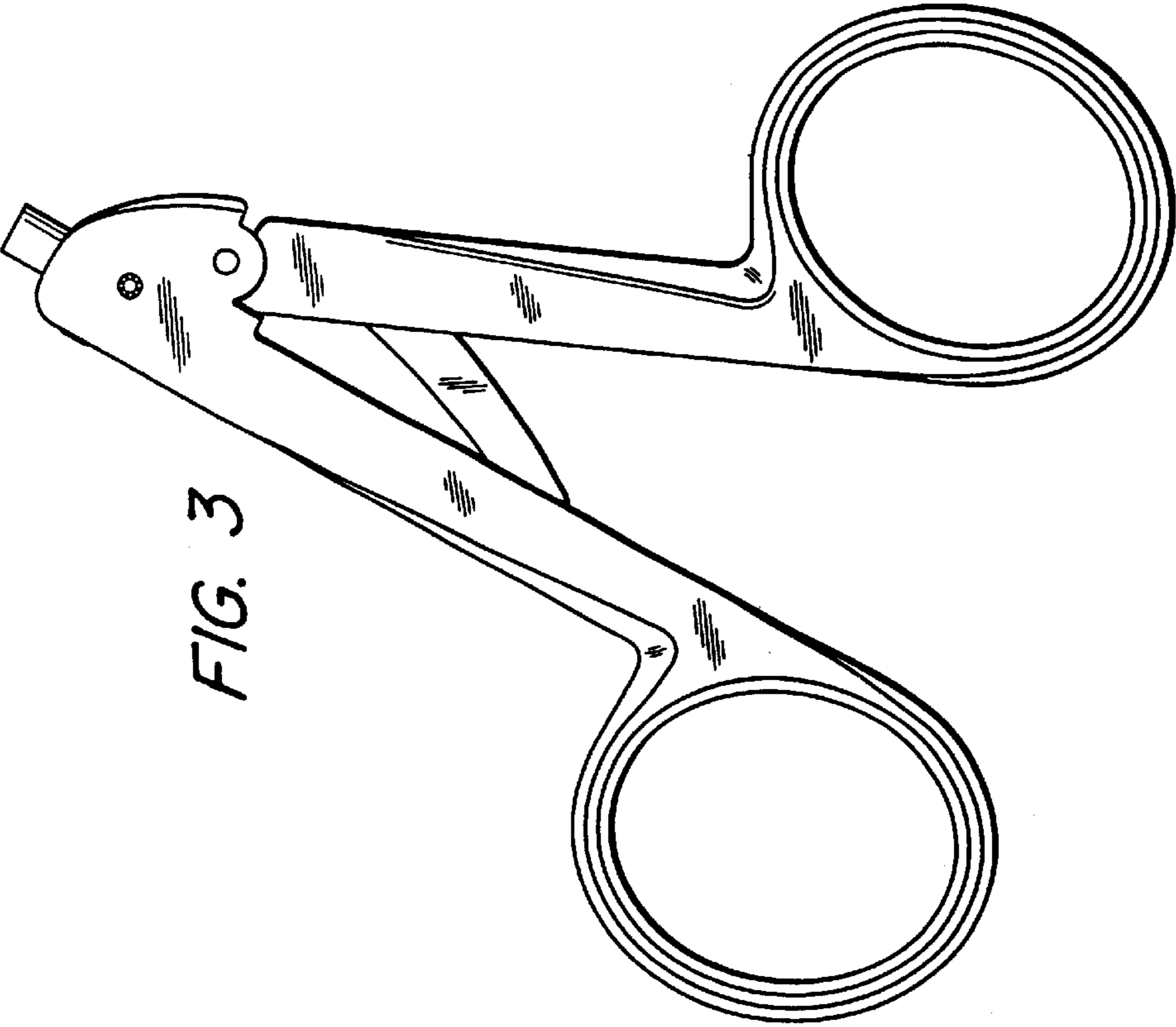

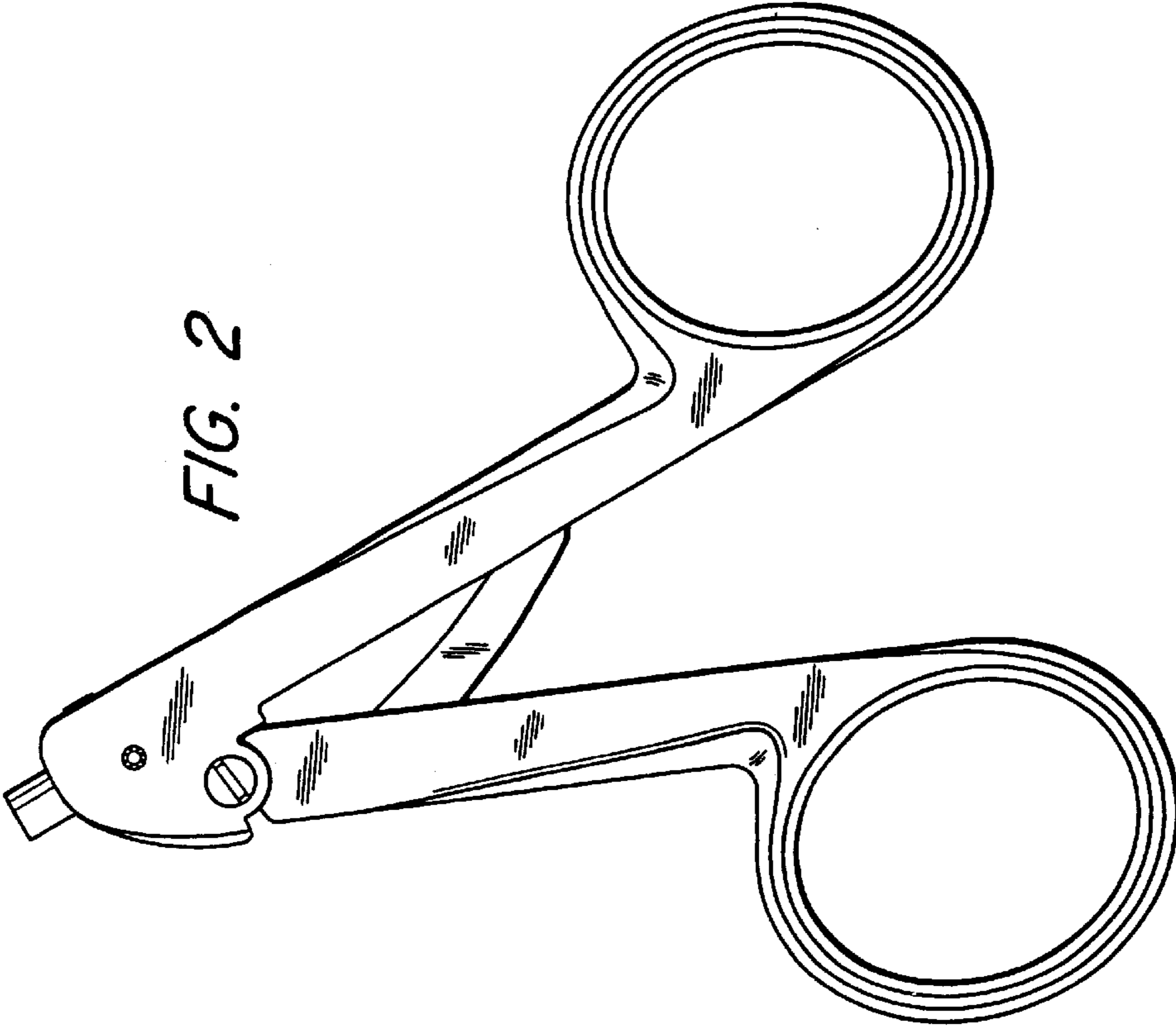

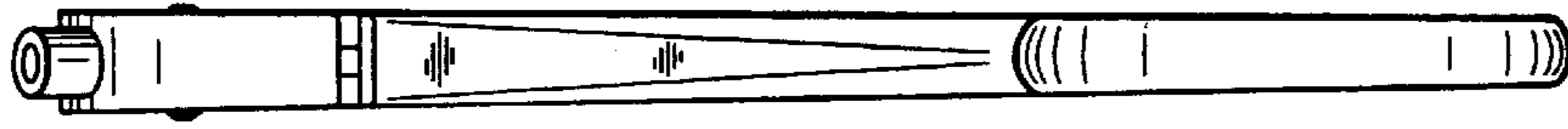

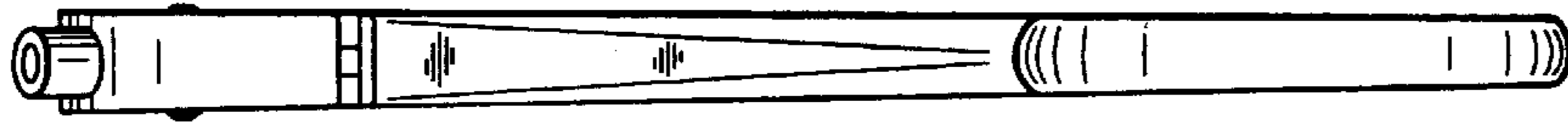

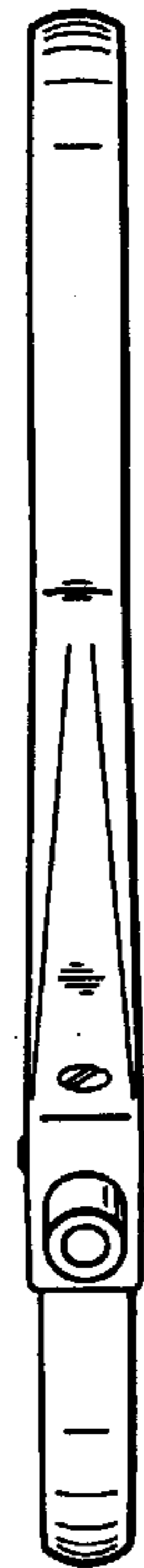
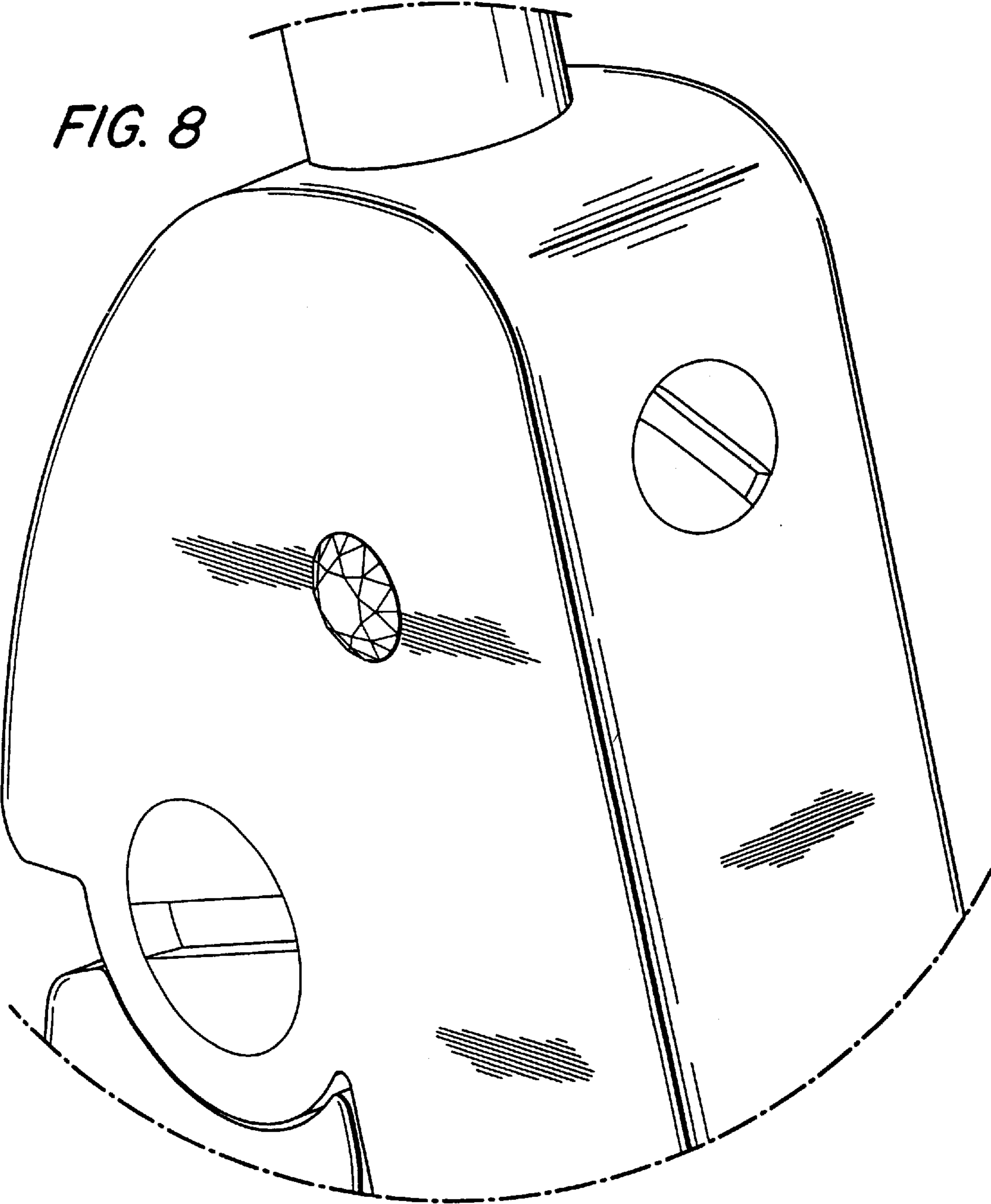

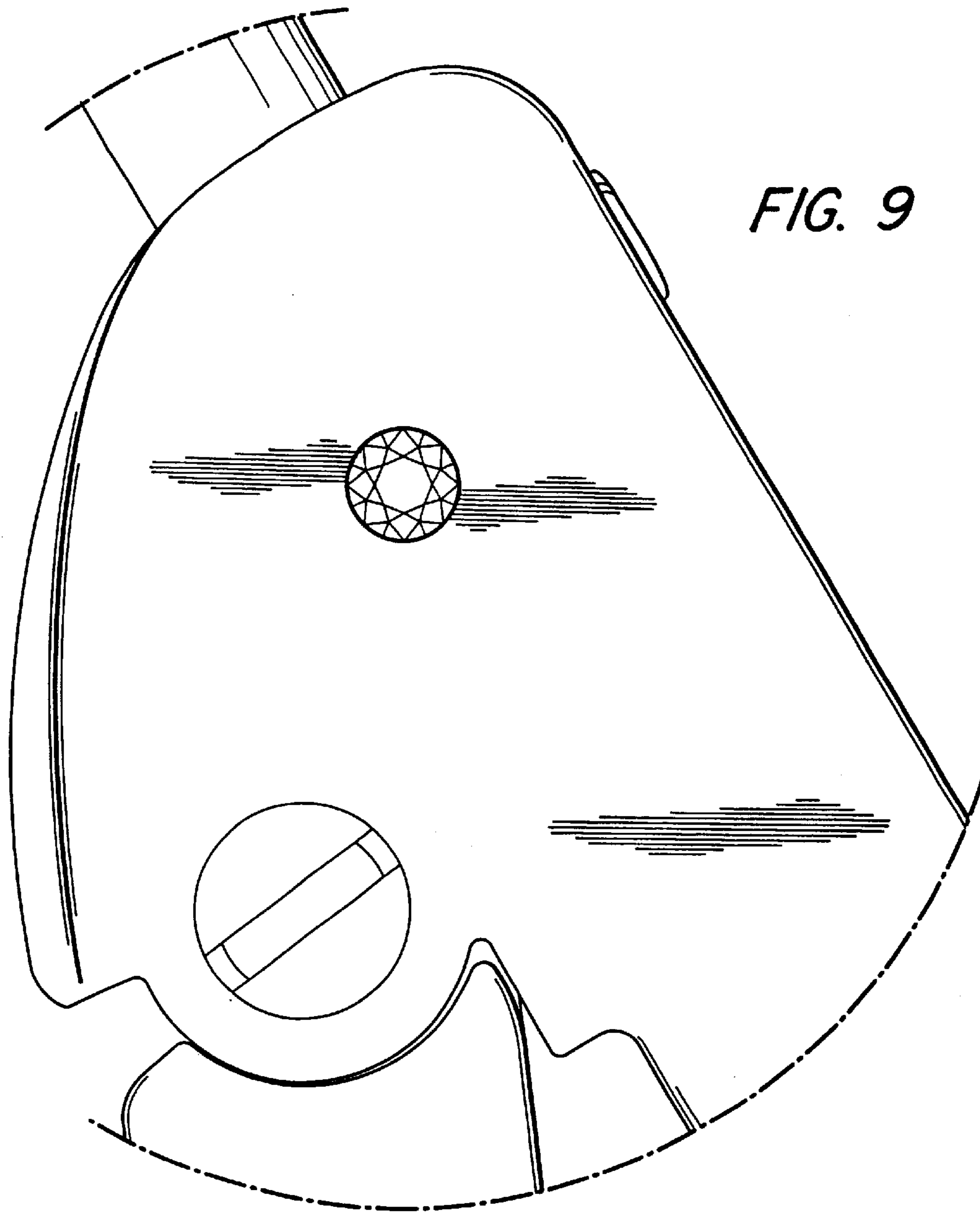
