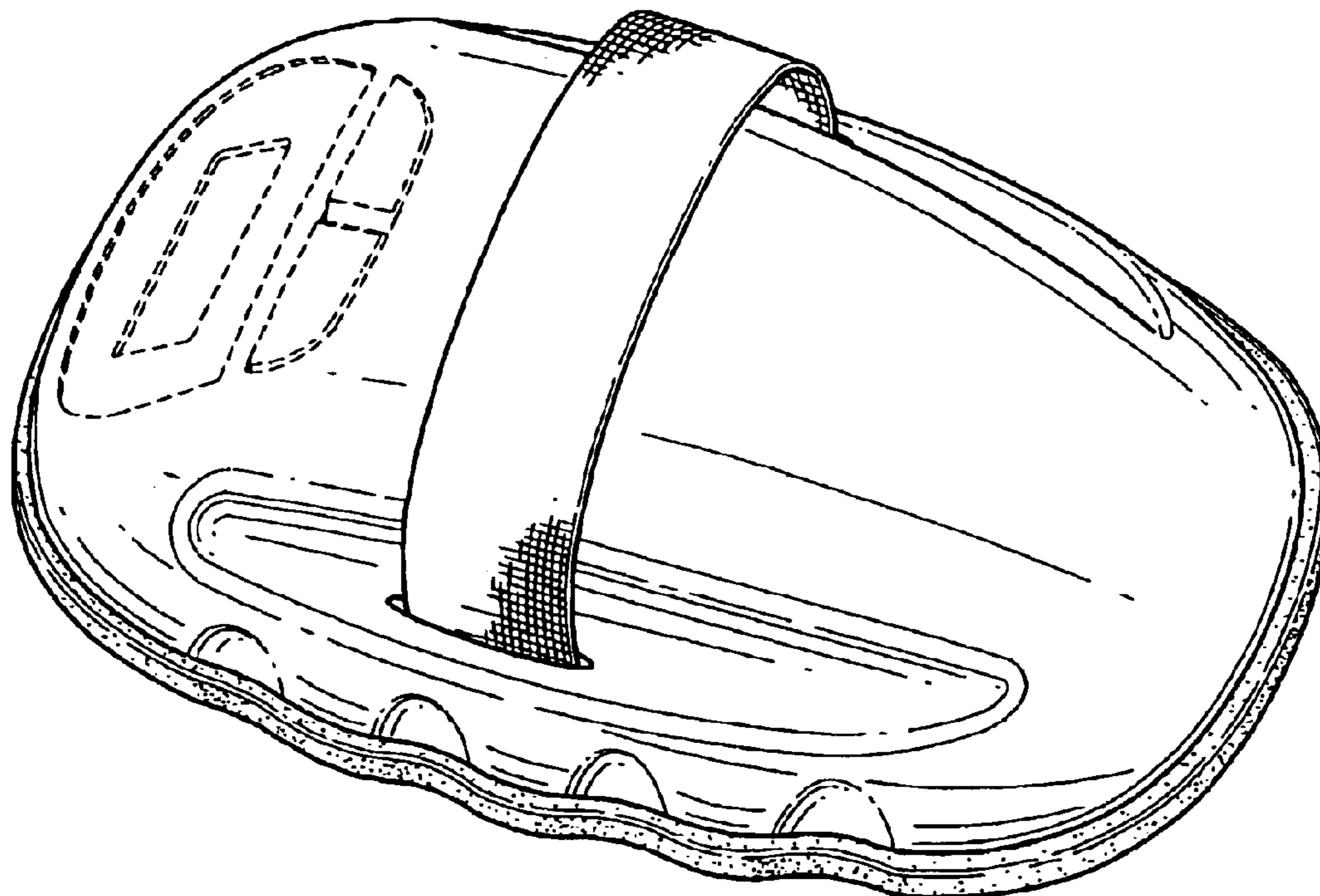
(57) **CLAIM**

We claim the ornamental design for the therapeutic device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a therapeutic device showing our new design, the broken line showing is for illustrative purposes only and forms no part of the claimed design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a side elevational view thereof; FIG. 5 is a front elevational view thereof; and, FIG. 6 is a rear elevational view thereof.

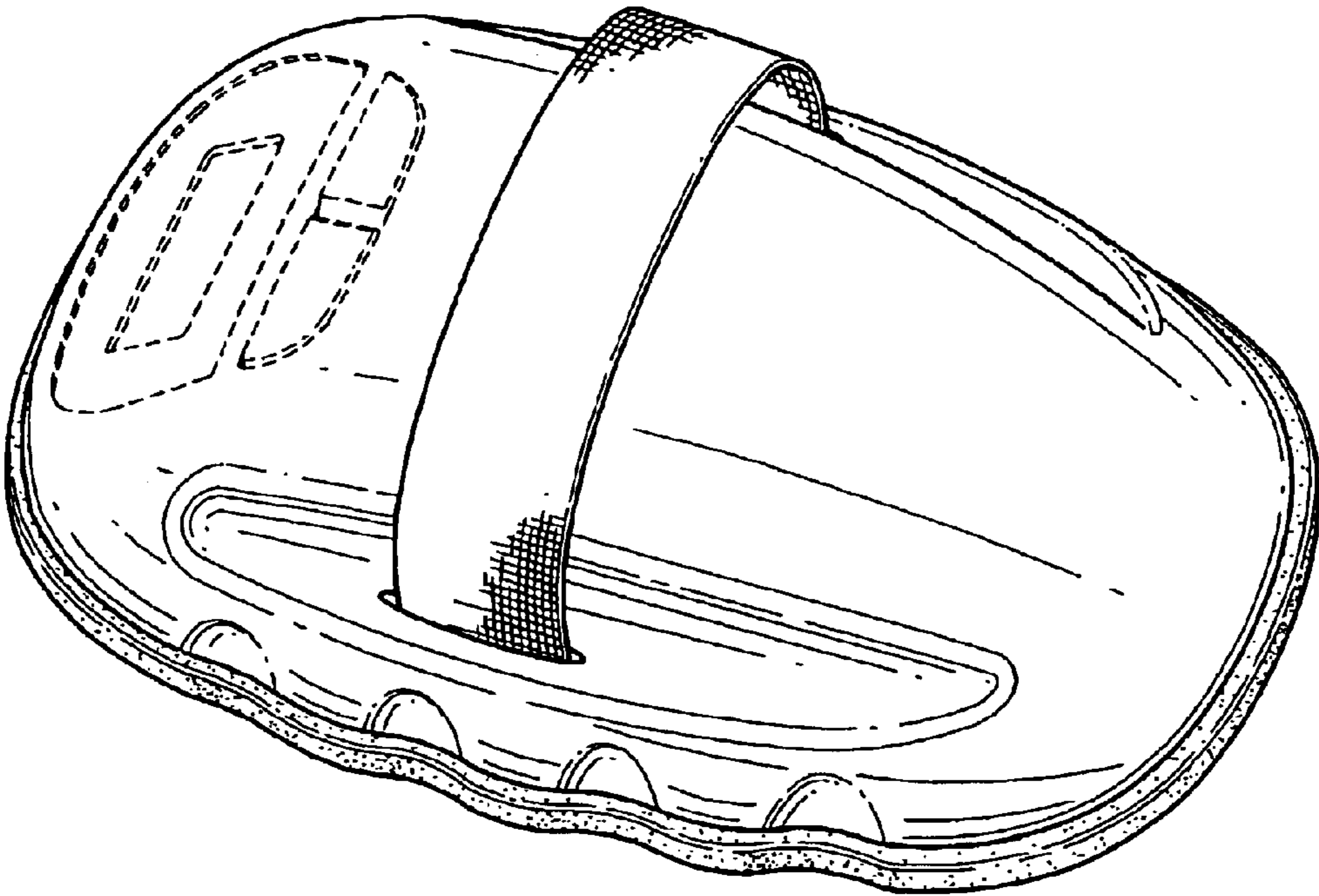

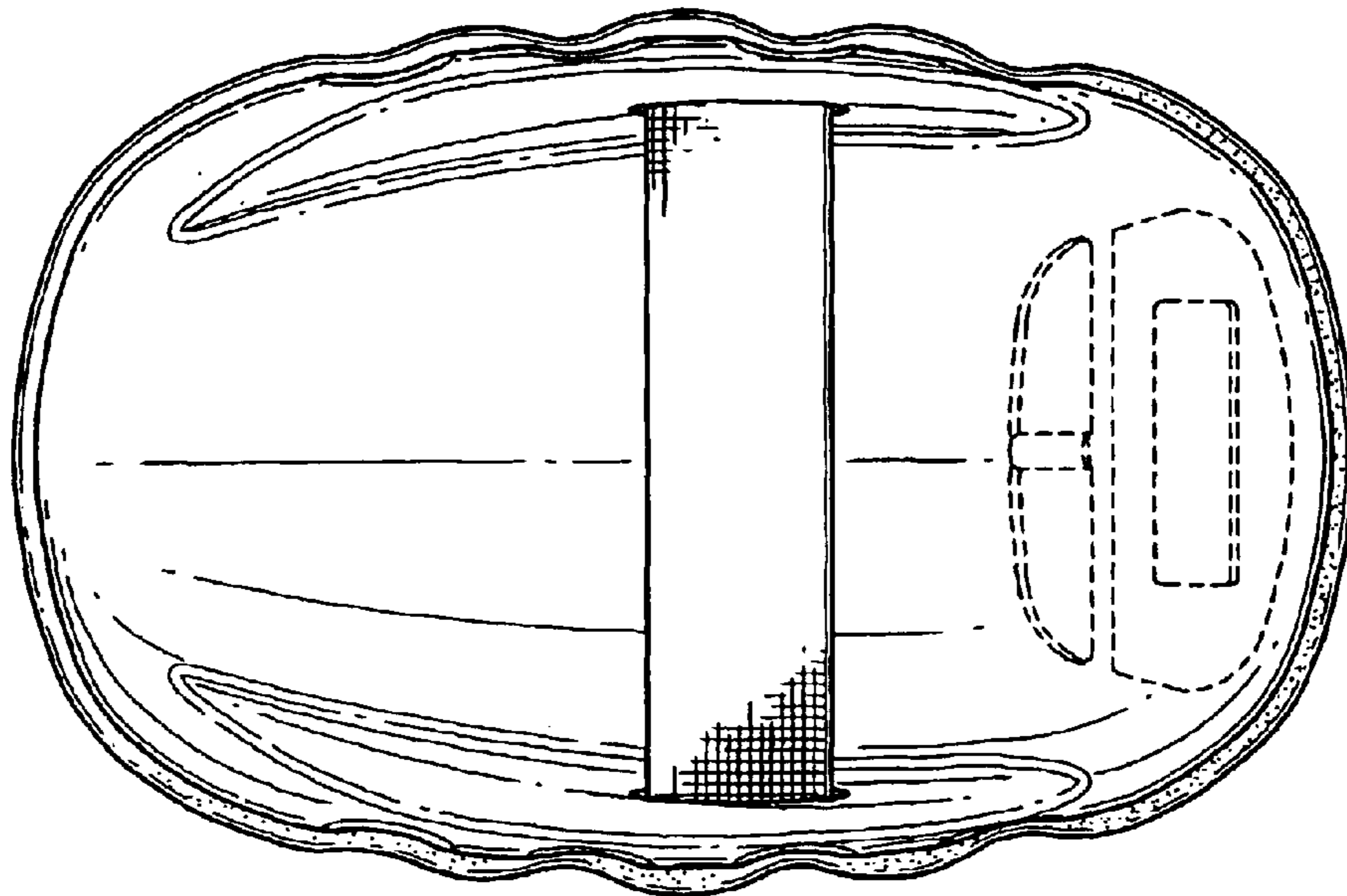

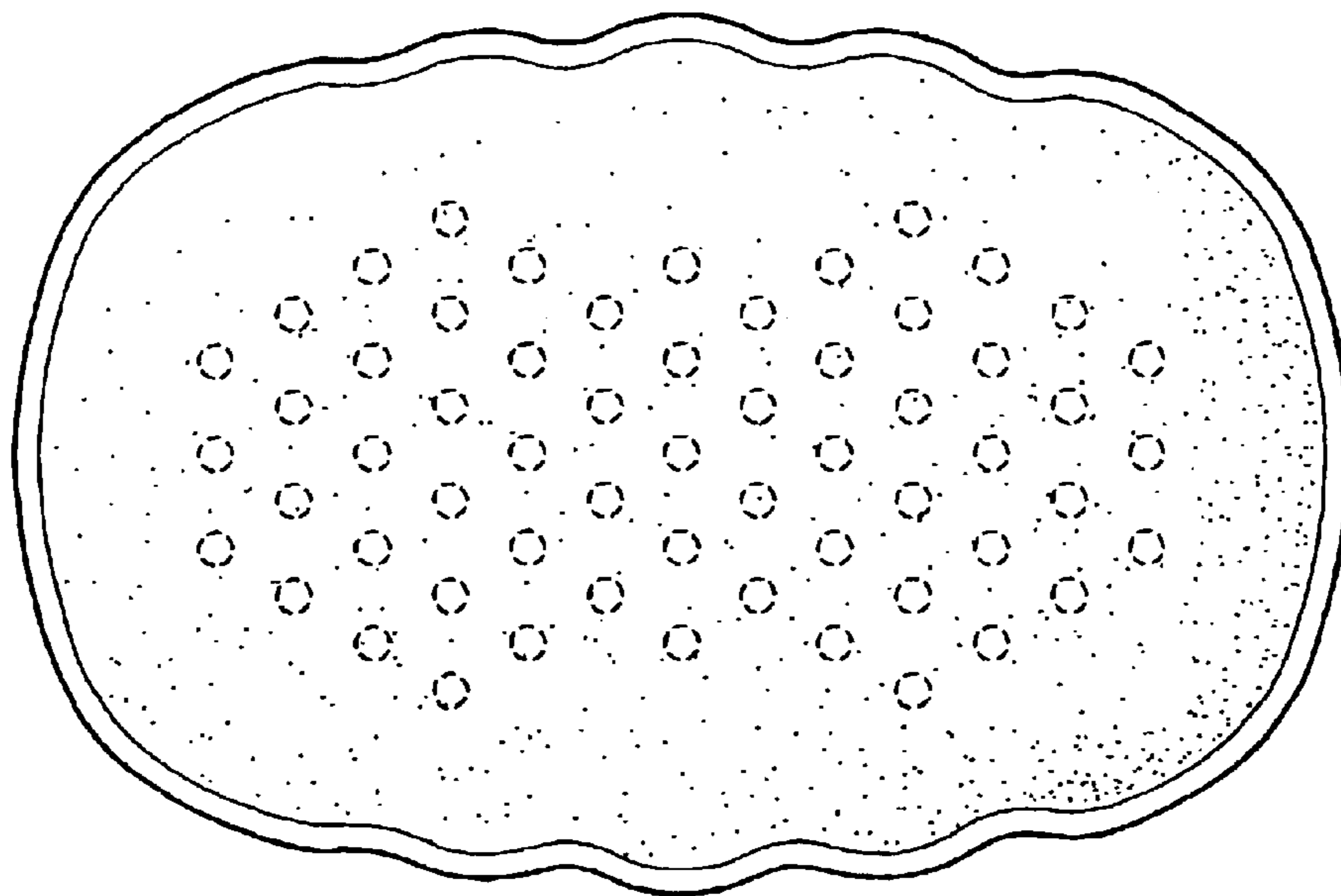

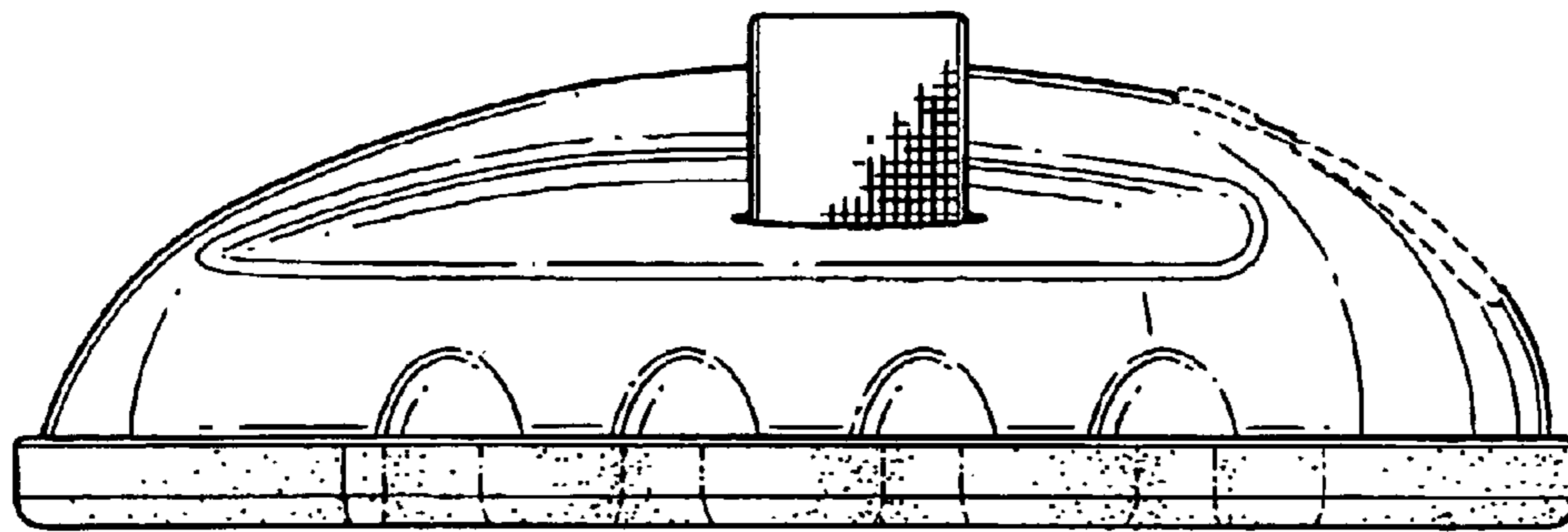

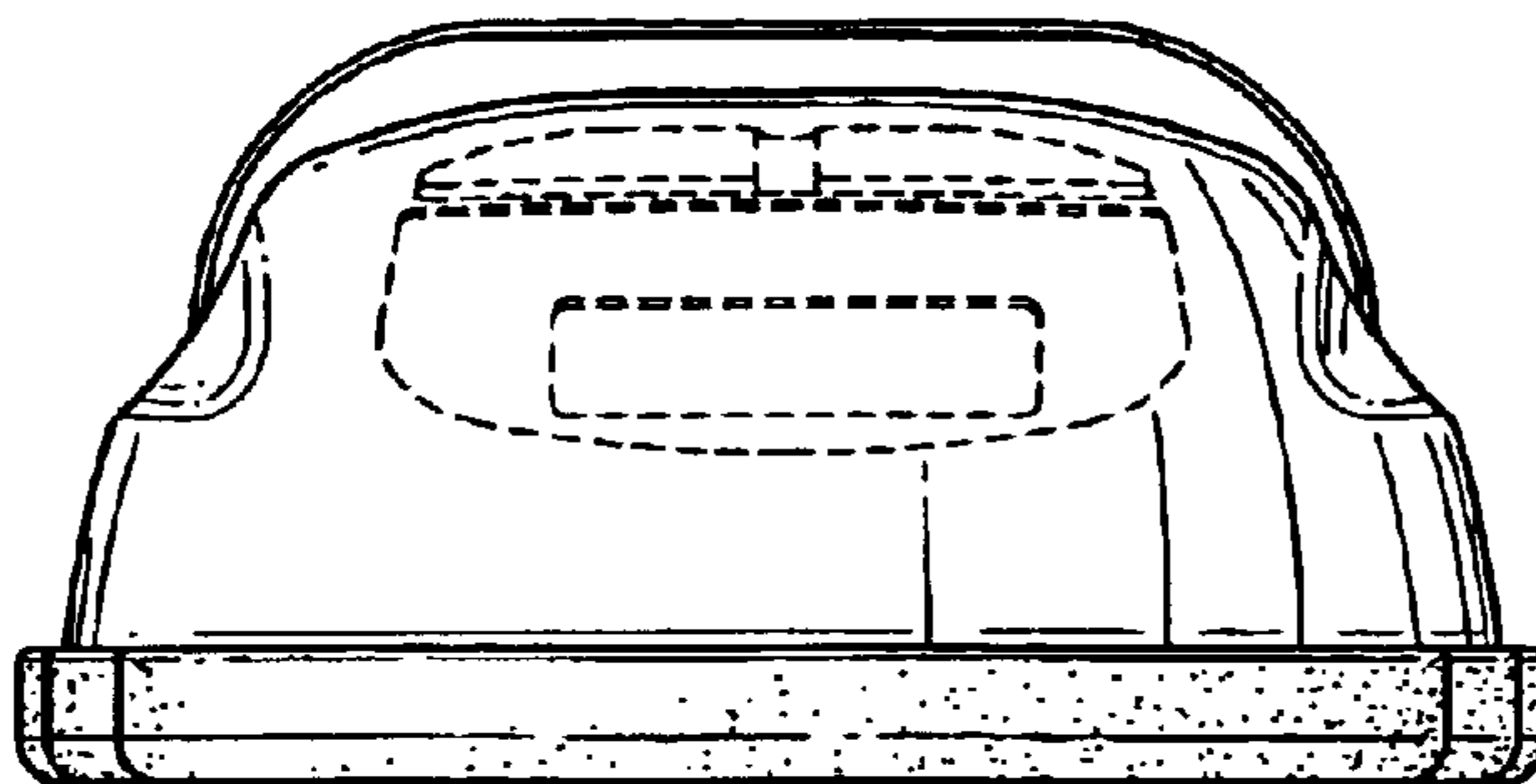

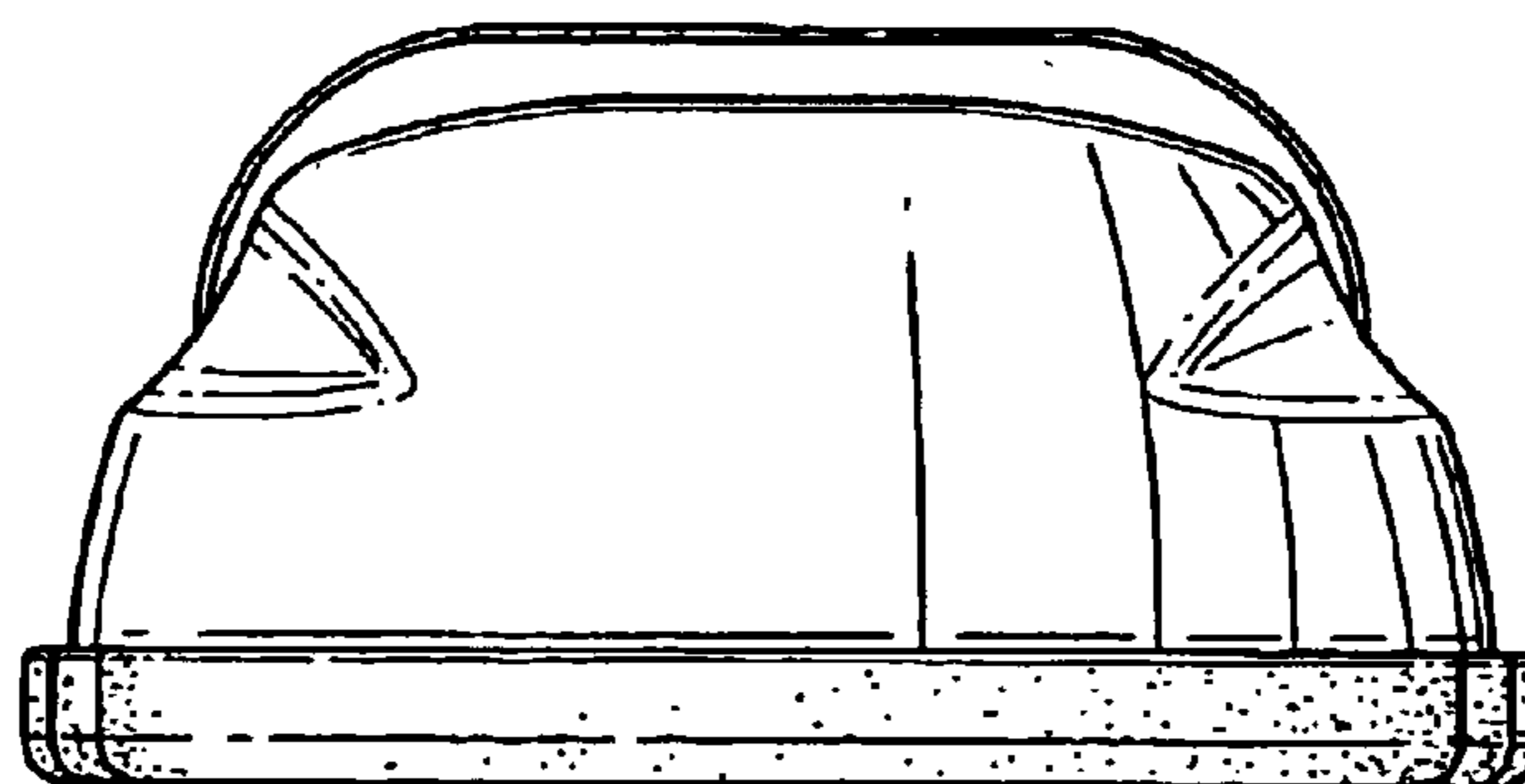
