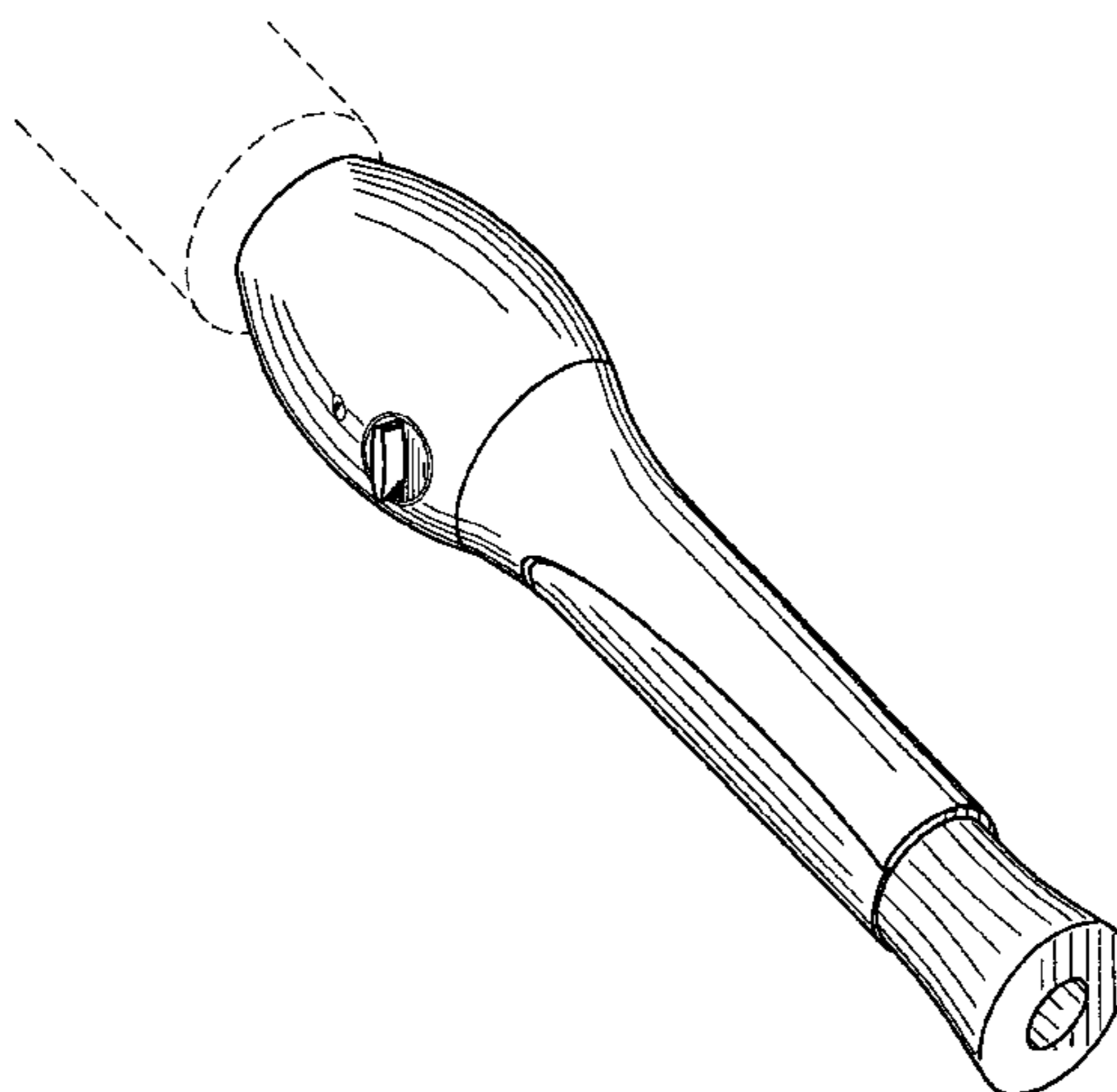
(57) **CLAIM**

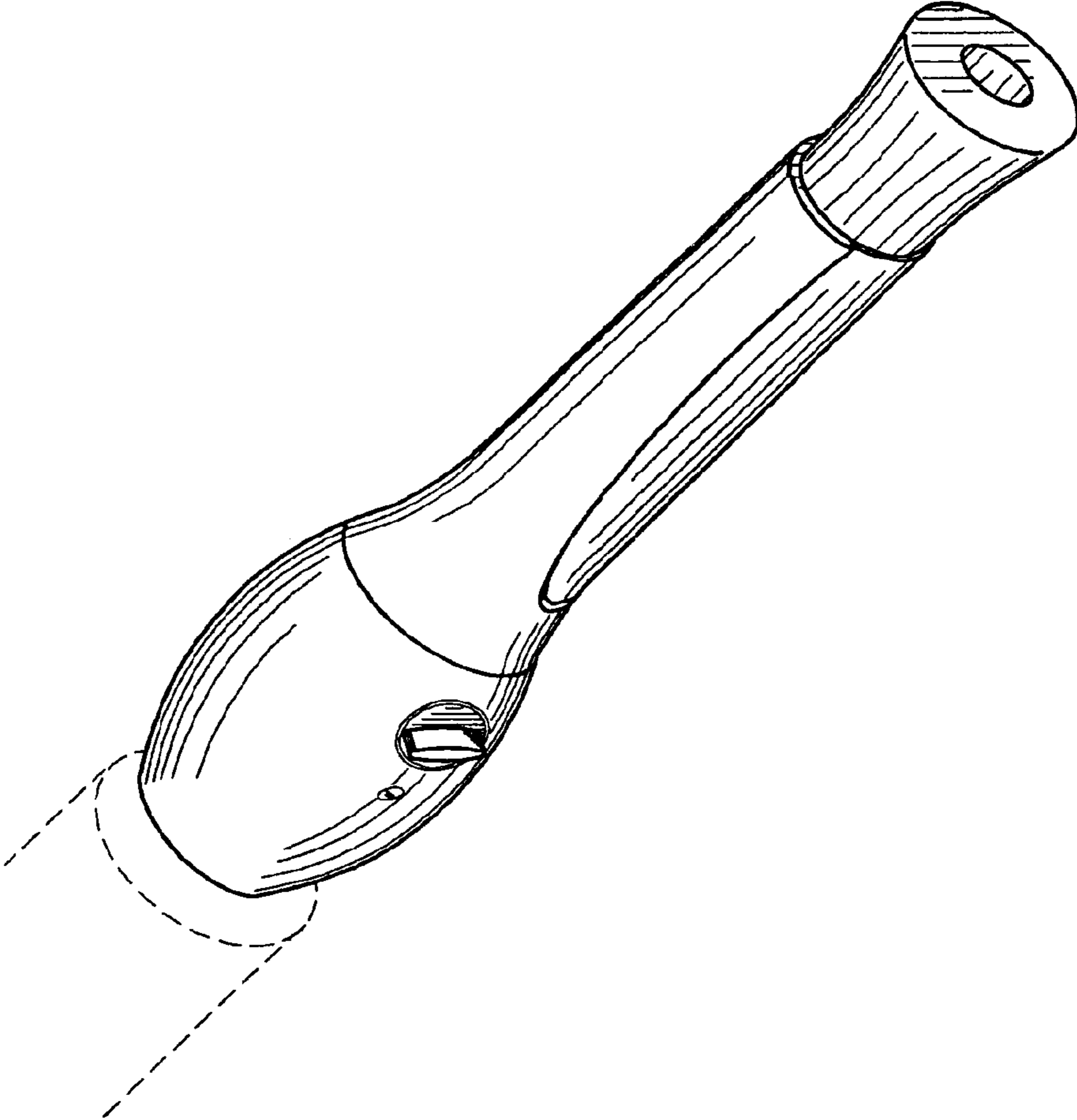
The ornamental design for a curling iron handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a drawing showing a perspective view, taken from the rear, top, and left side, illustrating a new design of a curling iron handle, a portion of the curling iron being shown in phantom;  
FIG. 2 is a top plan view of the curling iron handle, with the curling iron being shown in phantom;  
FIG. 3 is a left side elevation view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a right side elevation view thereof; and,  
FIG. 6 is a front elevation view of the handle.  
The phantom lines are shown for illustrative purposes only and form no part of the claimed design.

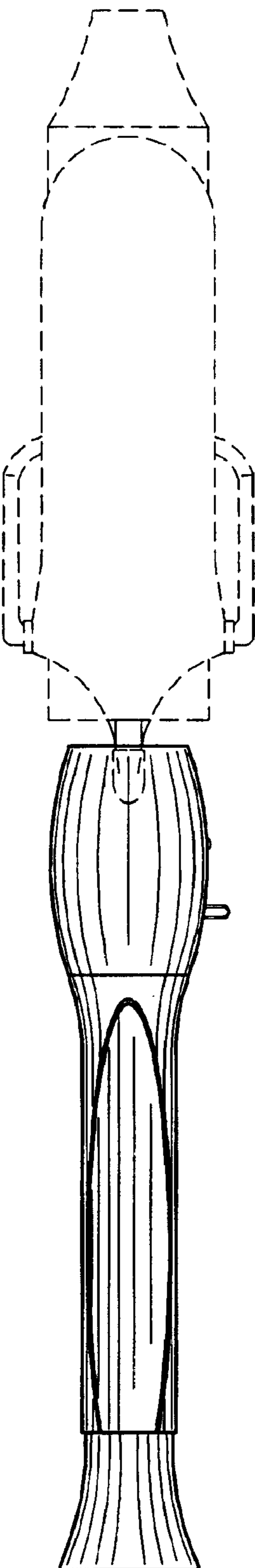

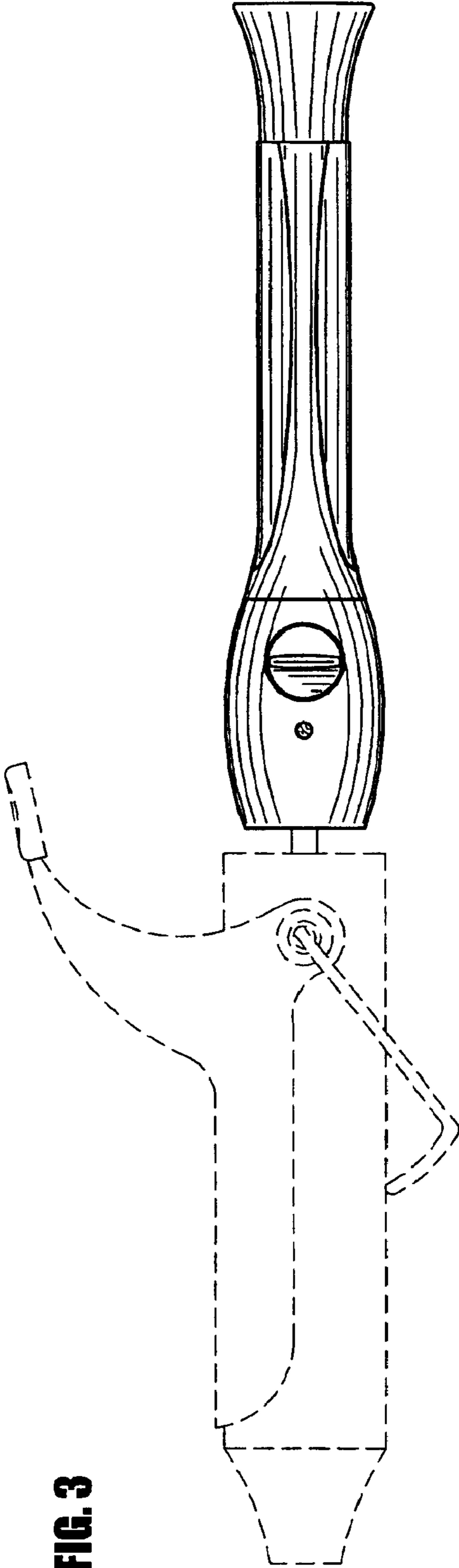


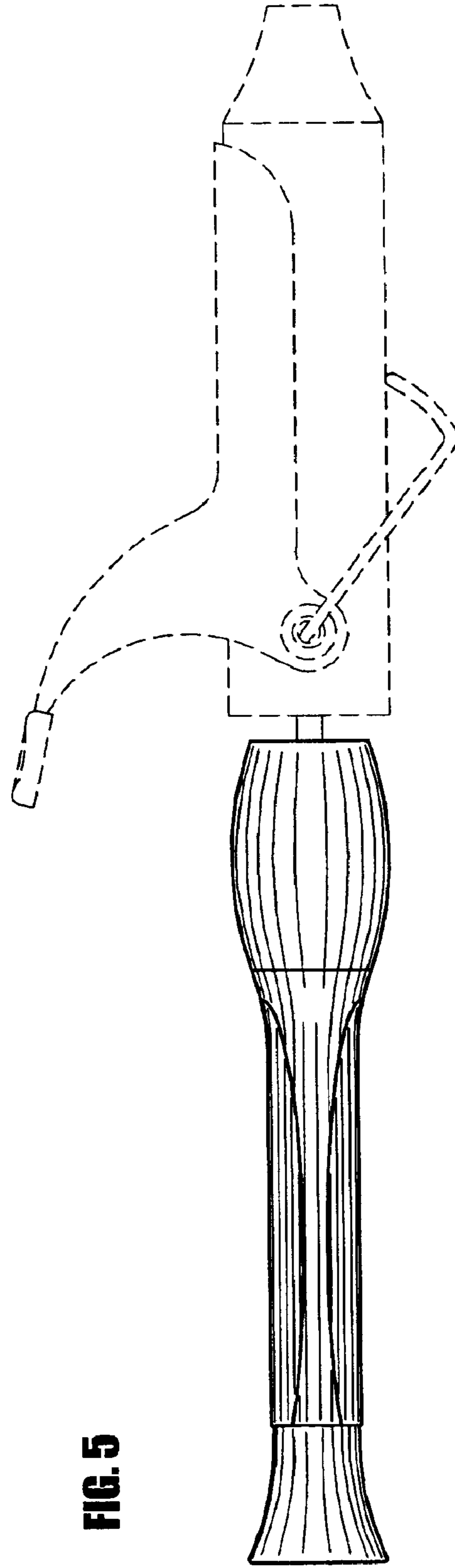
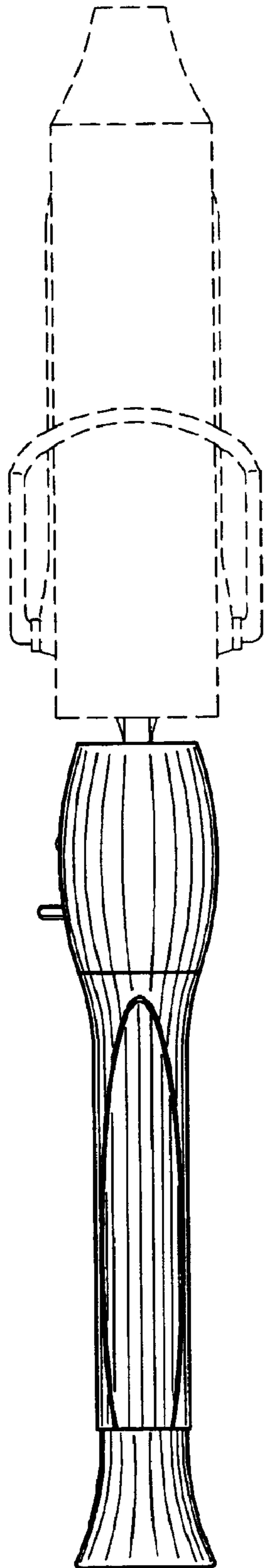
