(57) **CLAIM**

The ornamental design for set of a hip protector and three pairs of trousers for receiving and fixating the hip protector, as shown and described.

DESCRIPTION

FIG. 1 is a front view of one pair of trousers from the set of a hip protector and three pairs of trousers for receiving and fixating the hip protector;

FIG. 2 is a rear view of FIG. 1;

FIG. 3 is a front view of a second pair of trousers from the set;

FIG. 4 is a rear view of FIG. 3;

FIG. 5 is a front view of a third pair of trousers from the set;

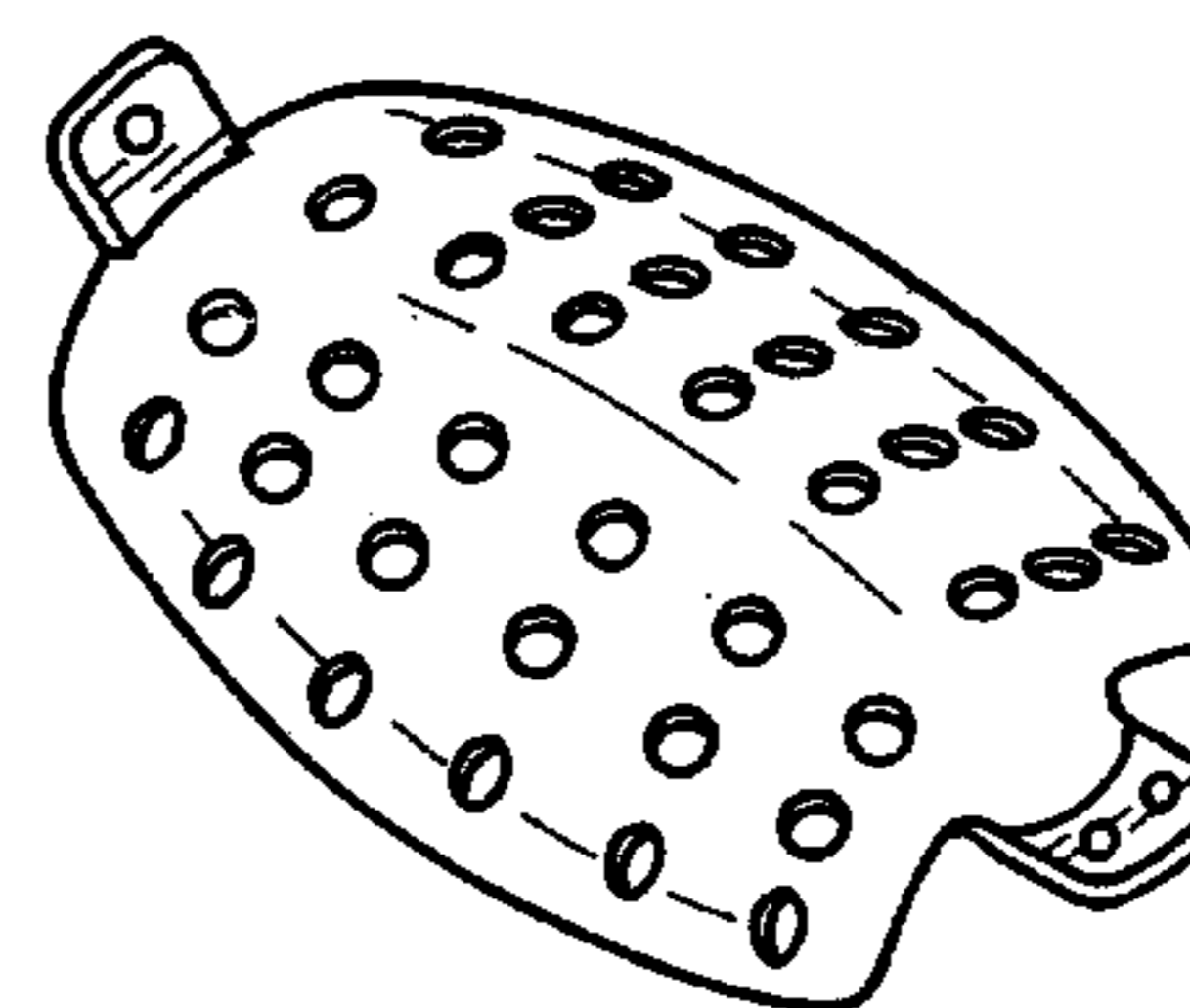
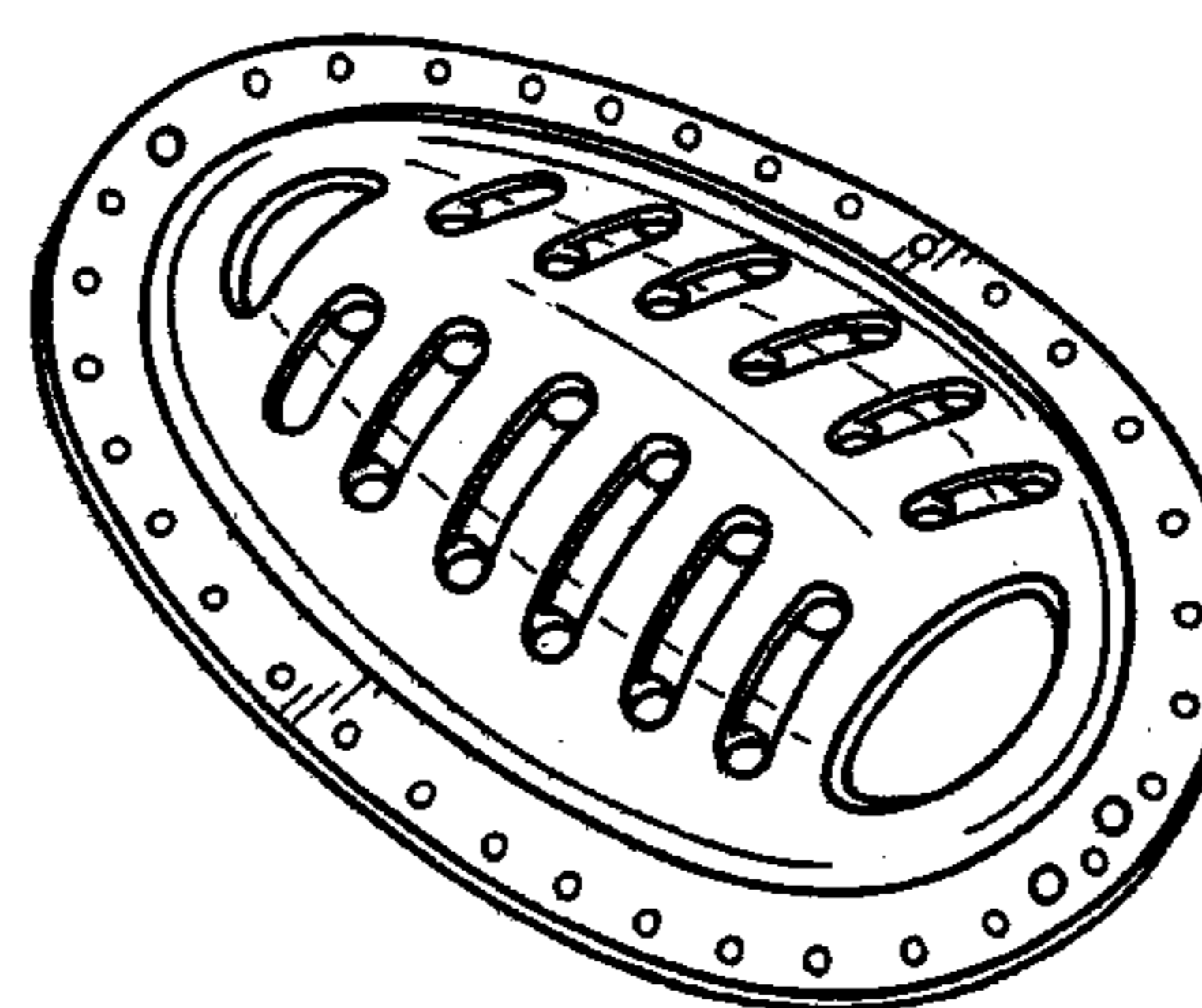
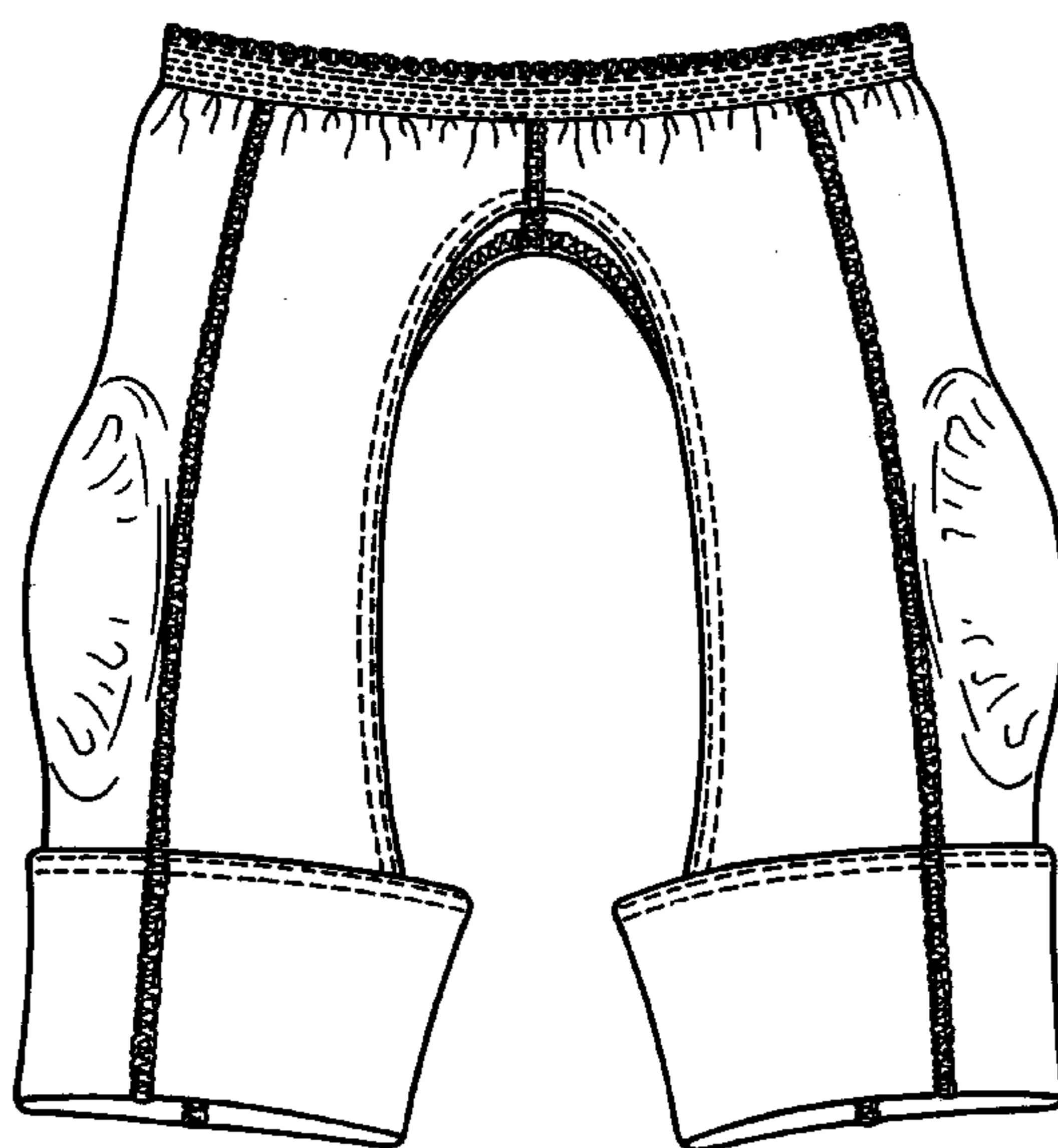
FIG. 6 is a rear view of FIG. 5;

FIG. 7 is a top perspective view of the hip protector shown in an exploded condition; and,

FIG. 8 is a bottom perspective view of the hip protector shown in an exploded condition with the separated parts shown in an alternate arrangement.

The broken lines shown on the three pairs of trousers represent stitching that does form part of the claimed design.

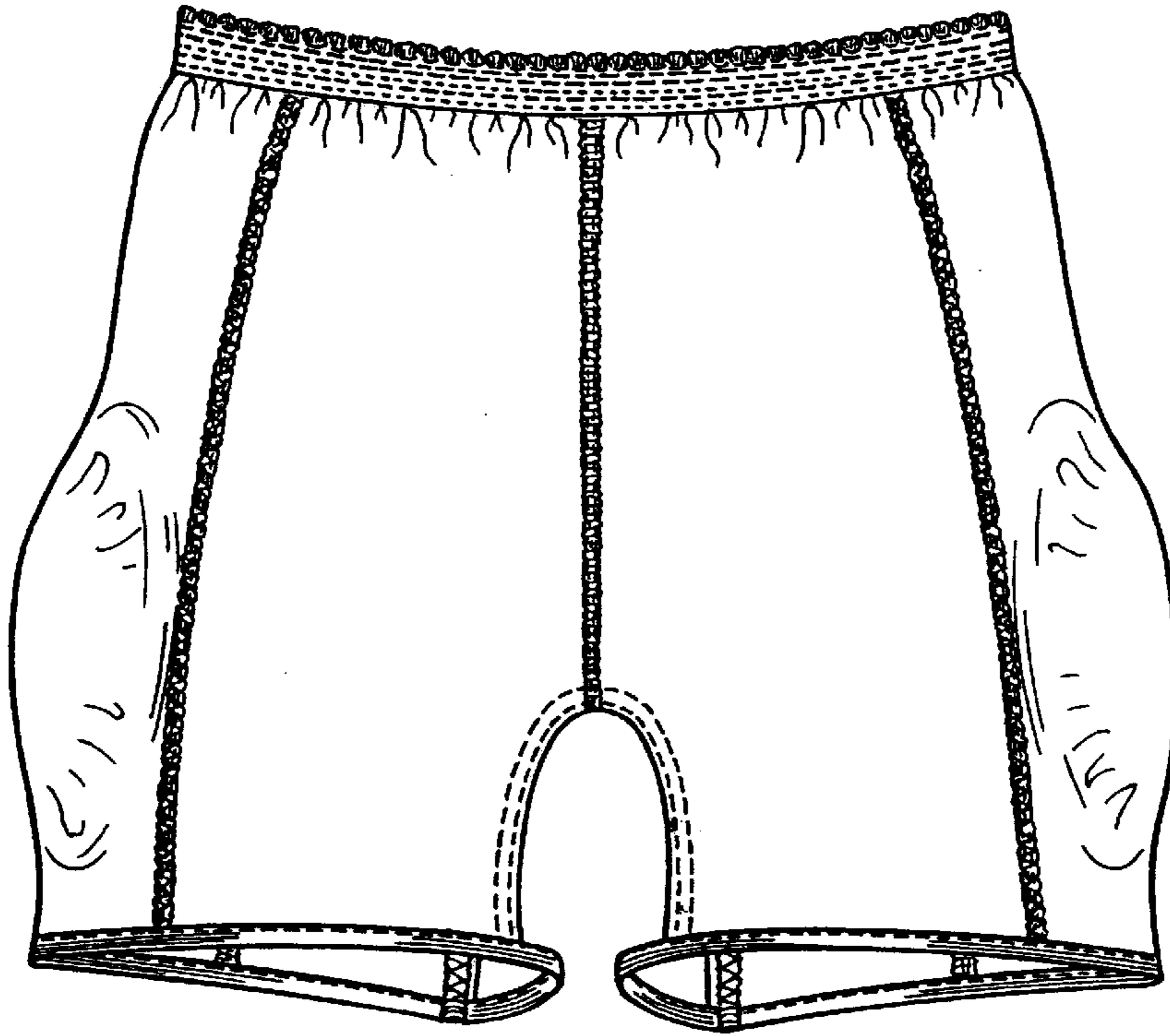

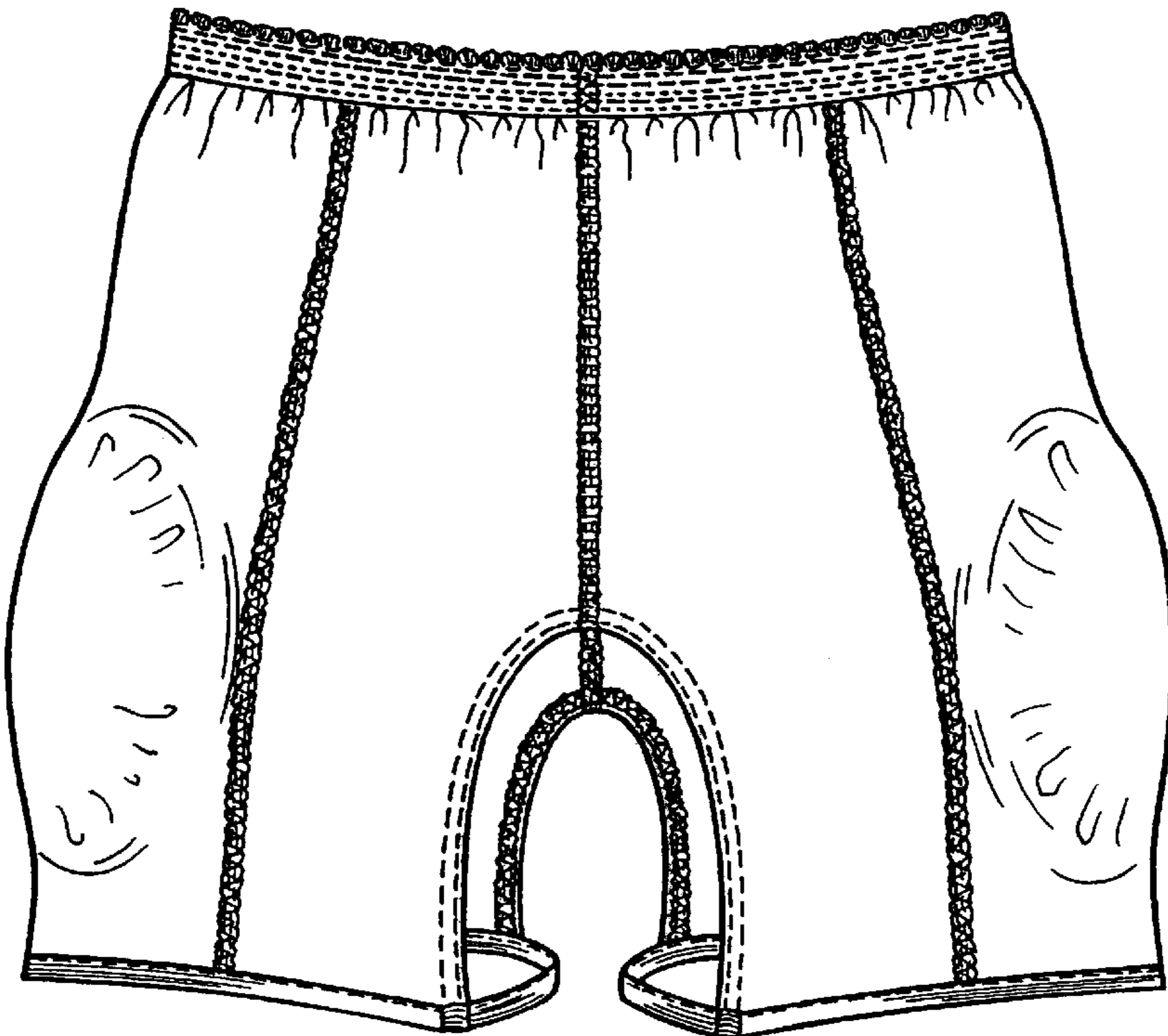

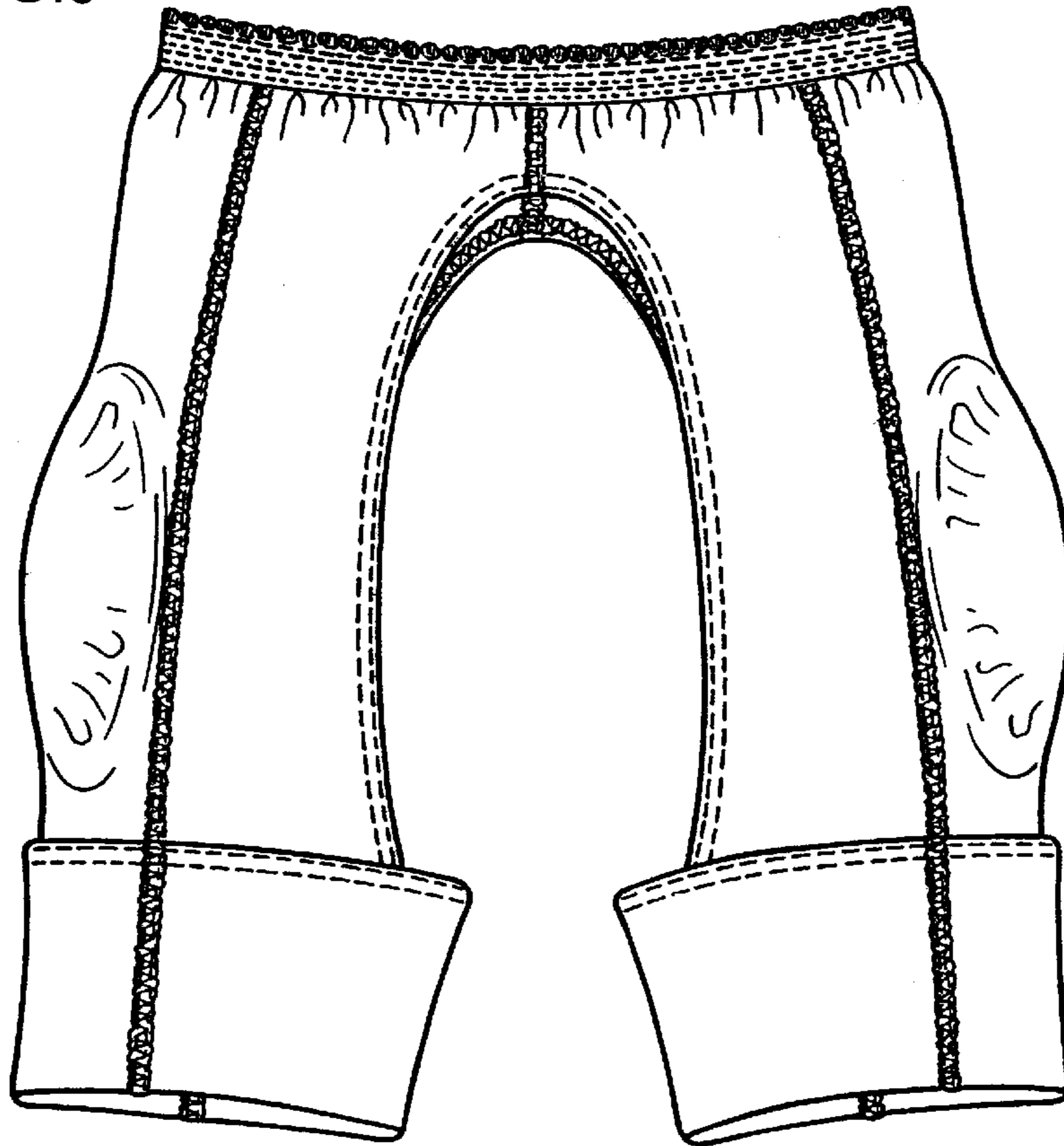

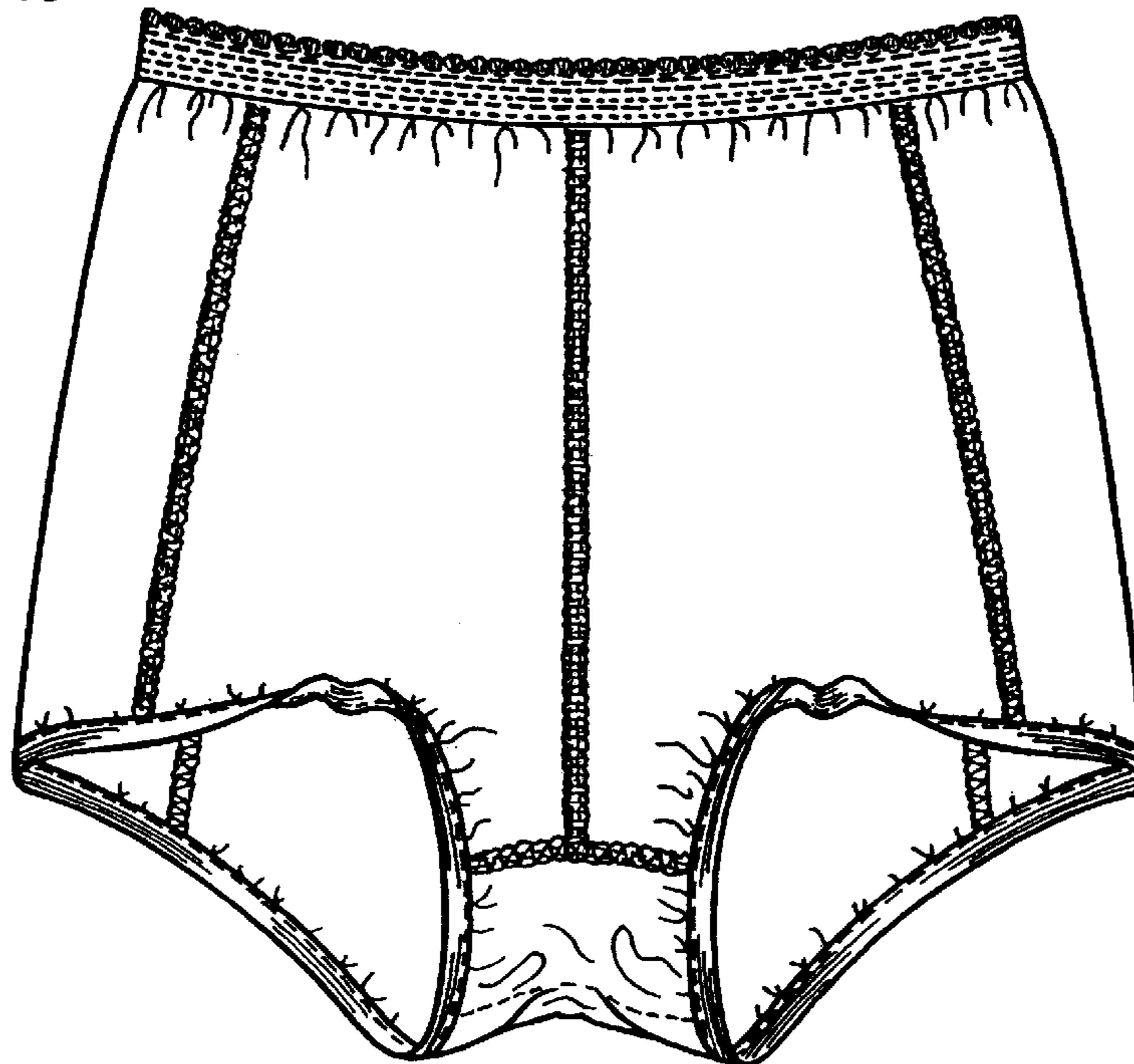

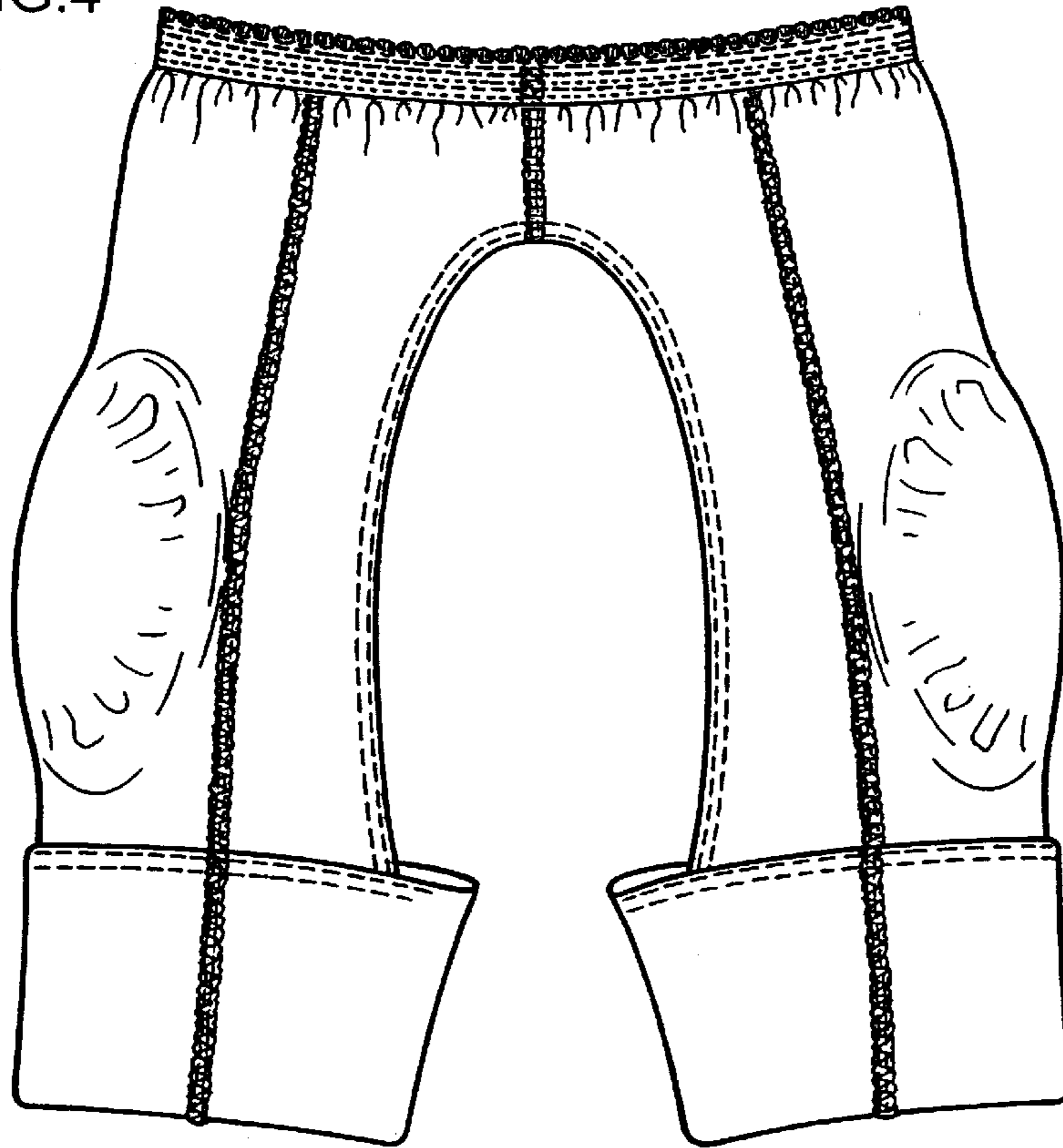

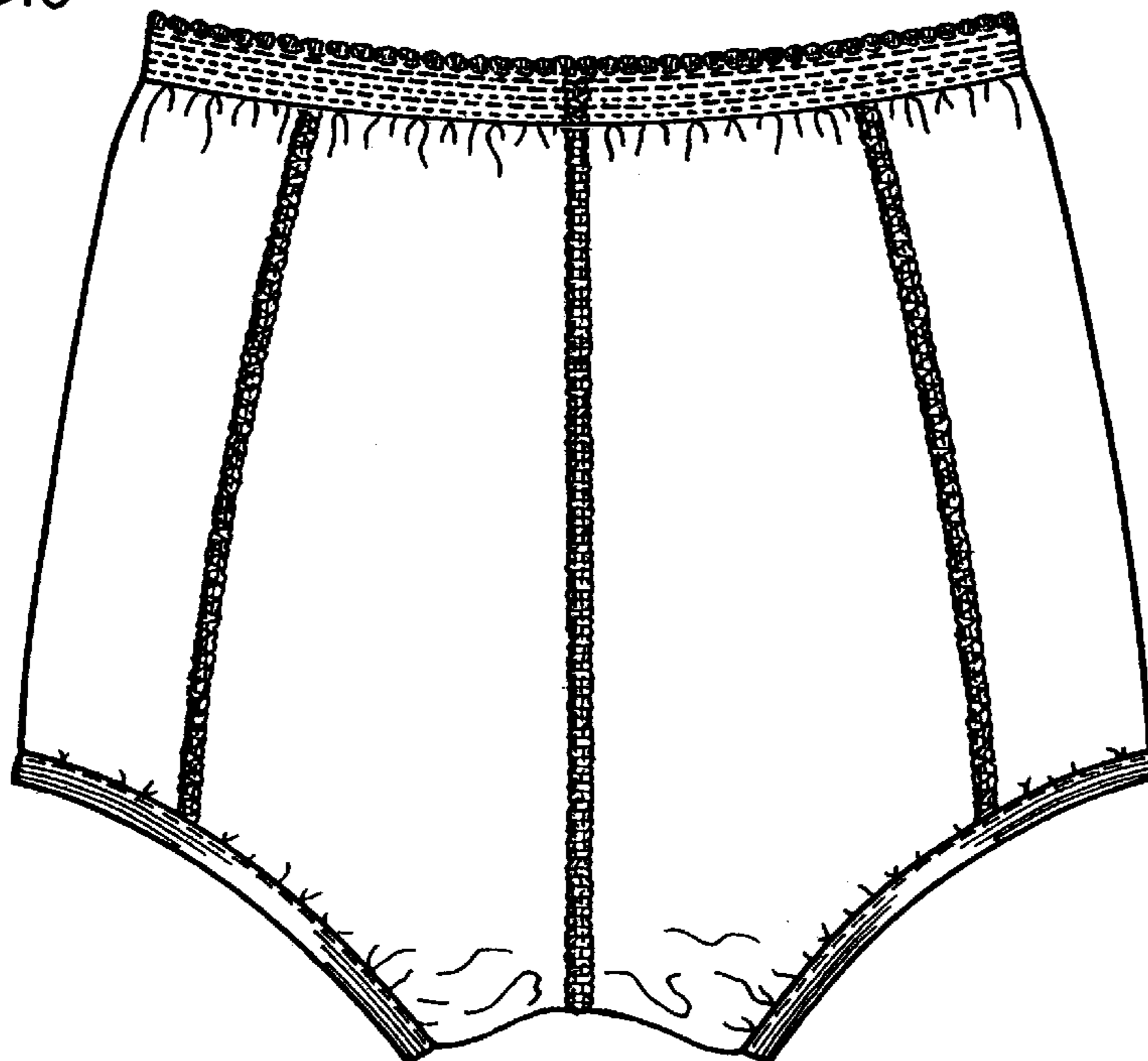

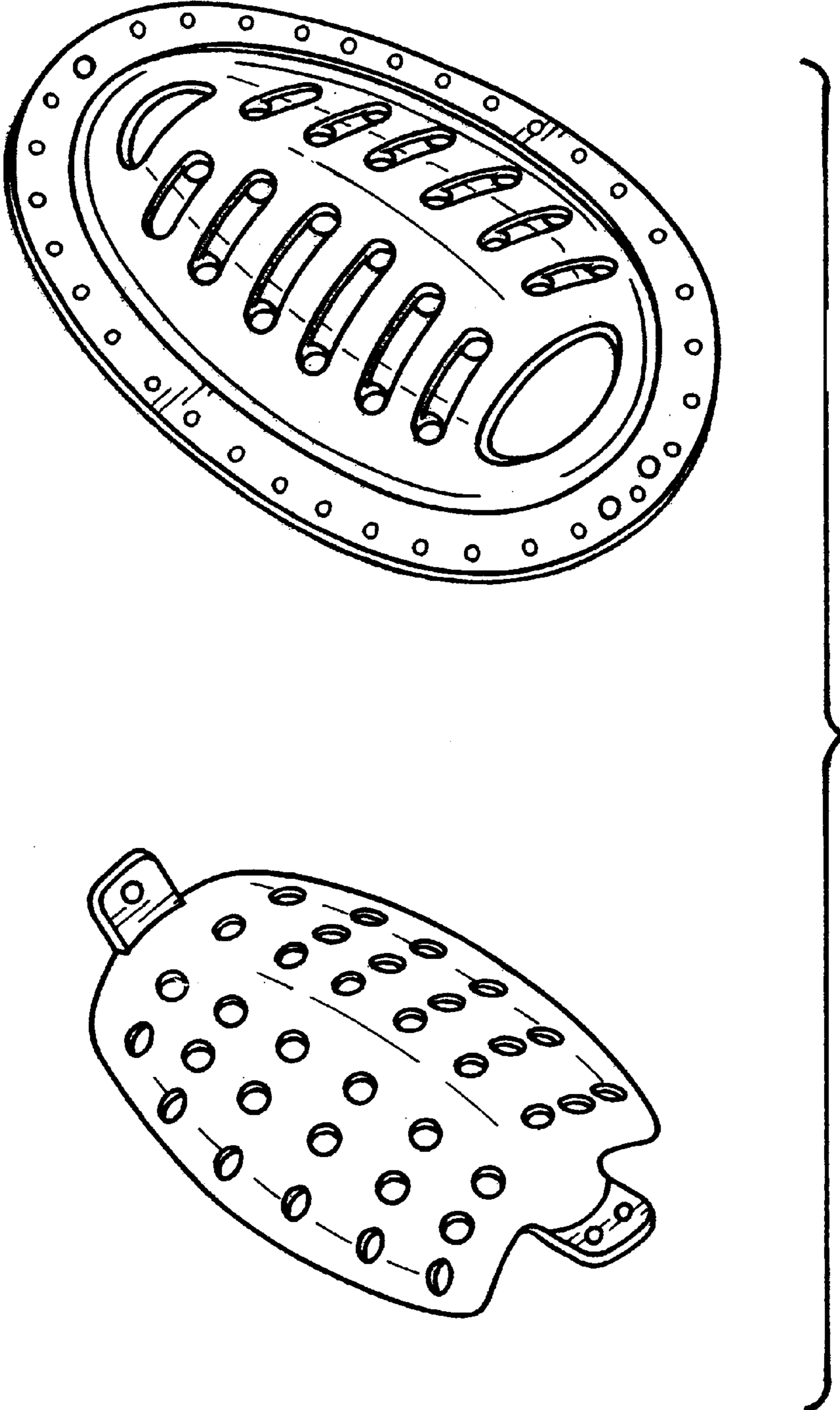
