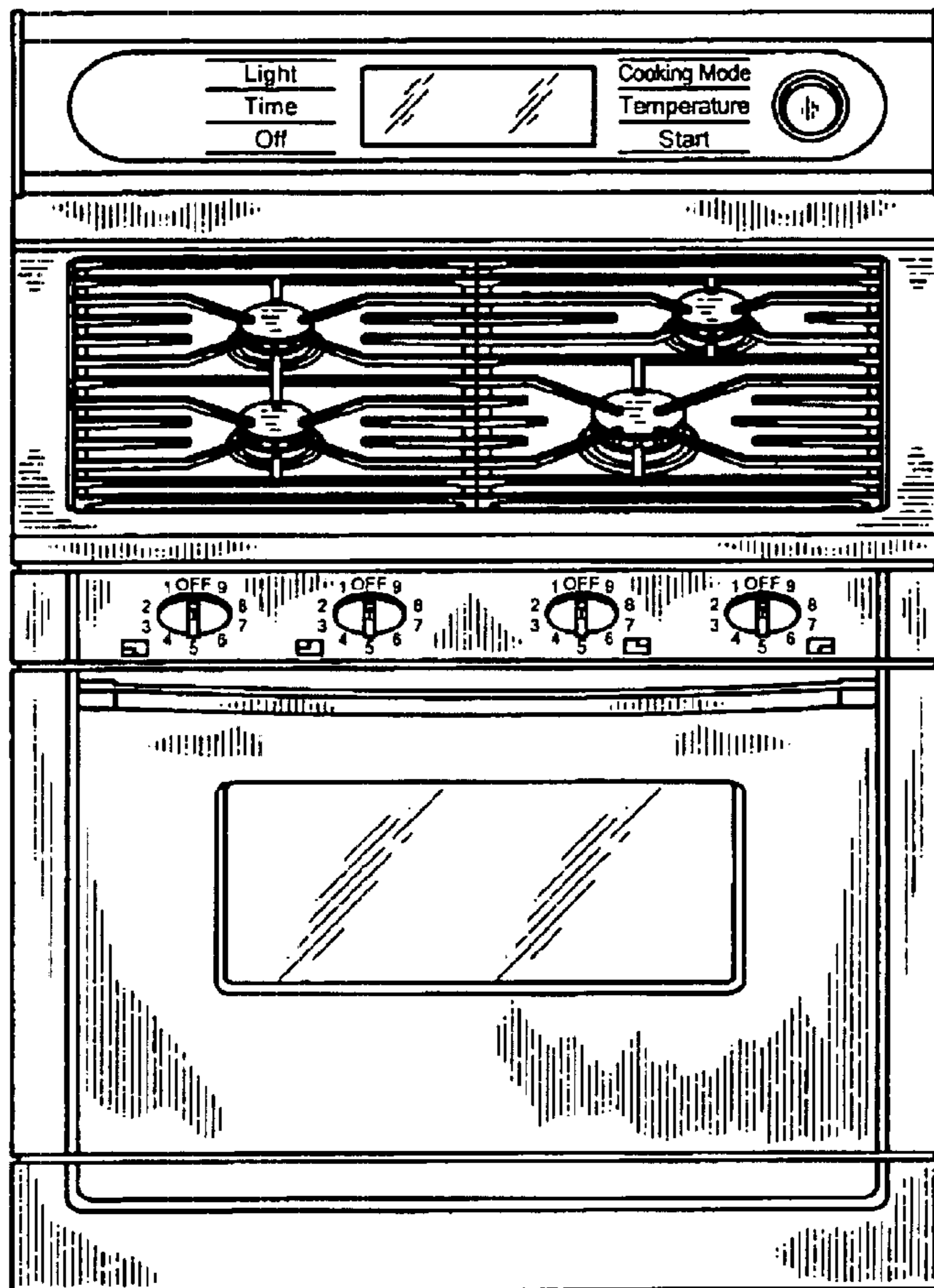
FIG. 1 is a perspective view of a gas cooking appliance showing my ornamental design;

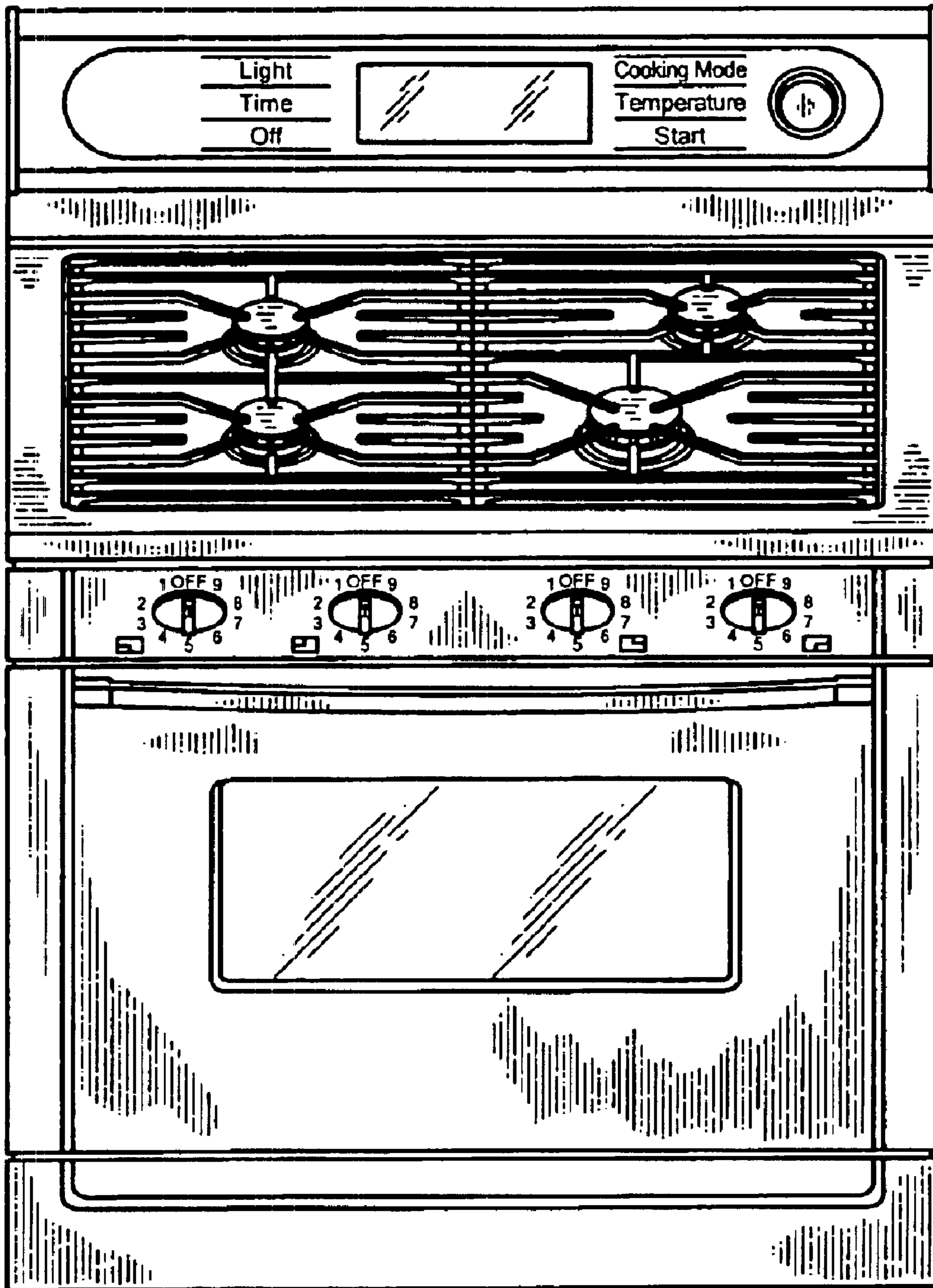

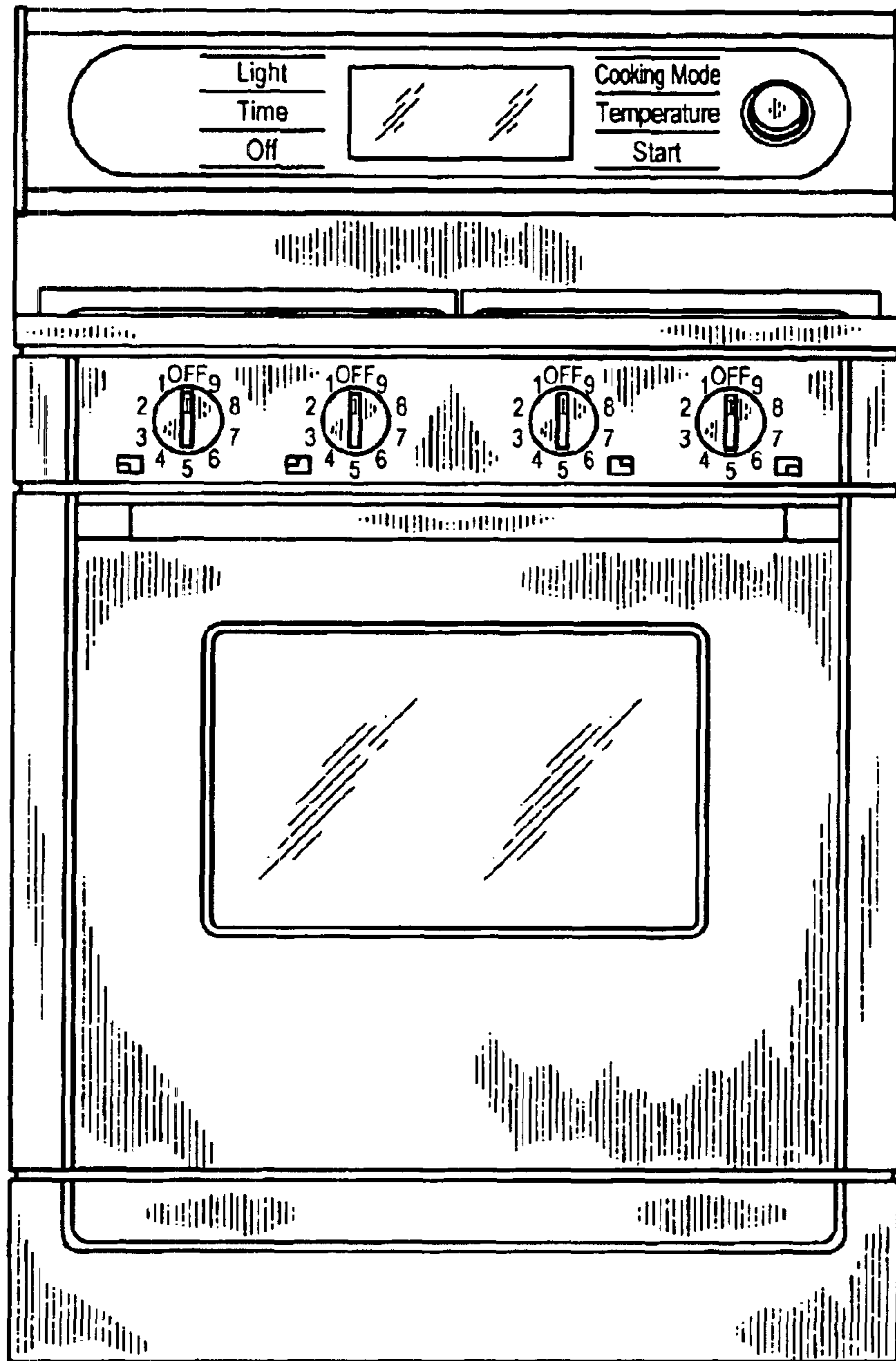

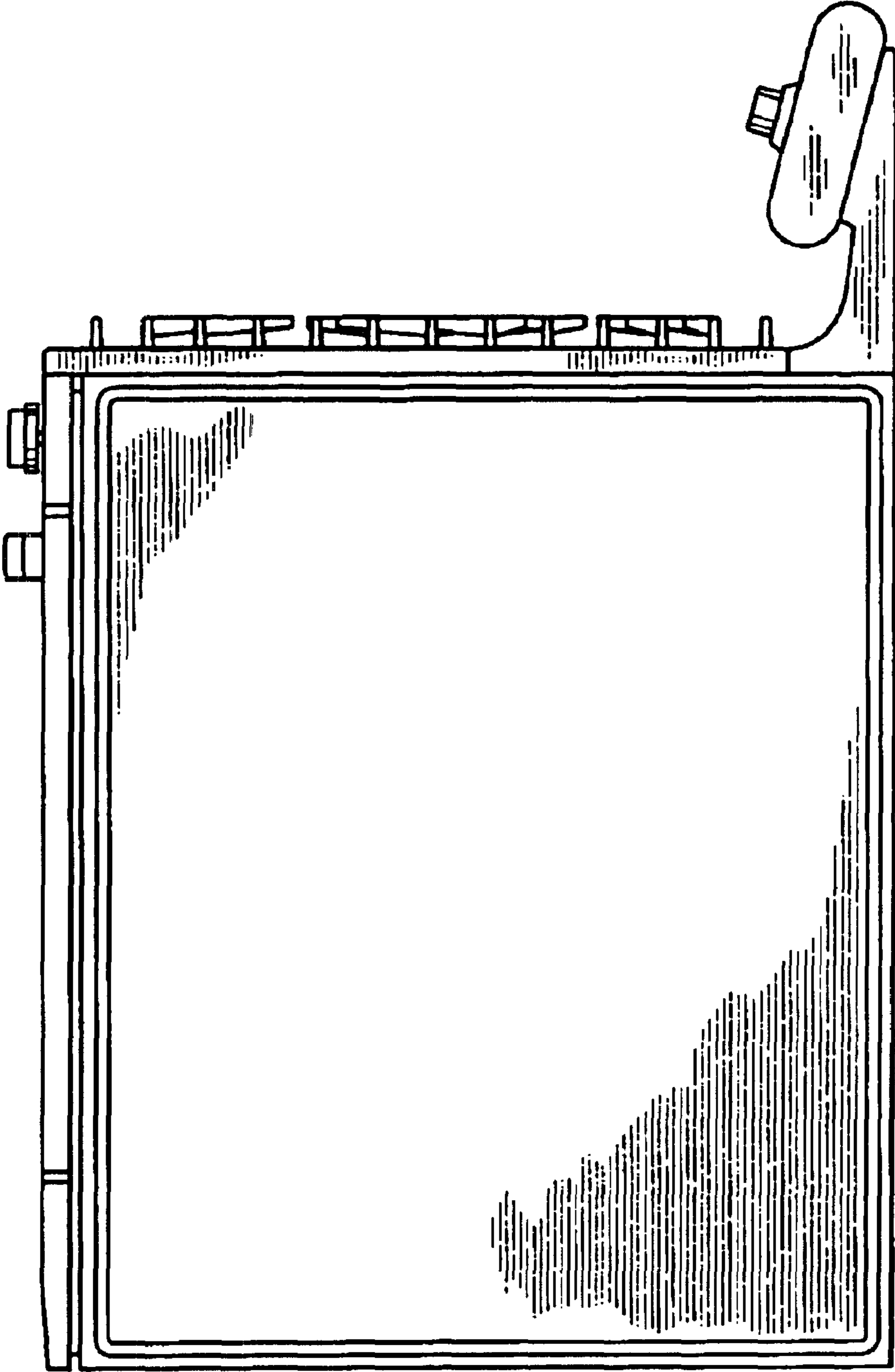

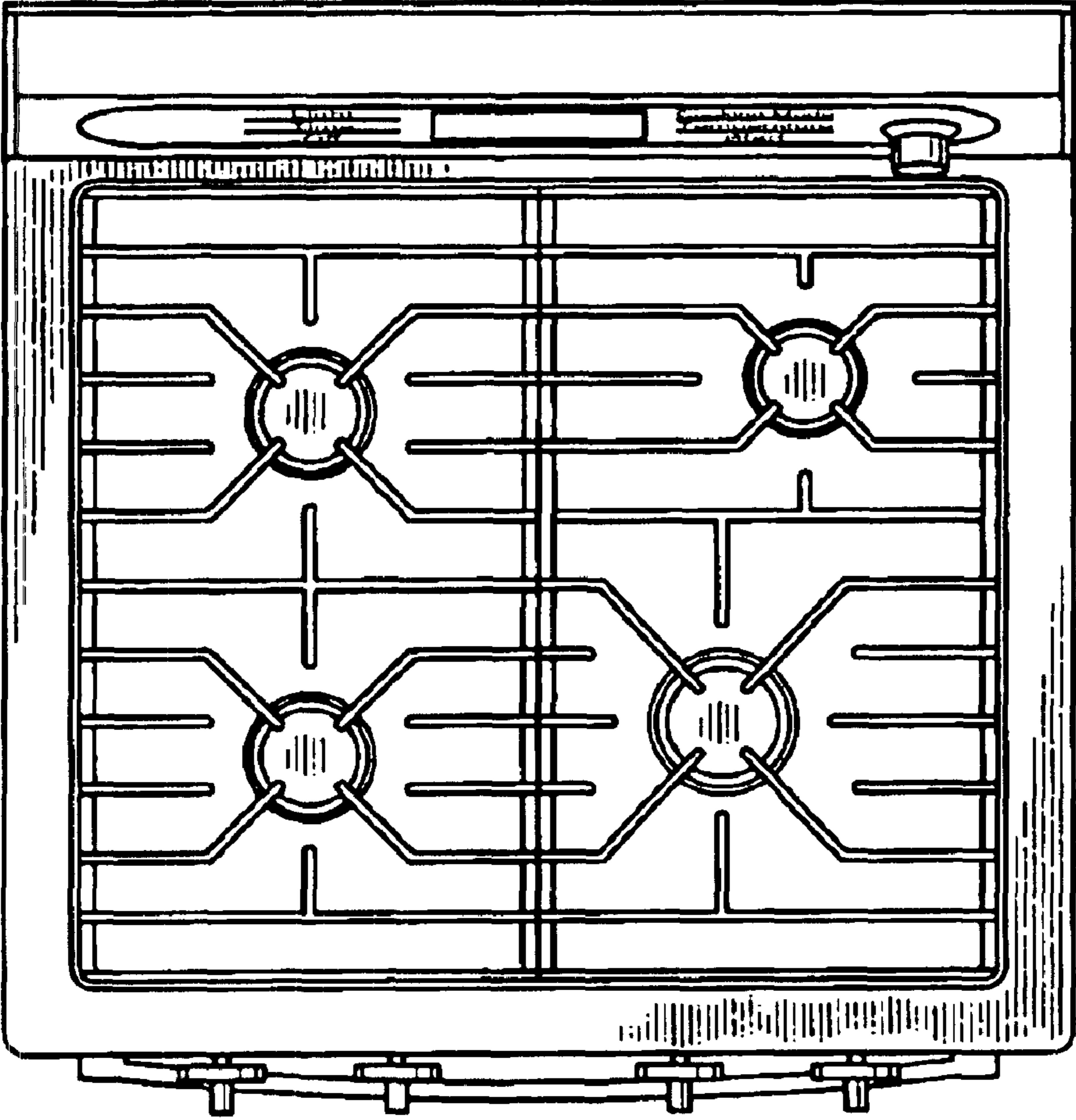
