FIG. 3 is a back elevational view of the tray of FIG. 1;

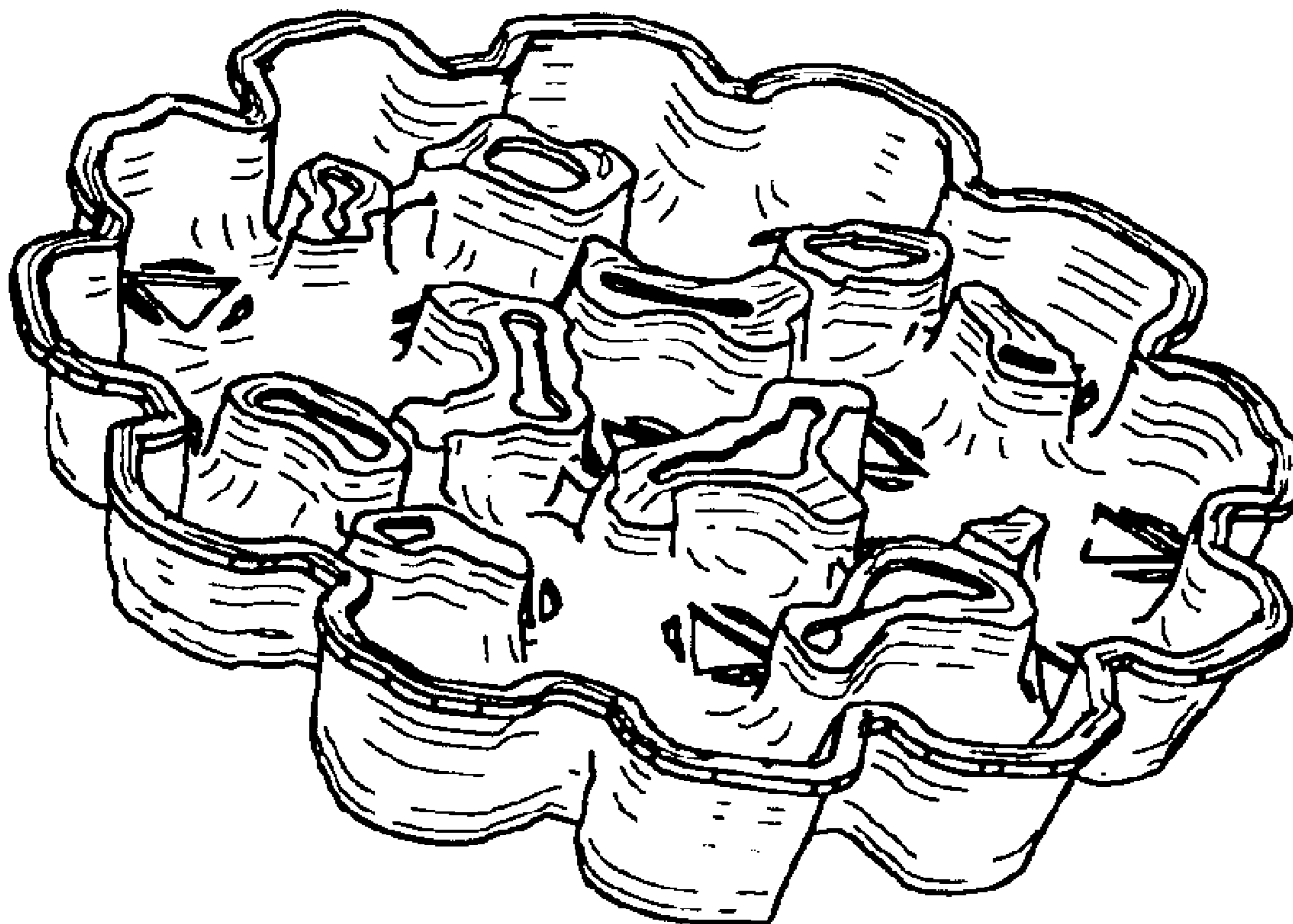
FIG. 4 is a left elevational view of the tray of FIG. 1;

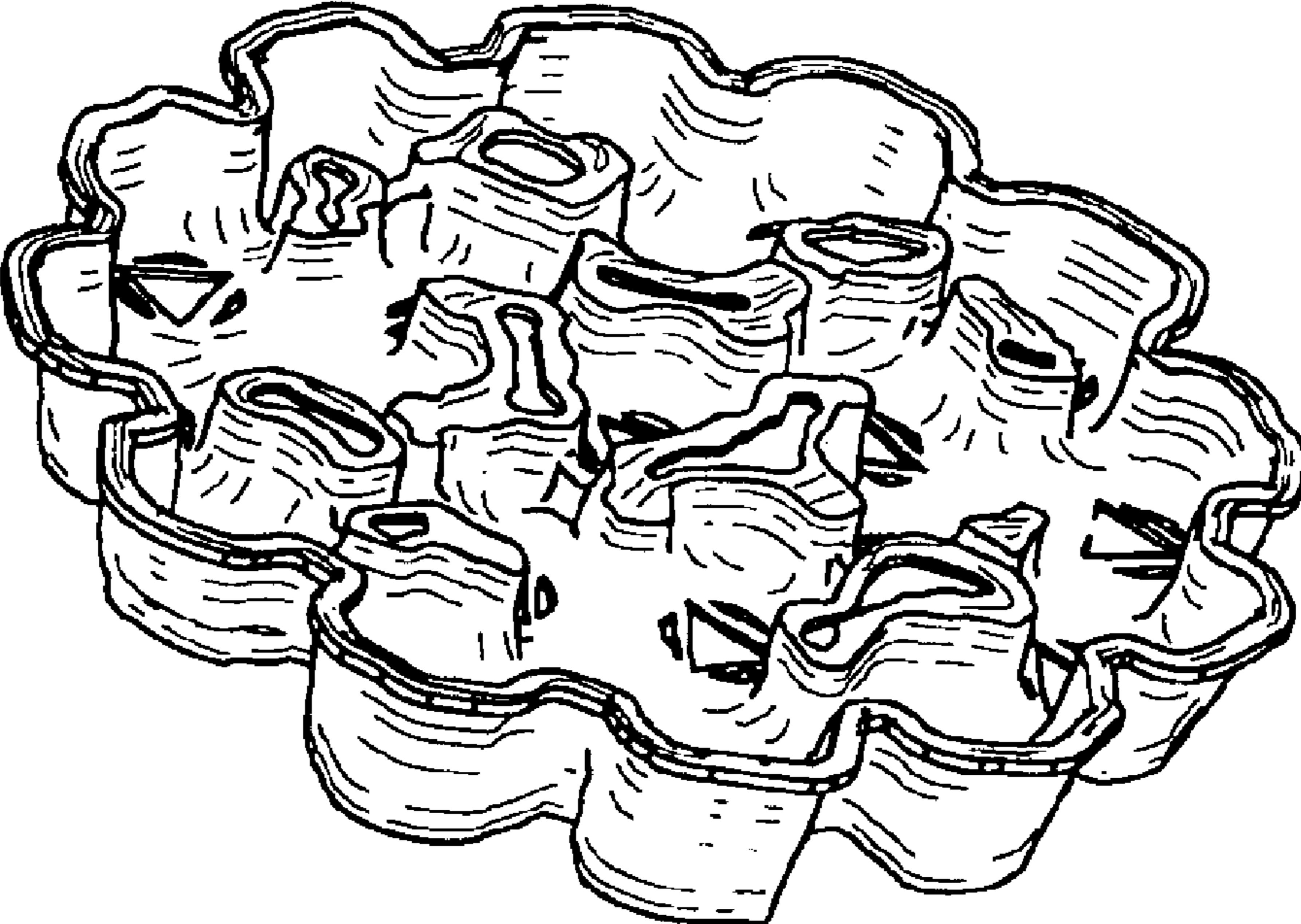

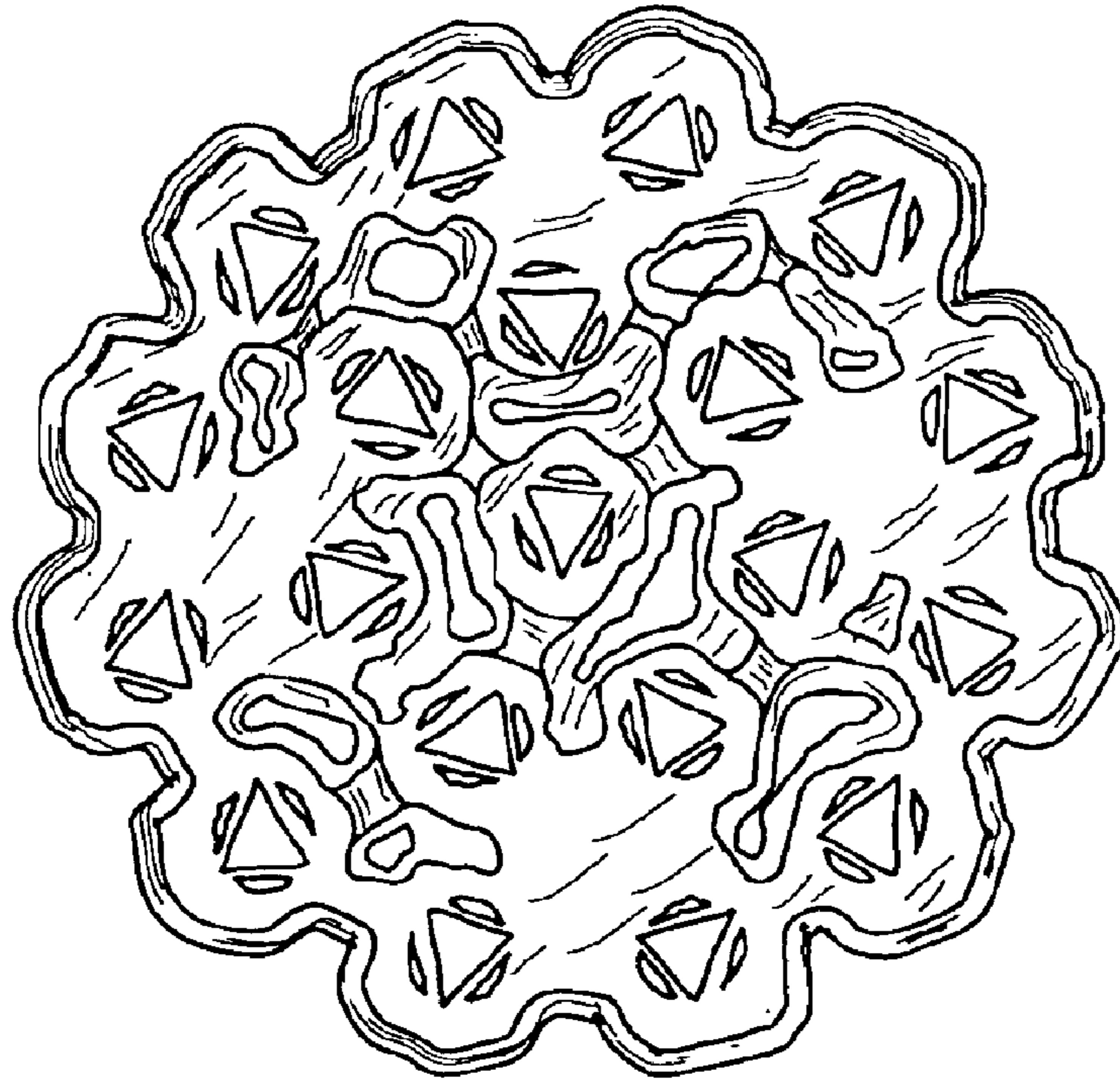

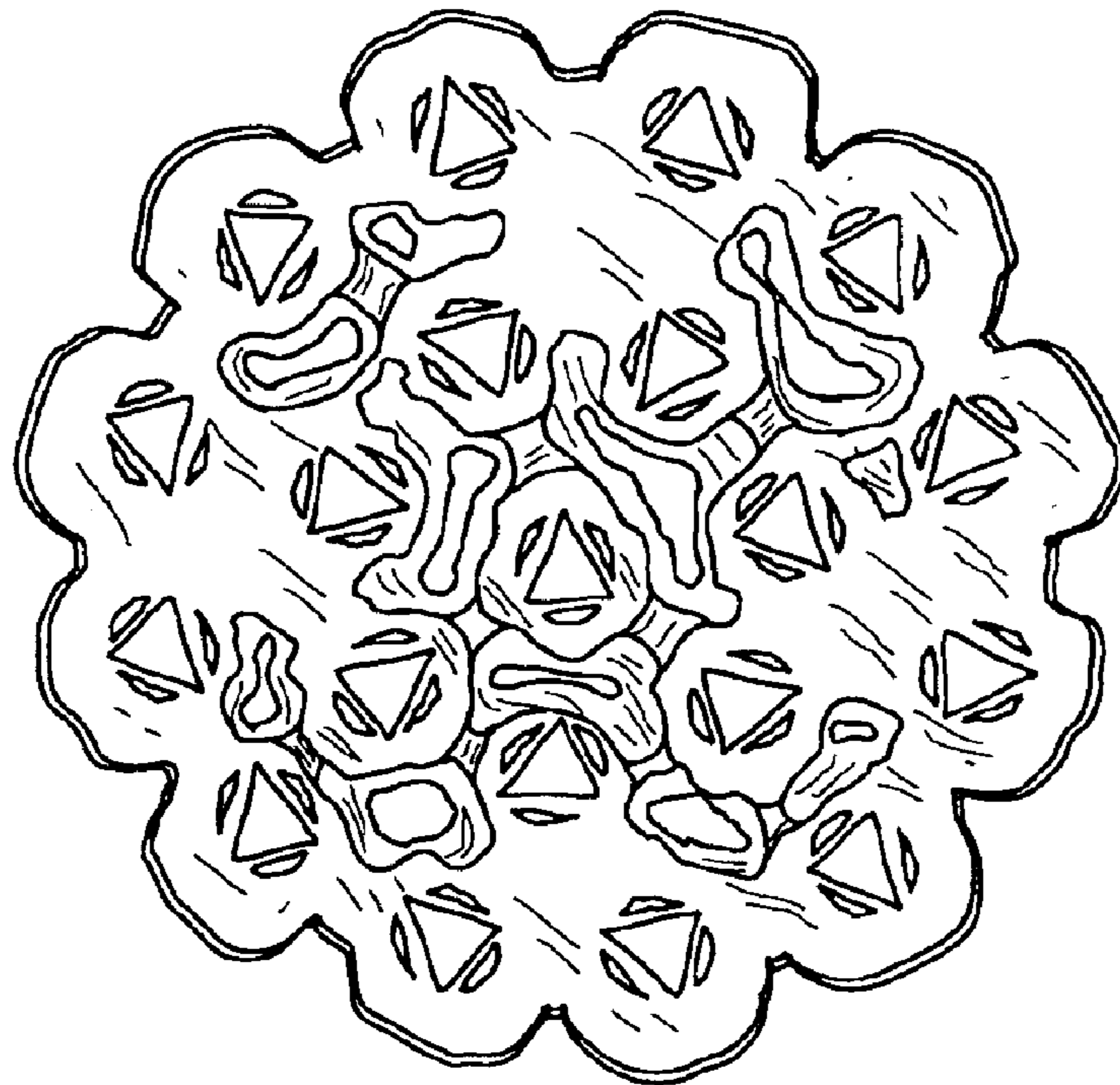
