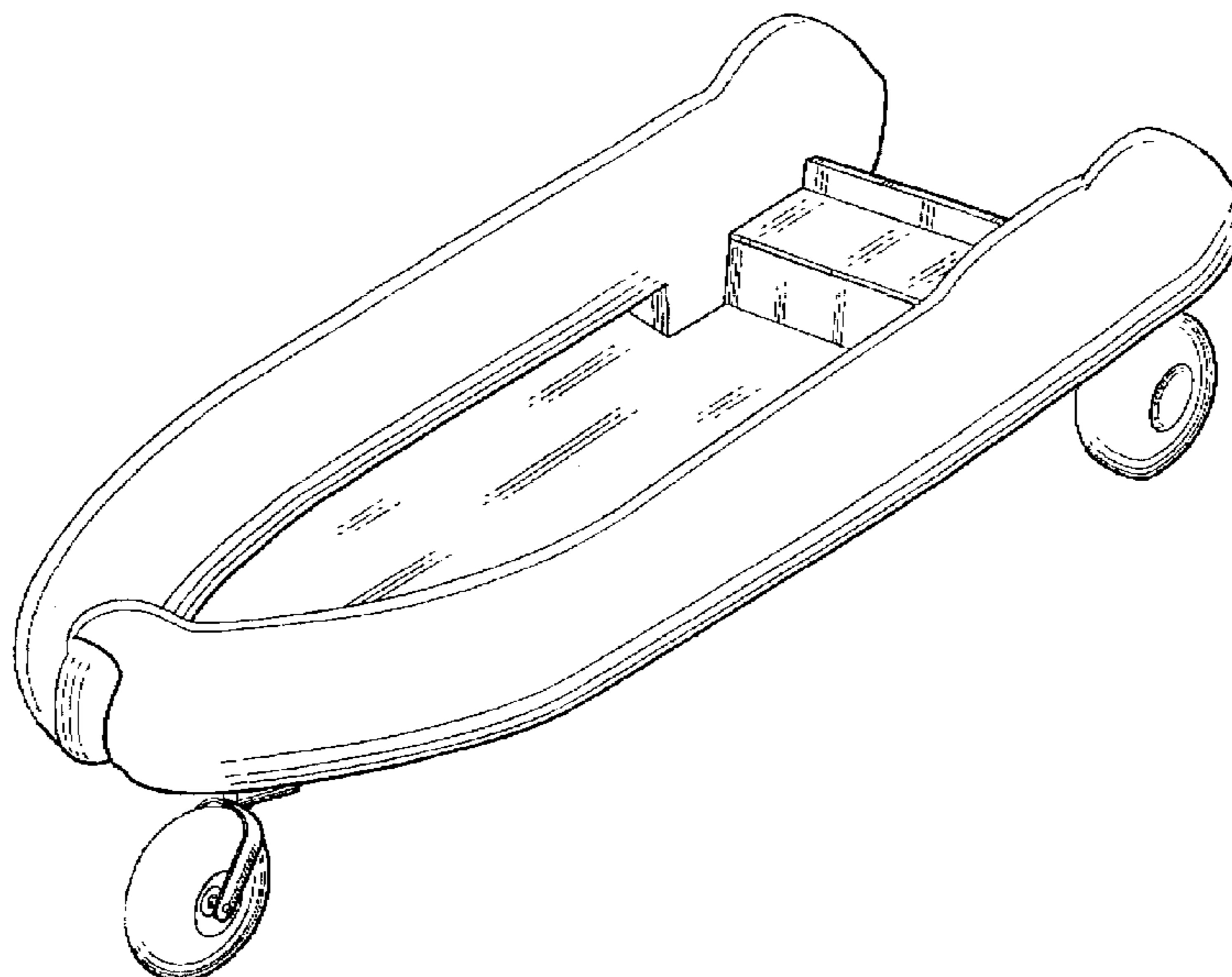
(57) **CLAIM**

The ornamental design for a boat, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a boat, showing my new design with the wheels up,
 FIG. 2 is a bottom view thereof, with wheels up,
 FIG. 3 is a top plan view thereof, with the wheels down,
 FIG. 4 is a bottom view thereof, with wheels down,
 FIG. 5 is a left side elevation view thereof, with wheels up,
 FIG. 6 is a right side elevation view thereof, with wheels up,
 FIG. 7 is a left side elevation view thereof, with wheels down,
 FIG. 8 is a right side elevation view thereof, with wheels down,
 FIG. 9 is a front elevation view thereof, with wheels up
 FIG. 10 is a rear elevation view thereof, with wheels up
 FIG. 11 is a front elevation view thereof, with wheels down
 FIG. 12 is a rear elevation view thereof, with wheels down
 FIG. 13 is a front top left perspective view thereof, with wheels up,
 FIG. 14 is a front top left perspective view thereof, with wheels down,
 FIG. 15 is a rear top left perspective view thereof, with wheels up,
 FIG. 16 is a rear top left perspective view thereof, with wheels down,
 FIG. 17 is a front left bottom perspective view thereof, with wheels up; and,
 FIG. 18 is a front left bottom perspective view thereof, with wheels down, and the boat has a retractable undercarriage system, and the accompanying drawings show the appearance of the boat with its wheels up, and the appearance of the same boat with its wheels down.

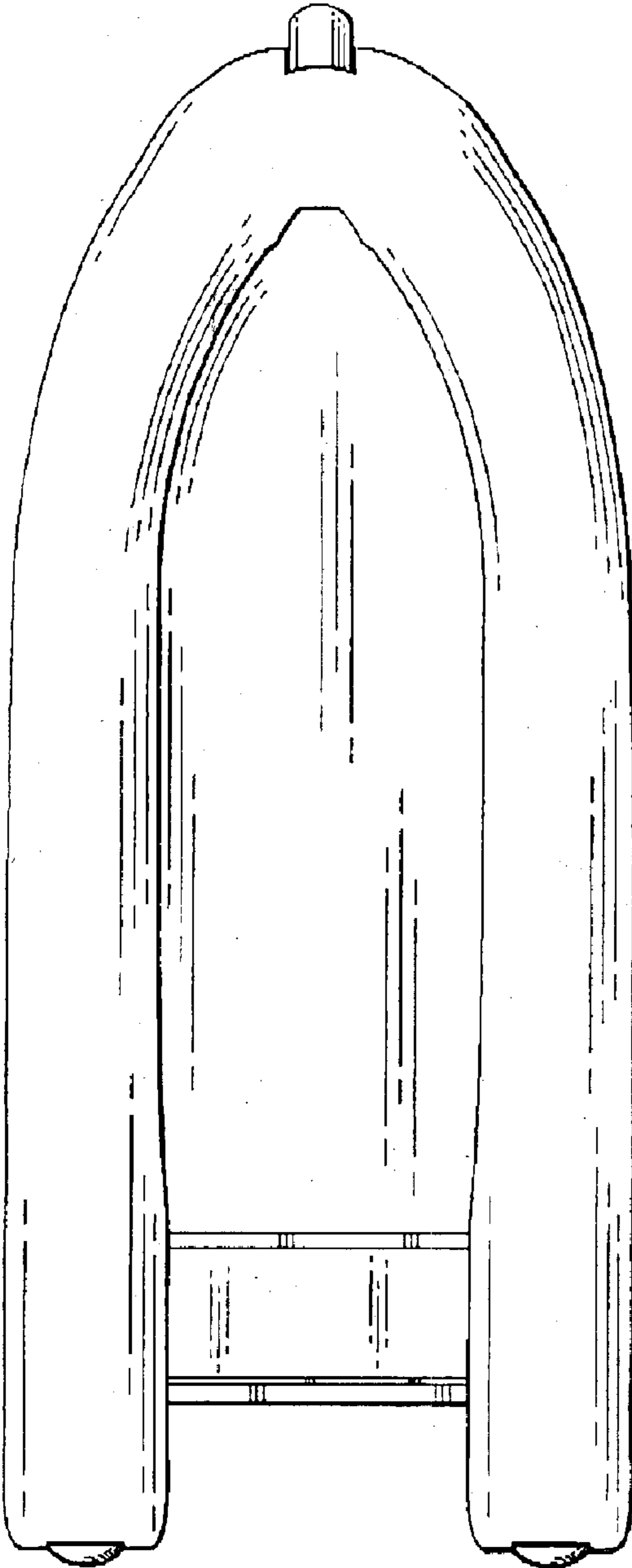

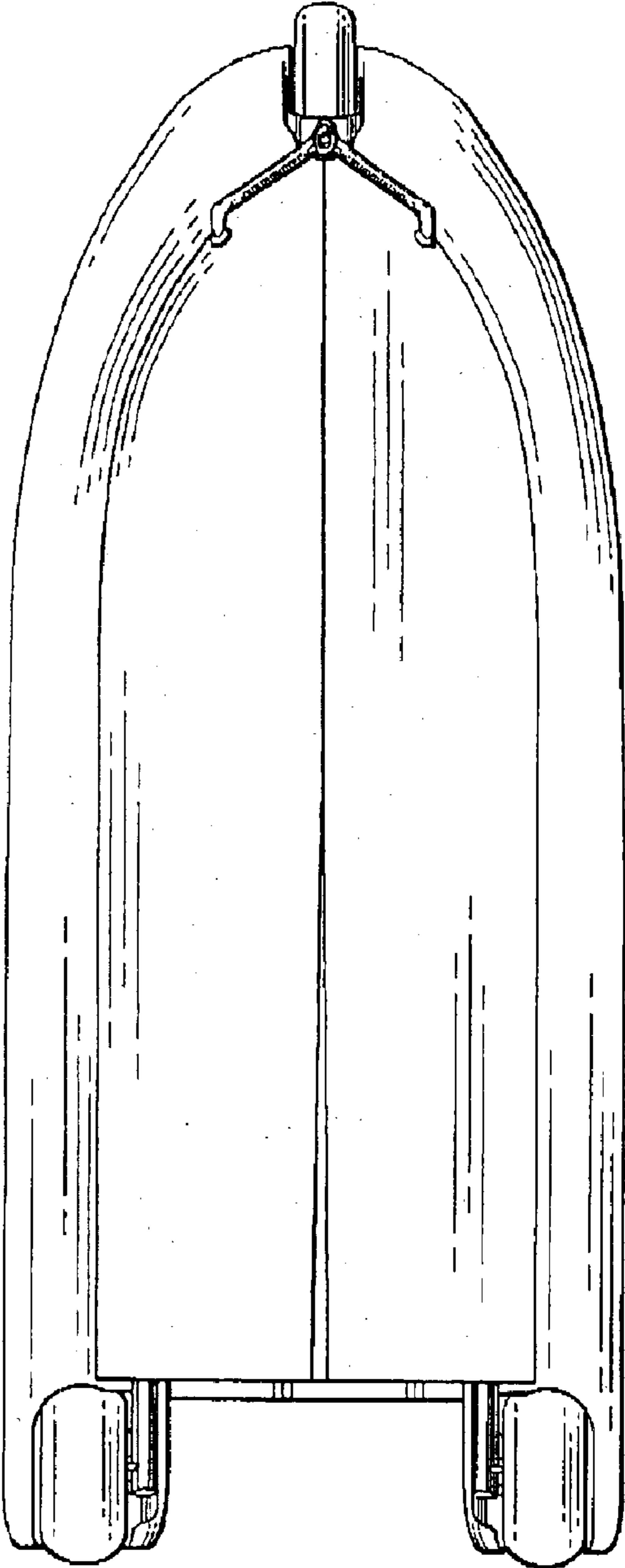

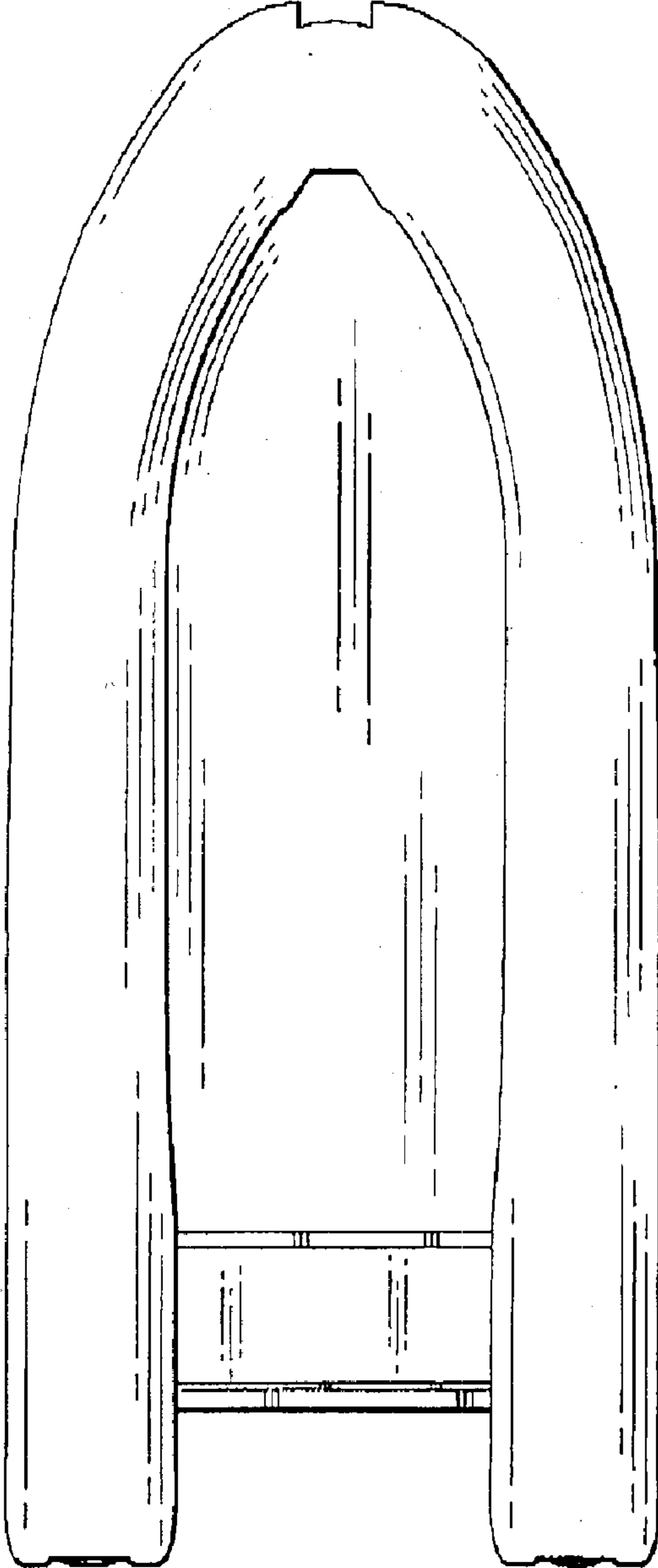

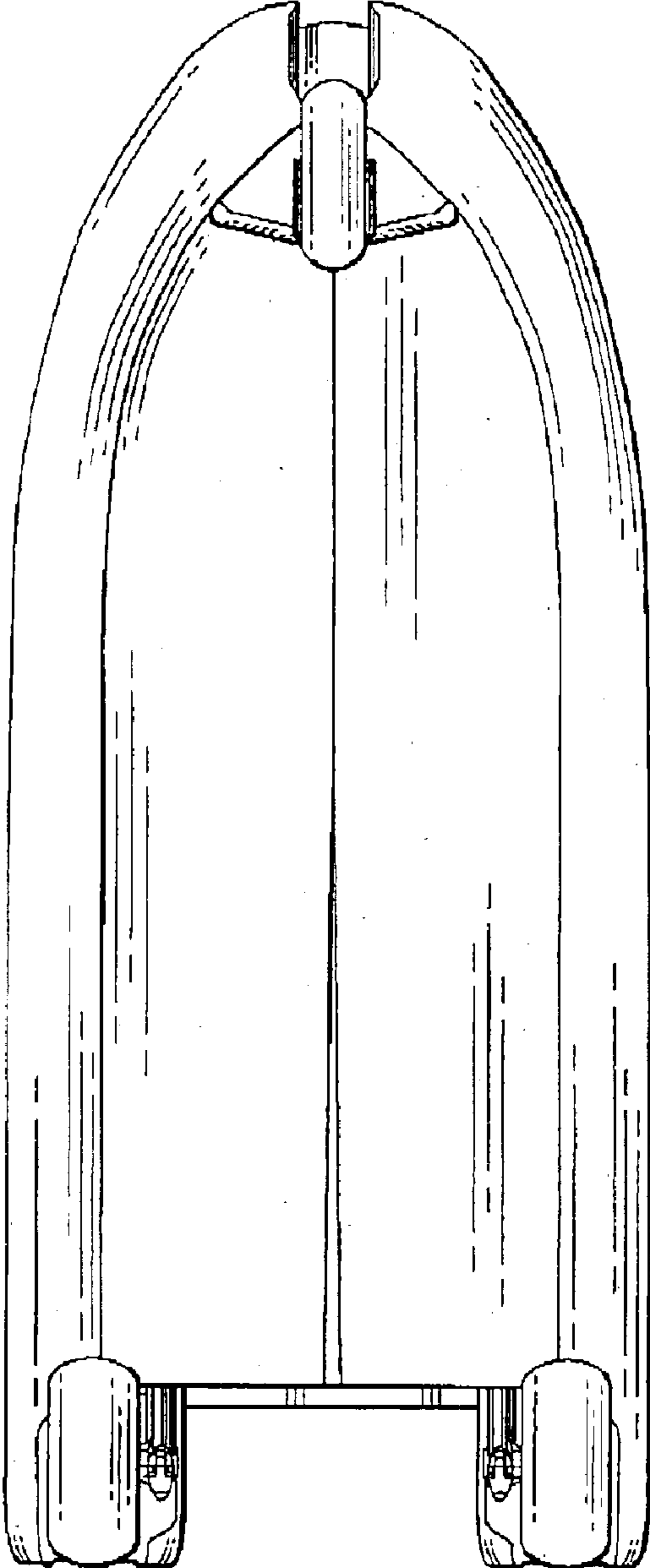

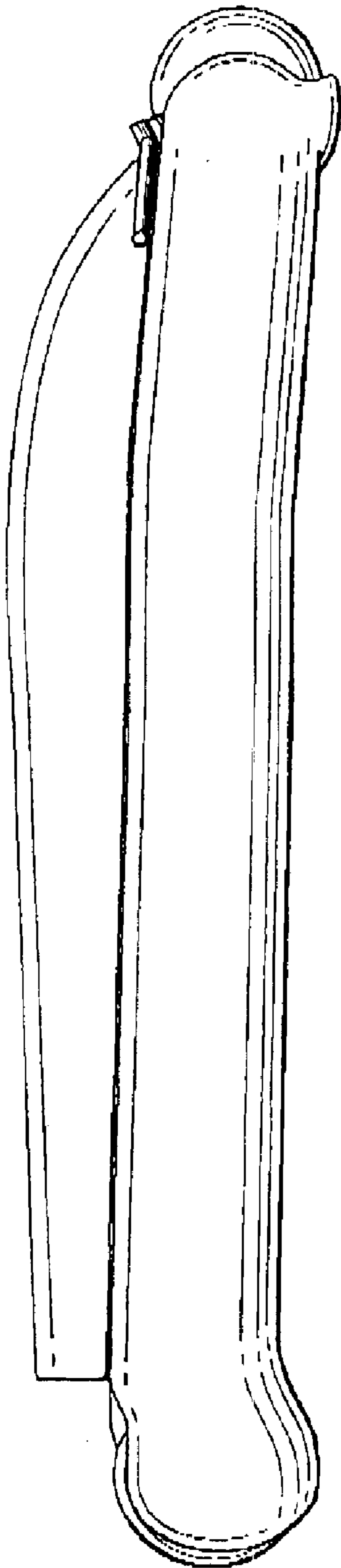

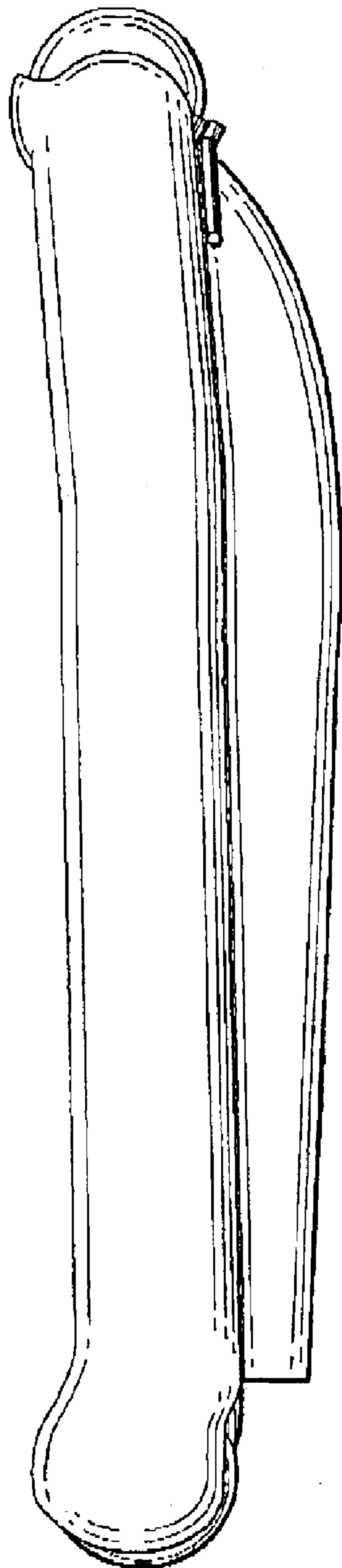

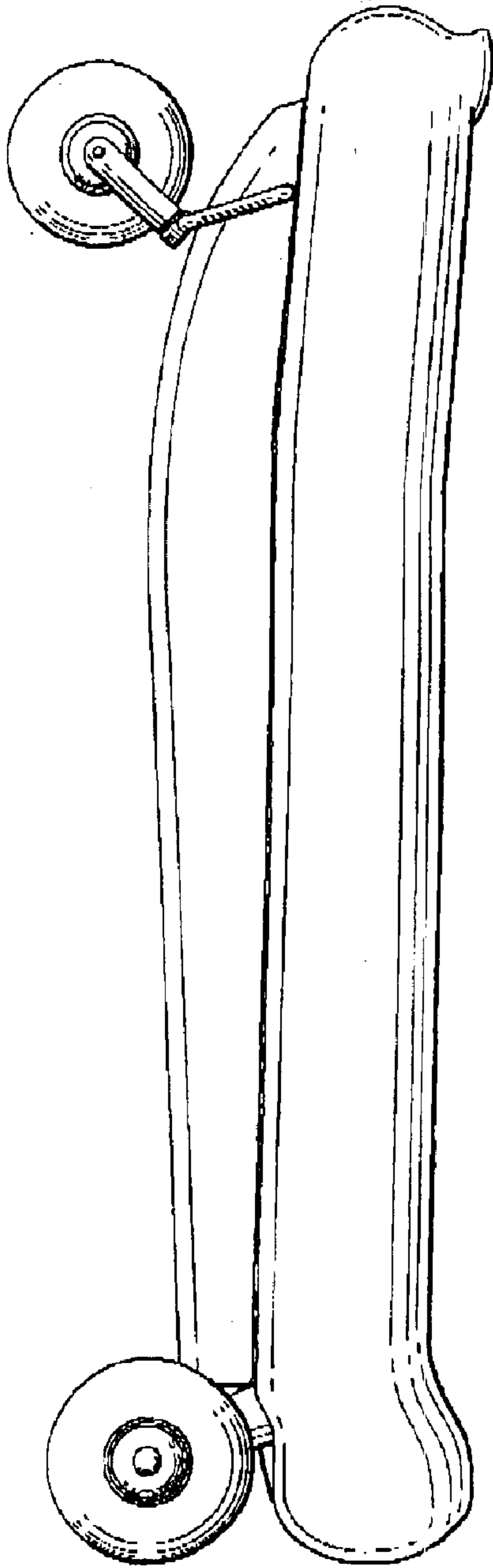

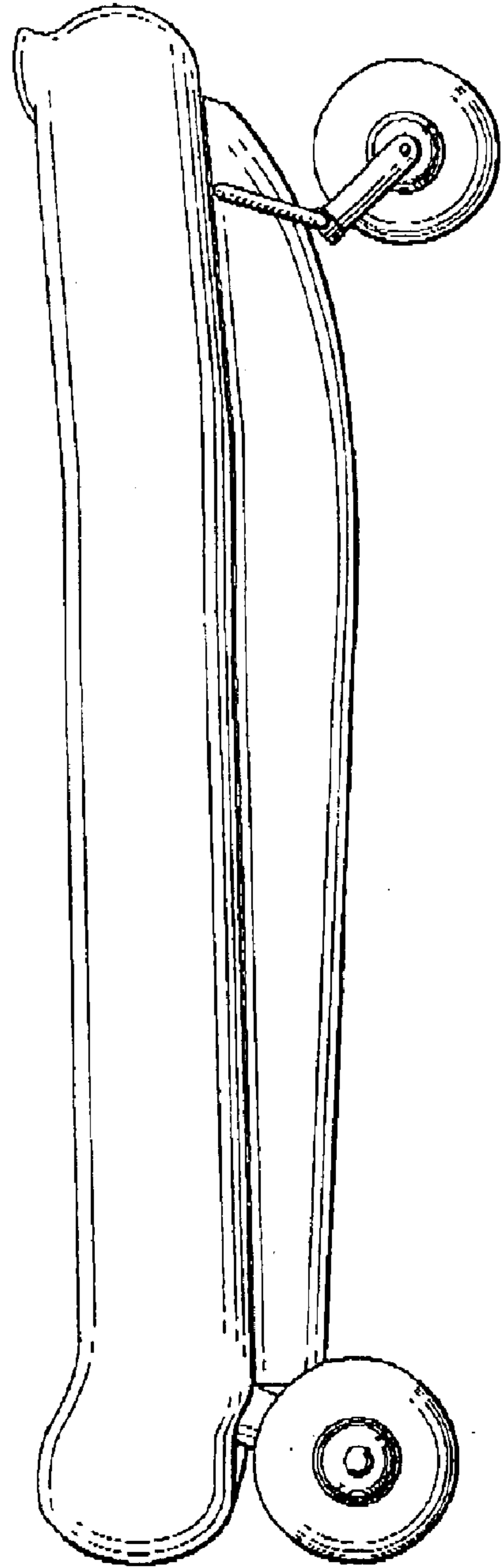

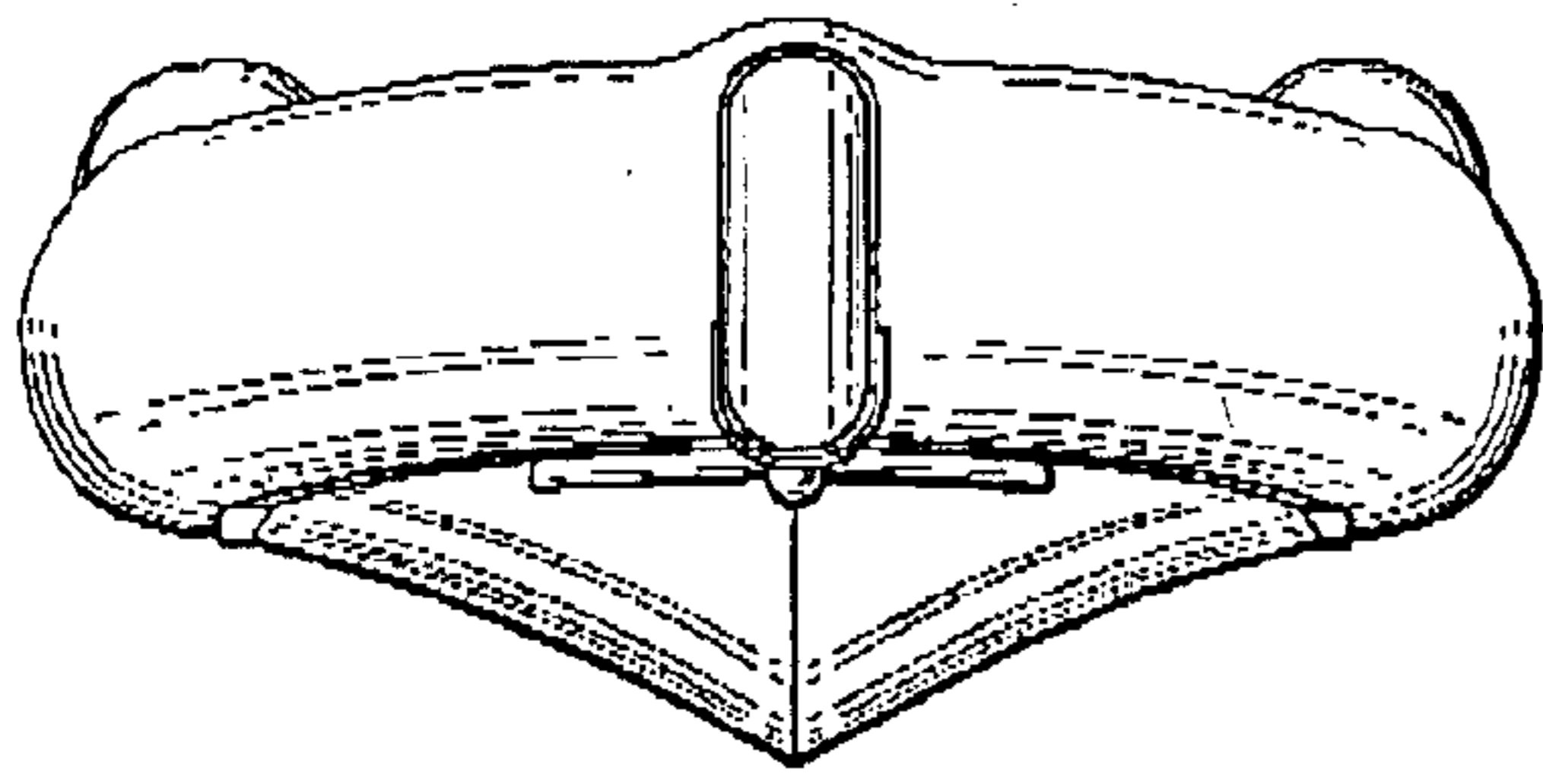

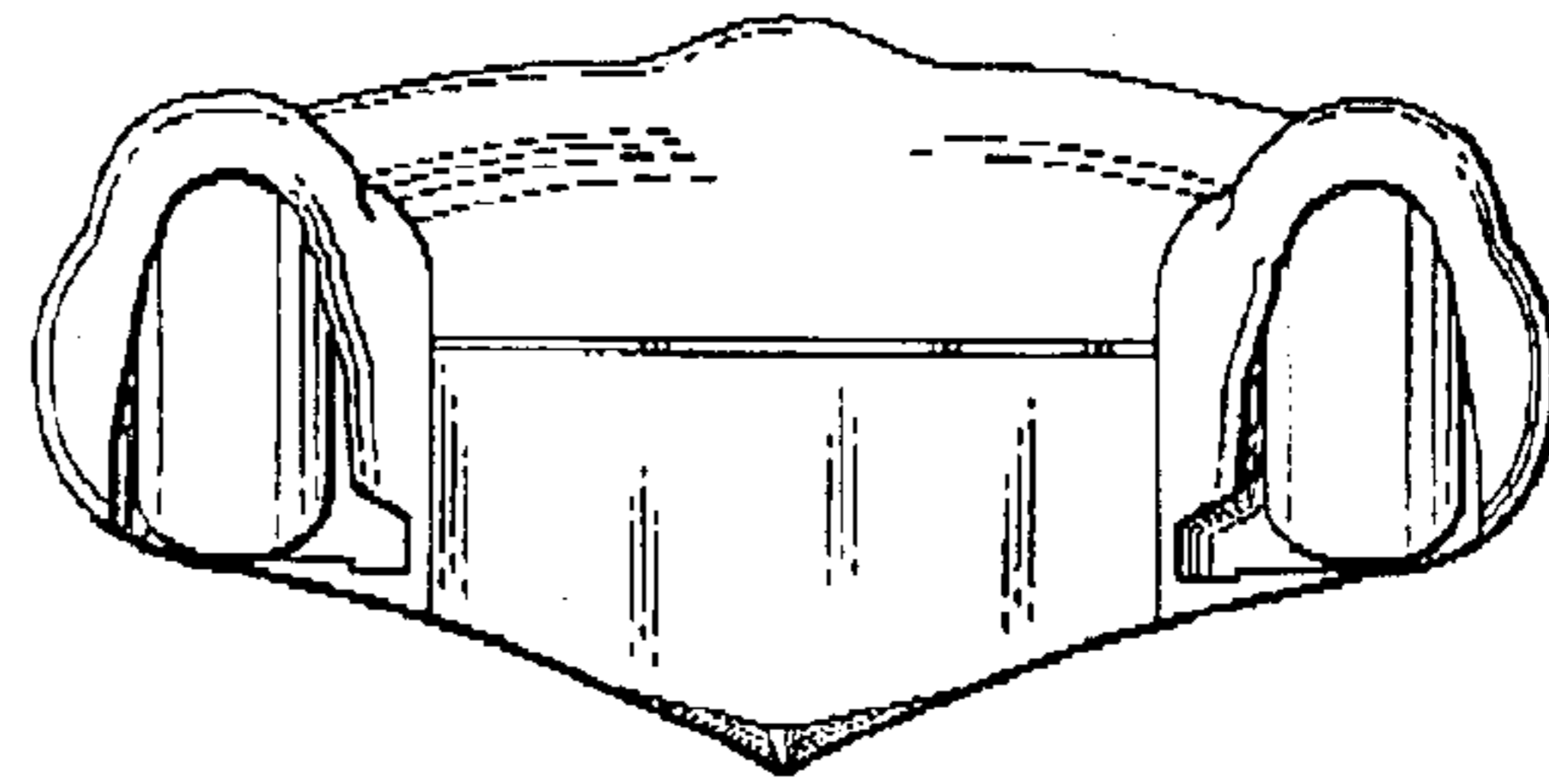

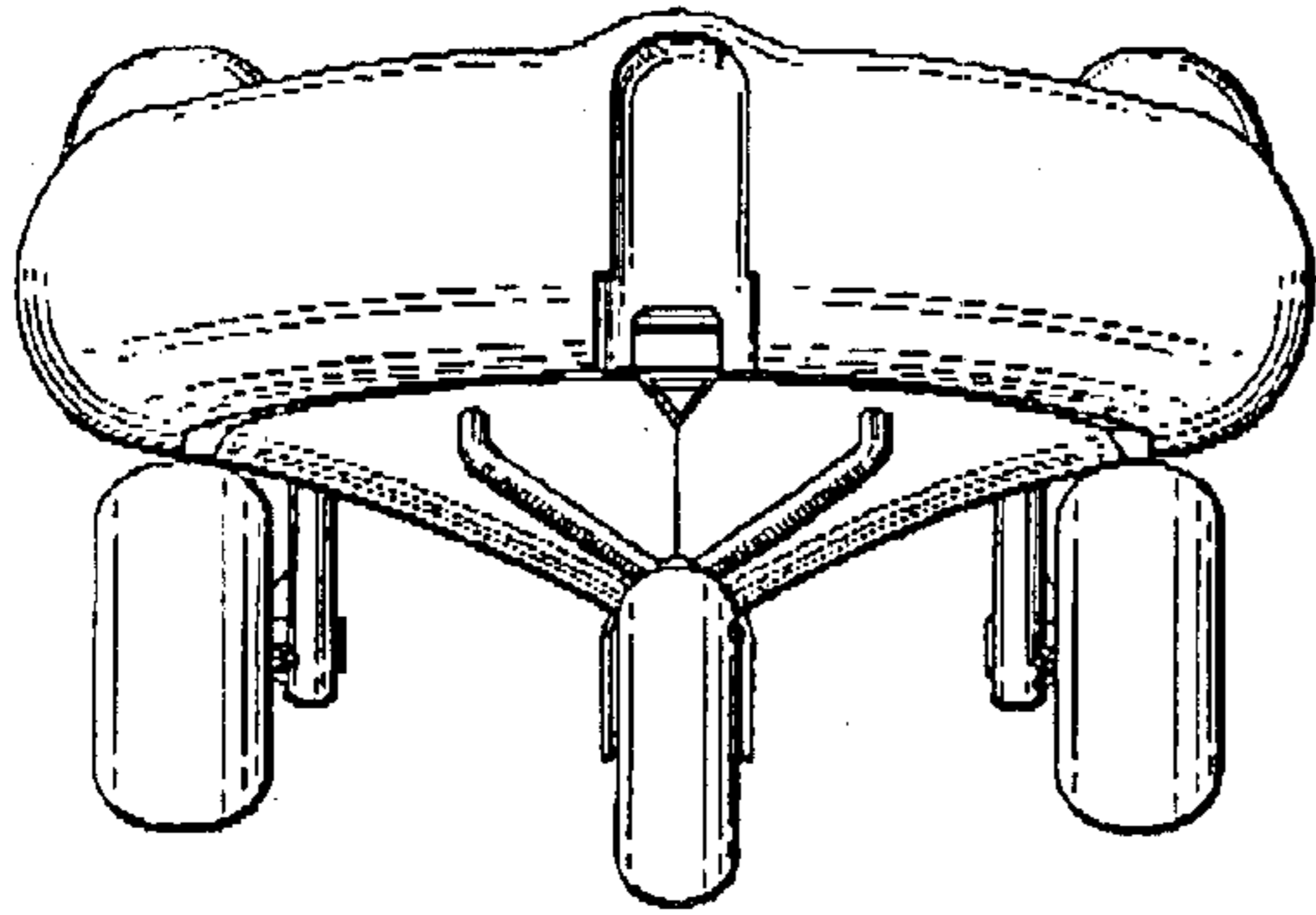

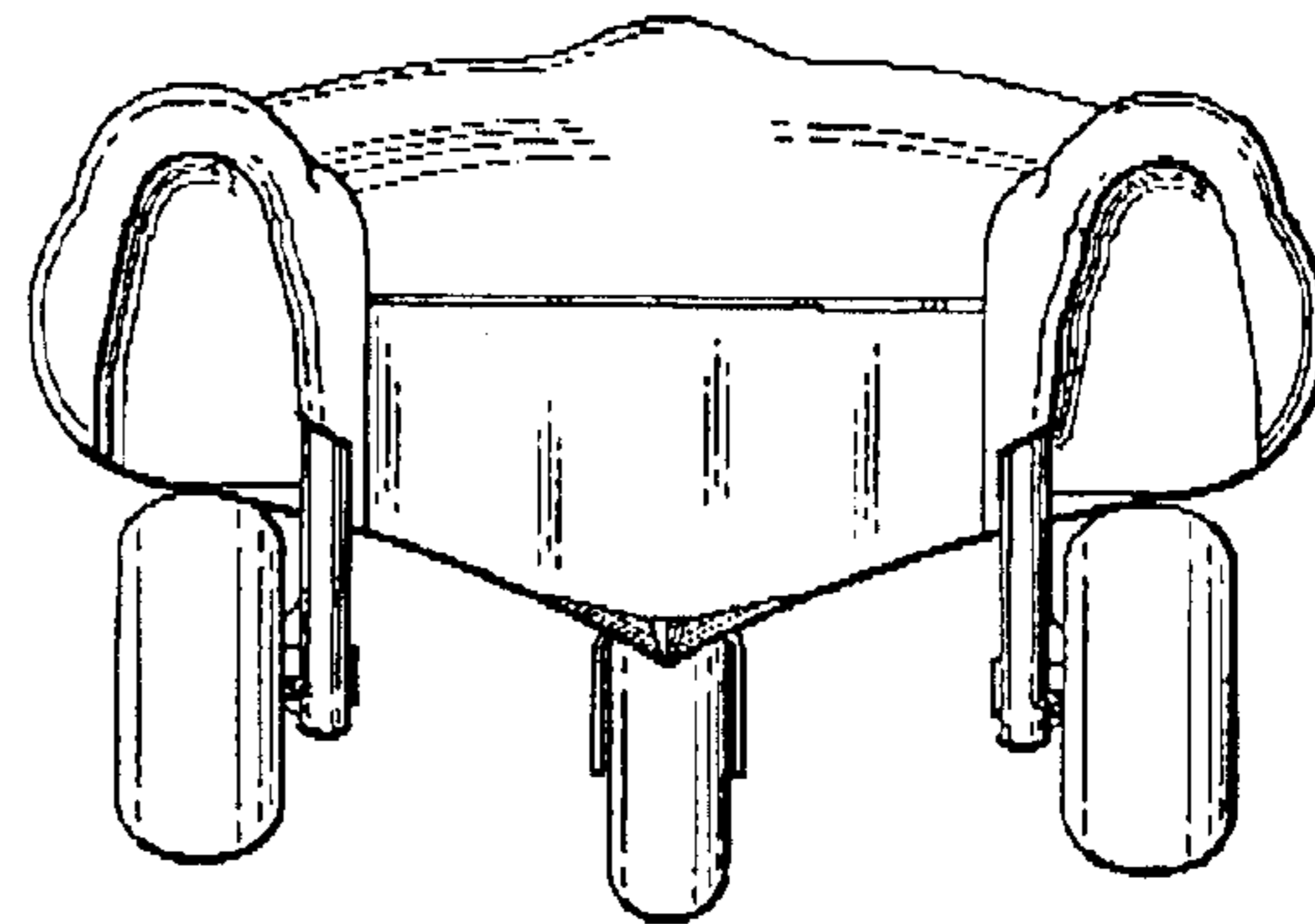

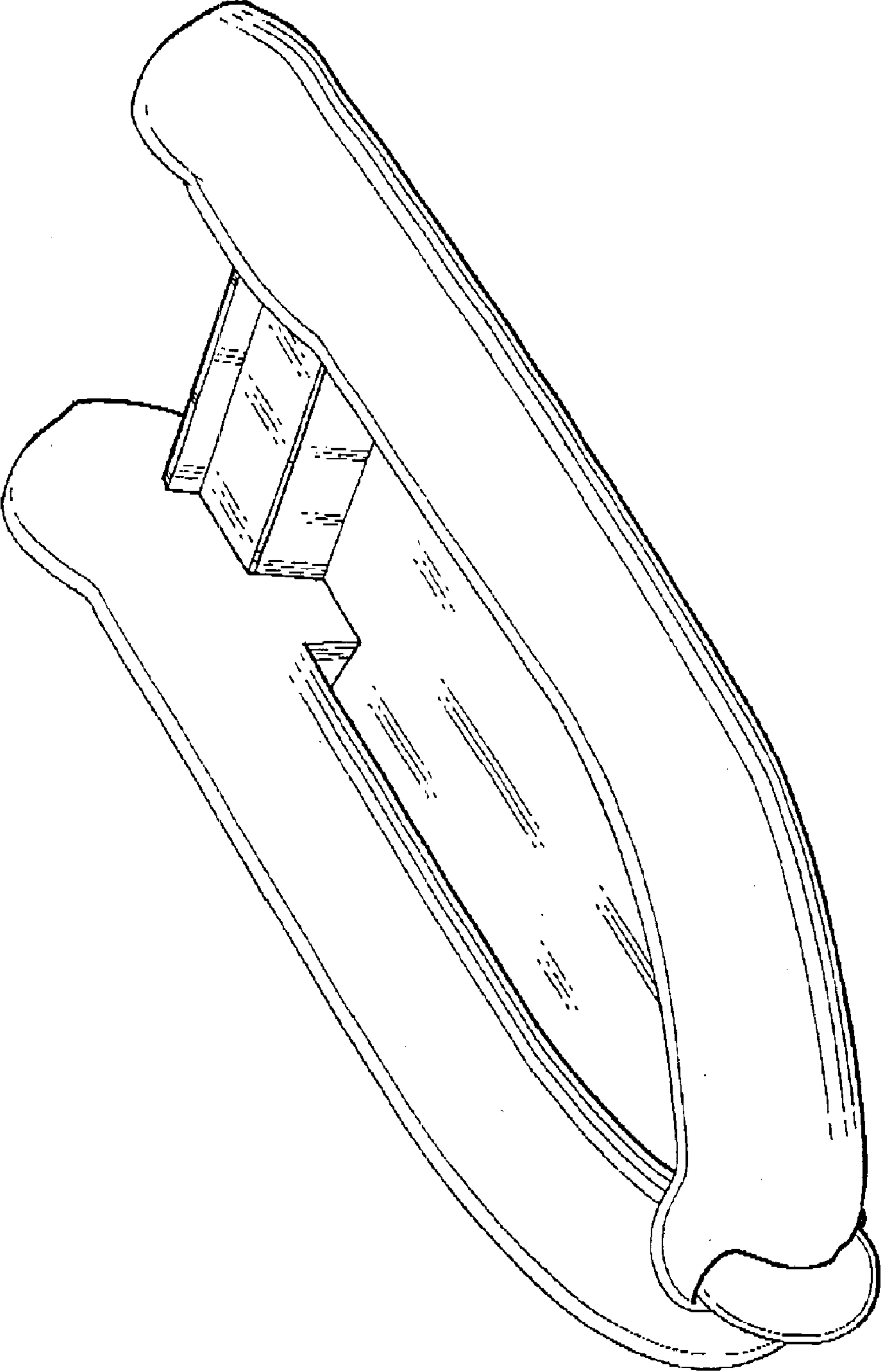

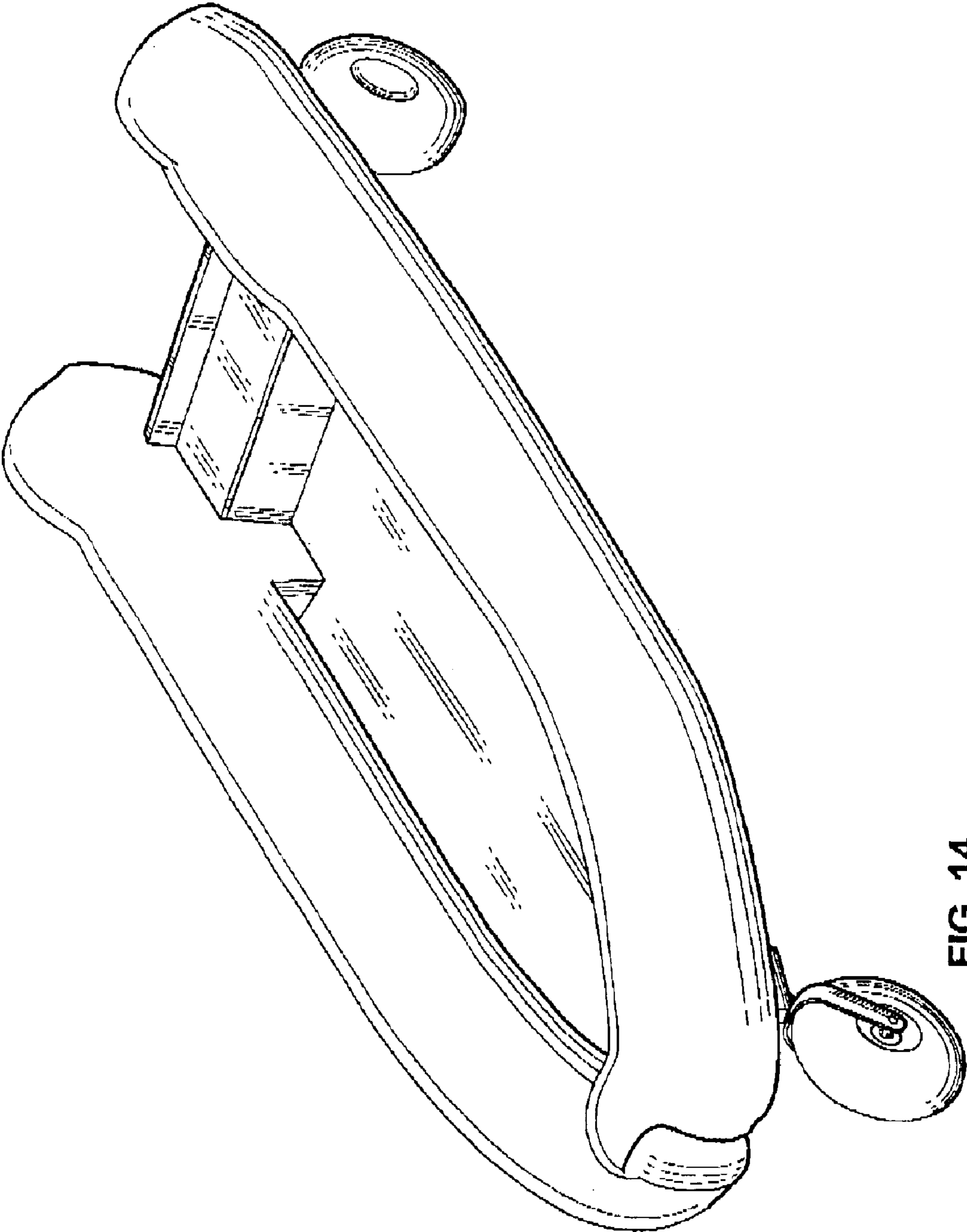

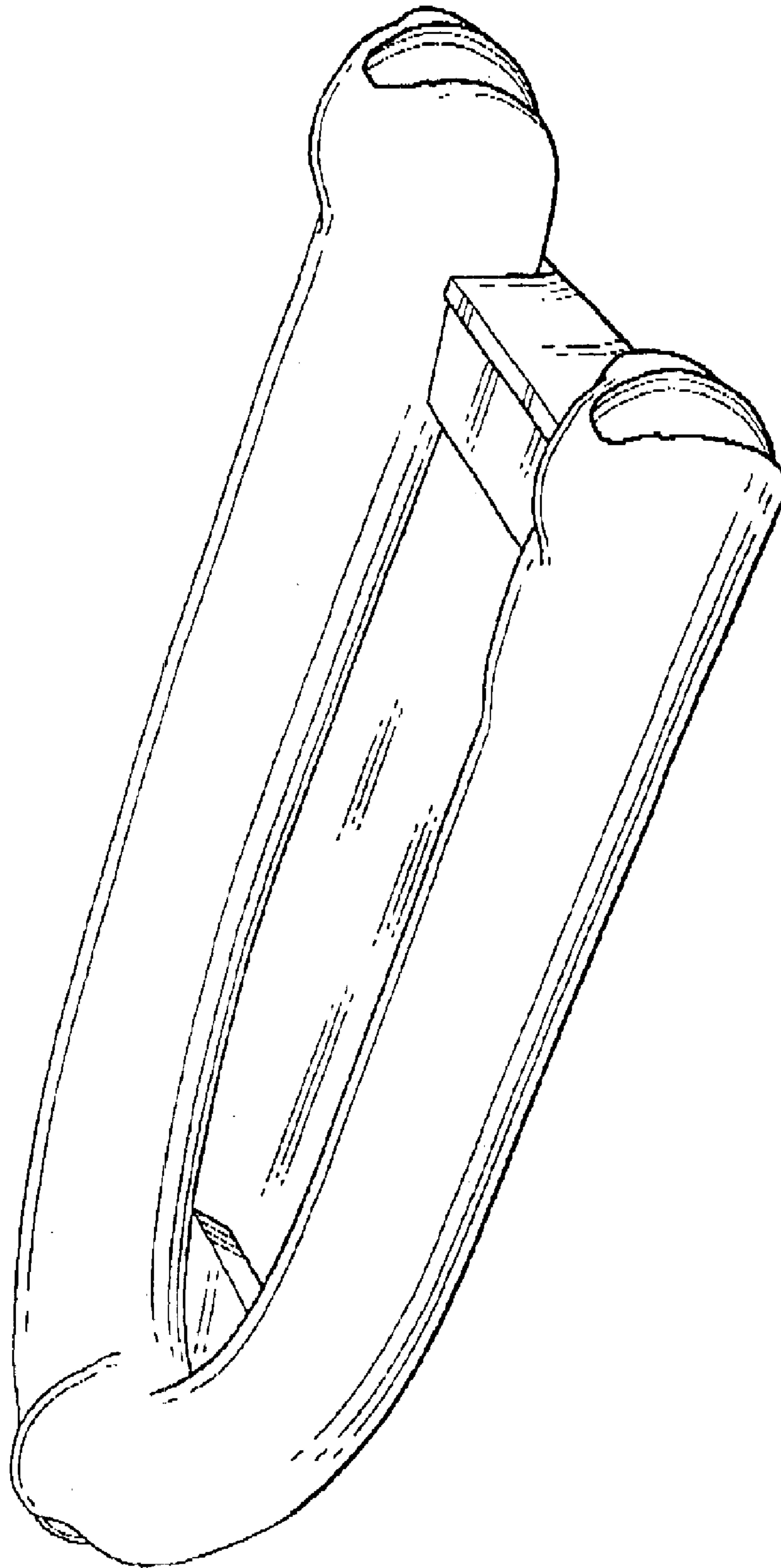

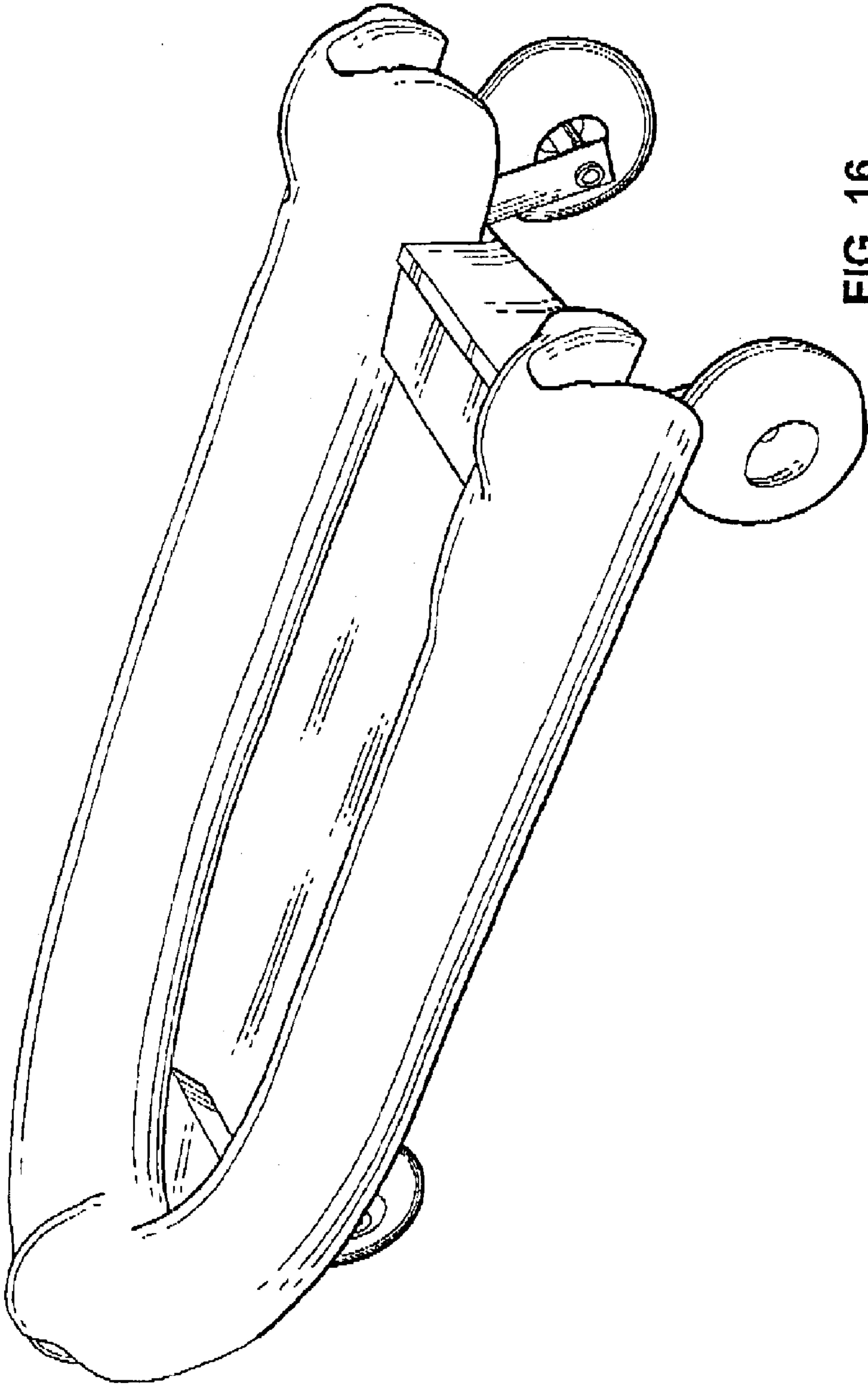

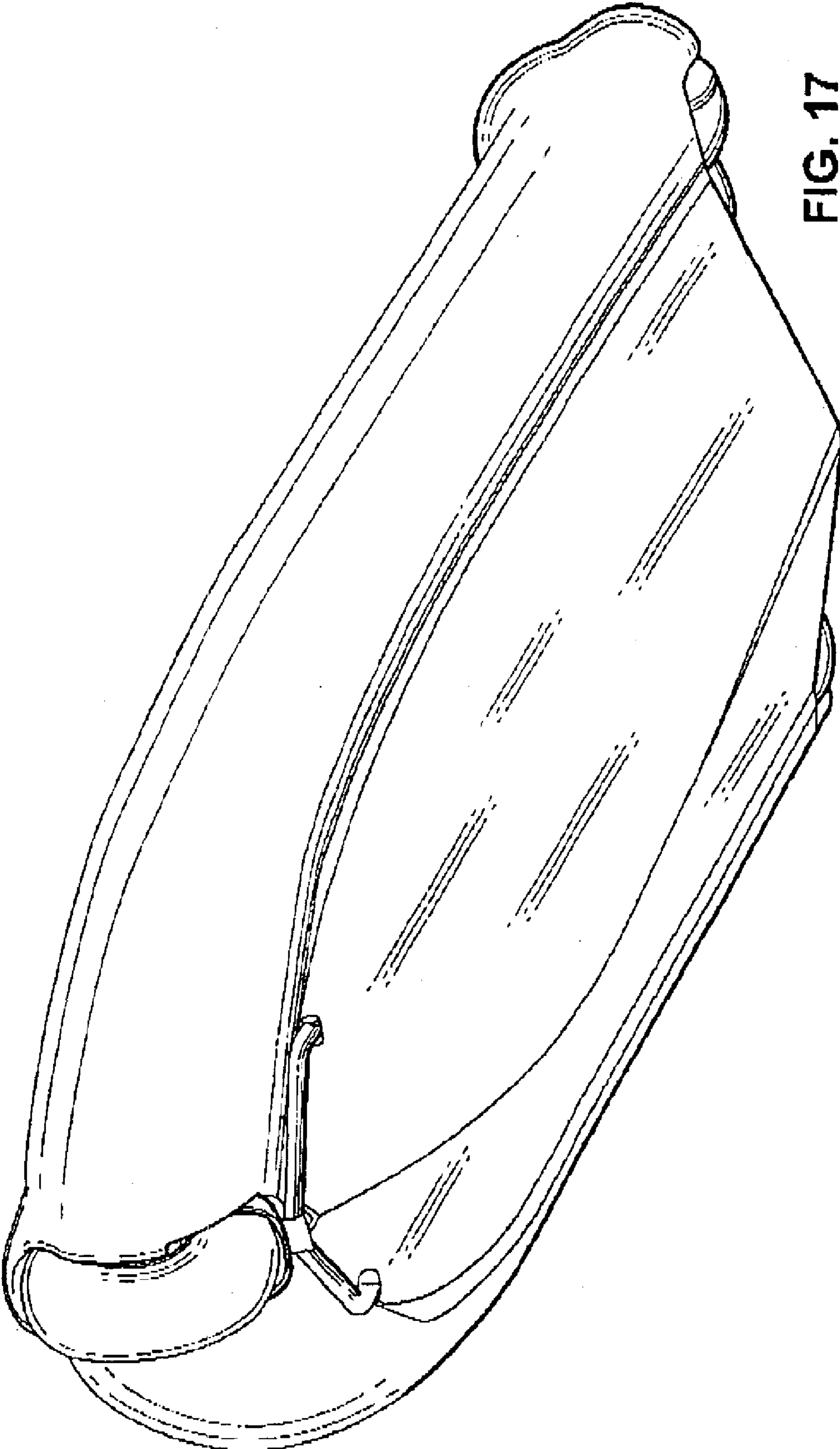

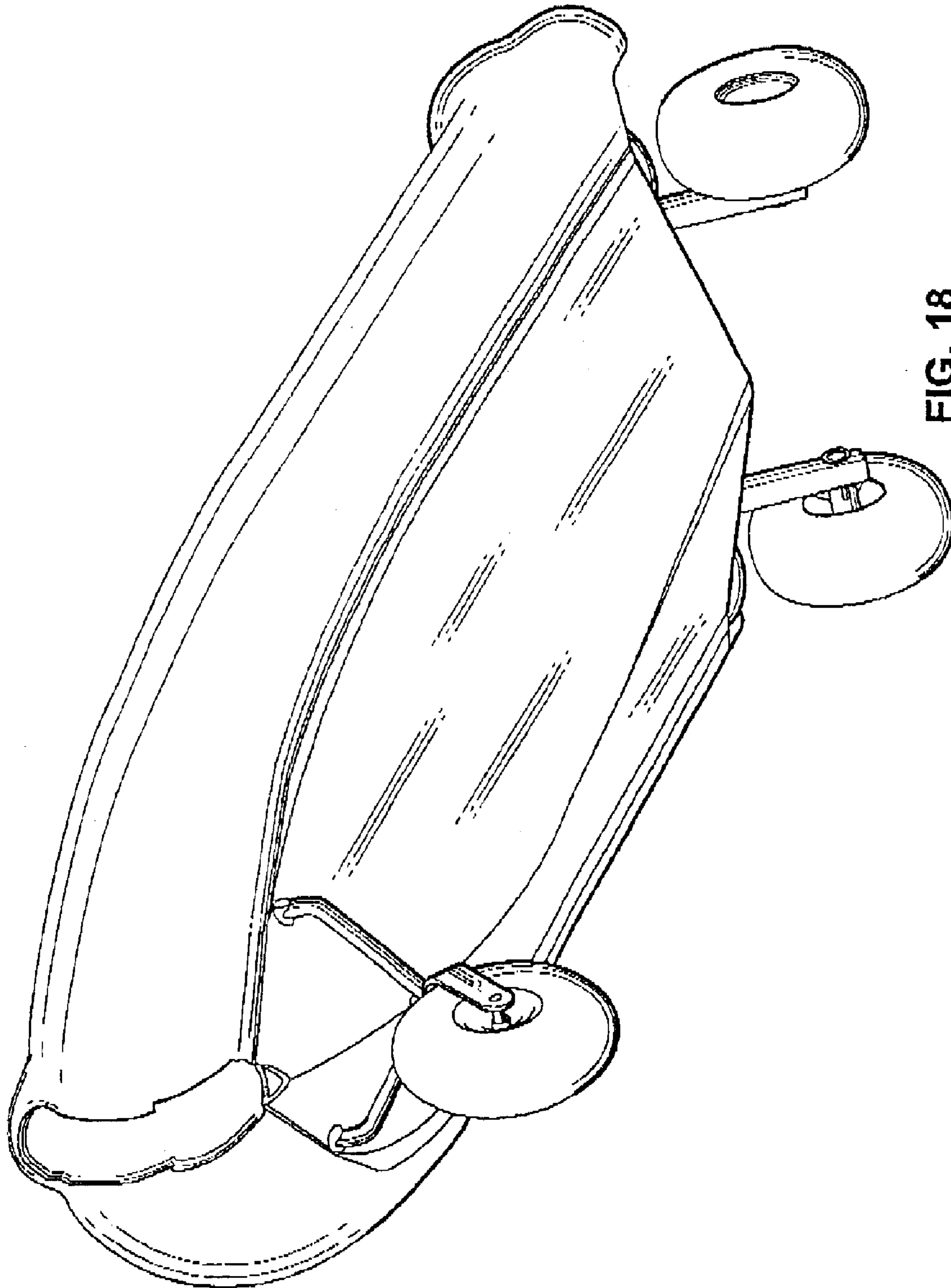
