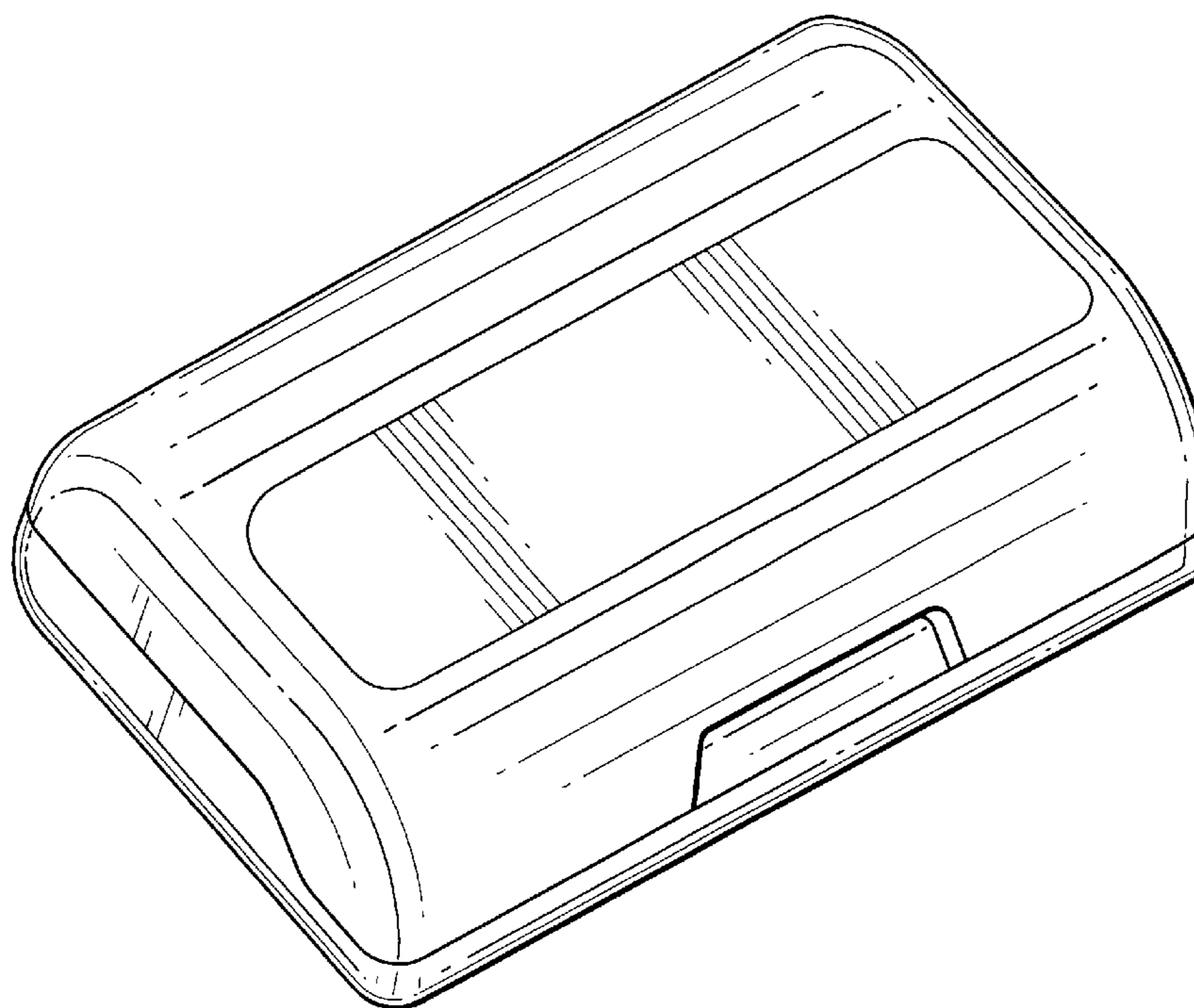
(57) **CLAIM**

The ornamental design for a “rechargeable battery storage case,” as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a rechargeable battery storage case;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a front elevational view with a lid opened thereof;

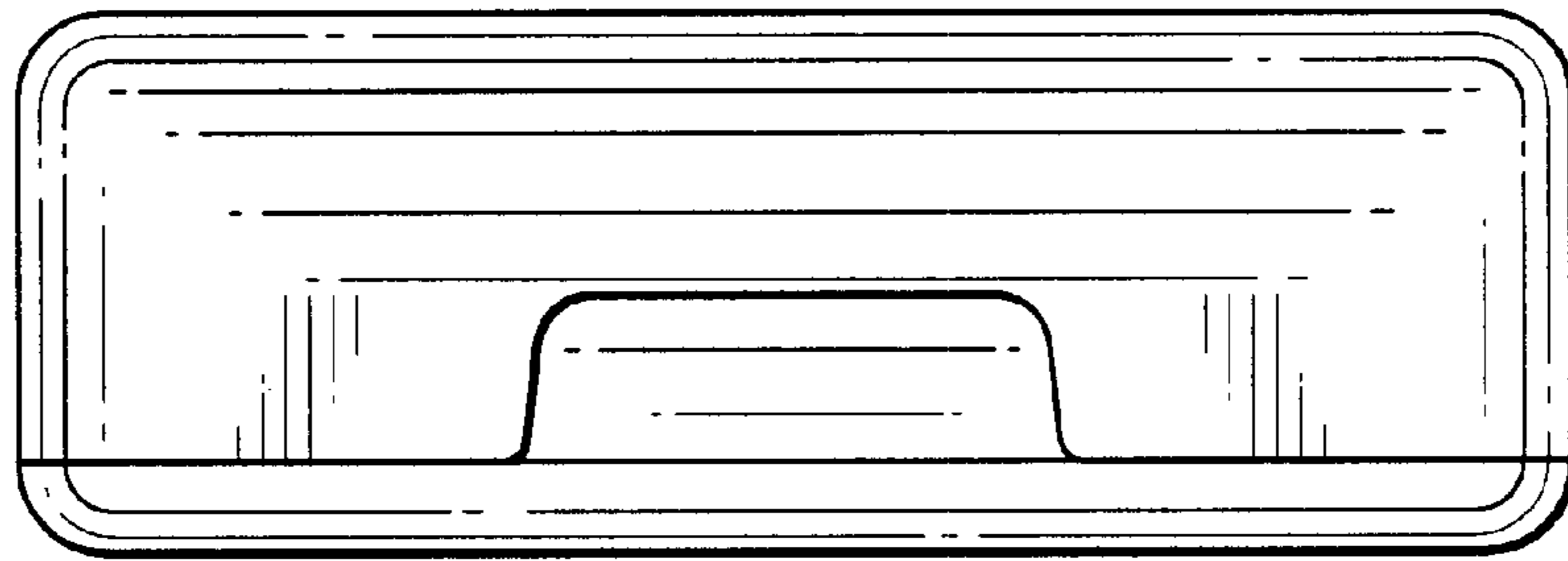

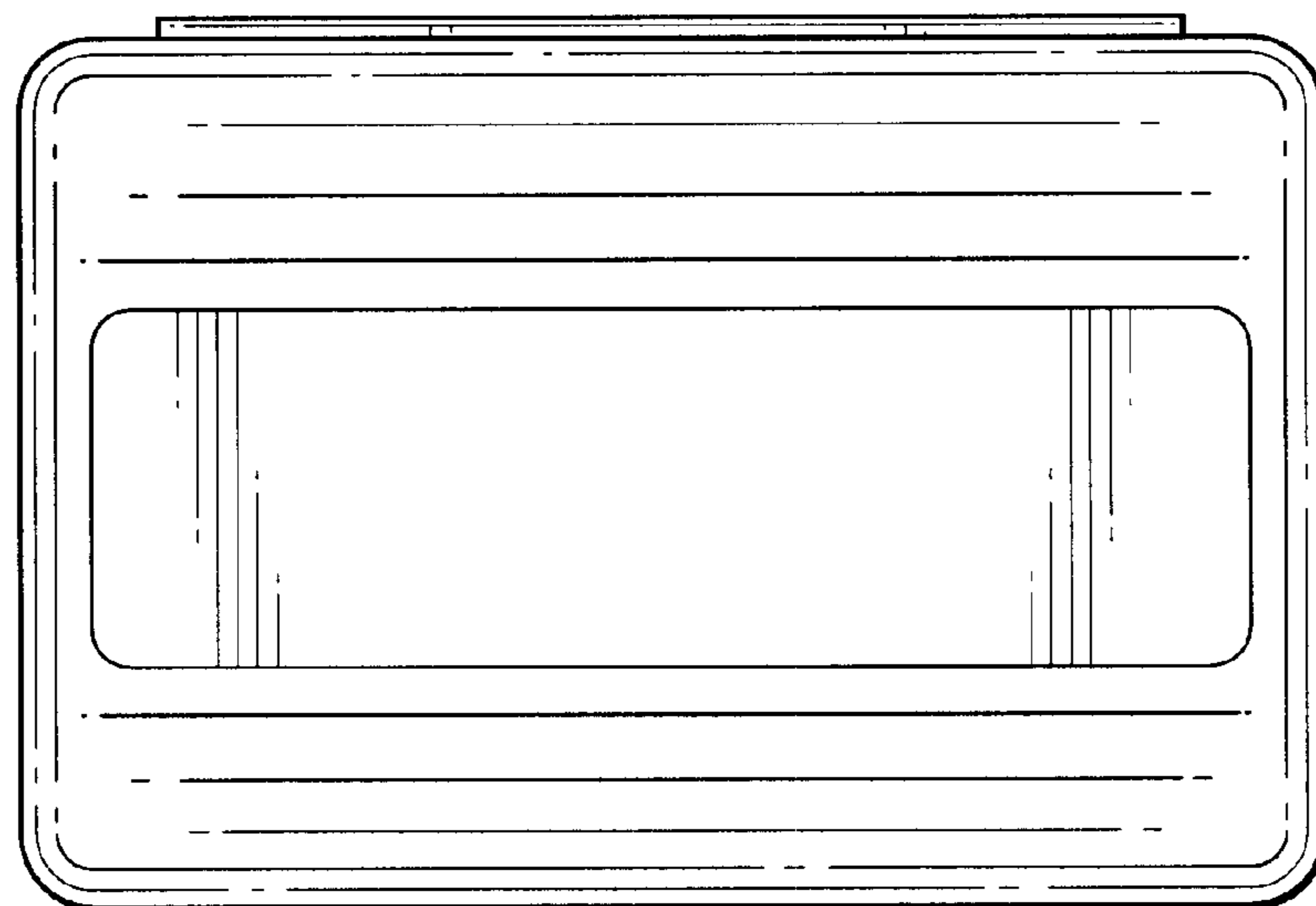

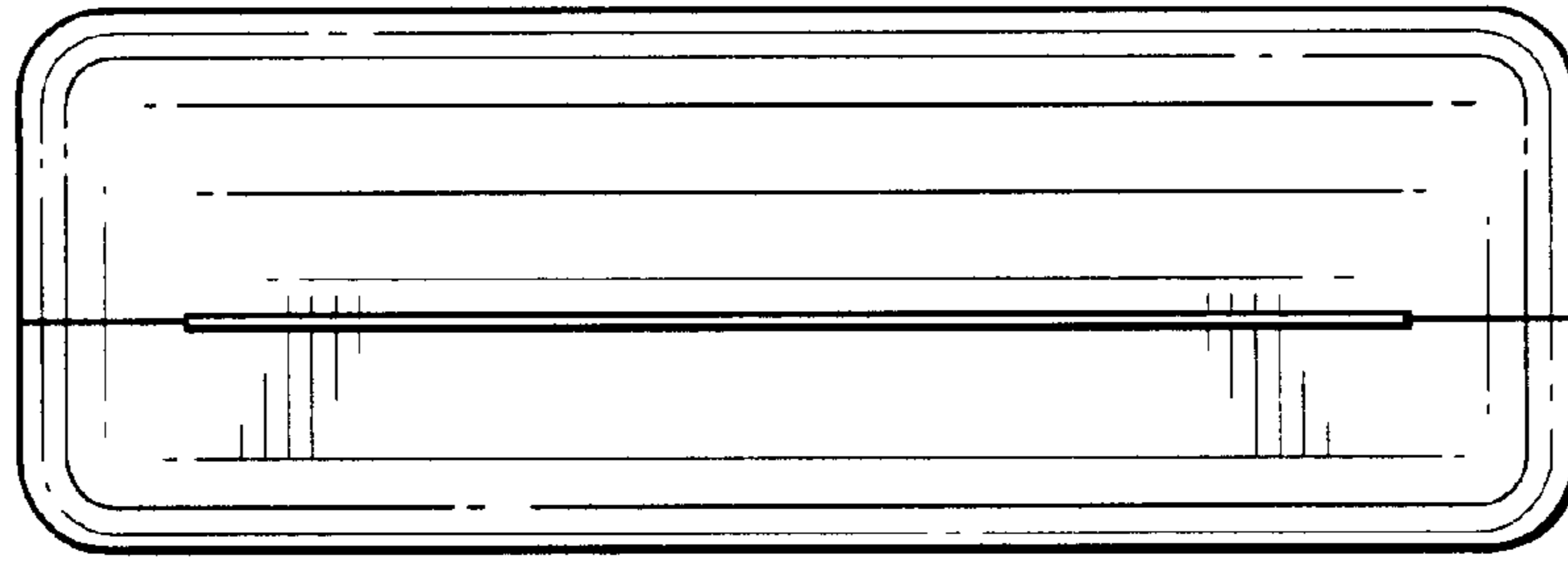

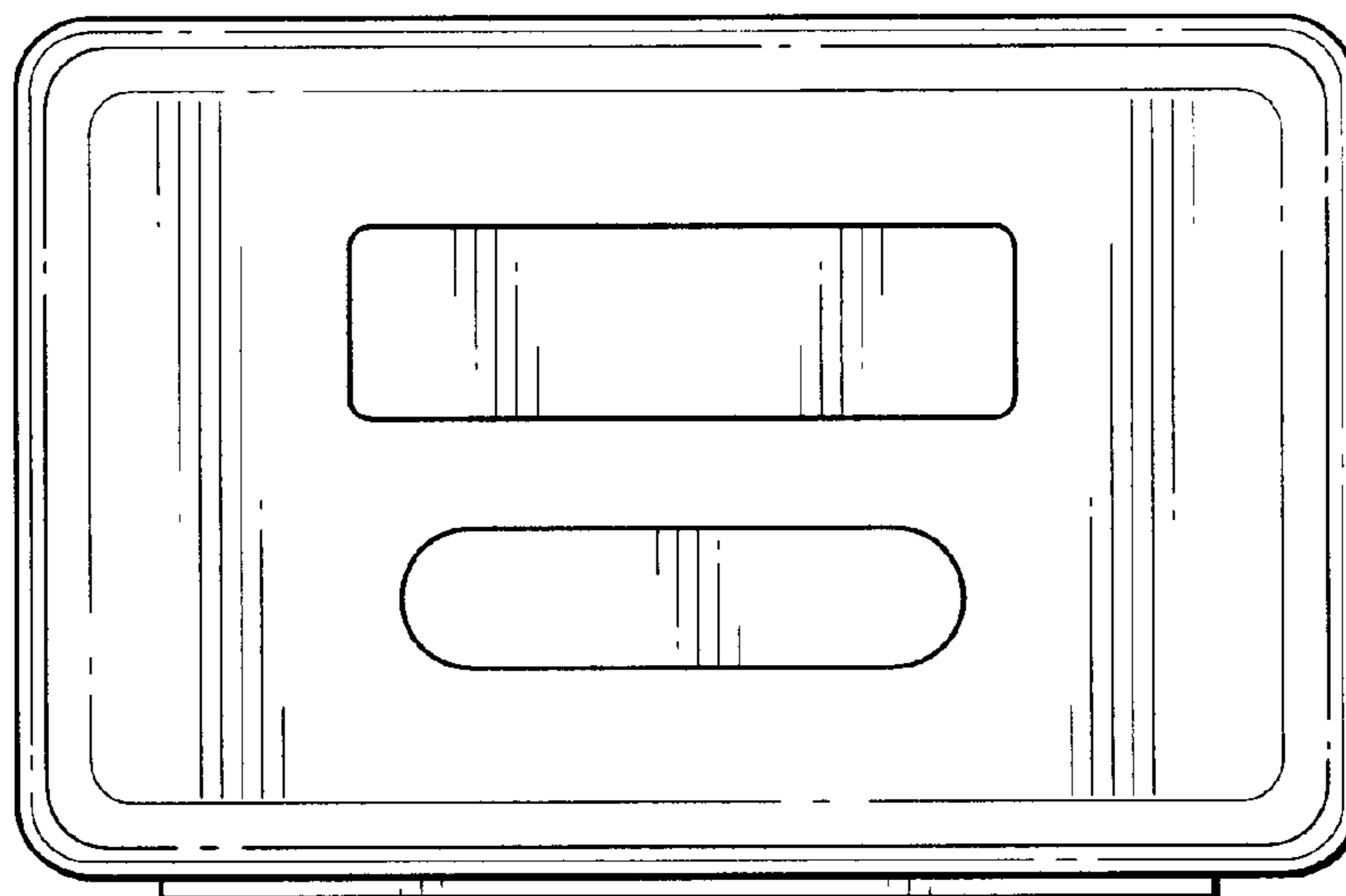

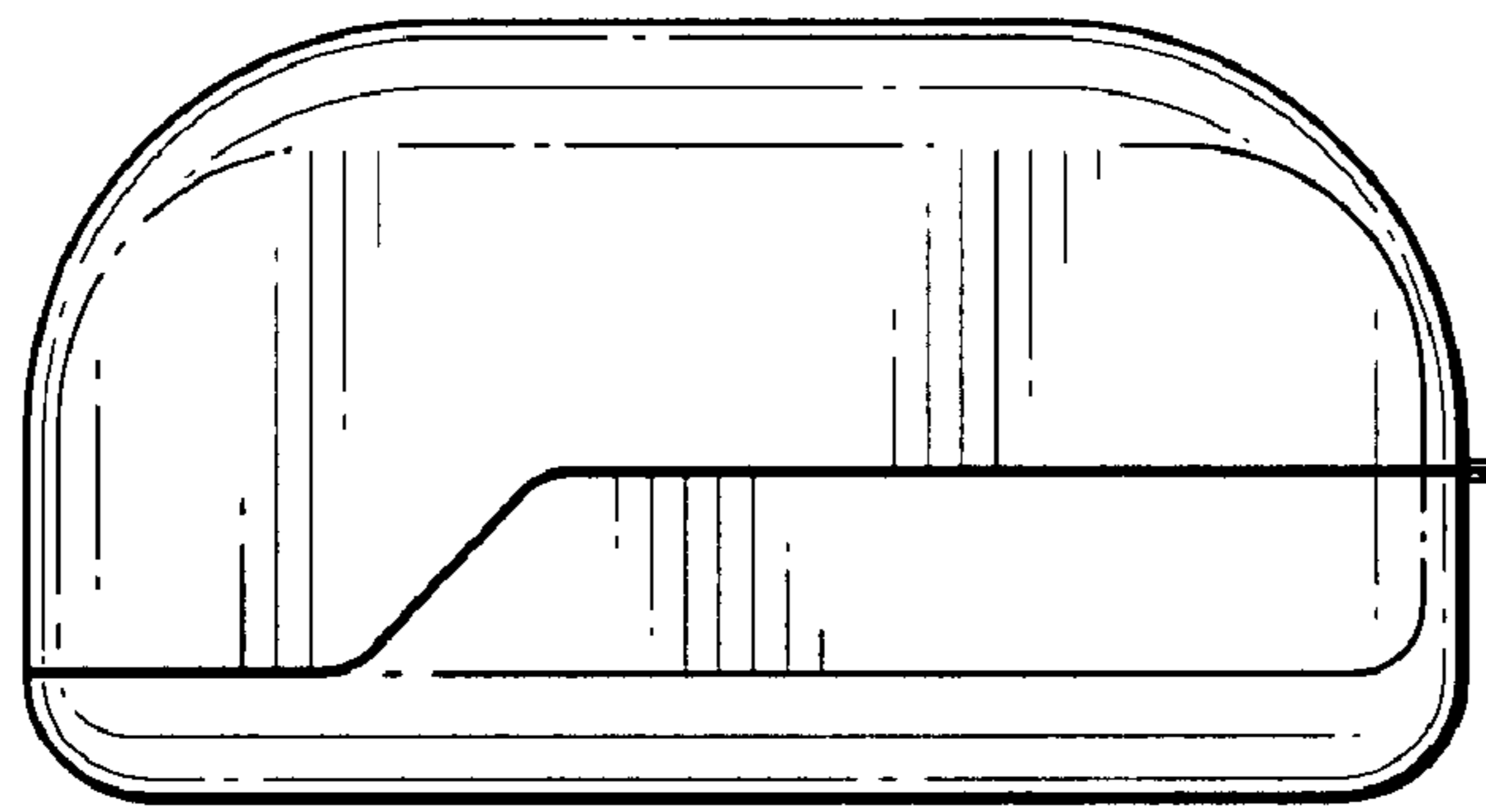

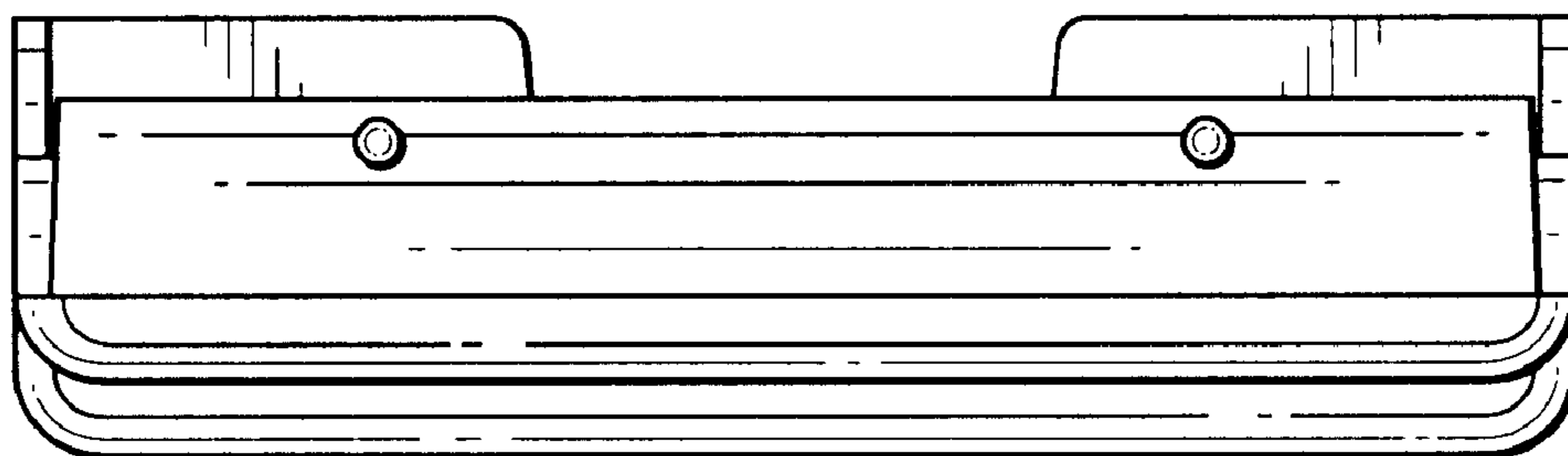

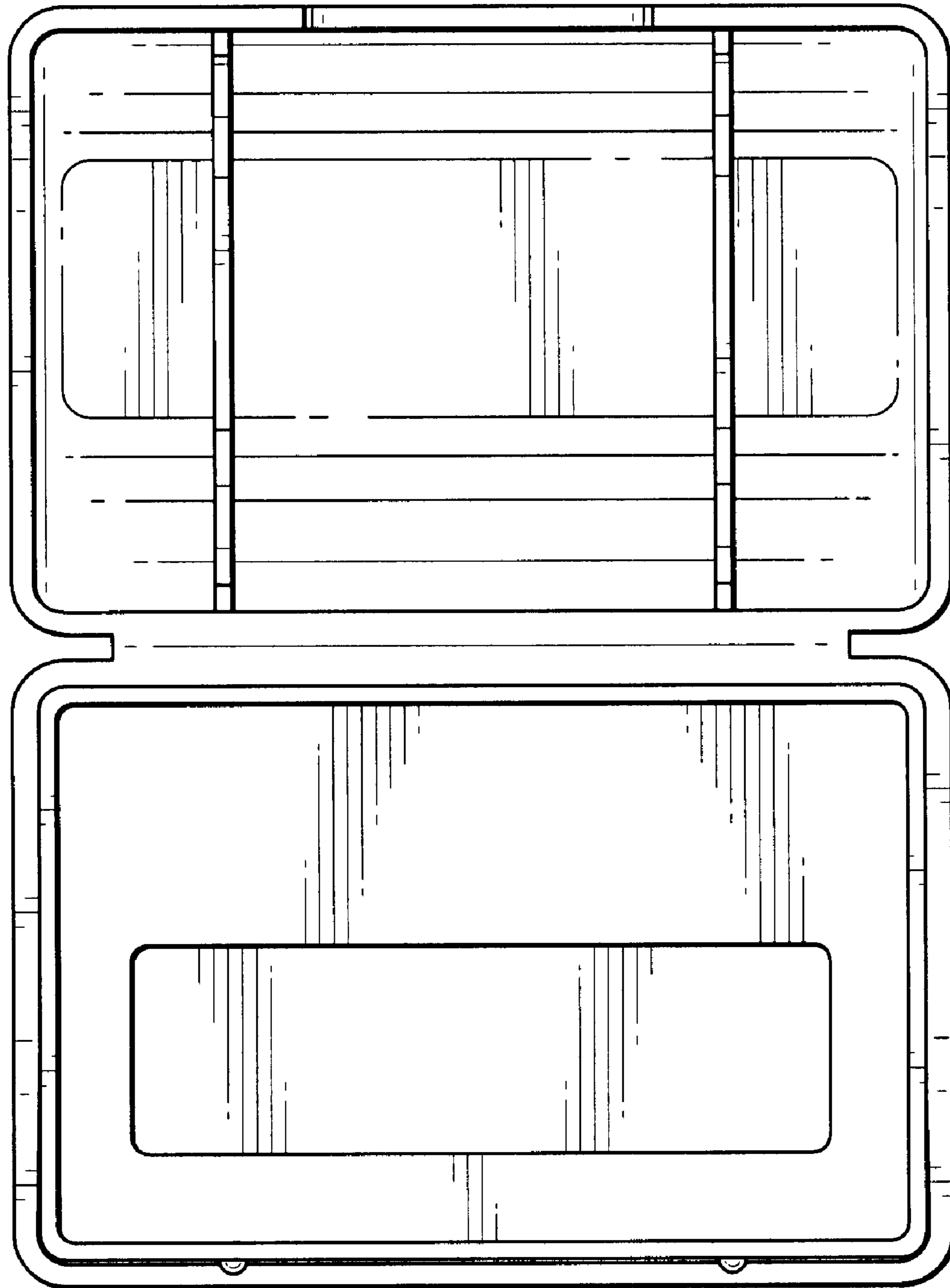

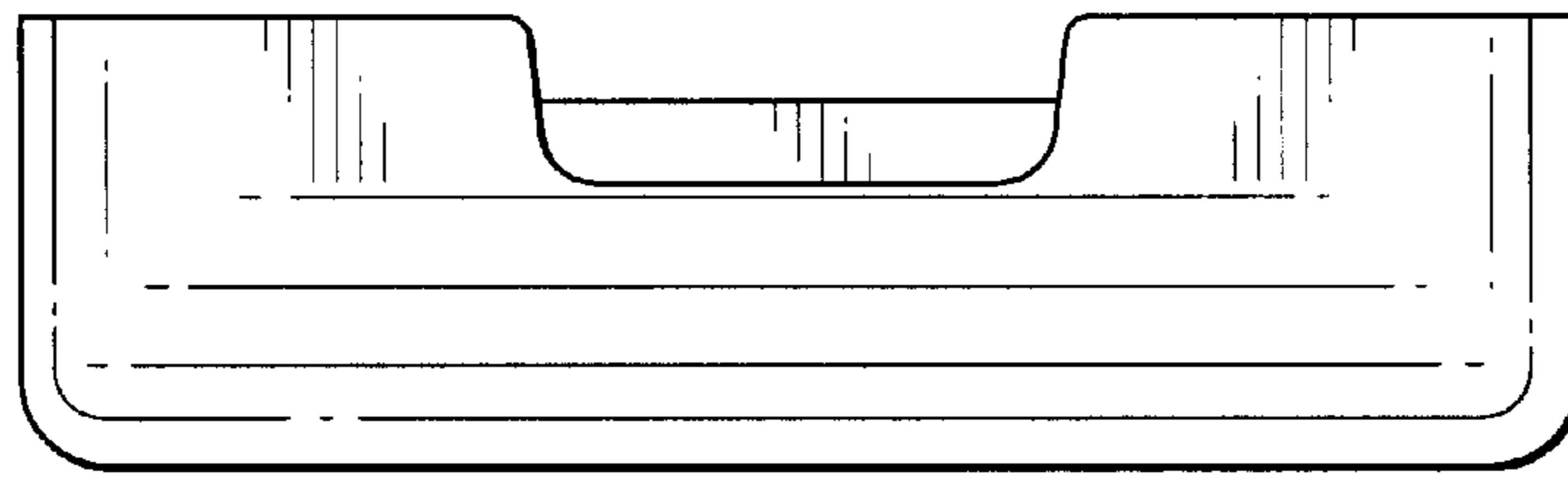

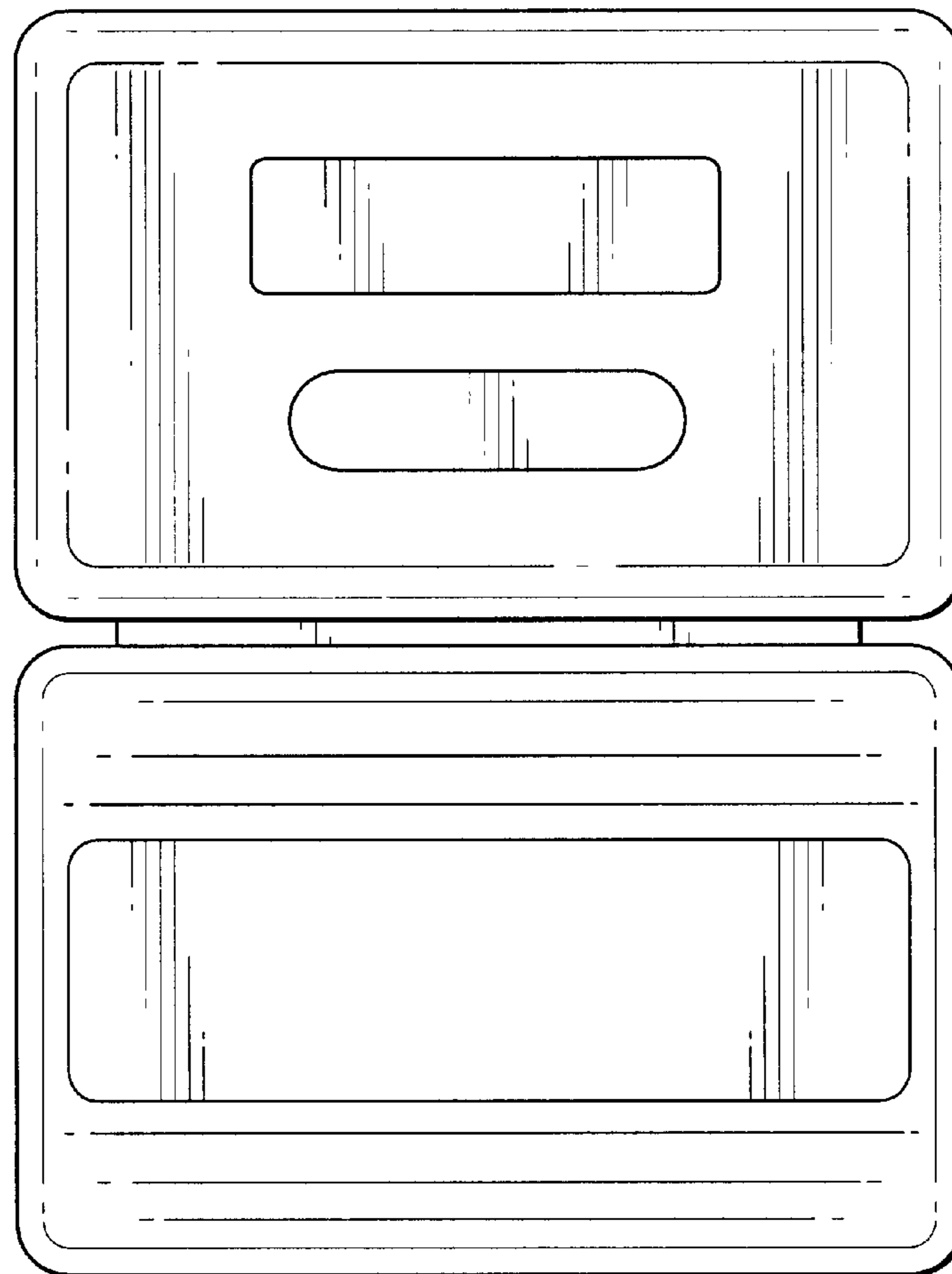

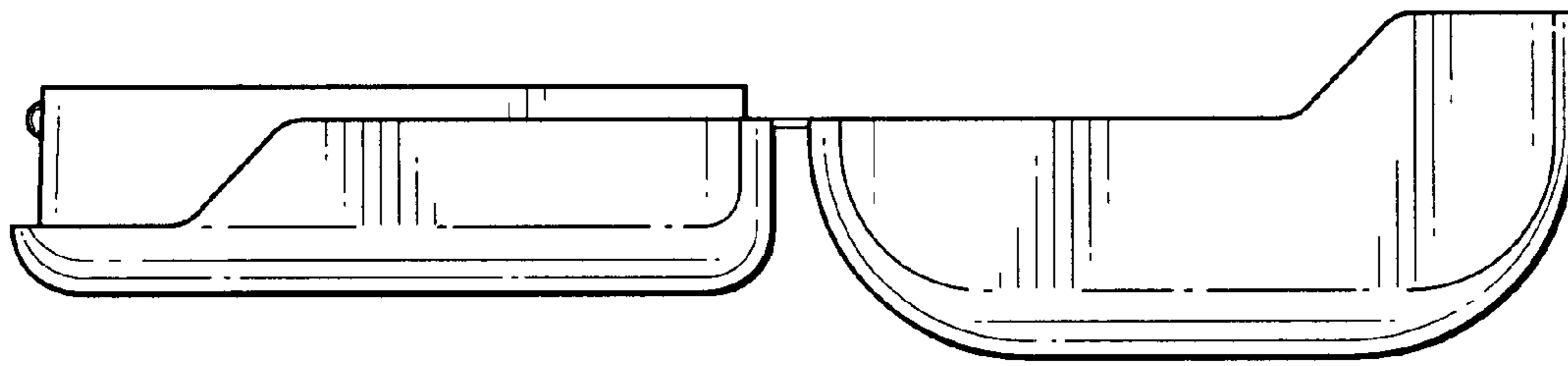

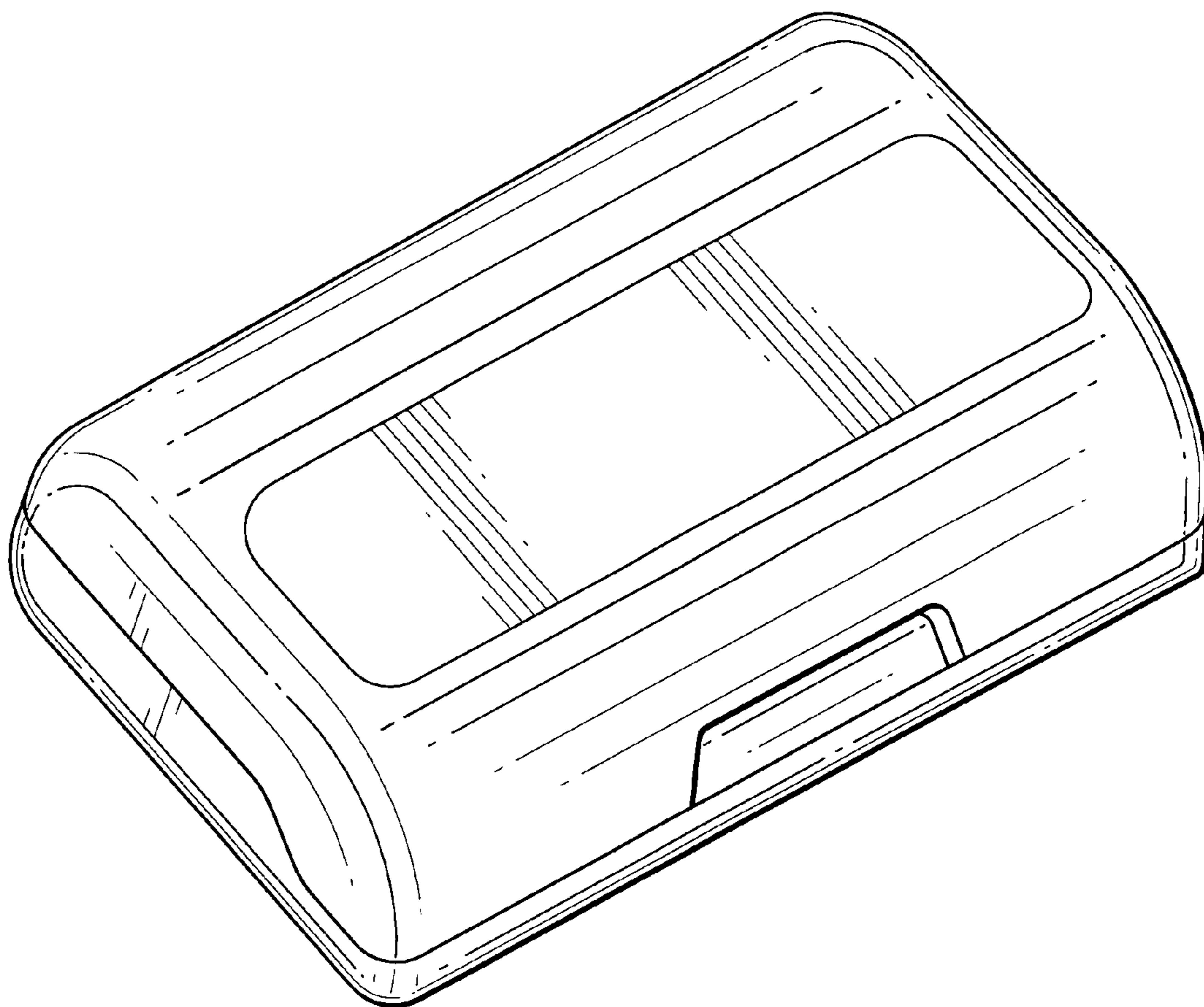

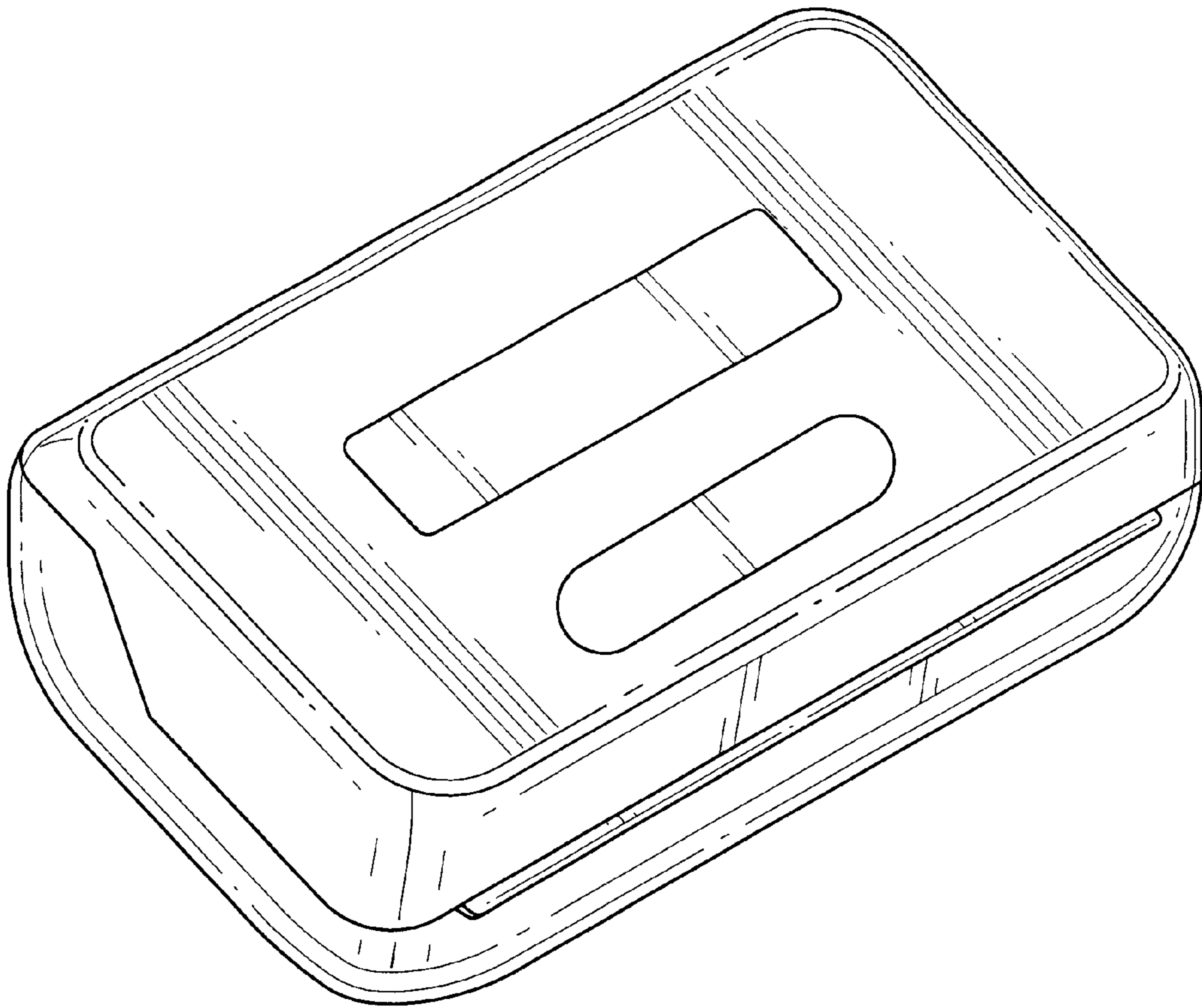
