(57) **CLAIM**

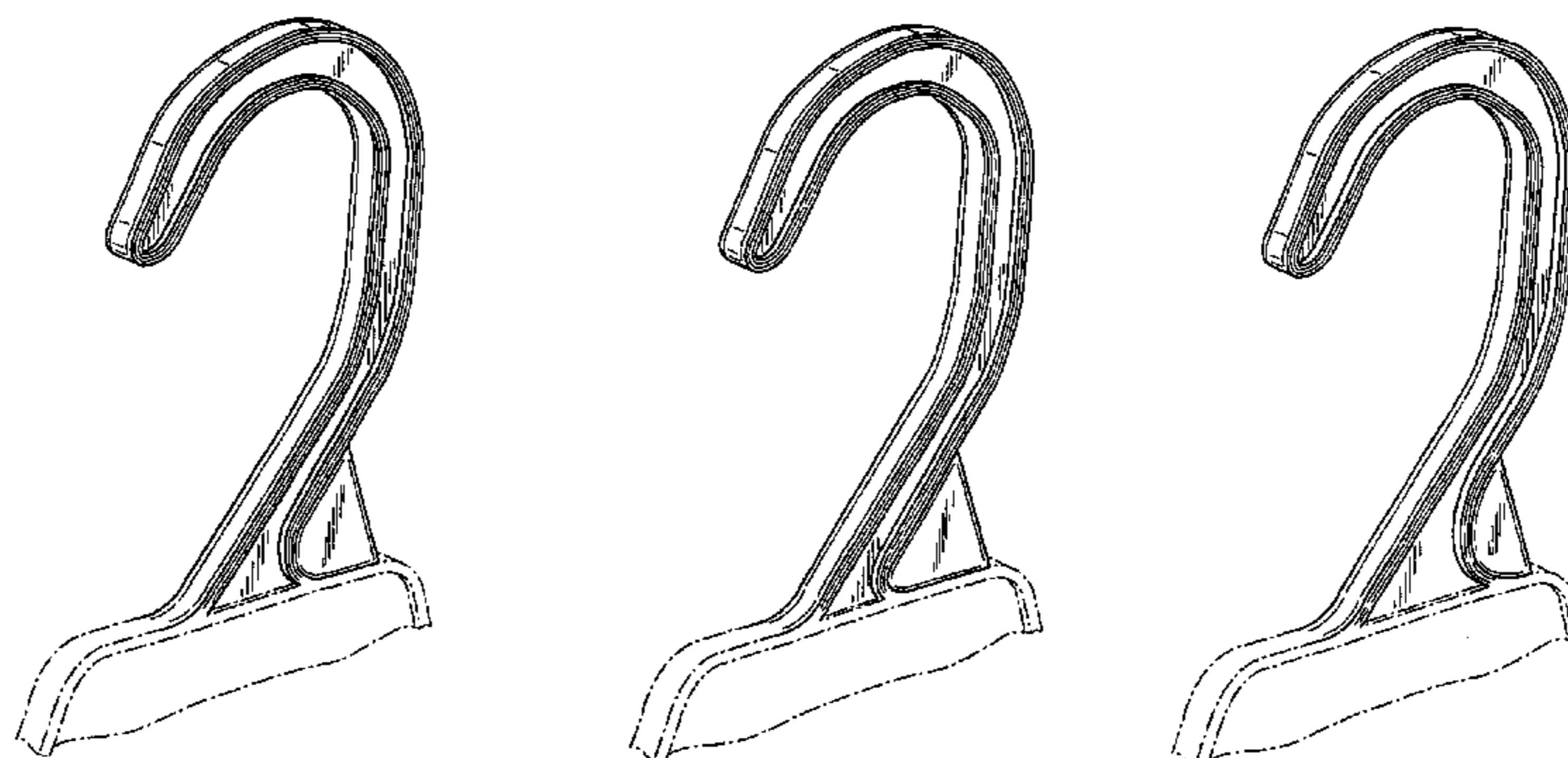
The ornamental design for a garment hanger hook with size indicator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a garment hanger hook and size indicator showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is an end view thereof; FIG. 4 is a perspective view of a second embodiment of the design of FIG. 1; FIG. 5 is a front elevation view thereof; FIG. 6 is an end view thereof; FIG. 7 is a perspective view of a third embodiment of the design of FIG. 1; FIG. 8 is a front elevation view thereof; and, FIG. 9 is a end view thereof.

The subject matter shown in broken lines is for illustrative purposes only and forms no part of the claimed design. The side elevation views (opposite the sides shown in FIGS. 3, 6 and 9), the top views and bottom views (all not shown) form no part of the claimed design.

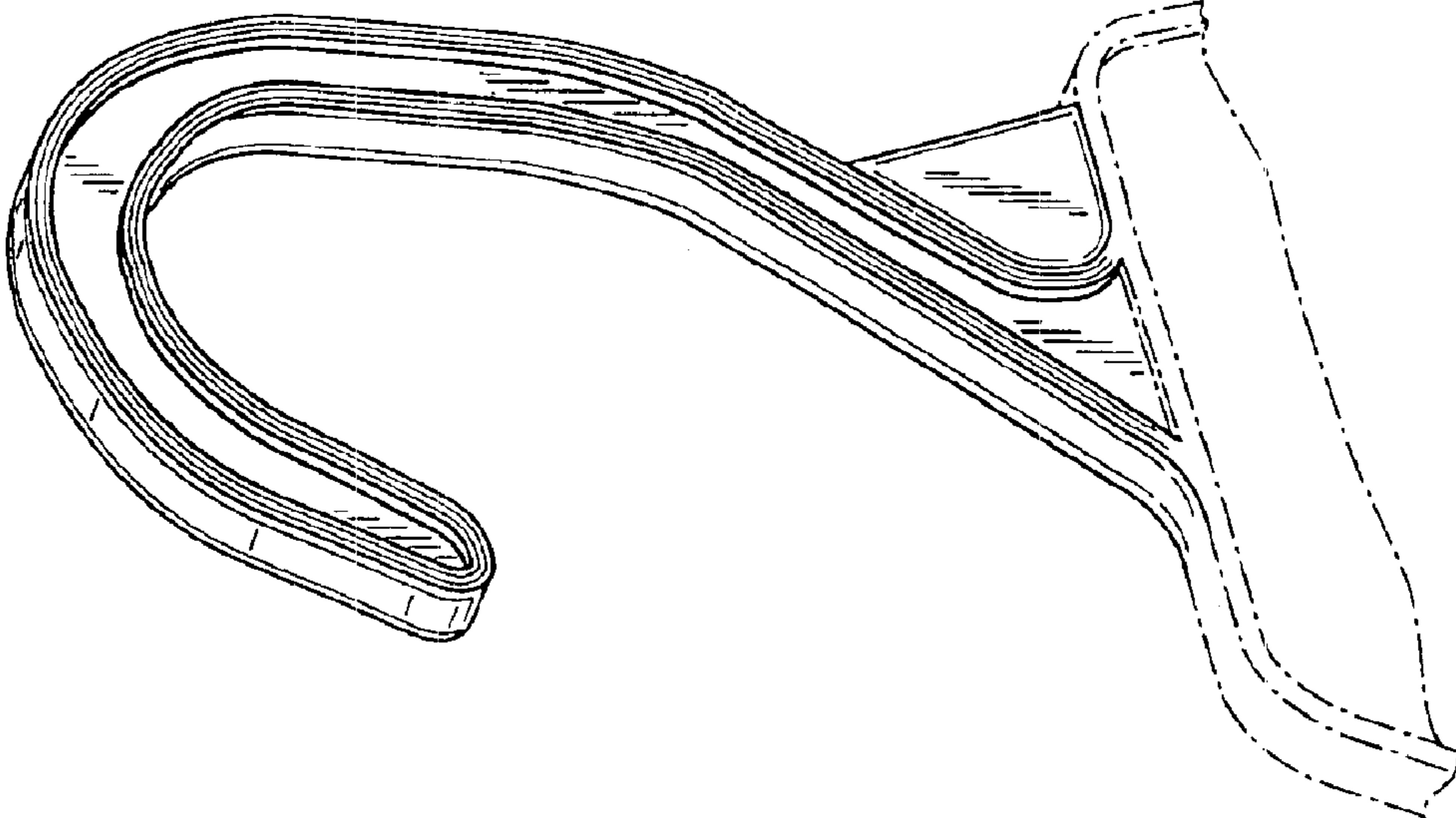
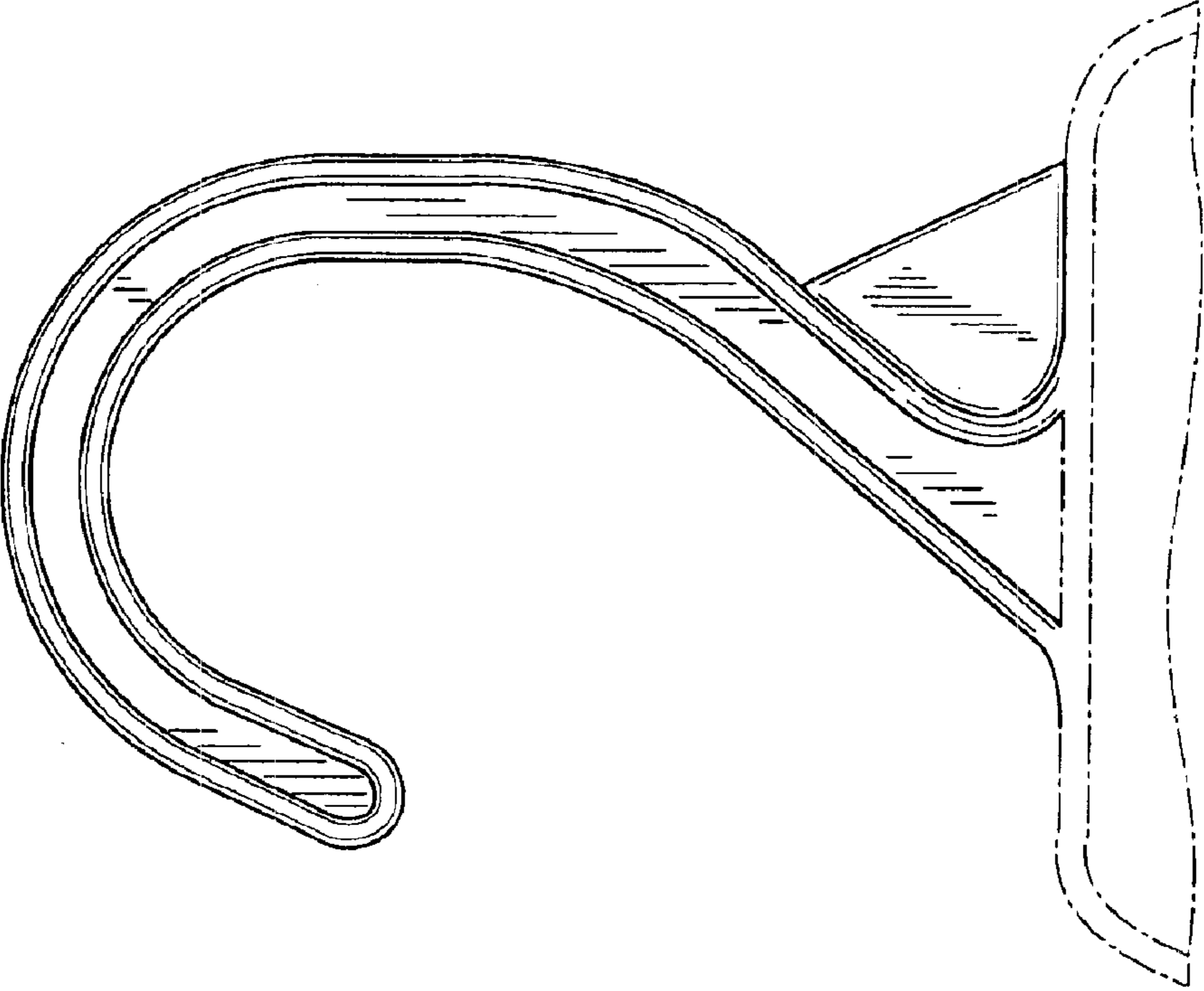

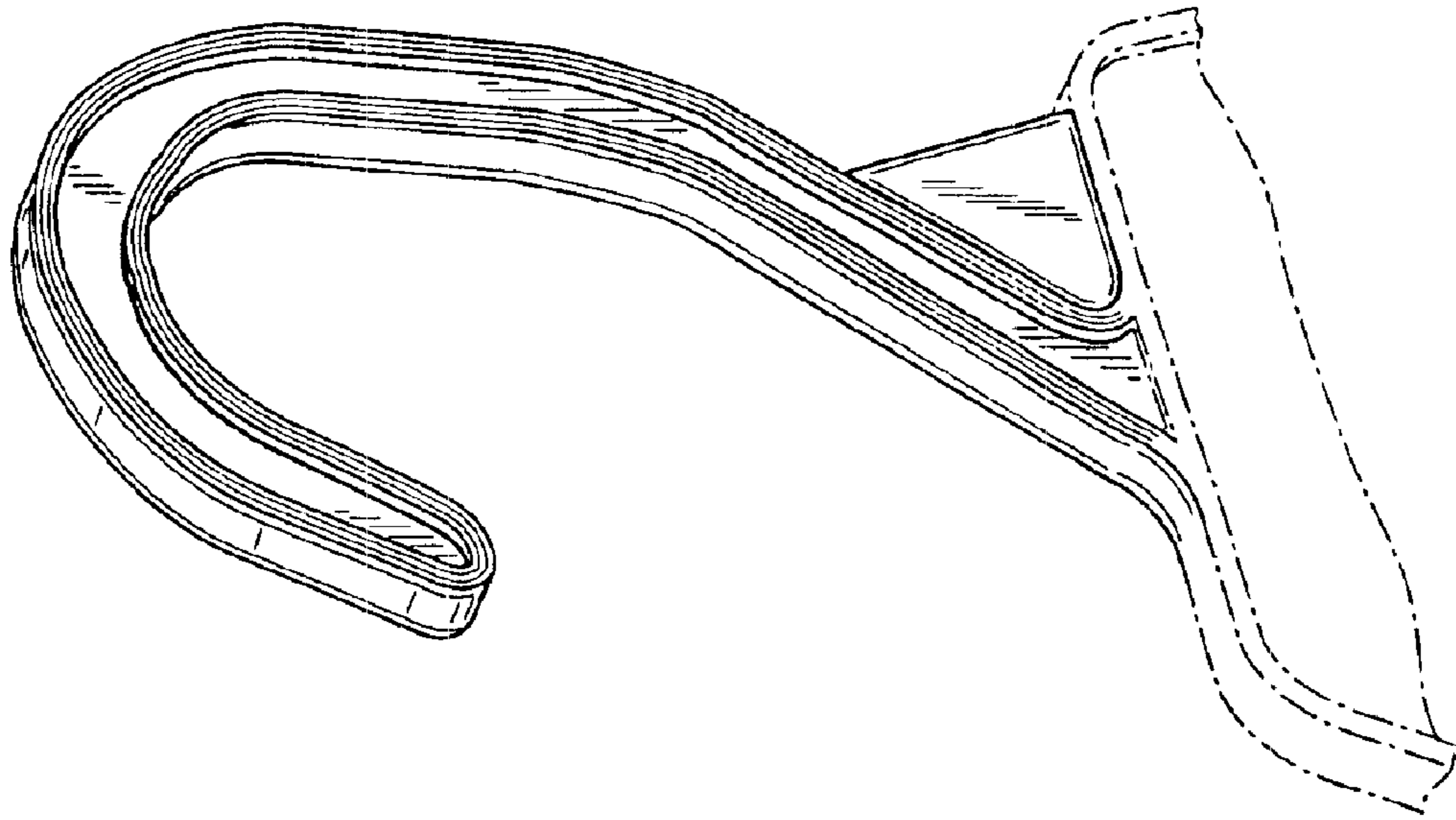
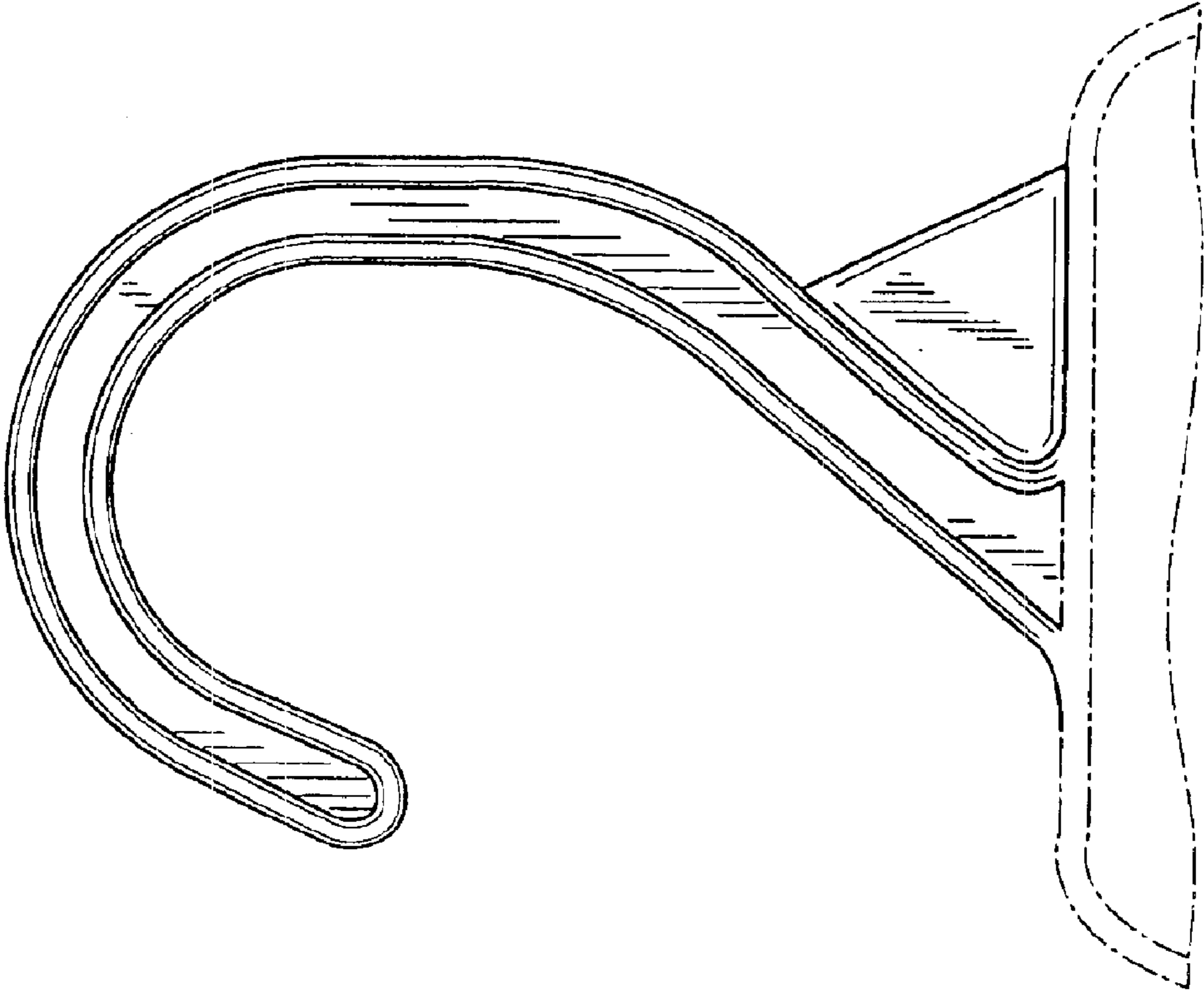

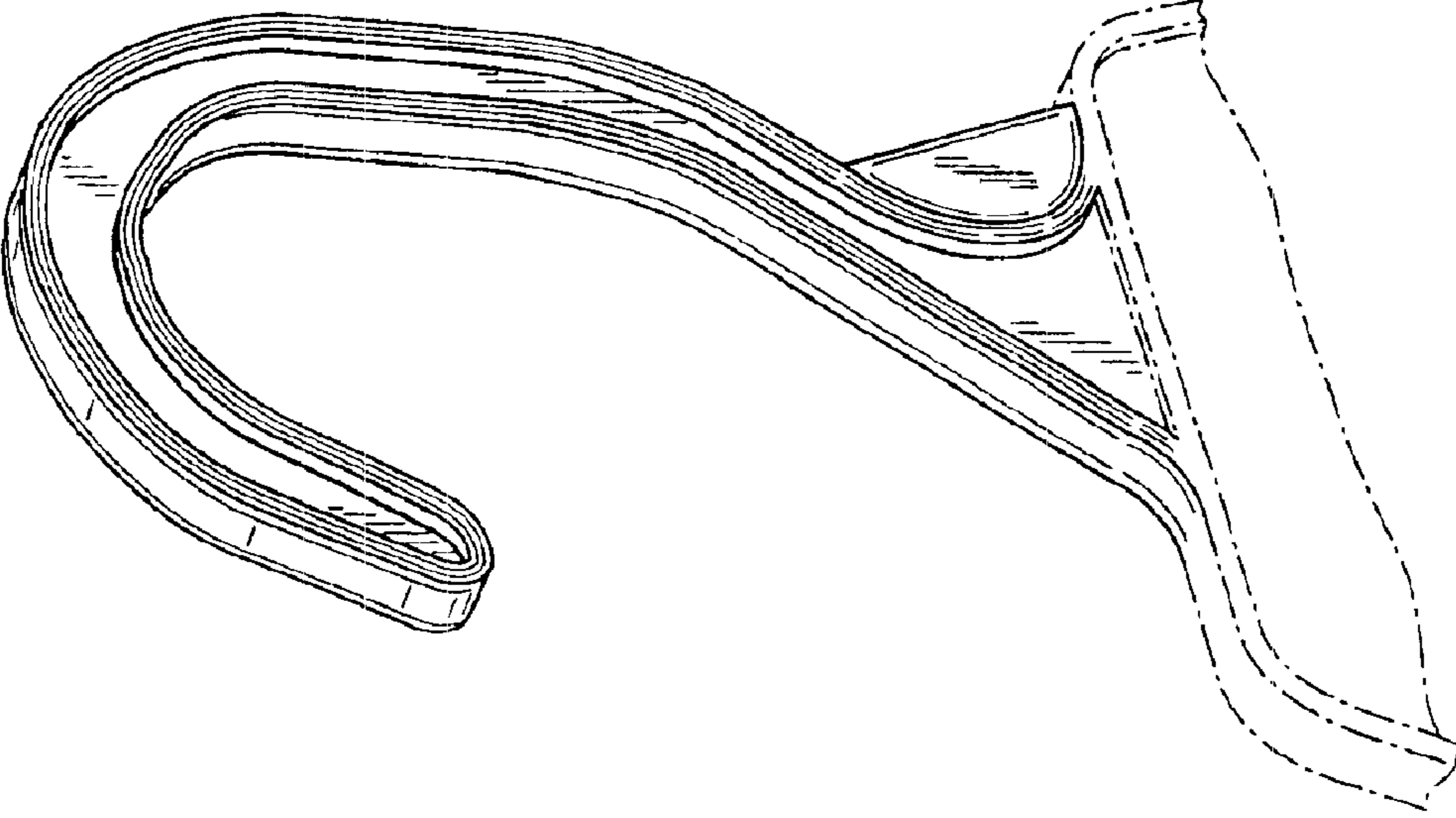

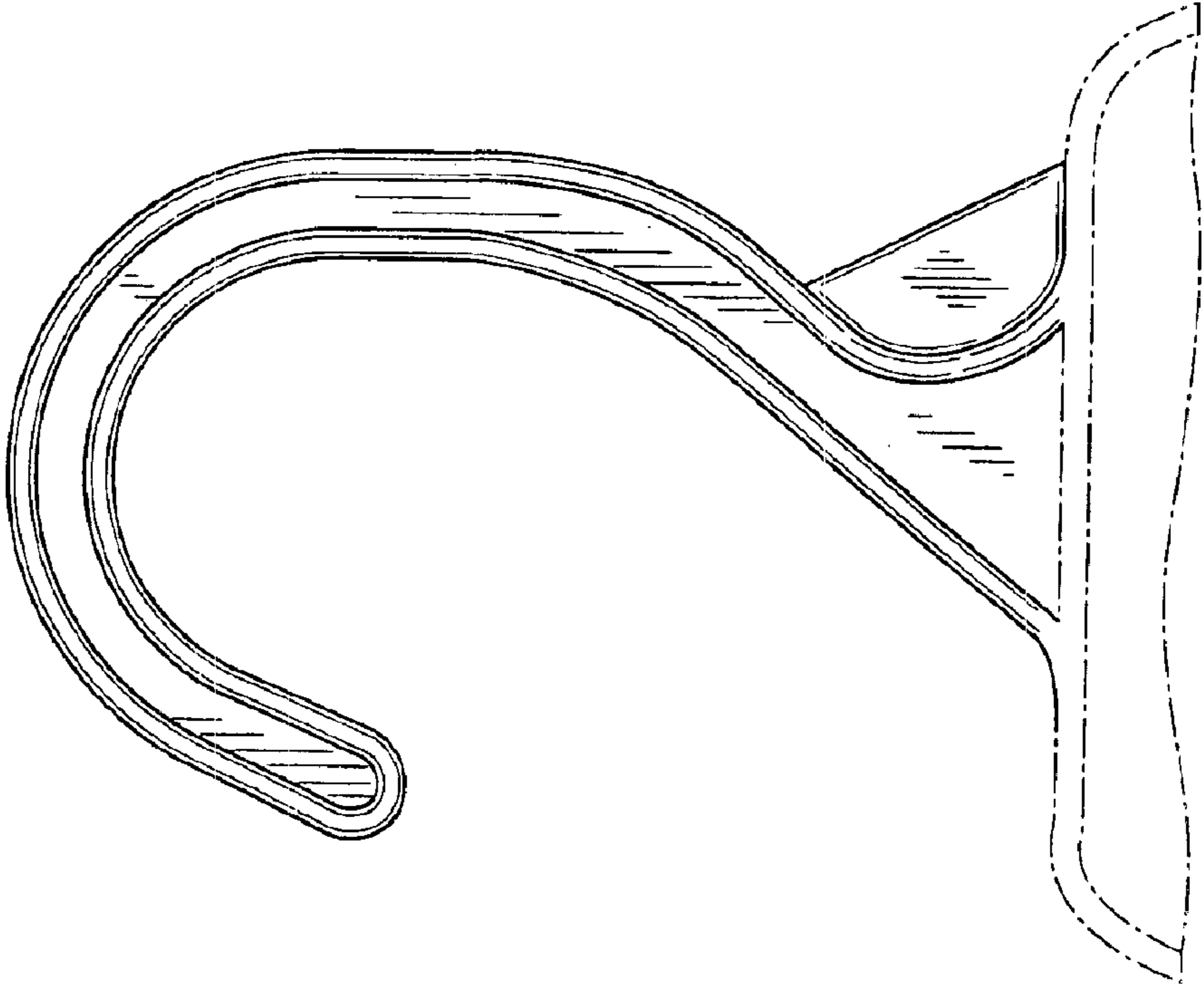
