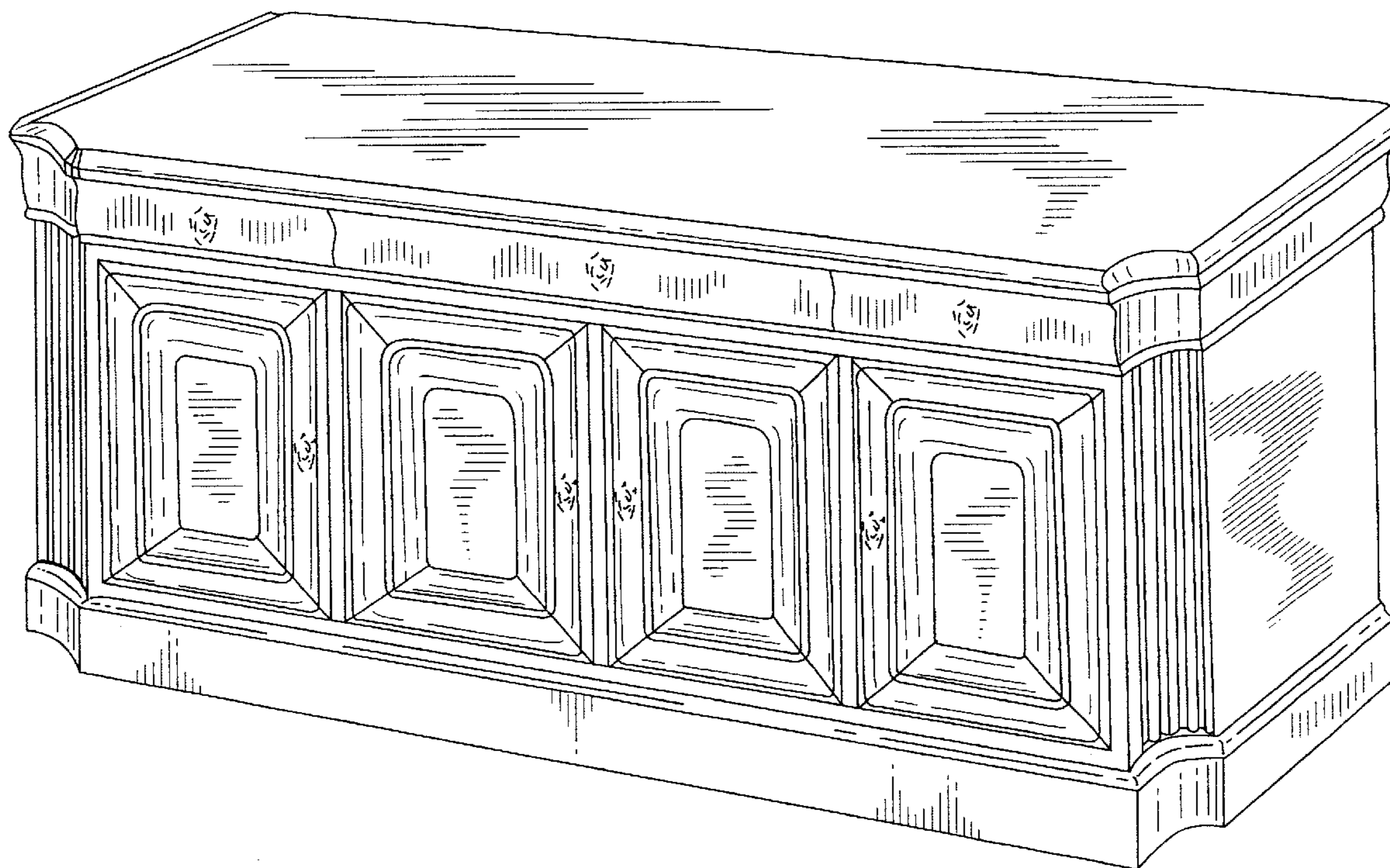
(57) **CLAIM**

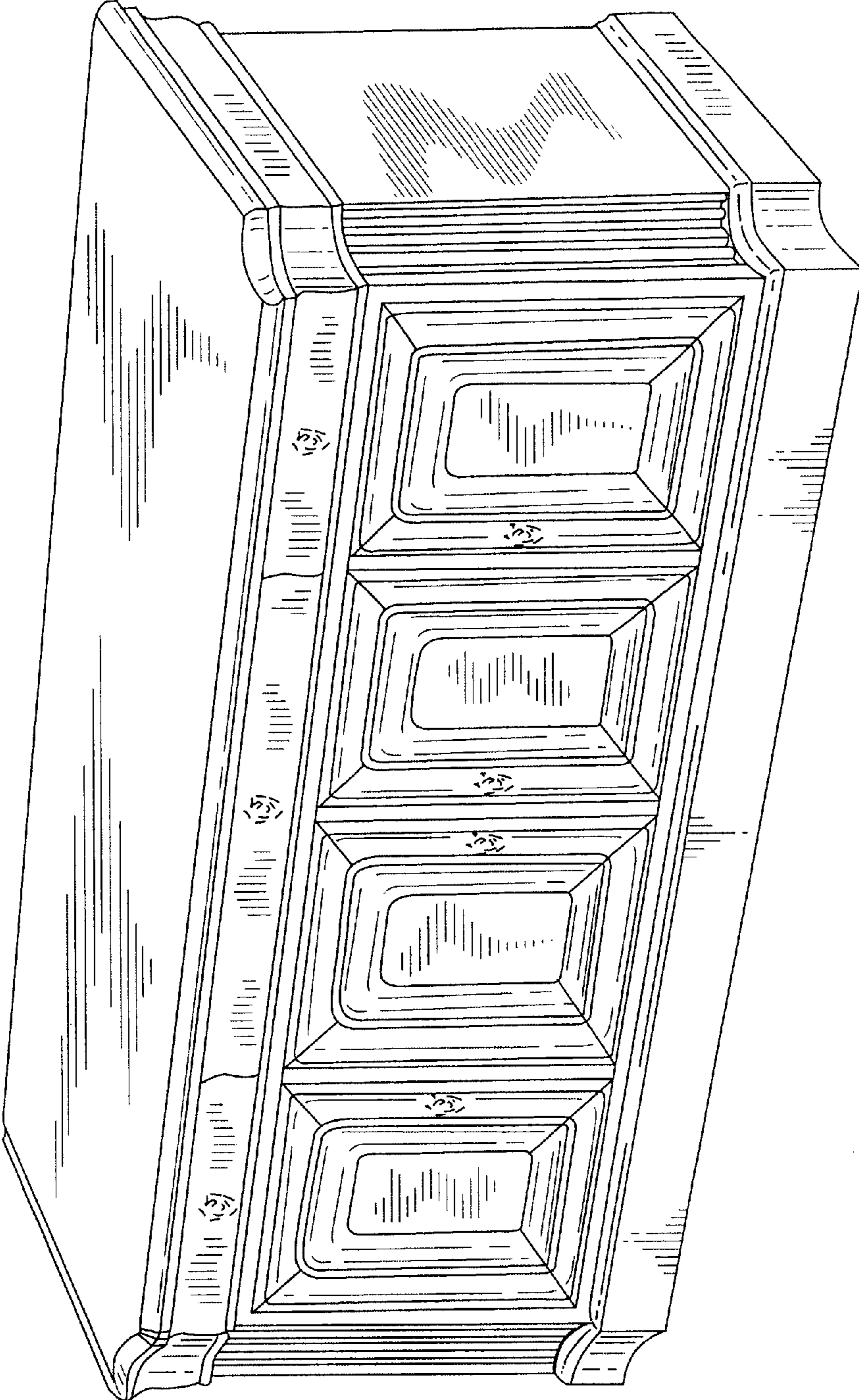
I claim the ornamental design for a furniture unit, as shown and described.

**DESCRIPTION**

The broken line showing is for illustrative purposes only and forms no part of the claimed design.

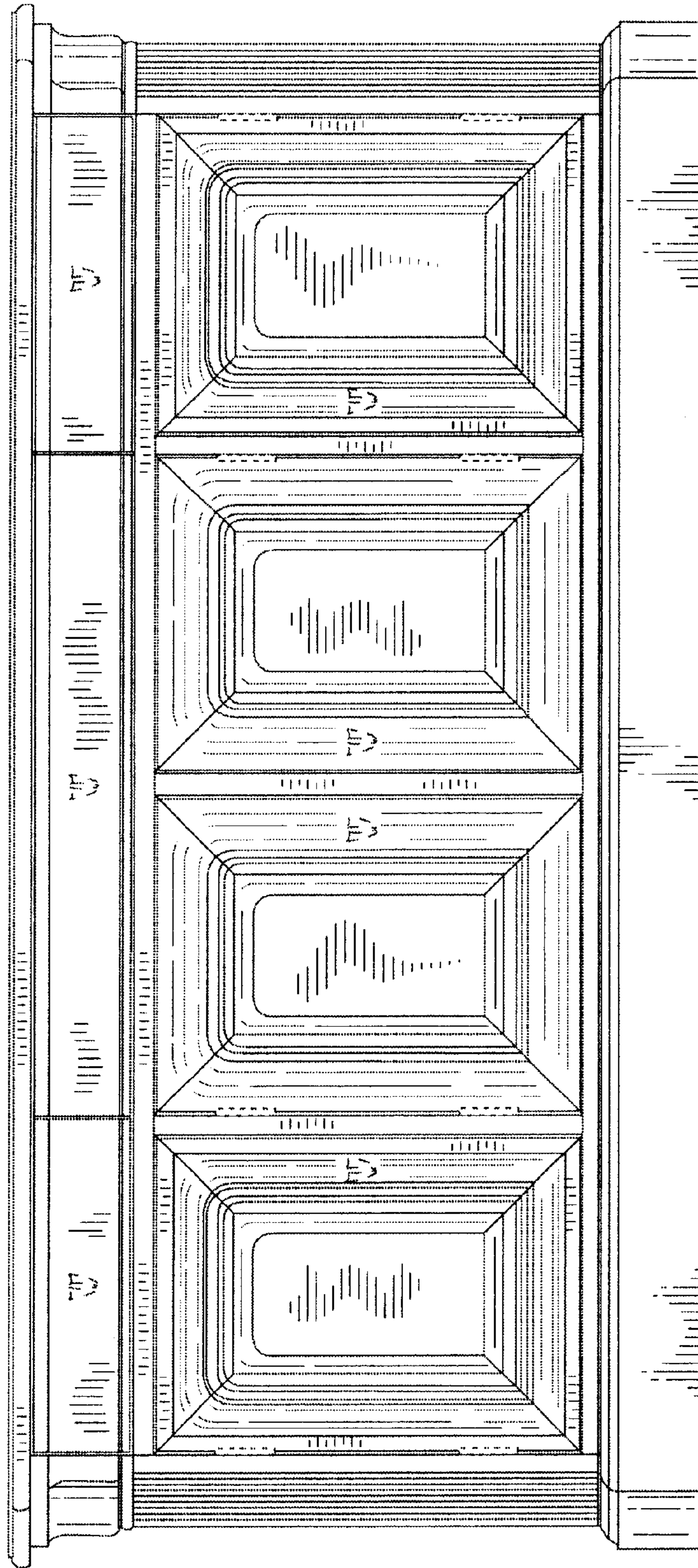

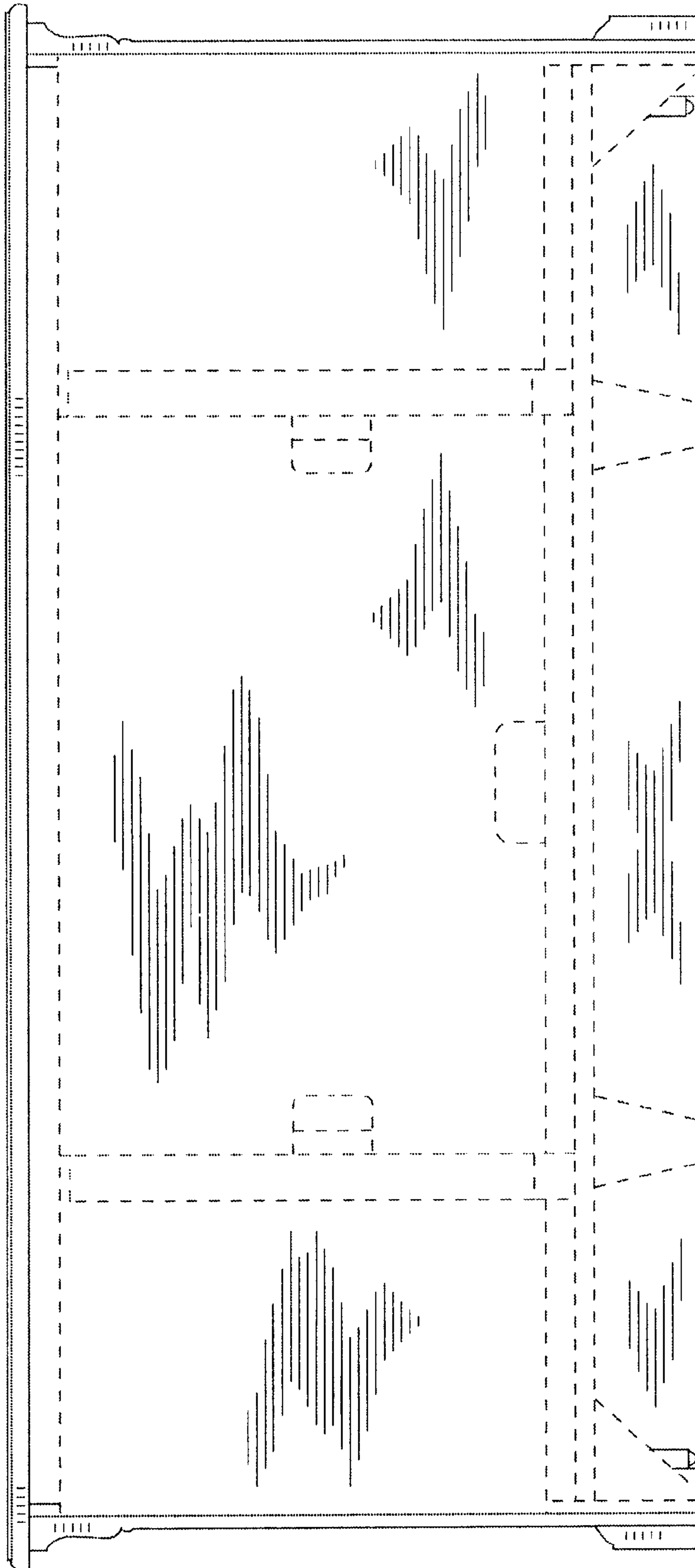

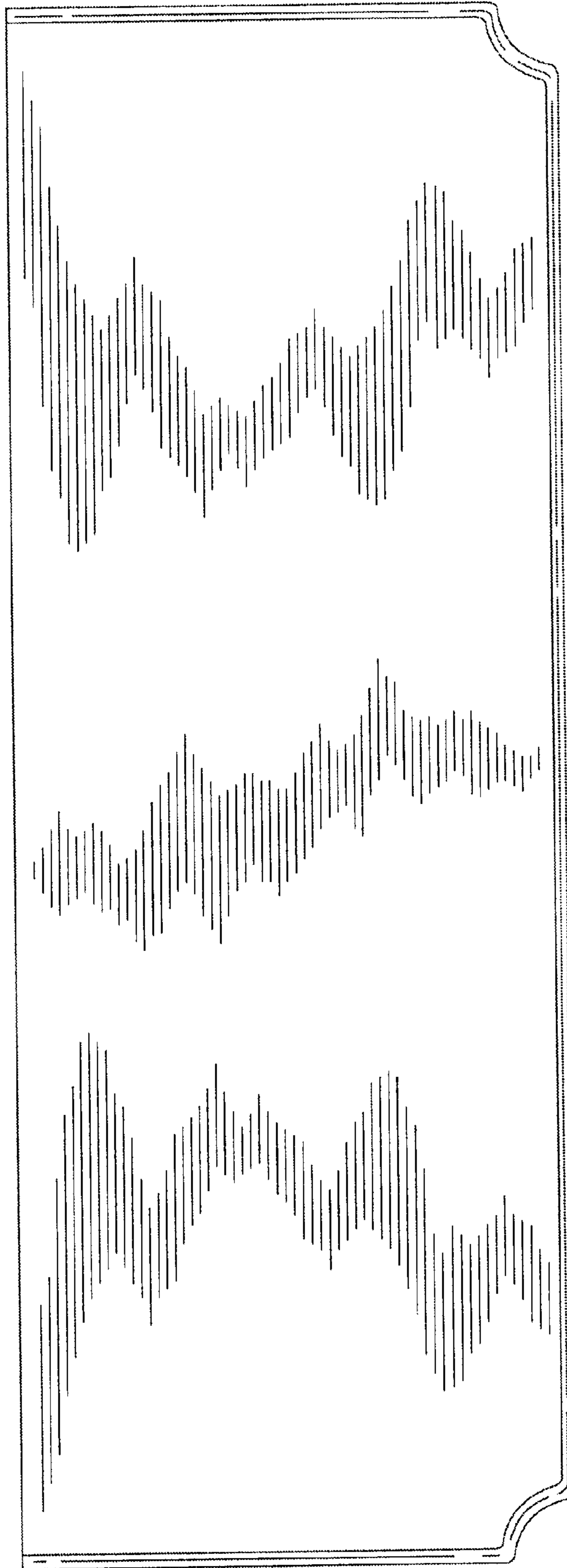




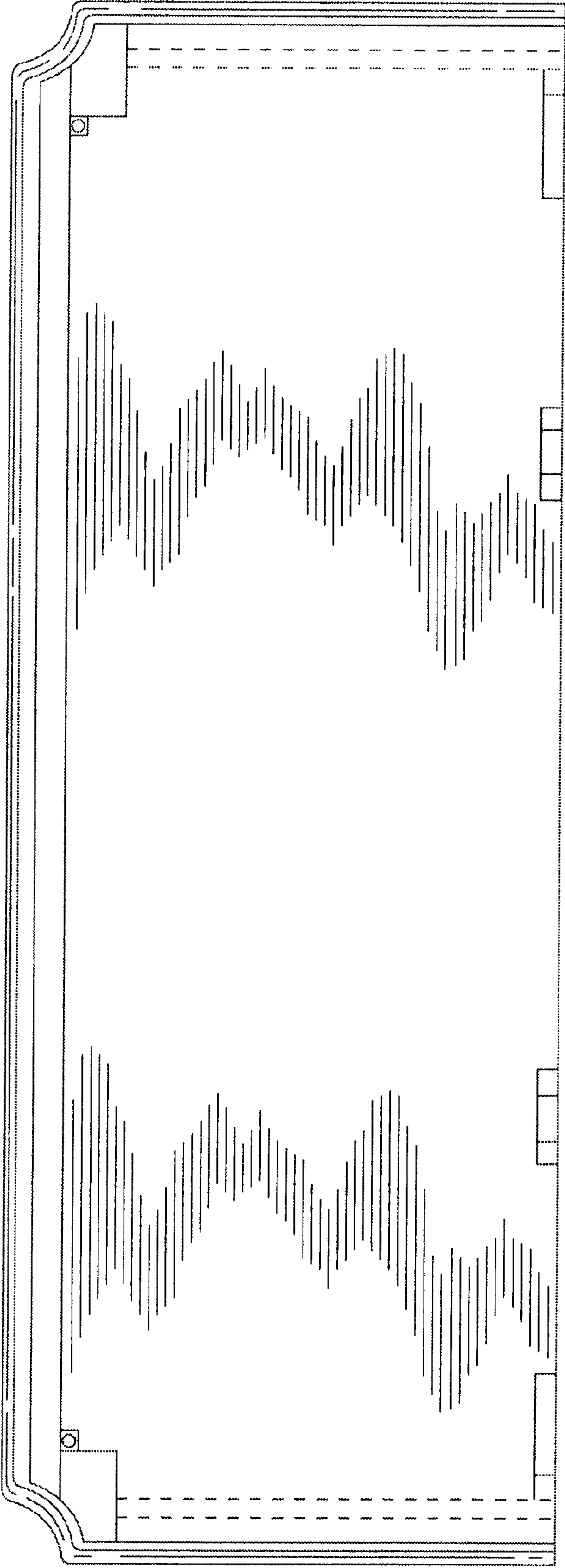

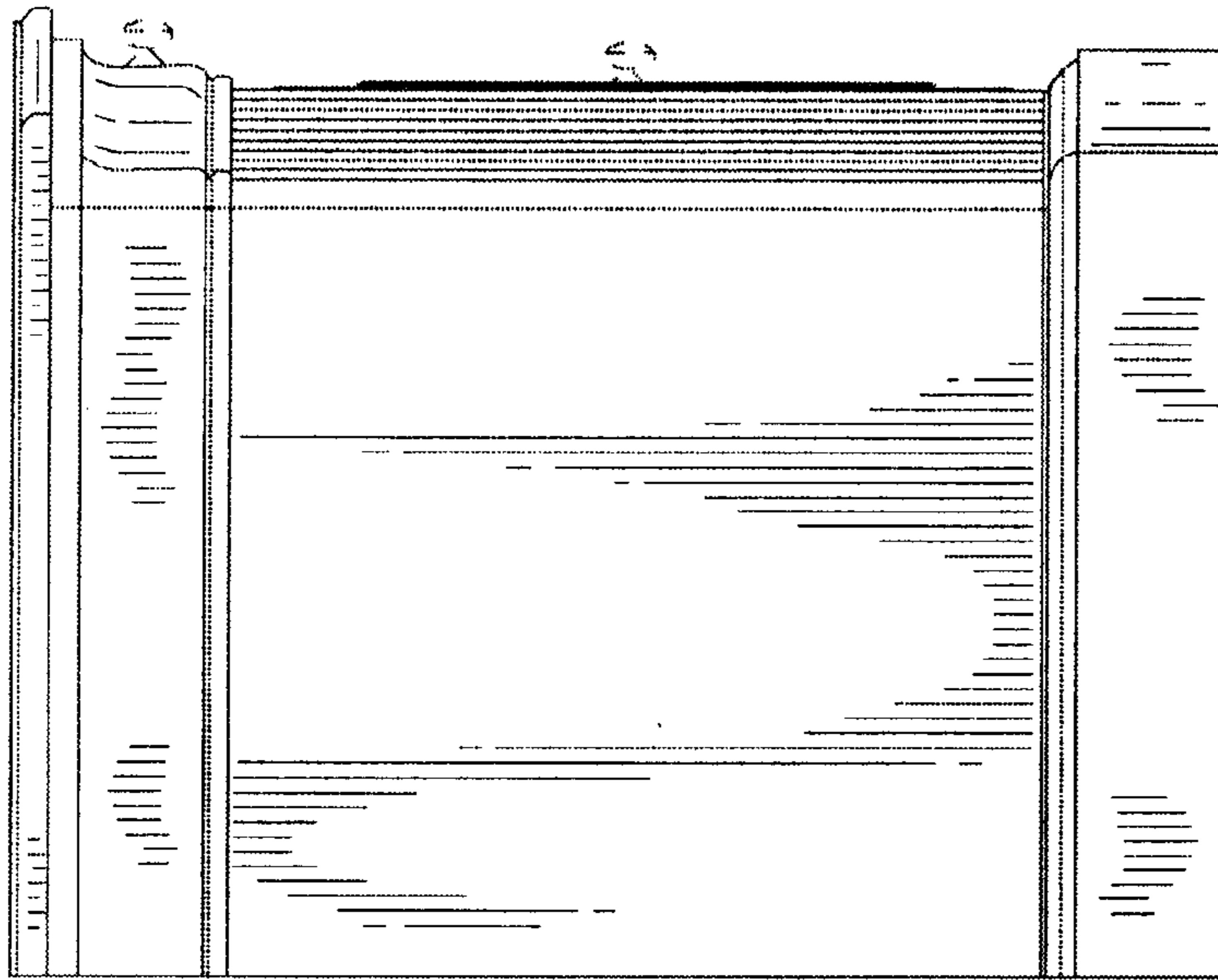

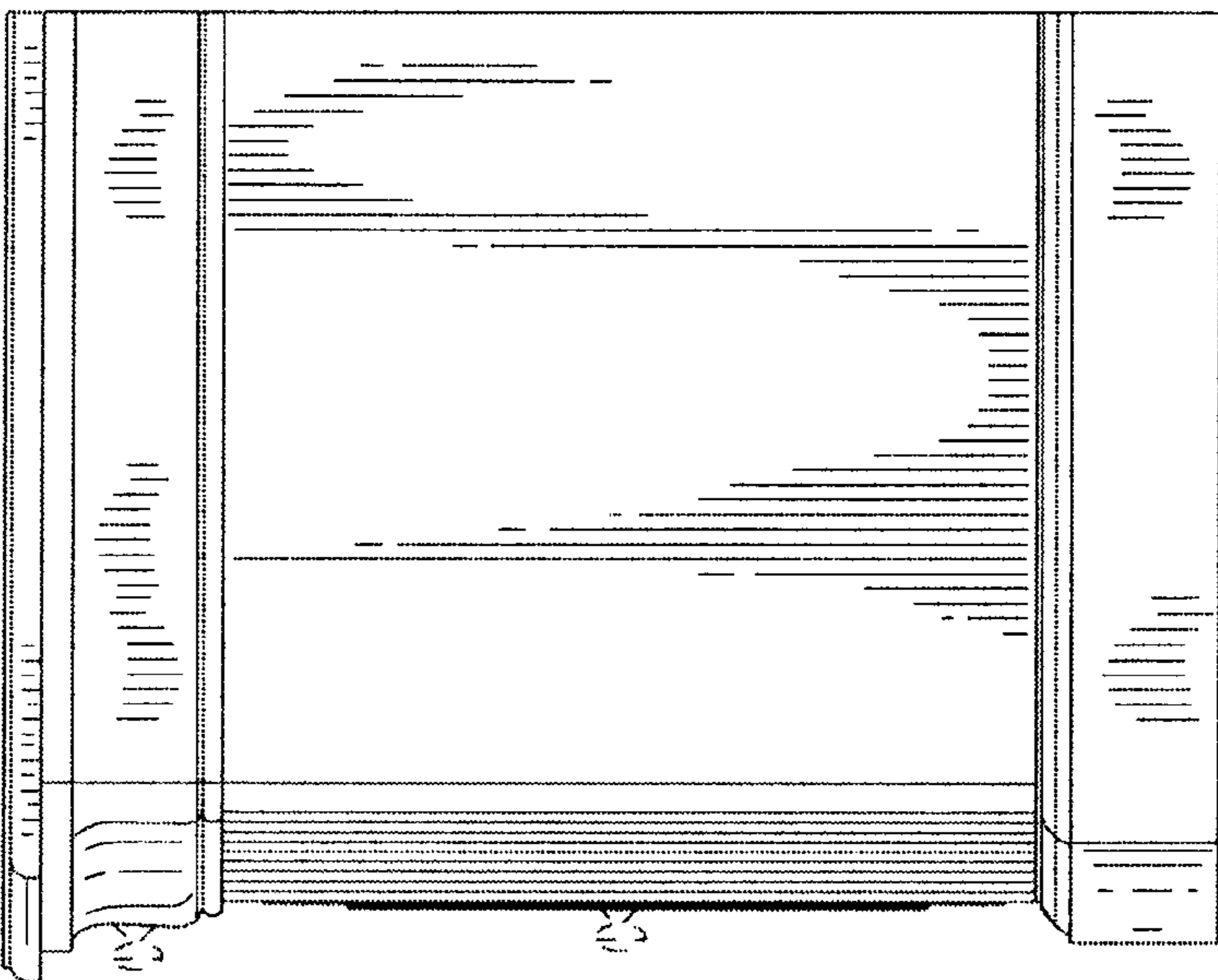
