(57) **CLAIM**

The ornamental design for a bottle portion, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle portion showing the new design;

FIG. 2 is a front elevation view thereof, the rear elevational view being identical except for the unclaimed threads;

FIG. 3 is a left side elevation view thereof, the right side elevational view being identical except for the unclaimed threads;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a perspective view showing a second embodiment of a bottle portion of the new design;

FIG. 7 is a front elevation view thereof, the rear elevational view being identical except for the unclaimed threads;

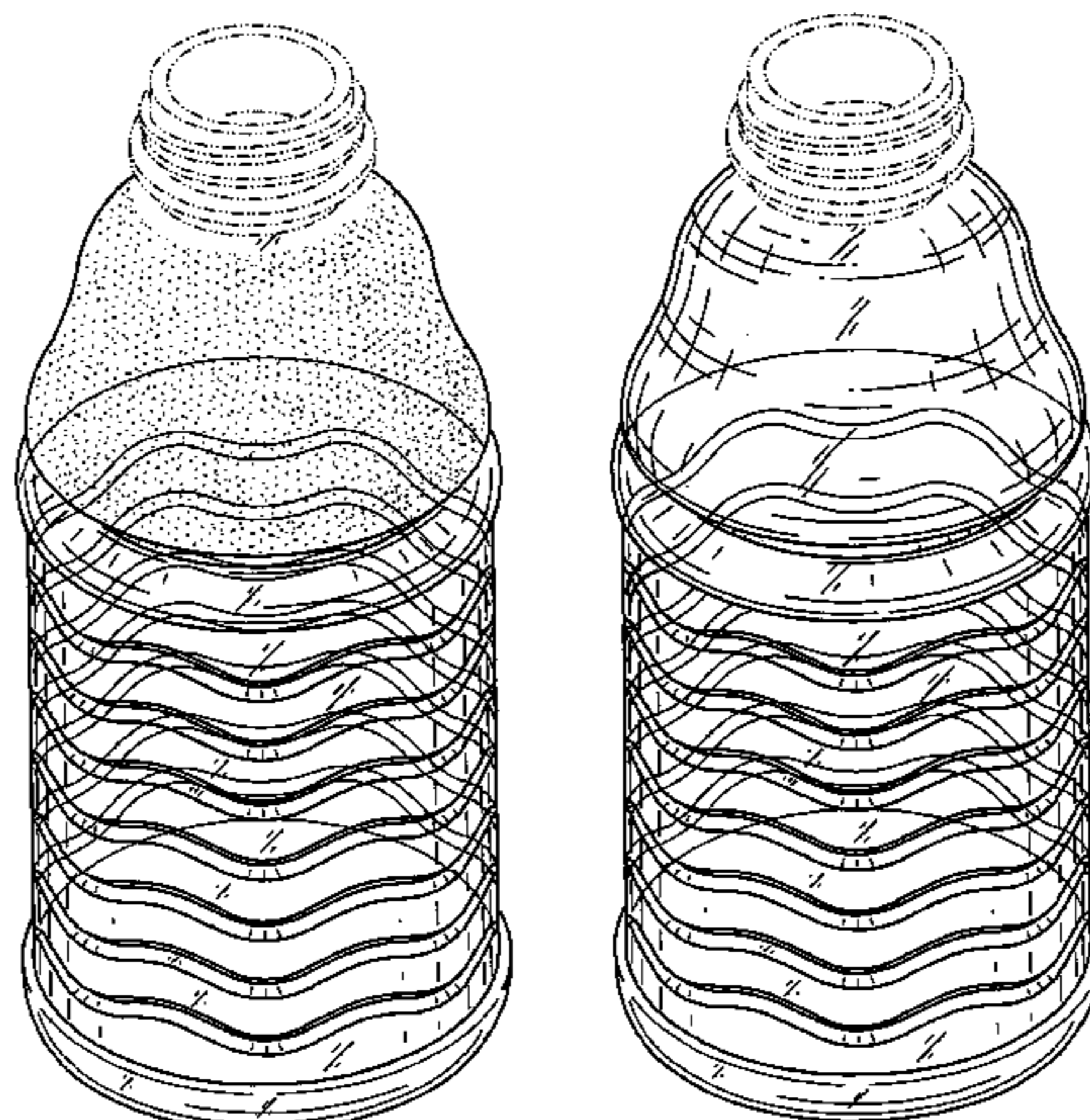
FIG. 8 is a left side elevation view thereof, the right side elevational view being identical except for the unclaimed threads; and,

FIG. 9 is a top plan view thereof, the bottom plan view being as shown in FIG. 5.

The stipple shading shown on the dome of the bottle portion in the FIGS. 1-4 drawing views represents a textured, transparent surface.

The broken line showing in the drawing figures is for environmental purposes only and forms no part of the claimed design.

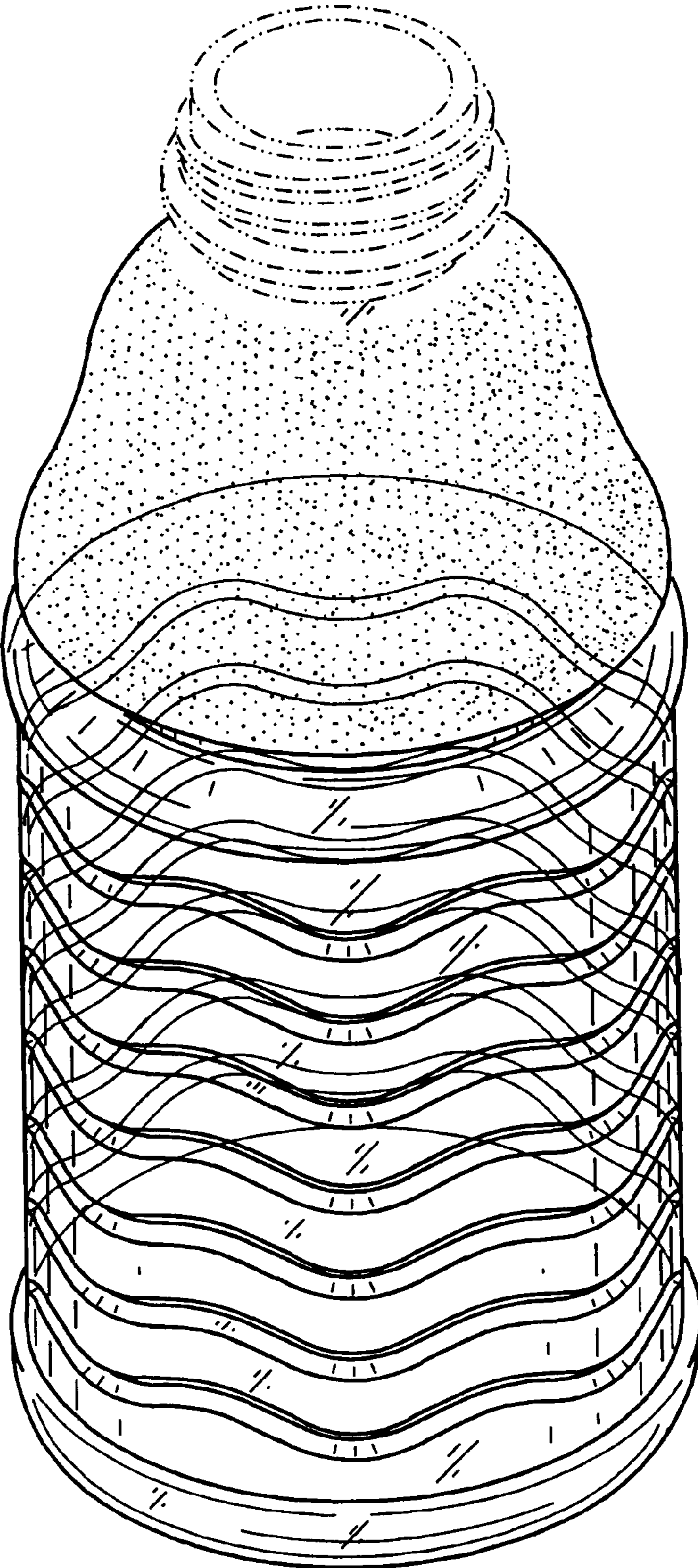

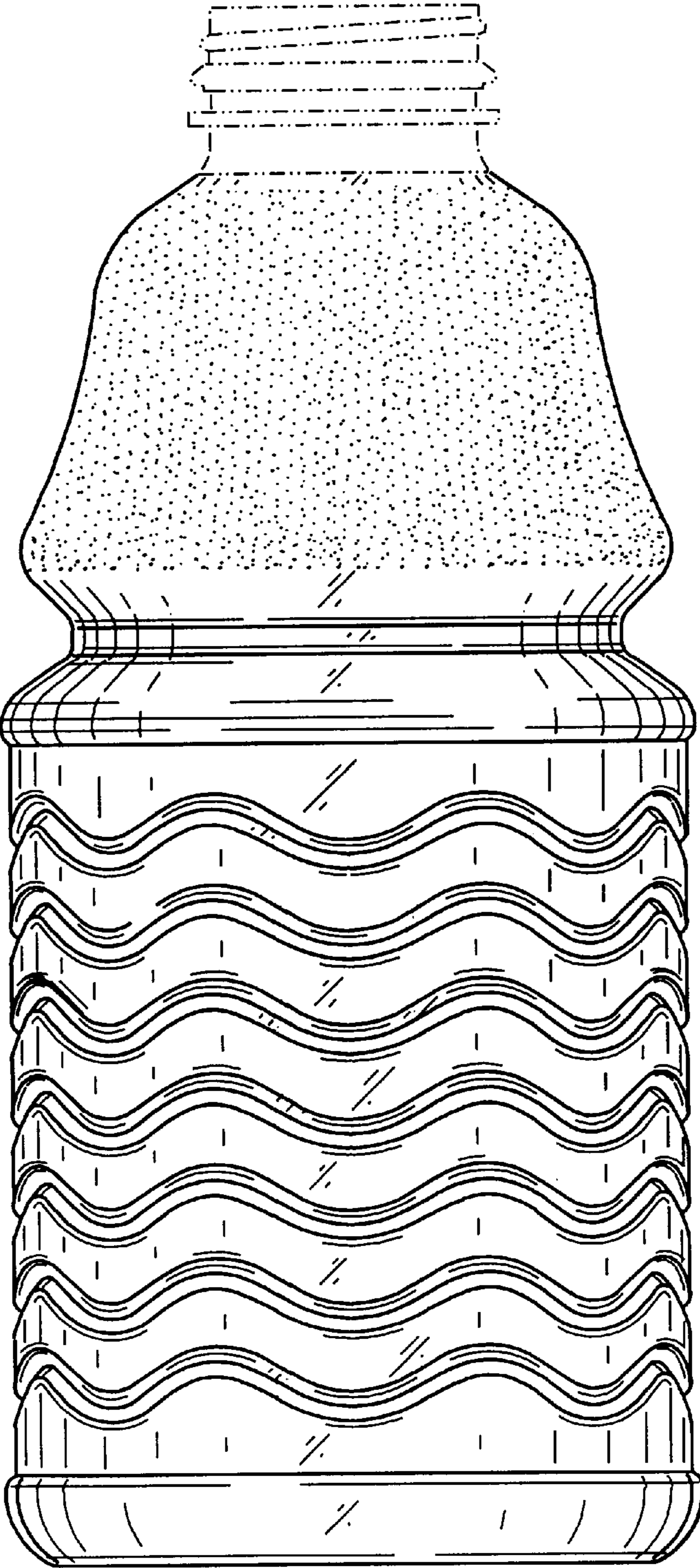

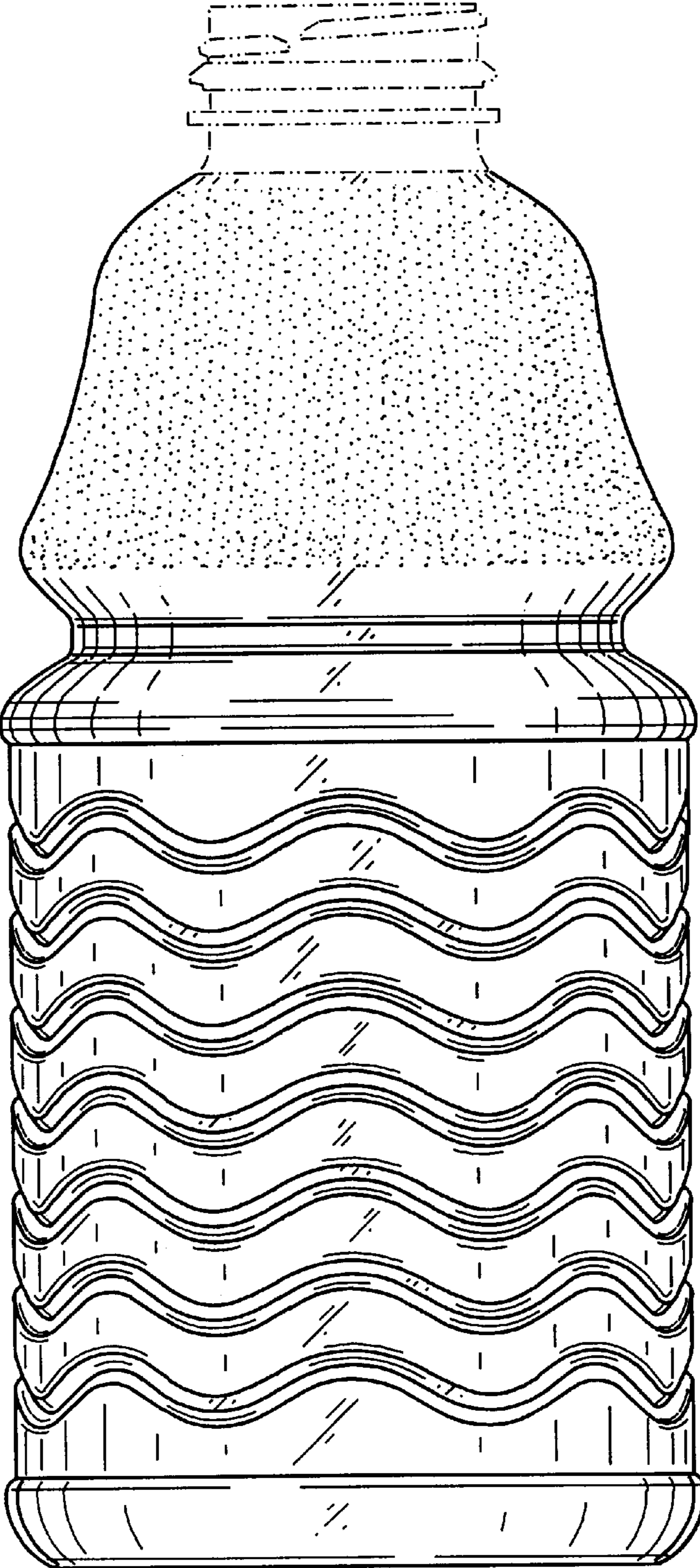

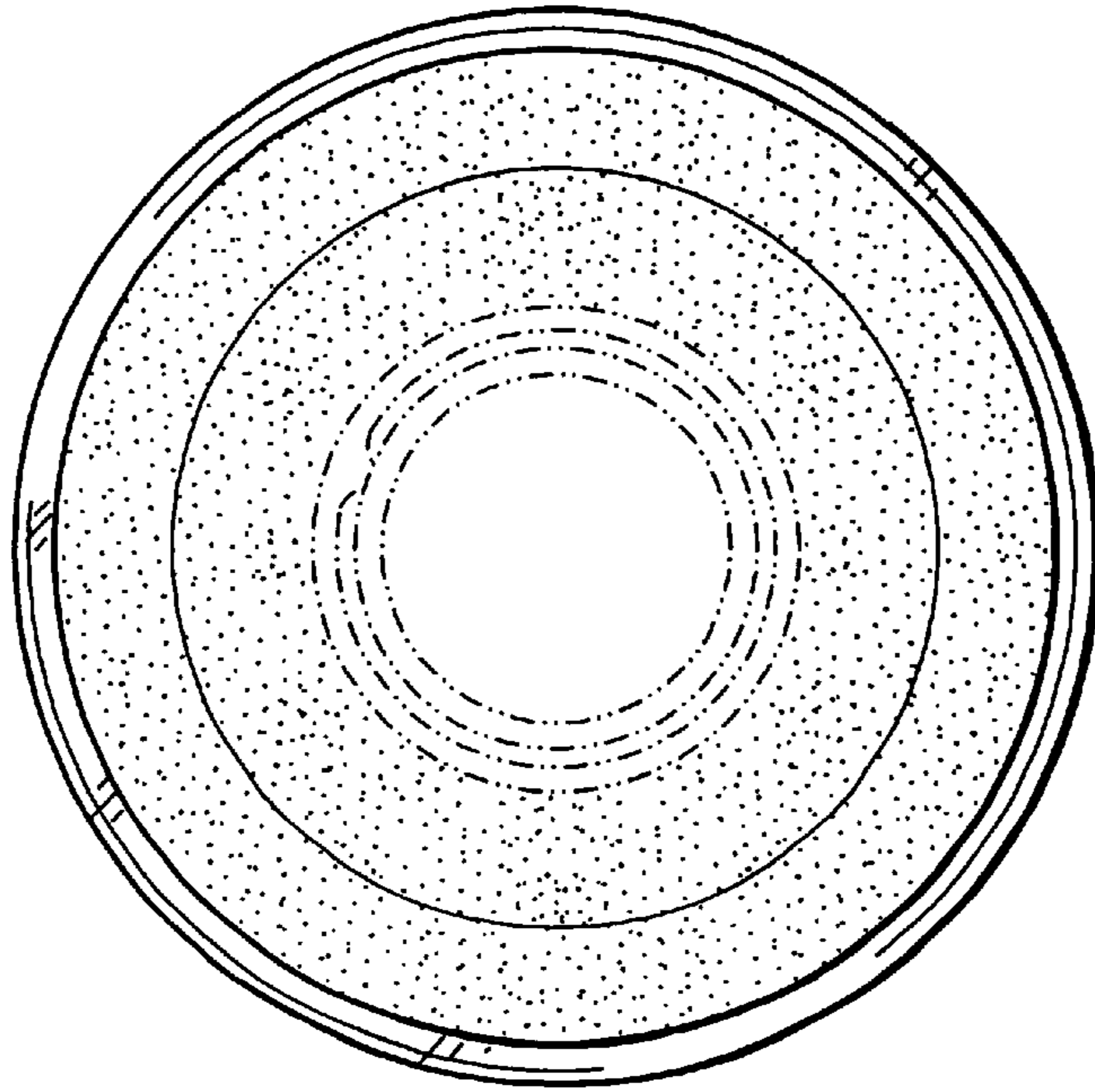

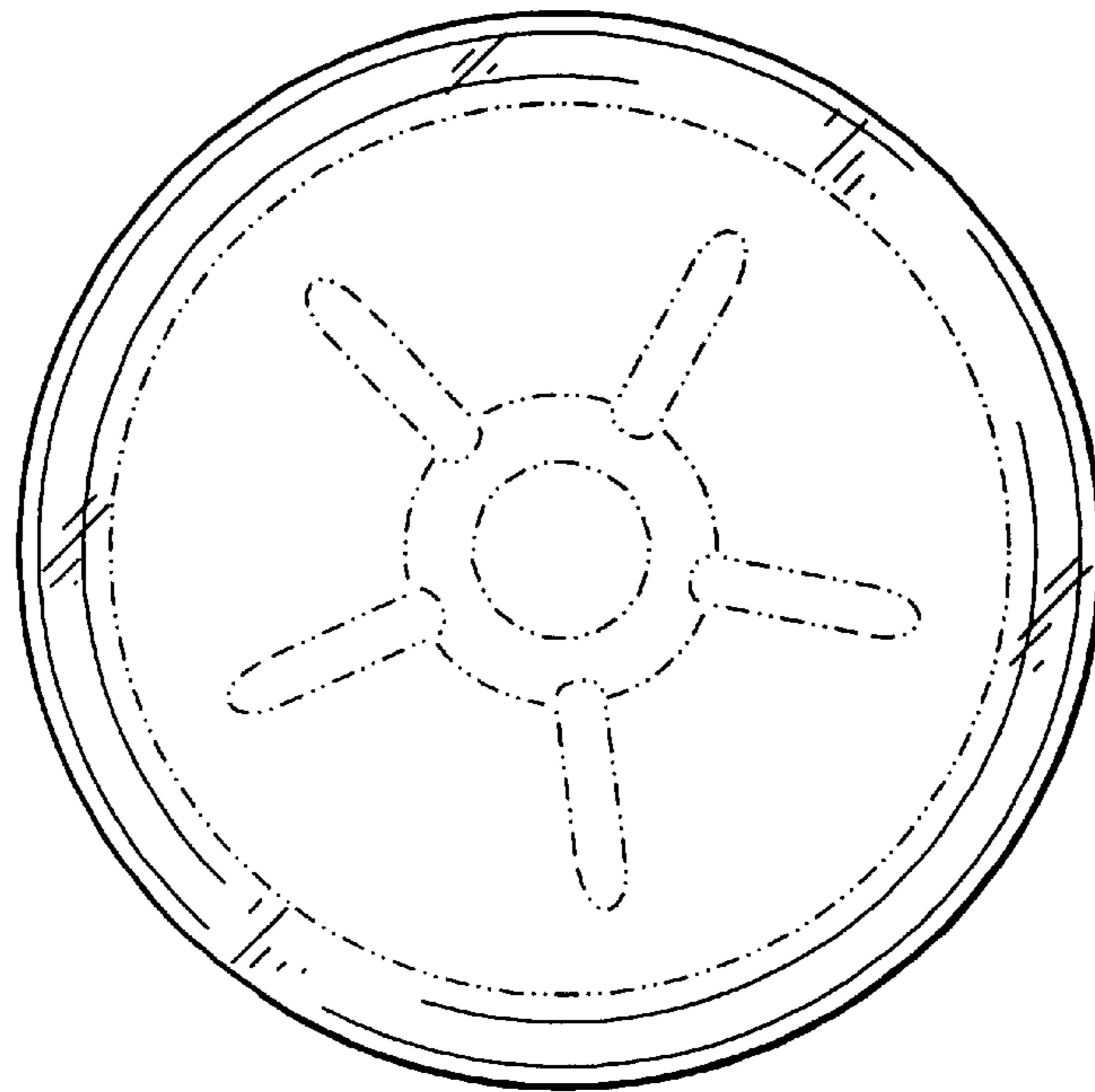

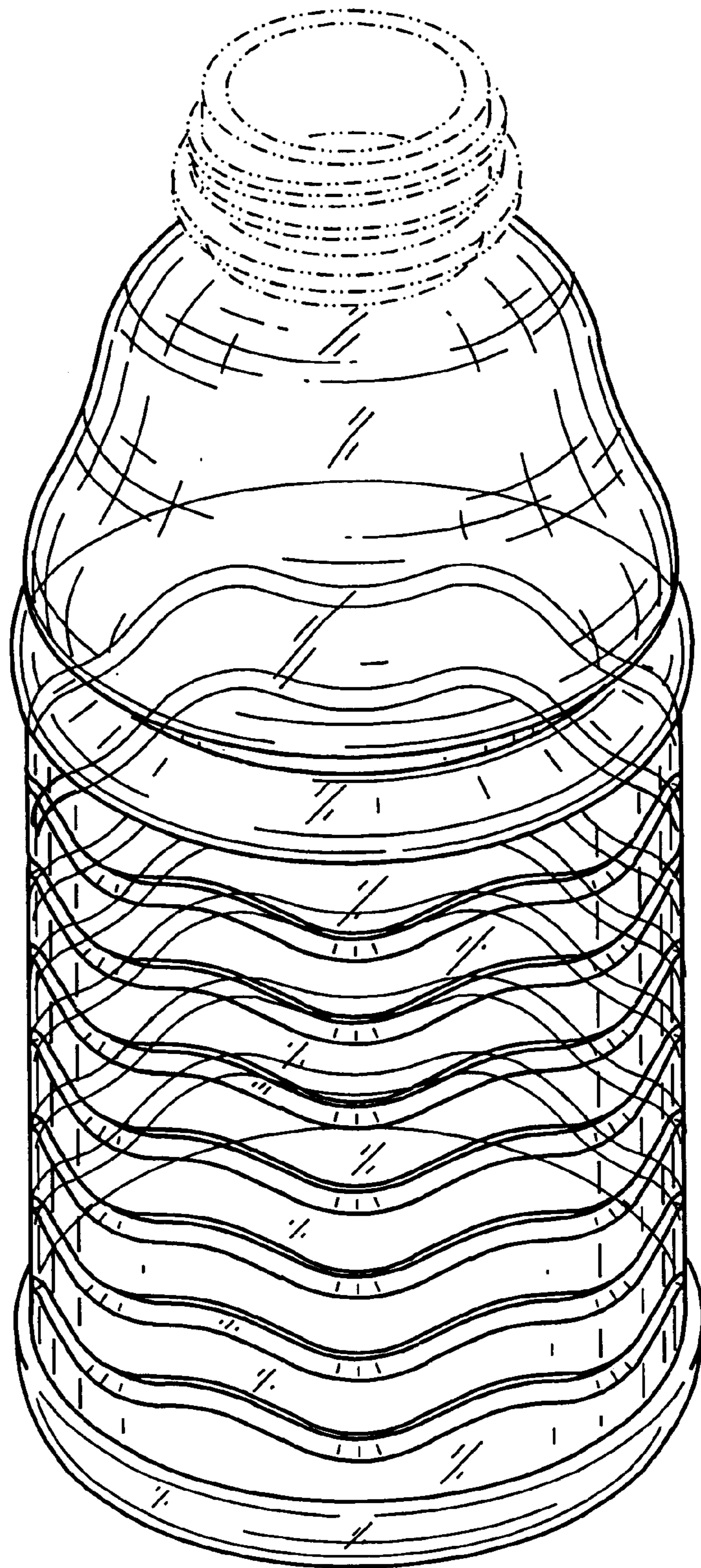

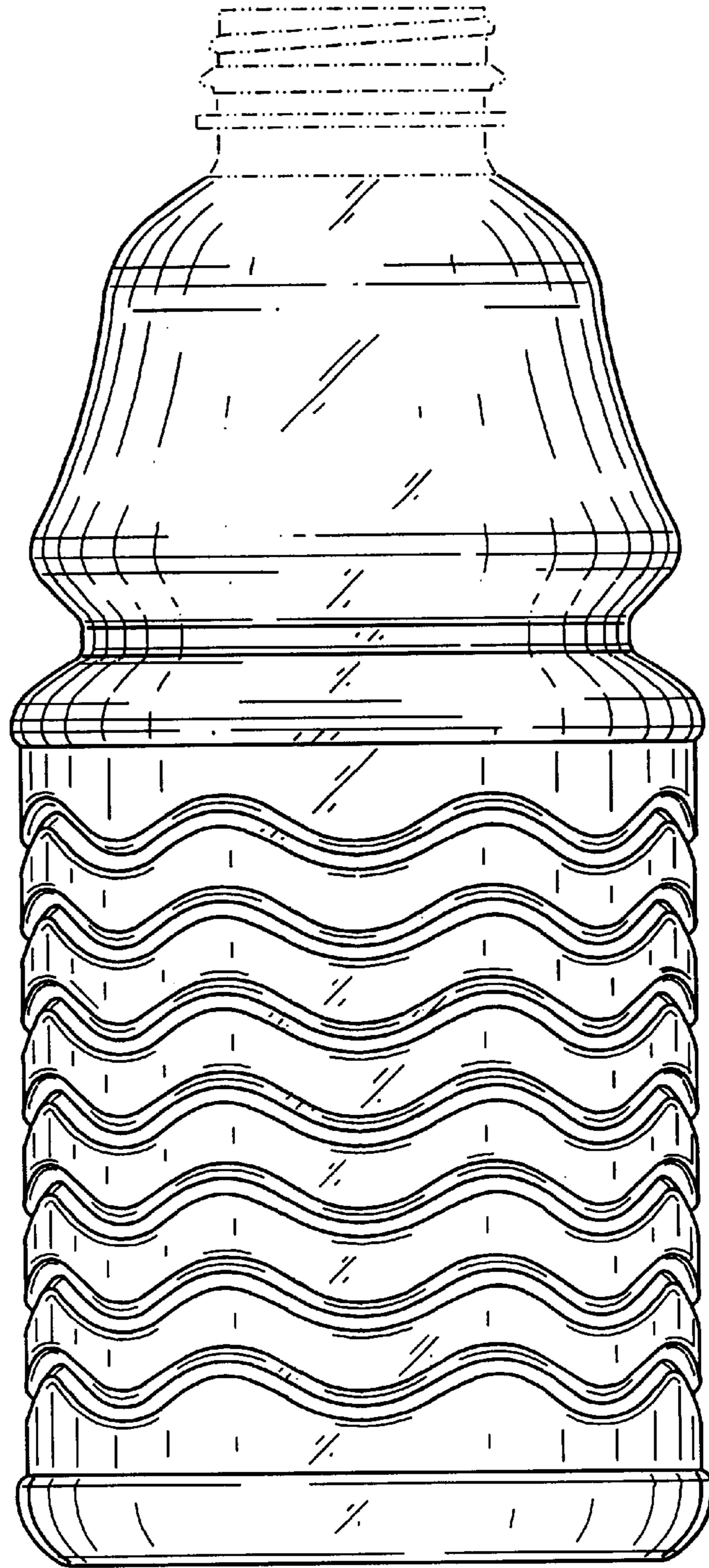

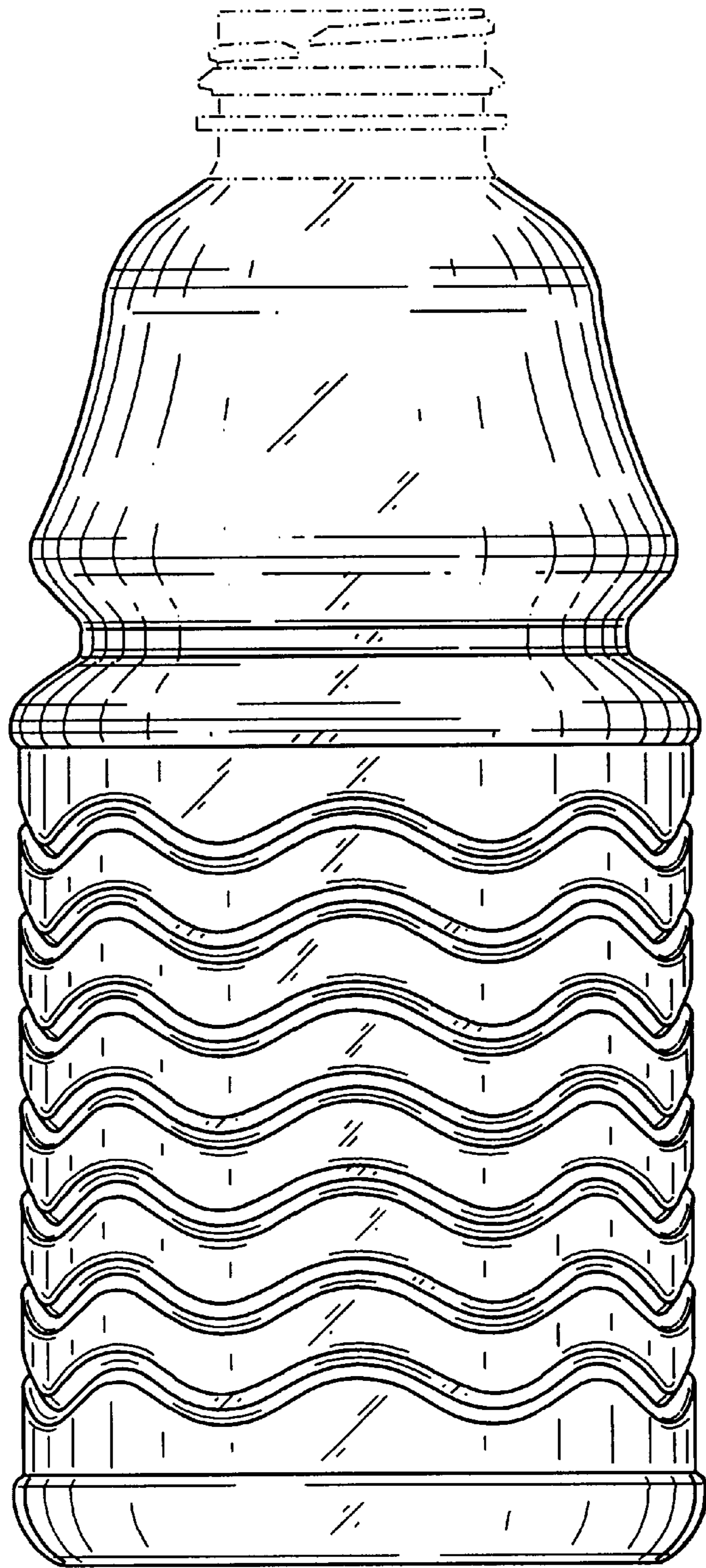

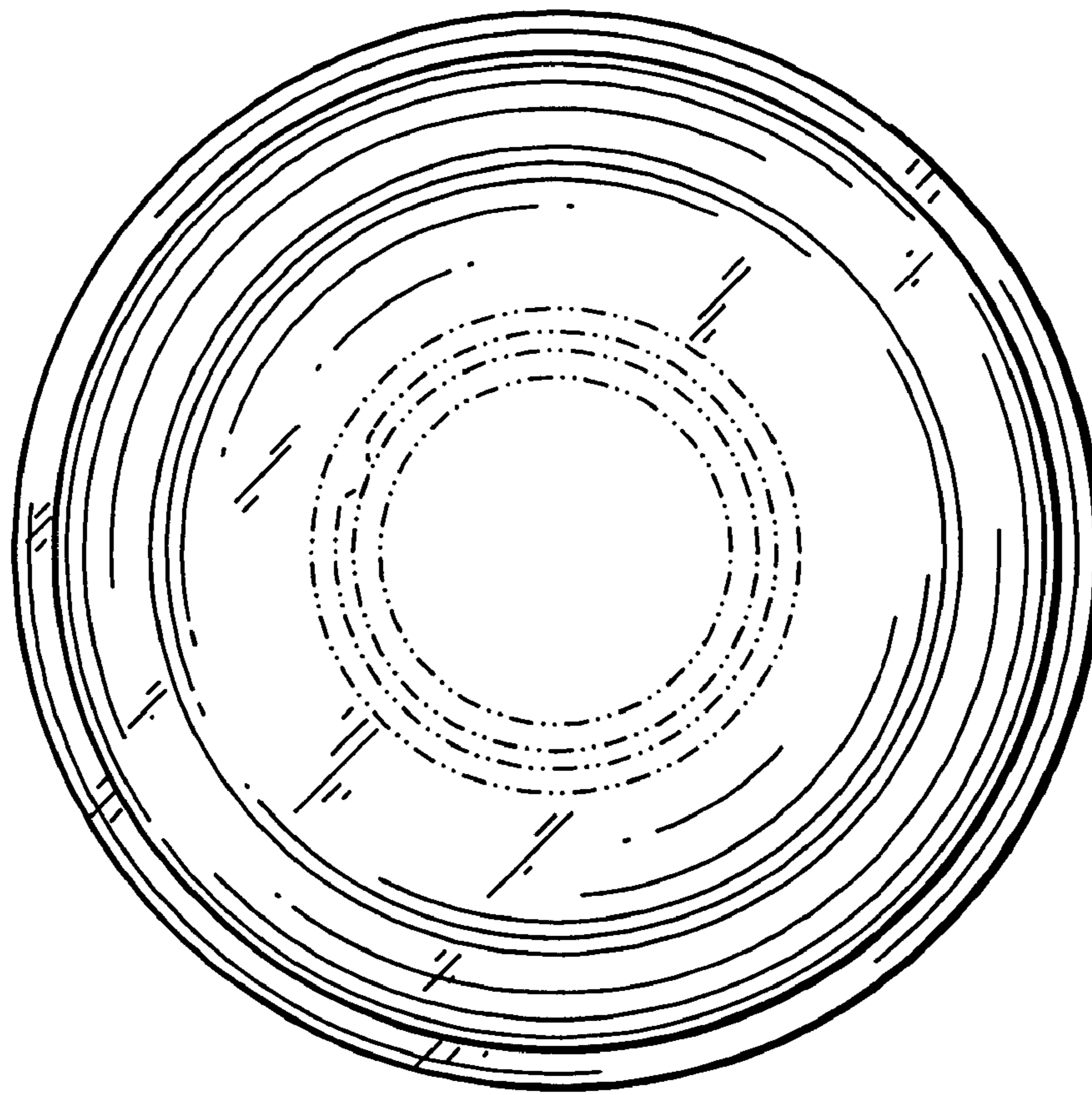
