The ornamental design for a vacuum packaging device, as shown and described.

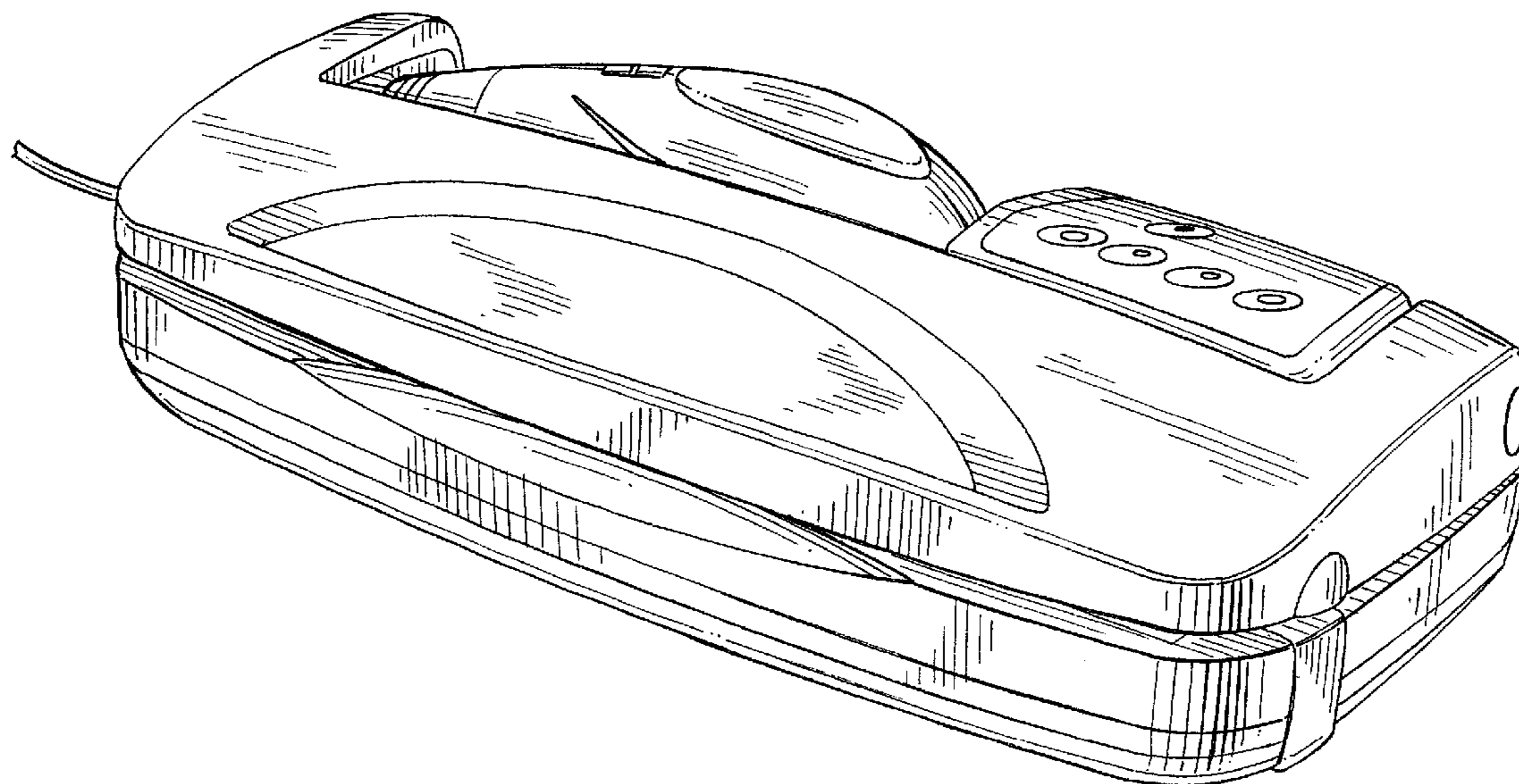
DESCRIPTION

FIG. 1 is a first perspective view of the vacuum packaging device of the present invention from a first angle;
 FIG. 2 is a second perspective view of the vacuum packaging device of the present invention from a second higher angle;

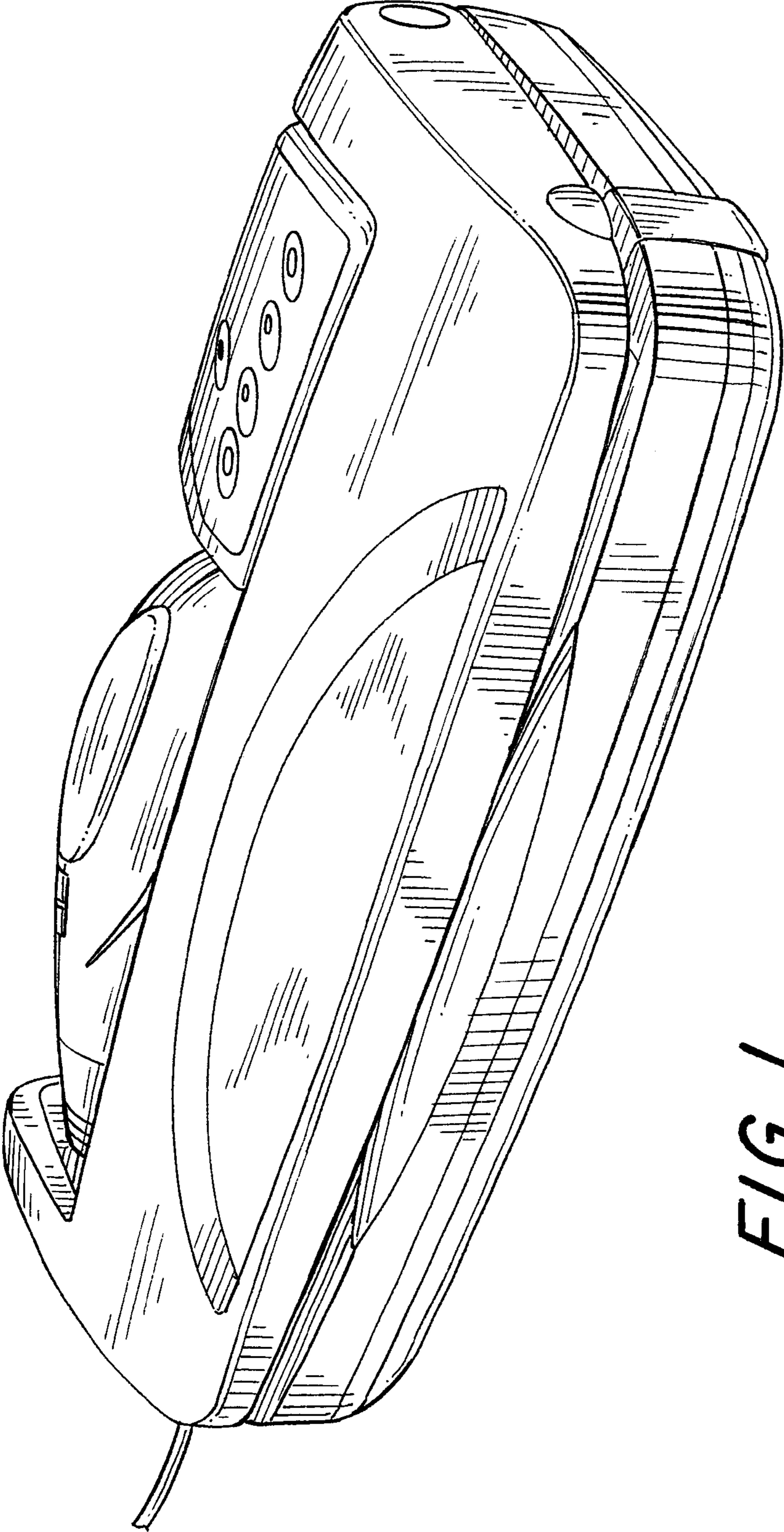

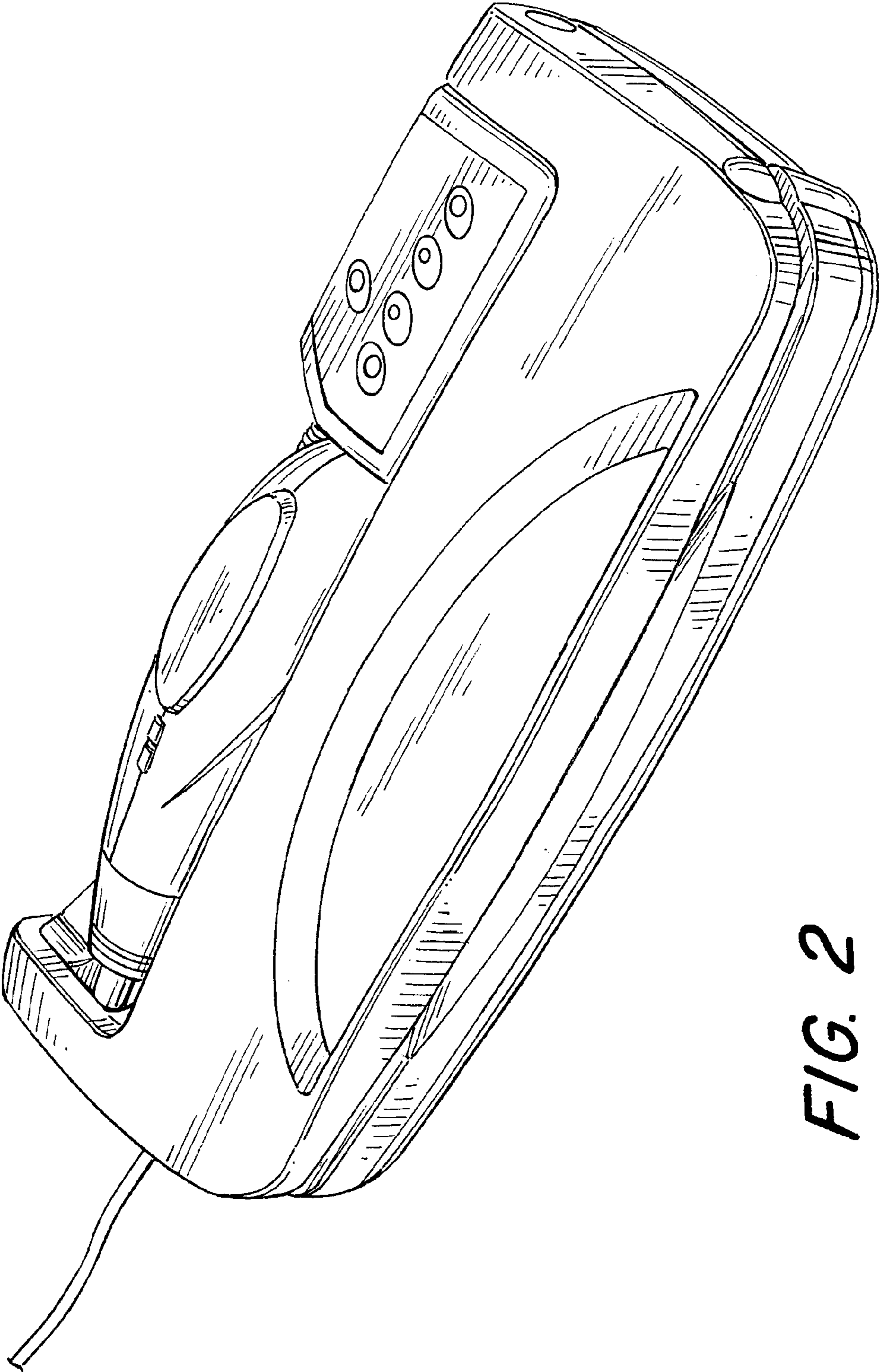

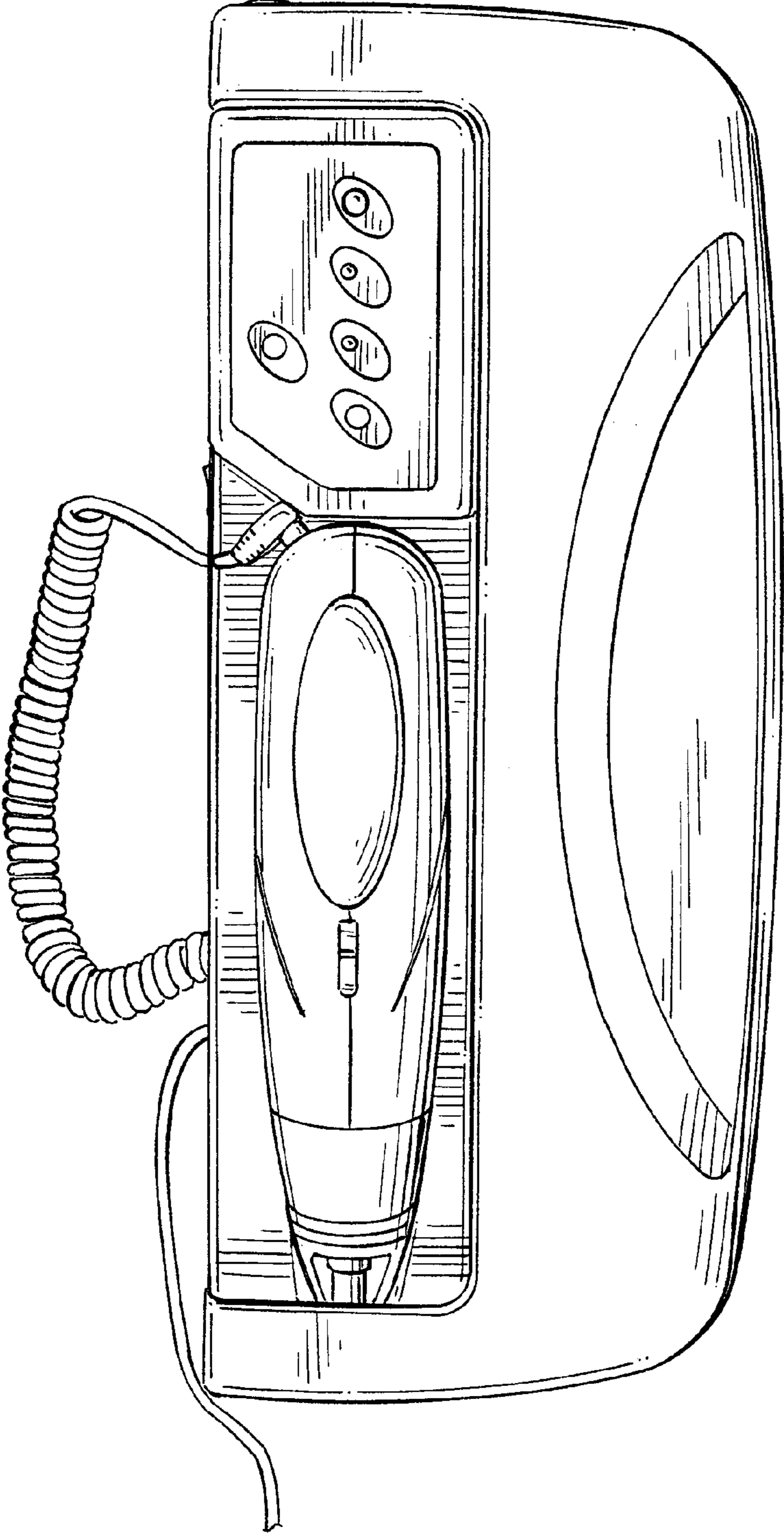

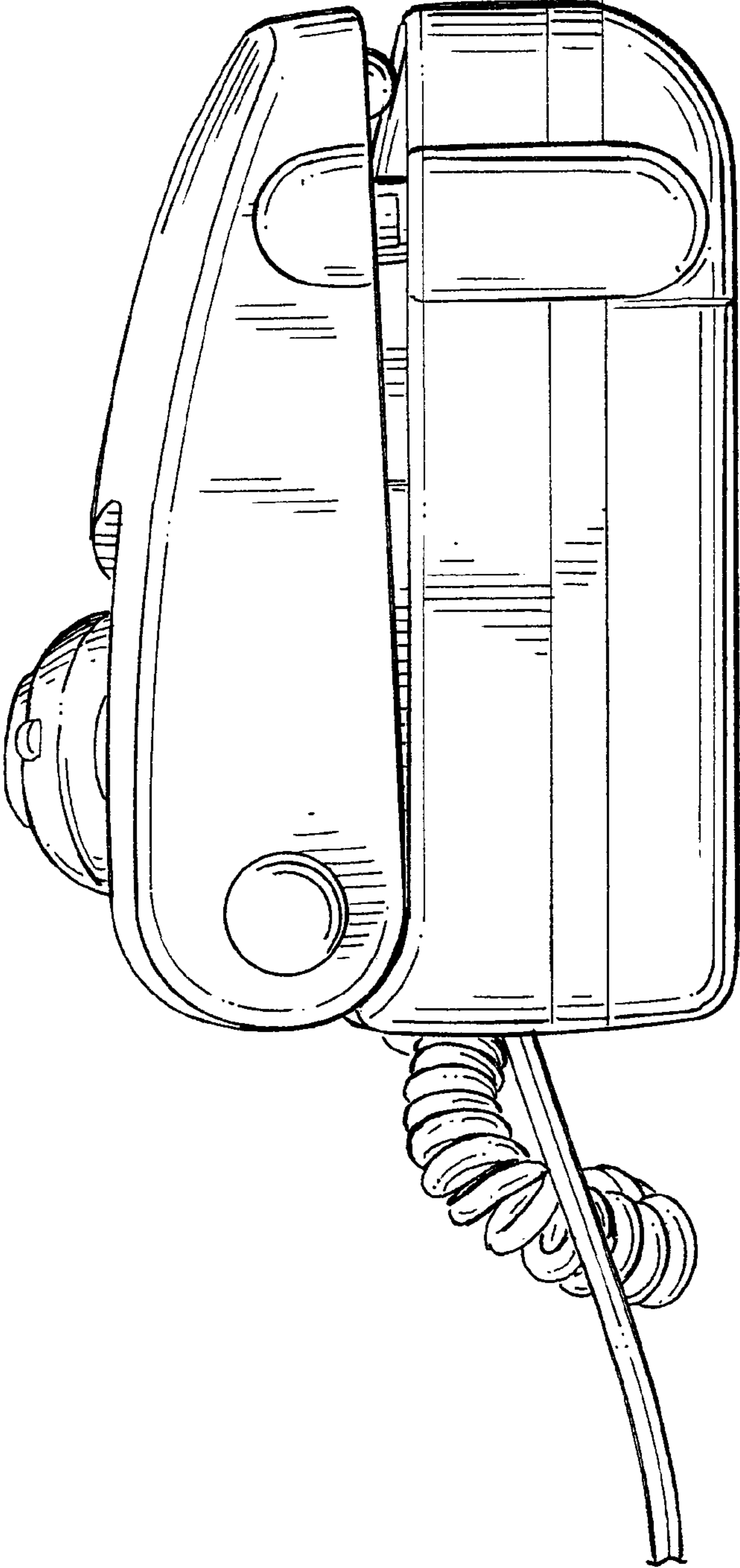

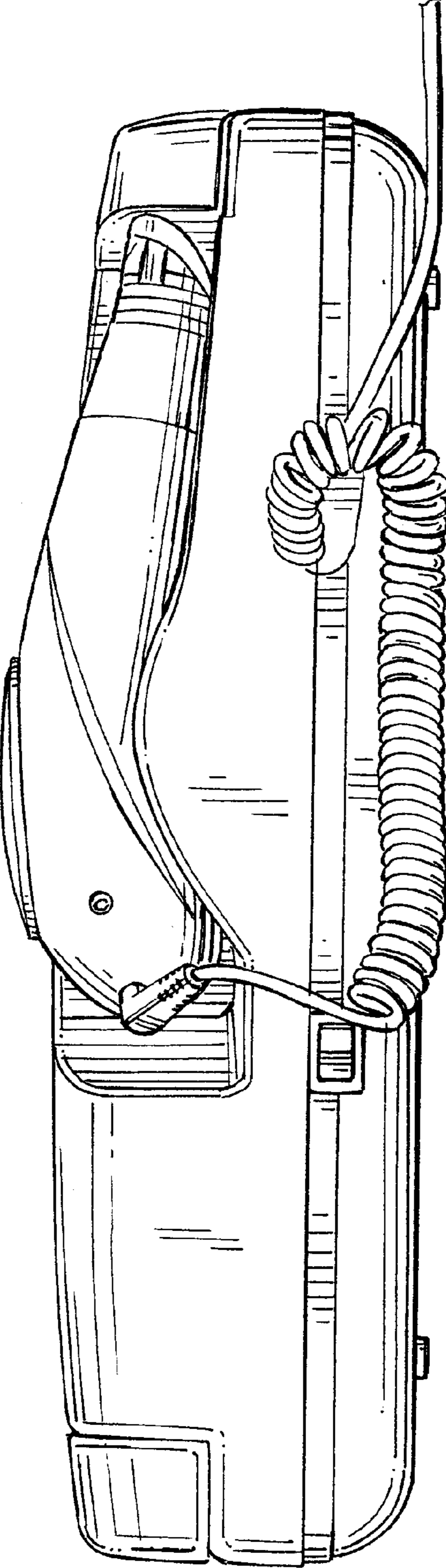

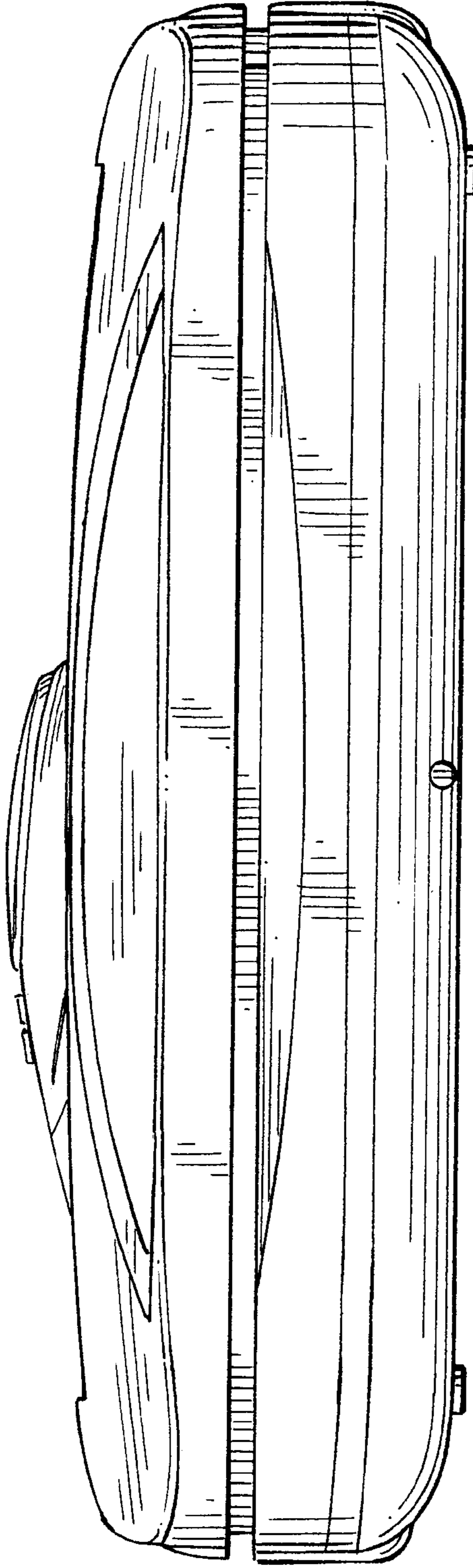
