FIG. 1 is a front elevational view of the training device for  
kicking a soccer ball, showing the new design;  
FIG. 2 is a side elevational view of the preferred embodi-  
ment of the training device for kicking a soccer ball;  
FIG. 3 is a plan view of the preferred embodiment of the  
training device for kicking a soccer ball;  
FIG. 4 is a bottom elevational view of the preferred embodi-  
ment of the training device for kicking a soccer ball; and,  
FIG. 5 is an illustrative view of the preferred embodiment of  
the training device for kicking a soccer ball in use.

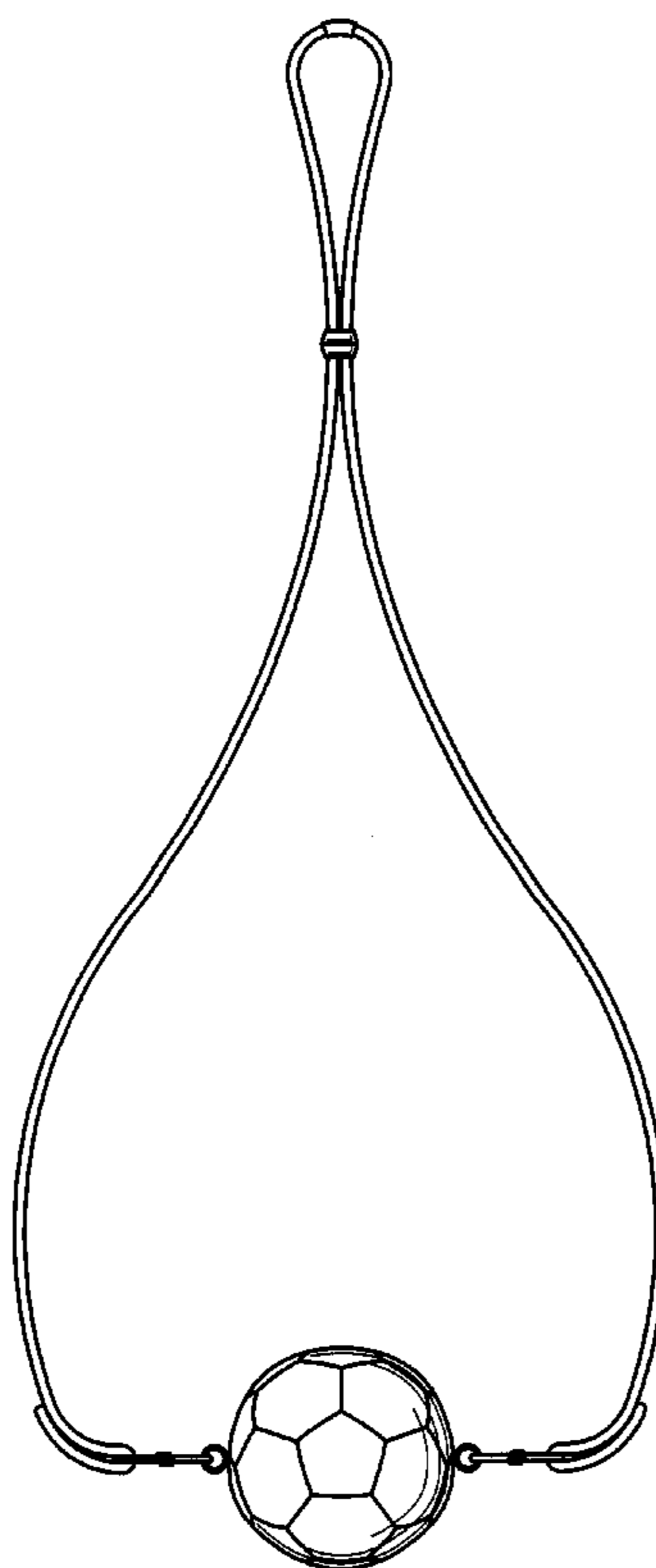

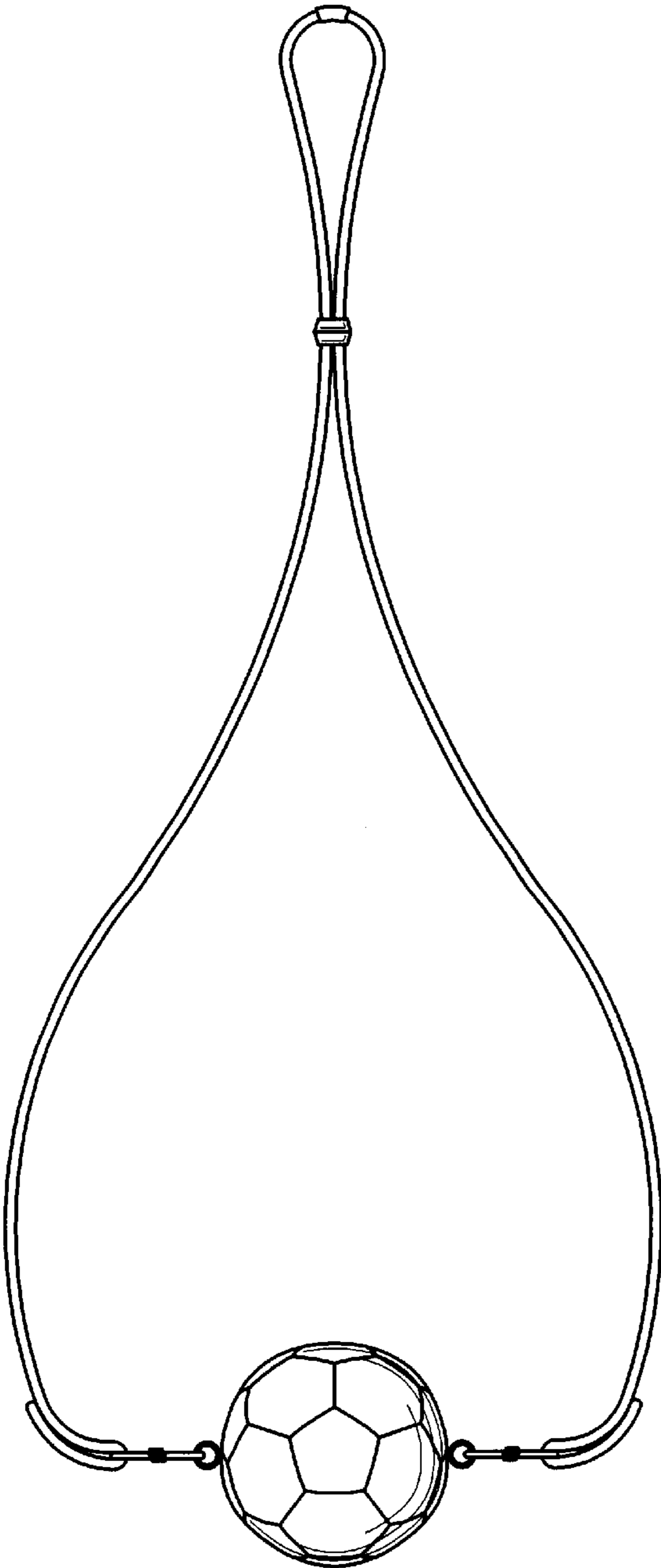

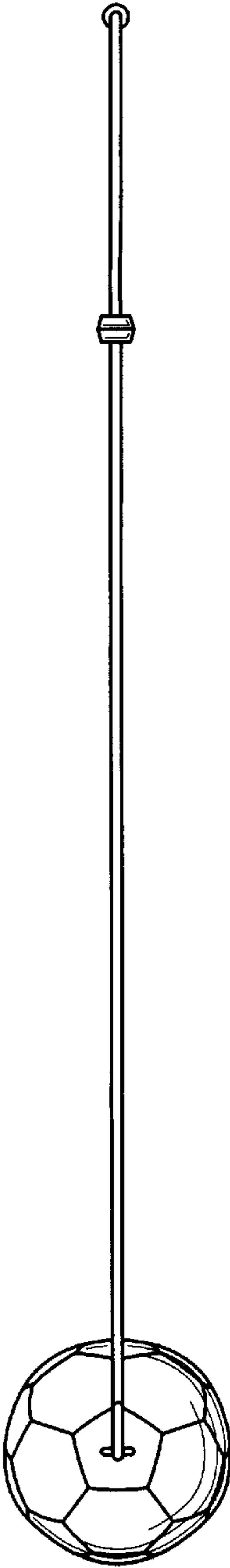

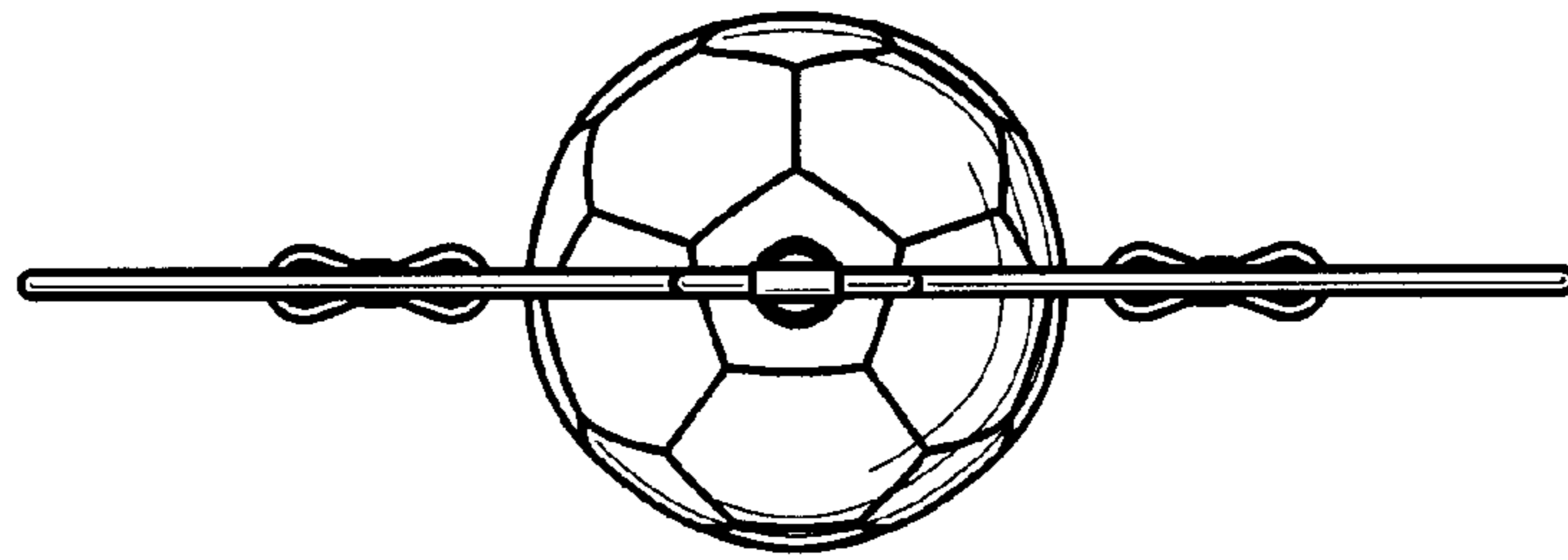

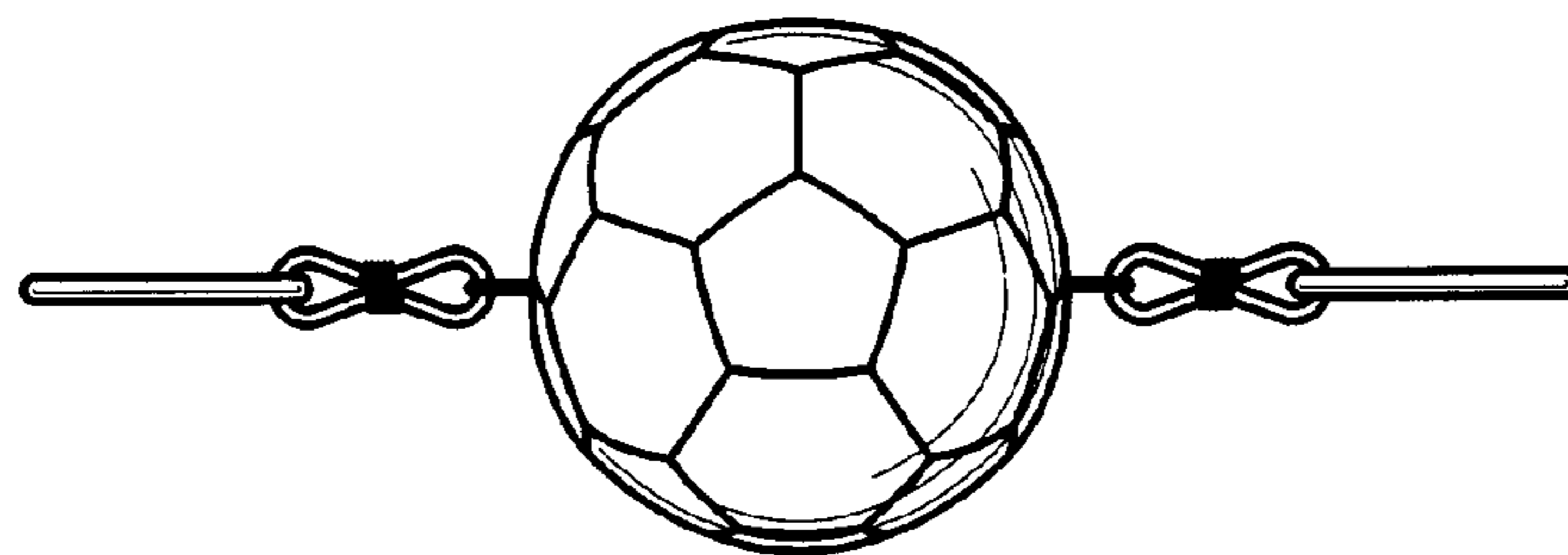

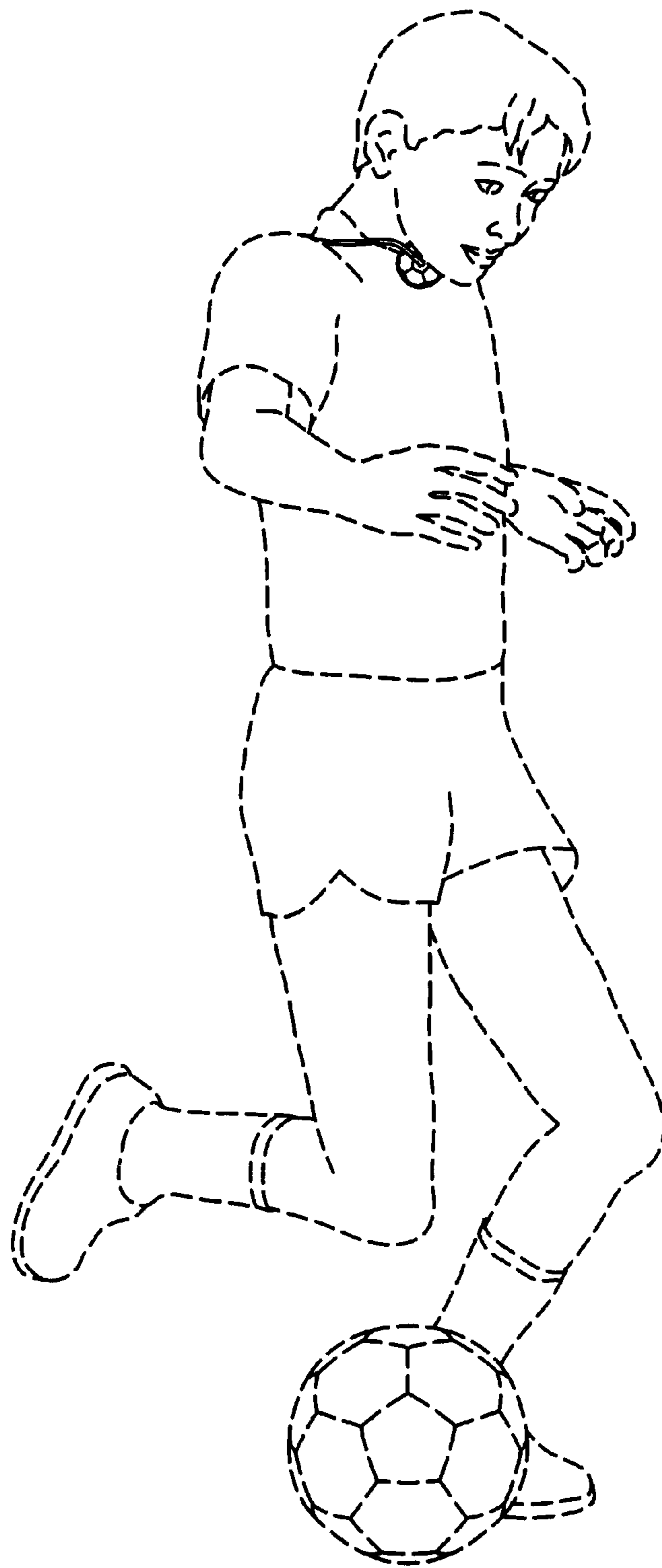
