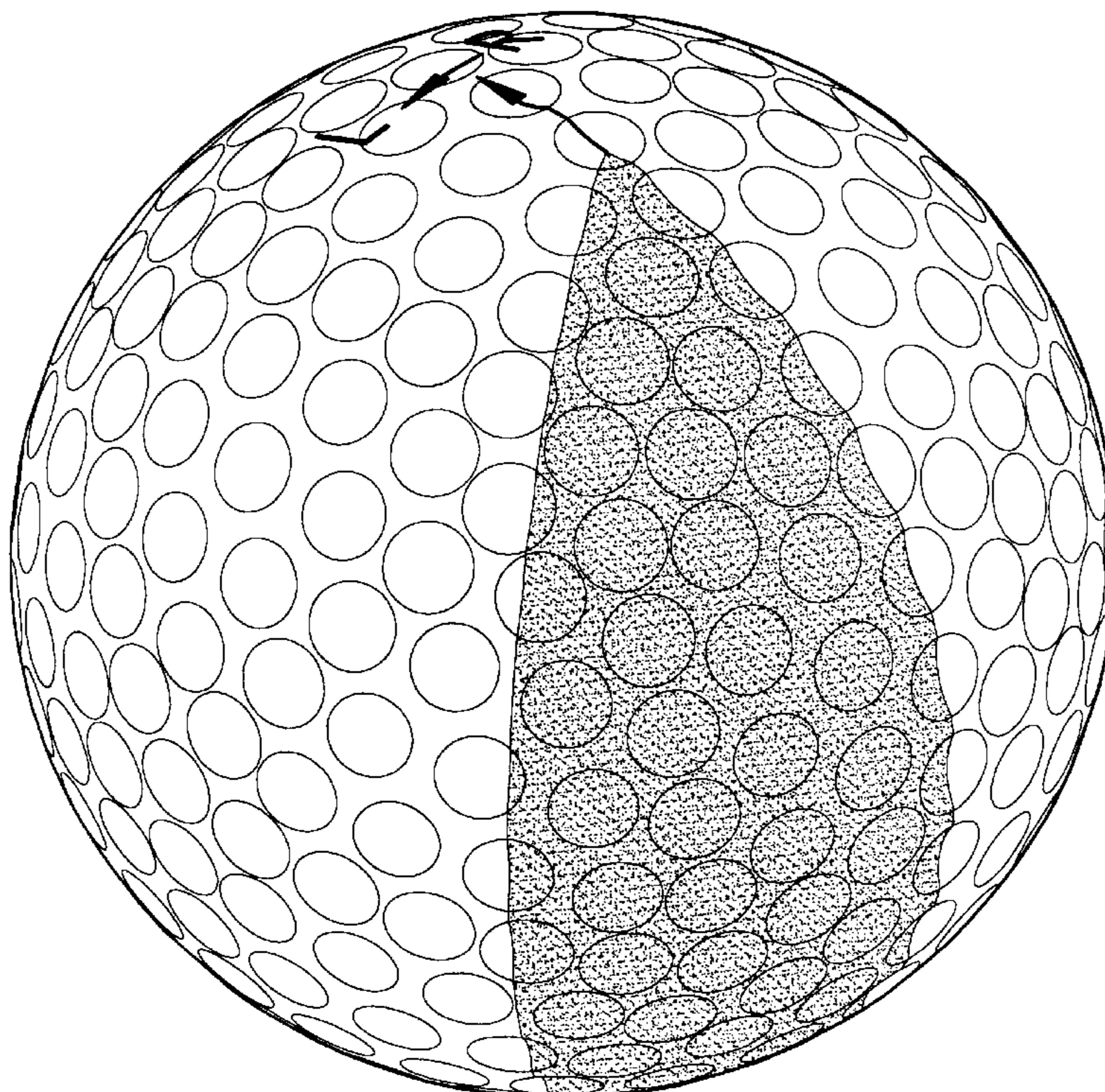
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a golf training aid showing our new design;

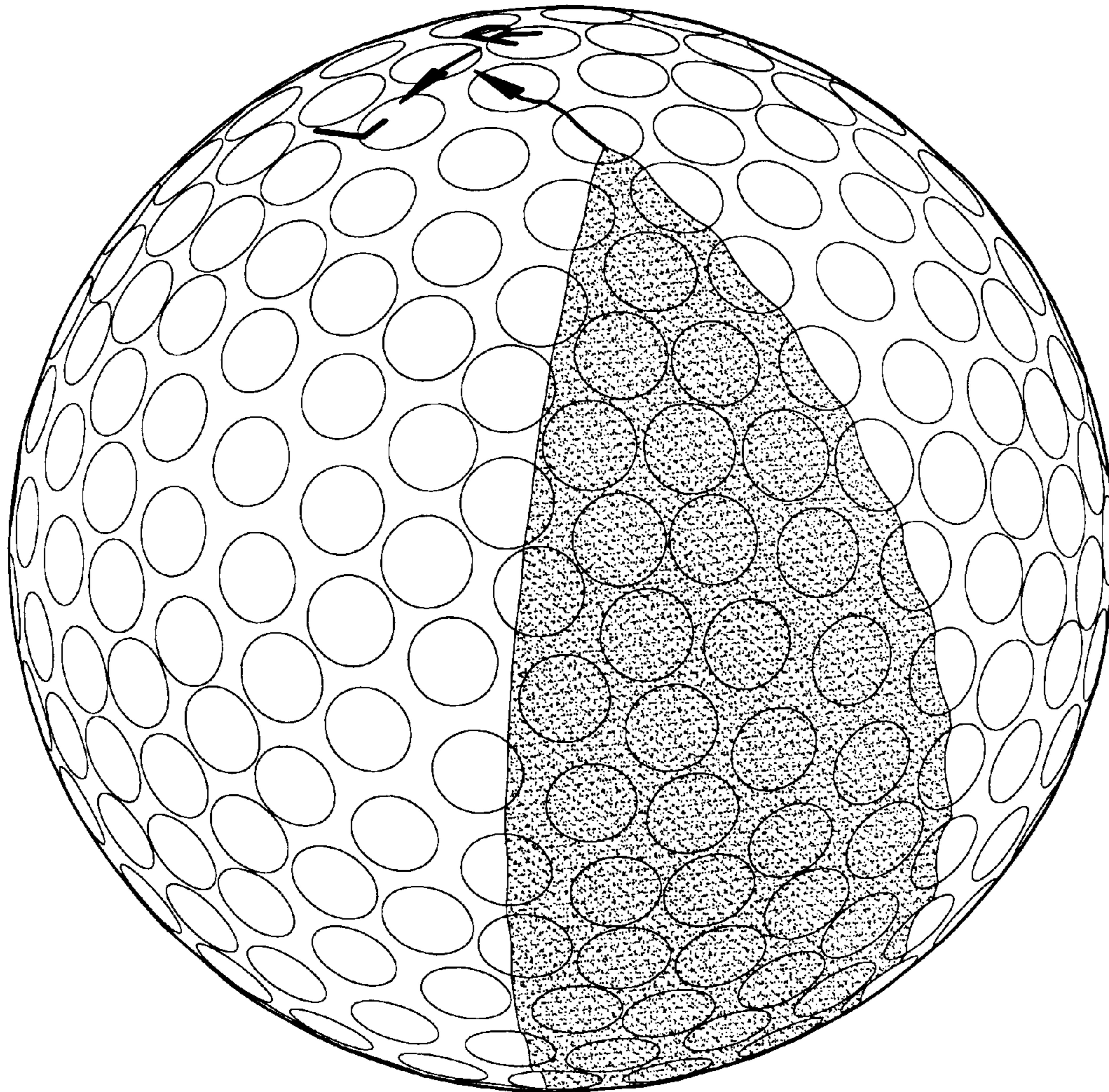

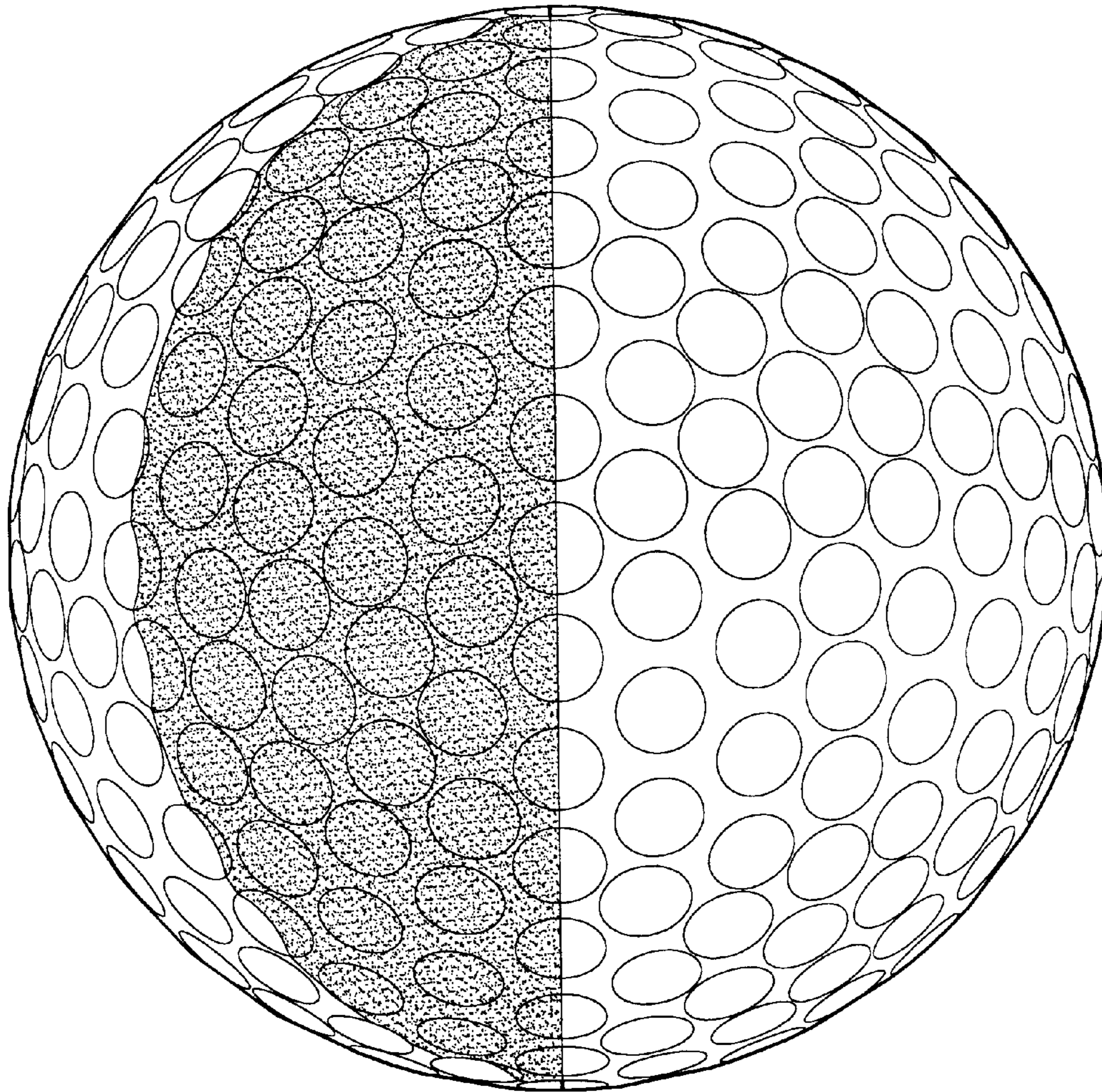

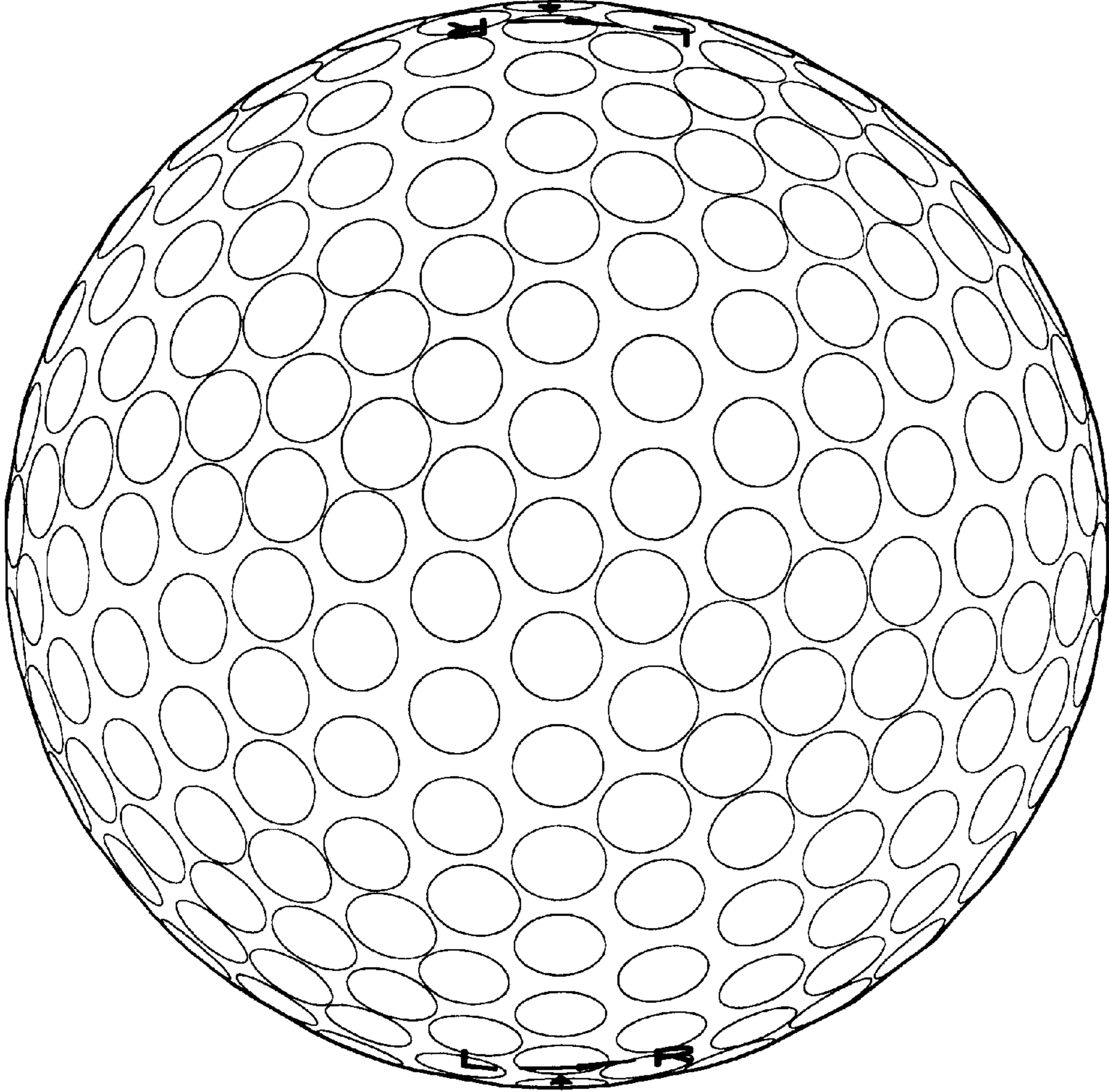

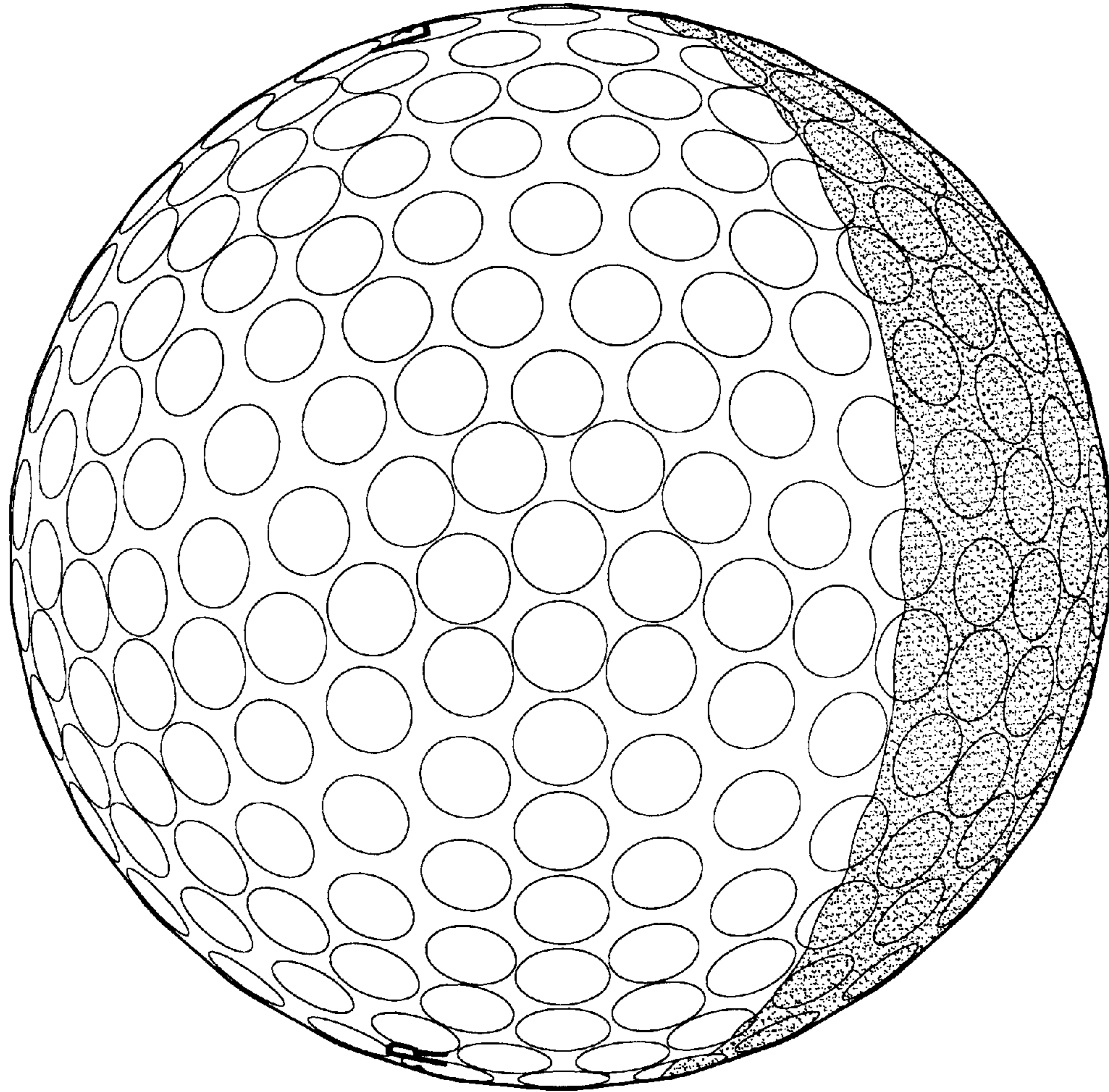

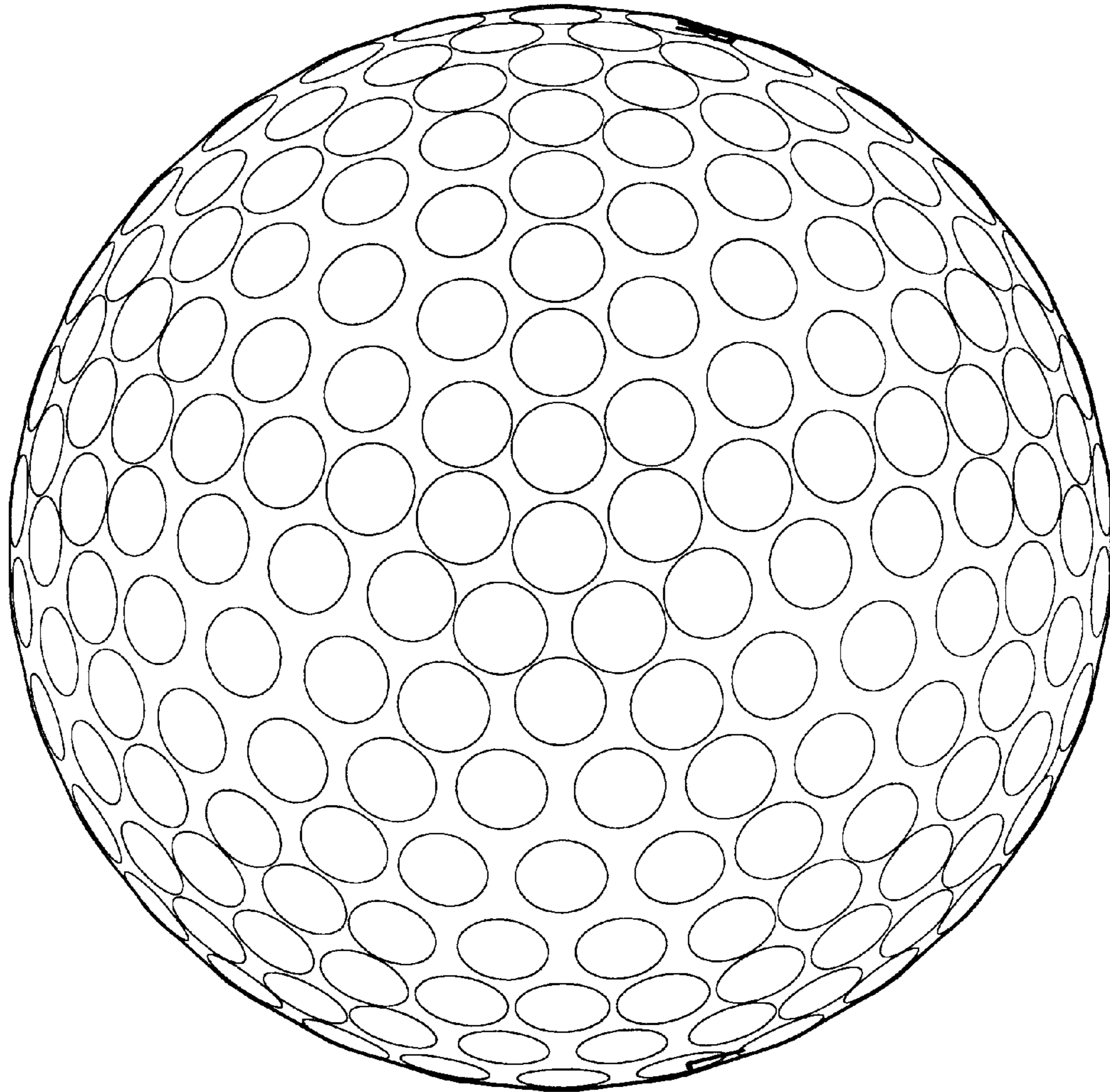

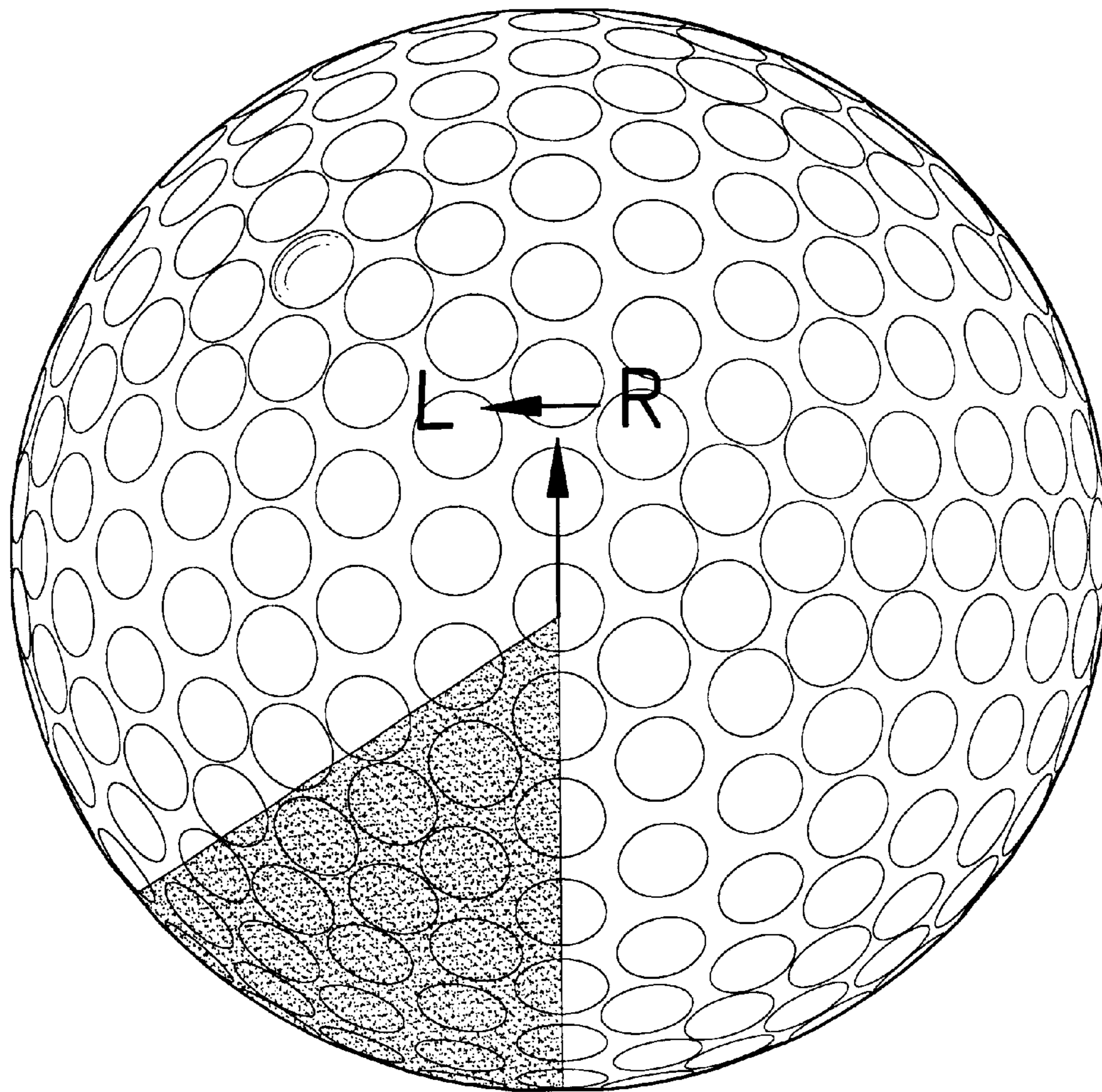

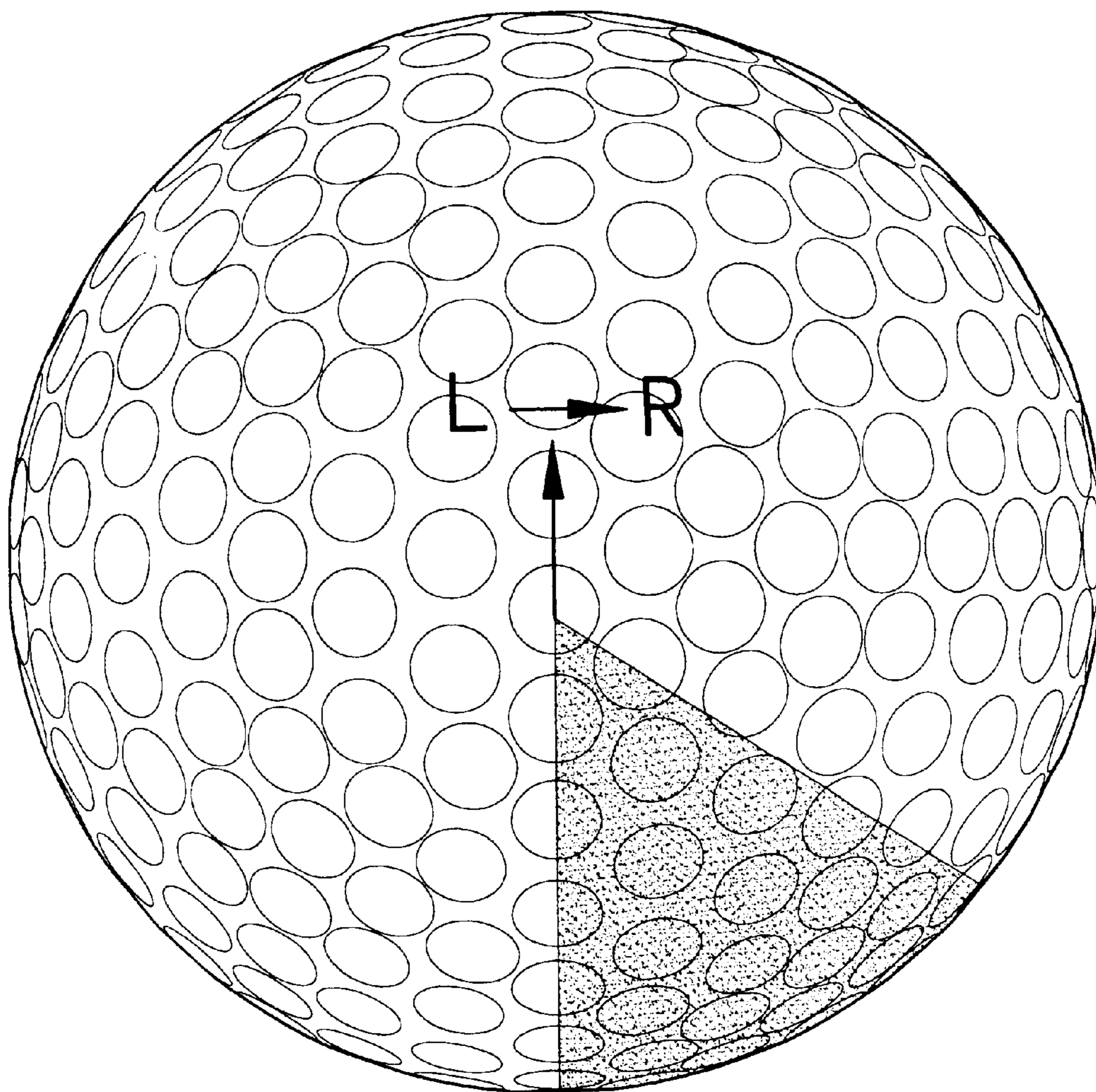
