(57) **CLAIM**

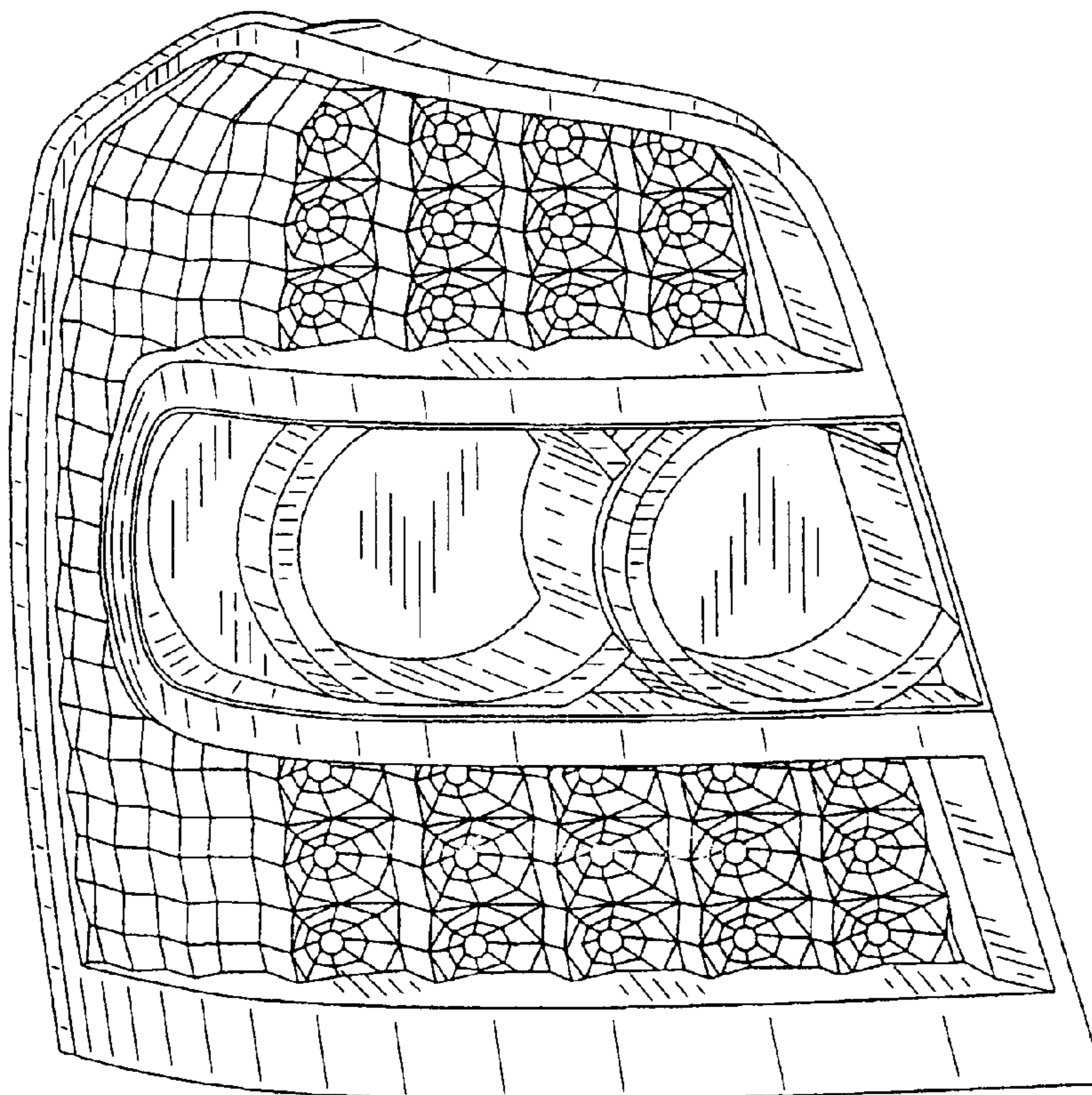
The ornamental design for a combination lamp for an automobile, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combination lamp for an automobile of our new design;
 FIG. 2 is a front view of our new design;
 FIG. 3 is a top view of our new design;
 FIG. 4 is a left-side view of our new design, the right-side view being no part of the claimed design;
 FIG. 5 is a bottom view of our new design;
 FIG. 6 is a cross-sectional view of our new design taken along line 6—6 in FIG. 2, showing the profile of that portion of the design; and,
 FIG. 7 is a cross-sectional view of our new design taken along line 7—7 in FIG. 4, showing the profile of that portion of the design.

Our design includes a mirror image of the embodiment depicted.

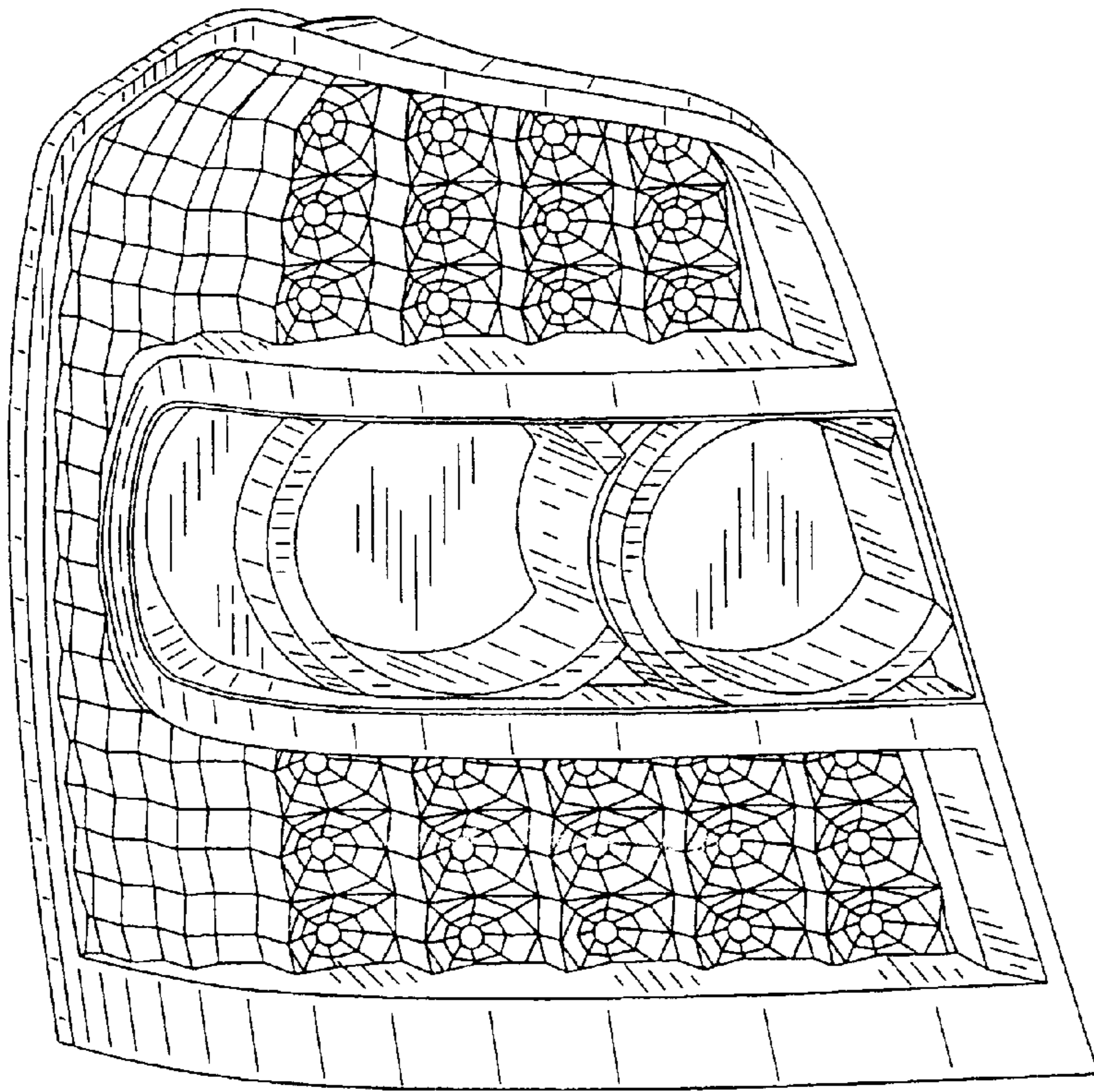

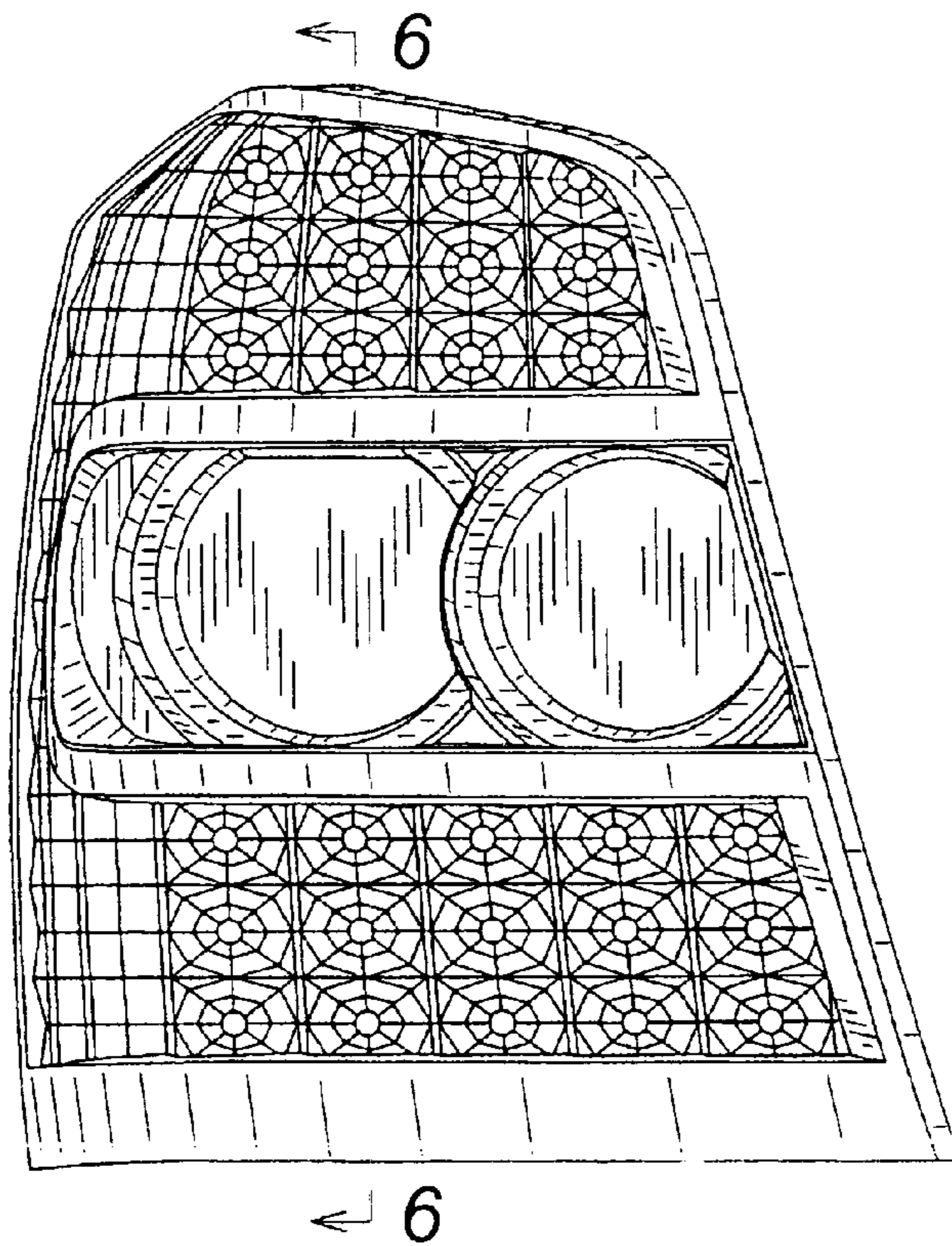

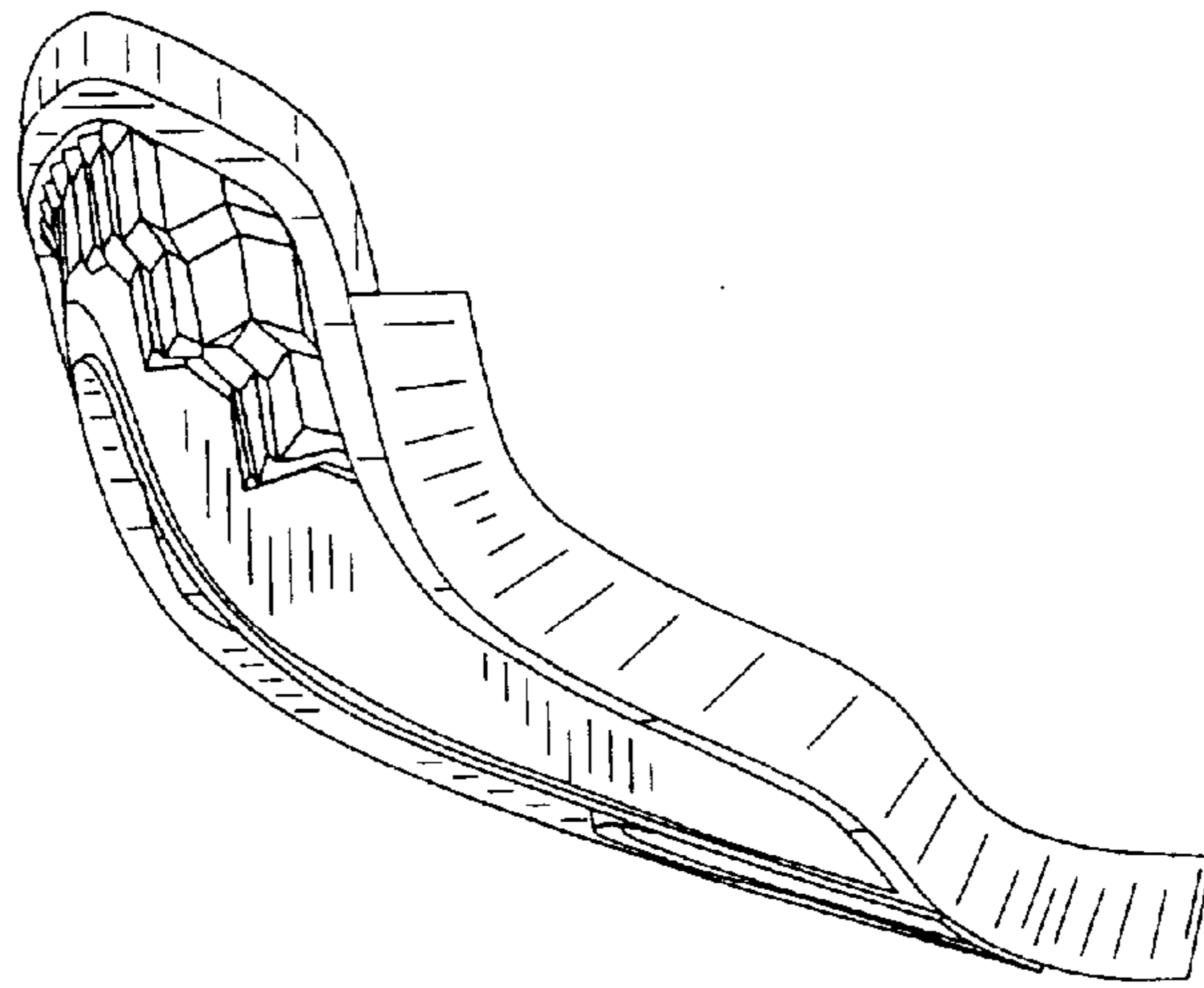

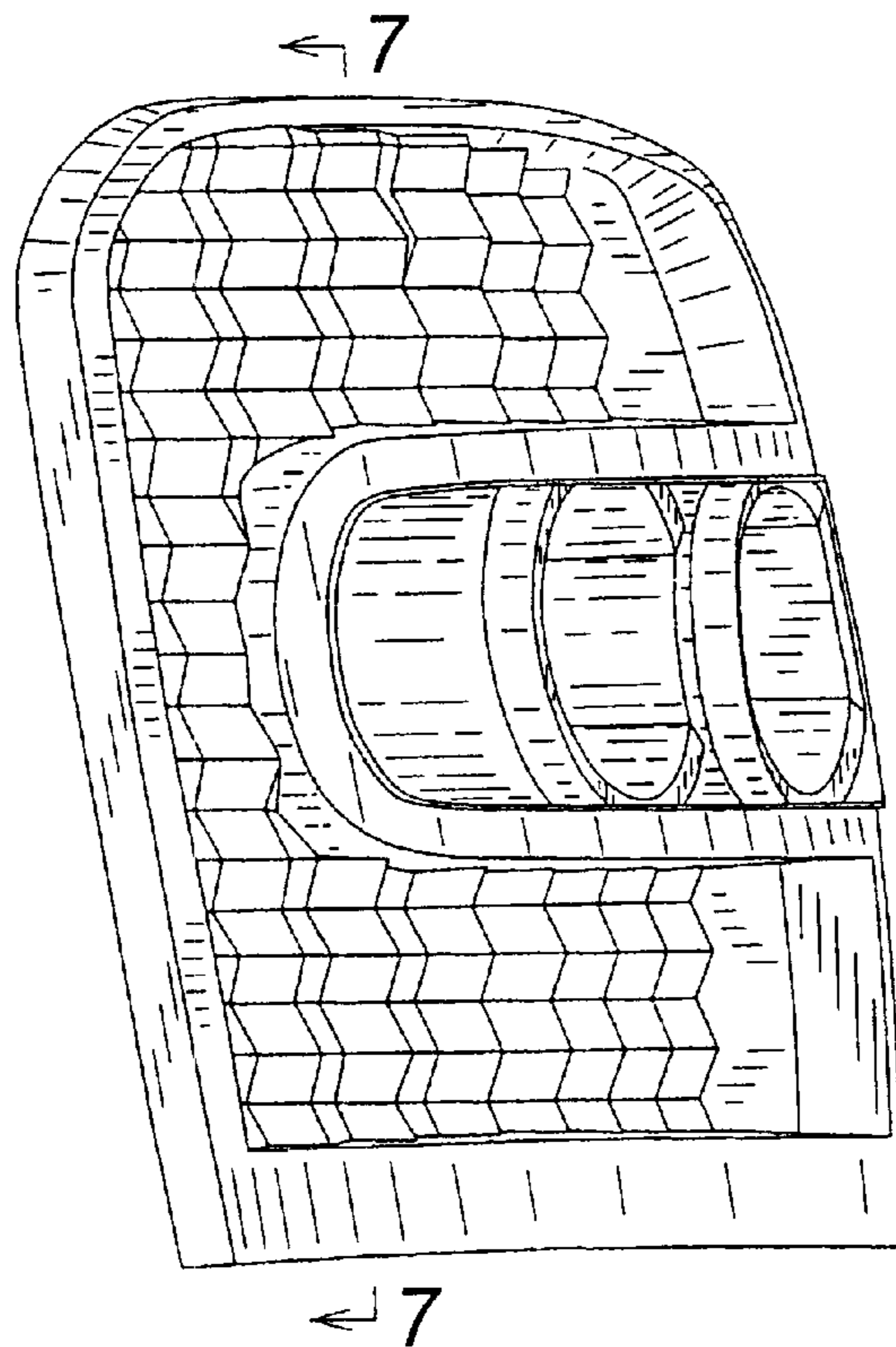

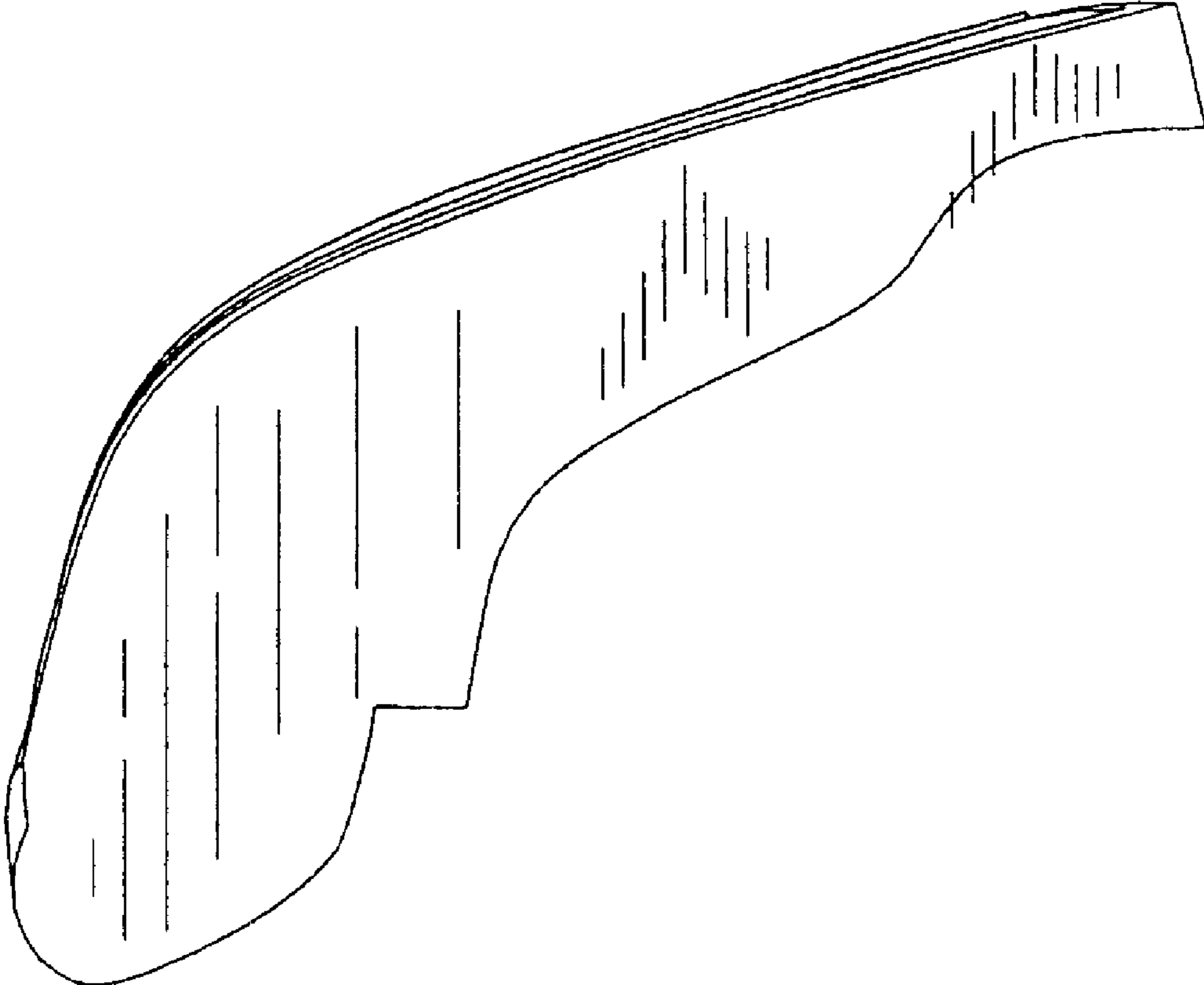

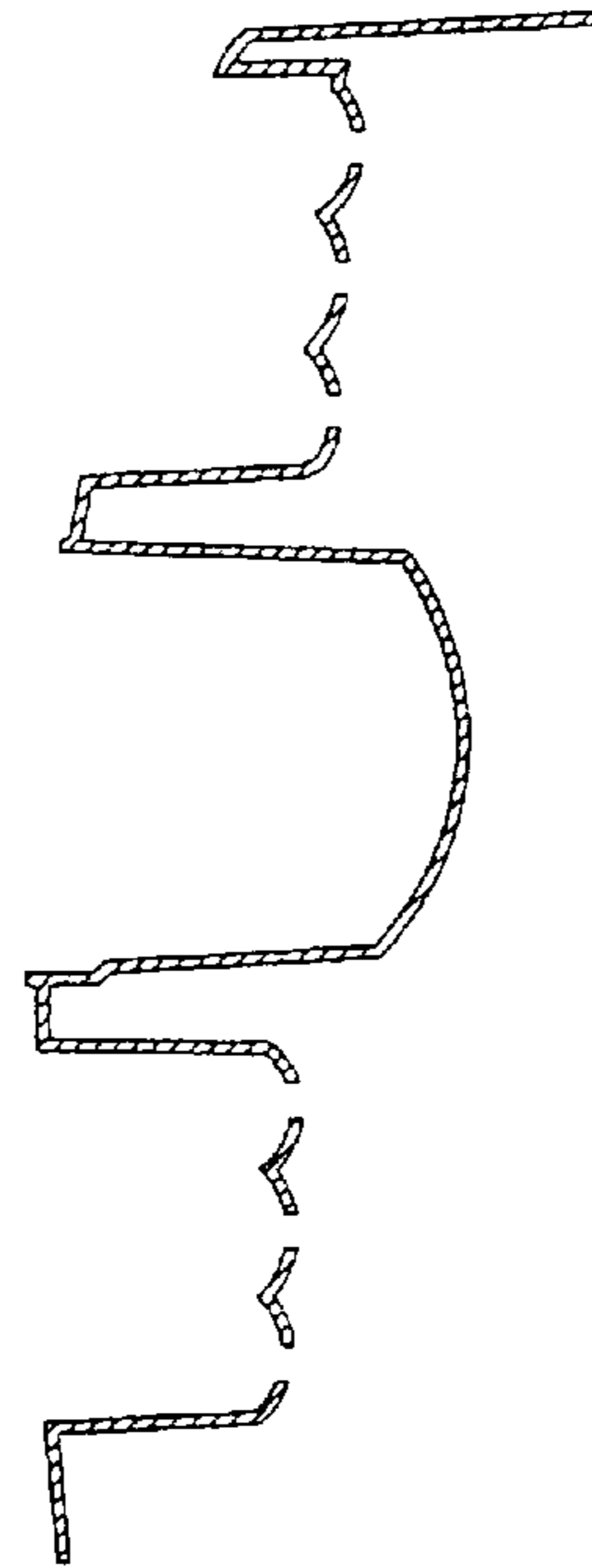

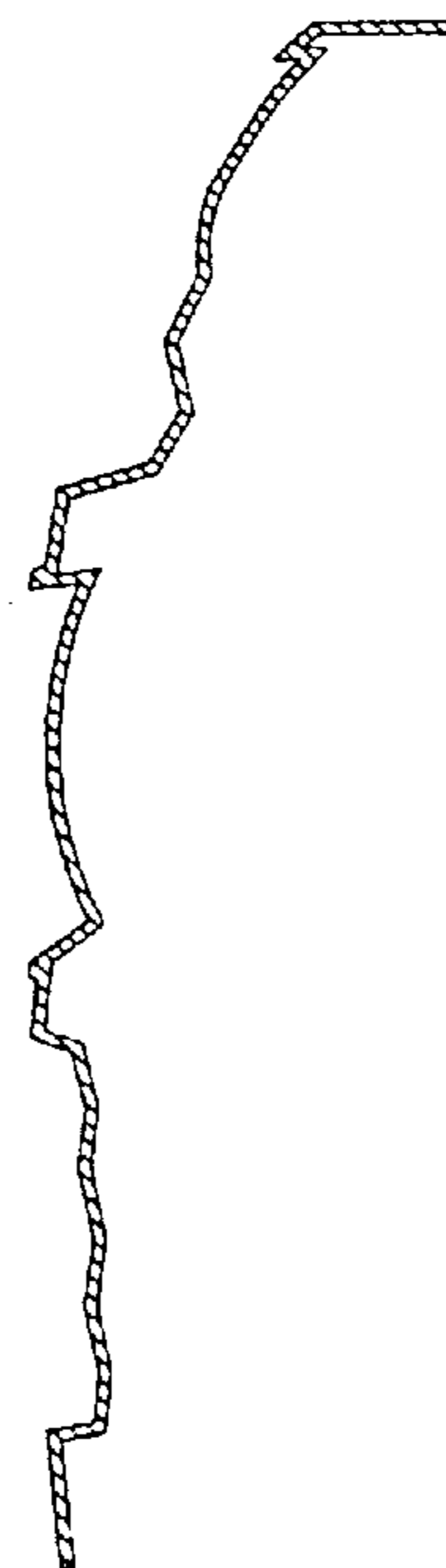
