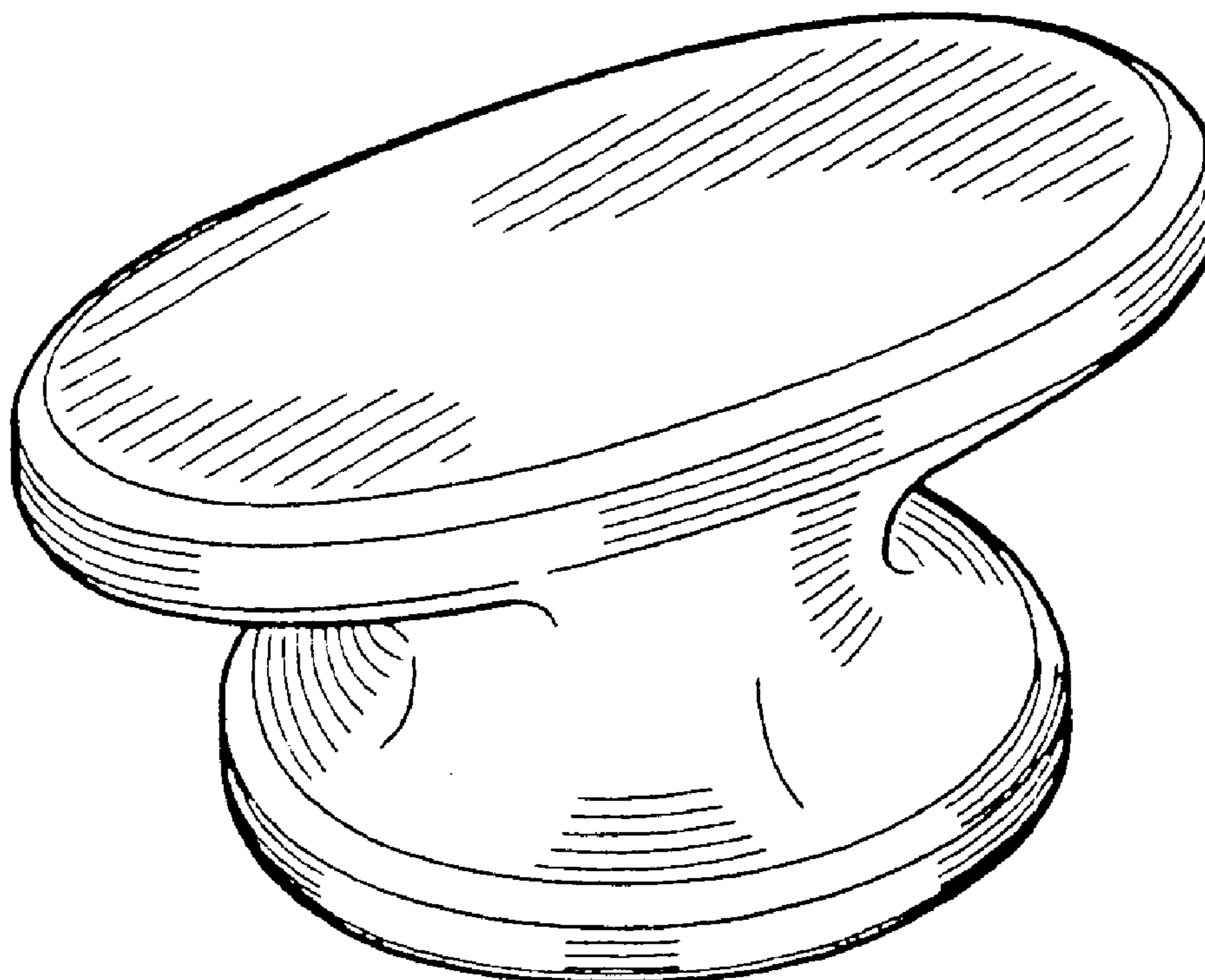
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a handle showing the new design;
FIG. 2 is a top view of the handle shown in FIG. 1;
FIG. 3 is a bottom view of the handle shown in FIG. 1;
FIG. 4 is a front view of the handle shown in FIG. 1;
FIG. 5 is a rear view of the handle shown in FIG. 1; and,
FIG. 6 is a right side view of the handle shown in FIG. 1, the left side being a mirror image.

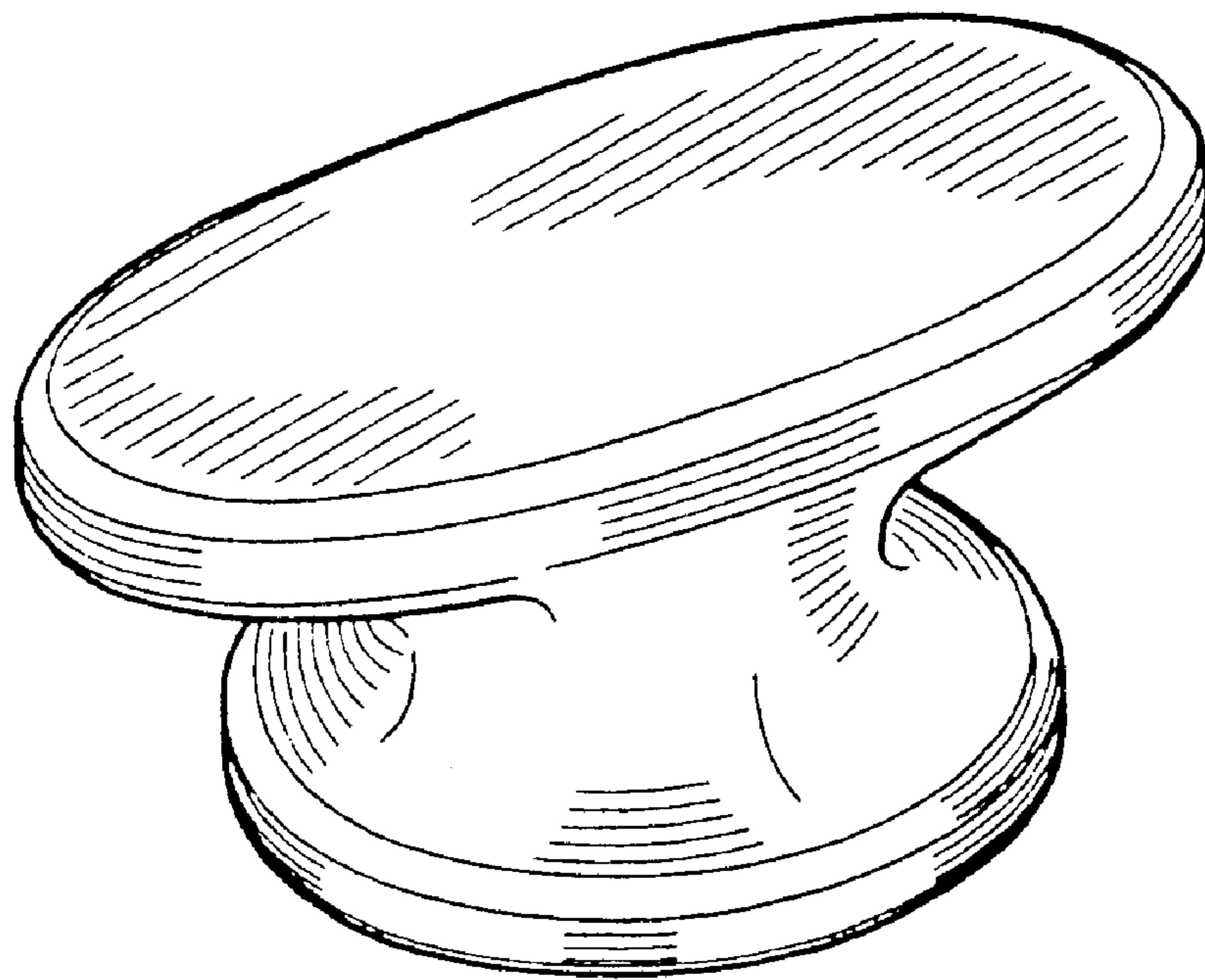

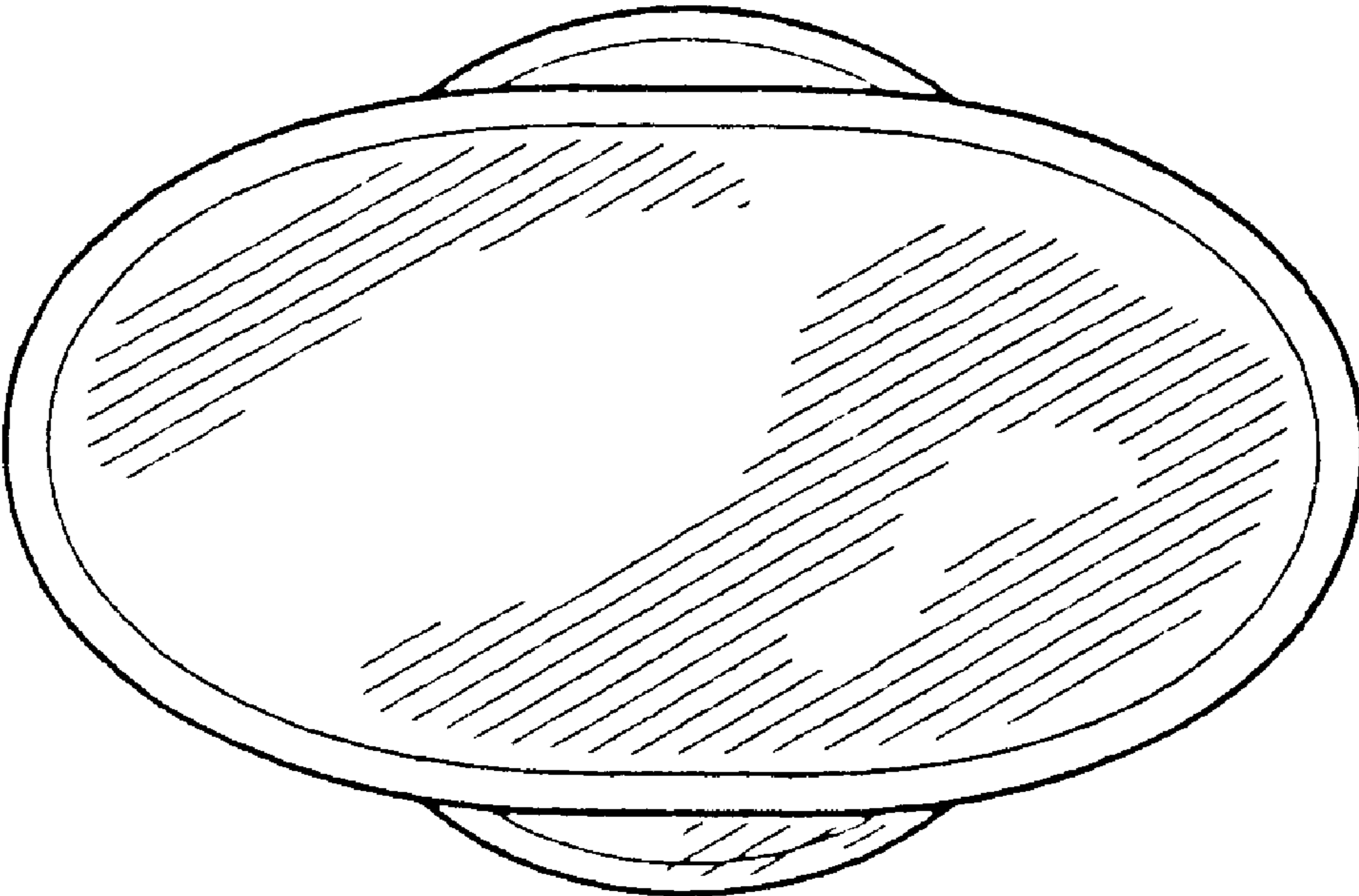

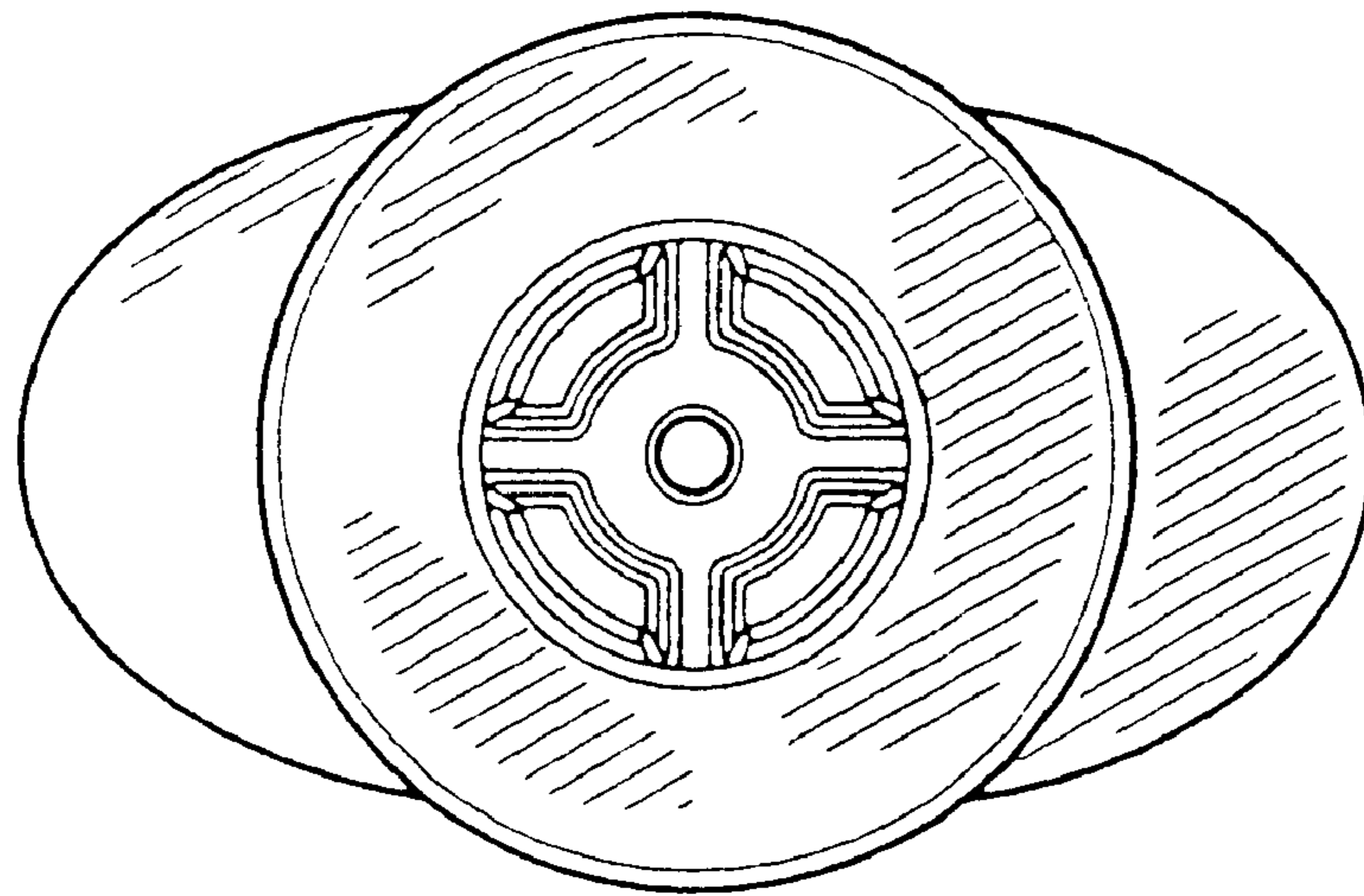

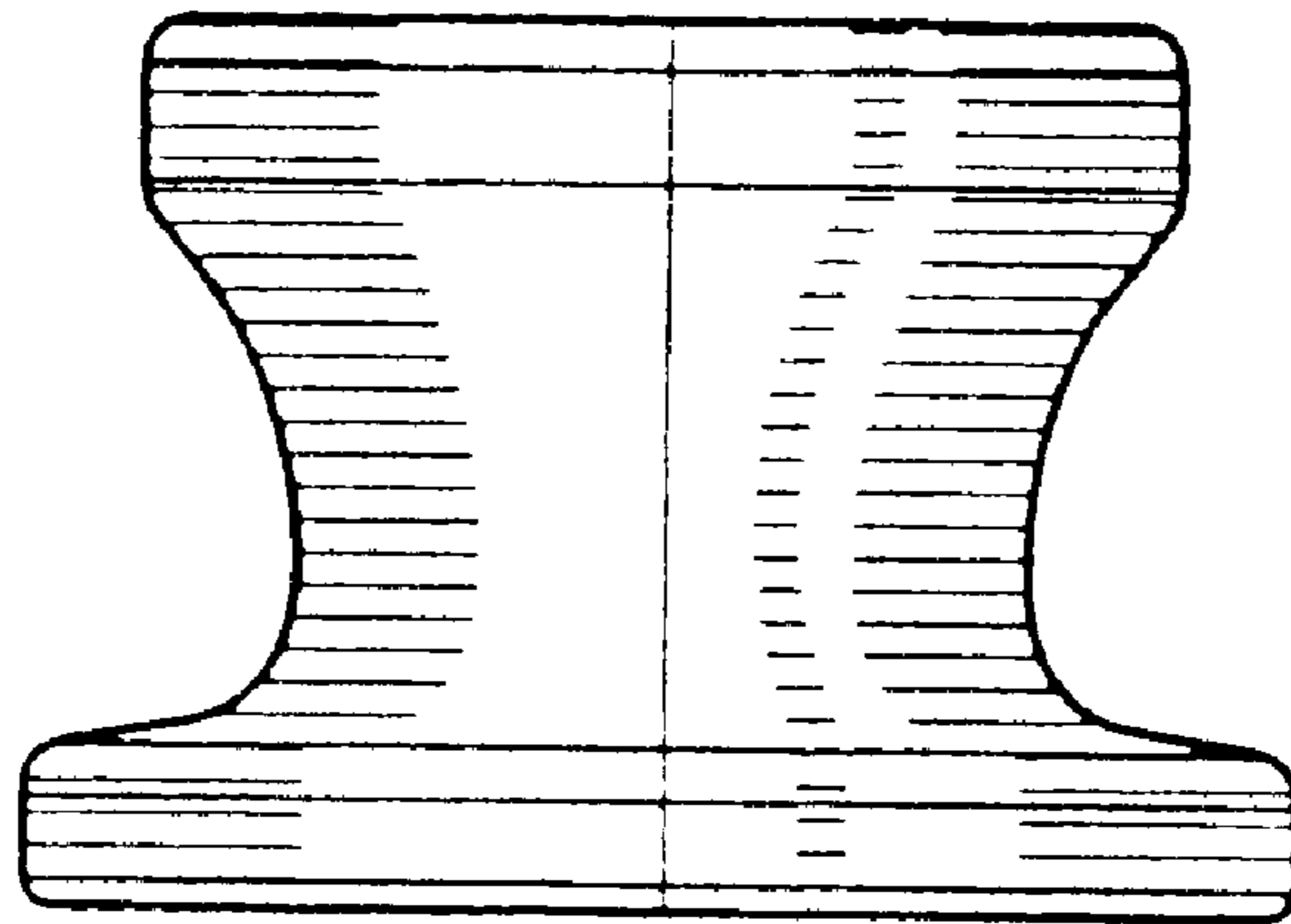

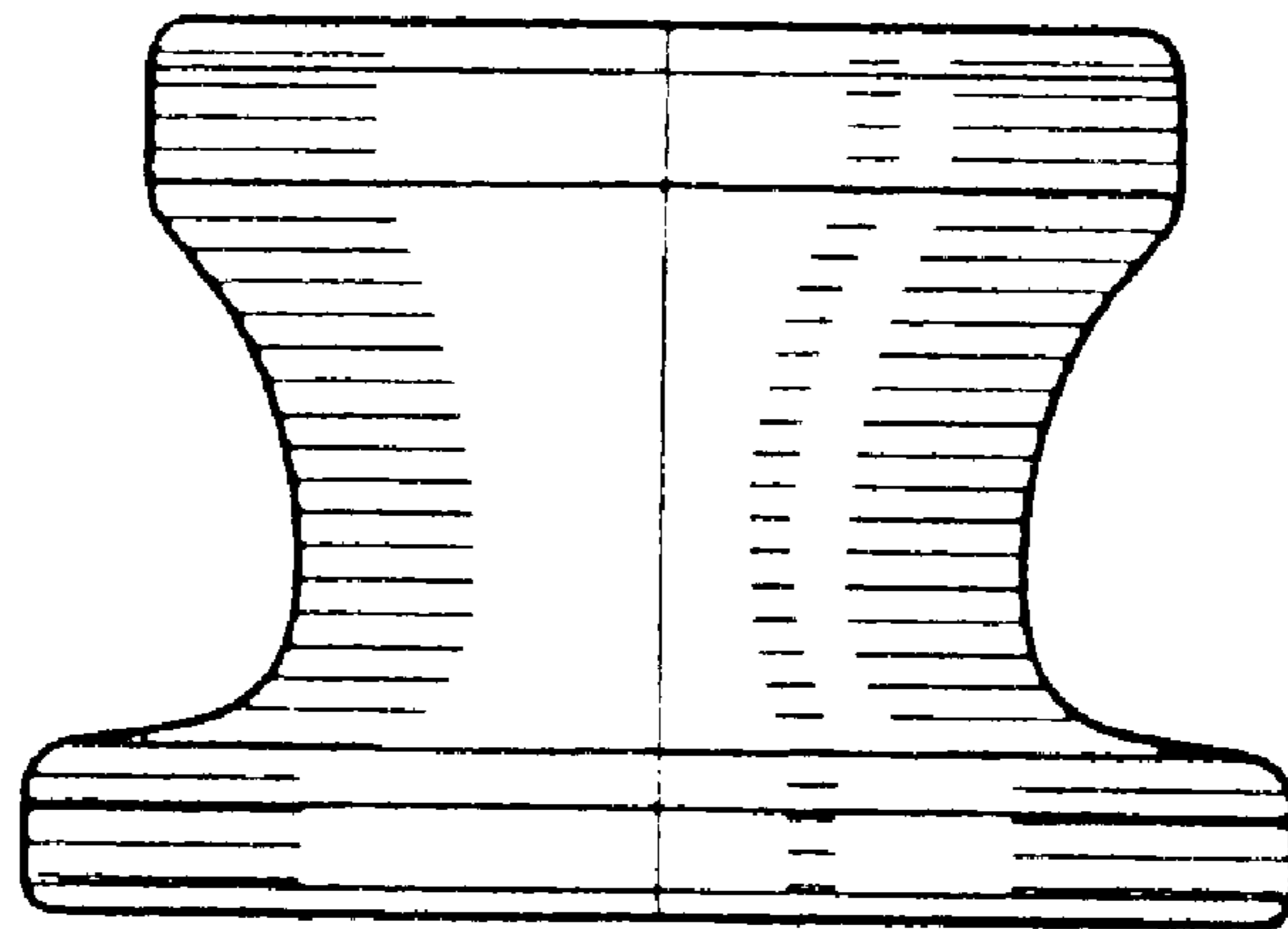

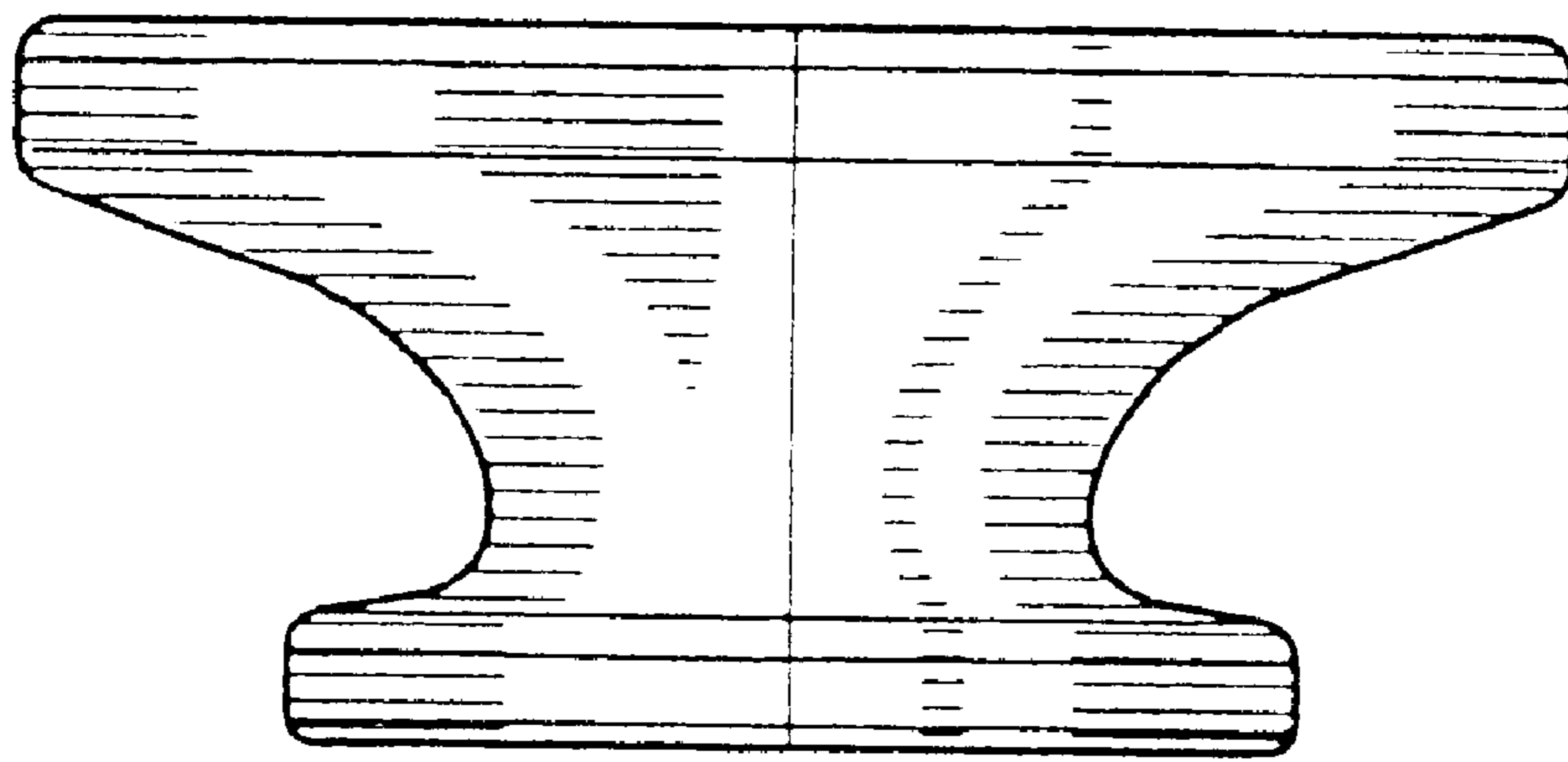
