(57) **CLAIM**

The ornamental design for a howling canine carabiner, as shown and described.

DESCRIPTION

FIG. 1 is a top or bottom plan view, which are mirror images, of my new design for a howling canine carabiner.

FIG. 2 is a right elevation view of the carabiner shown in FIG. 1.

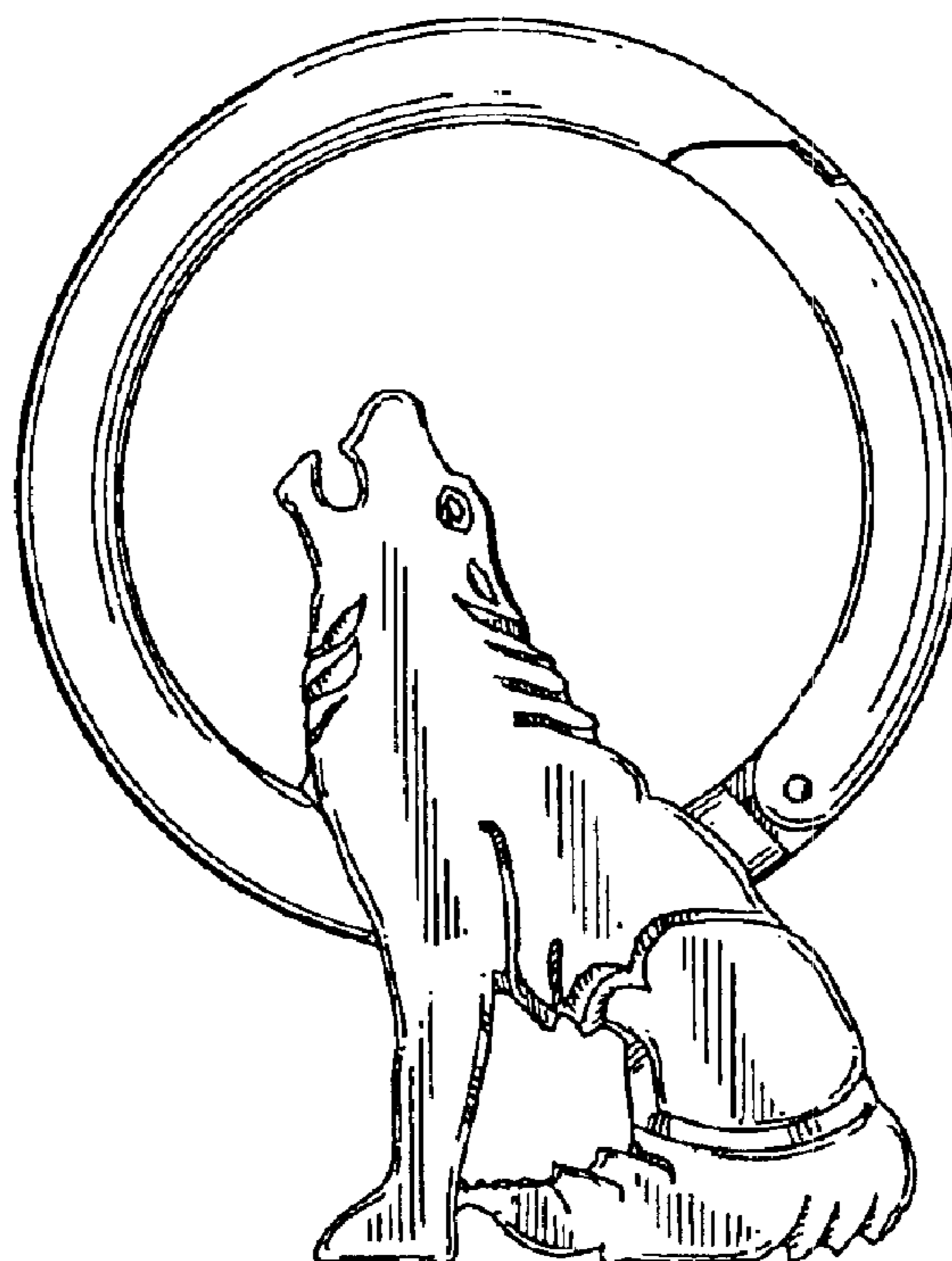
FIG. 3 is a left side elevation view of the carabiner shown in FIG. 1.

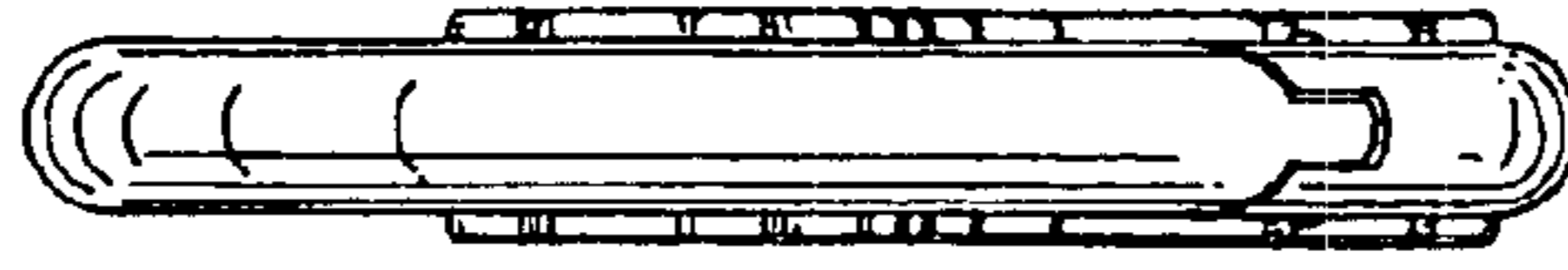

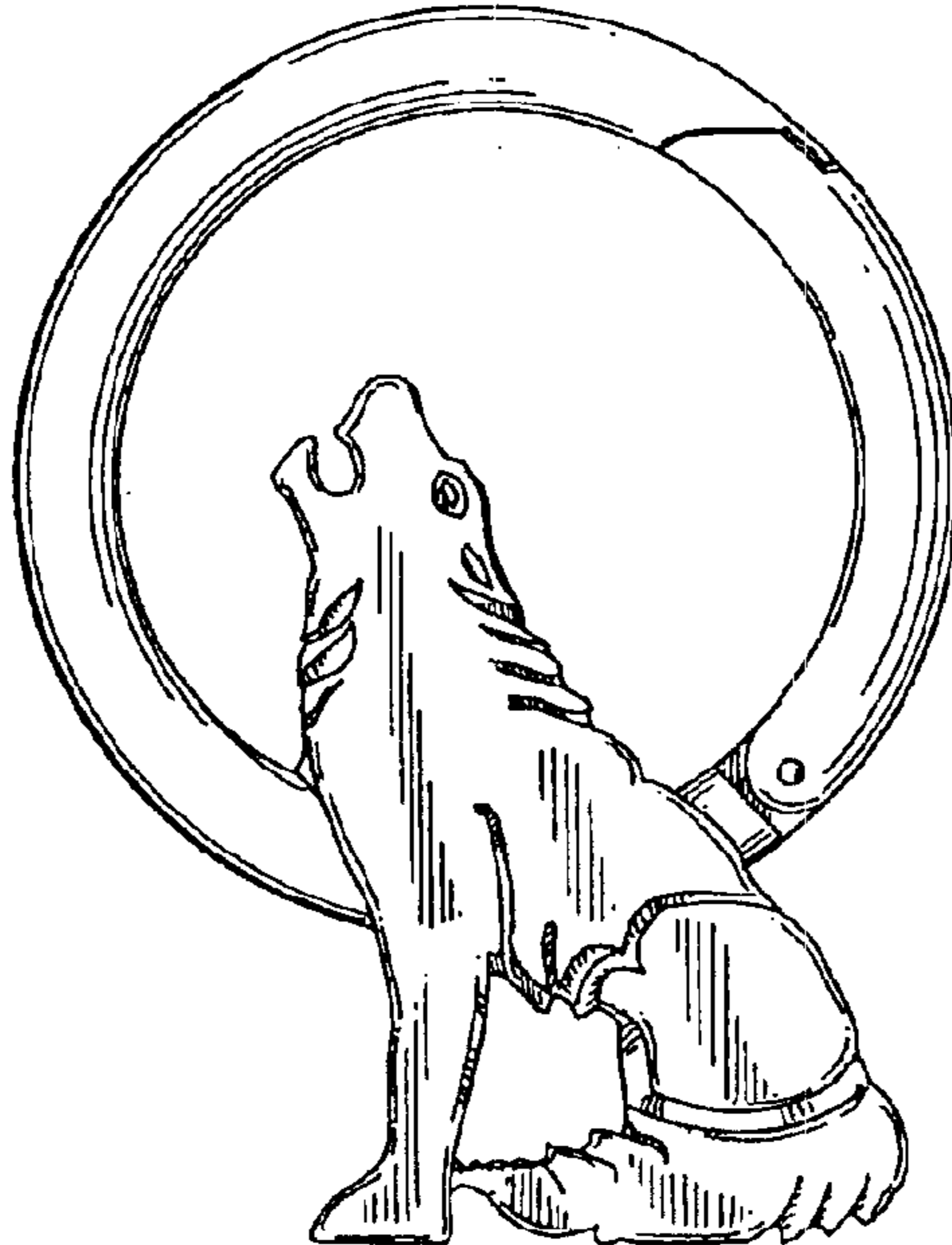

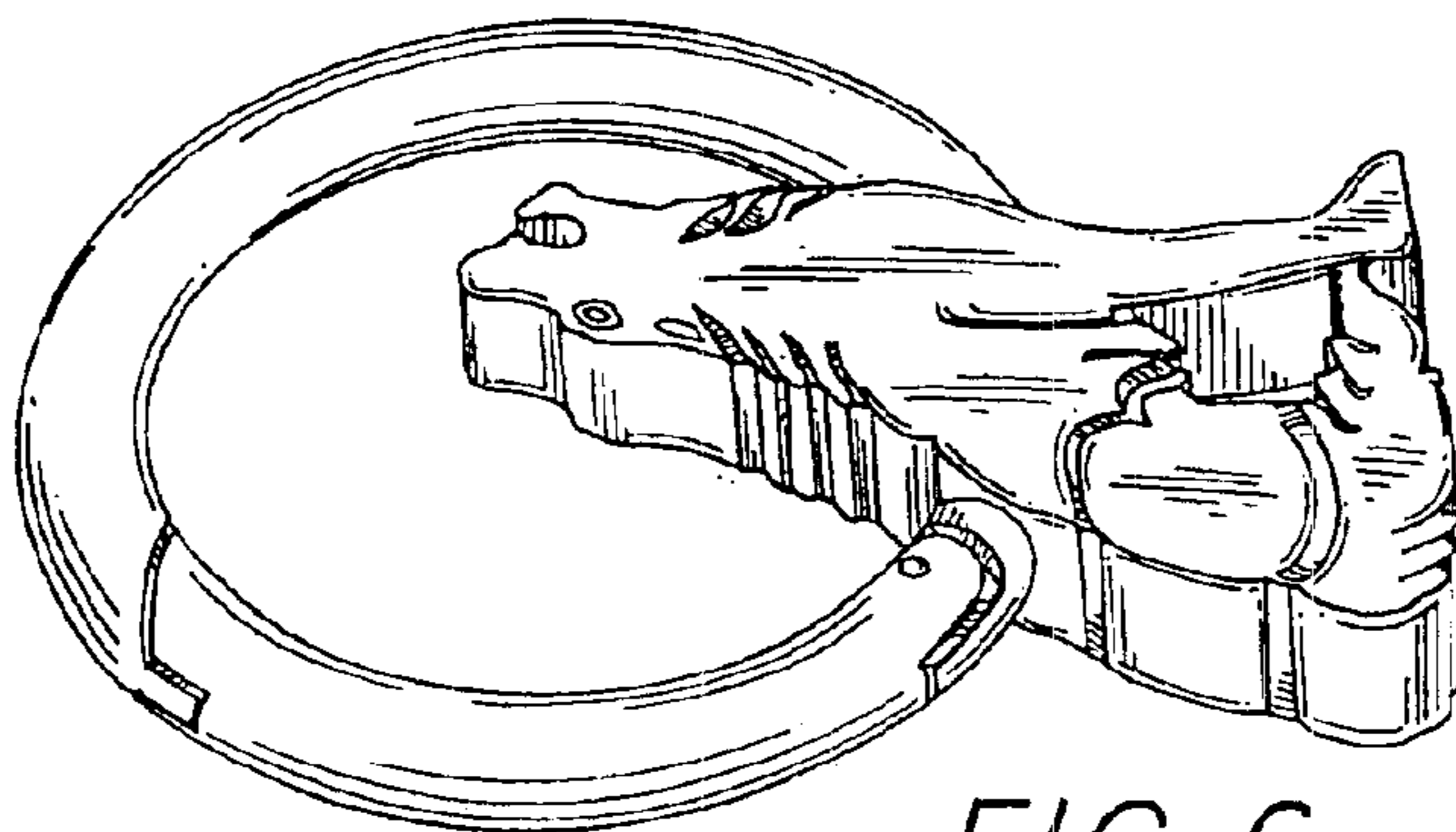
