(57) **CLAIM**

The ornamental design for a lining pad of disk brake for vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the top, front and left side of a lining pad of disk brake for vehicle showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof; and,

FIG. 6 is a left side elevational view thereof, the right side elevational view being a mirror image thereof.

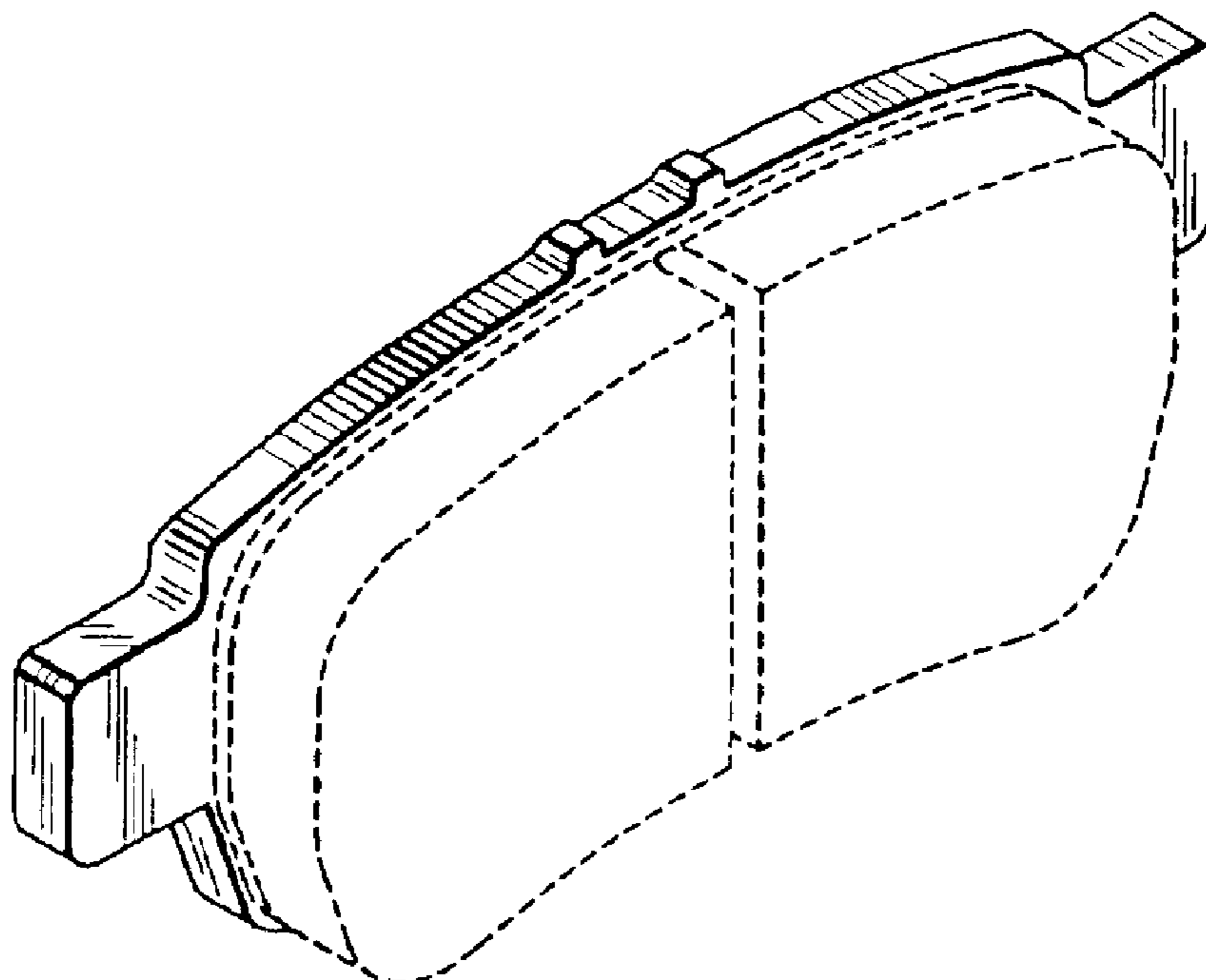

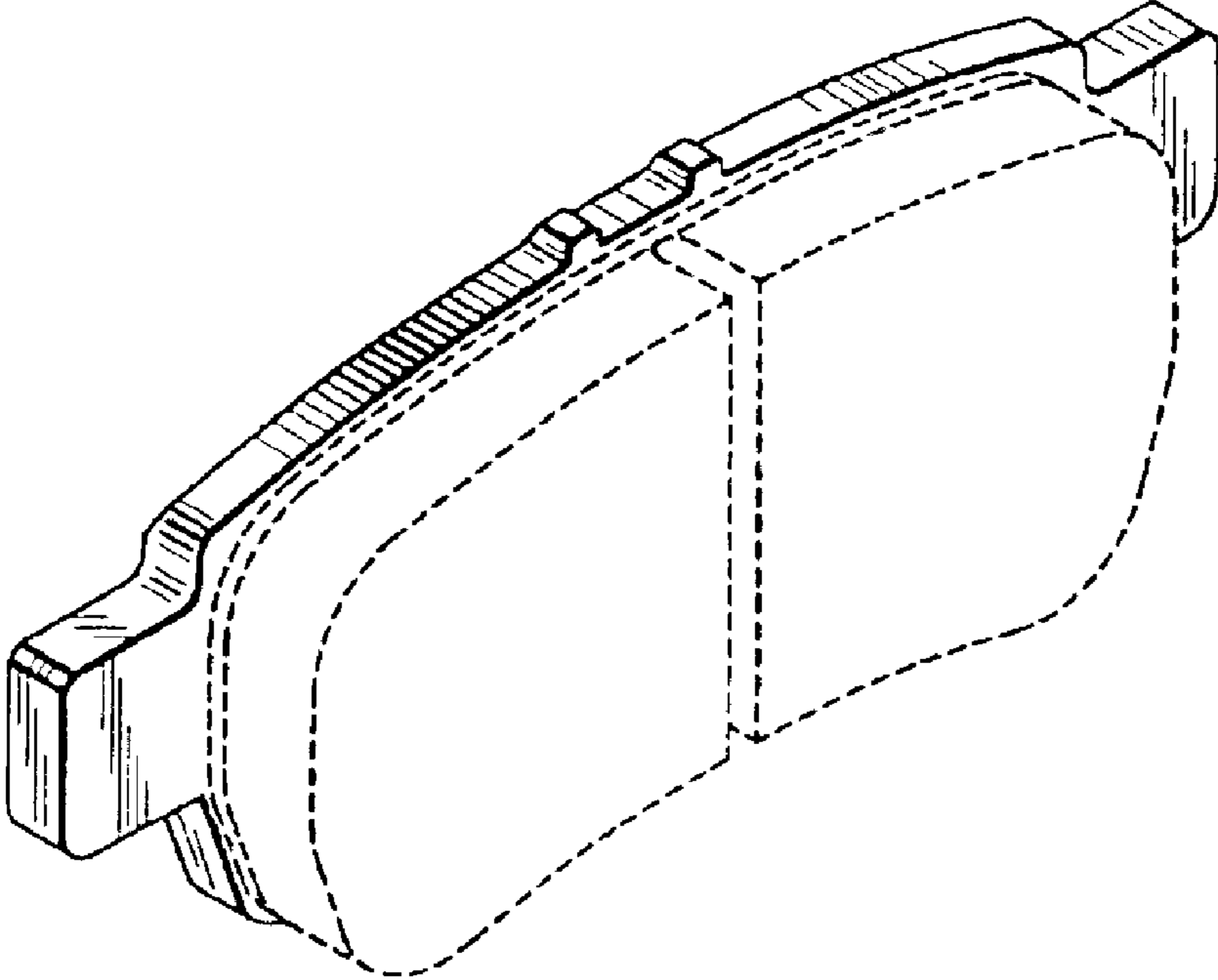

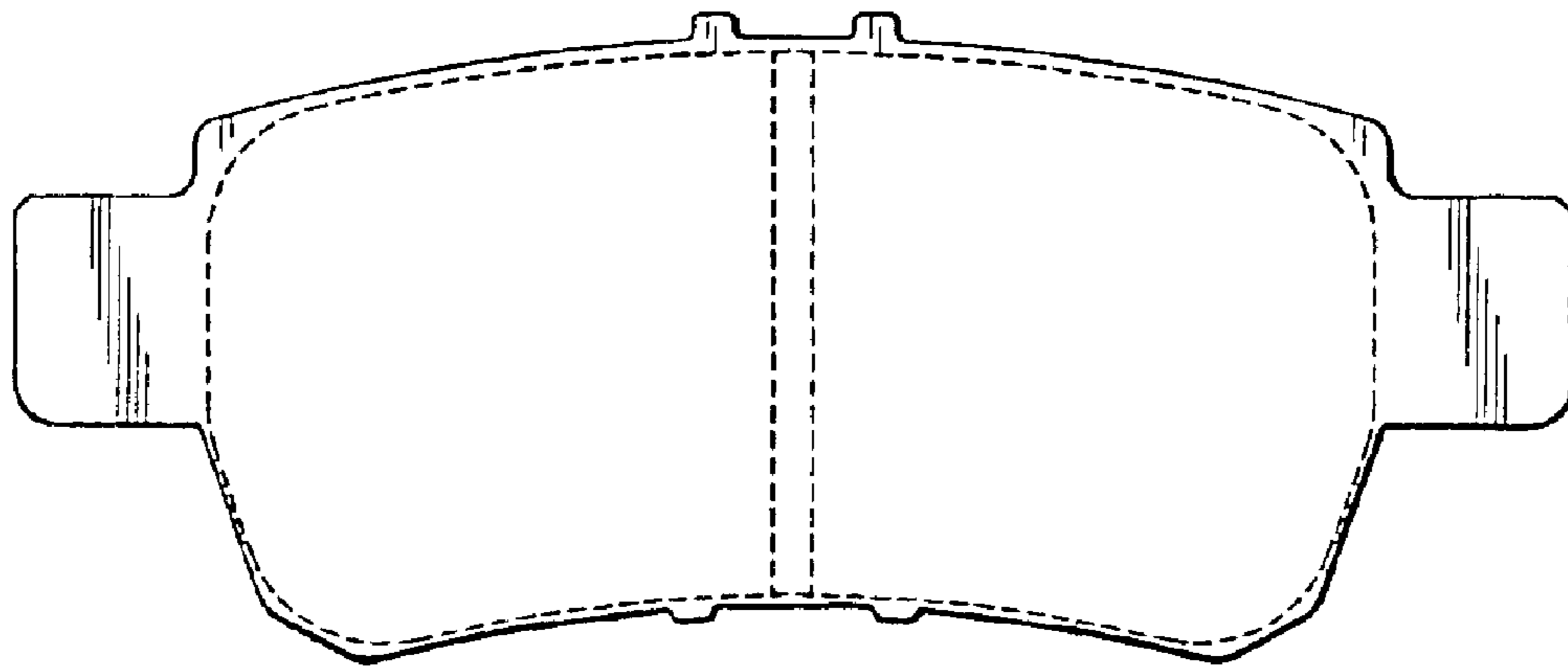

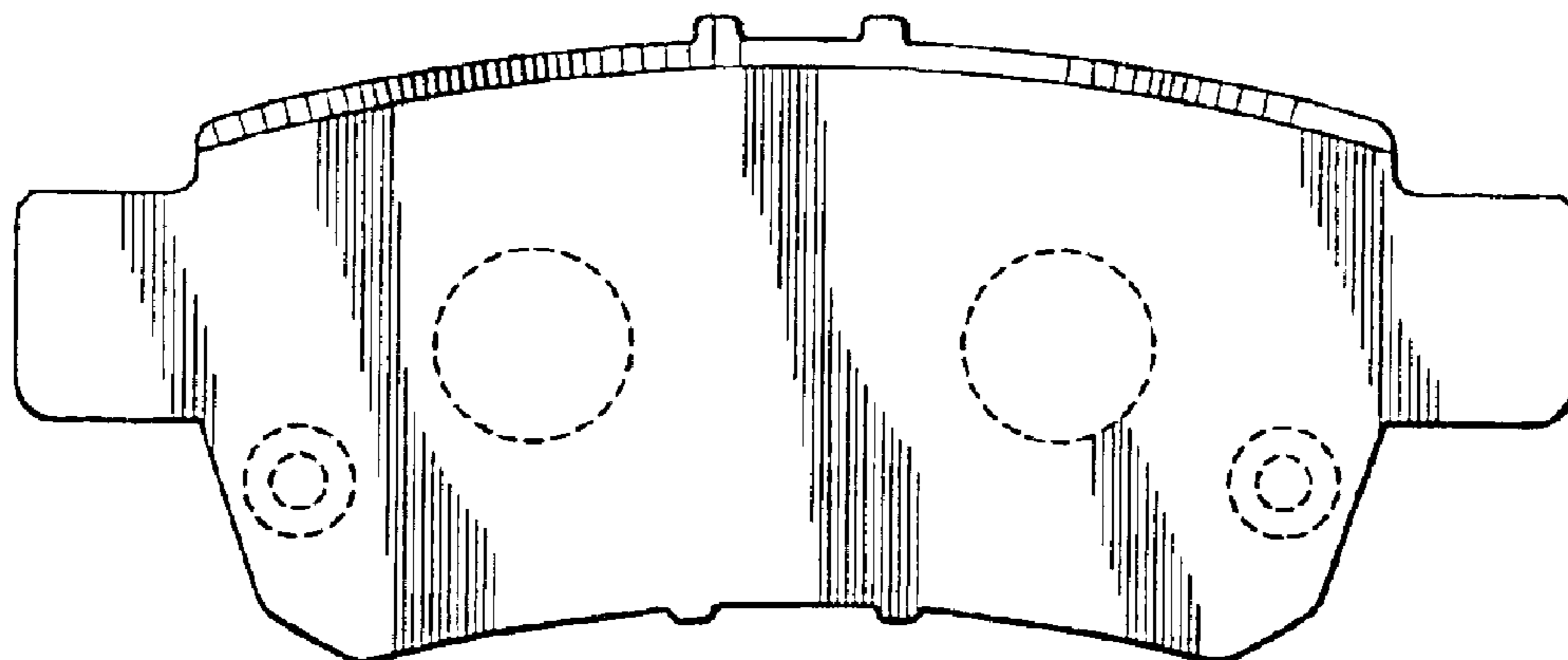

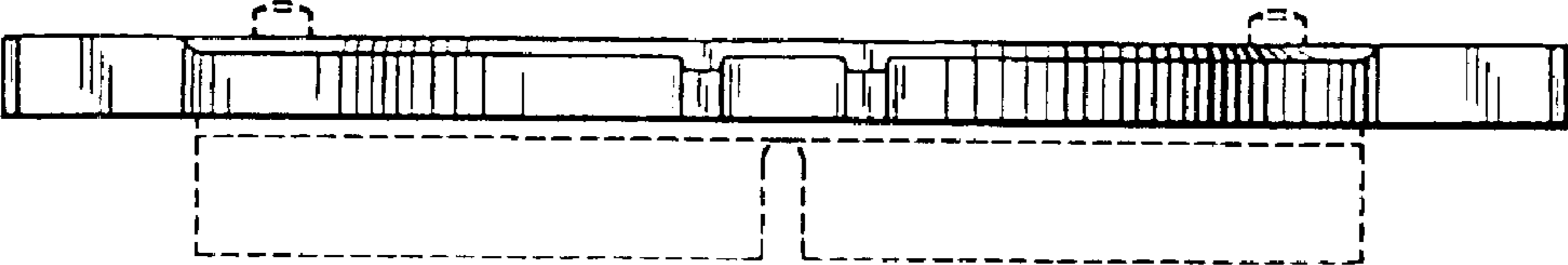

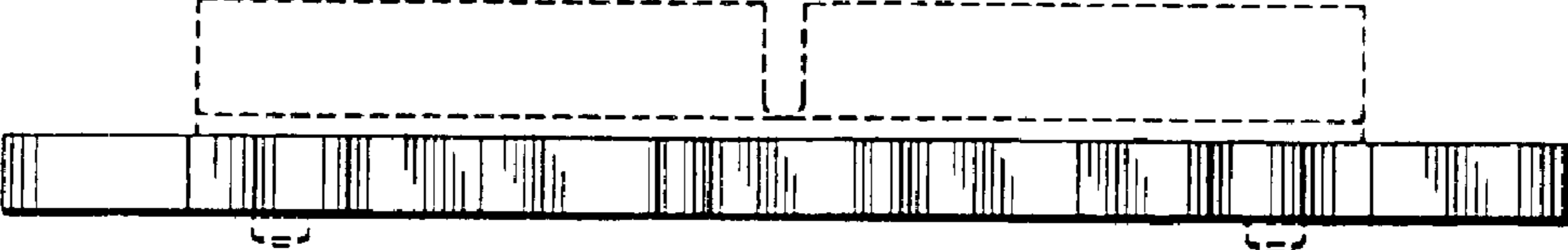
