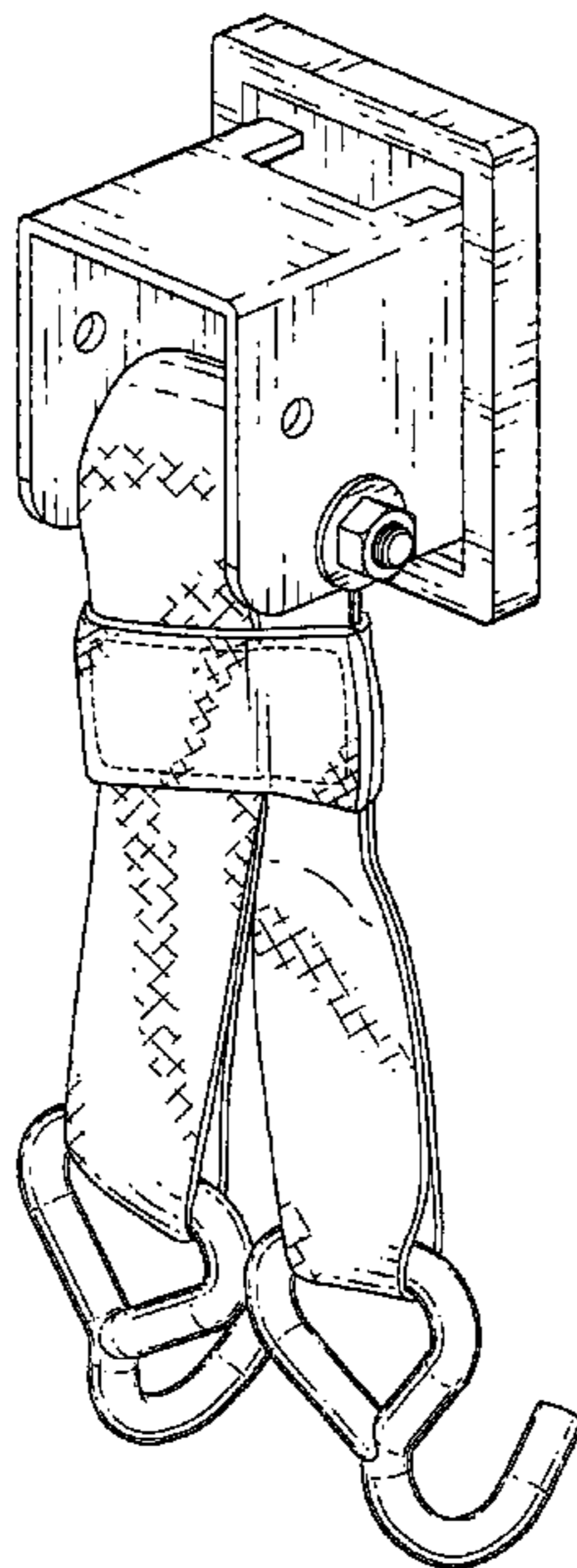
(57) **CLAIM**

The ornamental design for a wheel lift attachment, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the wheel lift attachment of the present invention.
FIG. 2 is a front elevation view.
FIG. 3 is a side elevation from the right side as viewed in FIG. 2.
FIG. 4 is a side elevation from the left side as viewed in FIG. 2.
FIG. 5 is a top plan view.
FIG. 6 is a bottom plan view; and,
FIG. 7 is a rear elevation view.

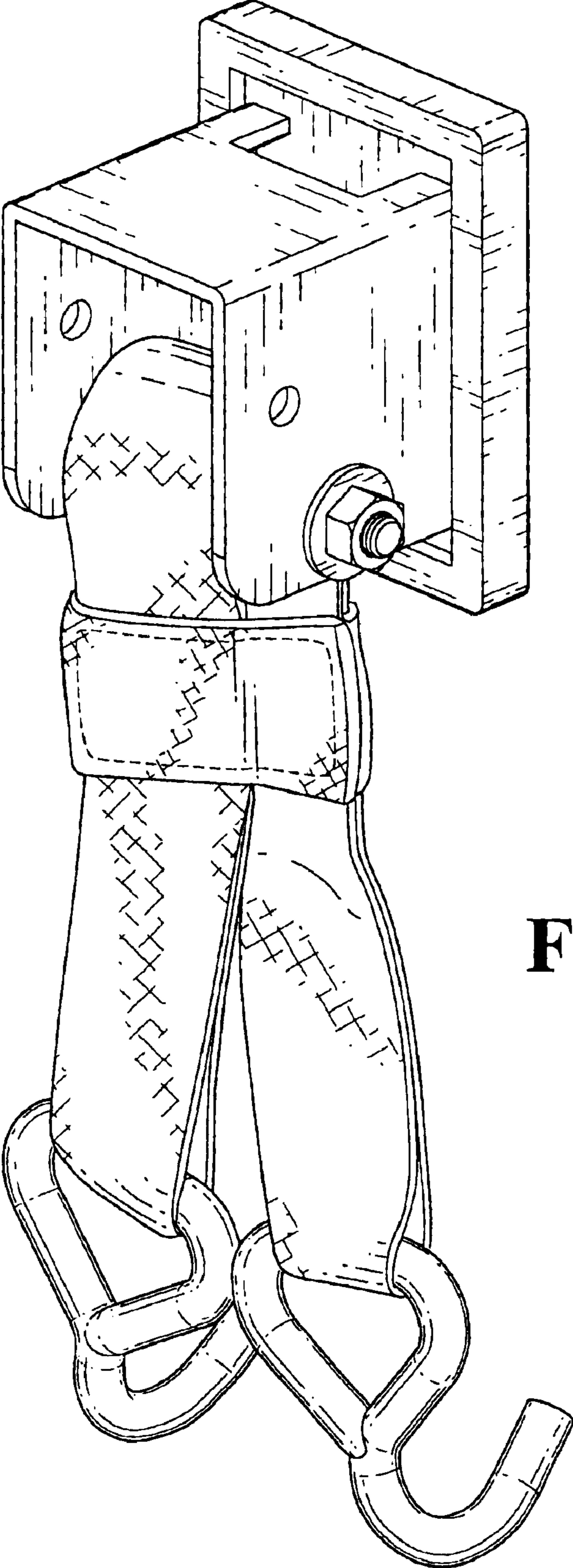

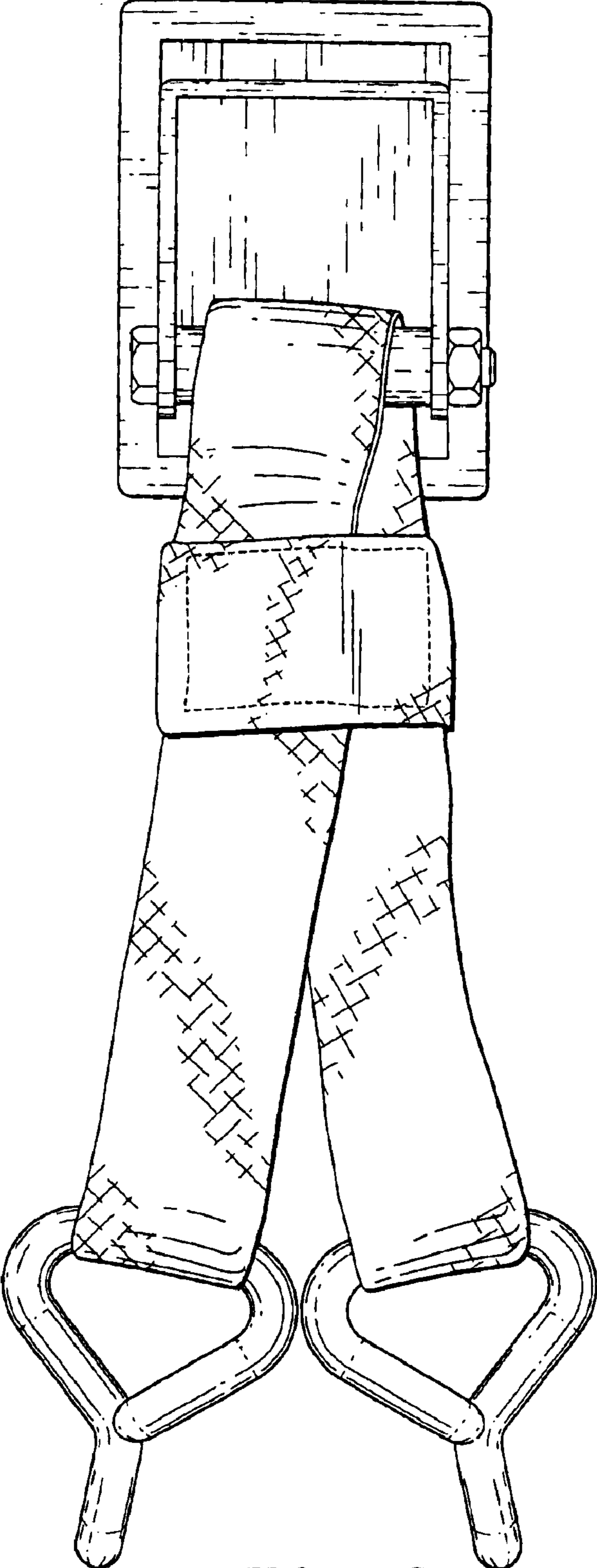

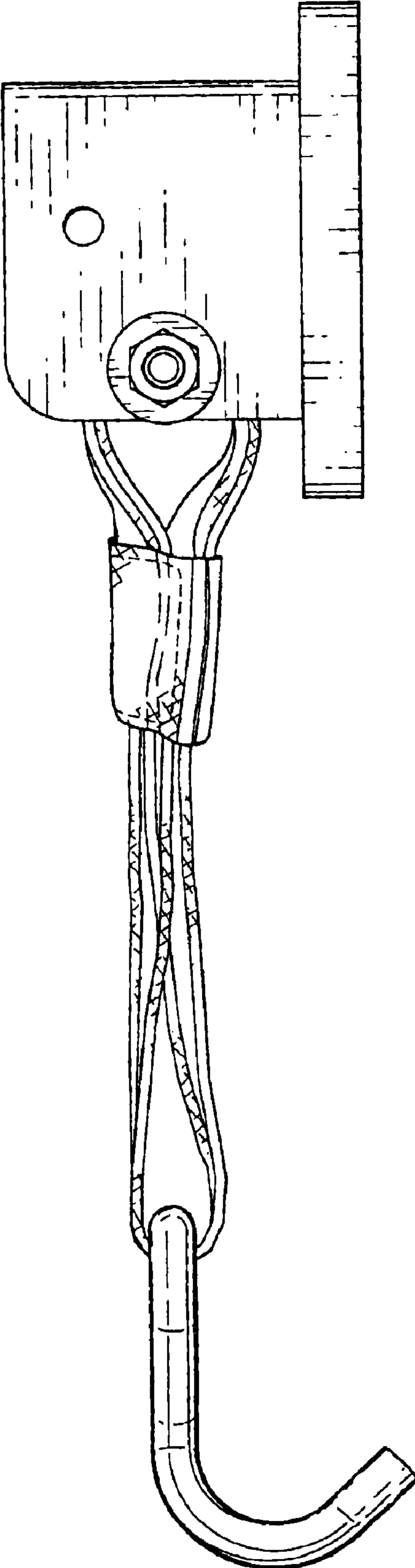

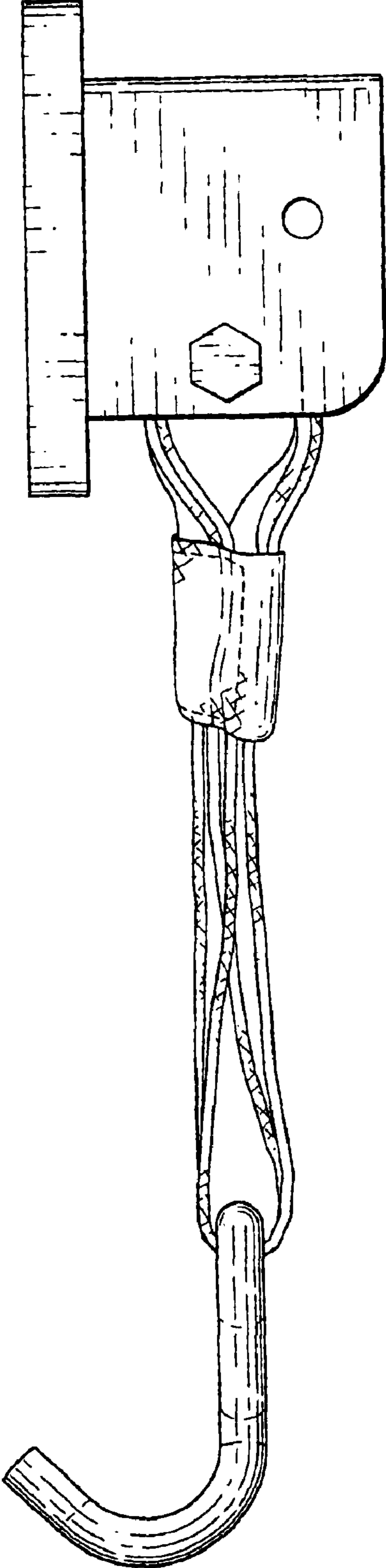

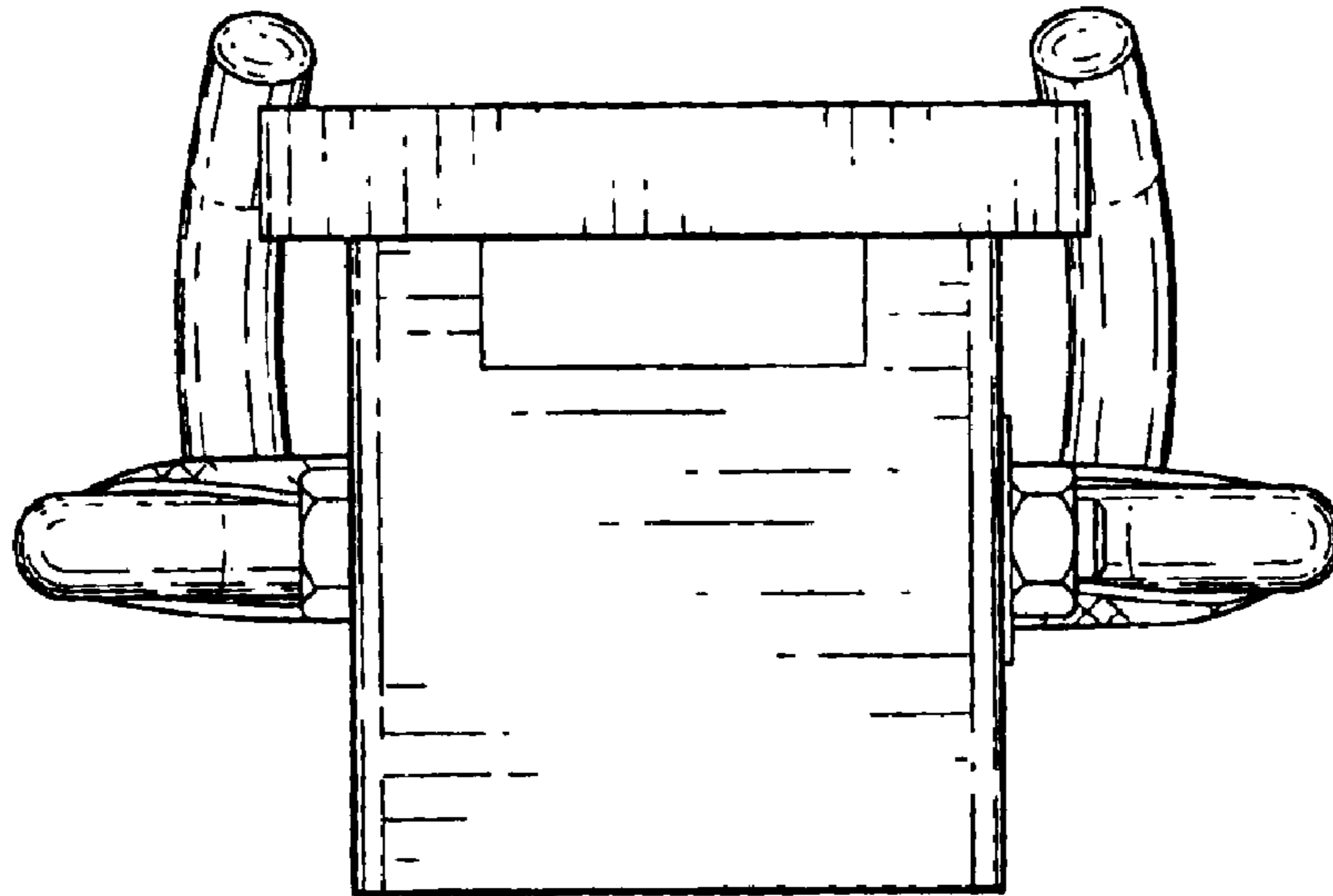

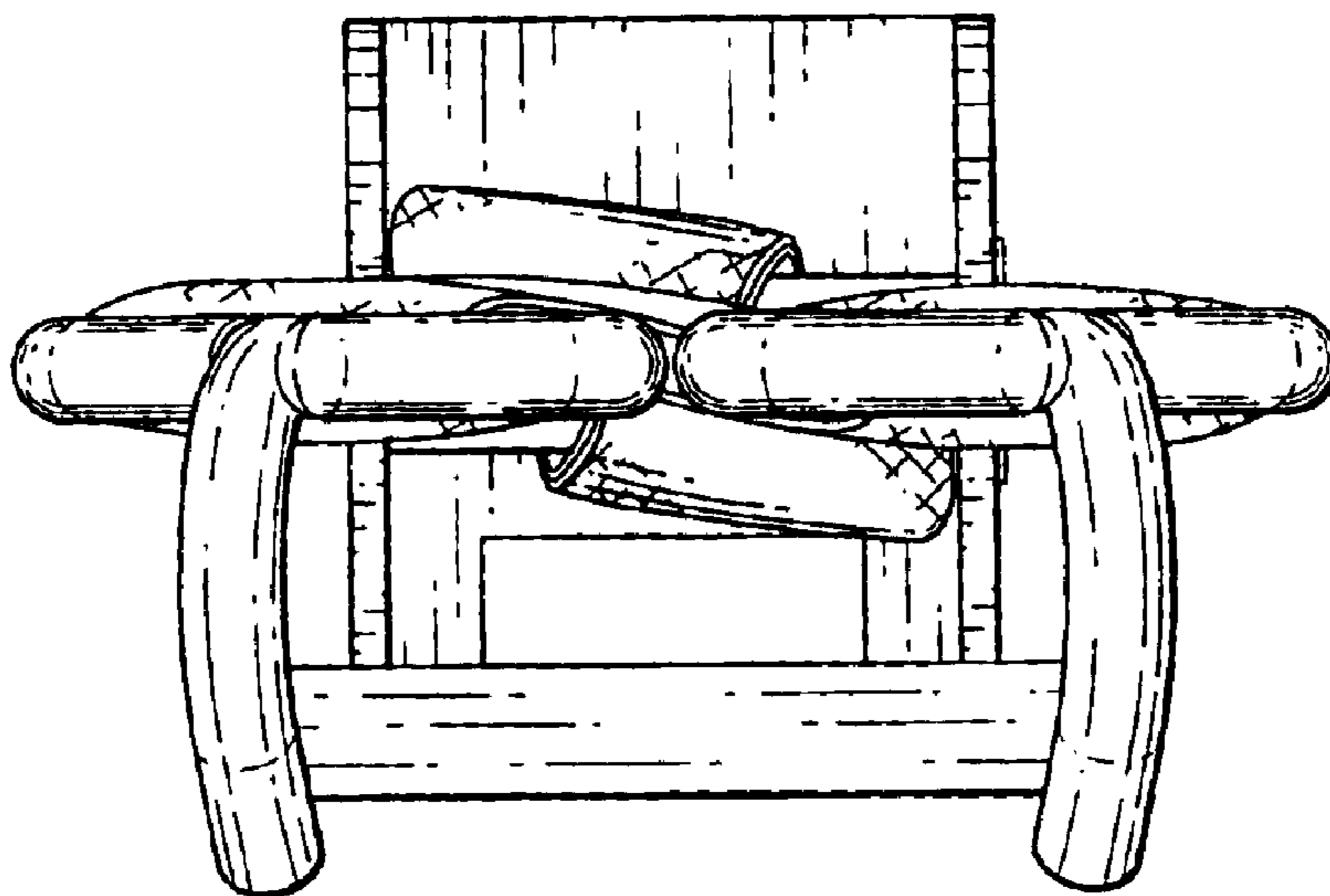

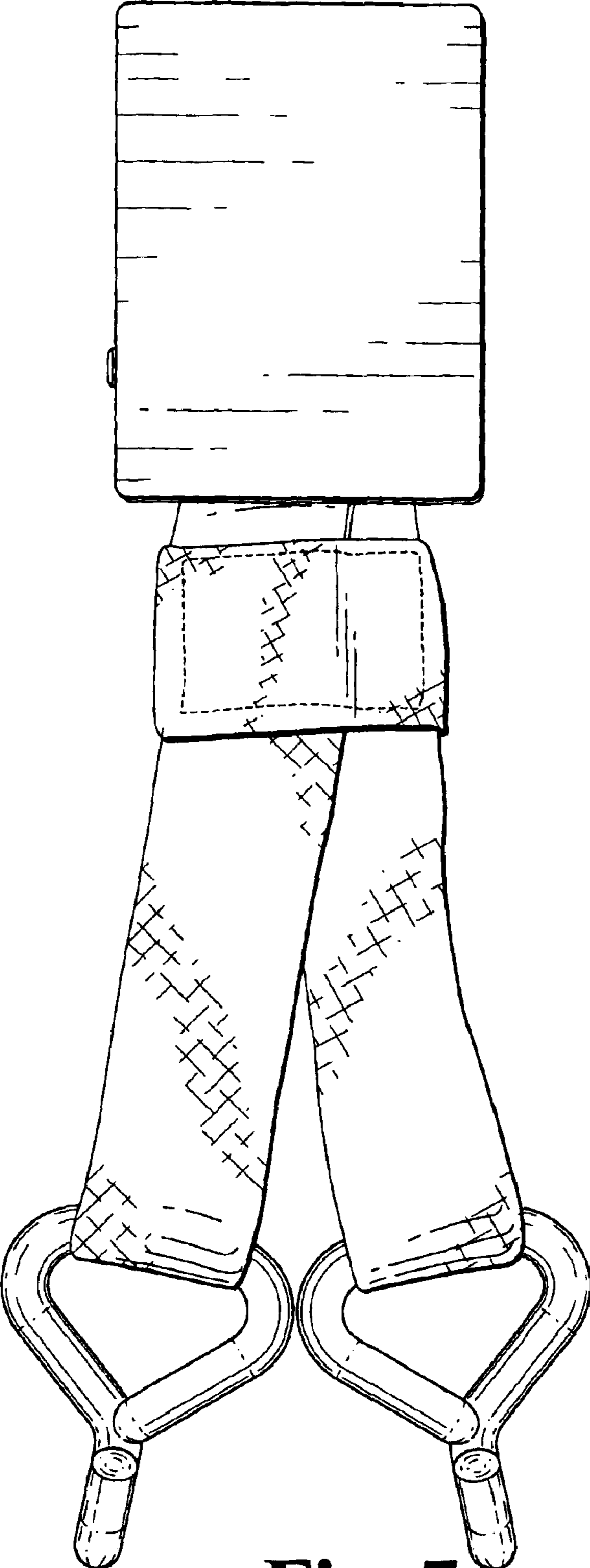
