(57) **CLAIM**

The ornamental design for an all-in-one garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of all-in-one garment showing my new design, wherein the removably attachable straps are shown in a first position of use;

FIG. 2 is a rear elevational view of the all-in-one garment of FIG. 1;

FIG. 3 is a perspective view of the all-in-one garment of FIG. 1, wherein the -removably attachable straps are shown in a second position of use;

FIG. 4 is a rear elevational view of the all-in-one garment of FIG. 3;

FIG. 5 is a perspective view of the all-in-one garment of FIG. 1, wherein the removably attachable straps are shown in a third position of use;

FIG. 6 is a rear elevational view of the all-in-one garment of FIG. 5;

FIG. 7 is a front elevational view of the all-in-one garment of FIG. 1, wherein the removably attachable straps are shown in a fourth position of use;

FIG. 8 is a rear elevational view of the all-in-one garment of FIG. 7;

FIG. 9 is a perspective view of a second embodiment of an all-in-one garment showing my new design, wherein the removably attachable clear straps are shown in a first position of use;

FIG. 10 is a rear elevational view of the all-in-one garment of FIG. 9;

FIG. 11 is a front elevational view of the all-in-one garment of FIG. 9, wherein the removably attachable clear straps are shown in a second position of use;

FIG. 12 is a rear elevational view of the all-in-one garment of FIG. 11;

FIG. 13 is a perspective view of the all-in-one garment of FIG. 9, wherein the -removably attachable clear straps are shown in a third position of use;

FIG. 14 is a rear elevational view of the all-in-one garment of FIG. 13;

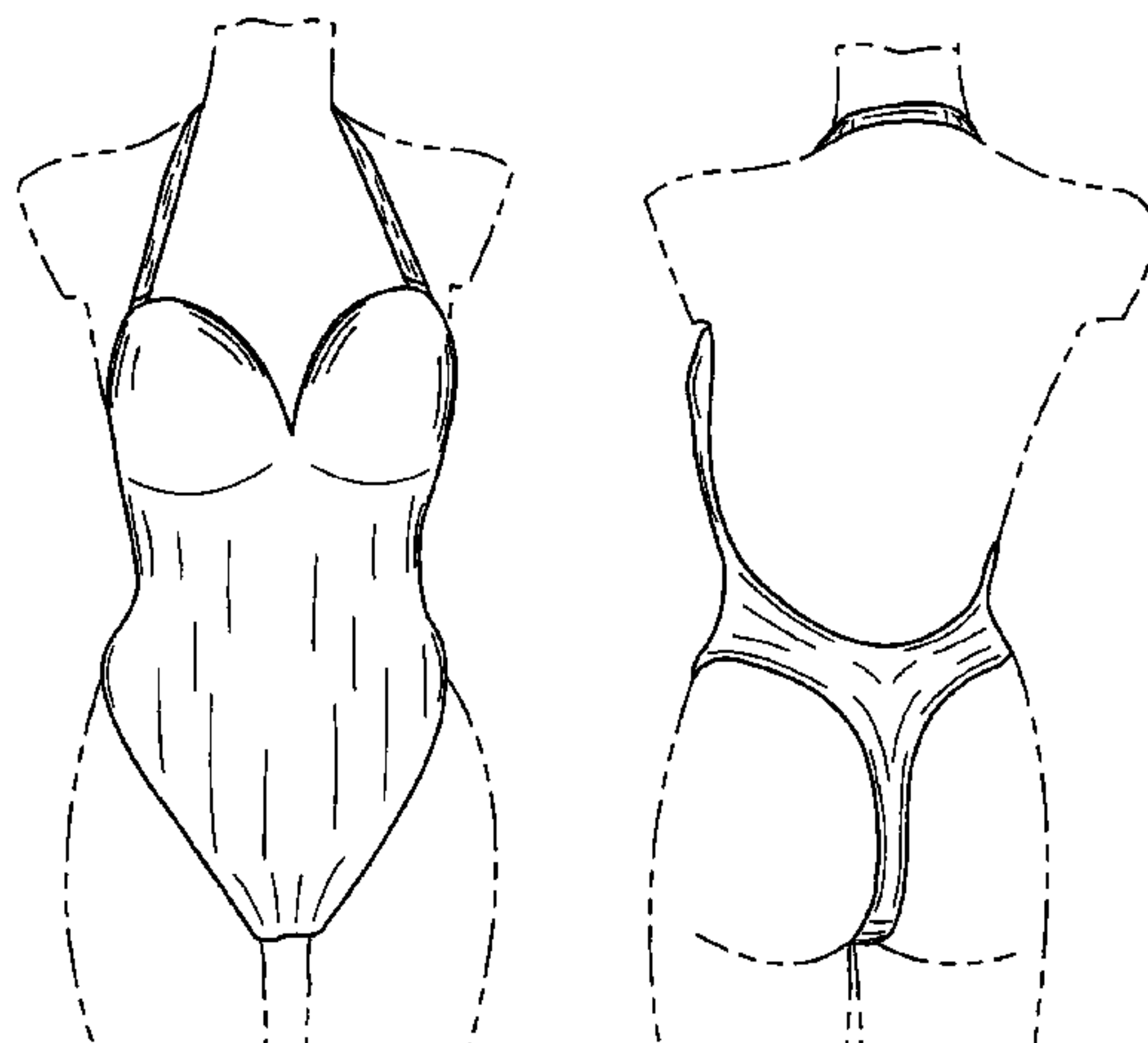
FIG. 15 is a front elevational view of the all-in-one garment of FIG. 9, wherein the removably attachable to clear straps are shown in a fourth position of use;

FIG. 16 is a rear perspective view of the all-in-one garment of FIG. 15; and,

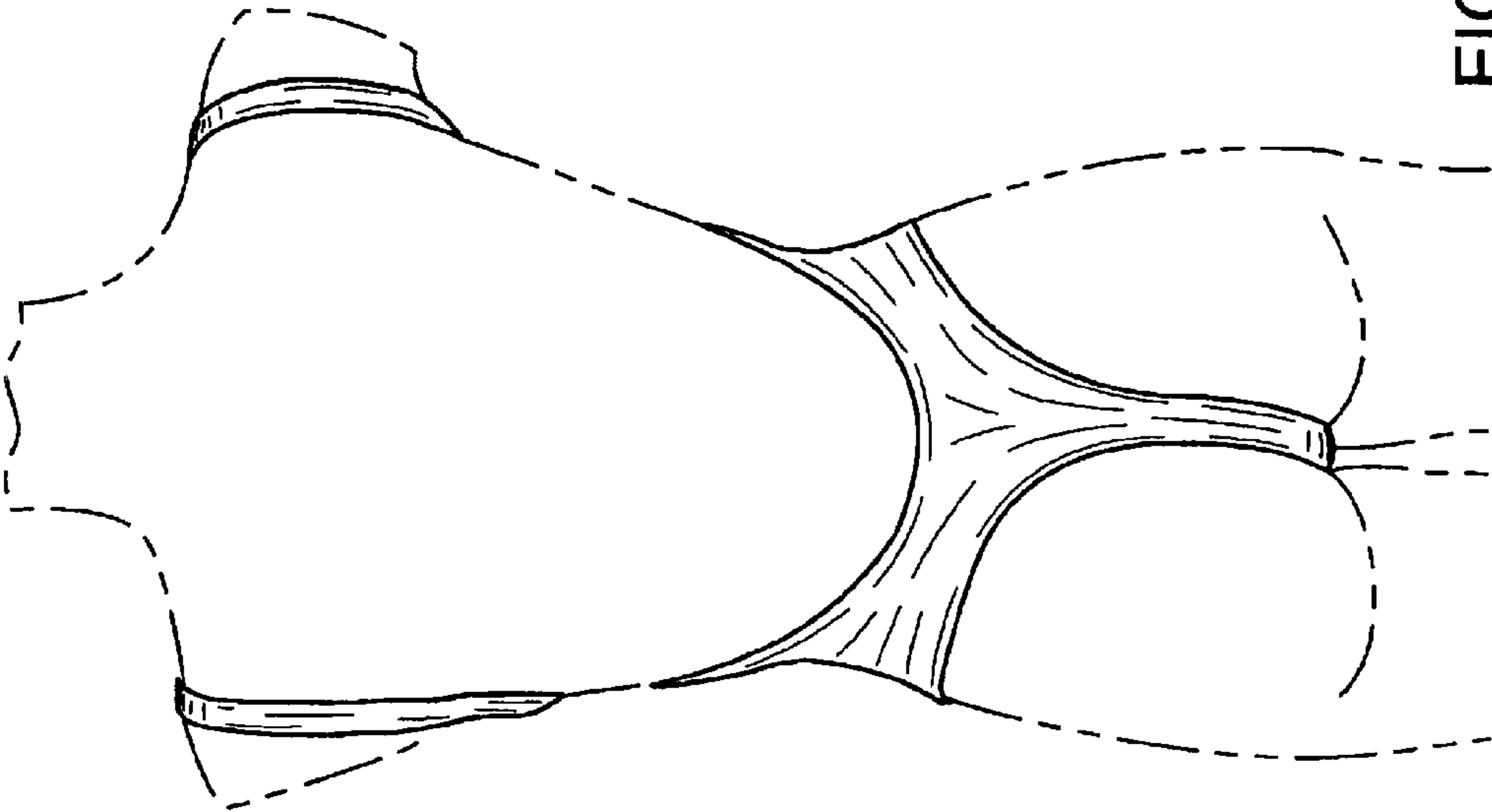

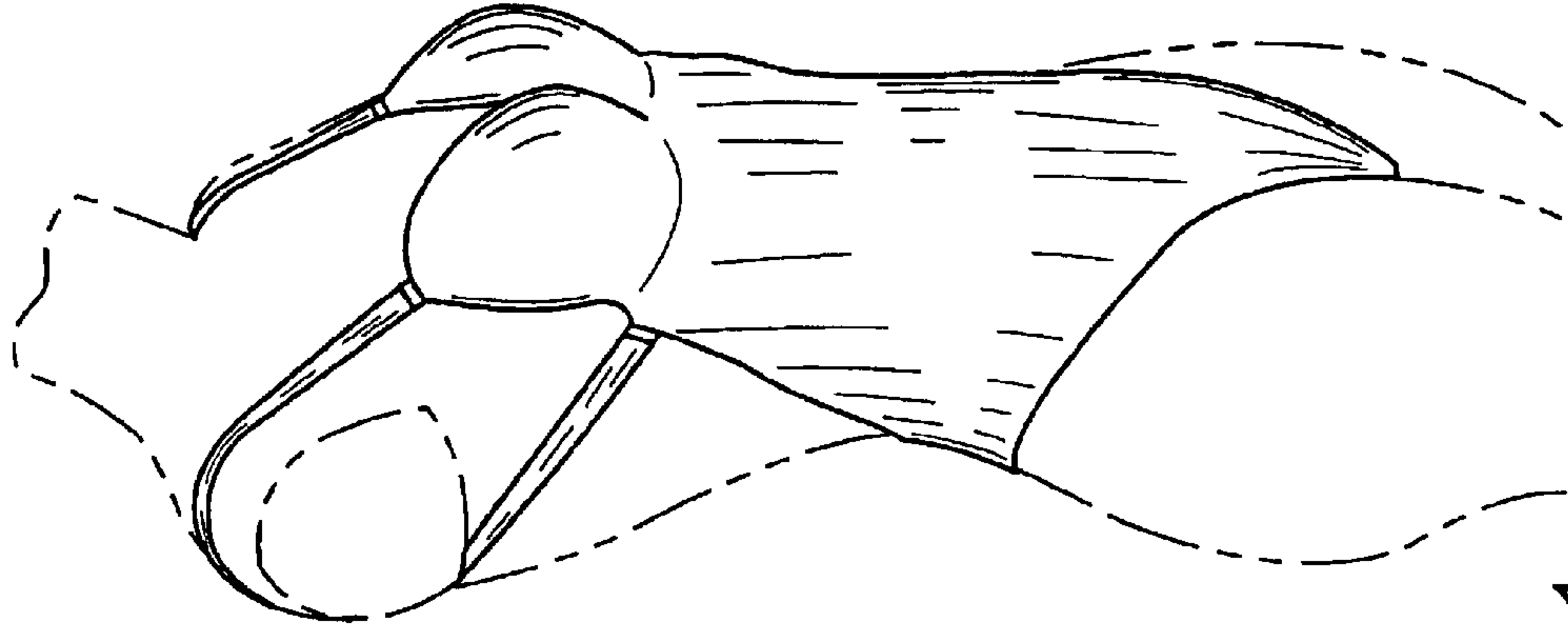

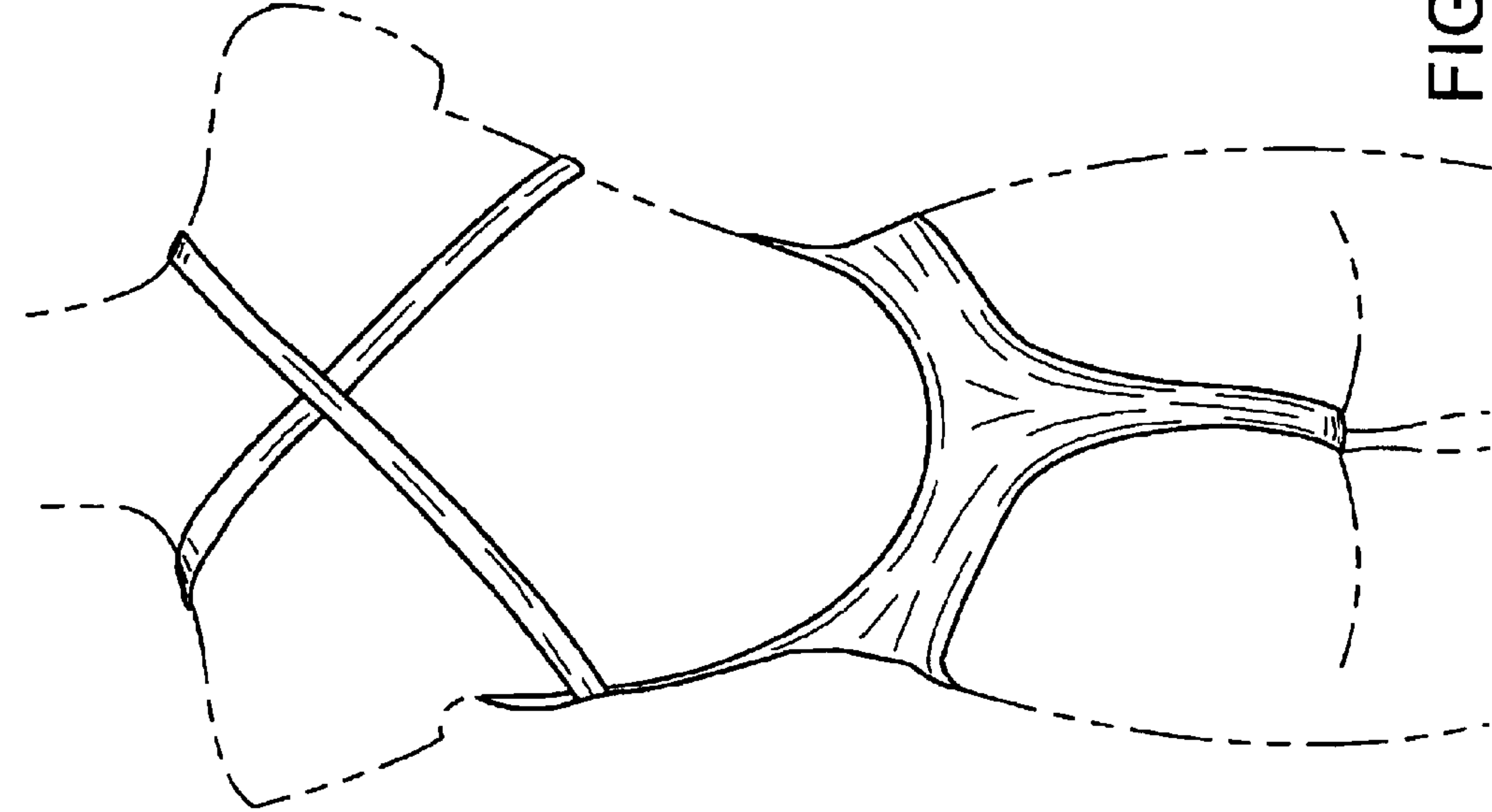

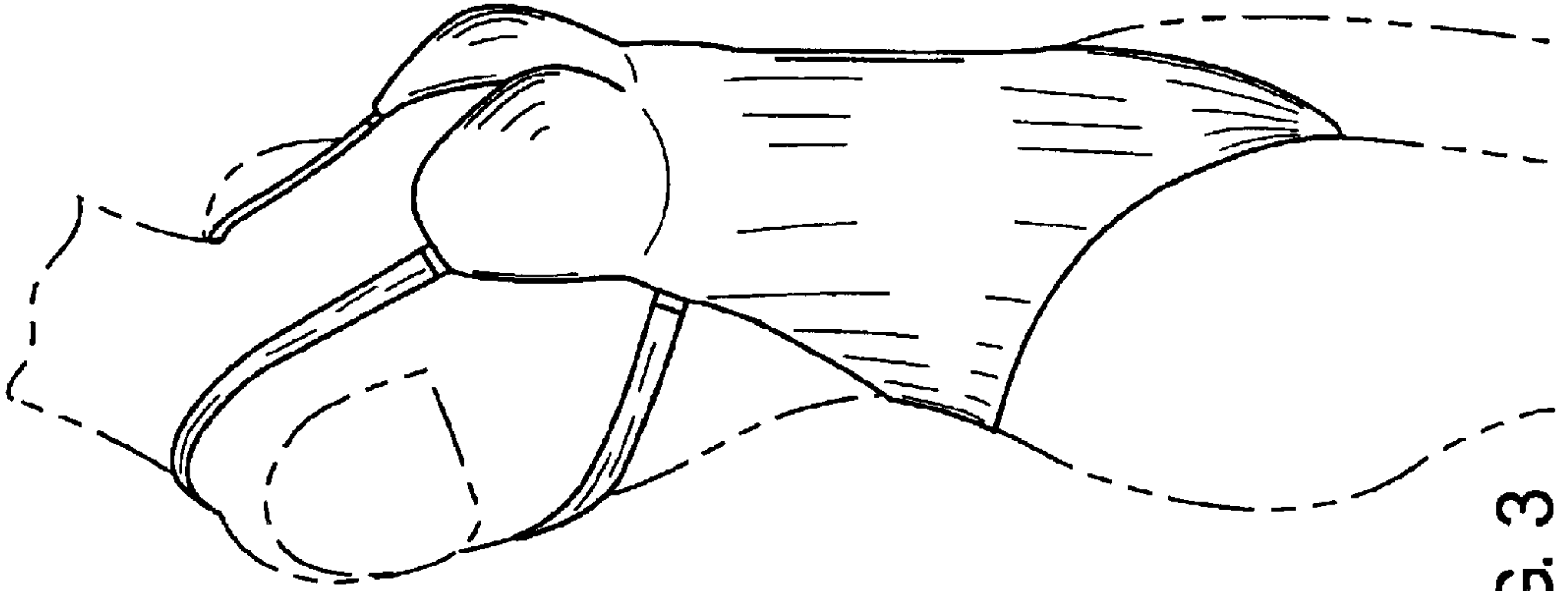

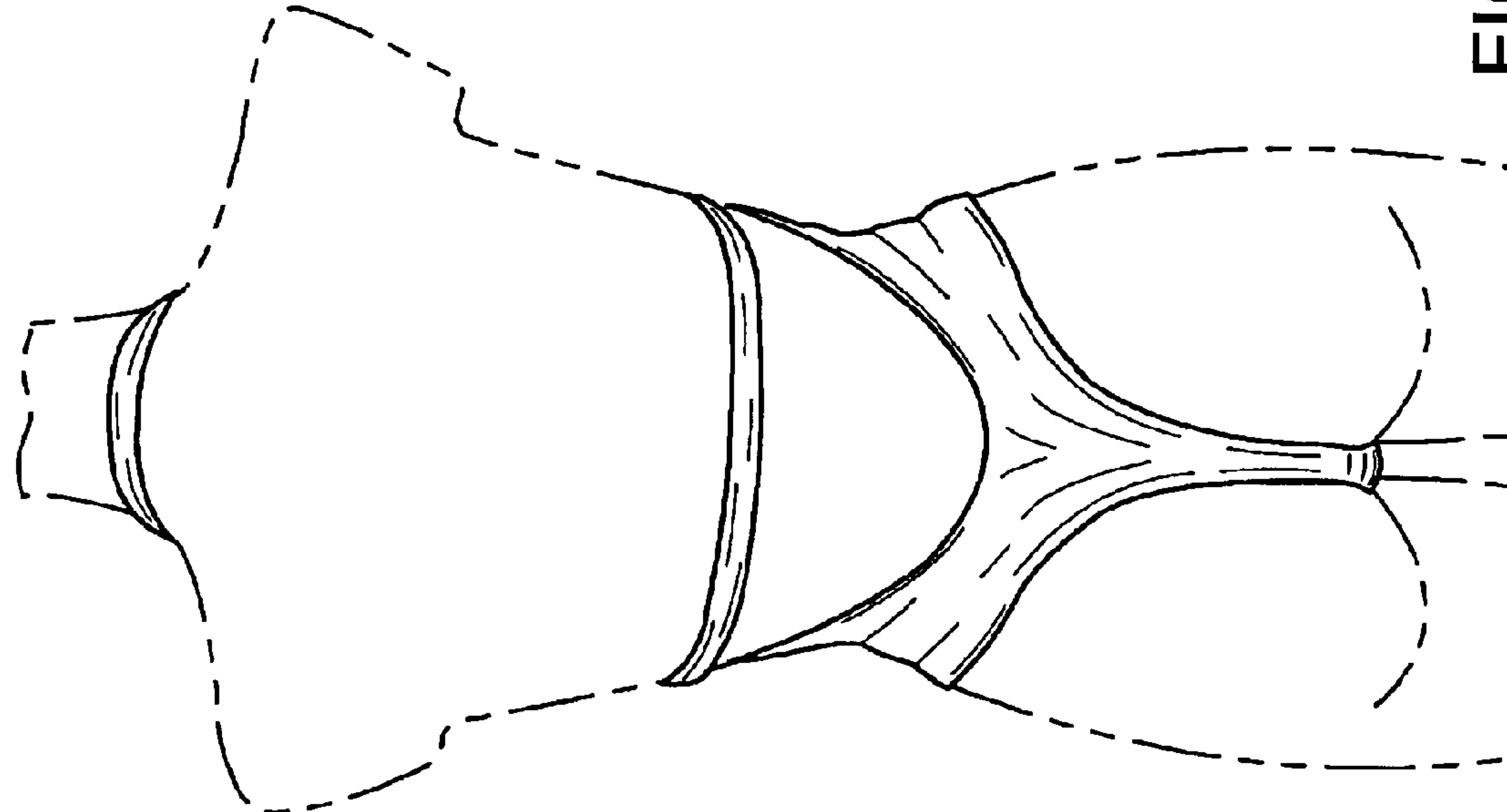

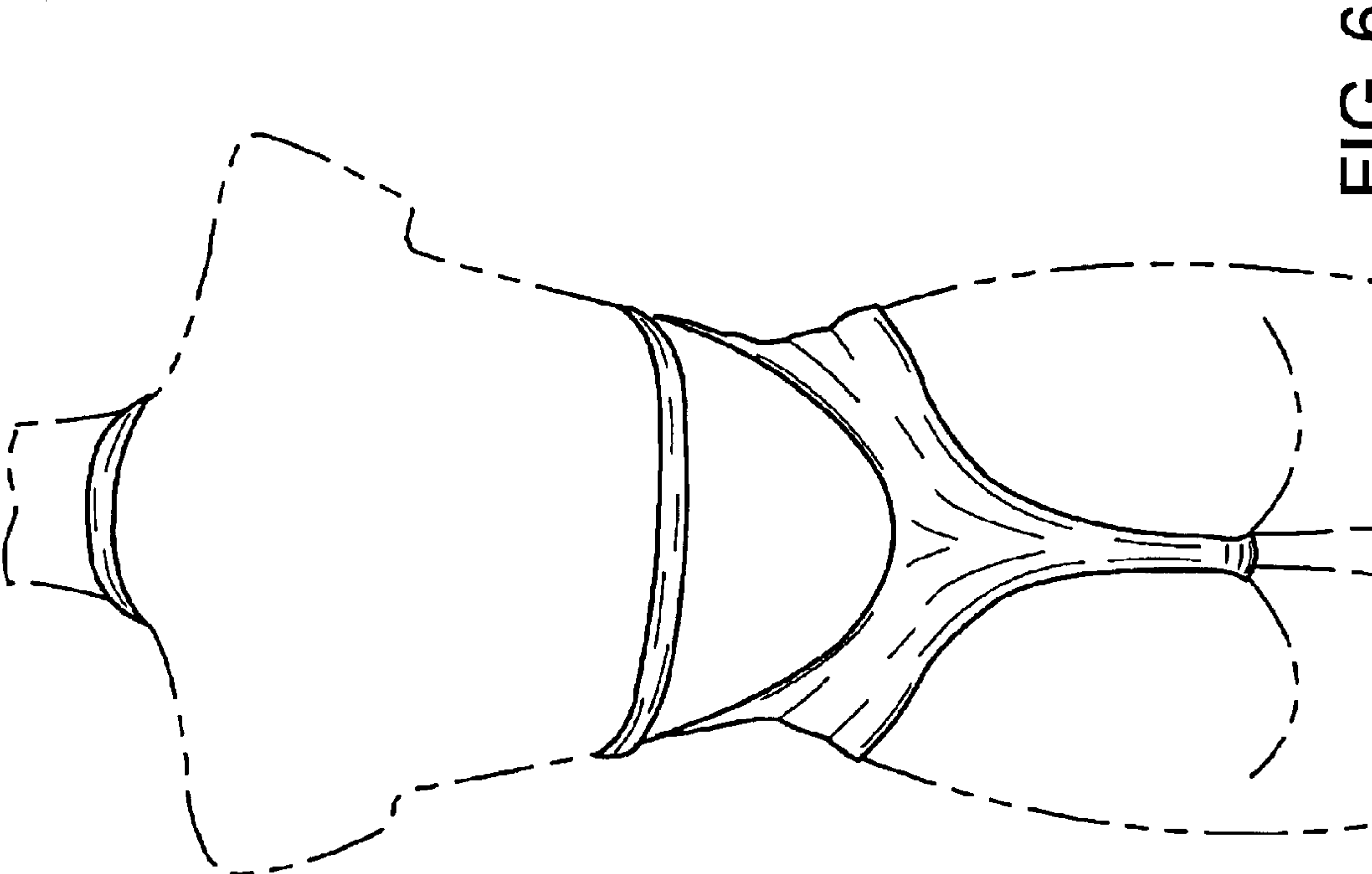

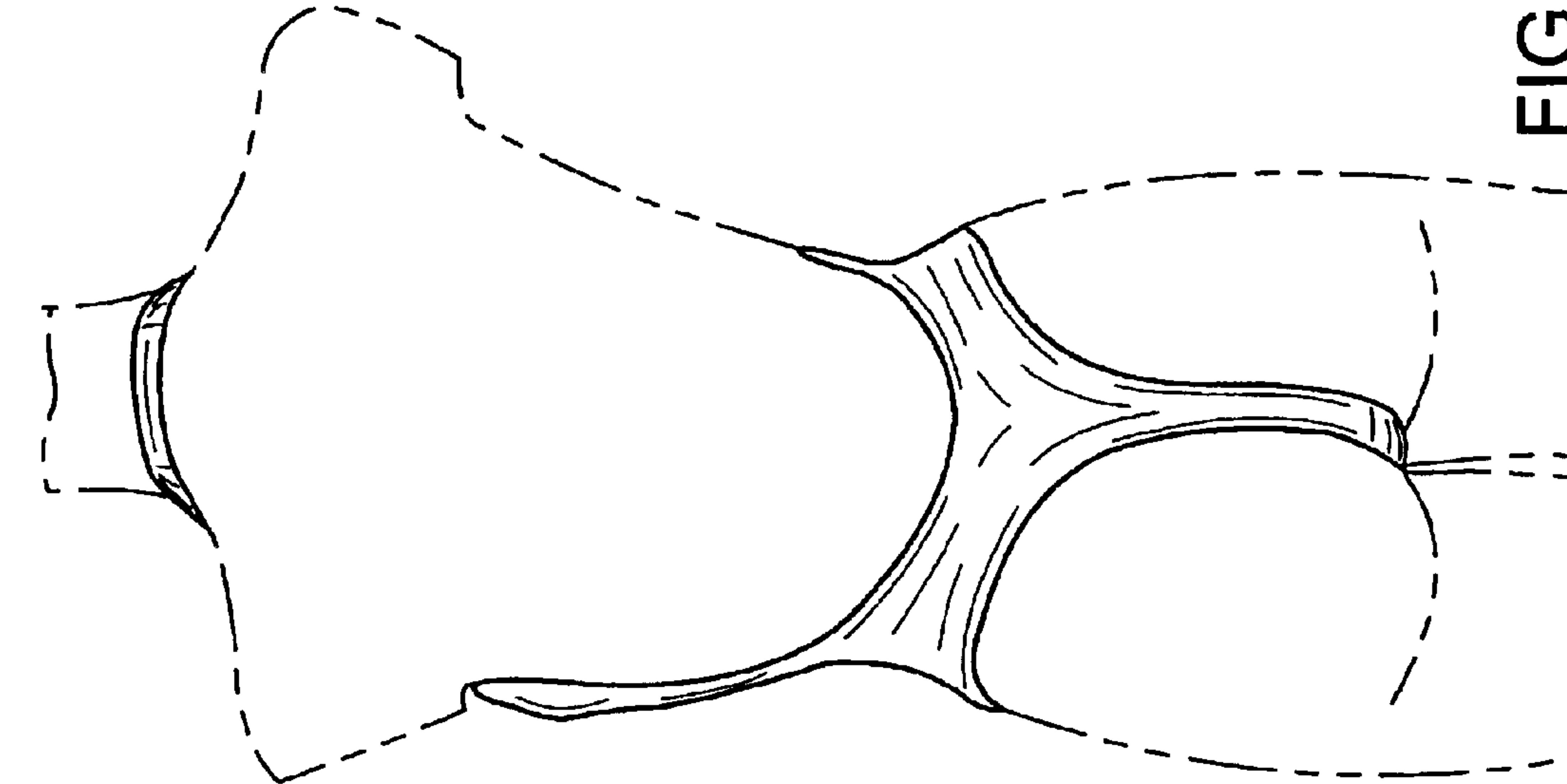

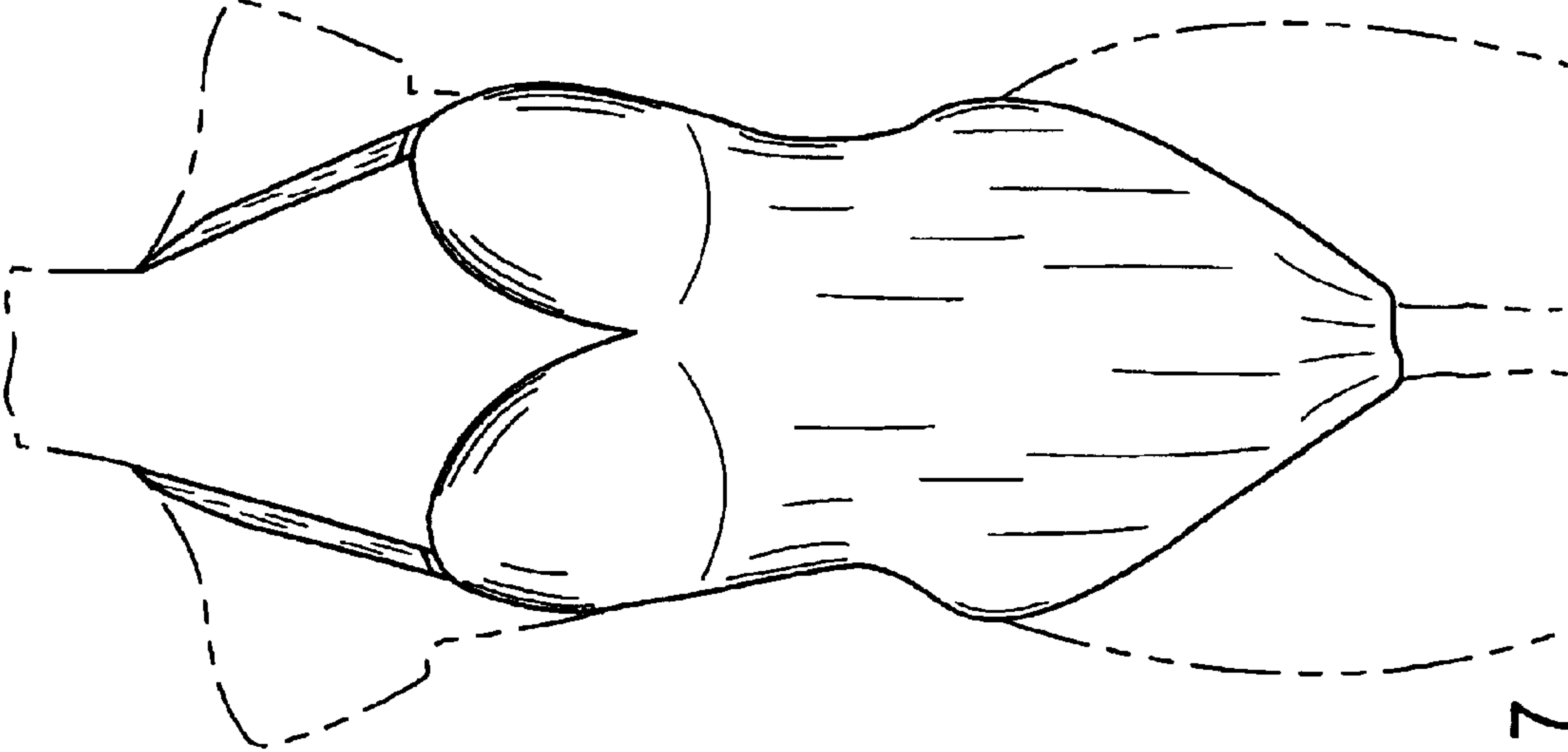

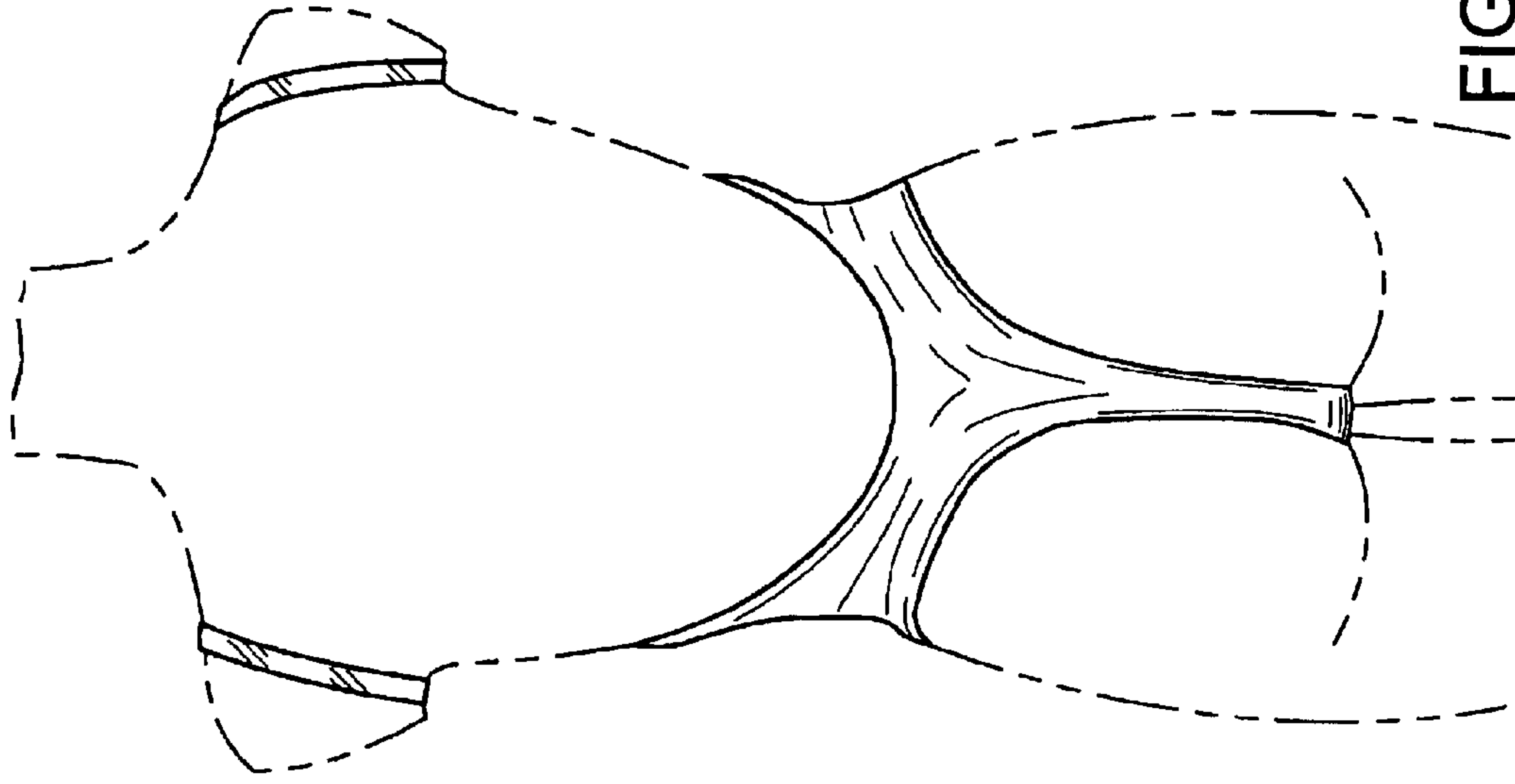

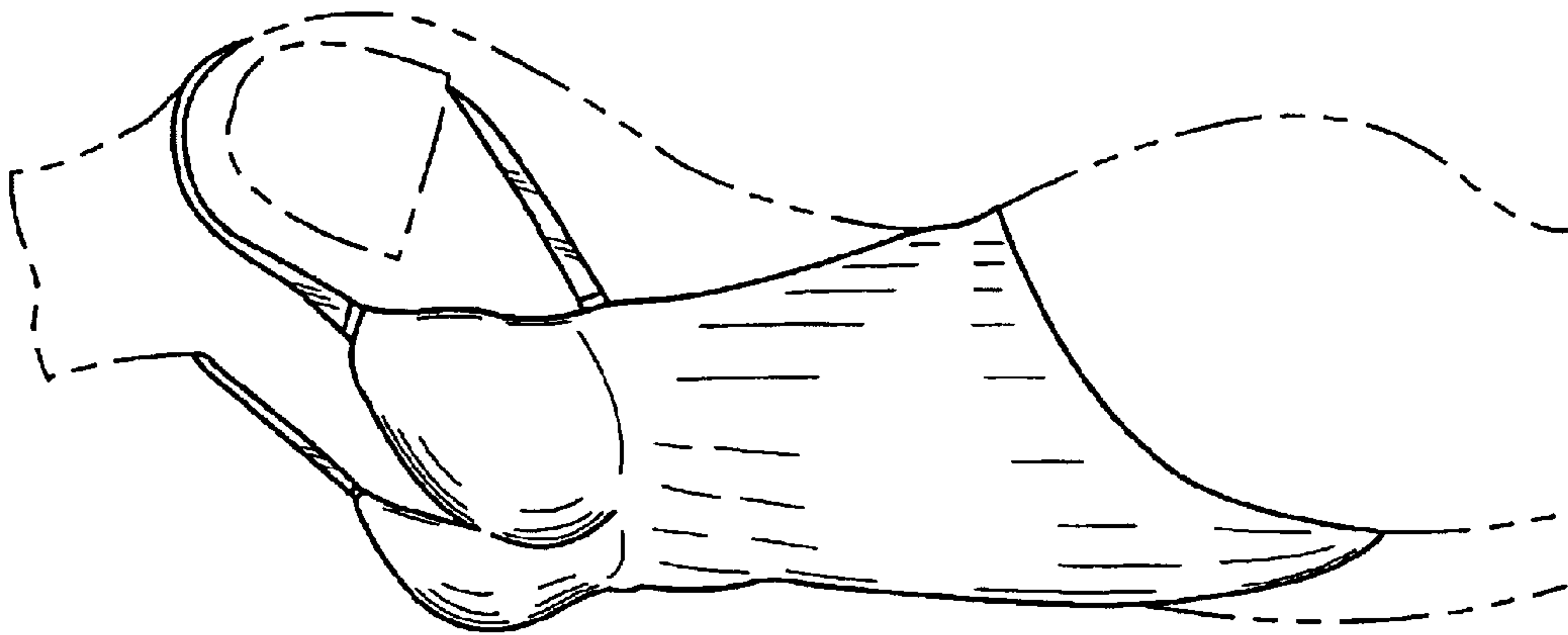

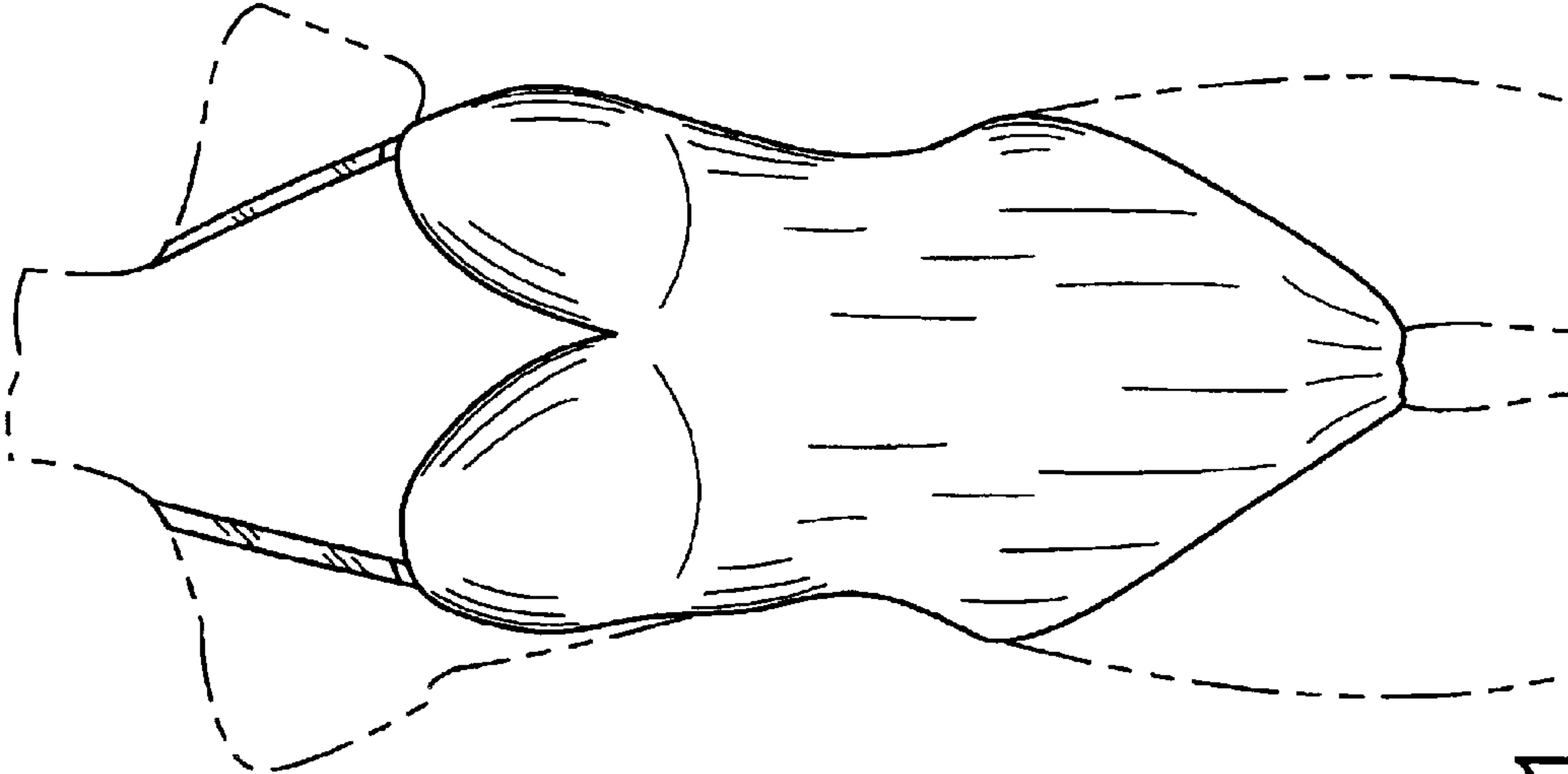

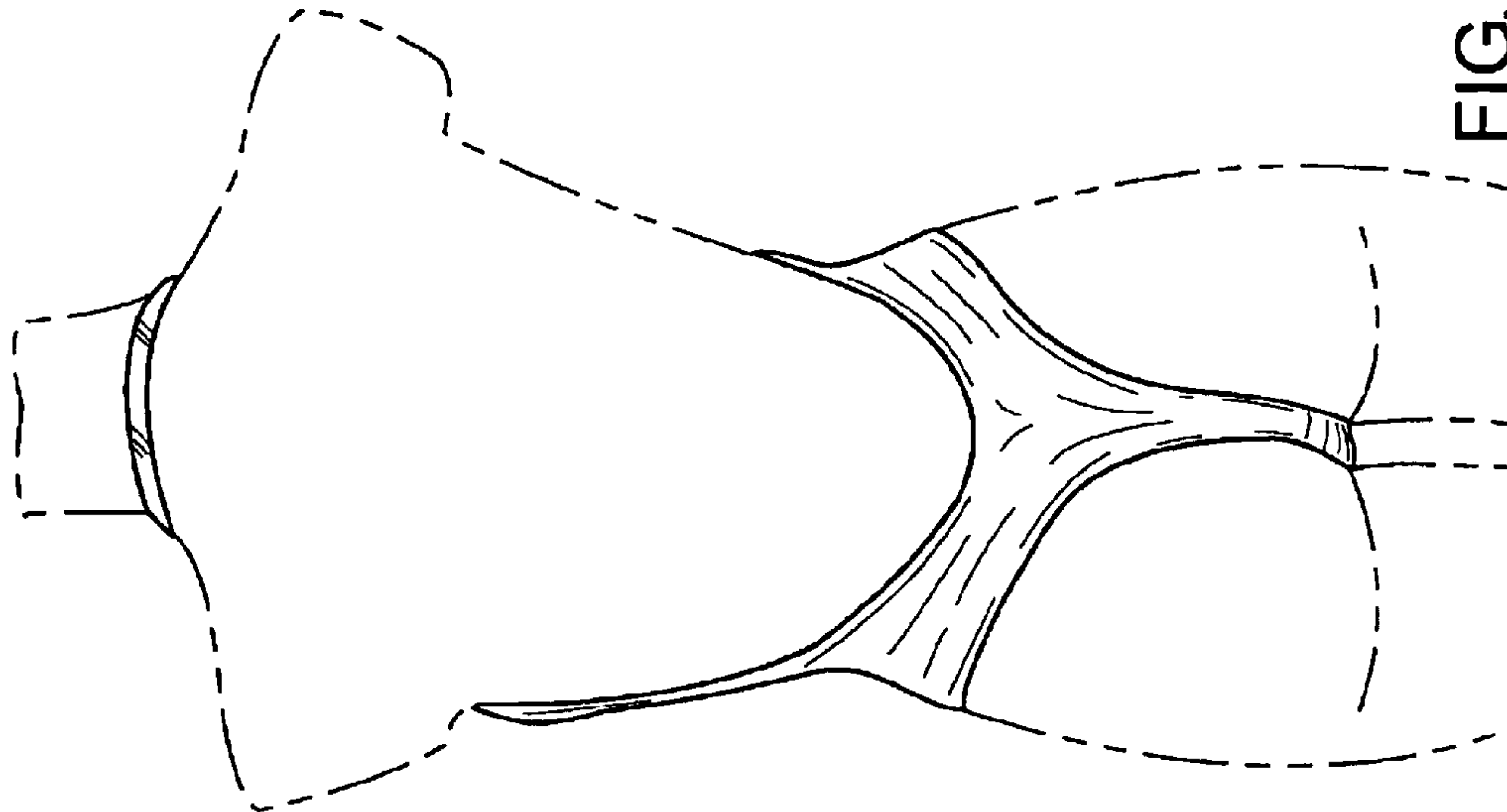

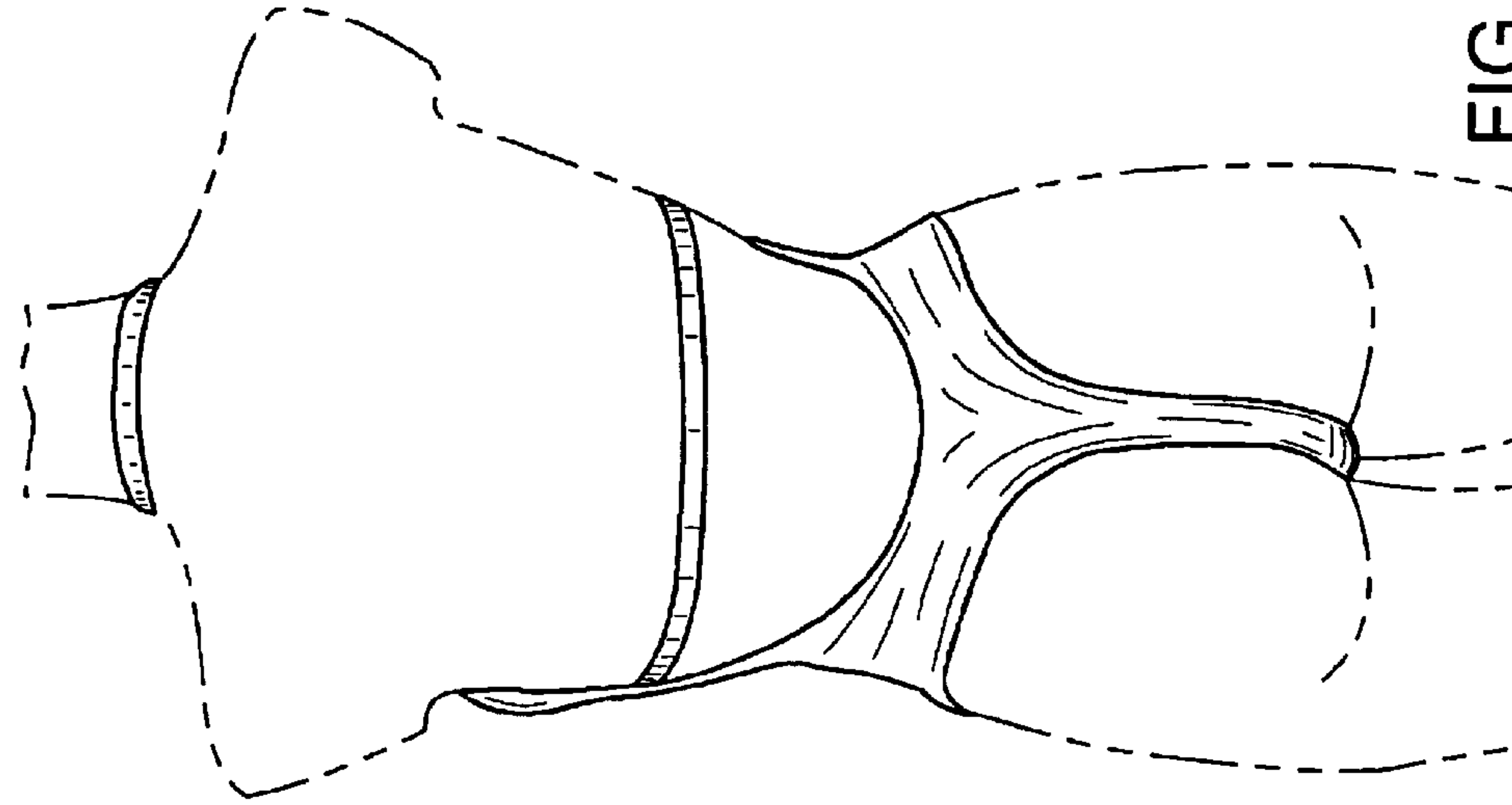

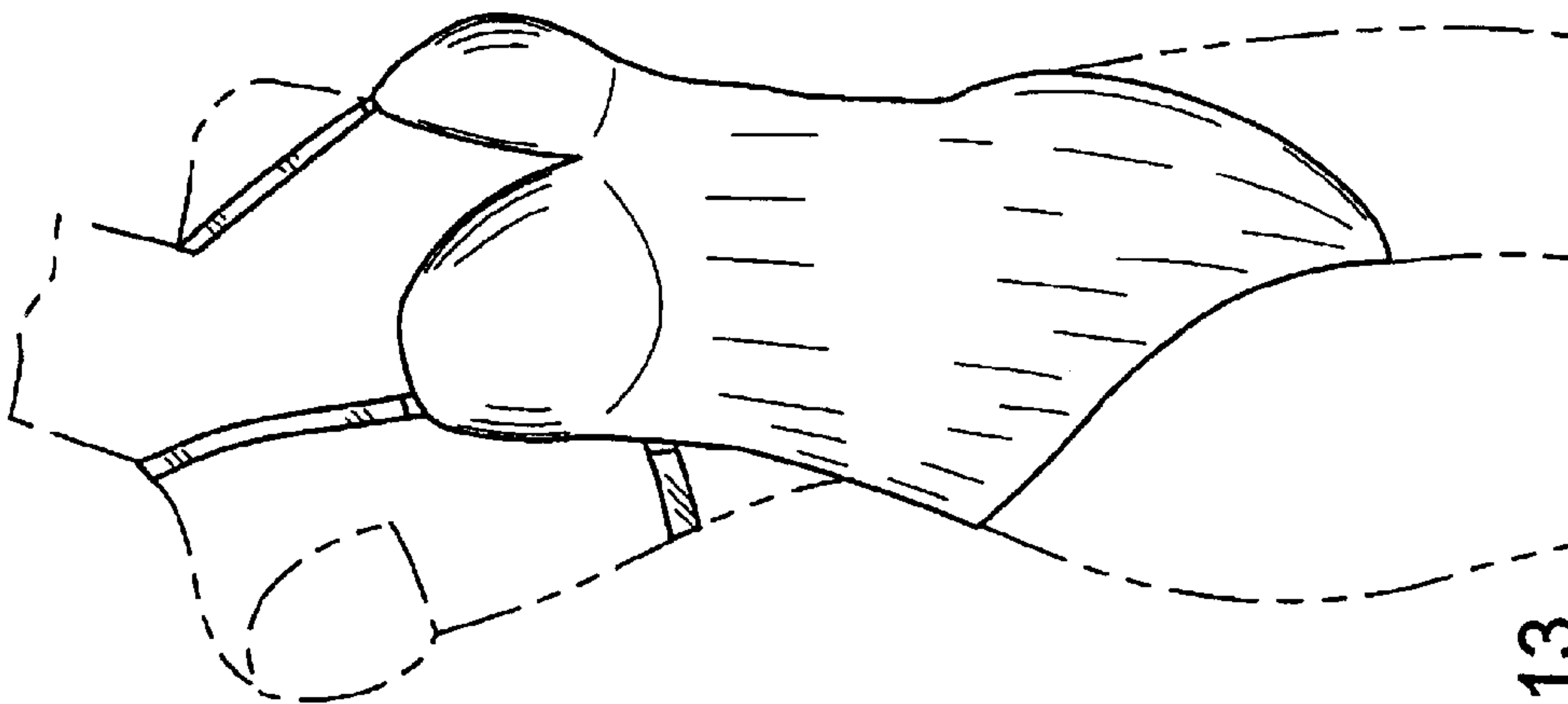

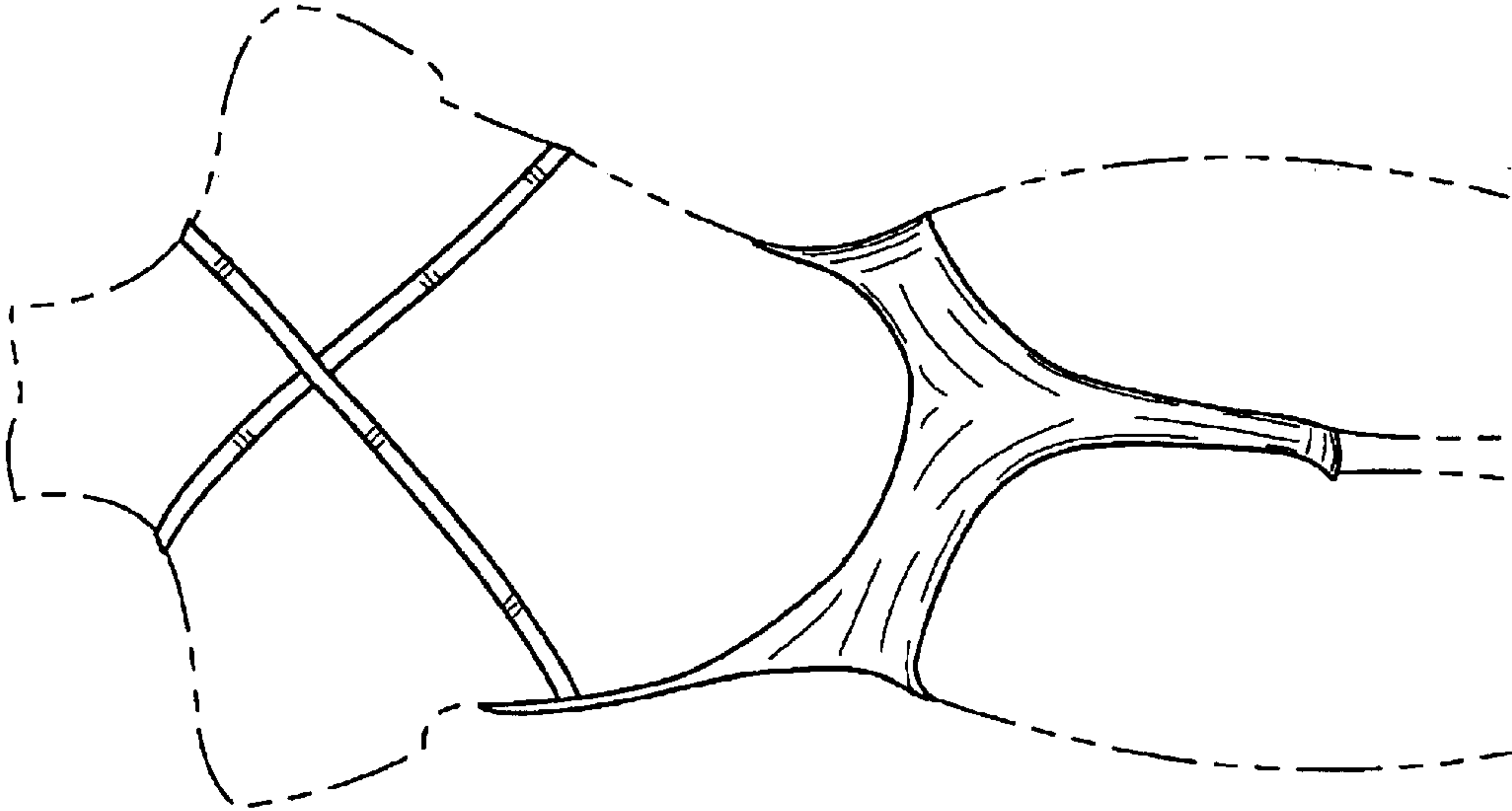

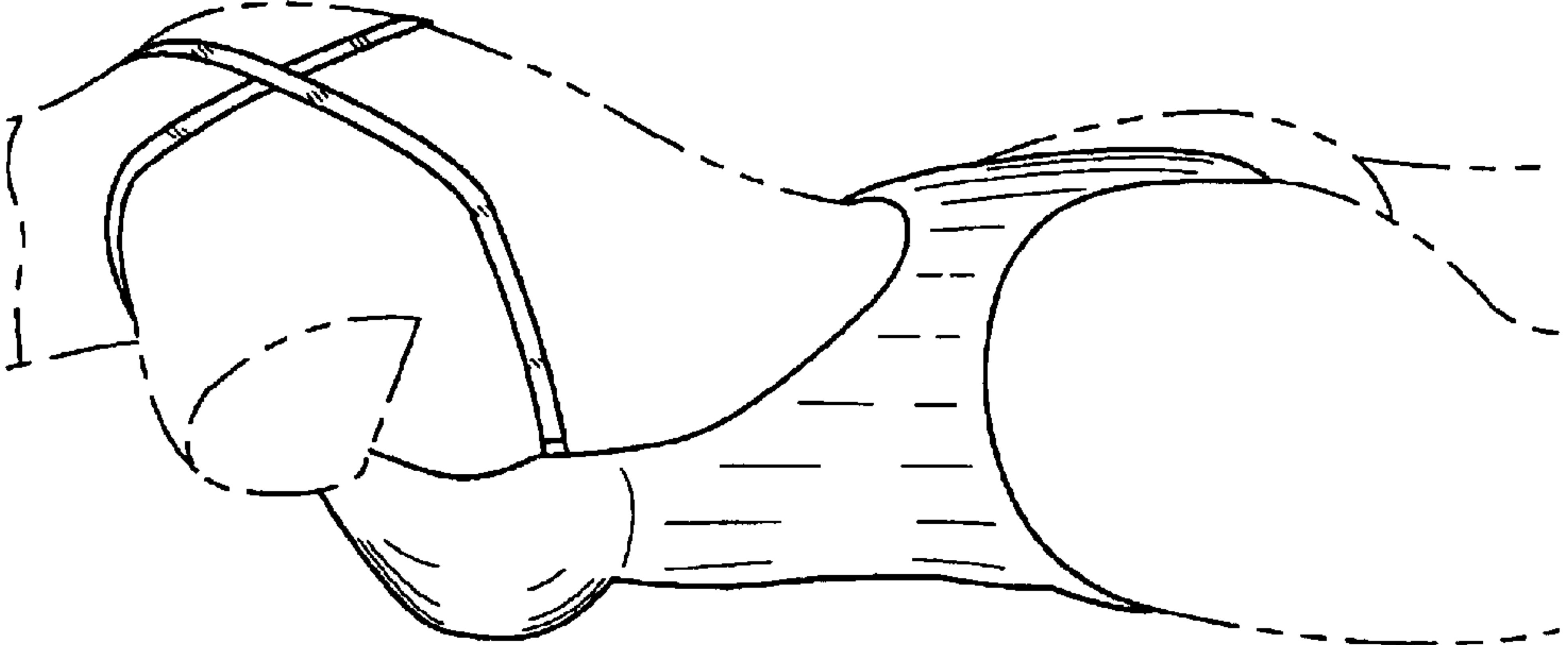
