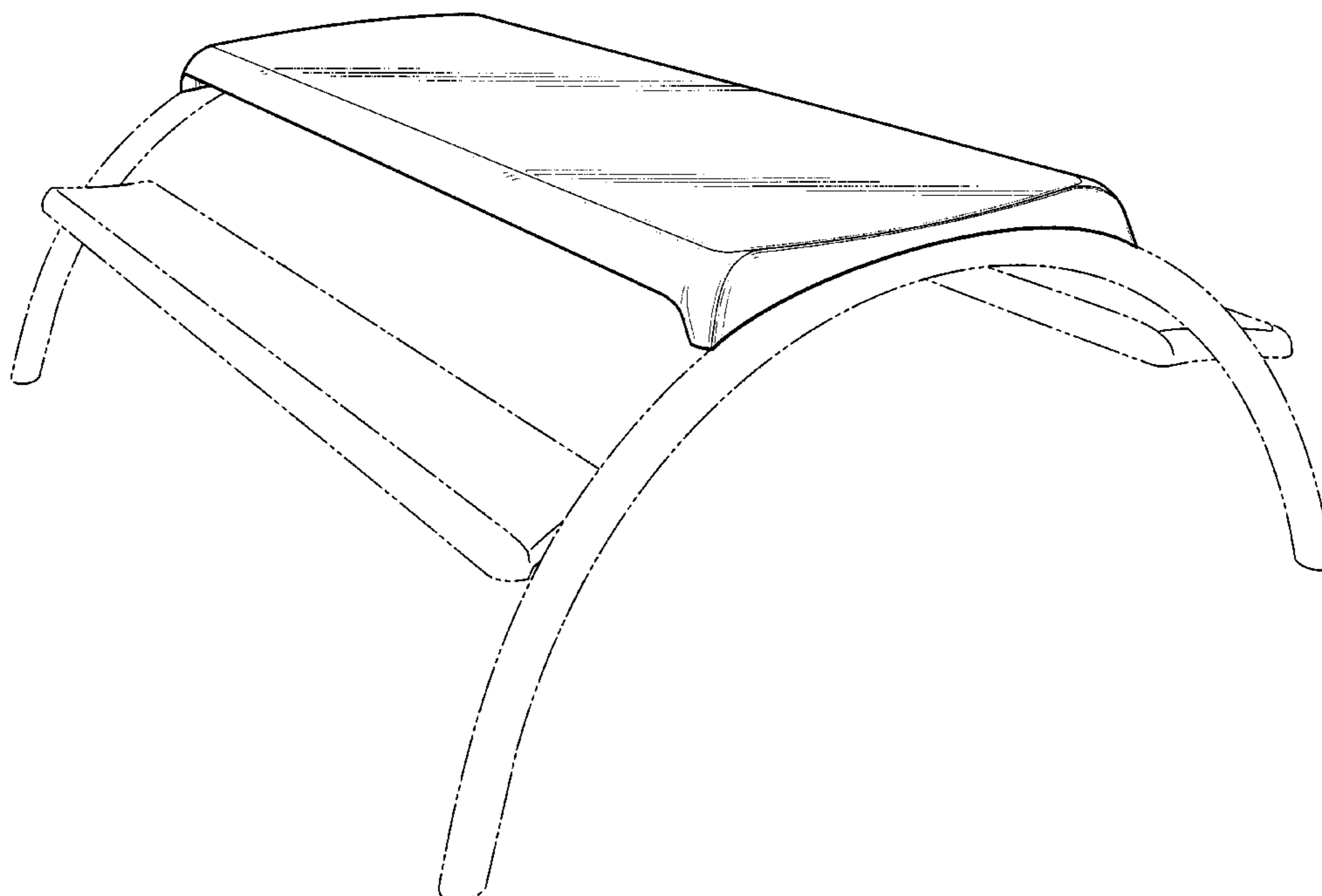
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a top for a picnic table; FIG. 2 is a top view of the top for a picnic table; FIG. 3 is a front view of the top for a picnic table, with the rear view being a mirror image thereof; and, FIG. 4 is a right side view of the top for a picnic table, with the left side view being a mirror image thereof. The broken lines shown in the figures are for illustrative purposes only and form no part of the claimed design.

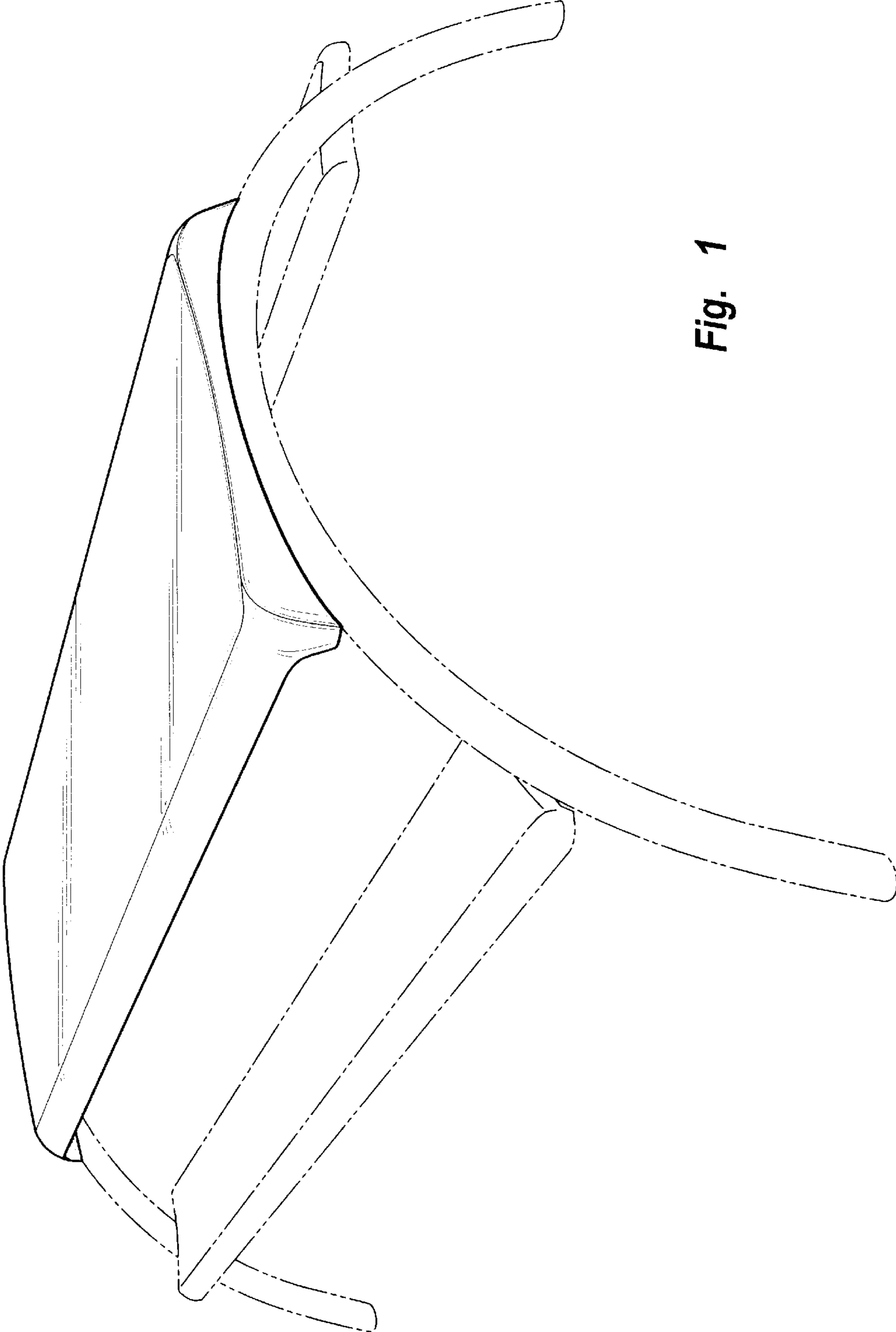

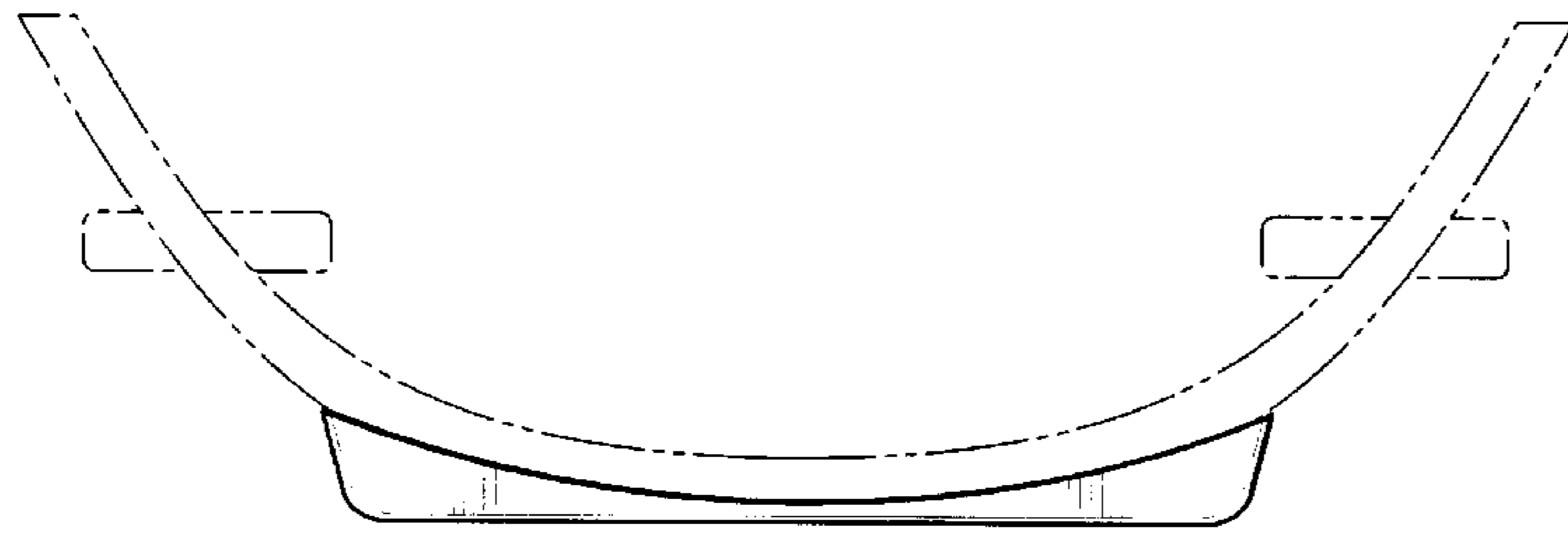

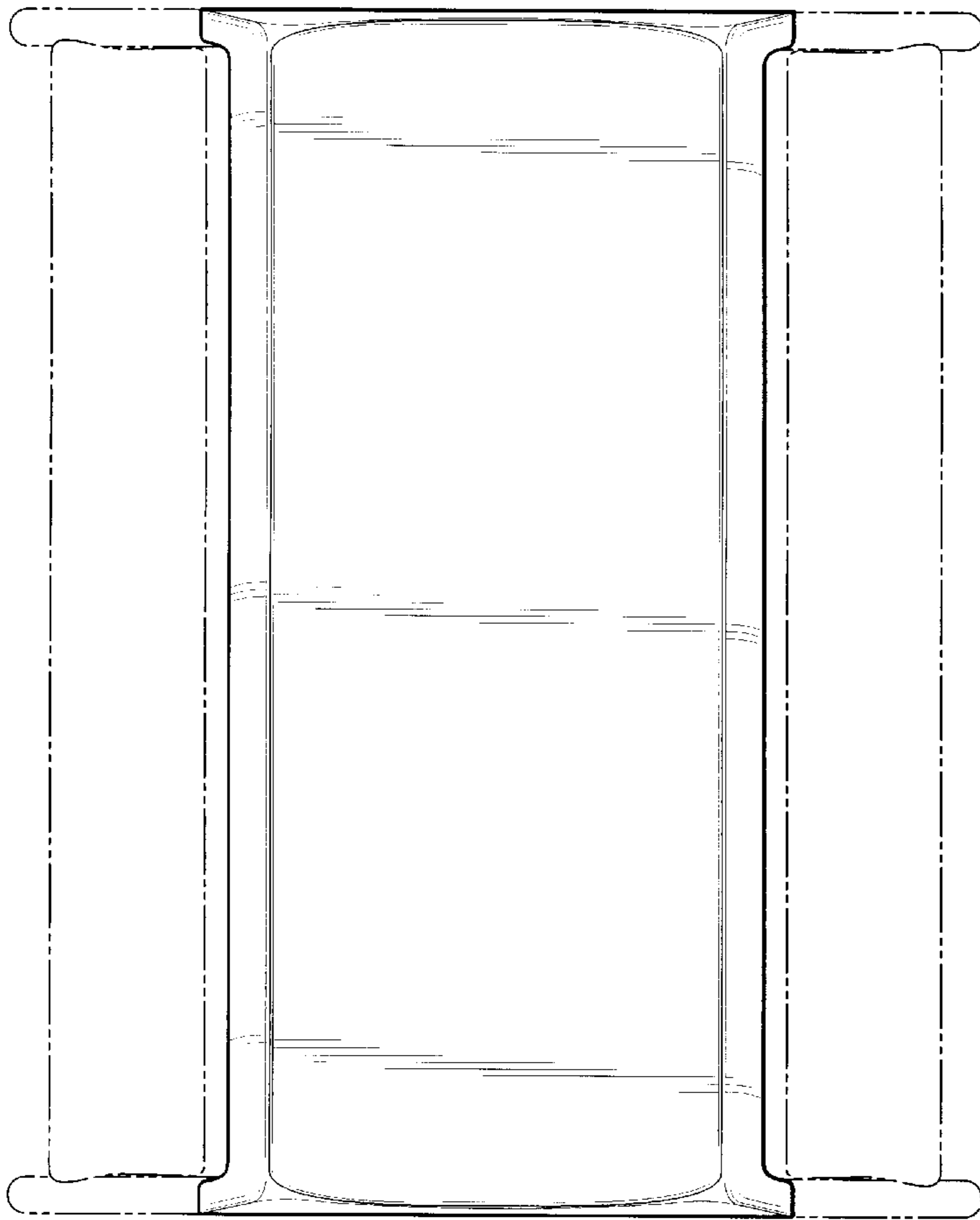

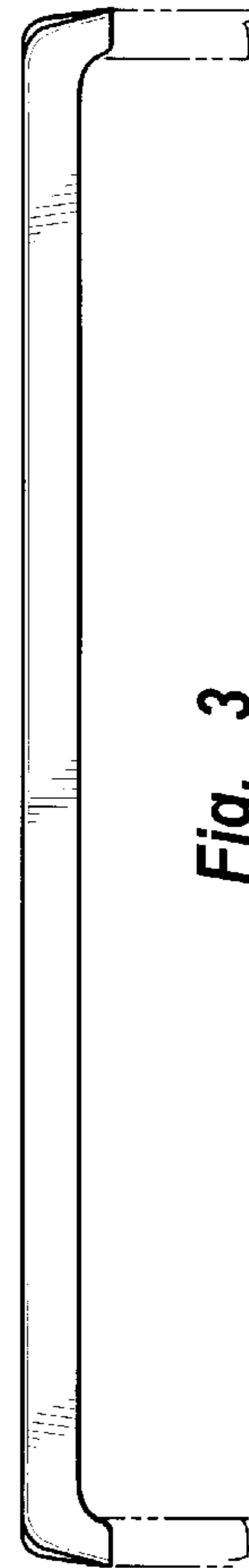
