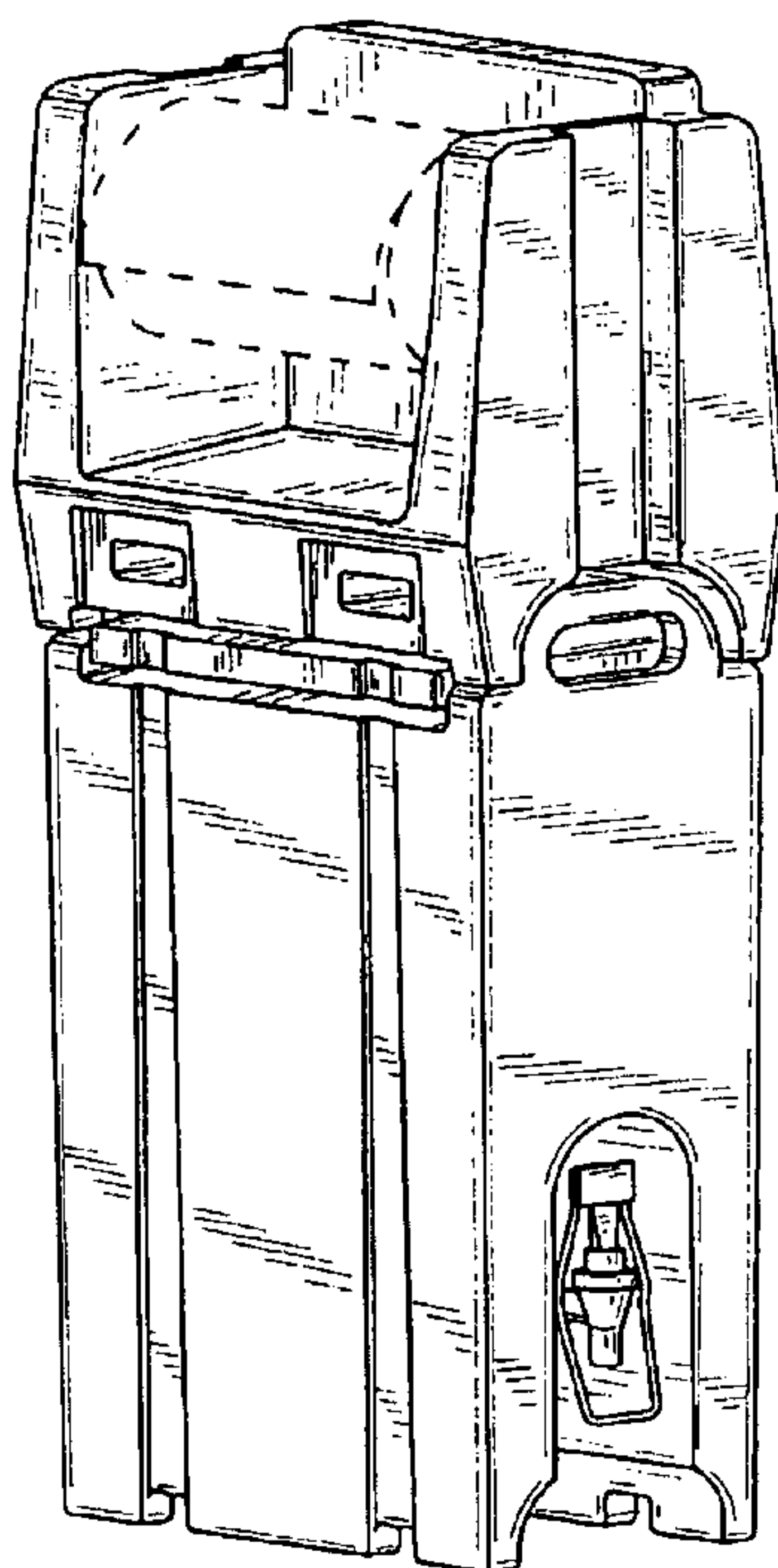
(57) **CLAIM**

I claim the paper towel roll holder and water dispenser, as substantially shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a paper towel roll holder and water dispenser showing my new design;
 FIG. 2 shows a front elevation thereof.
 FIG. 3 shows a right hand side elevation thereof.
 FIG. 4 shows a top plan view.
 FIG. 5 shows a left side elevation view thereof.
 FIG. 6 shows a rear elevation view thereof; and,
 FIG. 7 shows a bottom plan view.

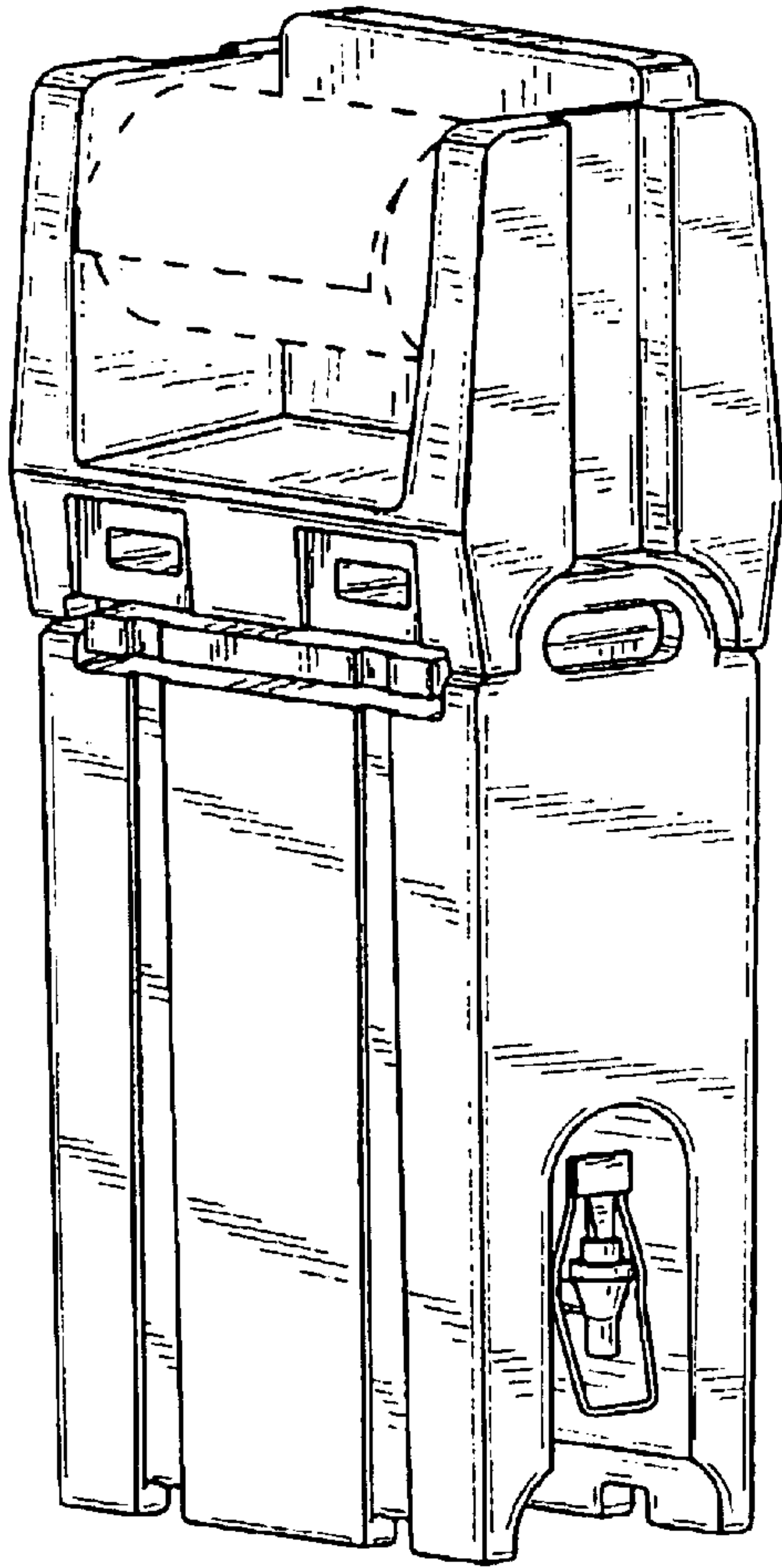

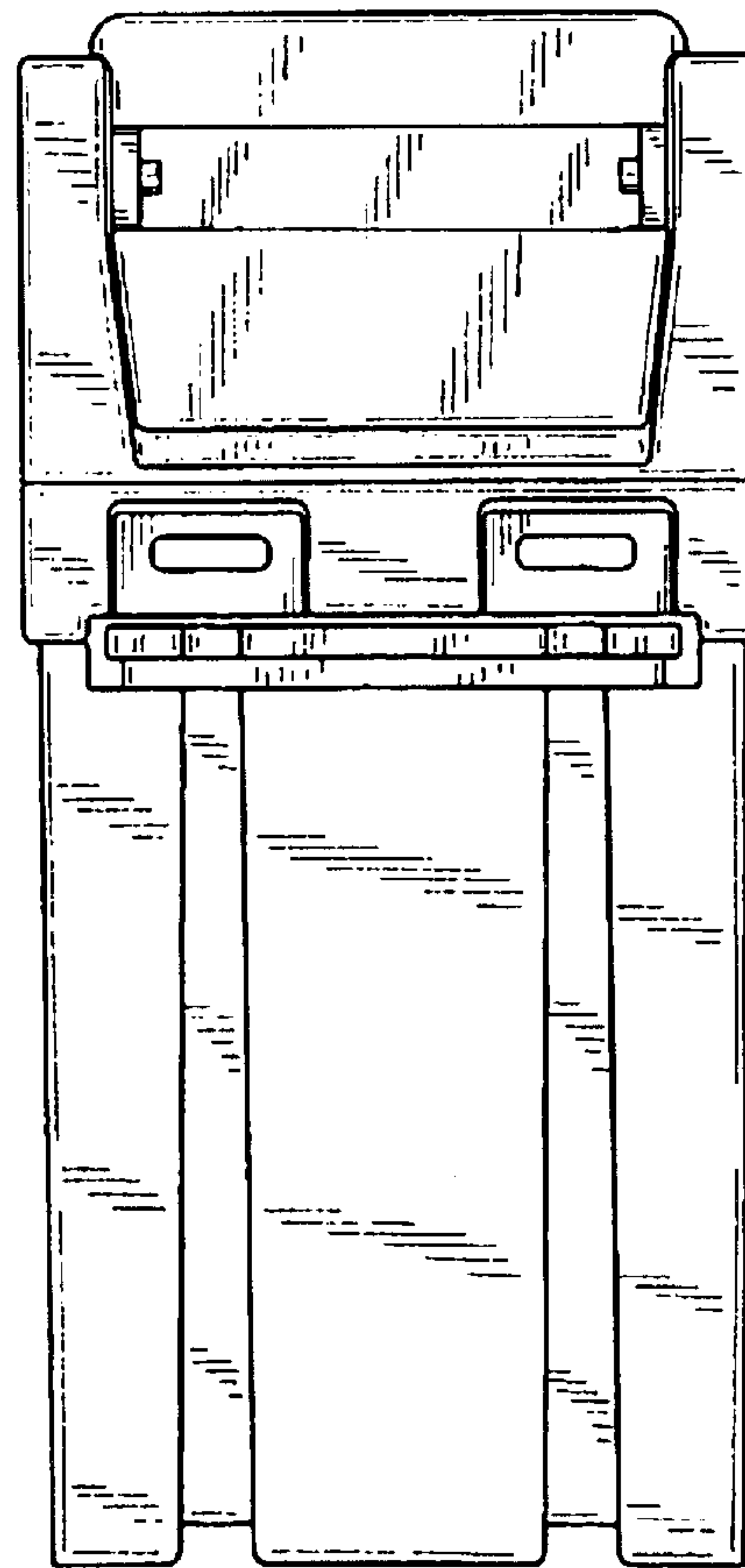

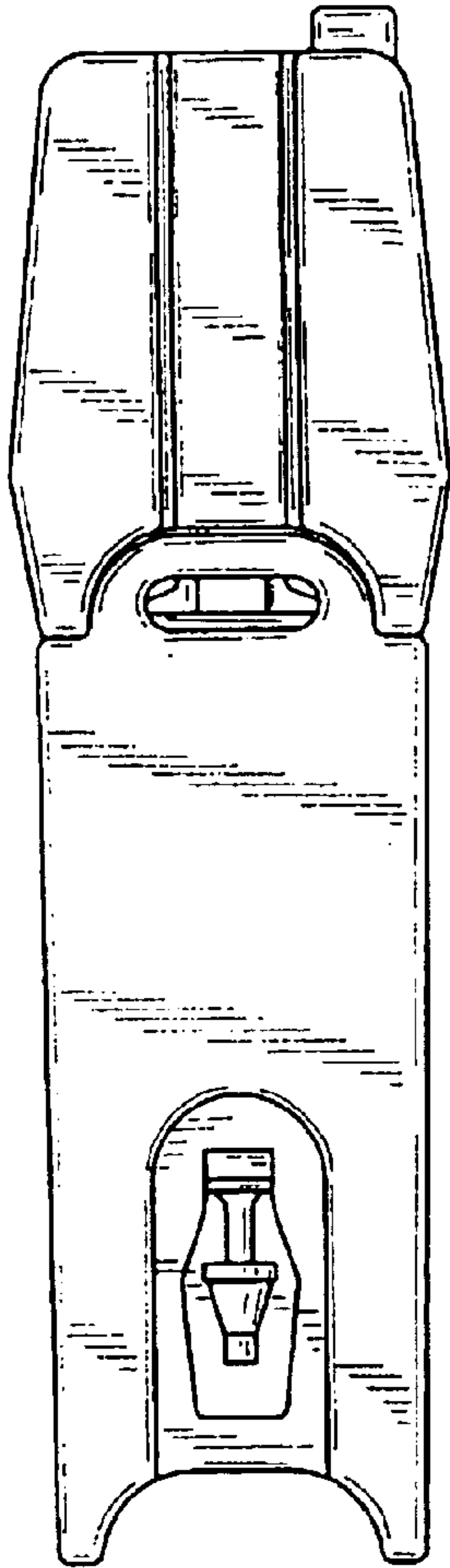

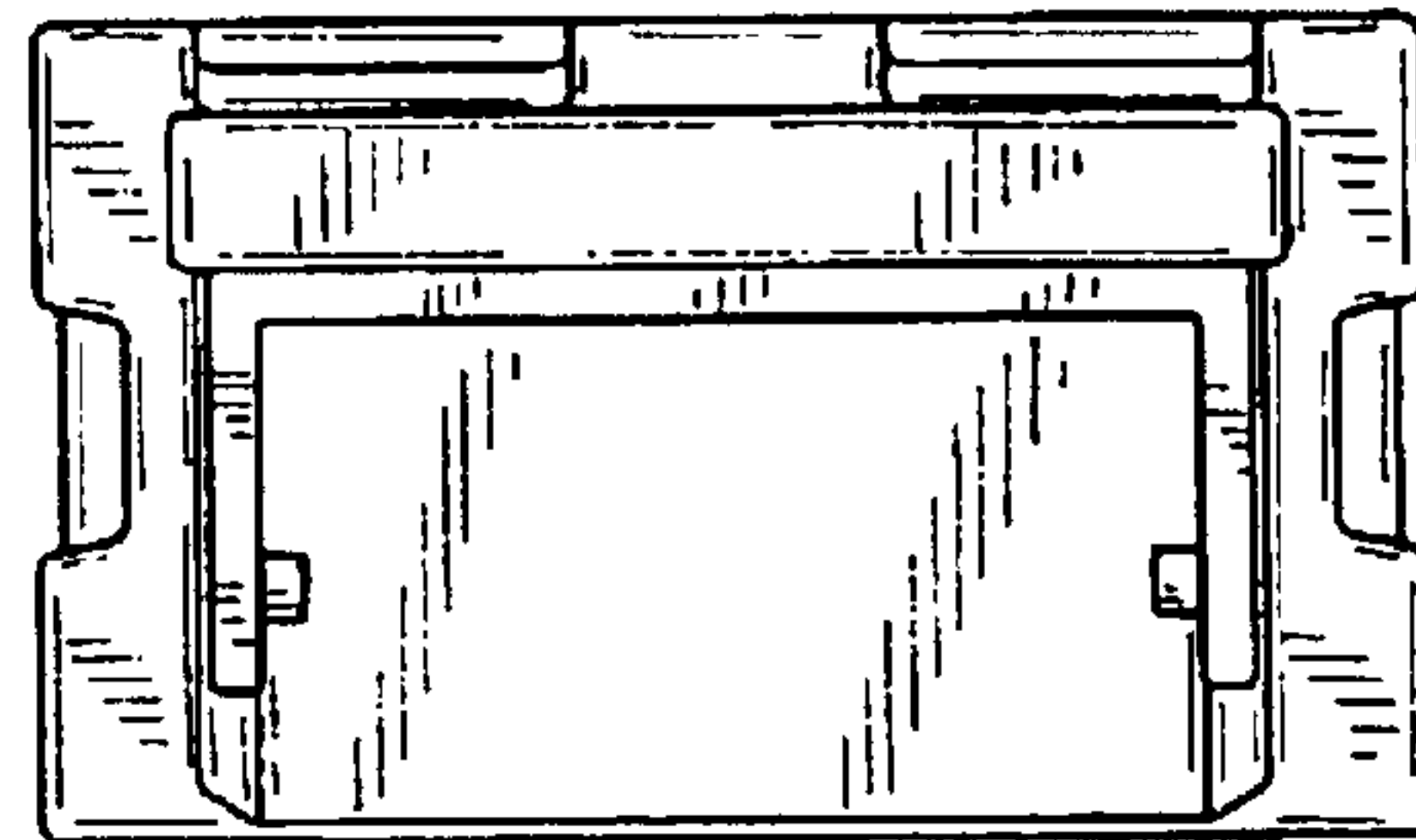

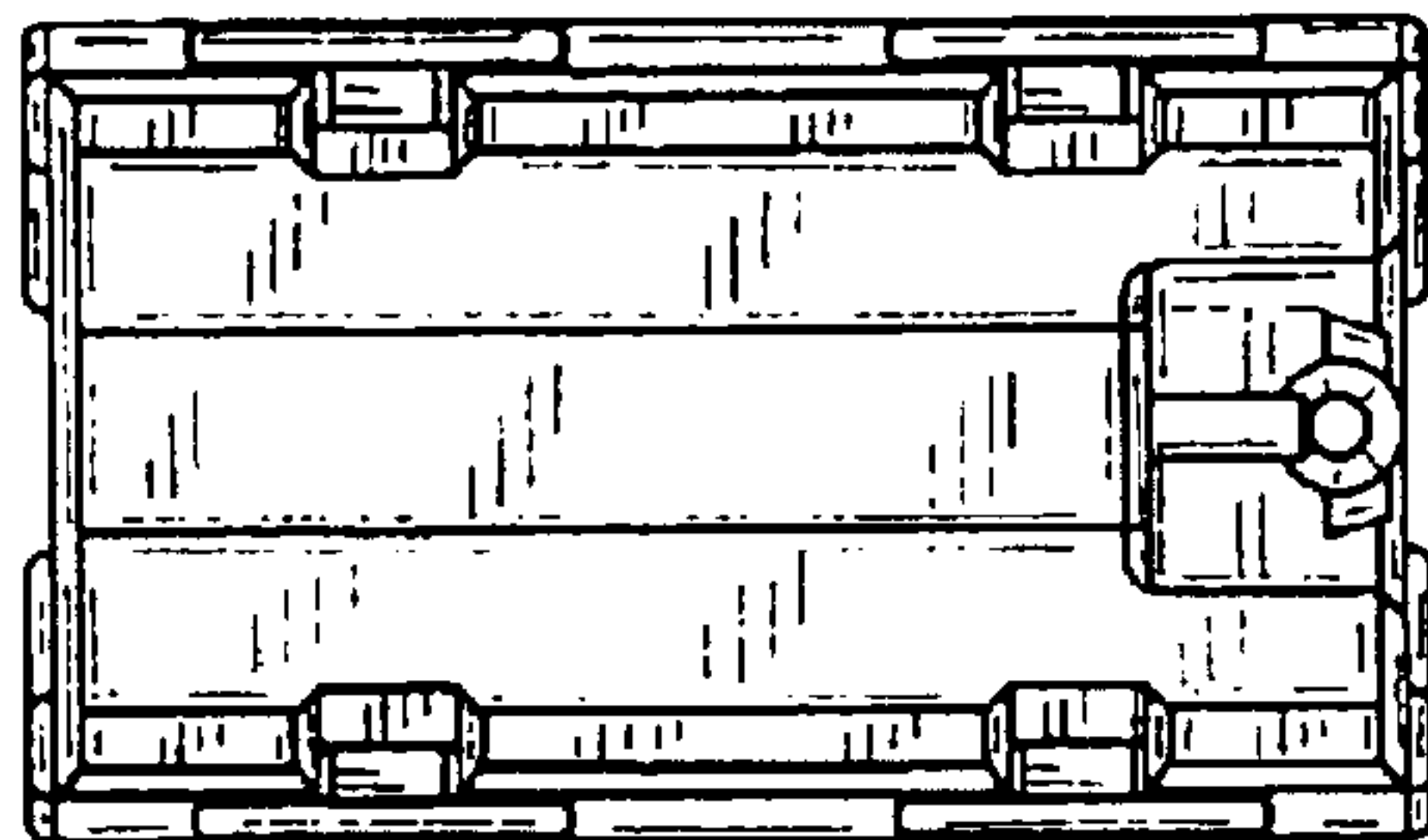

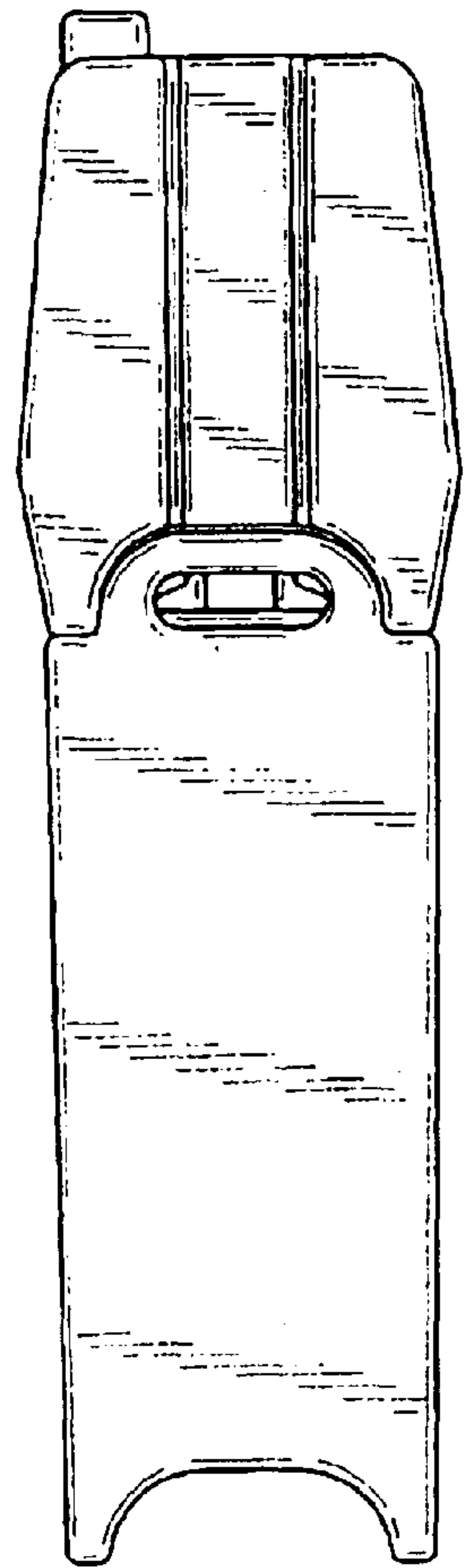

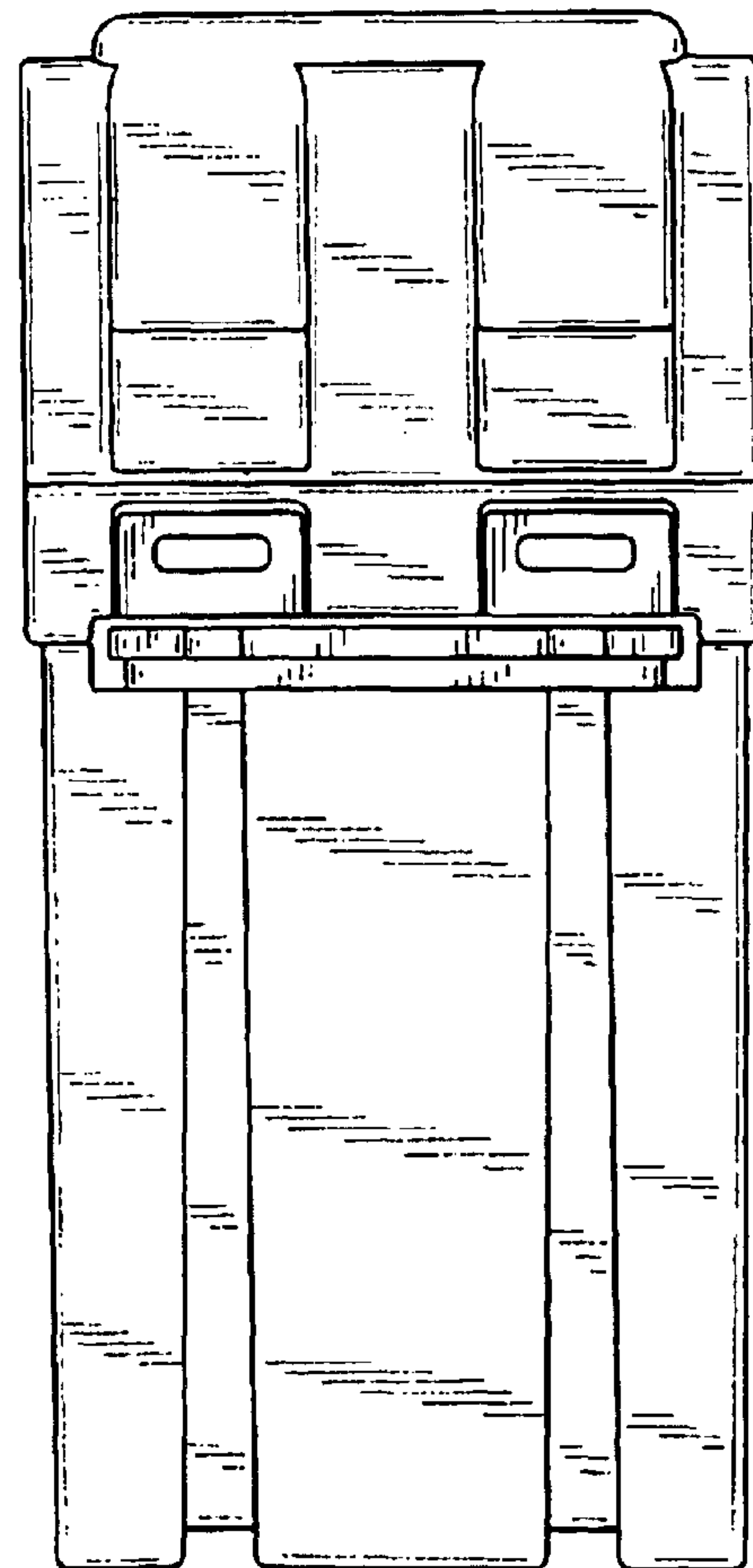
