The ornamental design for a glass, as shown.

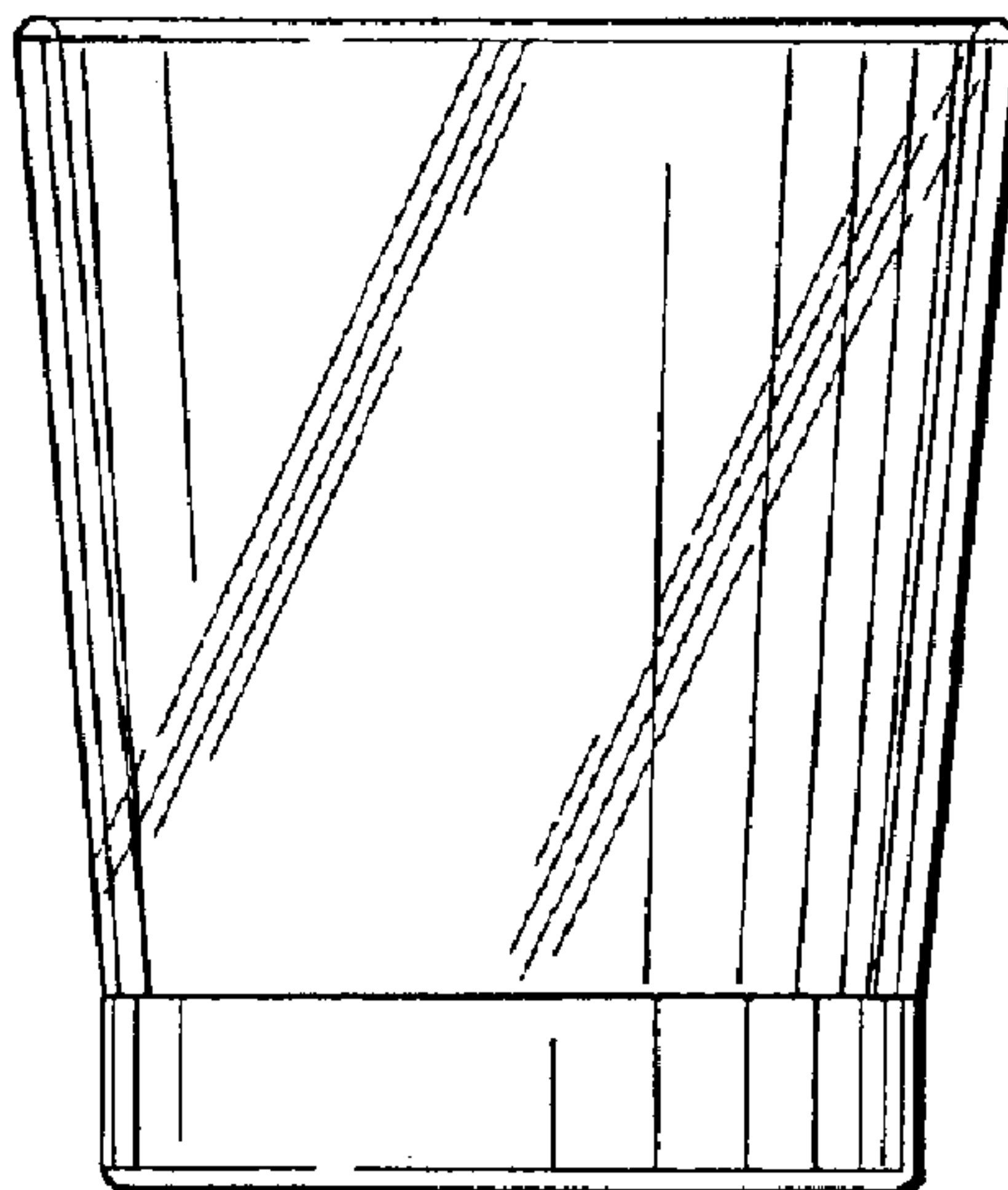
**DESCRIPTION**

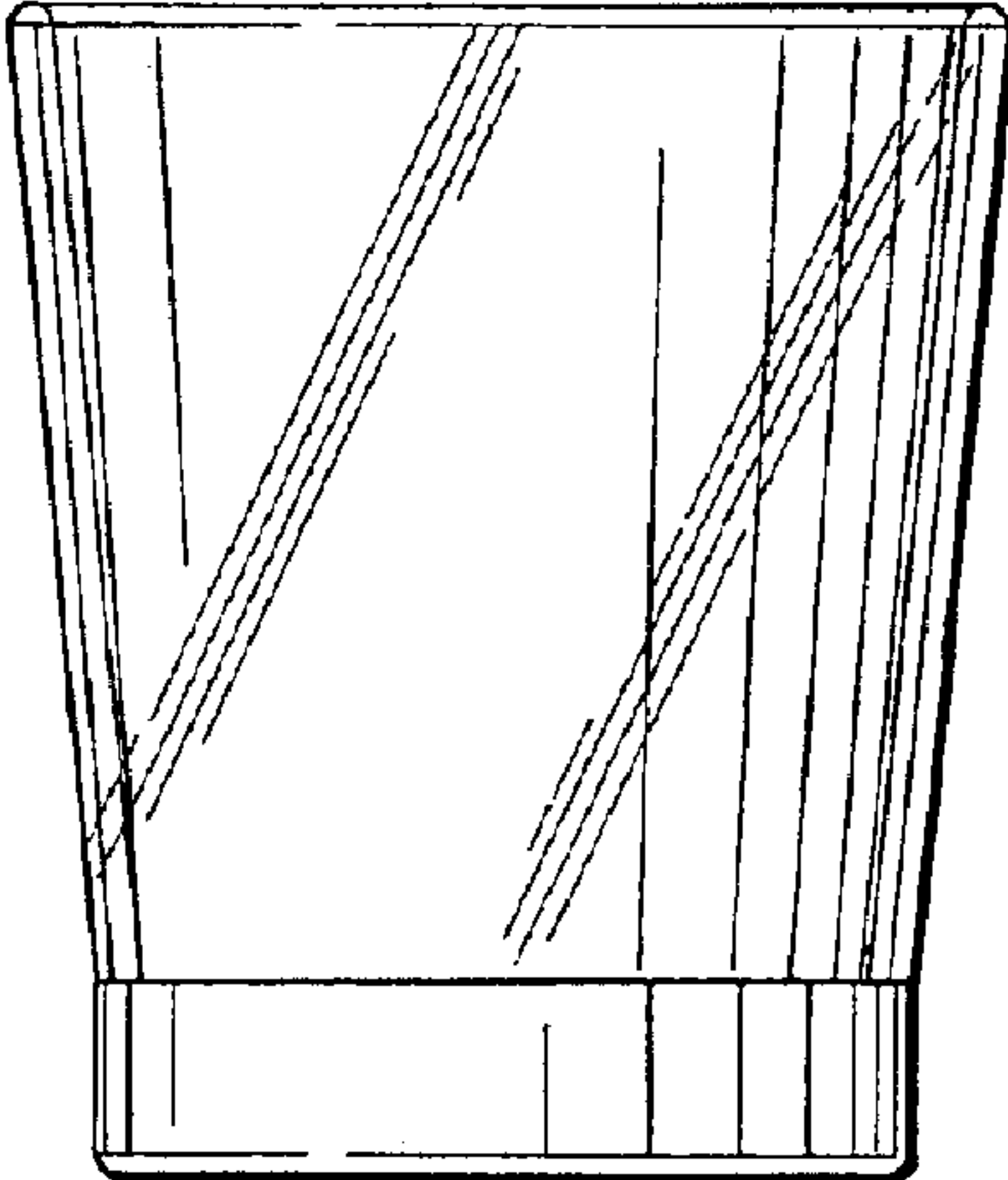
FIG. 1 is a side elevational view of a glass embodying our design.

FIG. 2 is a top plan view thereof; and,

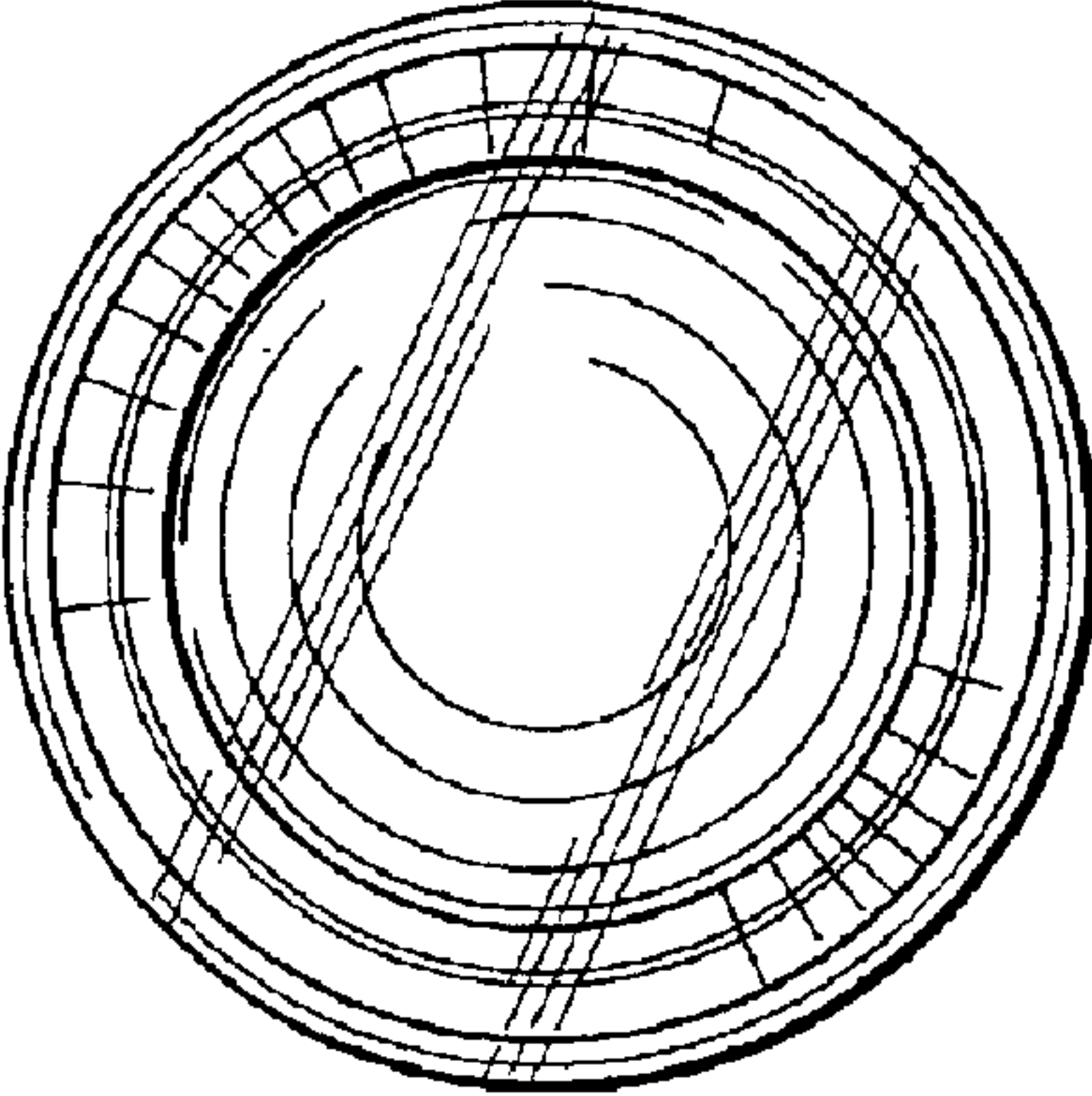
FIG. 3 is a bottom plan view thereof.

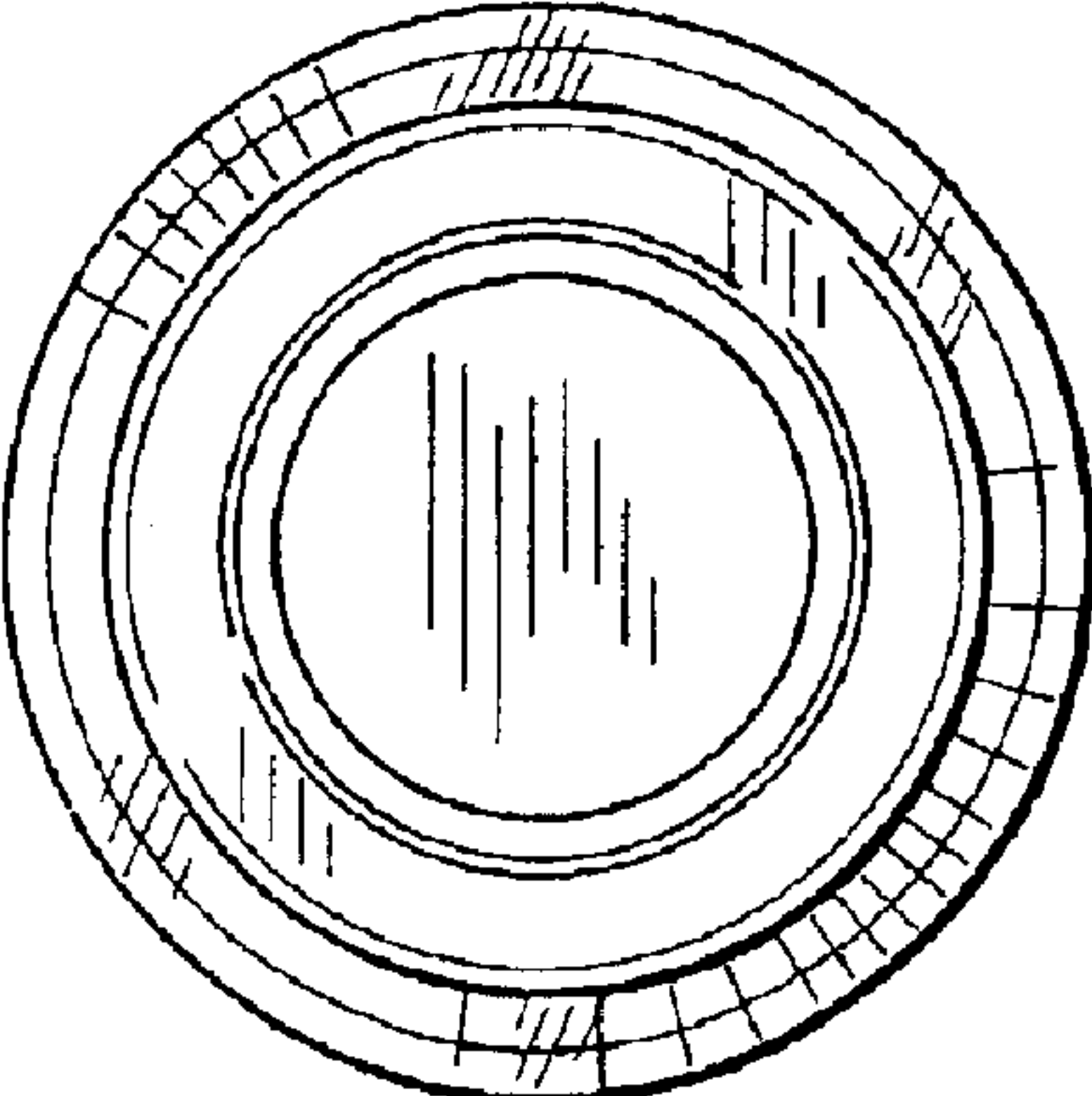
