**DESCRIPTION**

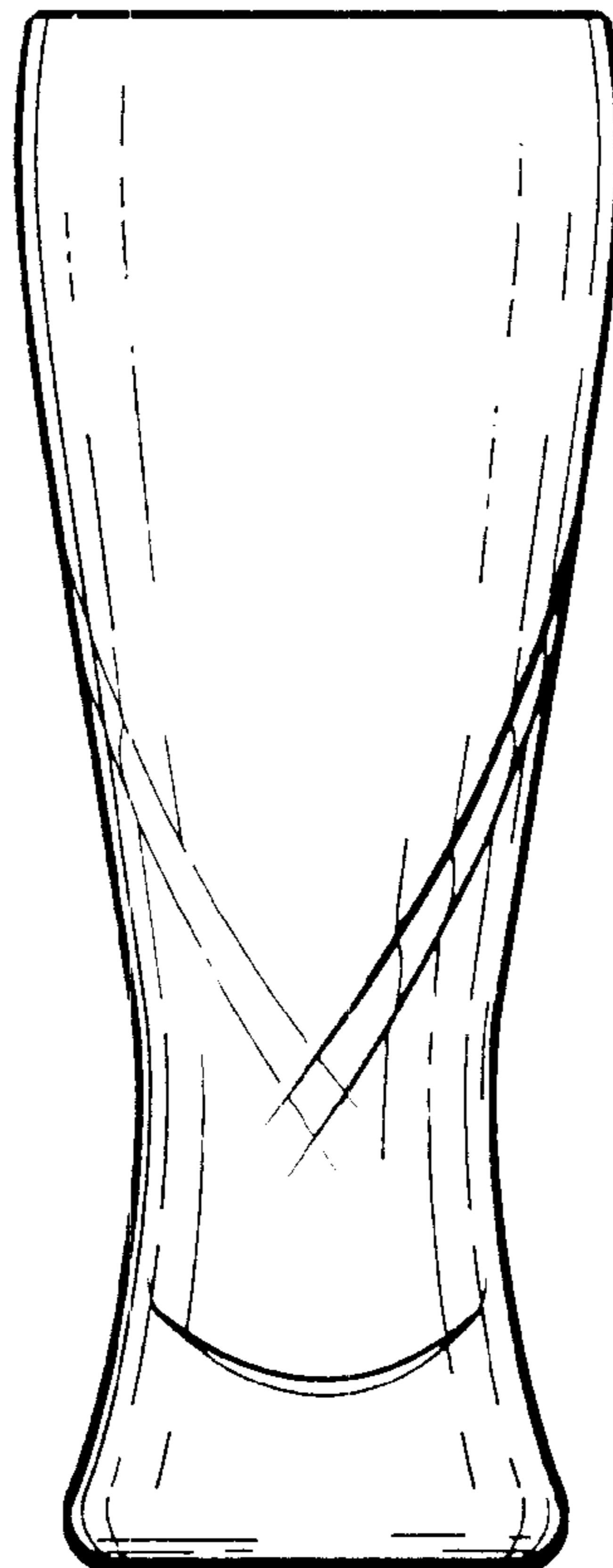
FIG. 1 is a front elevational view of a drinking vessel showing our new design;

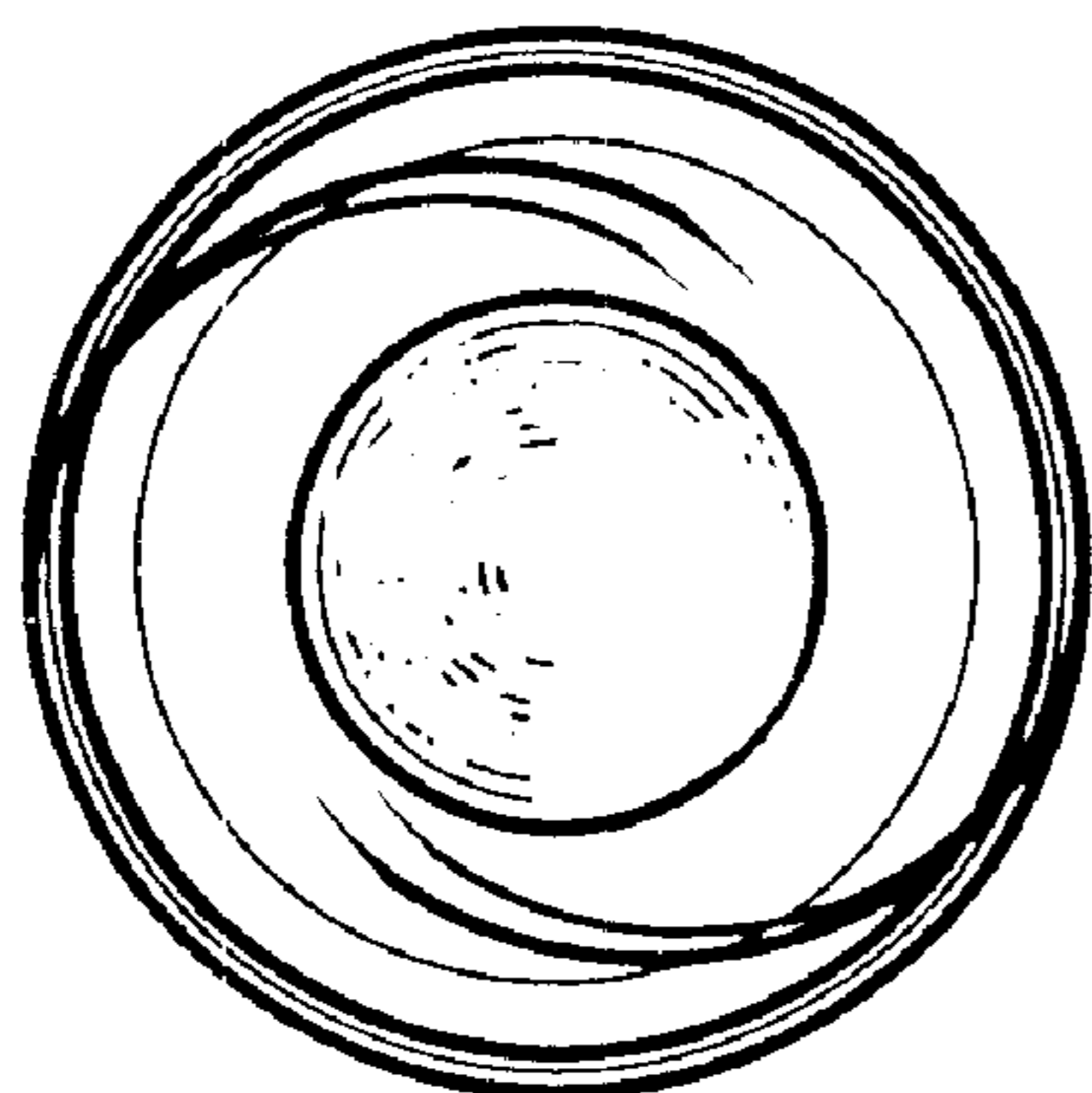

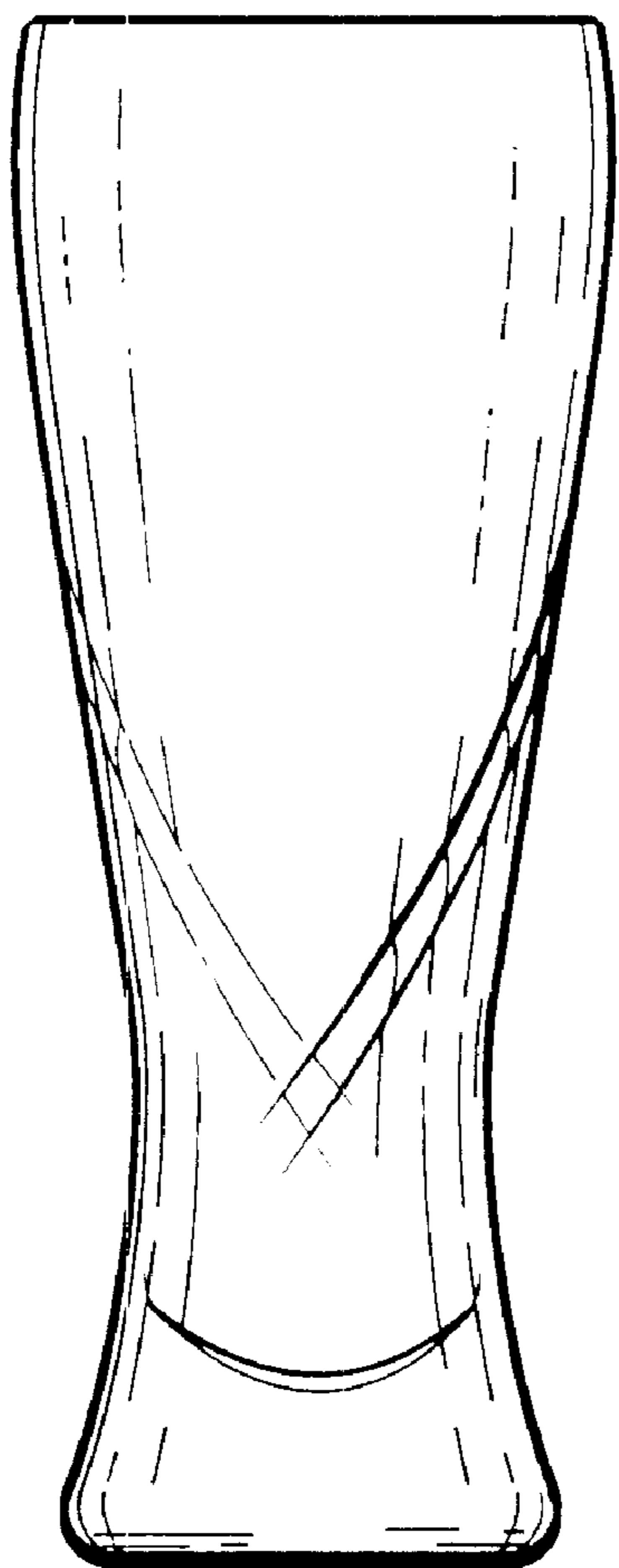

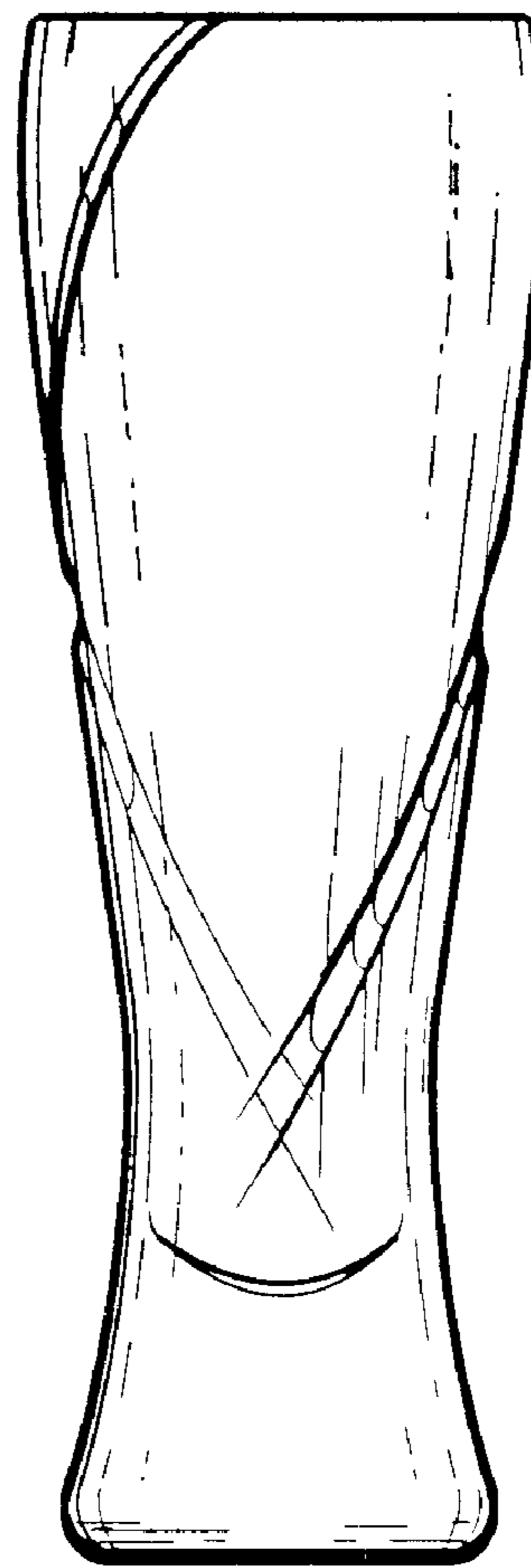
