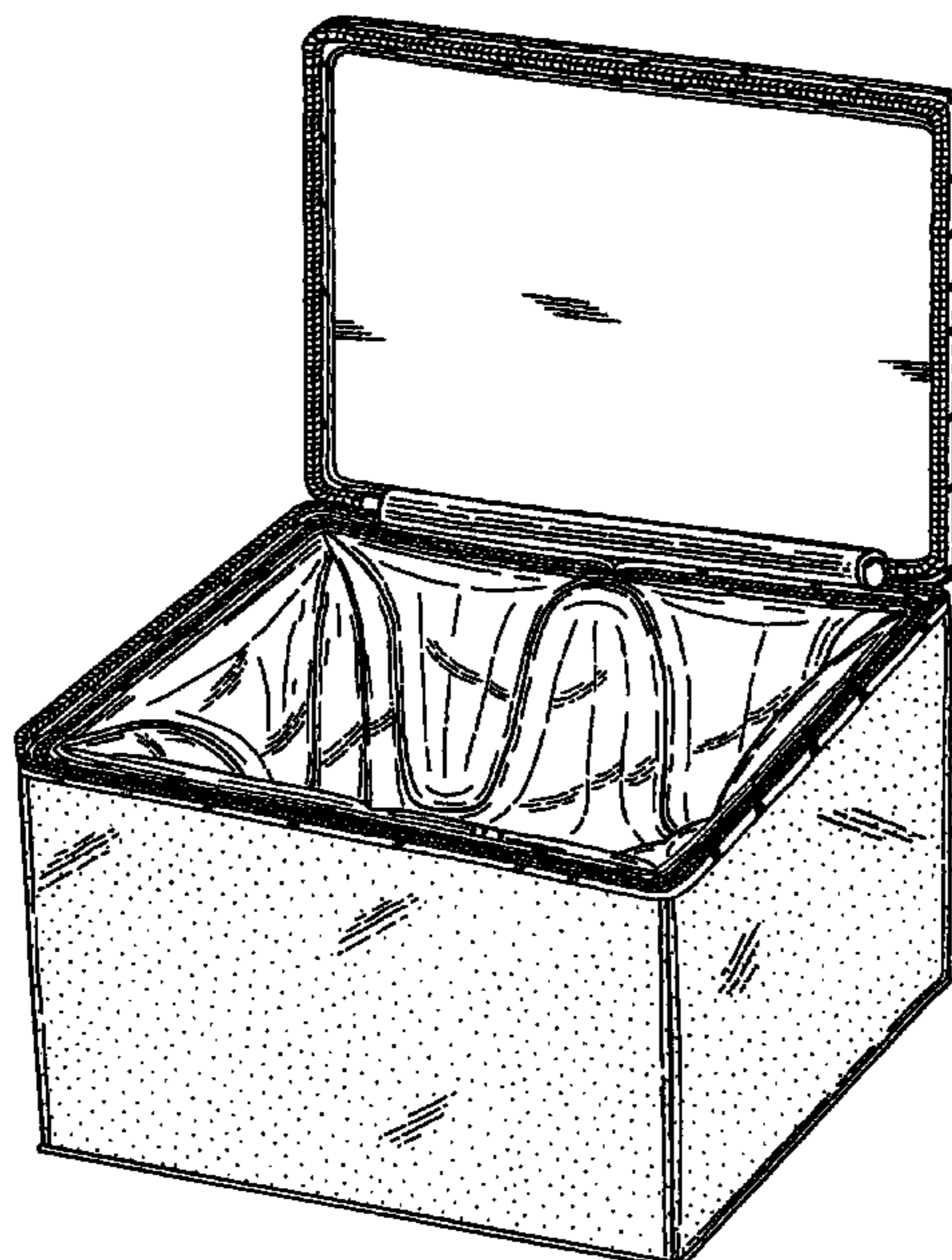
(57) **CLAIM**

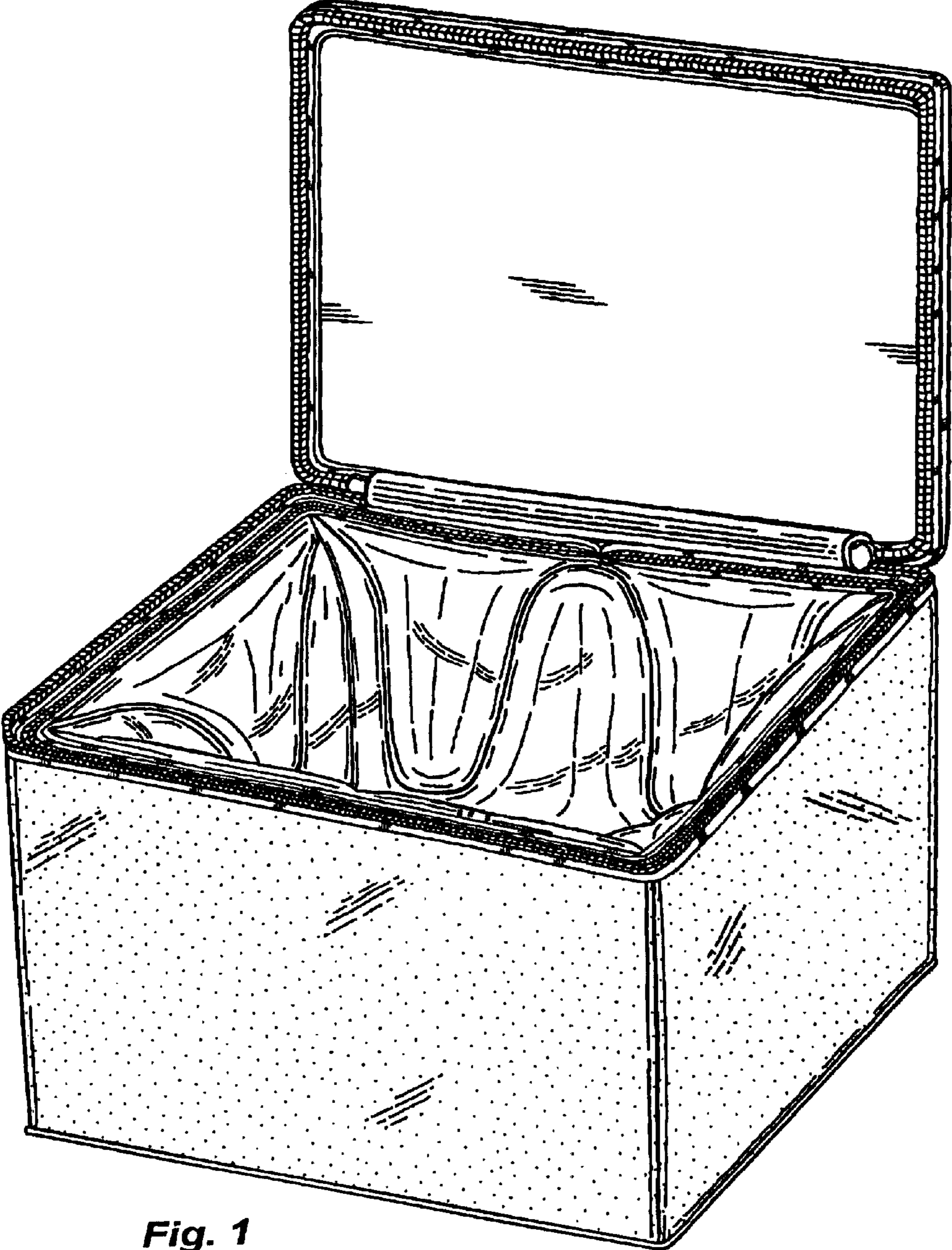
The ornamental design for a cooler, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front isometric view of the cooler showing our new design, the stipple shading on the exterior is to show a contrasting material from what is shown in the interior;

 FIG. 4 is a left-side view thereof;

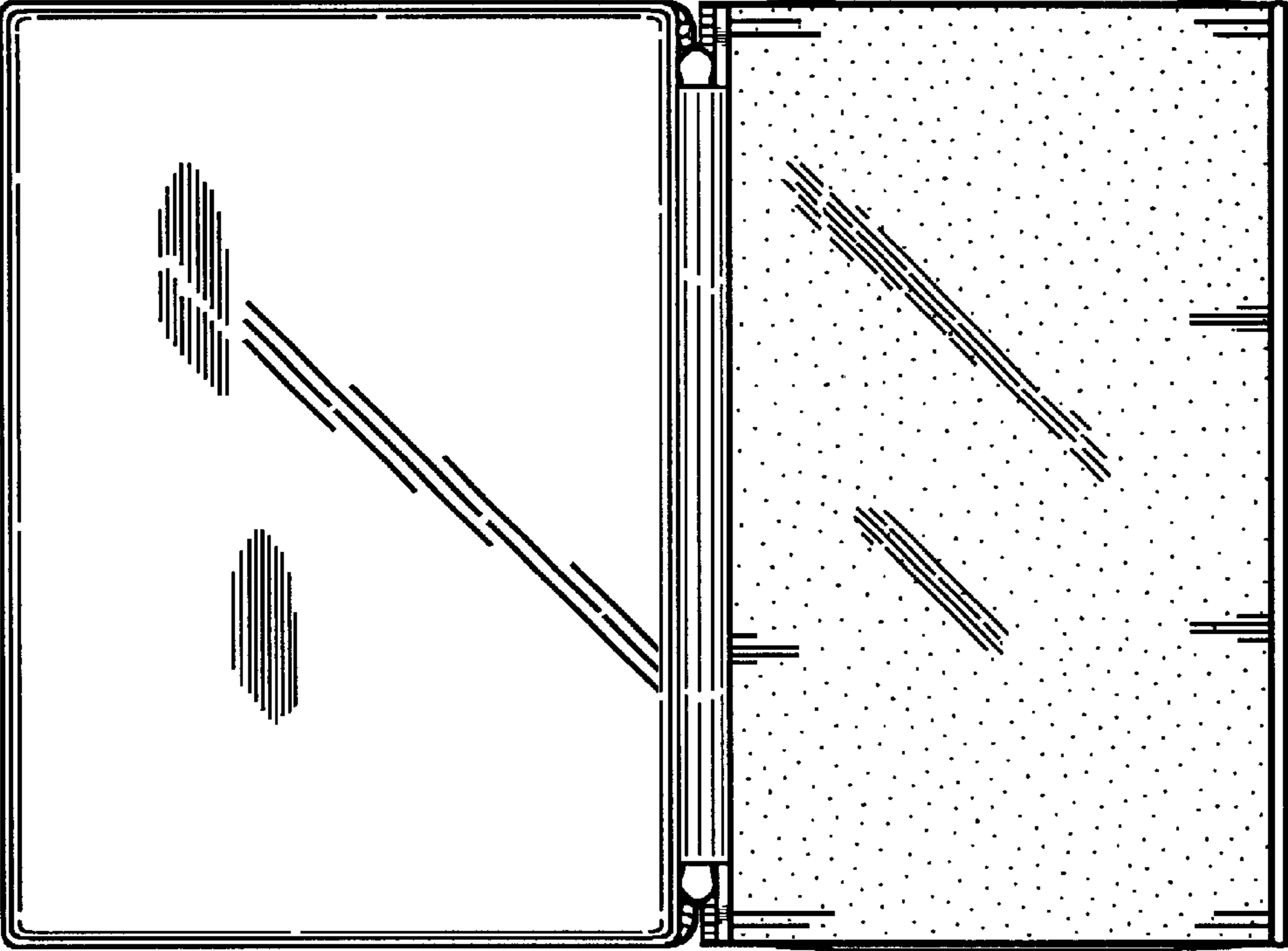

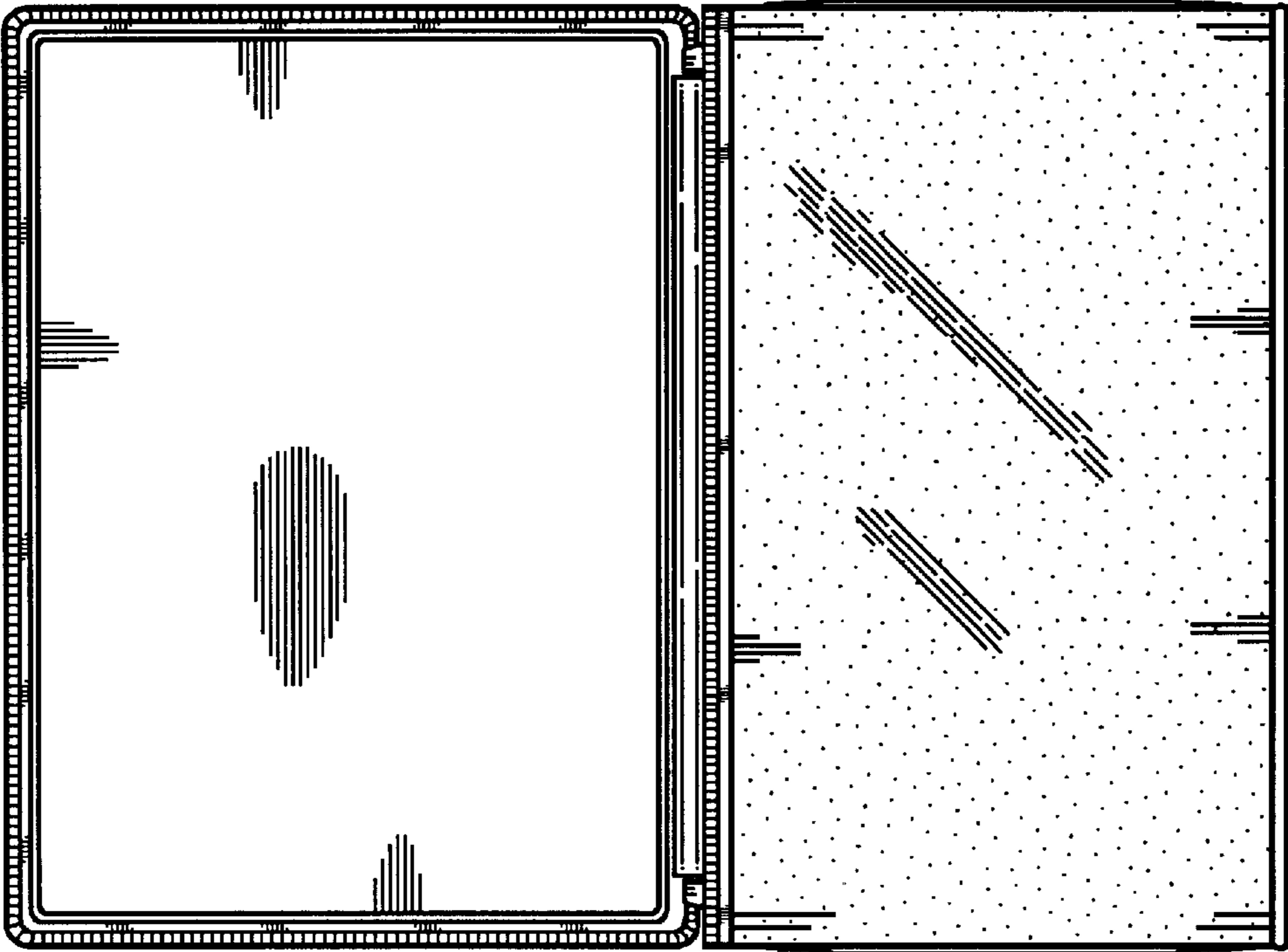

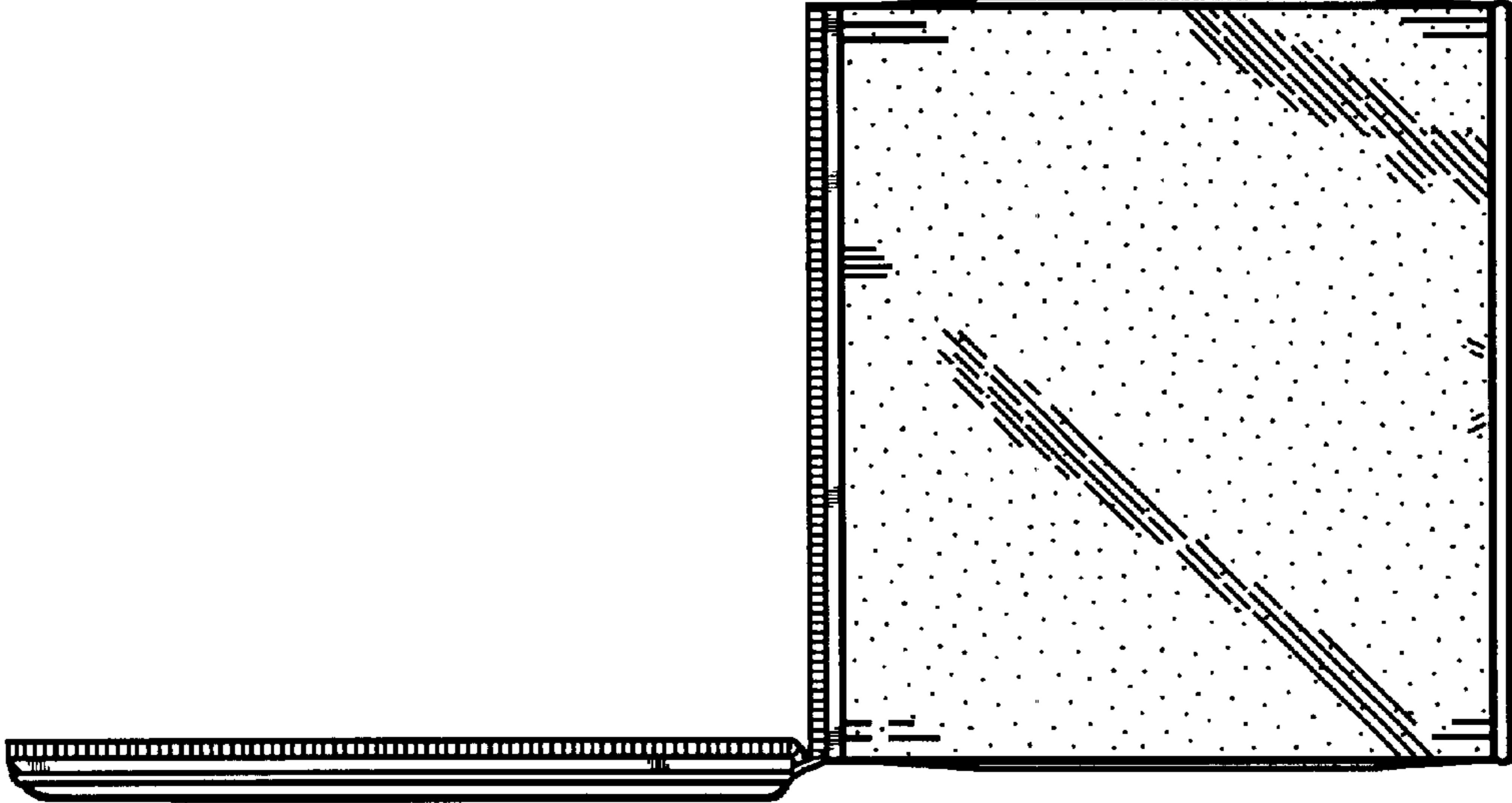

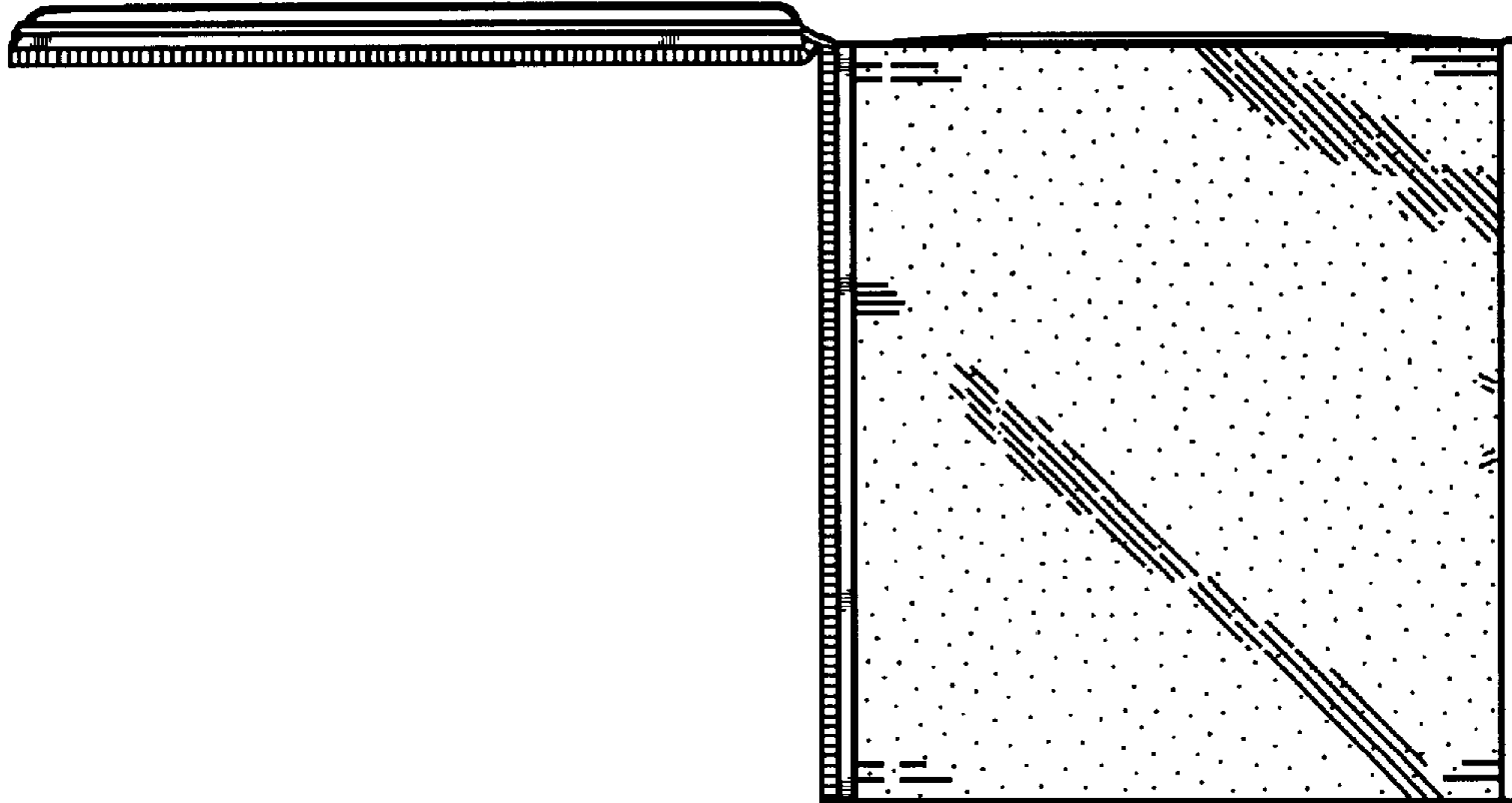
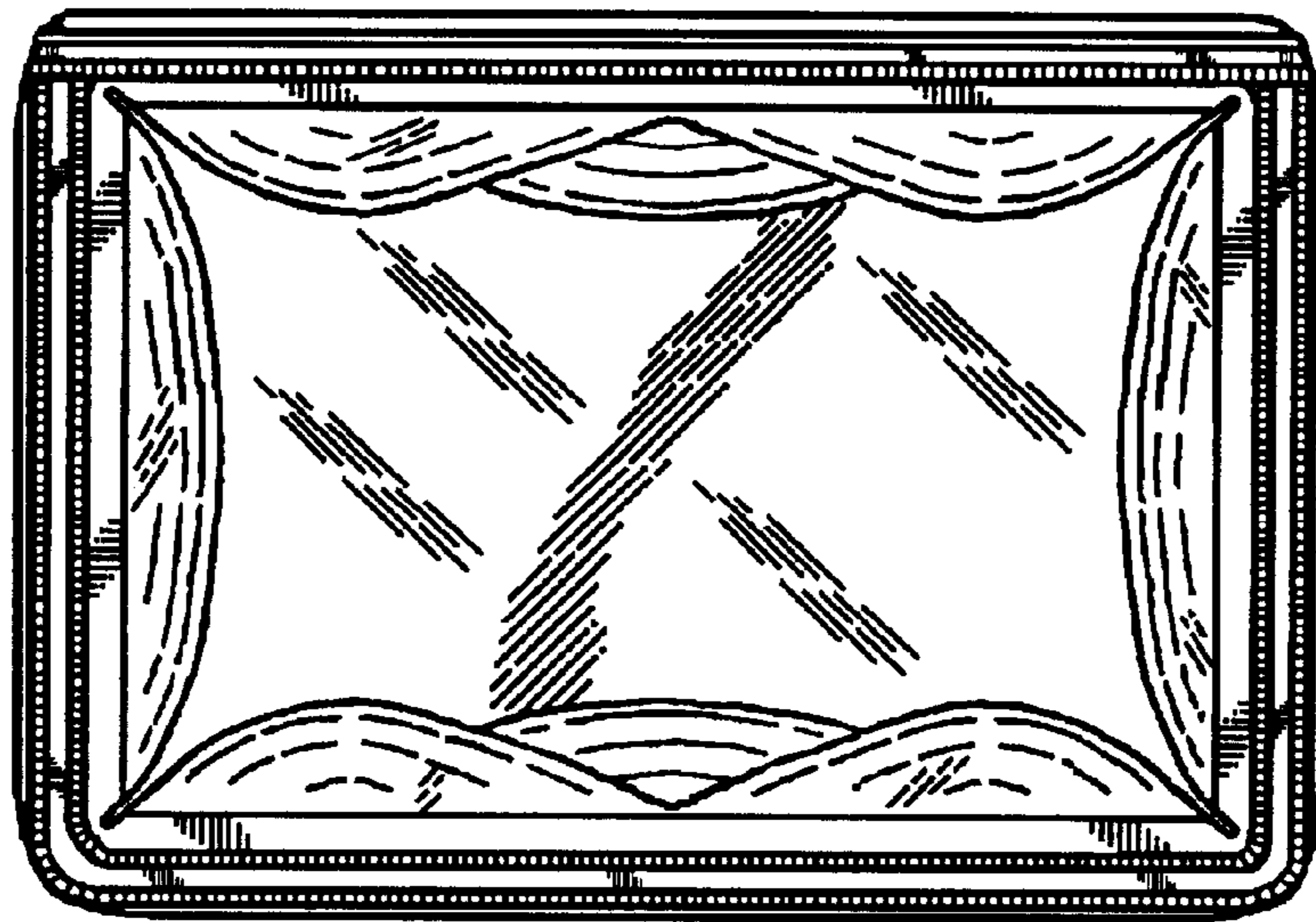
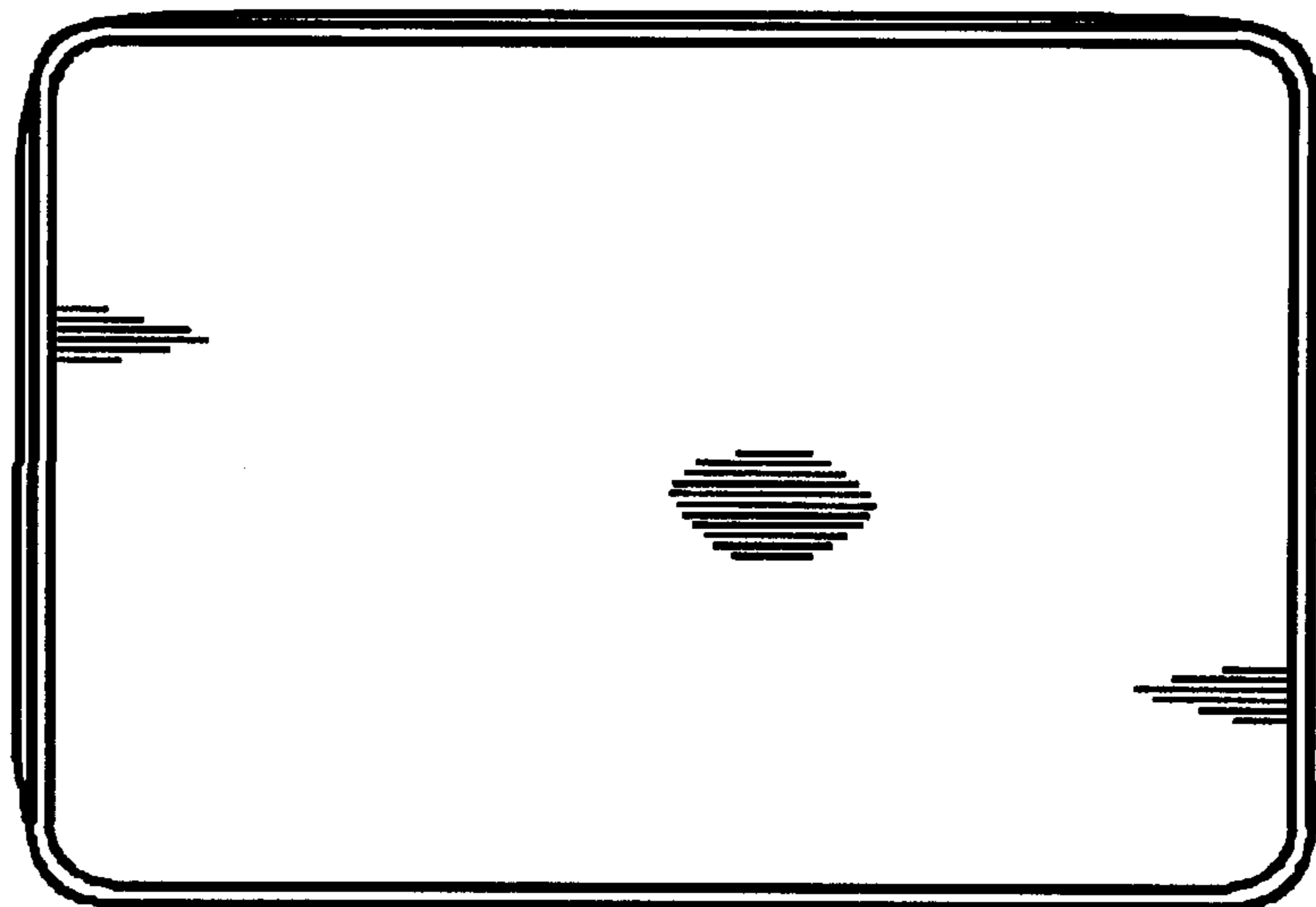
