FIG. 1 is a perspective view of a doorknob of the subject design;

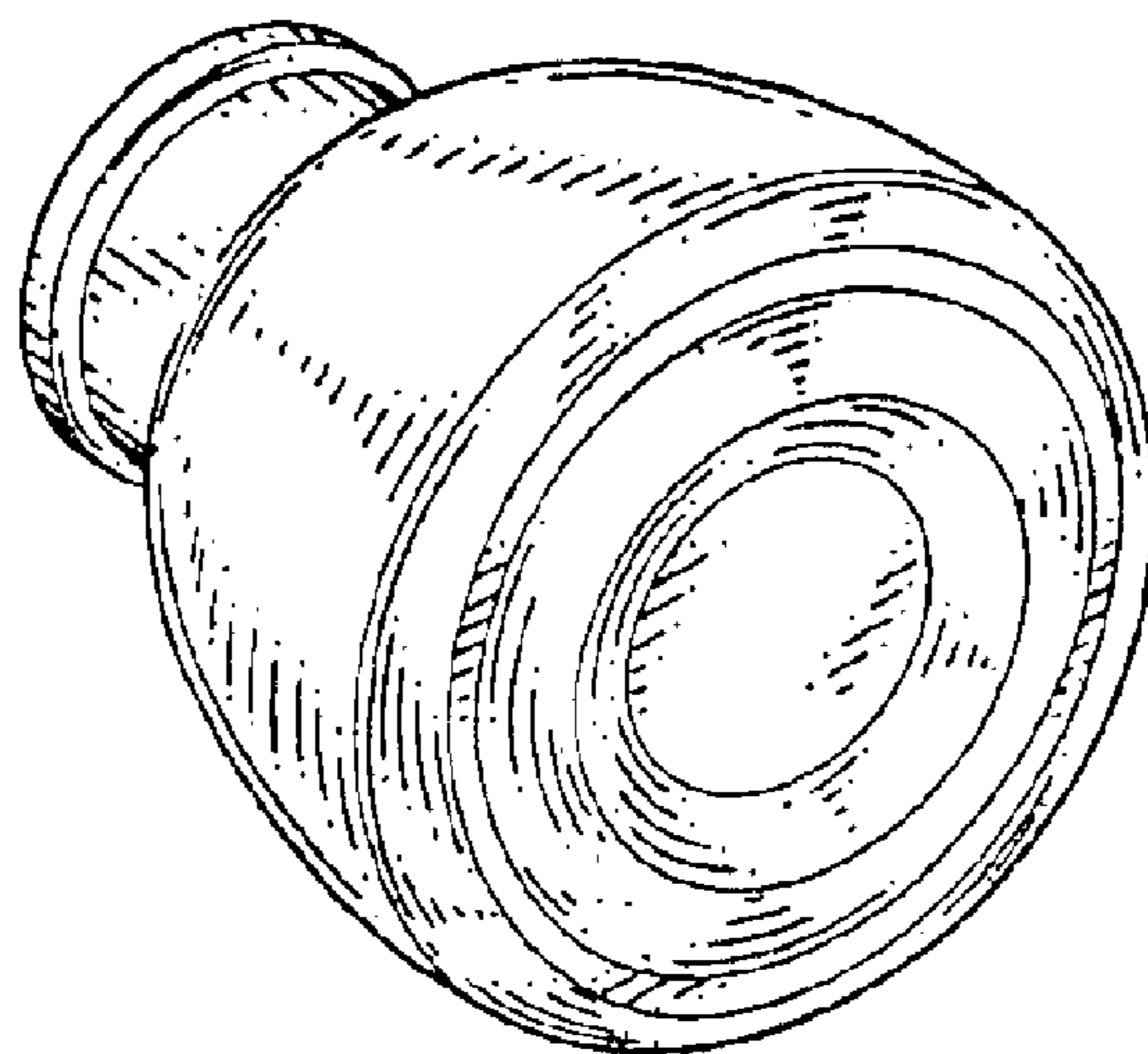
FIG. 2 is a front elevational view thereof;

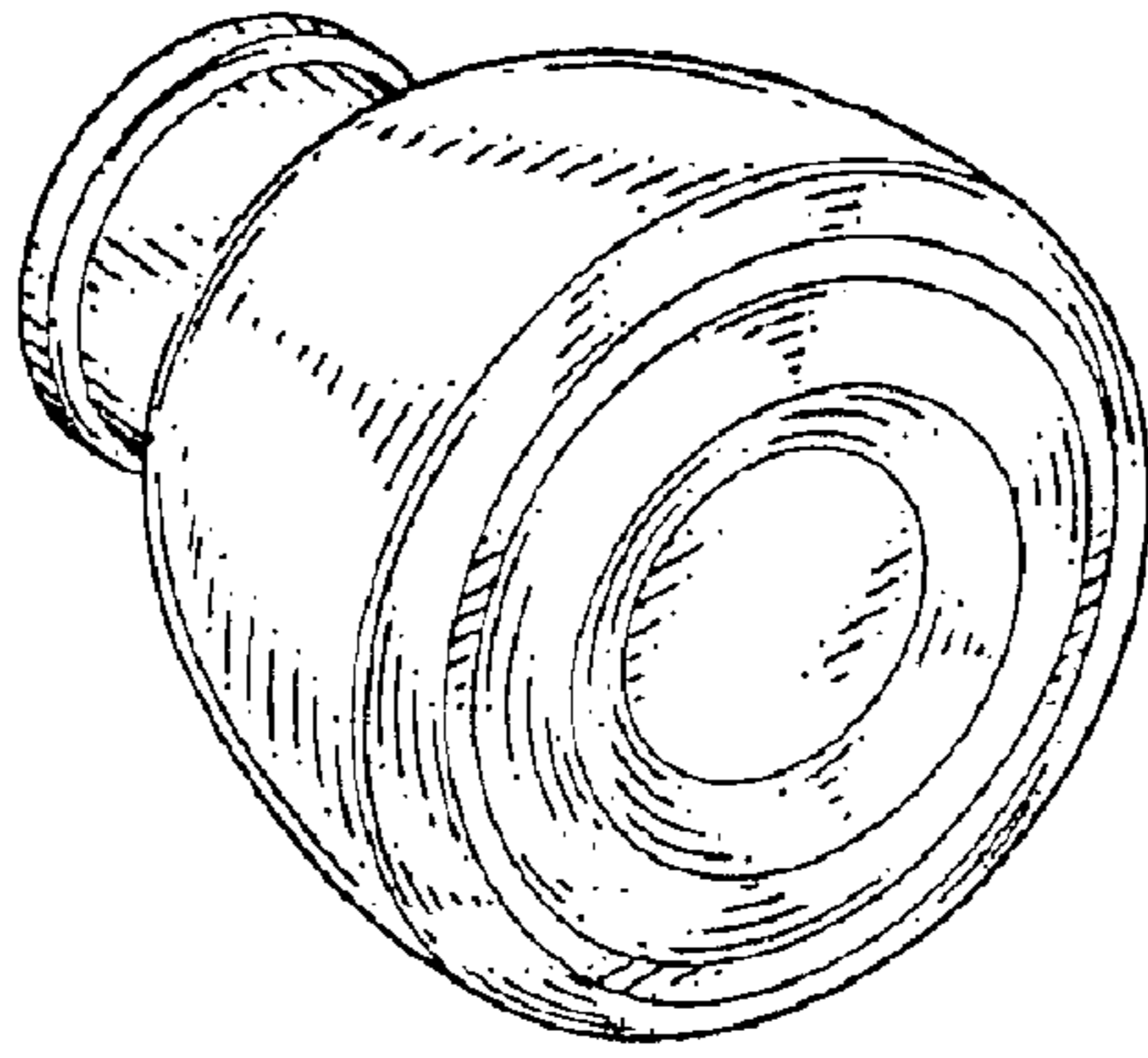

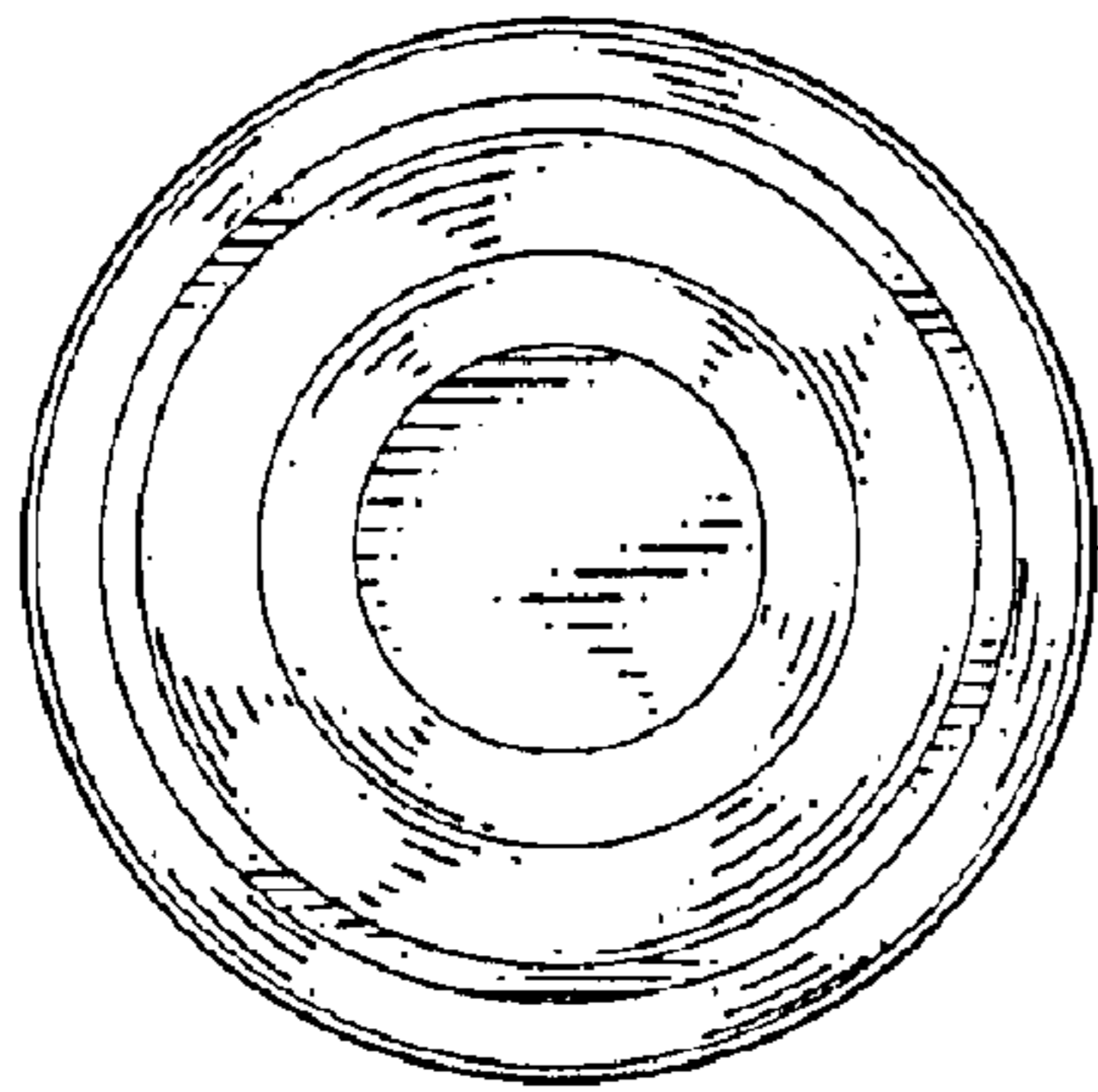

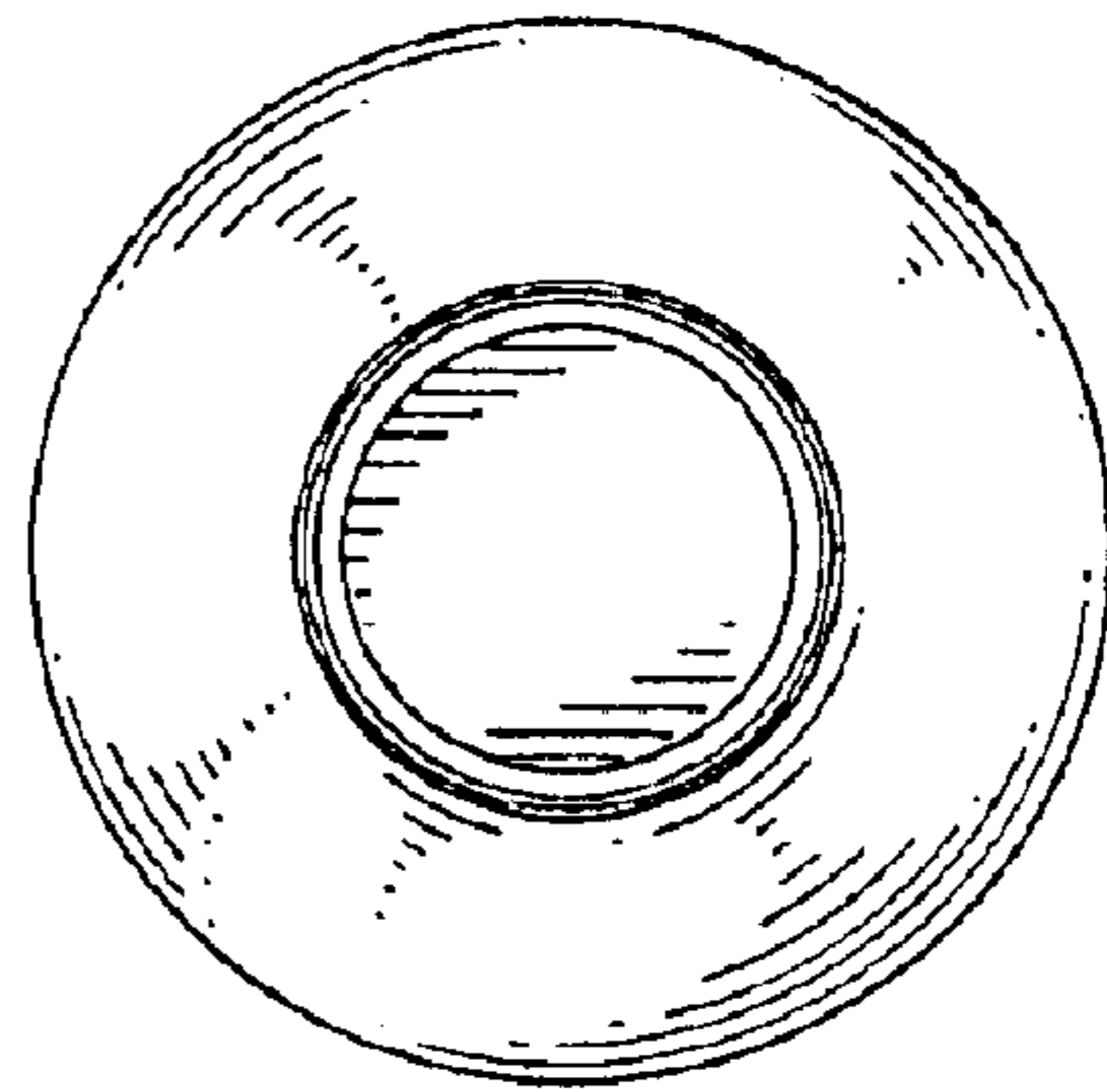

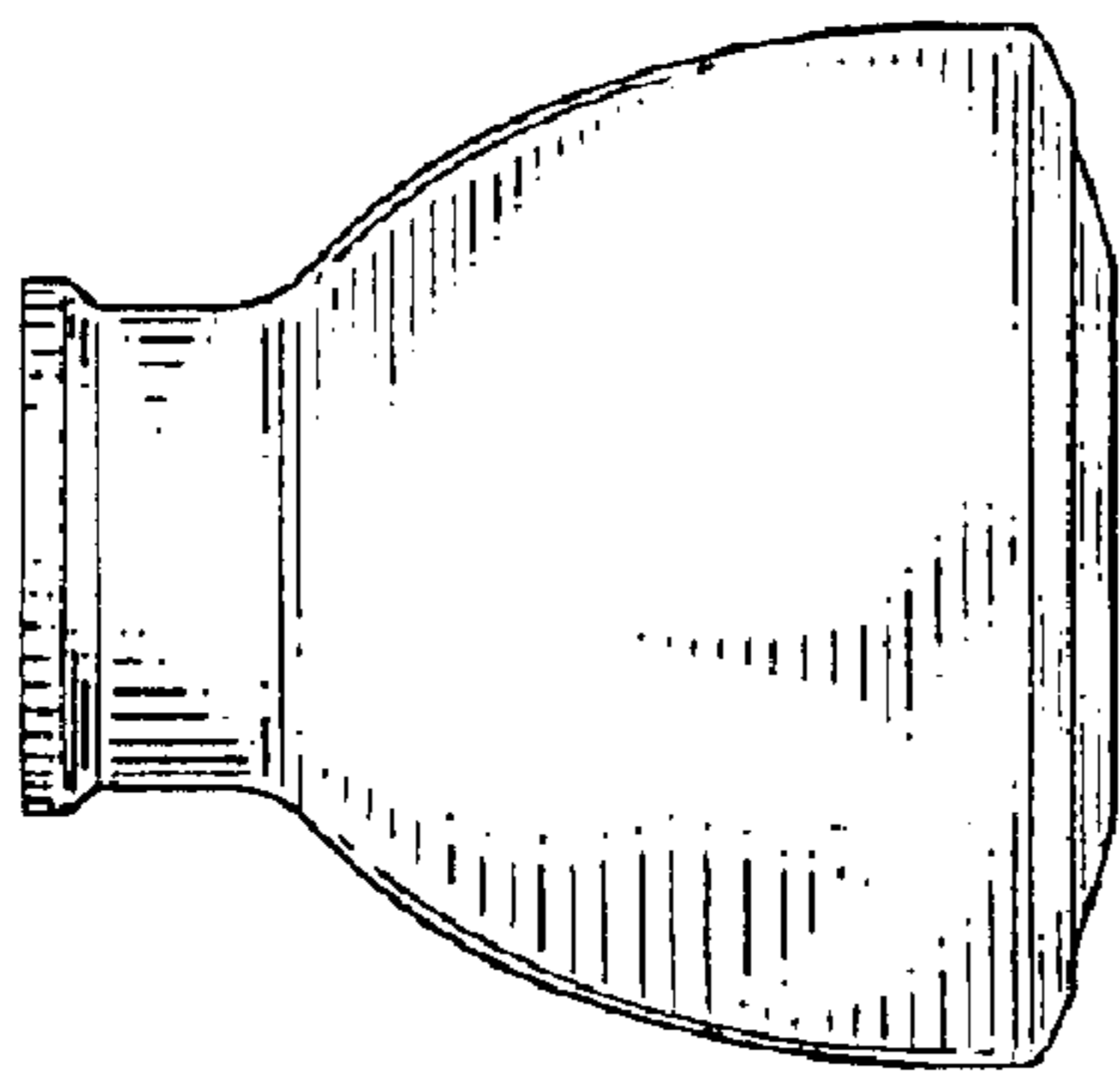
