(57) **CLAIM**

We claim the ornamental design for a tooth-shaped bottle cap, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a tooth-shaped bottle cap.

FIG. 2 is a top plan view of the bottle cap.

FIG. 3 is a front elevational view of the bottle cap.

FIG. 4 is a 45° side elevational view of the bottle cap; and,

FIG. 5 is a bottom plan view of the bottle cap.

The ornamental design which is claimed is shown in solid lines in the drawings. The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design.

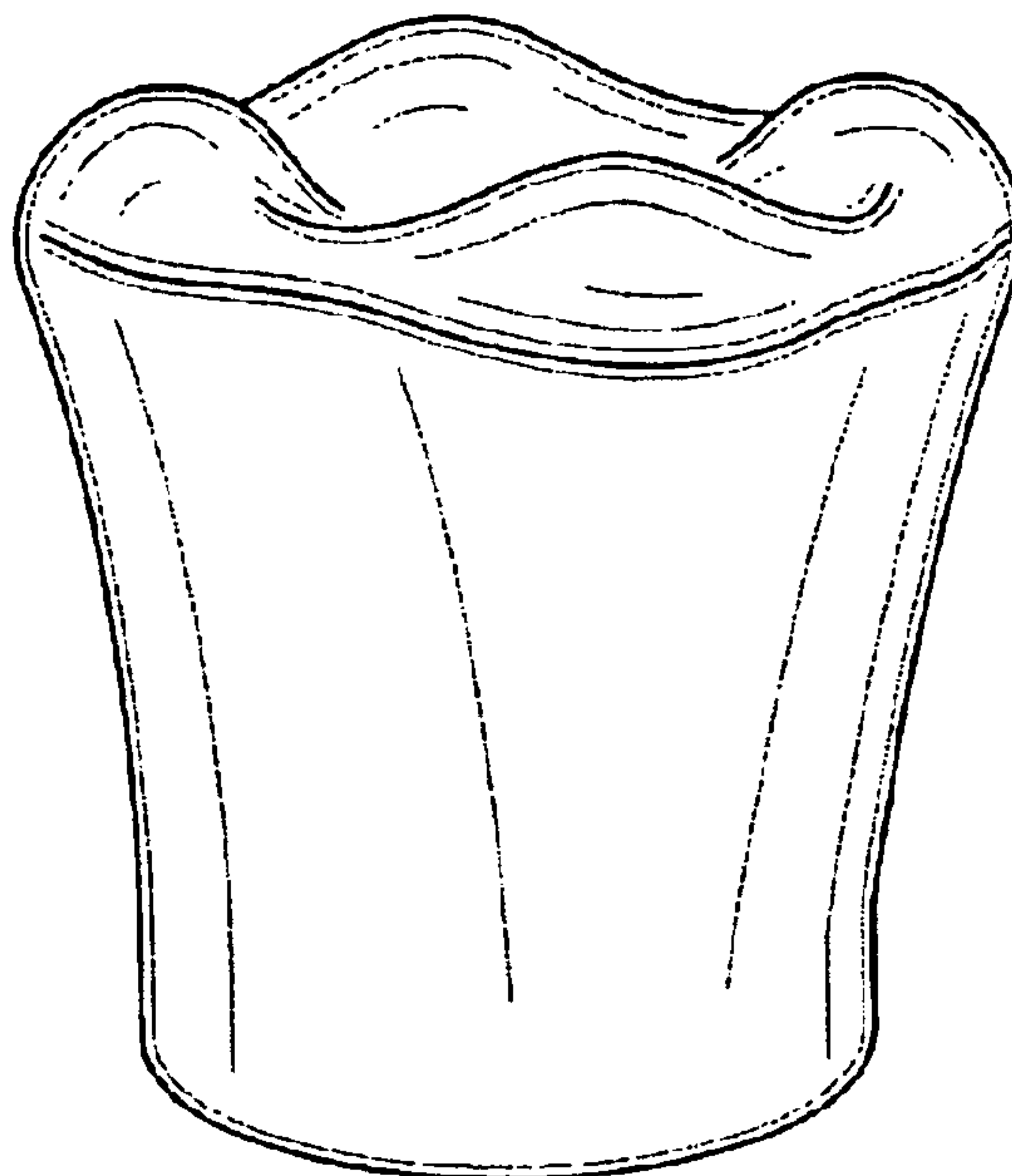

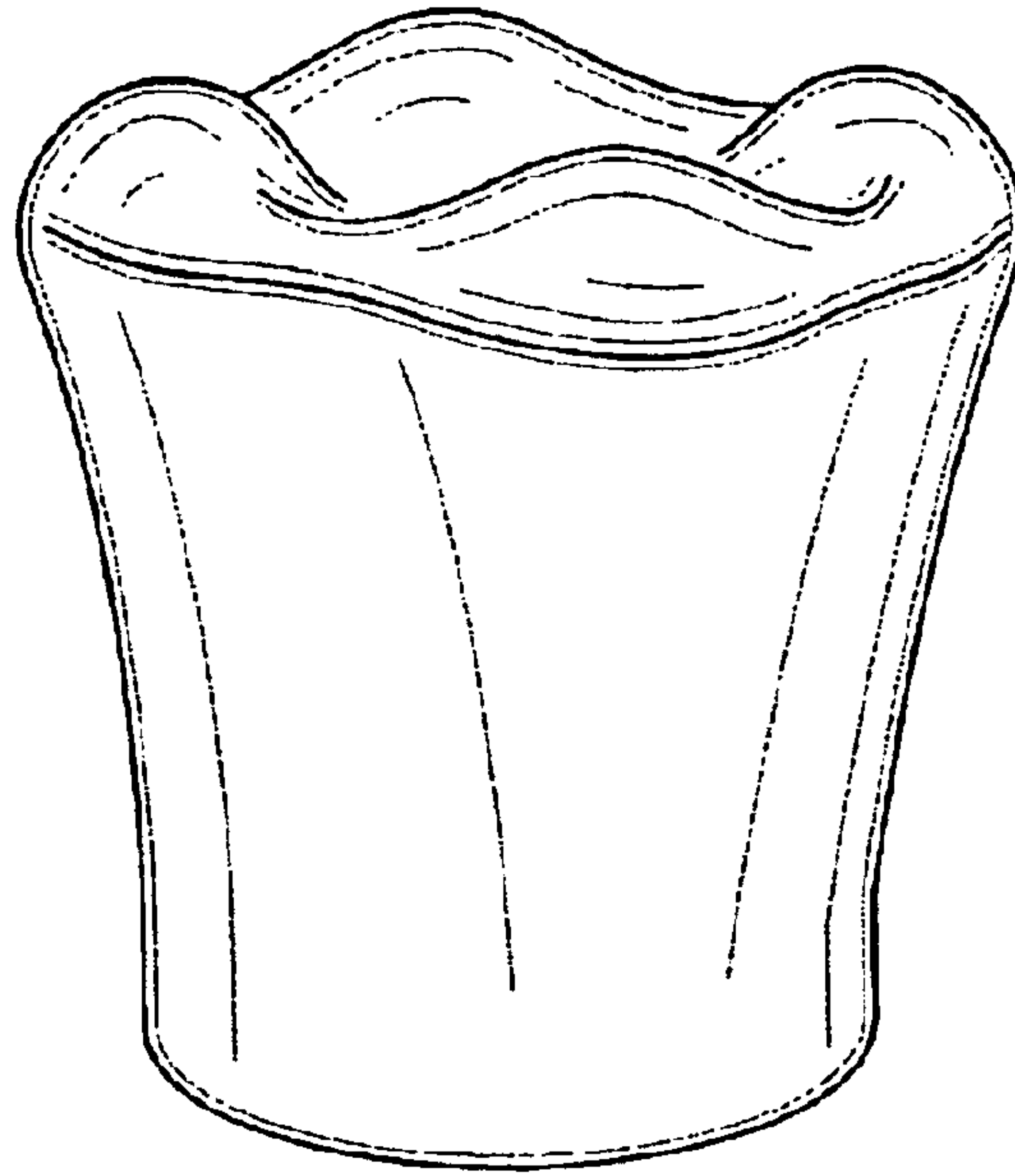

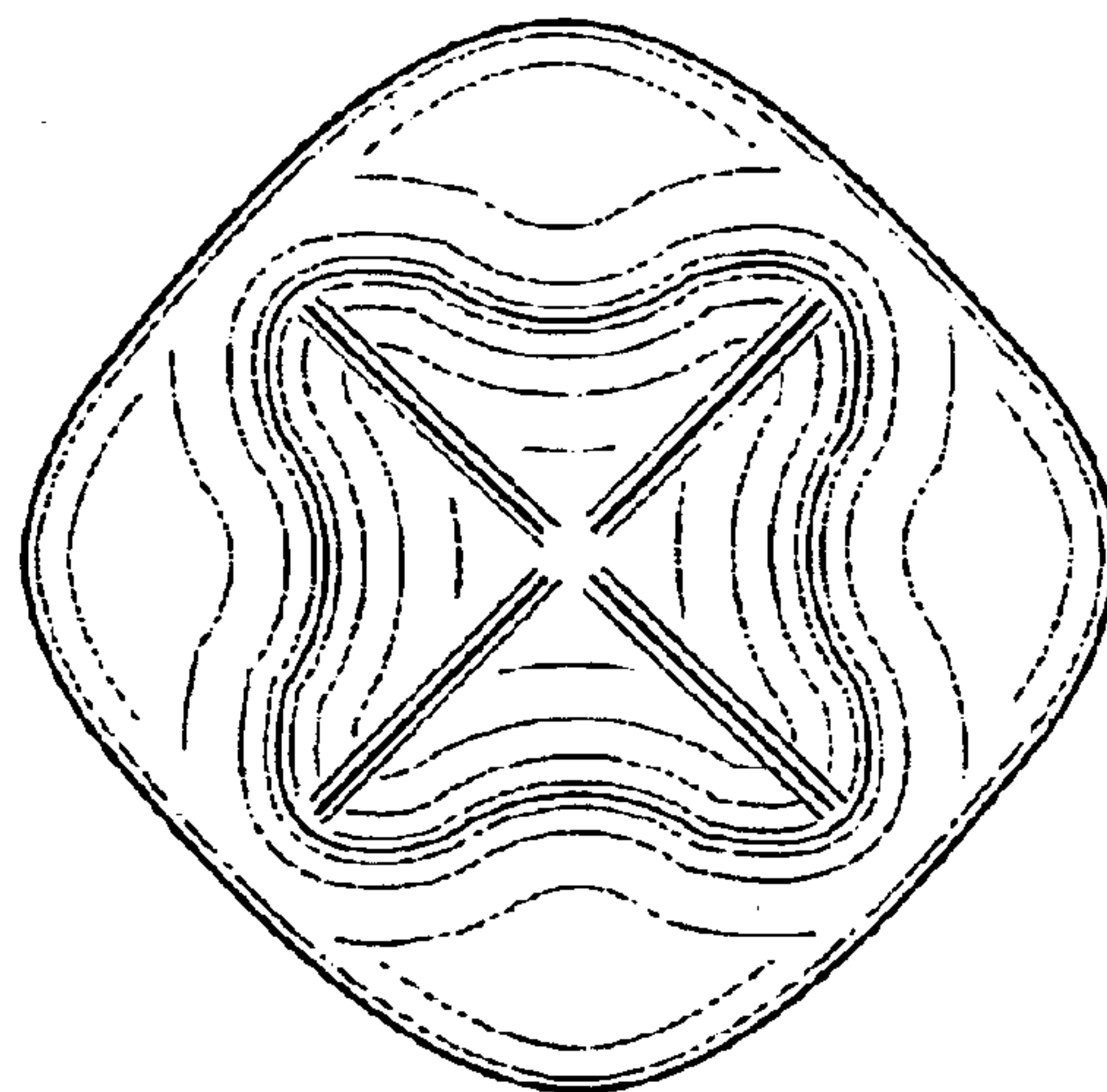

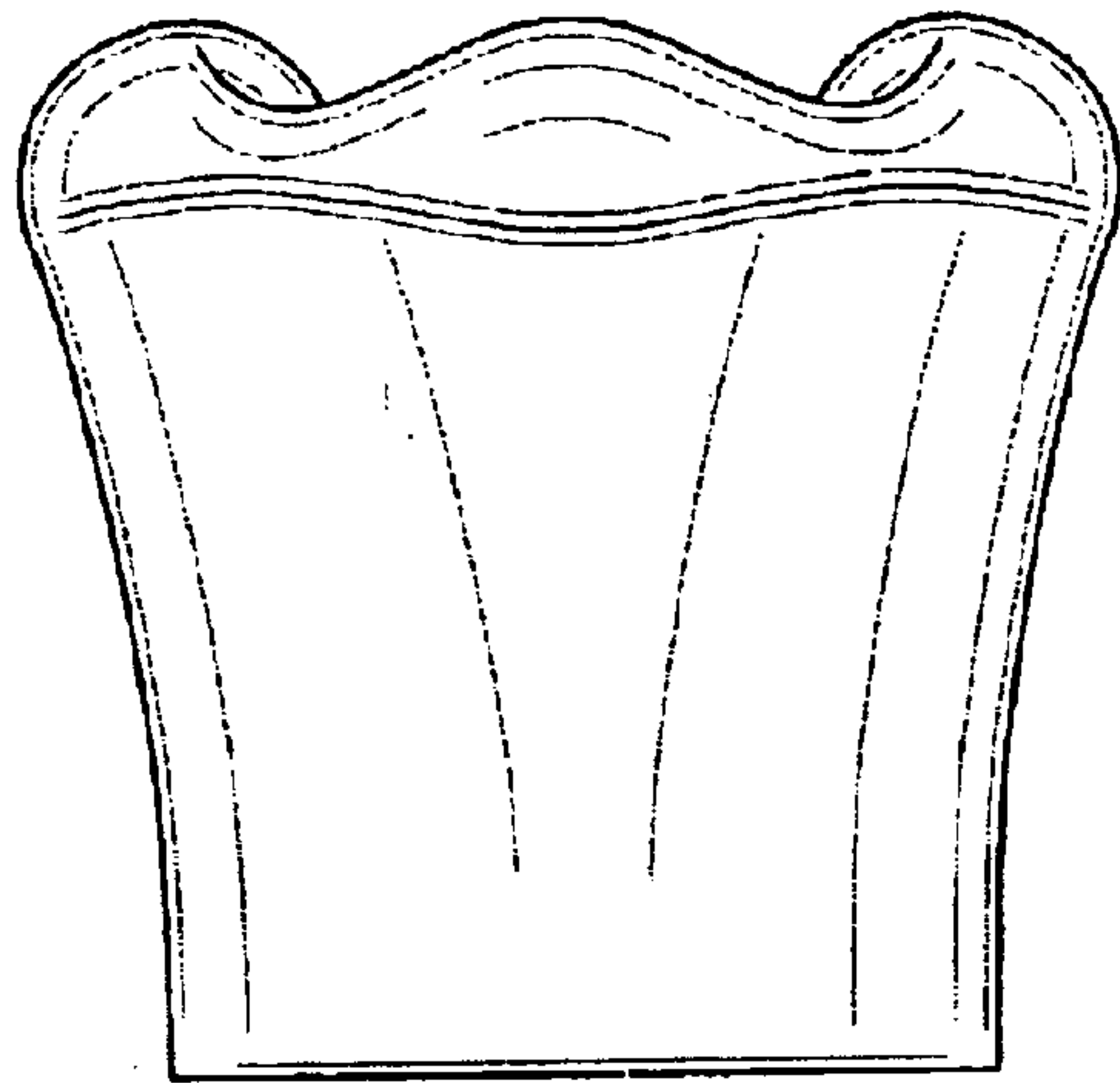

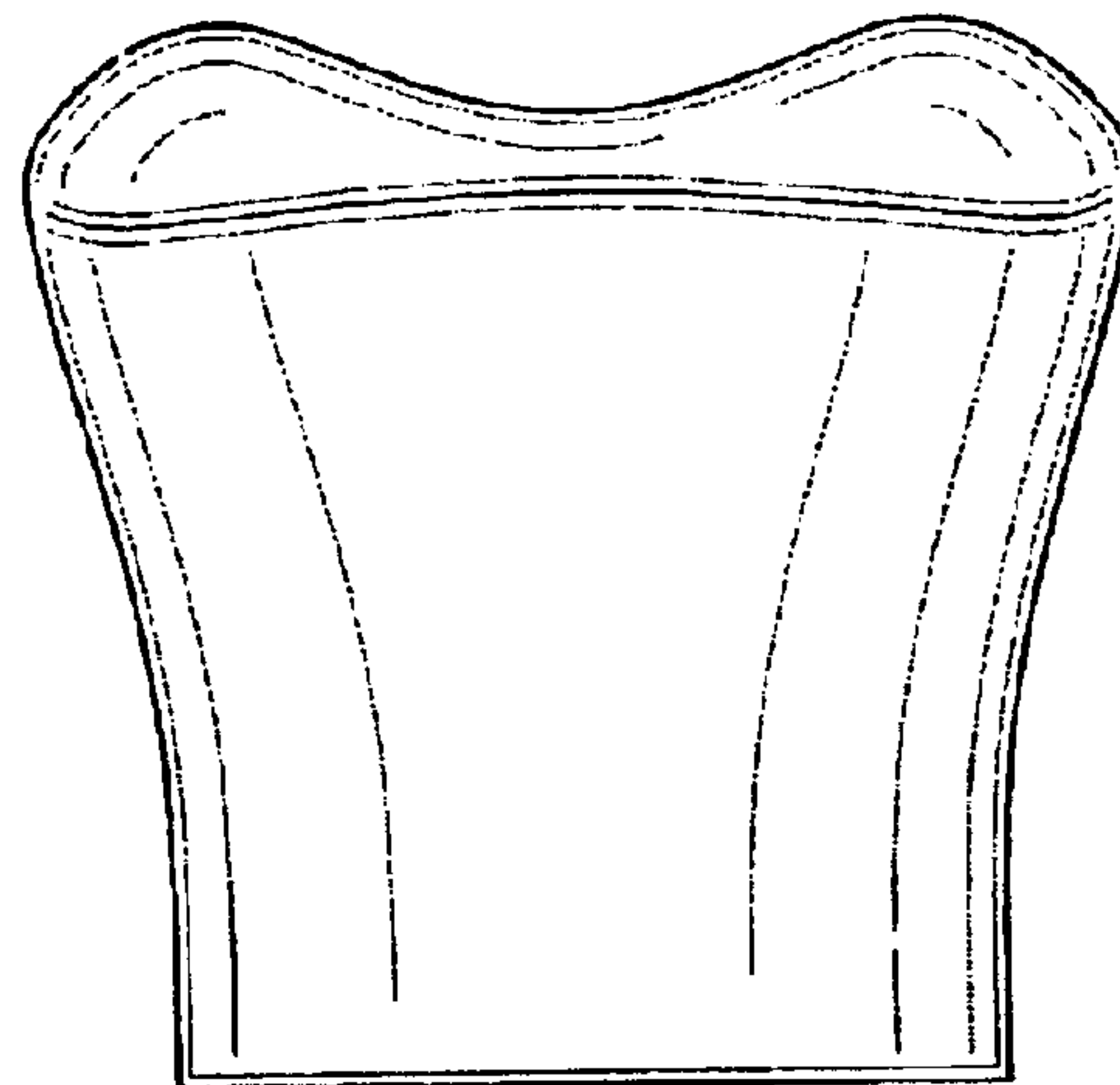
