(57) **CLAIM**

The ornamental design for a sprayer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the sprayer embodying our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a back side view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom view thereof; and,

FIG. 8 is a right side view thereof, with the lock button on the sidewall shown in an alternate position to how it is shown in FIG. 5.

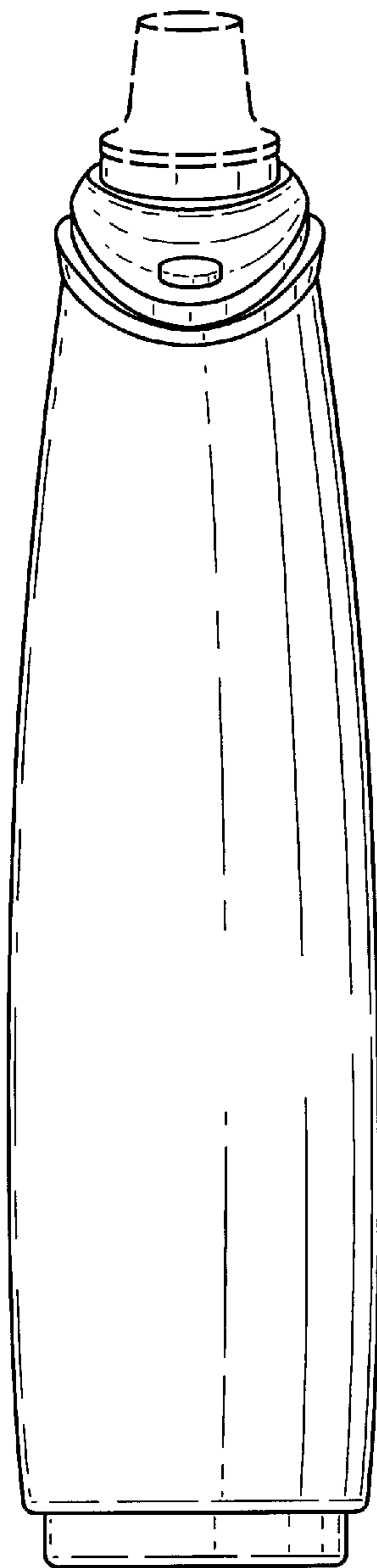

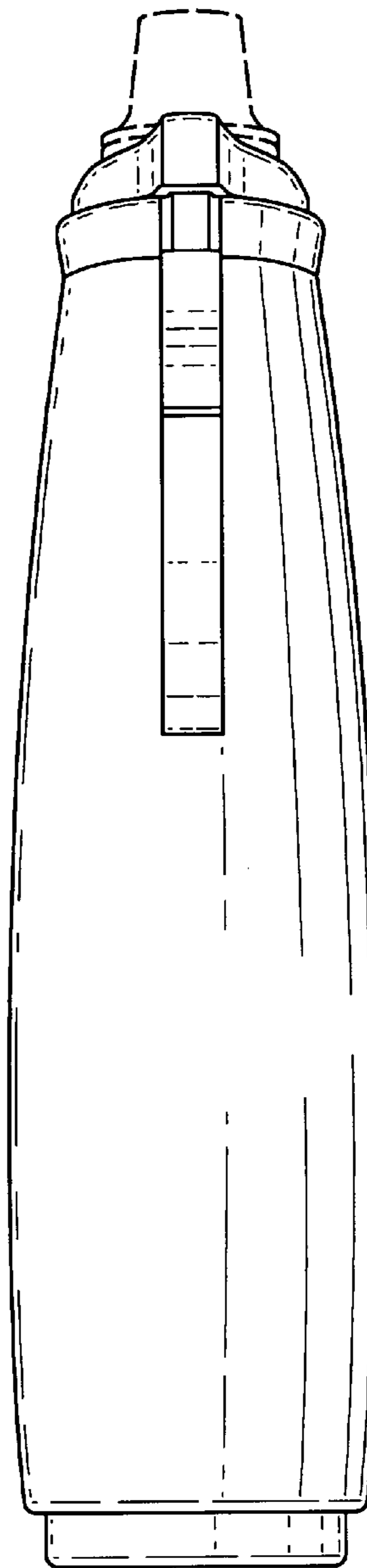

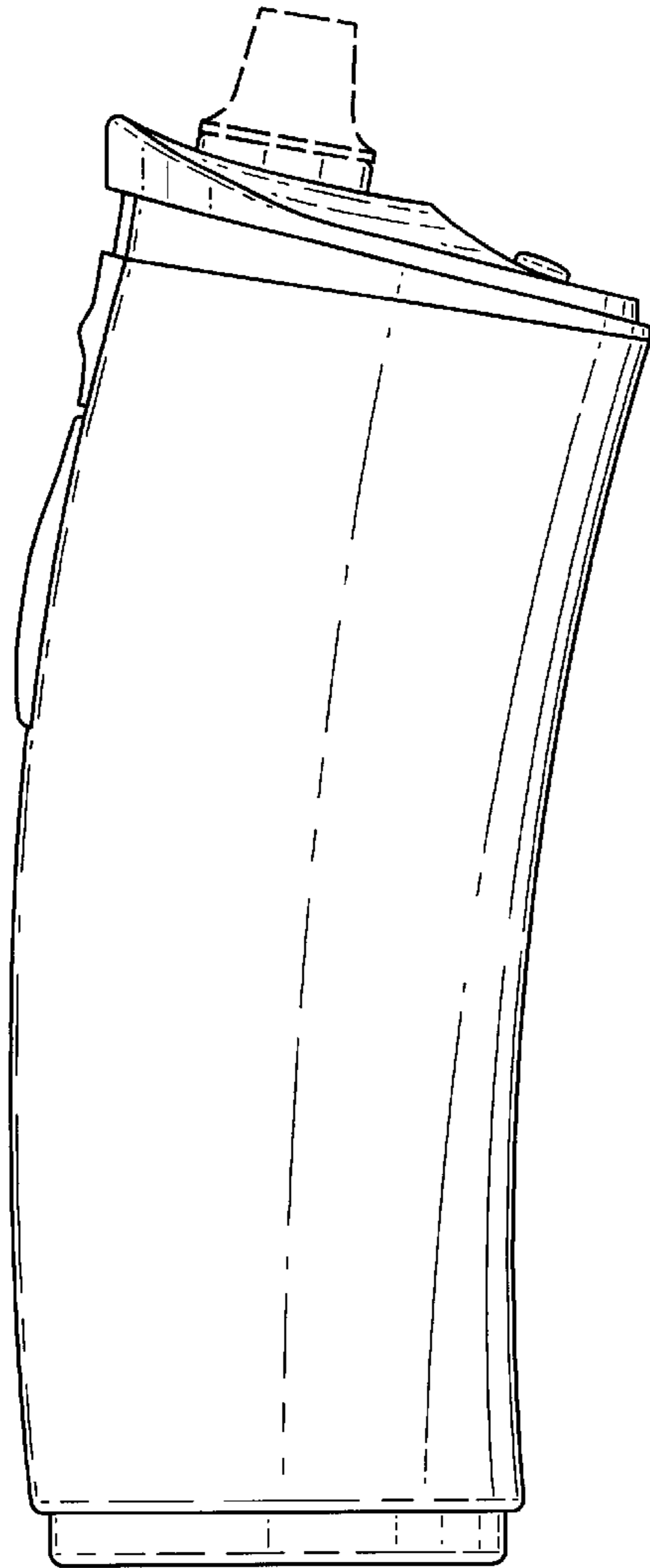

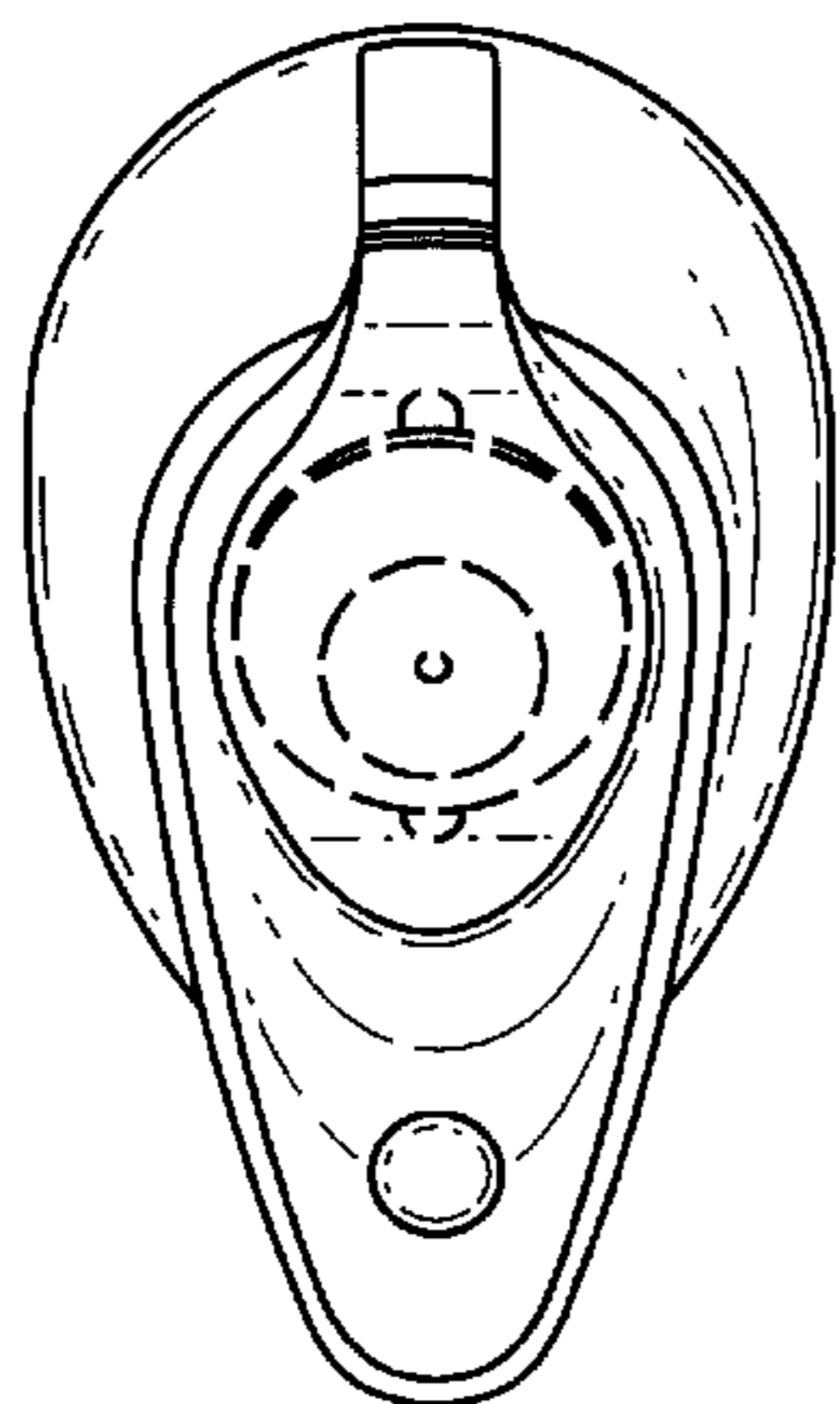

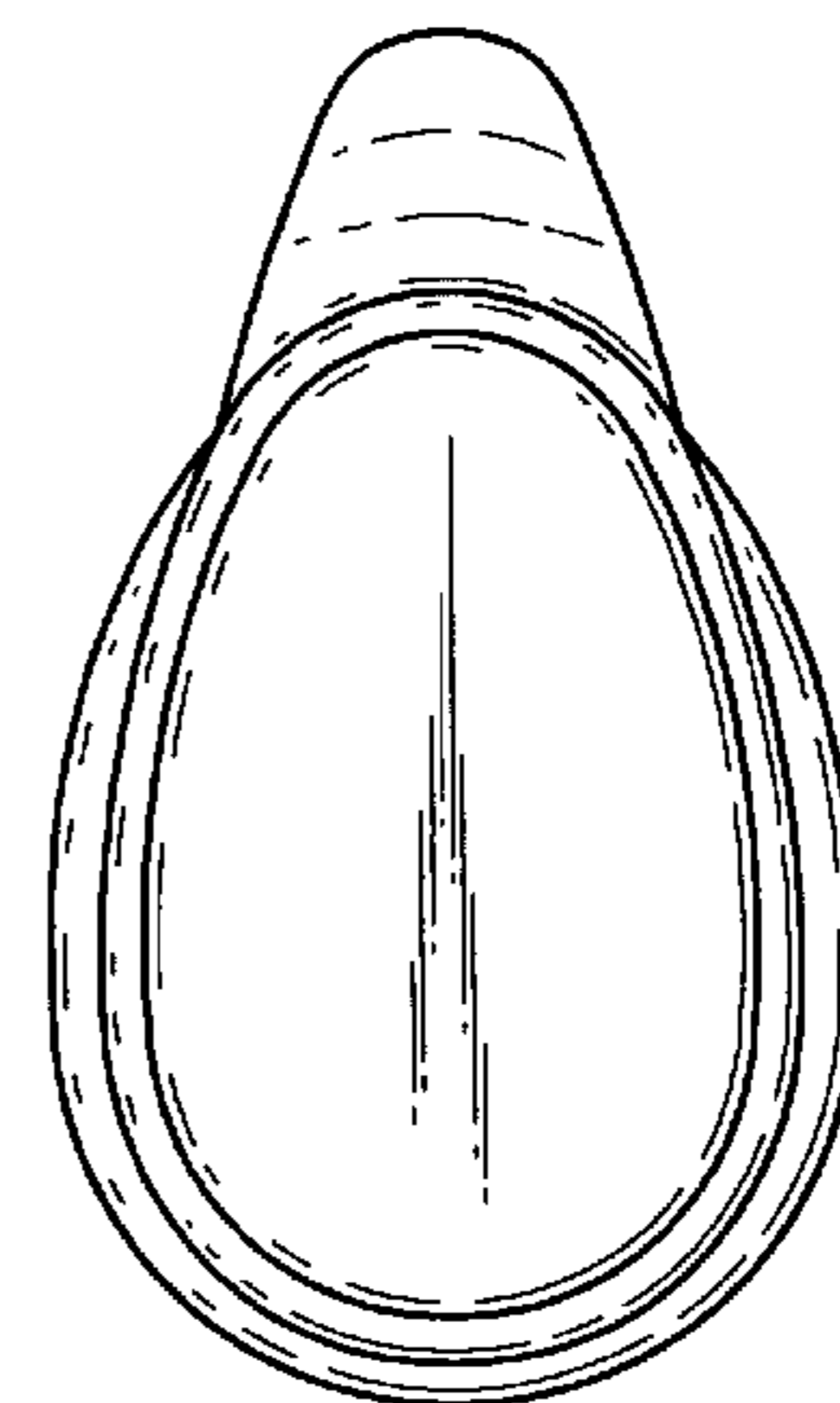

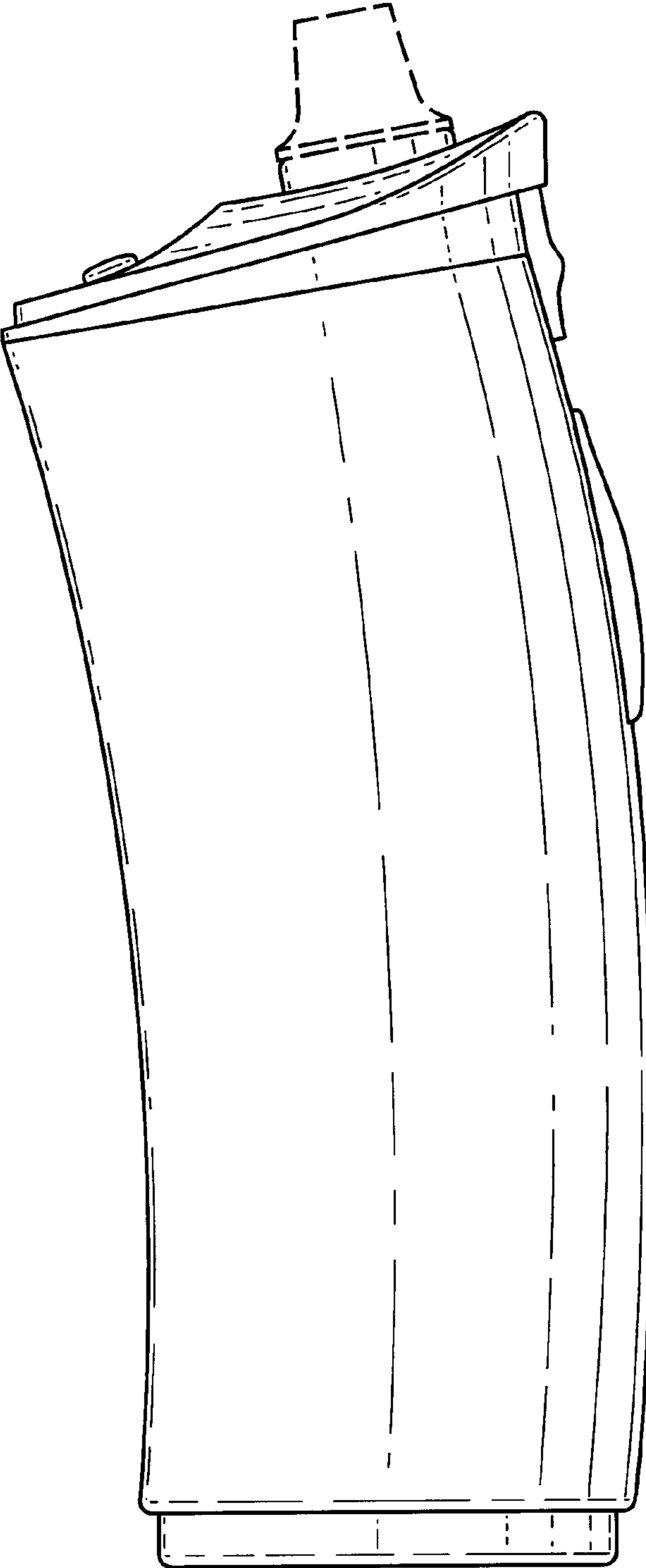
