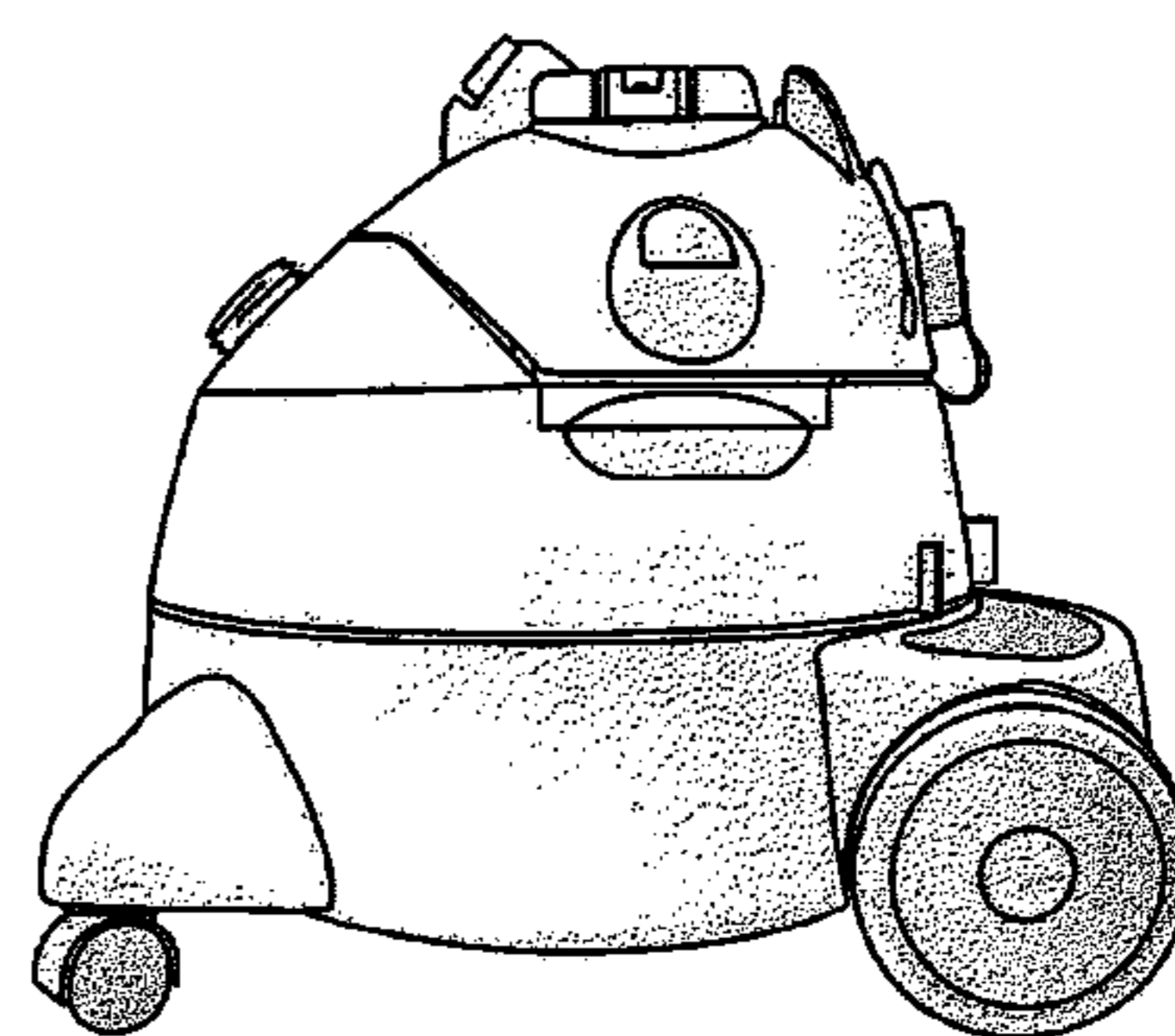
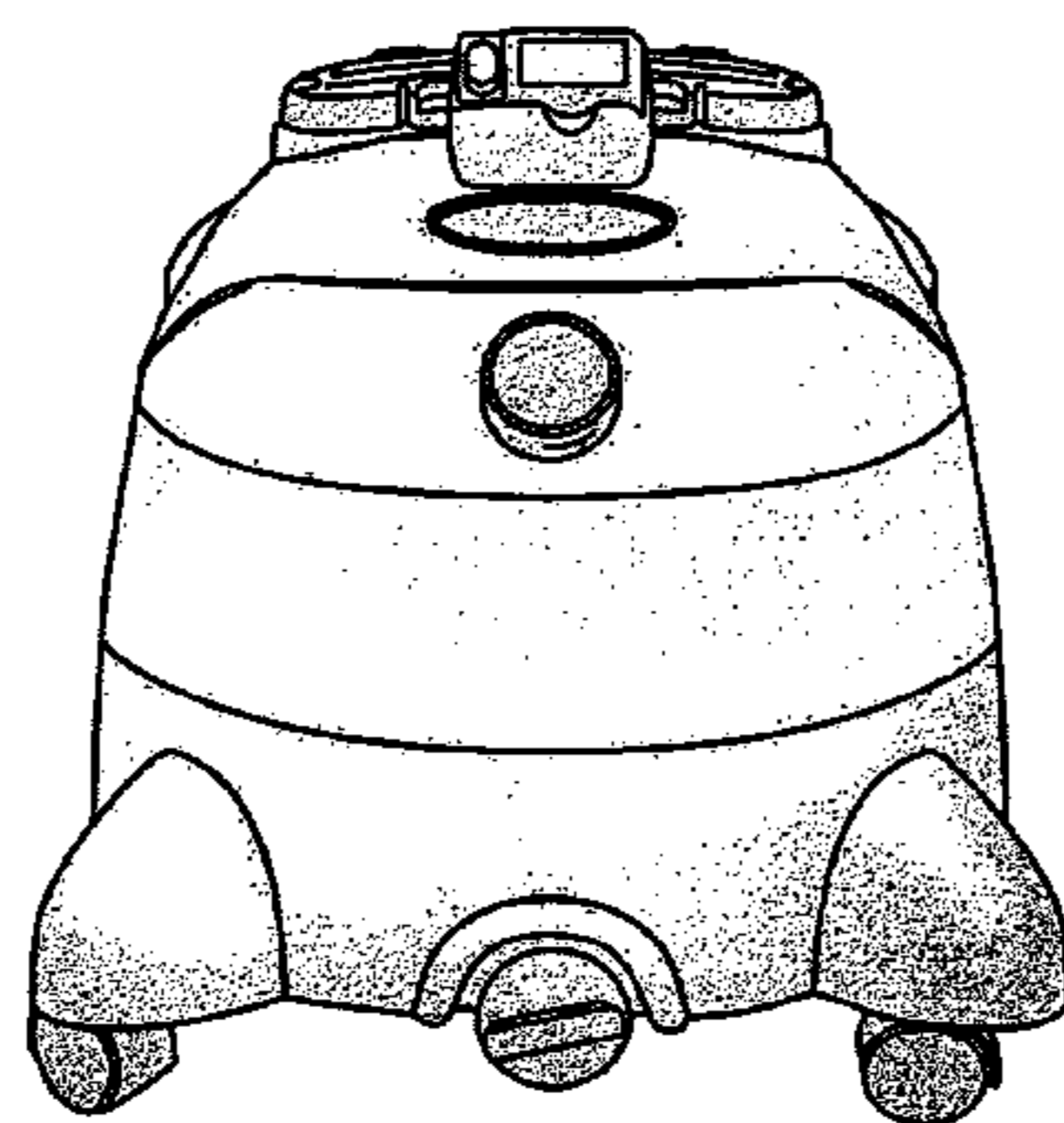
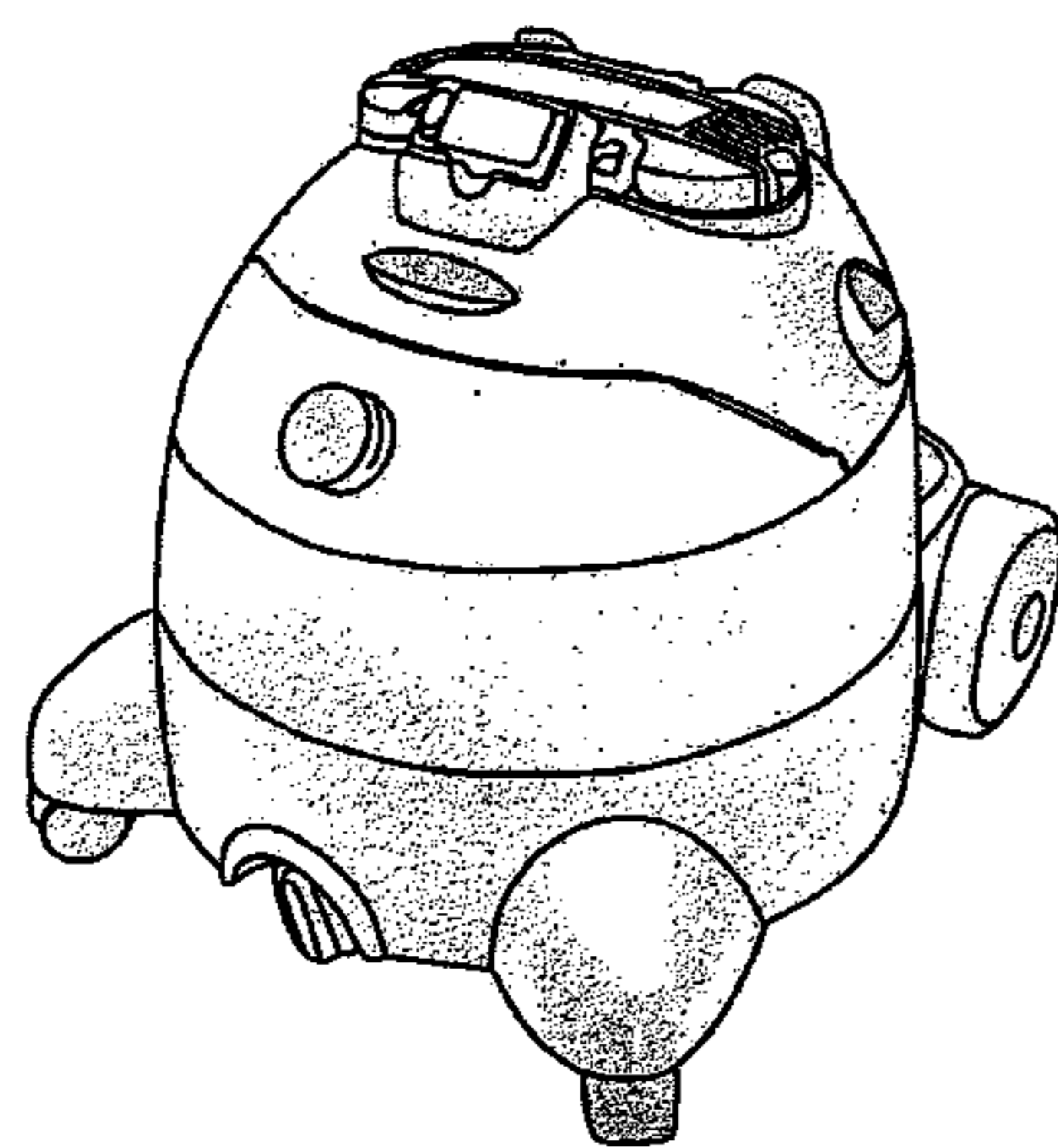
(57) **CLAIM**

The ornamental design for a “combination wet/dry vacuum cleaner,” as shown and described.

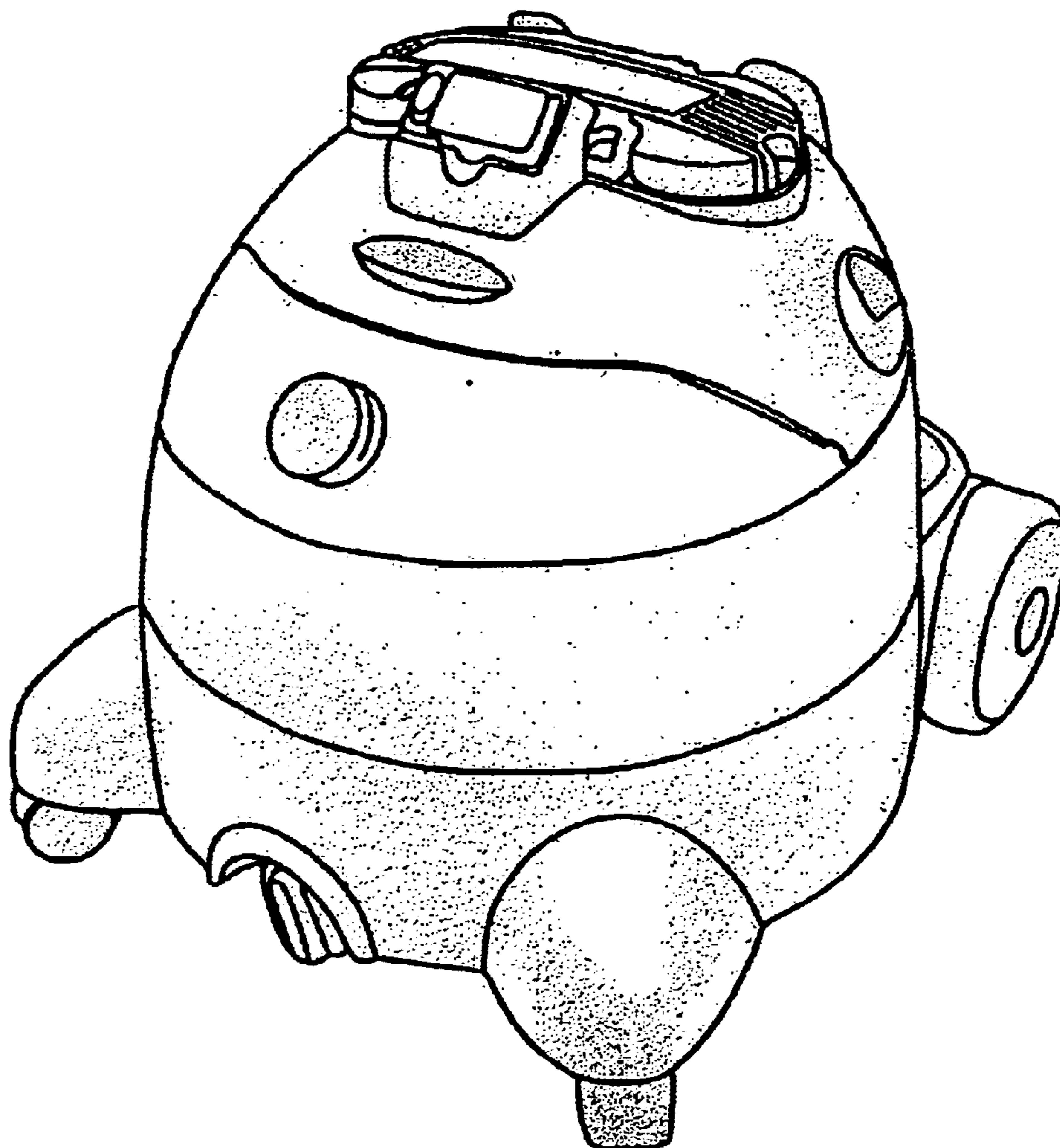
**DESCRIPTION**

FIG. 5 is a top plan view thereof.

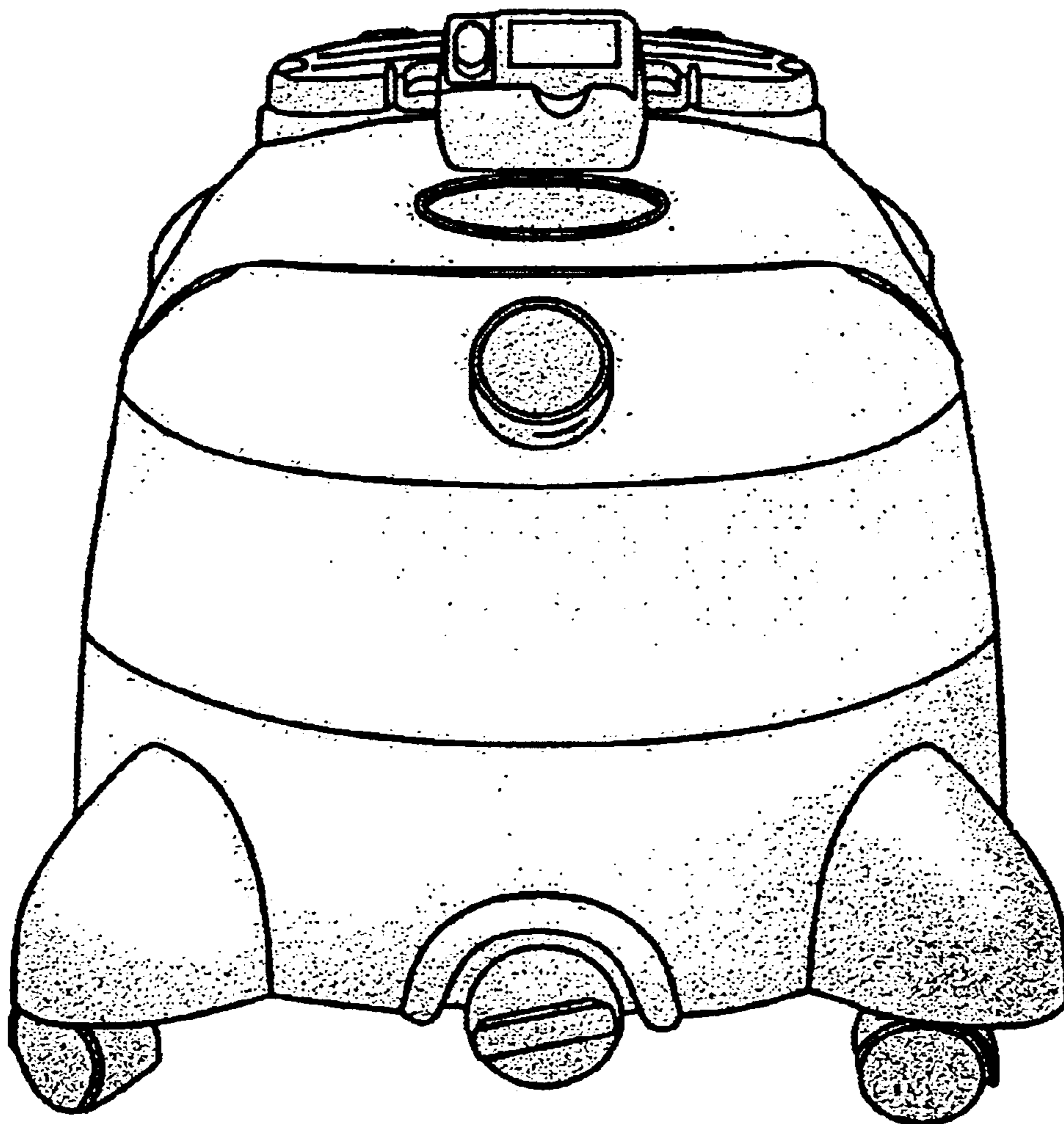

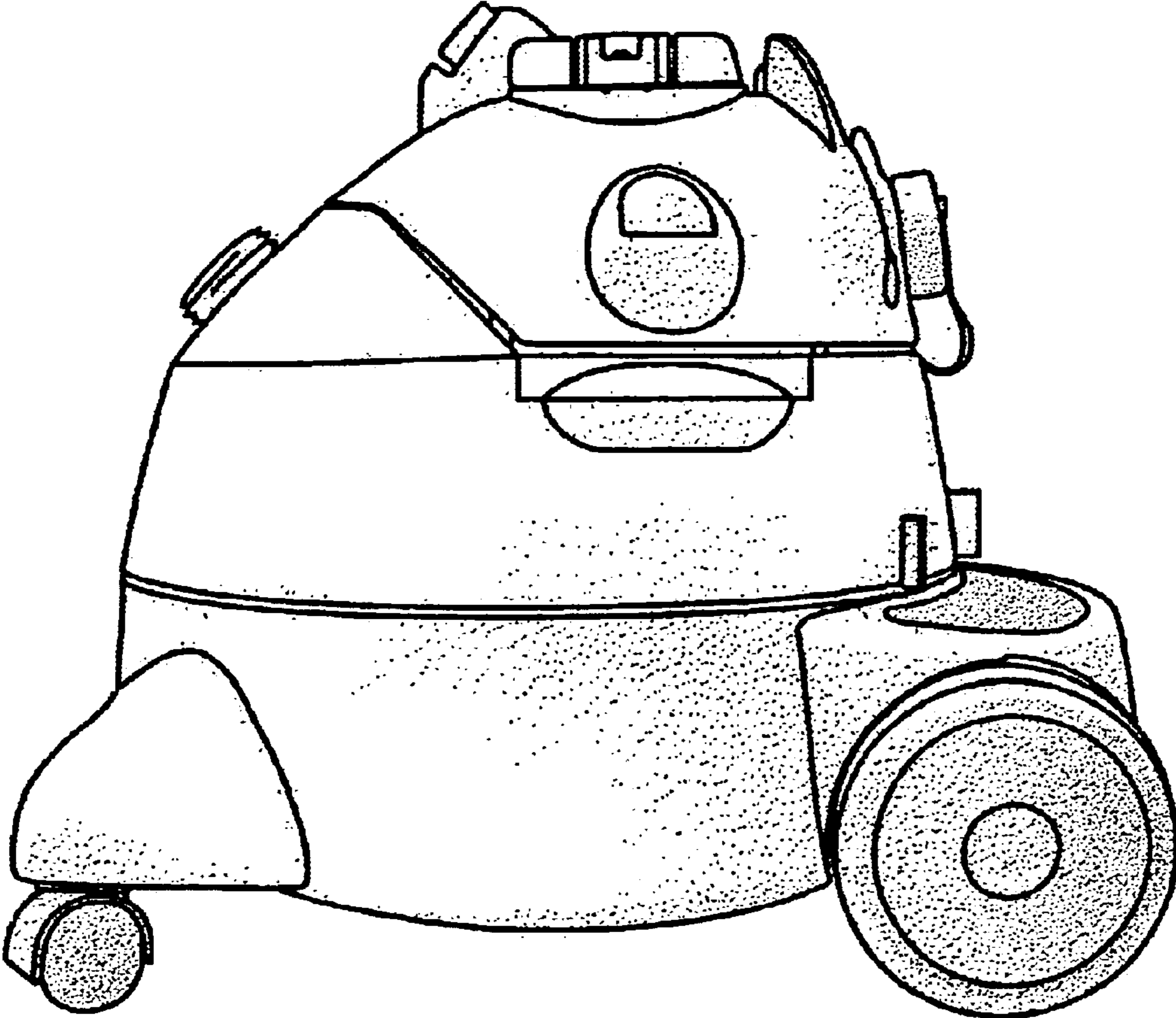

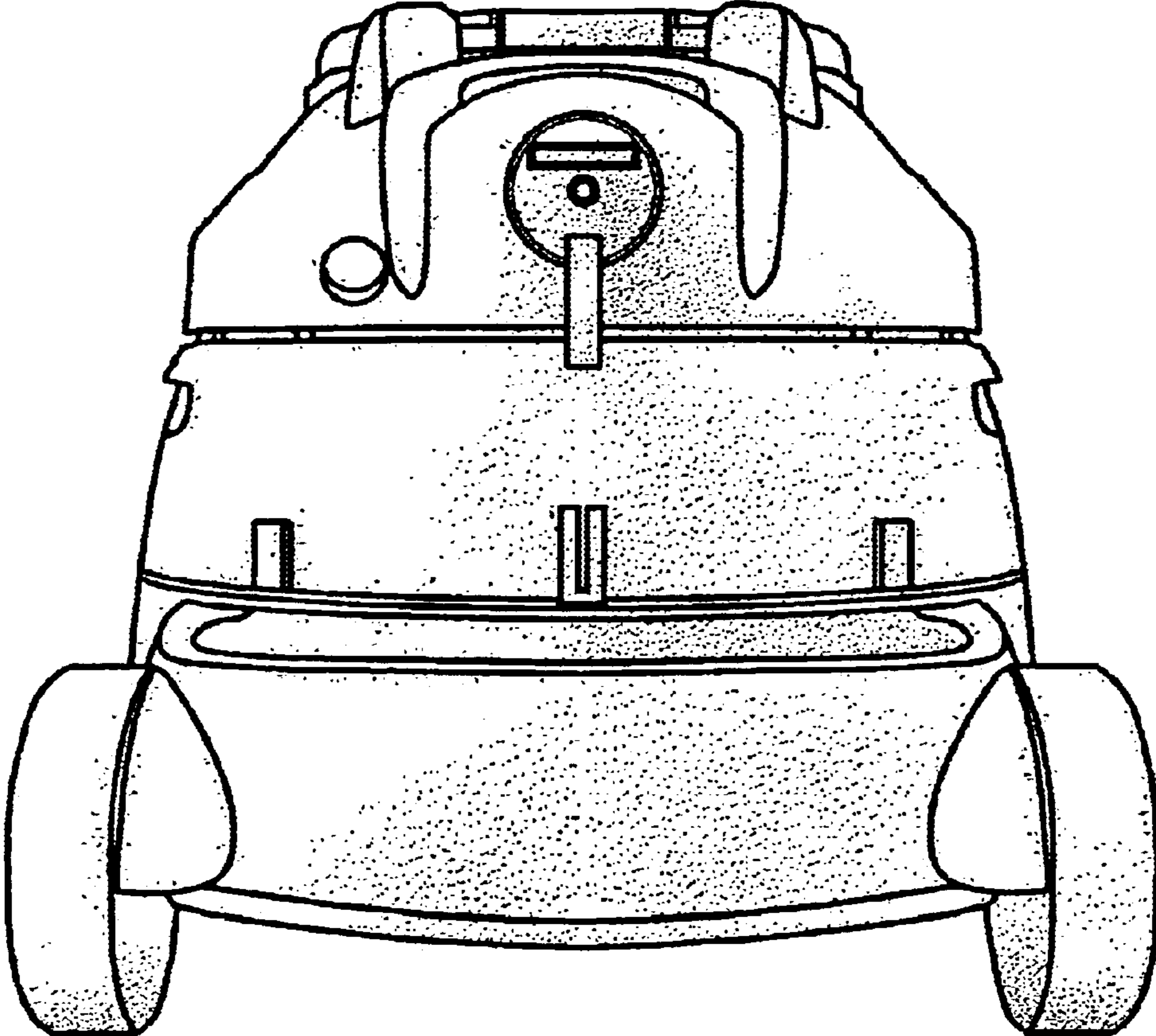
