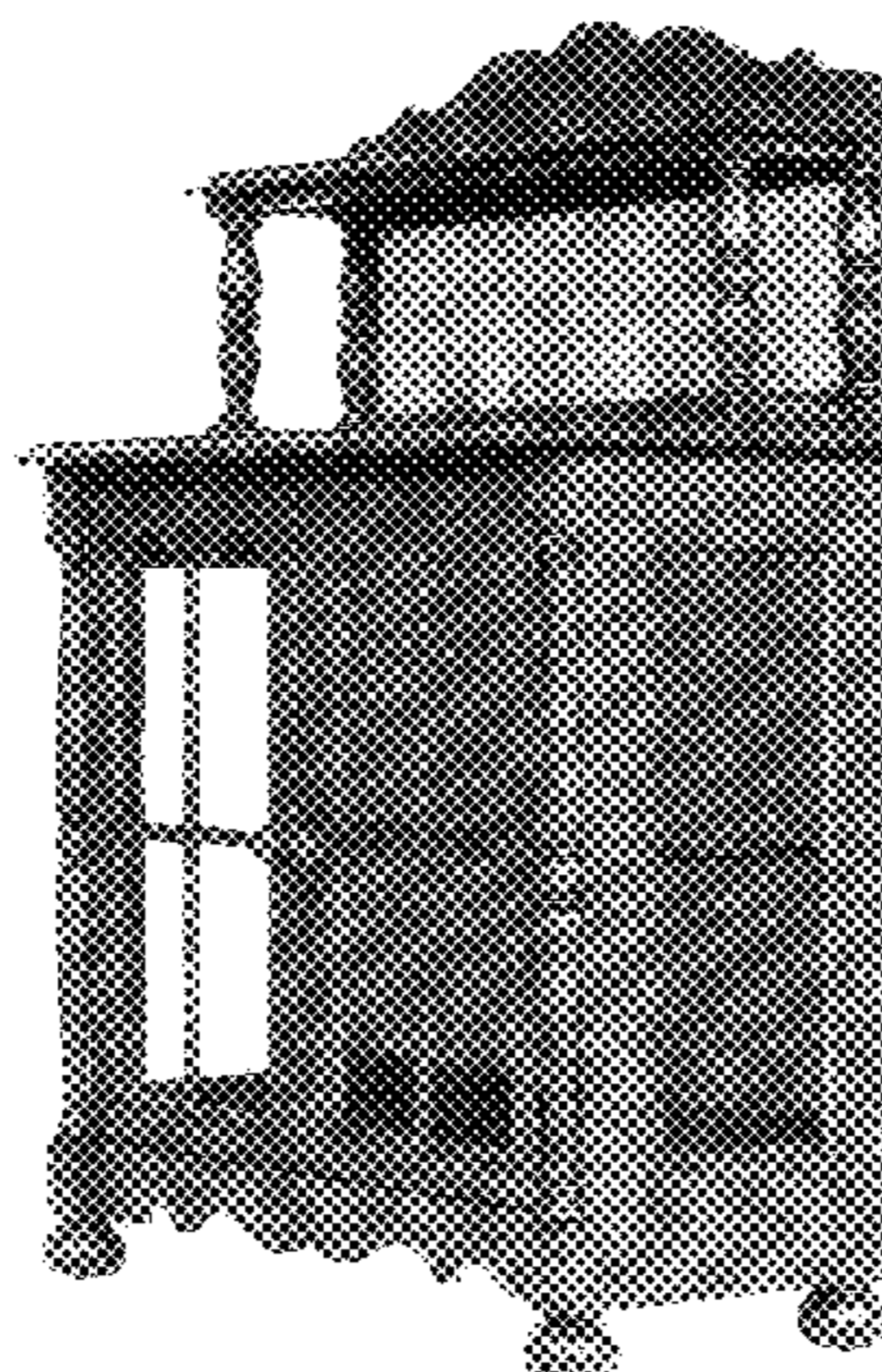
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a dining chest showing our new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a right side perspective view thereof, the left side being a mirror image of the right side; and,  
 FIG. 4 is a top plan view thereof.

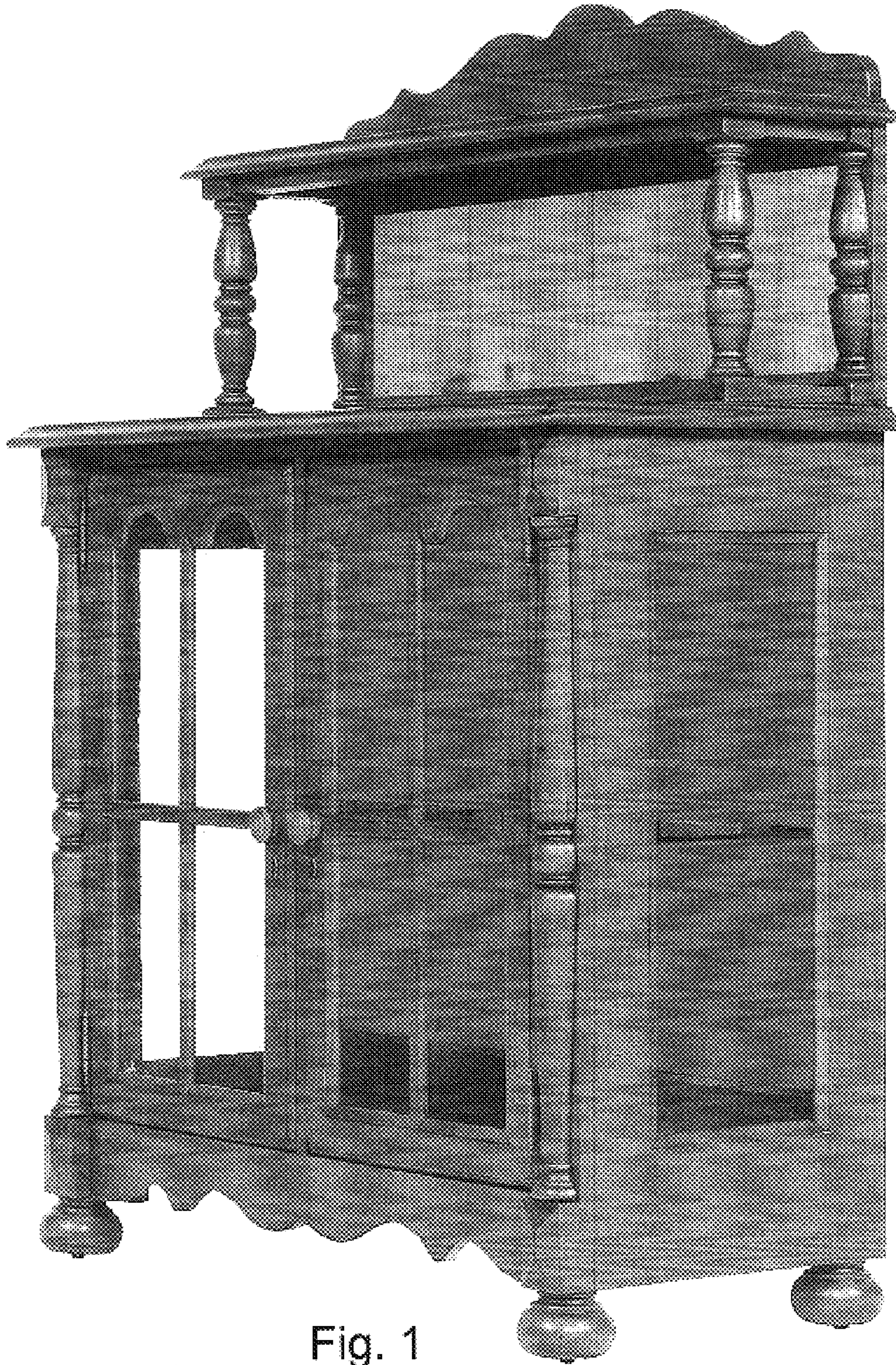

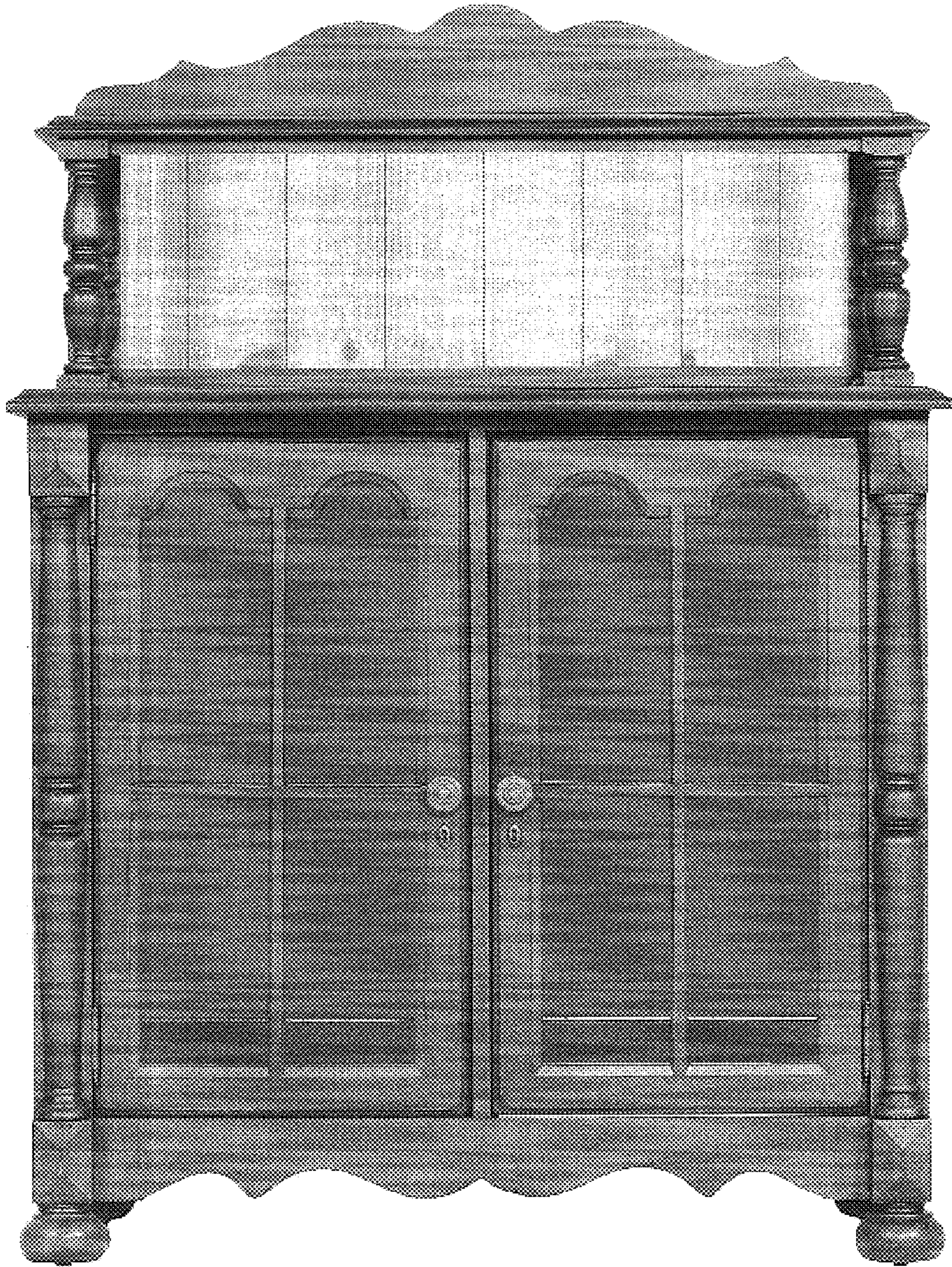

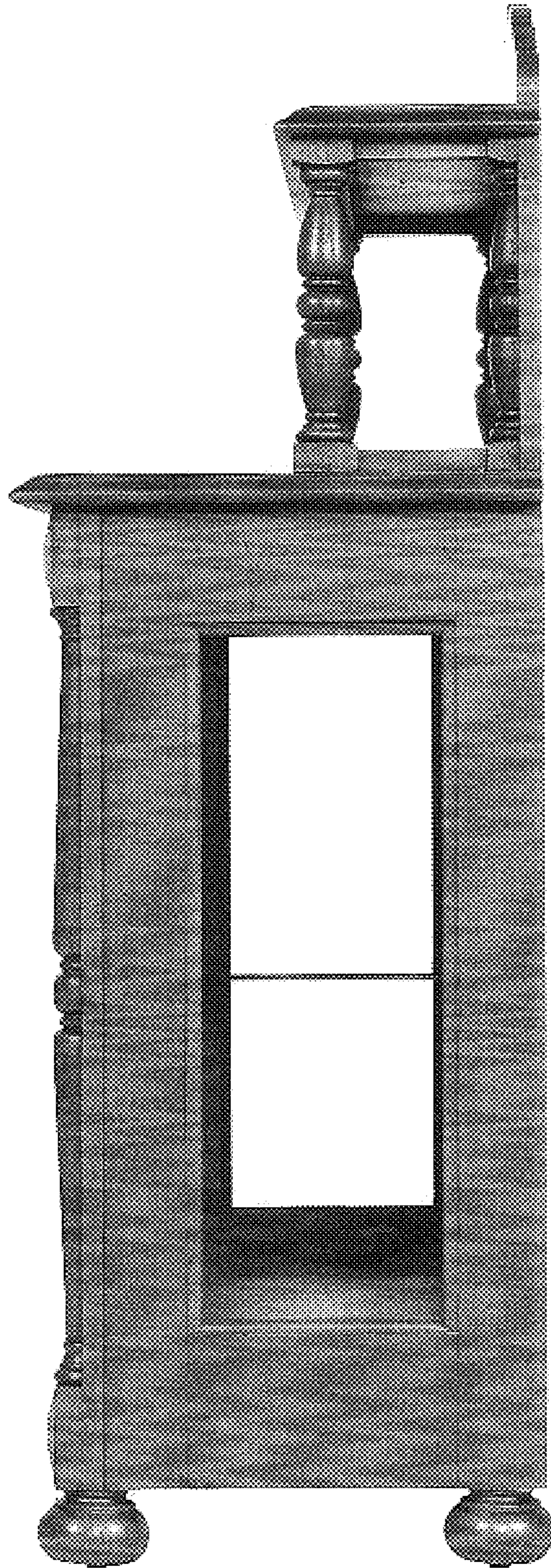

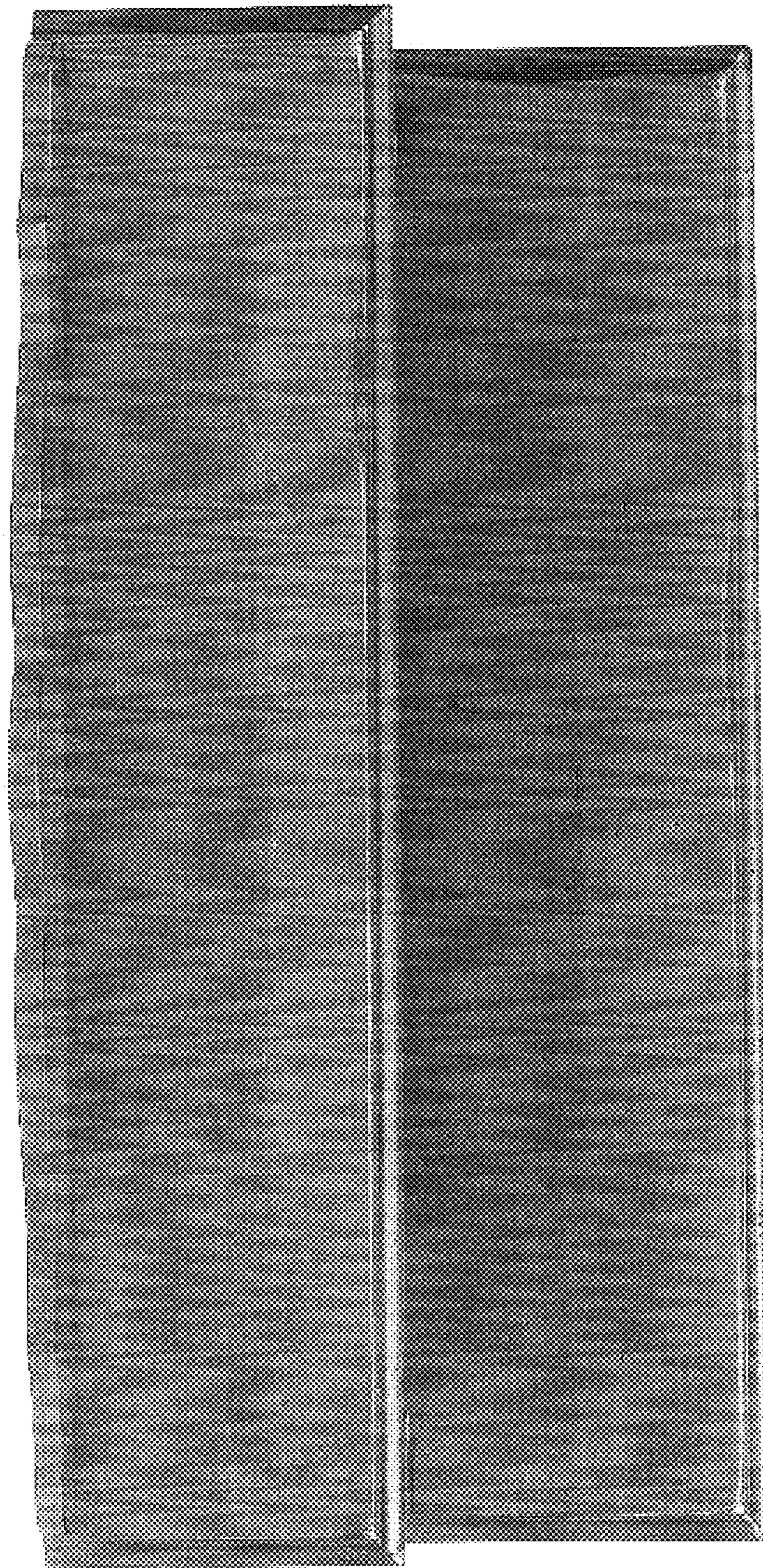
