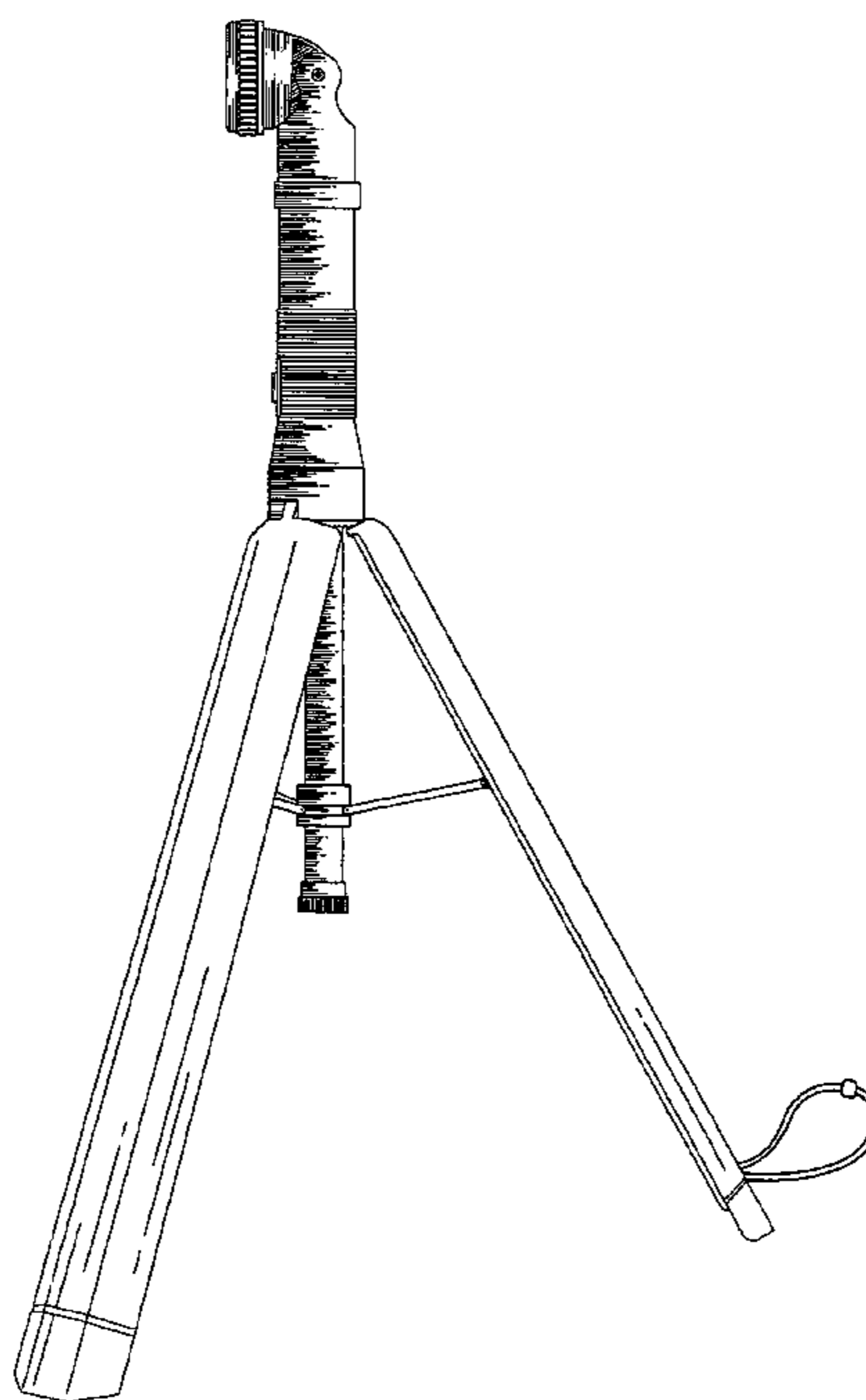
(57) **CLAIM**

The ornamental design for a warning flashlight with torch for vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a warning flashlight with torch for vehicle showing our new design;
 FIG. 2 is a rear view thereof;
 FIG. 3 is right side view thereof;
 FIG. 4 is a top view of our design of FIG. 1 in a first alternate position;
 FIG. 5 is a bottom view of FIG. 4;

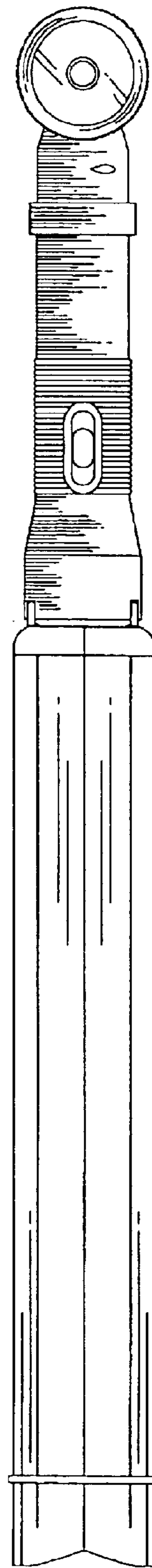

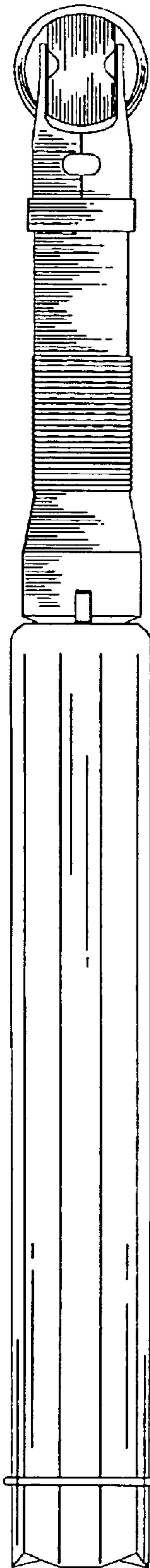

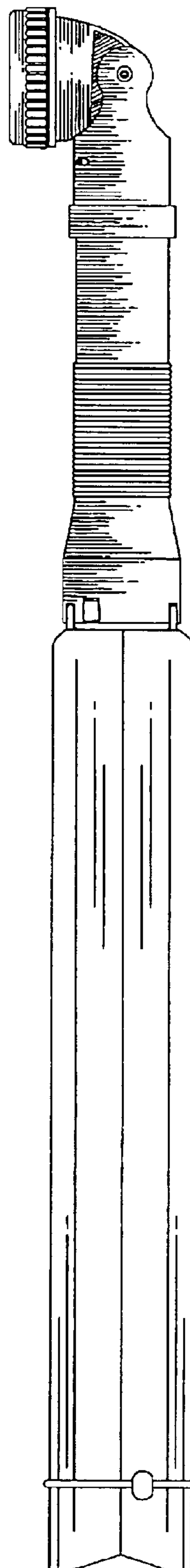

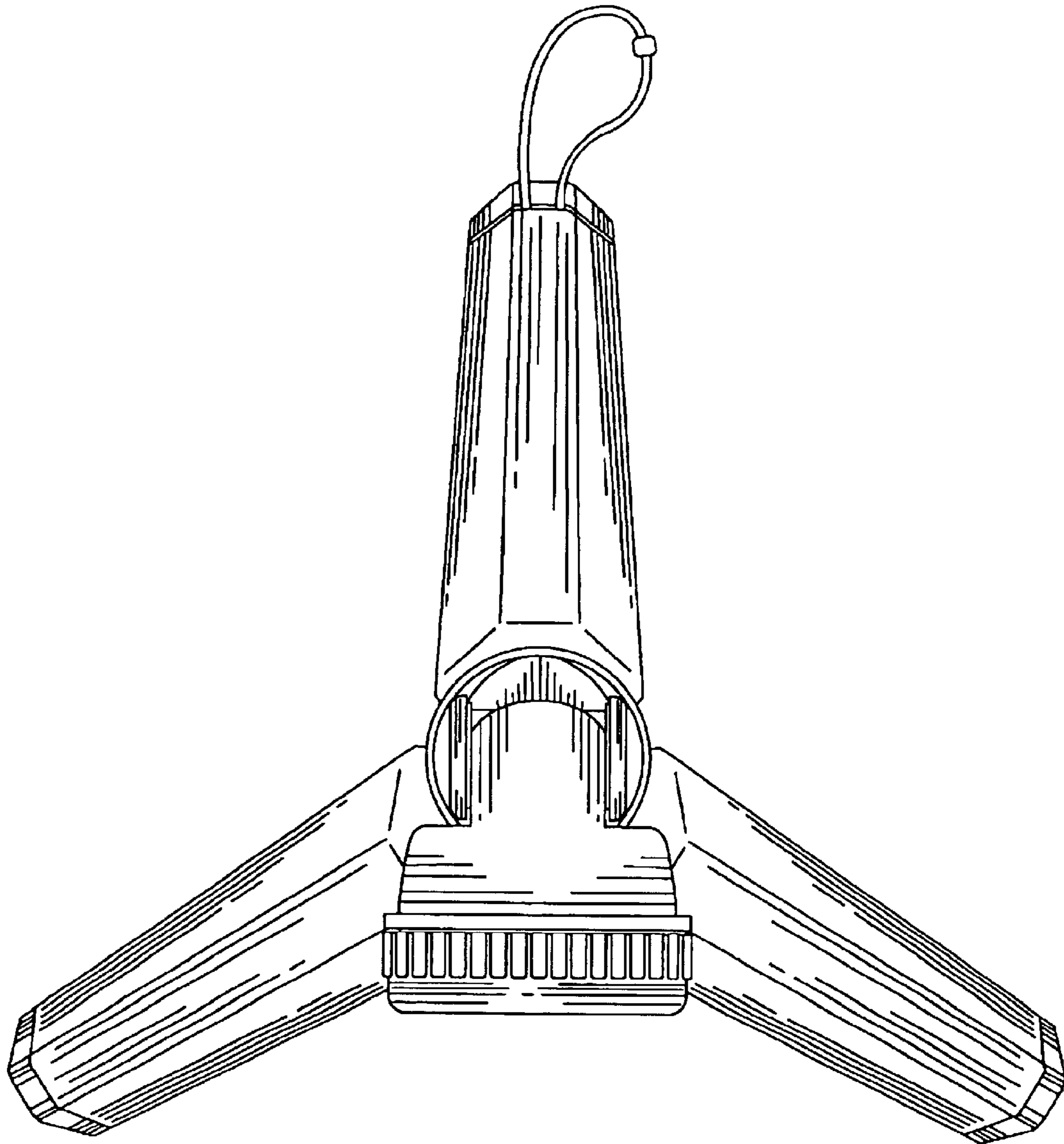

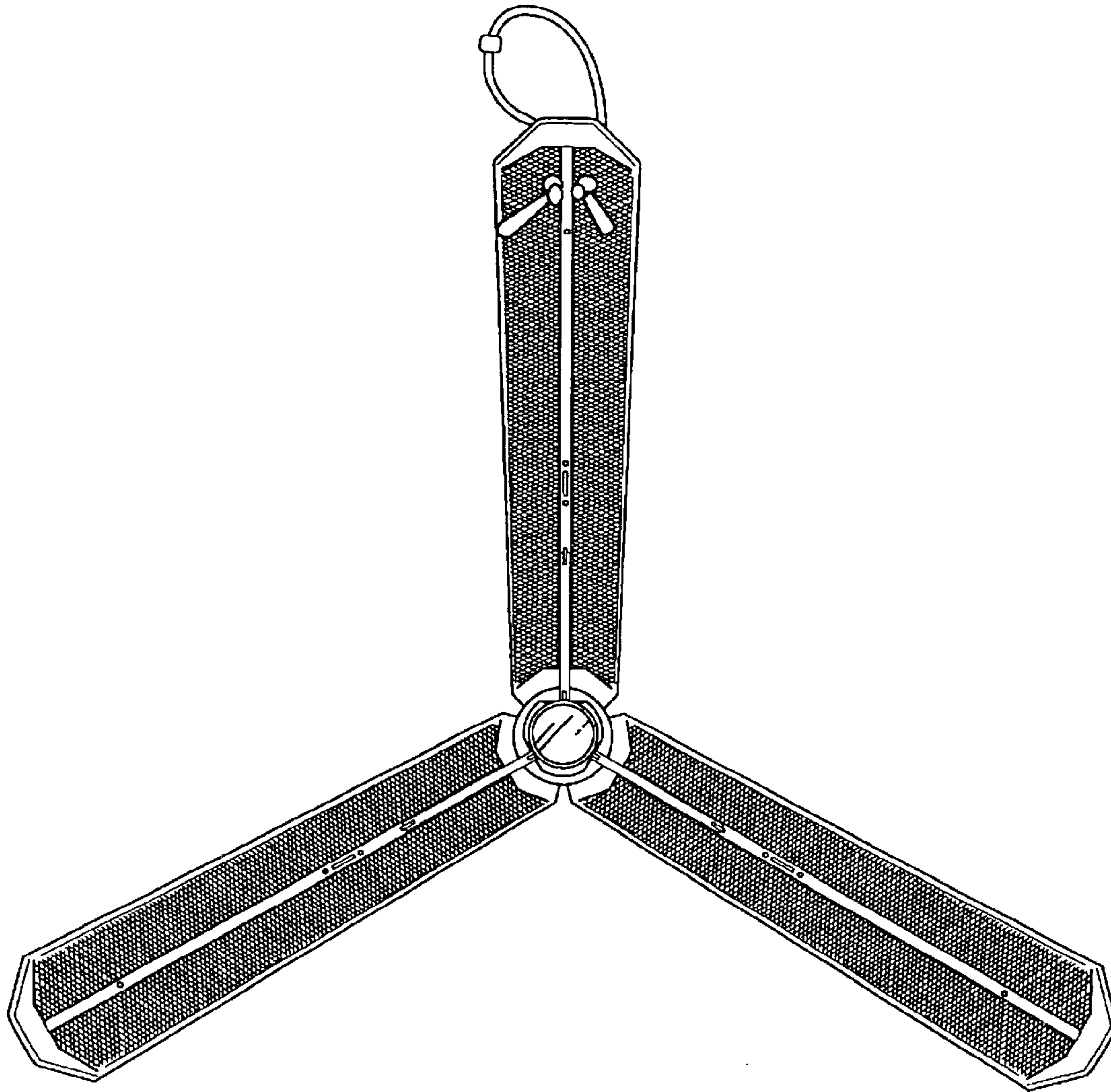

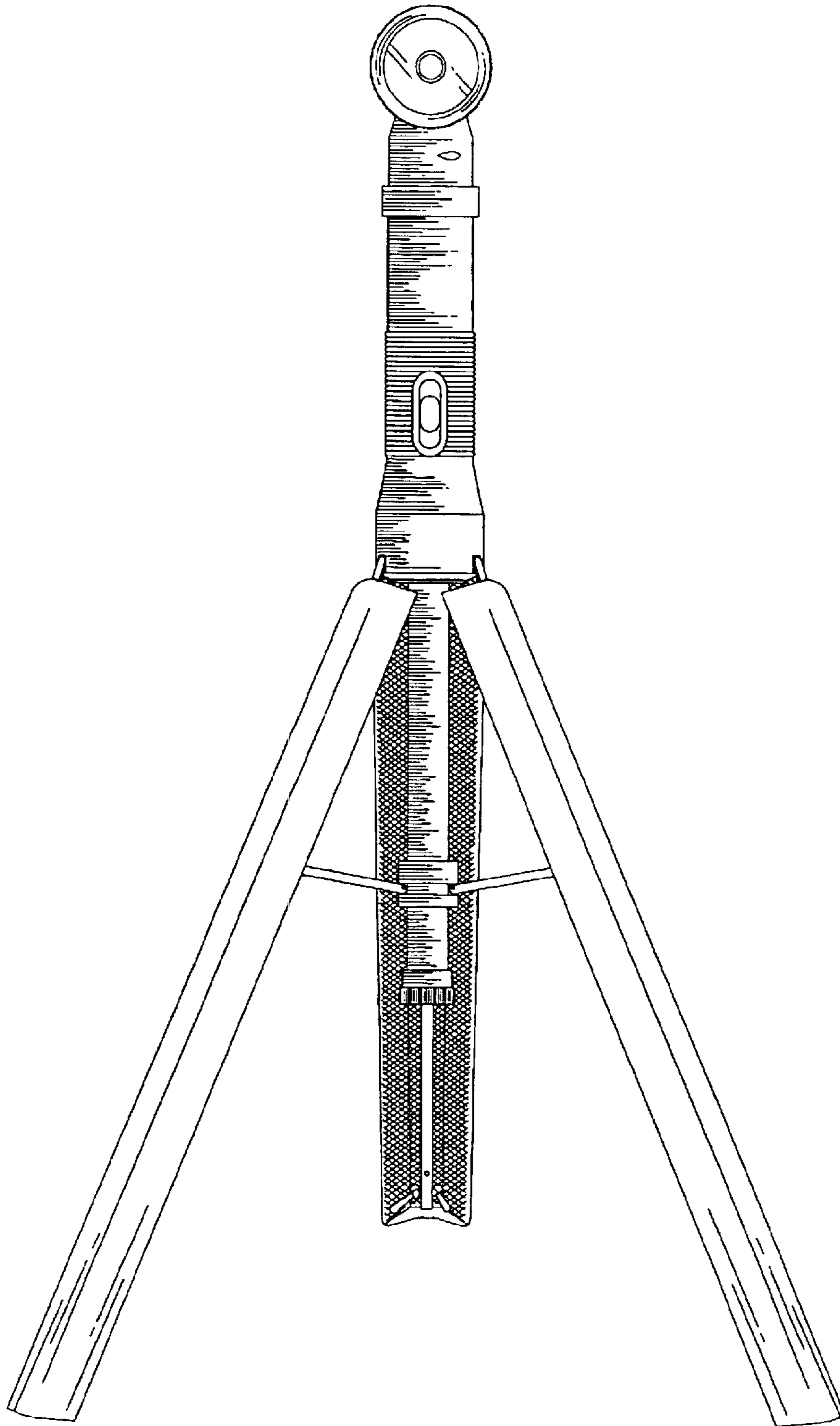

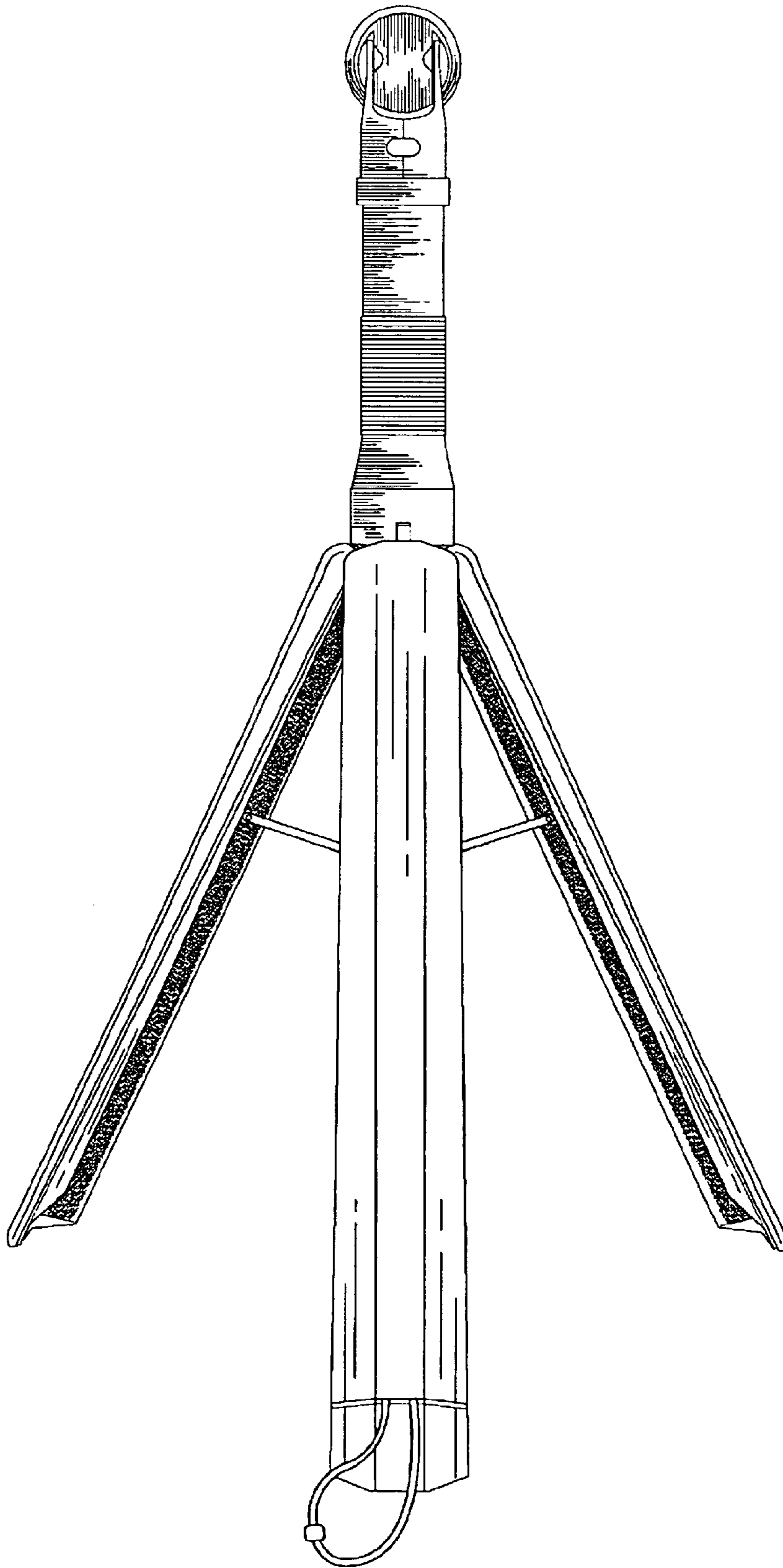

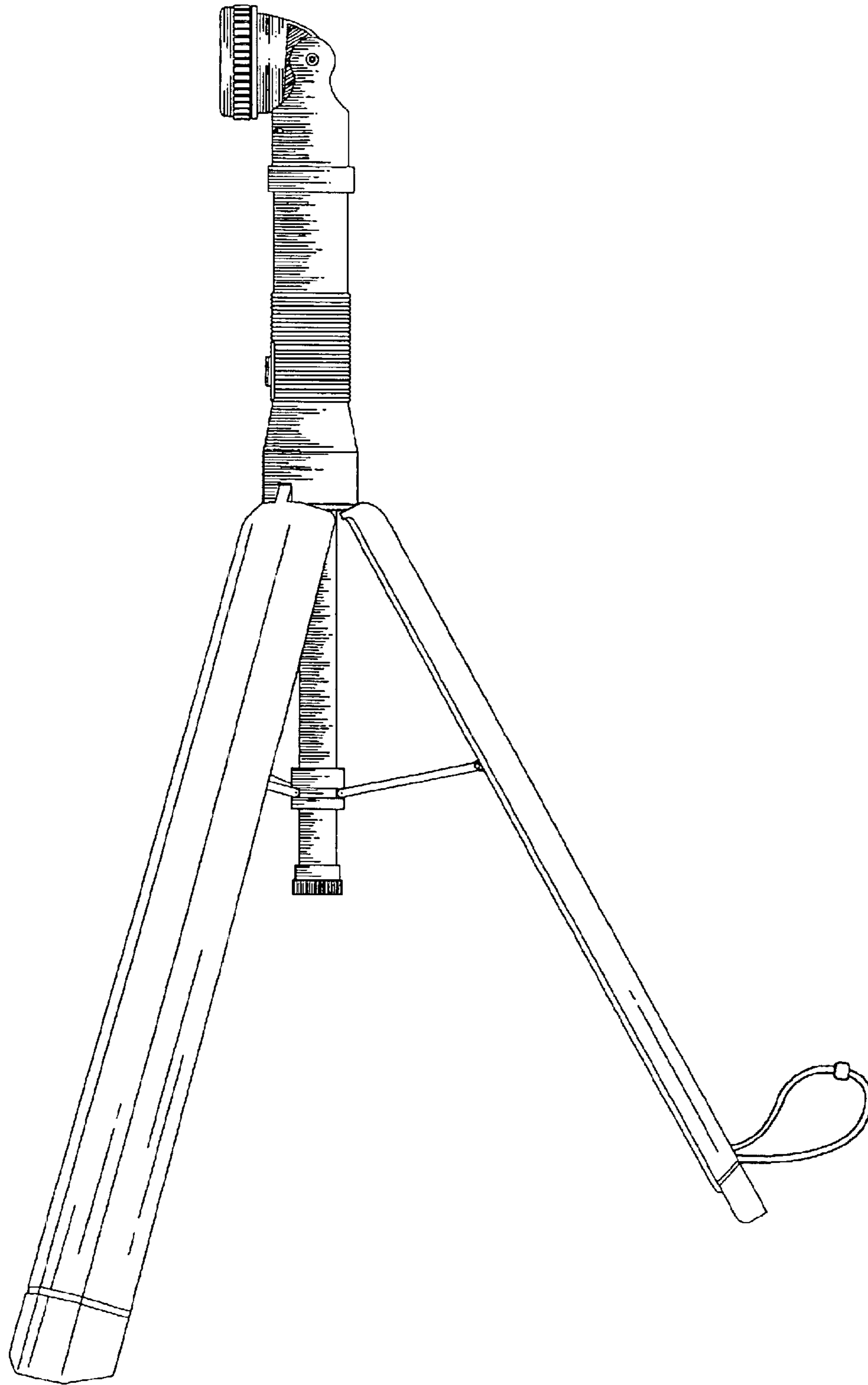

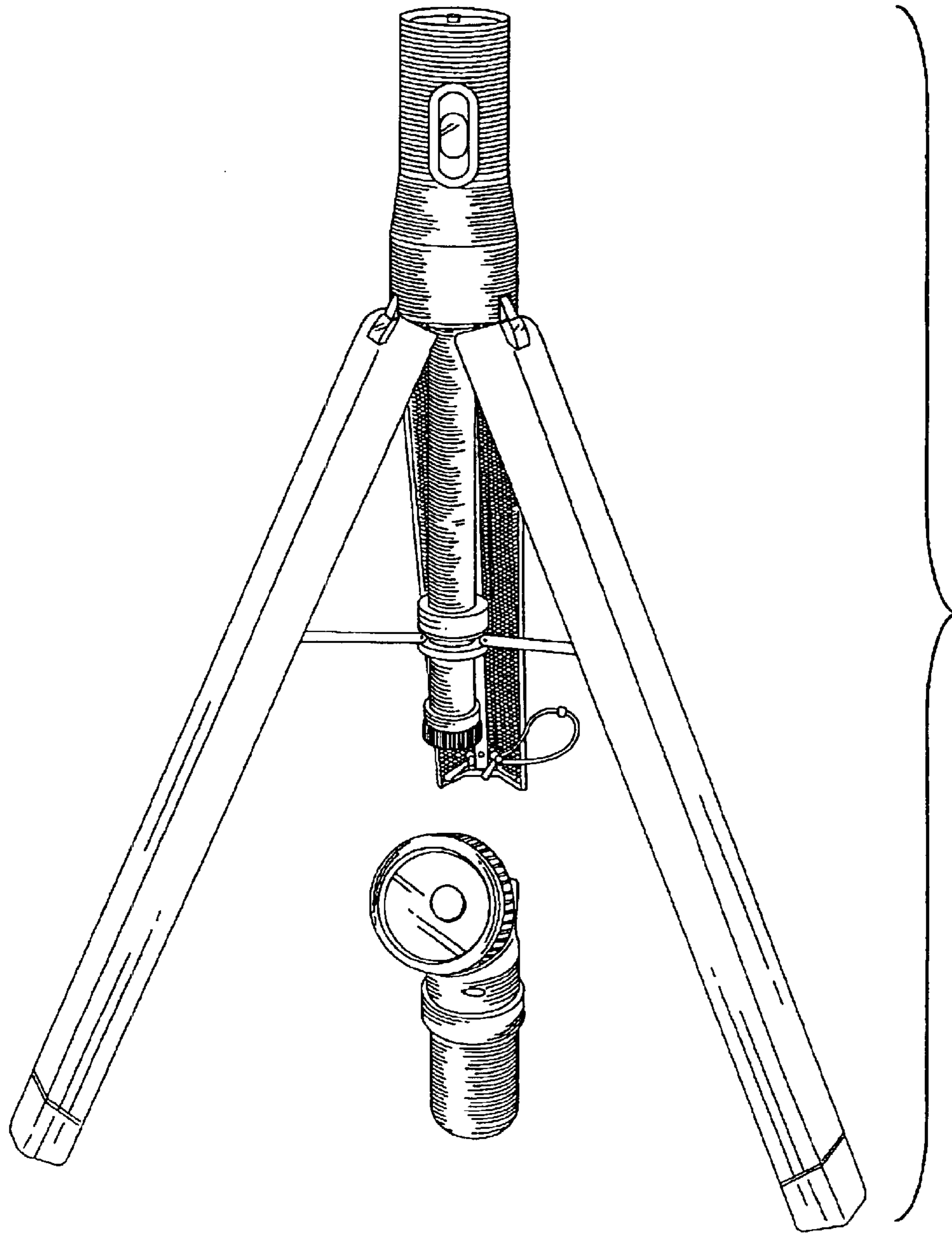
