We claim the ornamental design for a pool table, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an embodiment of a pool table in accordance with our new design.

FIG. 2 is a front elevational view of the pool table of FIG. 1.

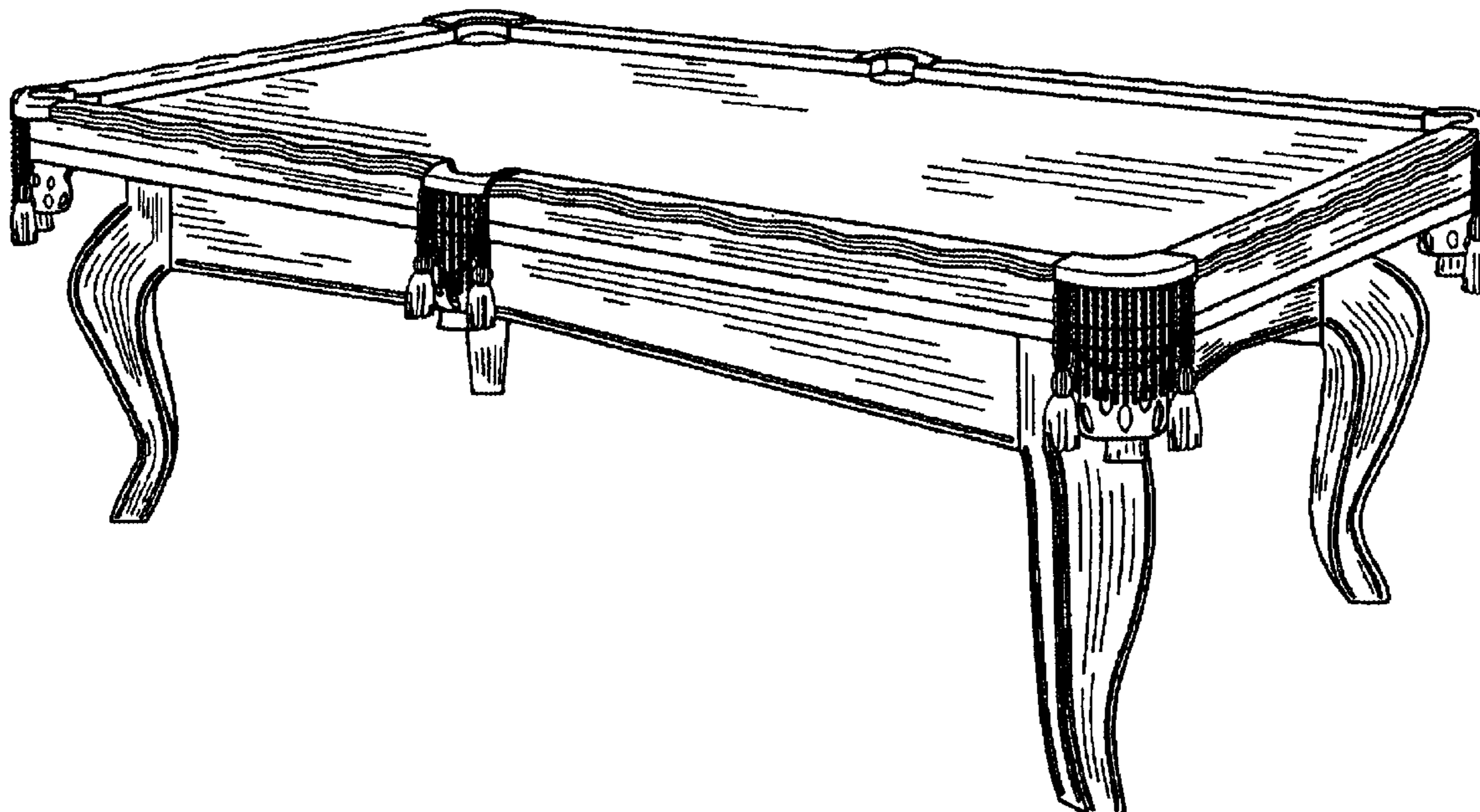
FIG. 3 is a back elevational view of the pool table of FIG. 1.

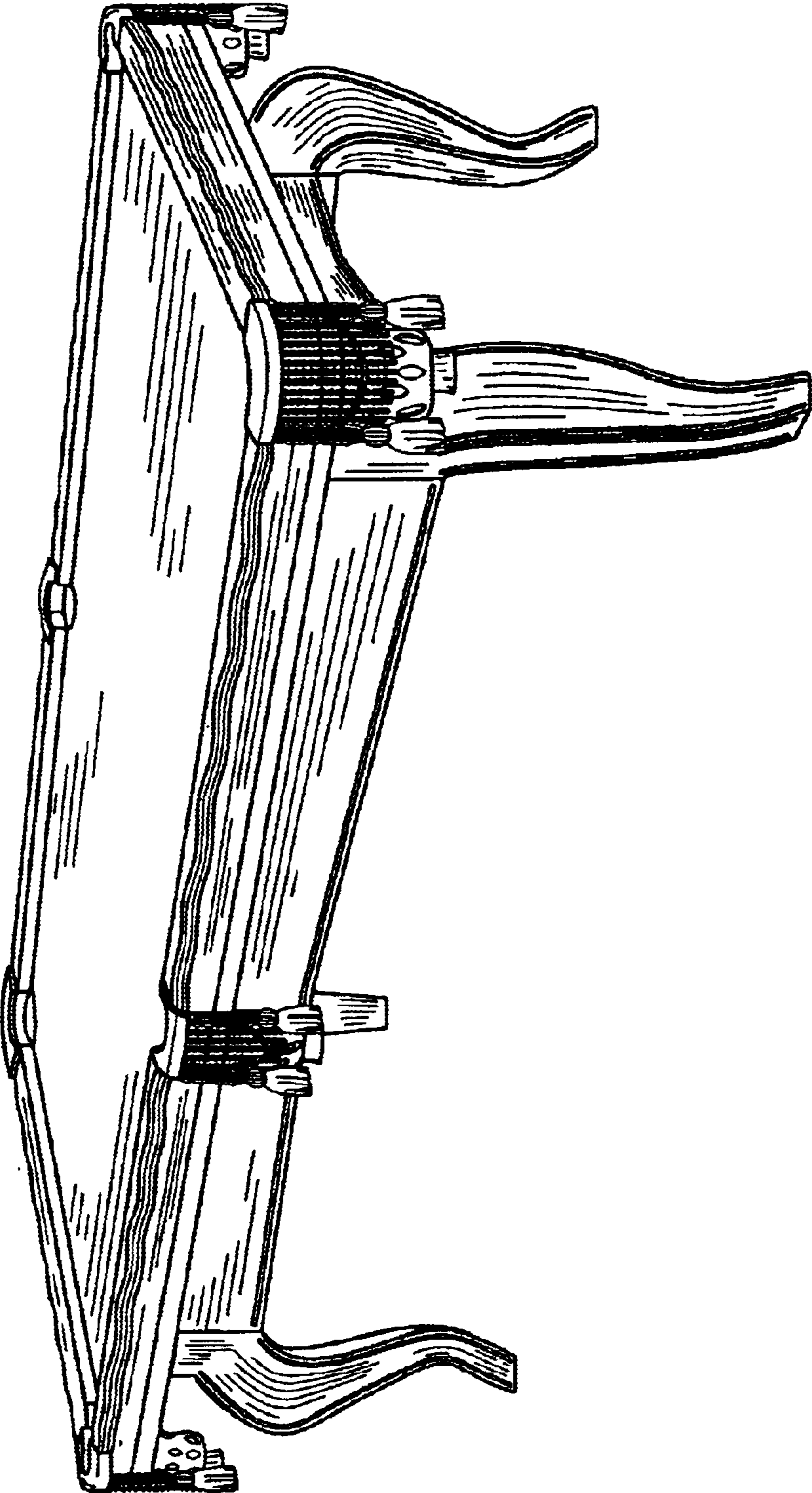

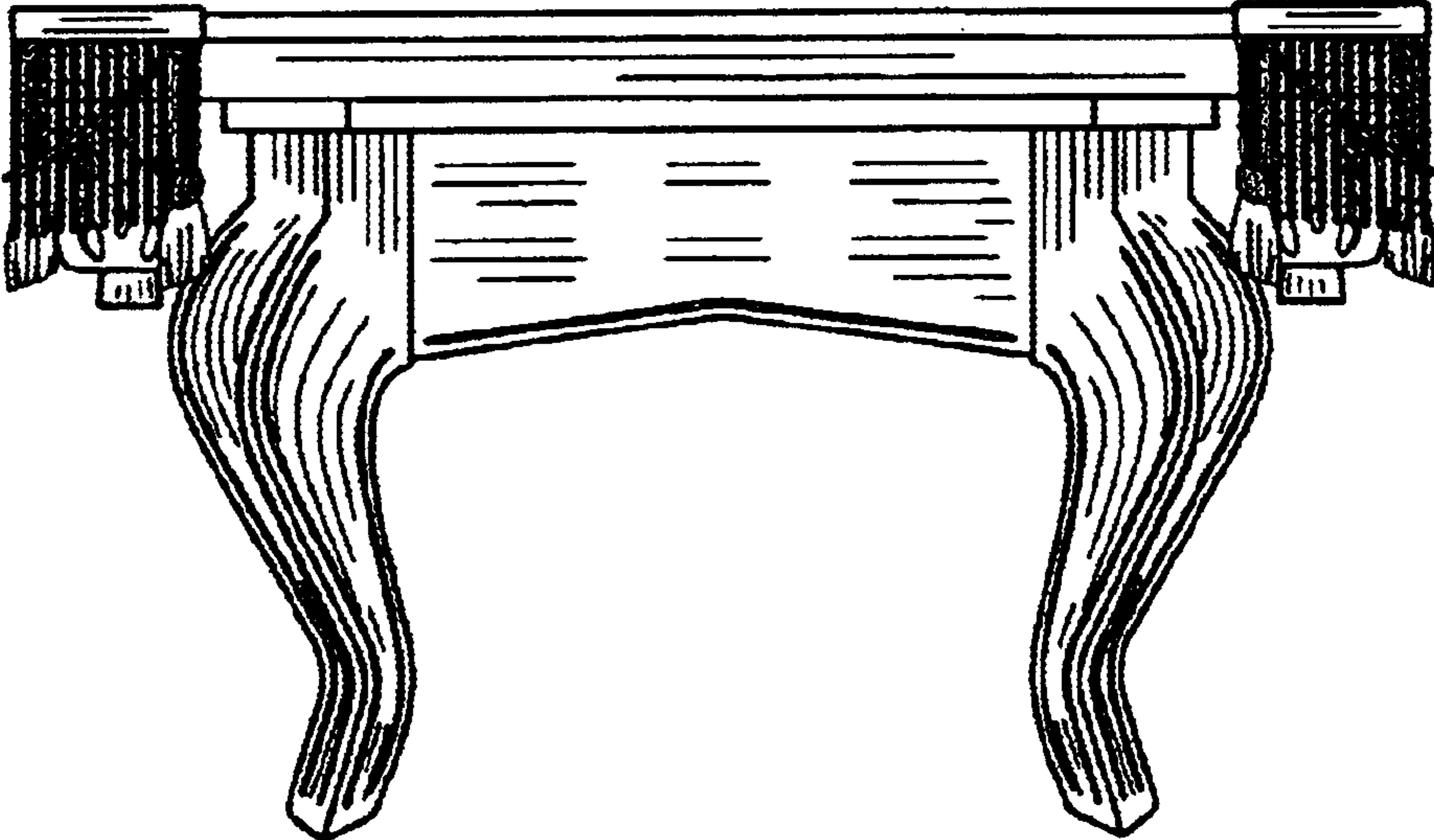

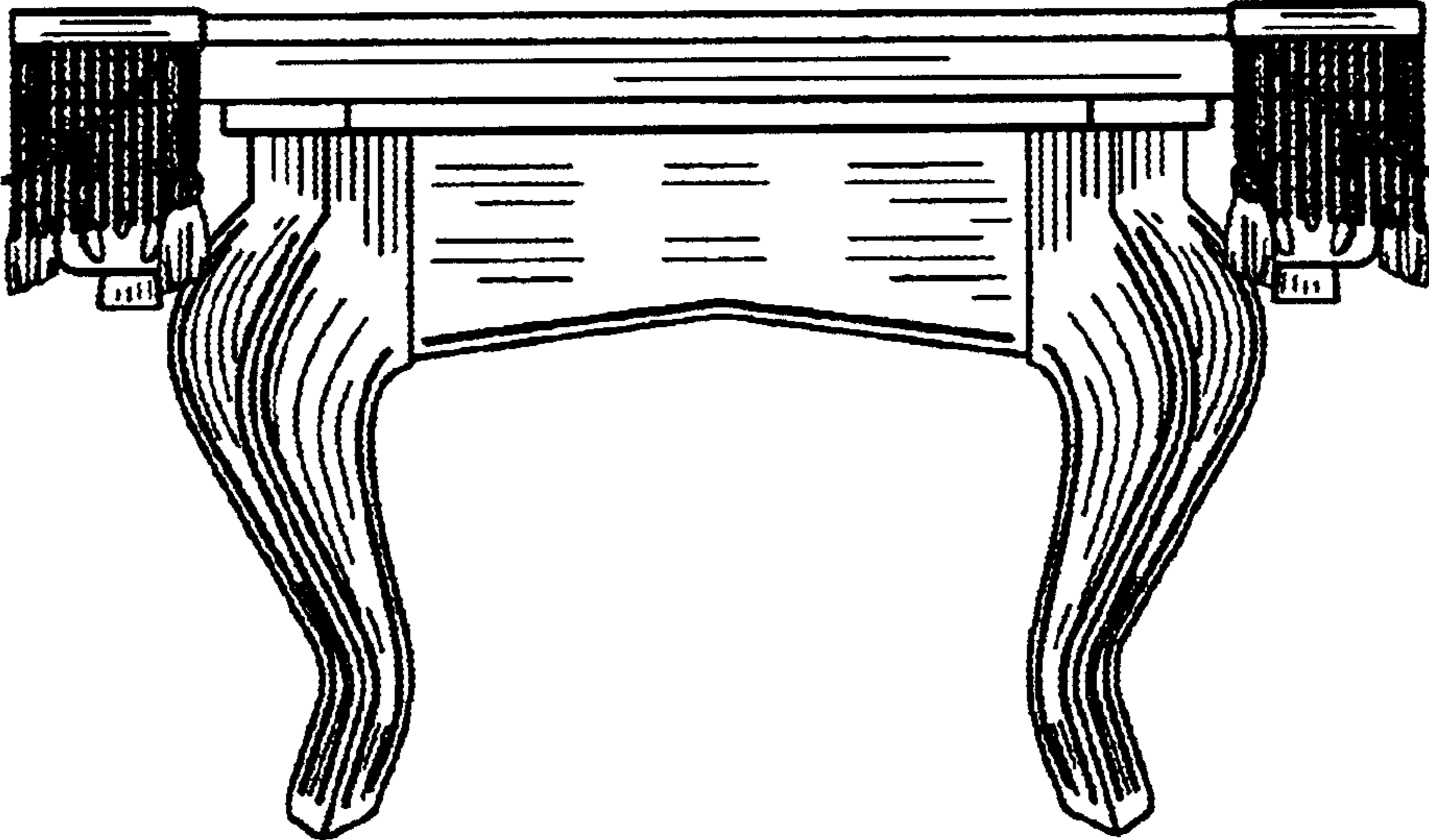

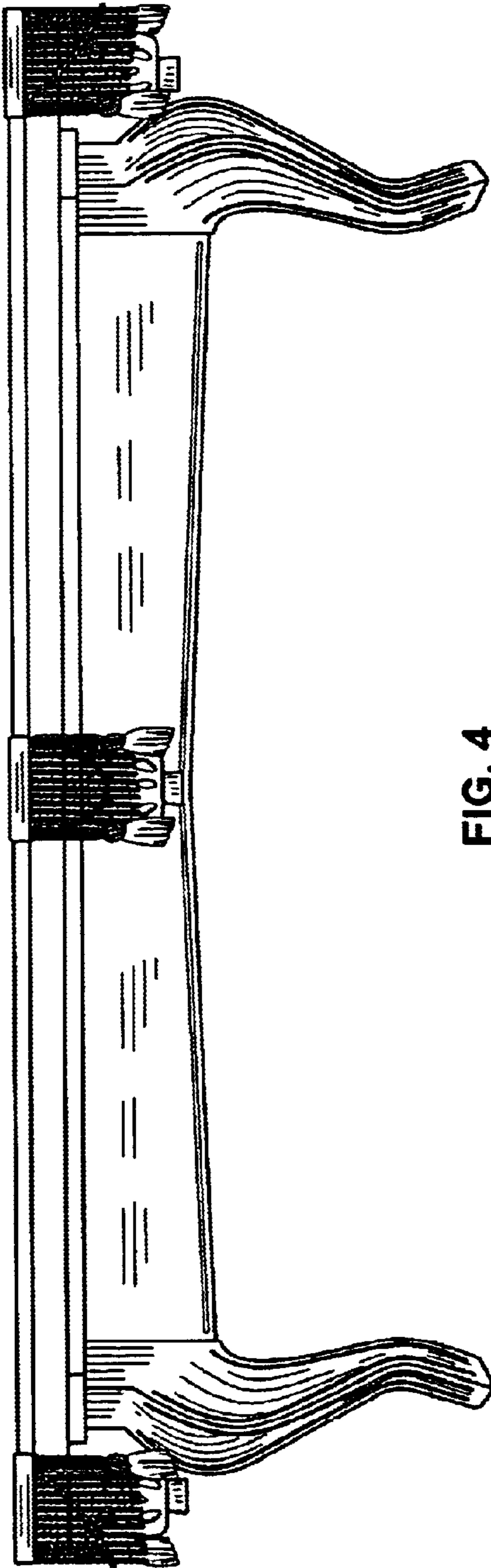

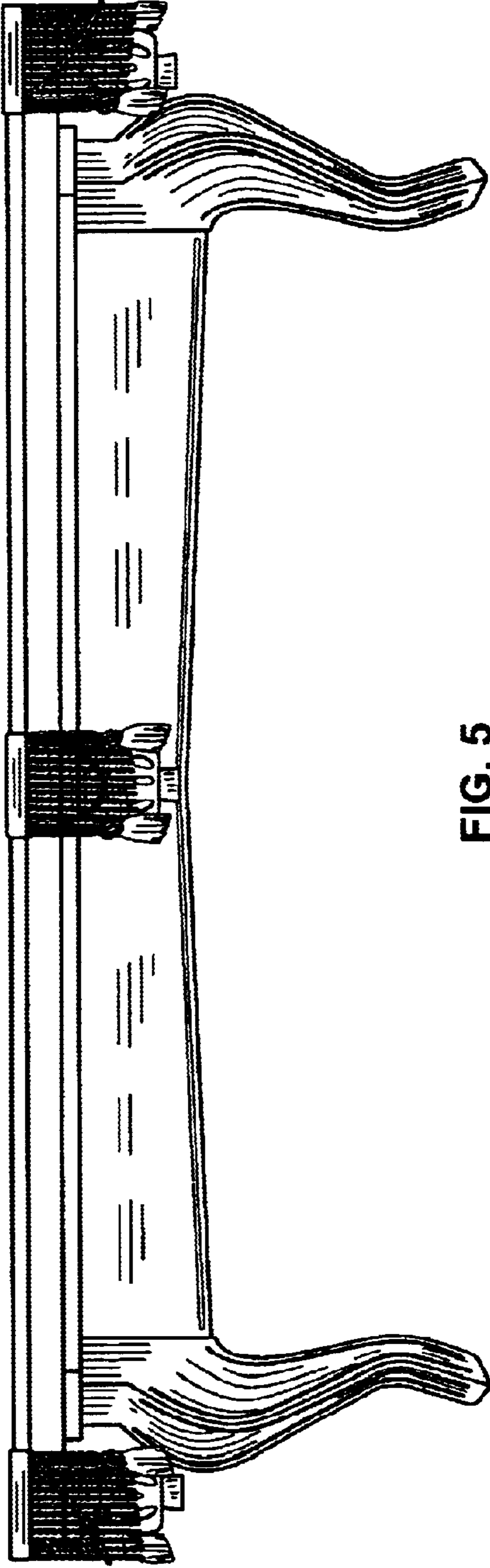

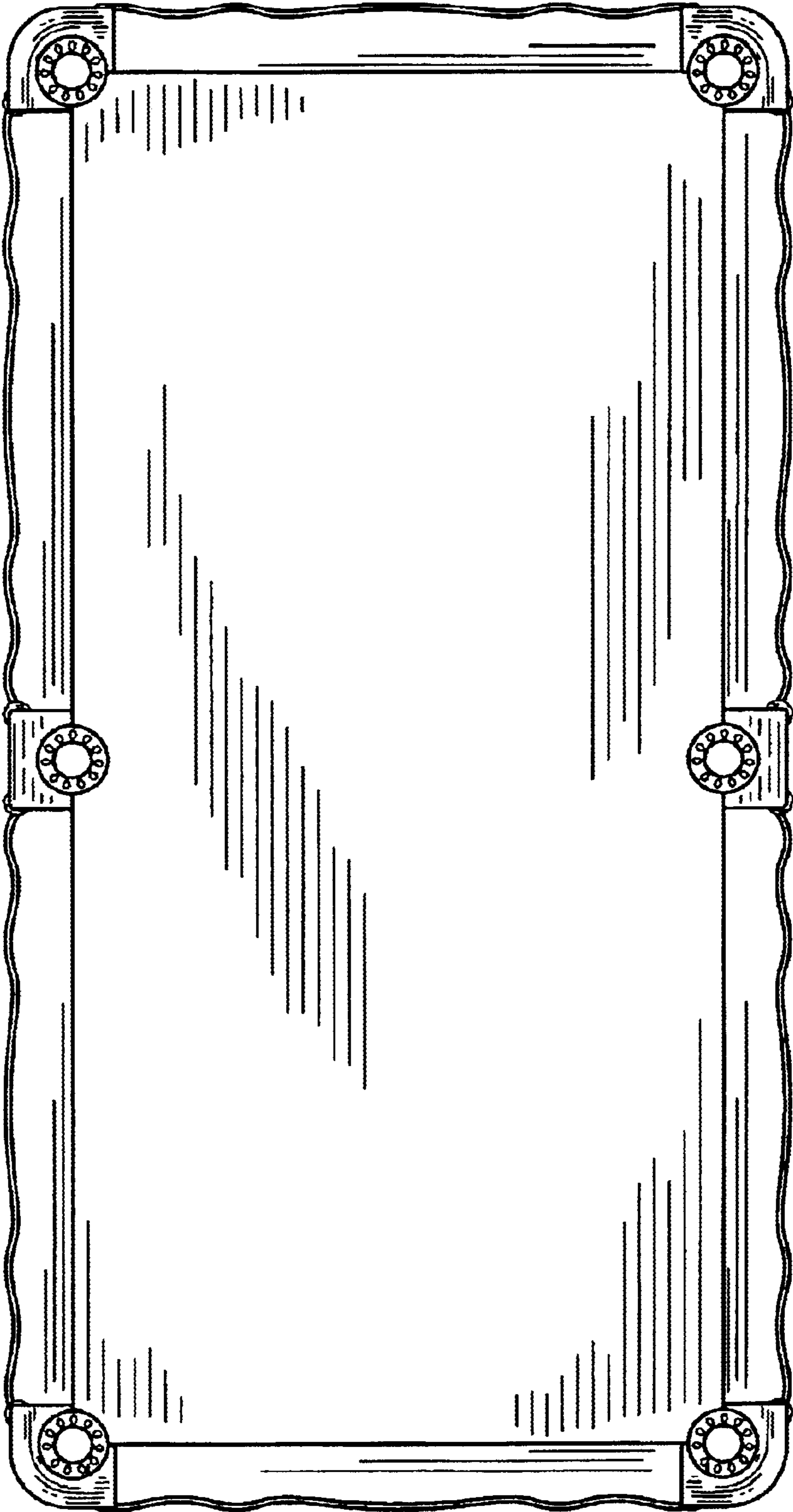

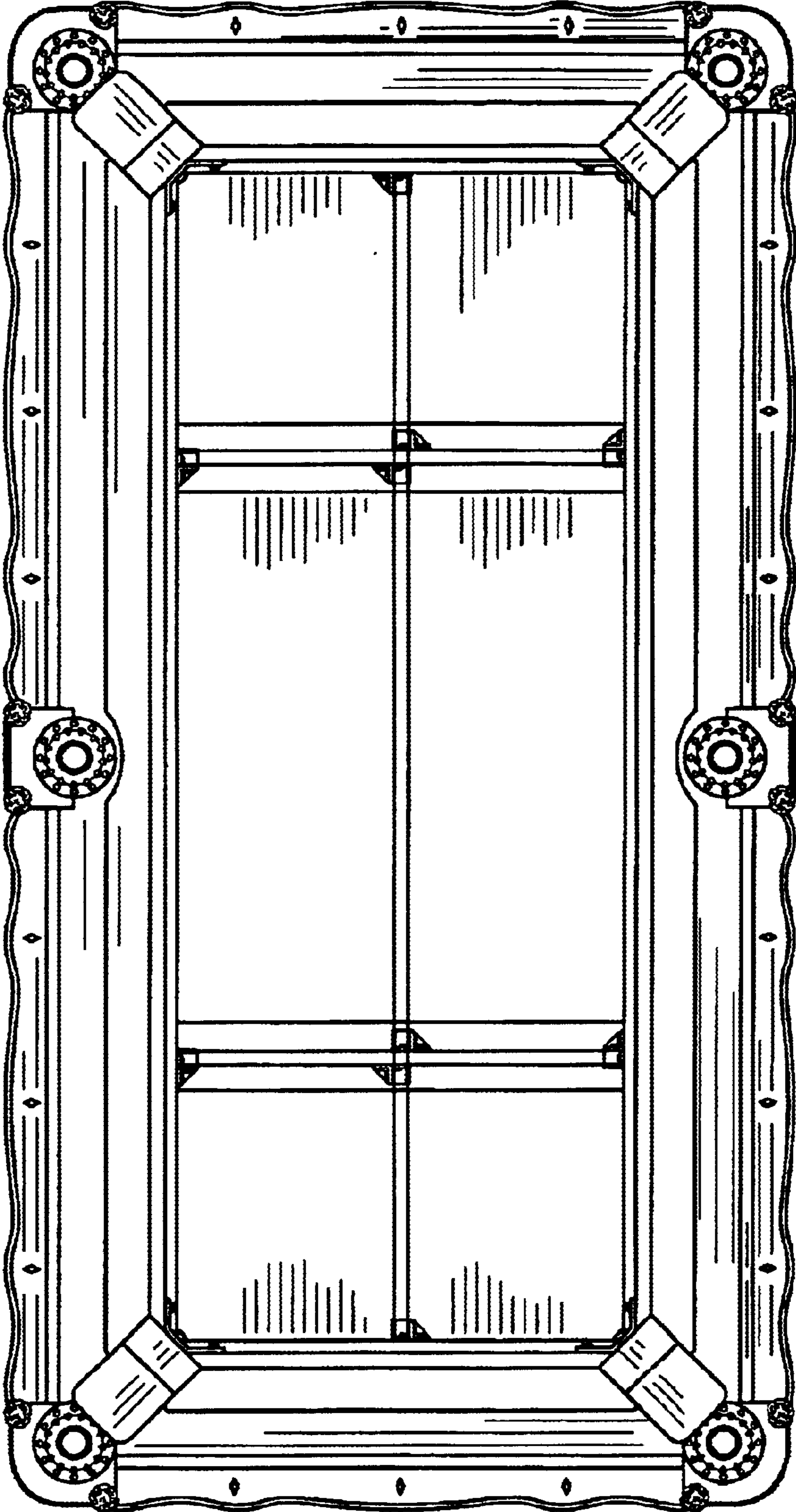
